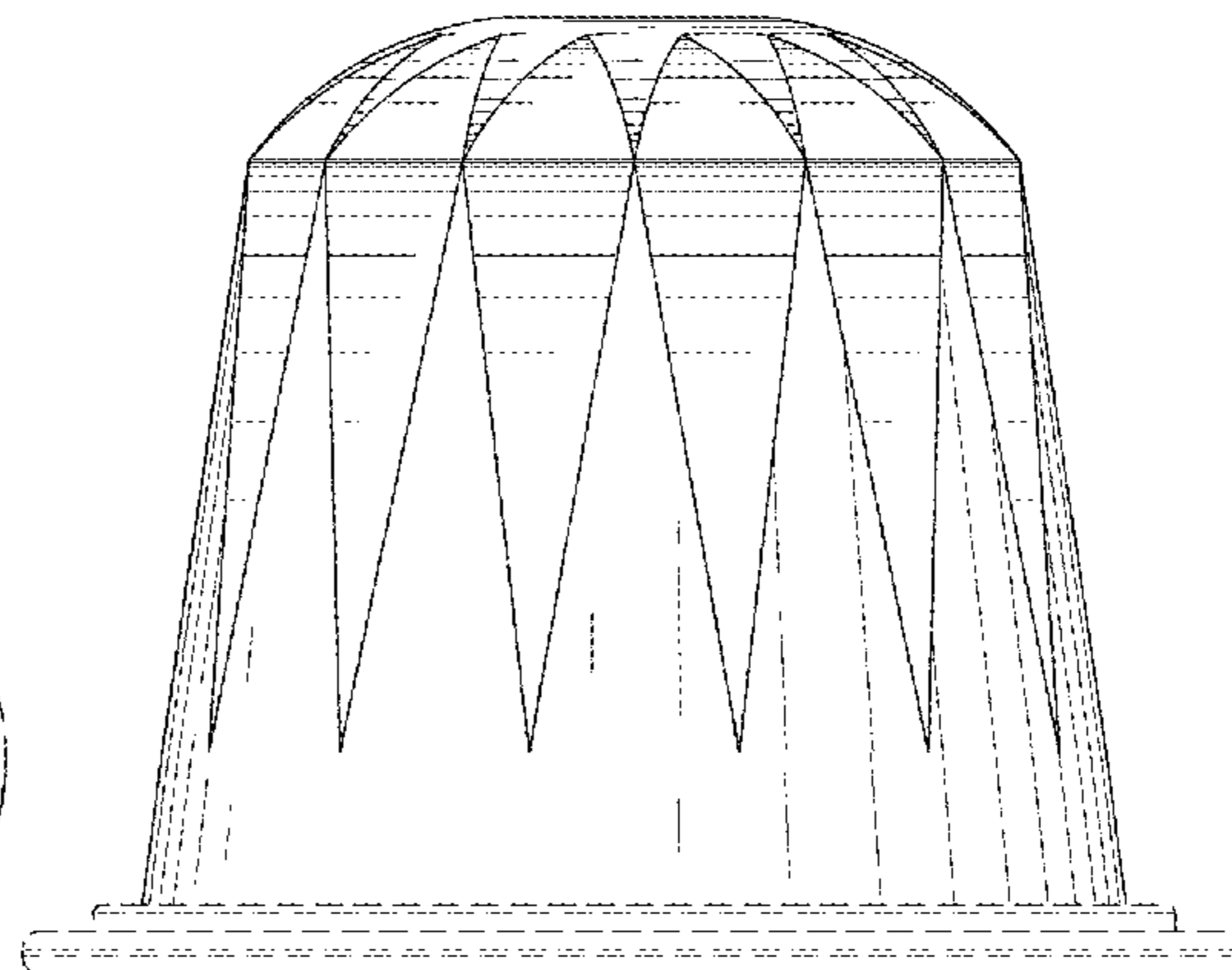
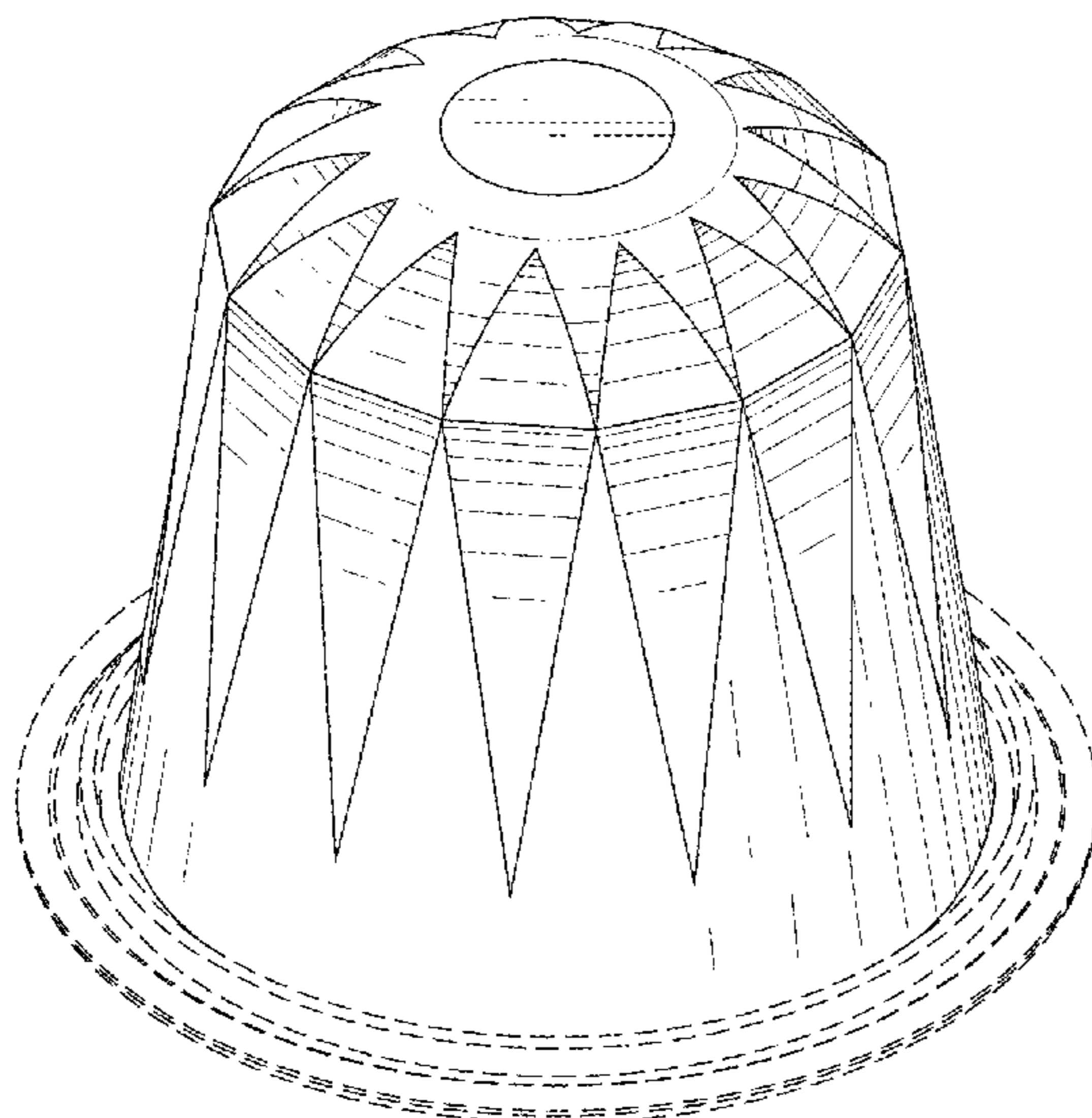
(57) **CLAIM**

The ornamental design for a beverage pod, as shown and described.

DESCRIPTION

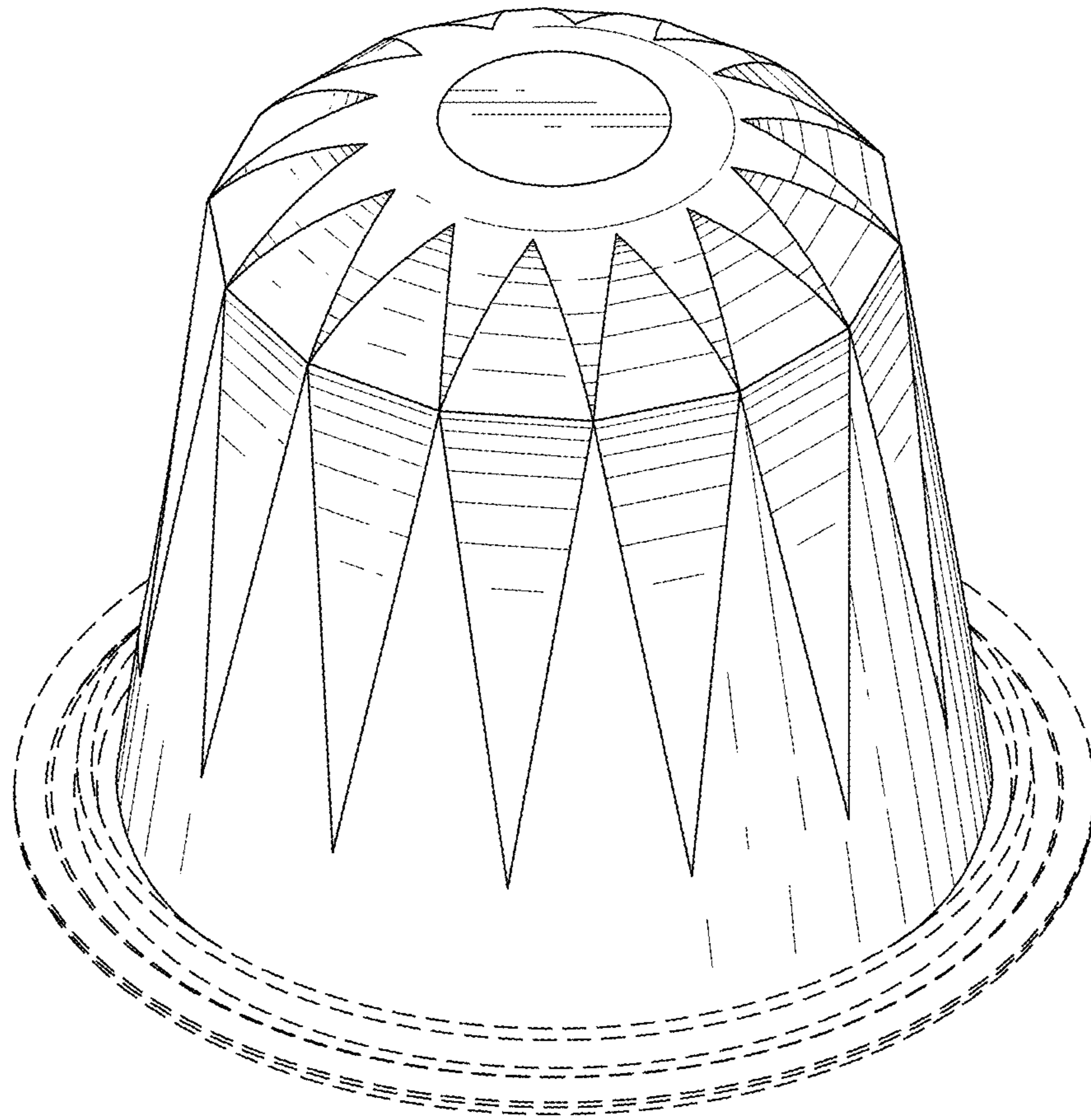

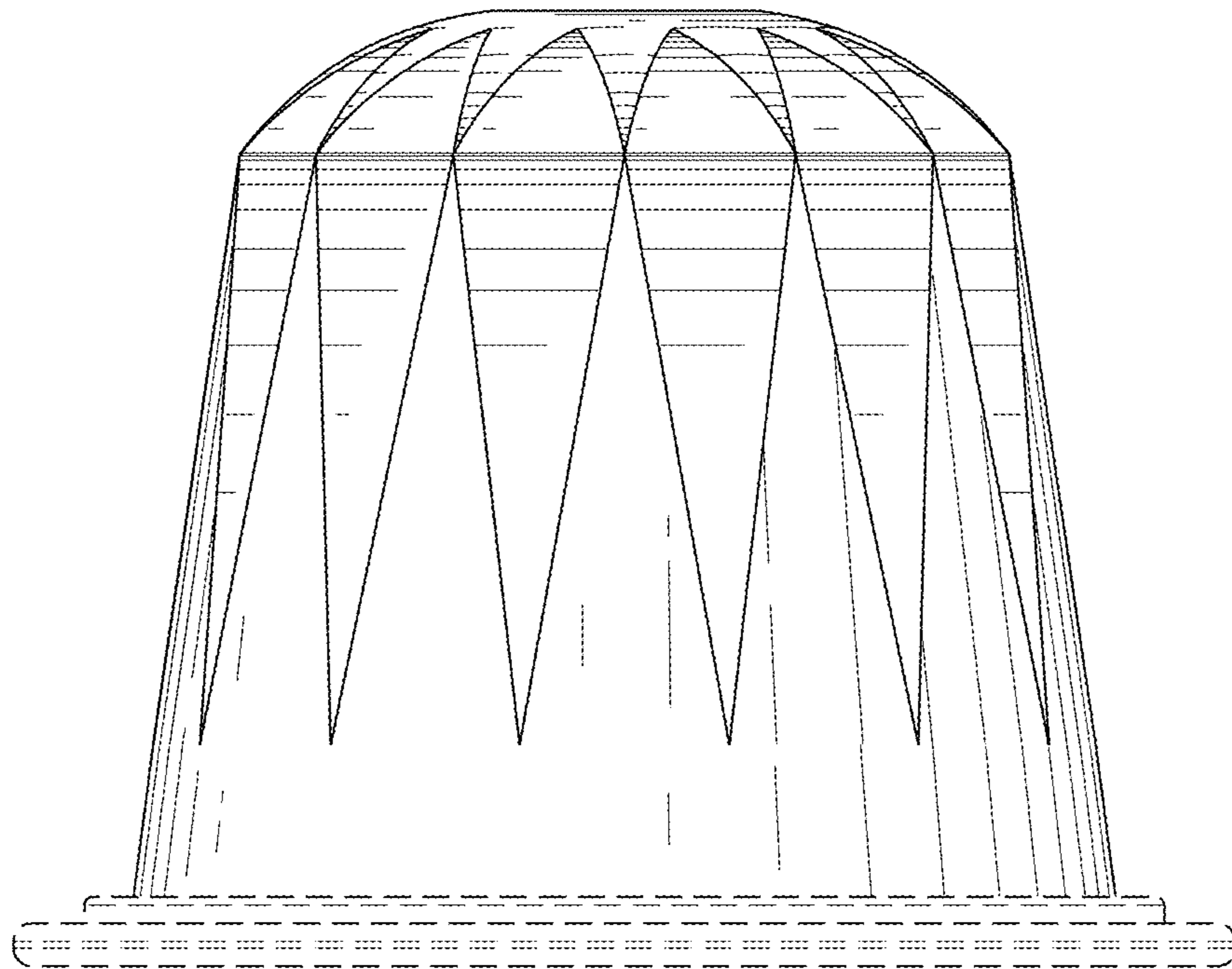

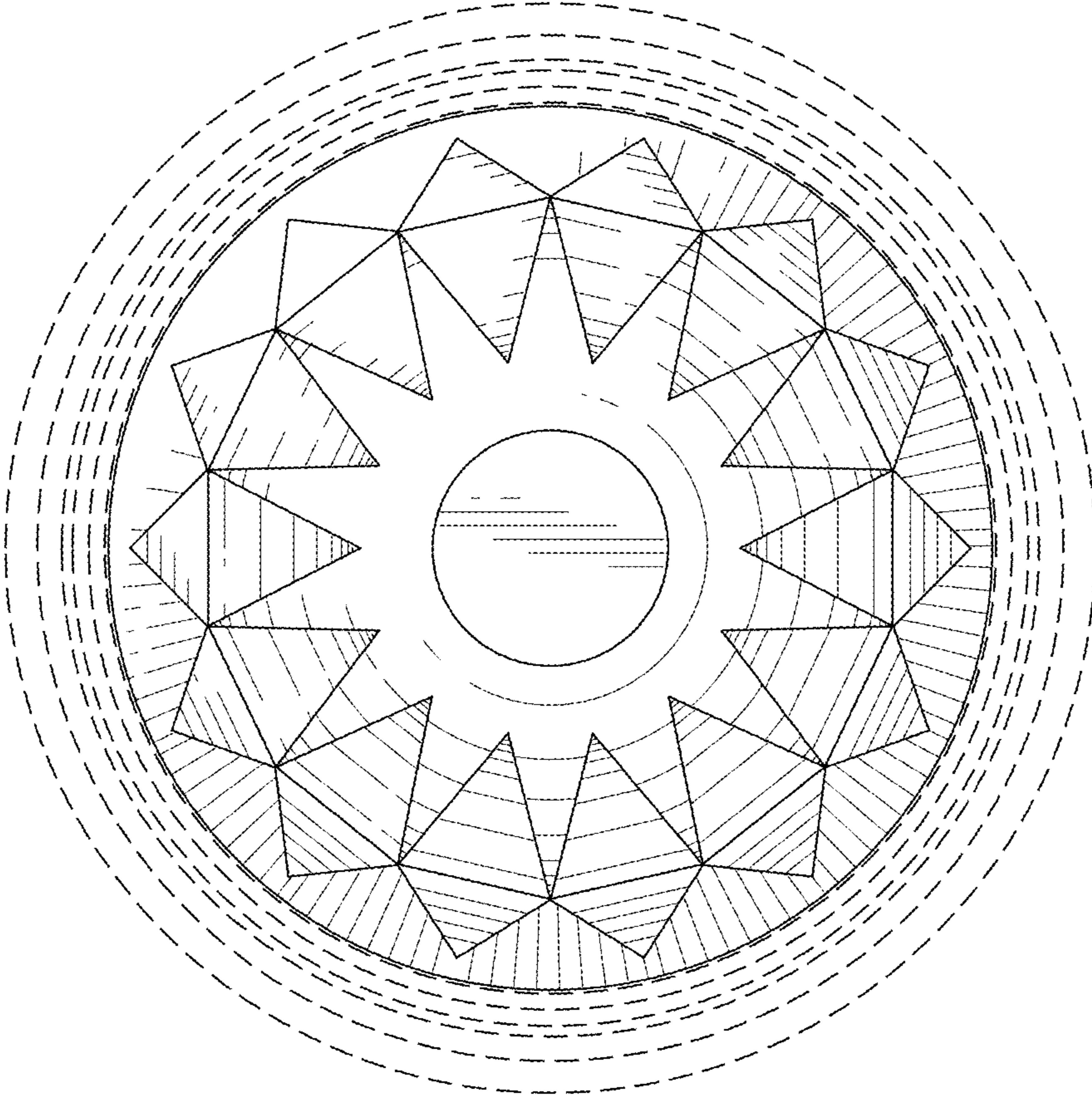
