FIG. 7 is a right-side elevational view.

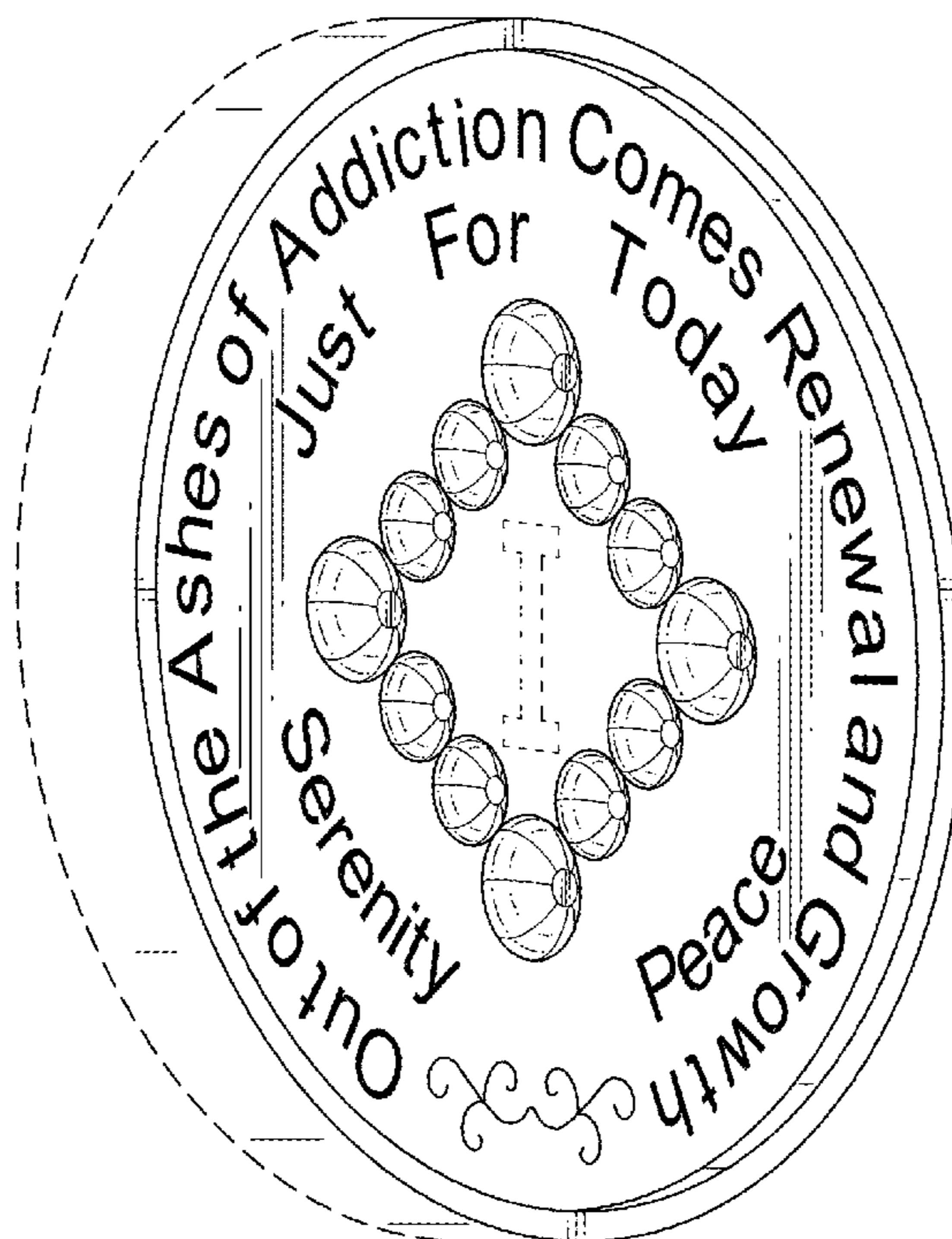

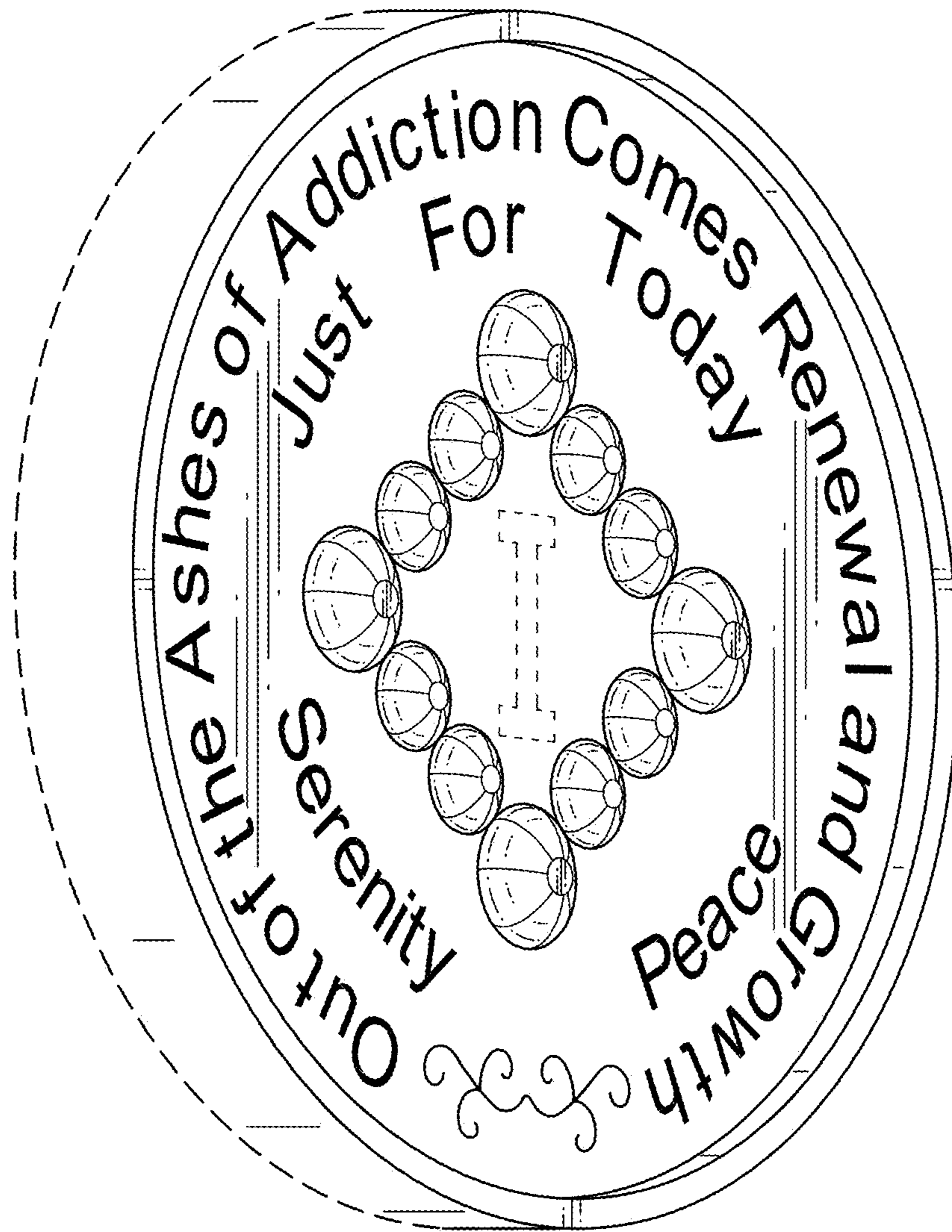

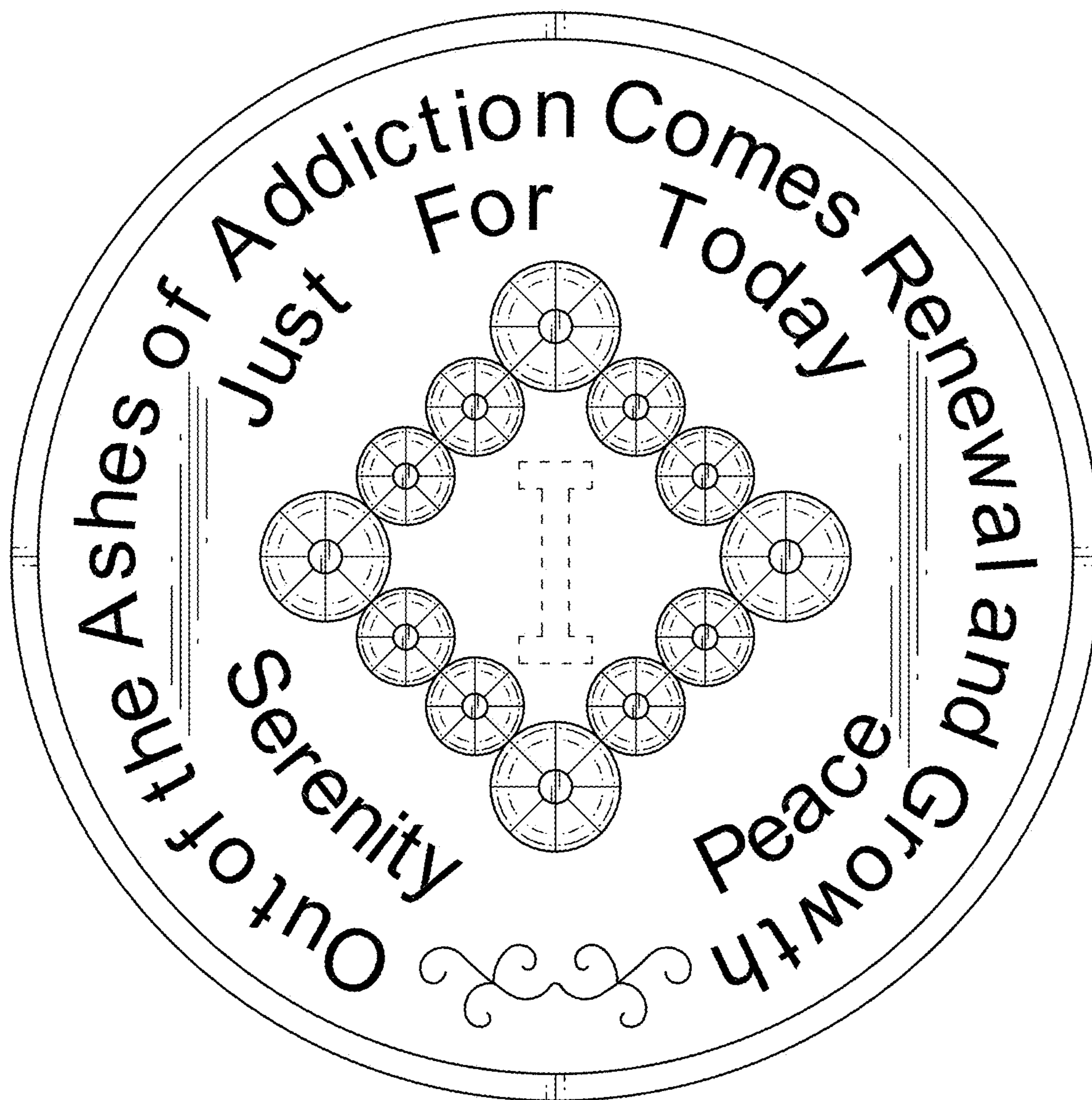

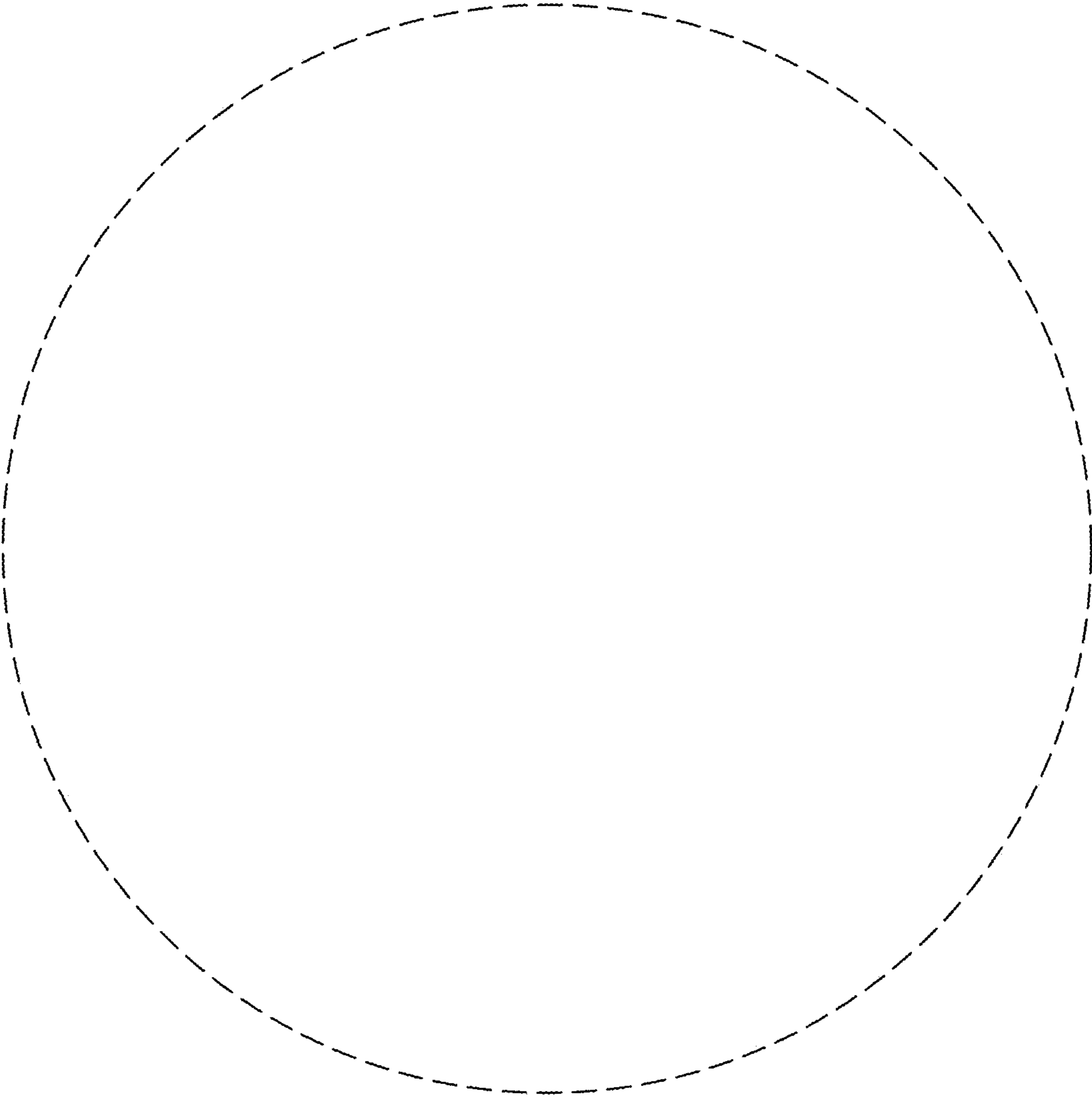

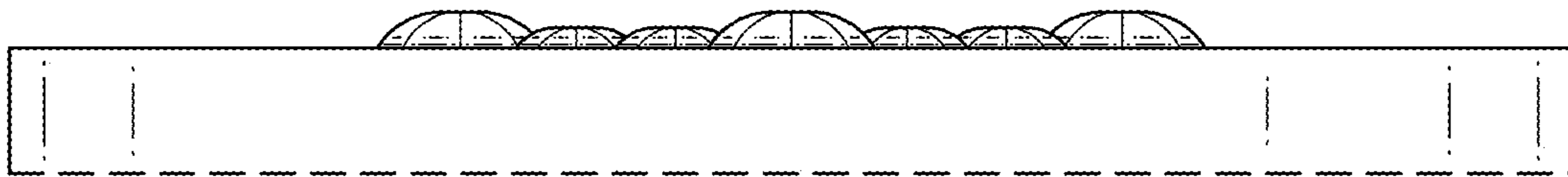

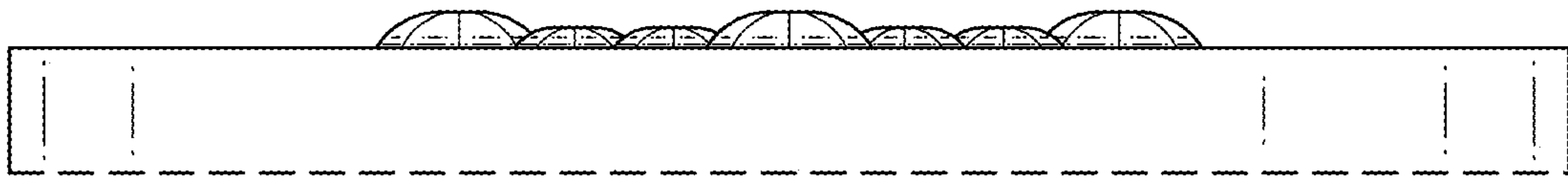
