(57) **CLAIM**

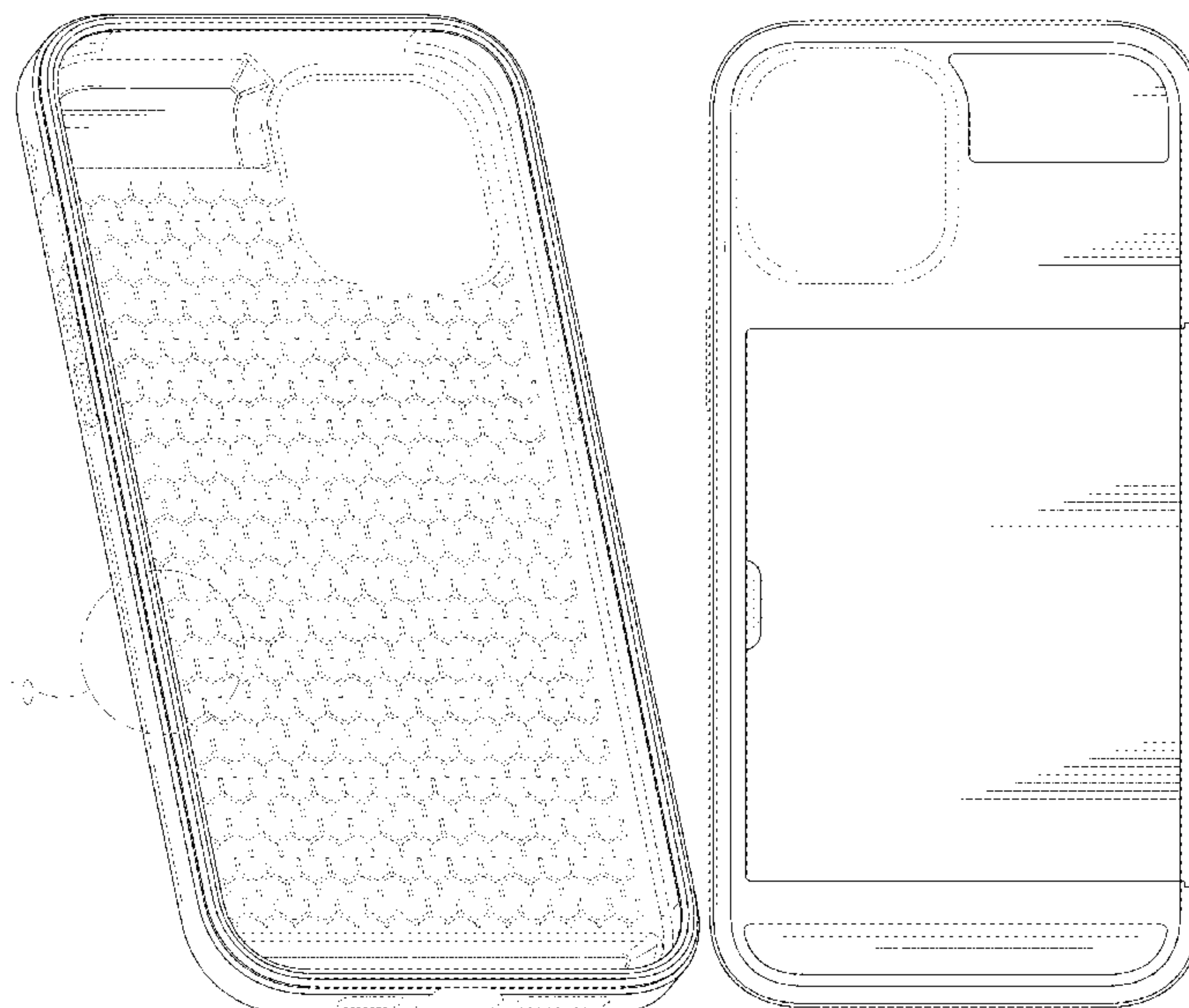
The ornamental design for a mobile phone case, as shown and described.

DESCRIPTION

FIG. 1 is a front, left-side, and bottom perspective view of a mobile phone case showing my new design;

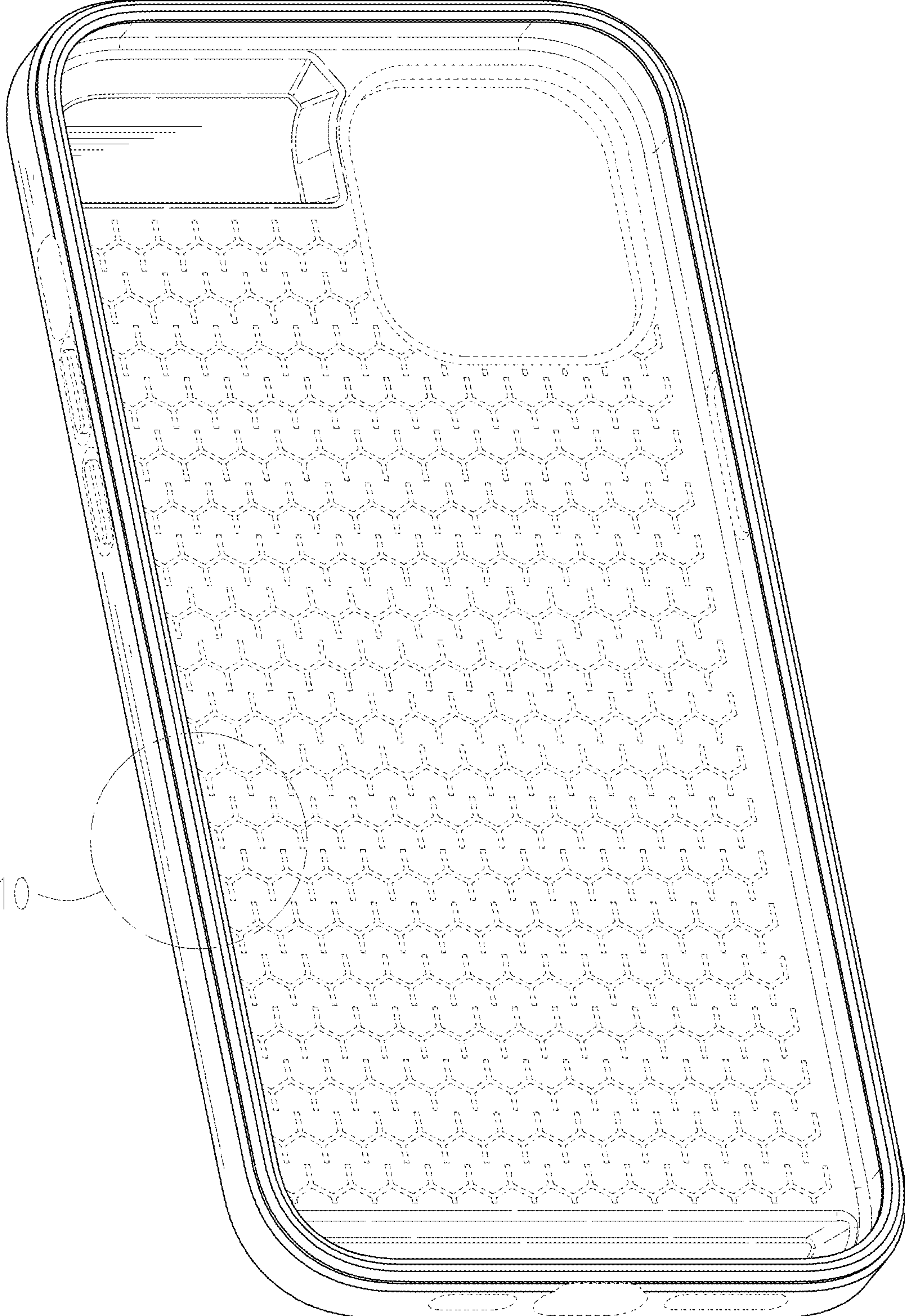

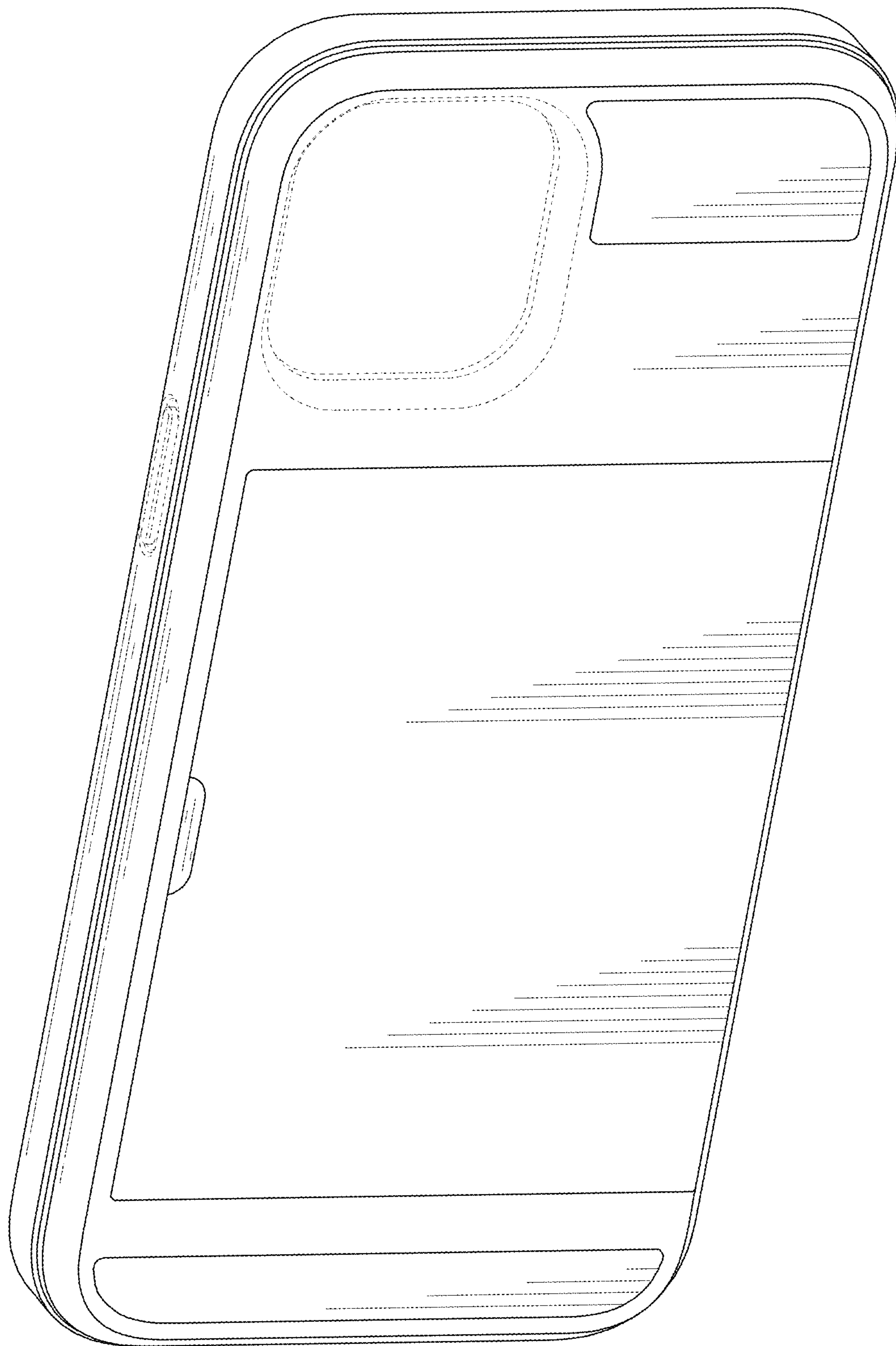

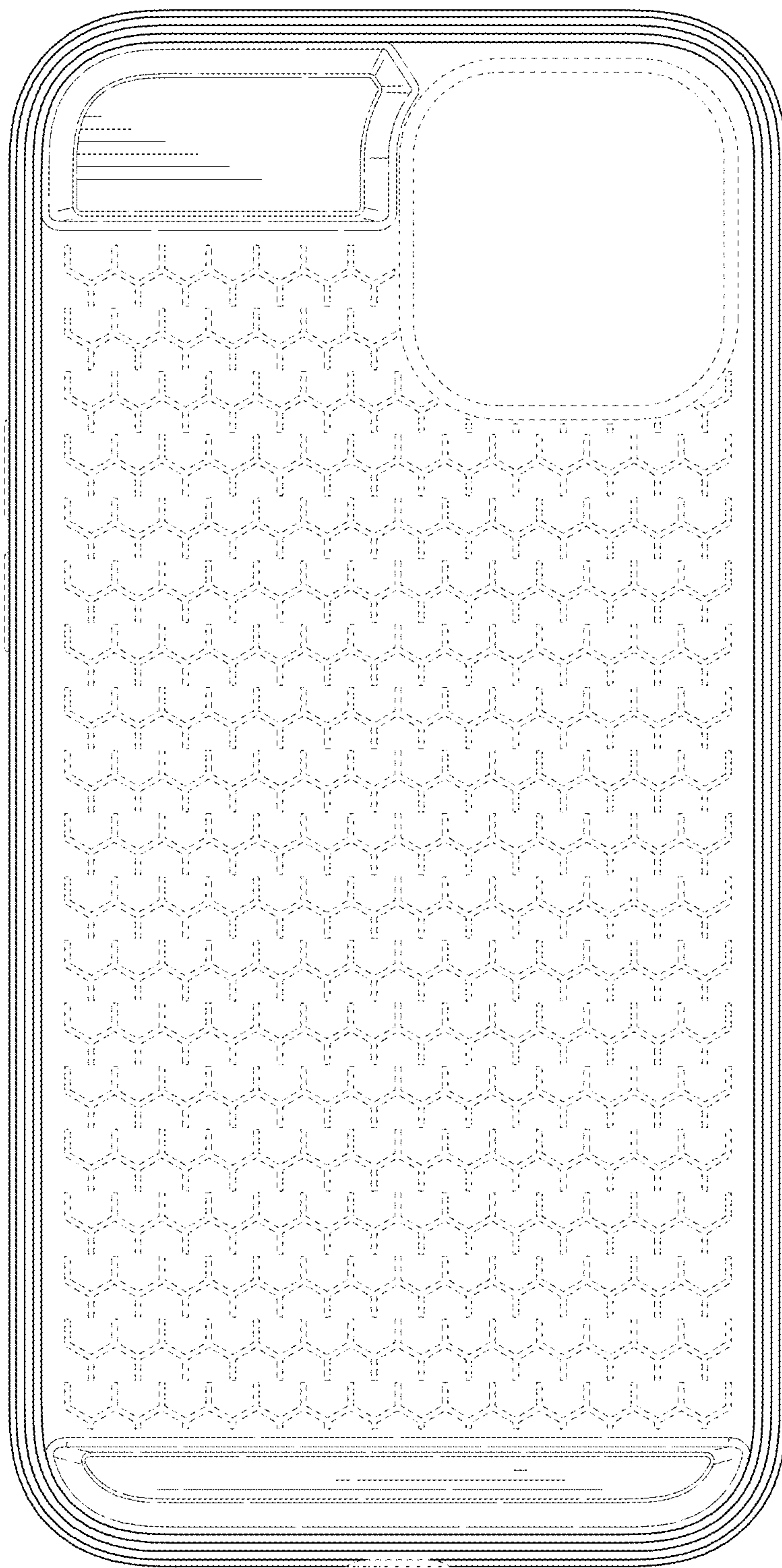

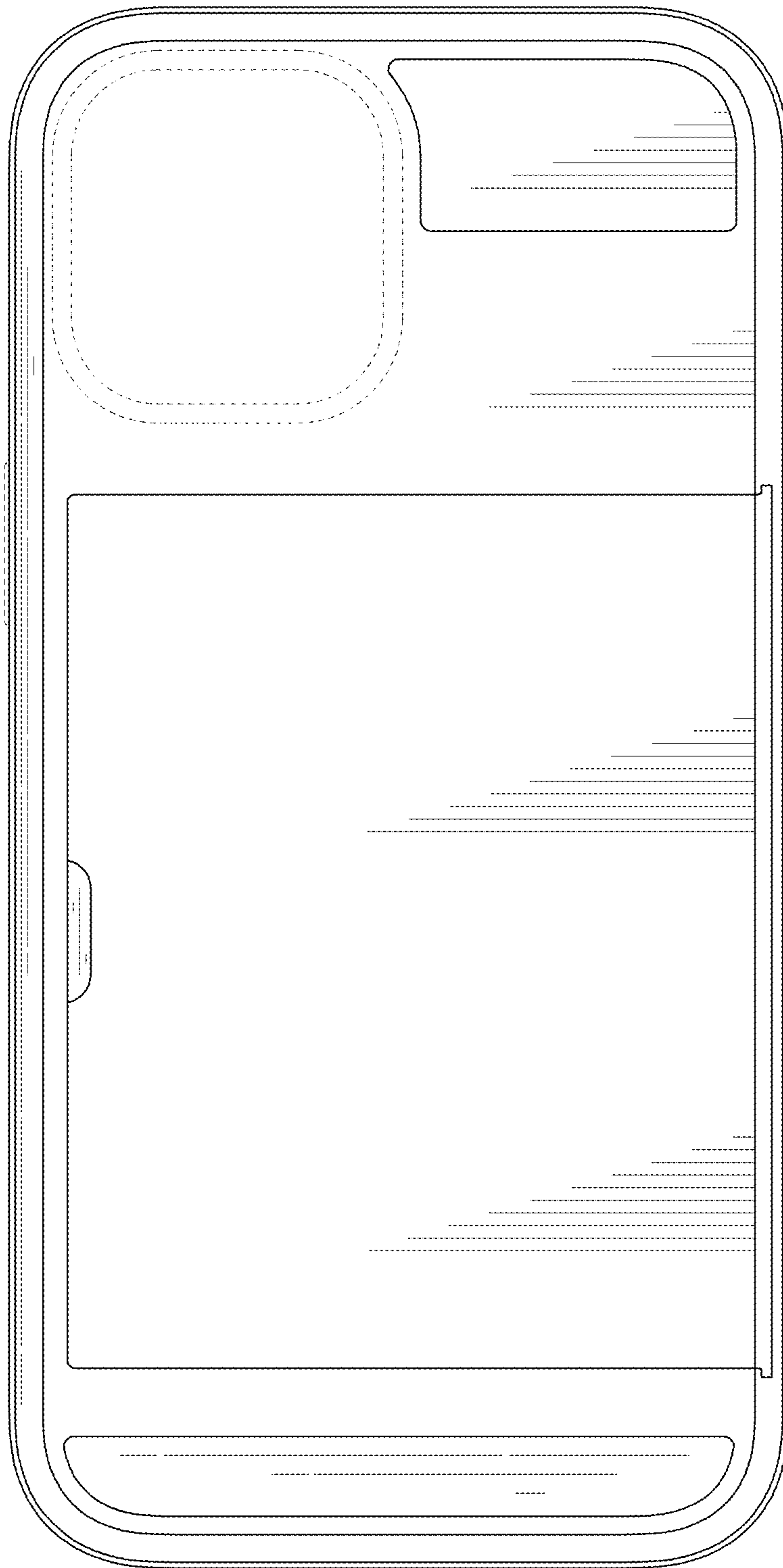

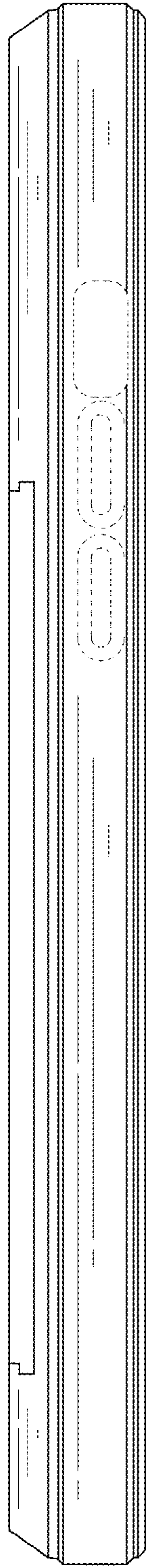

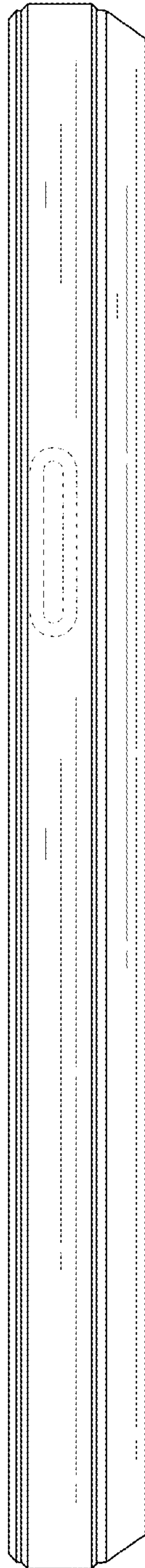

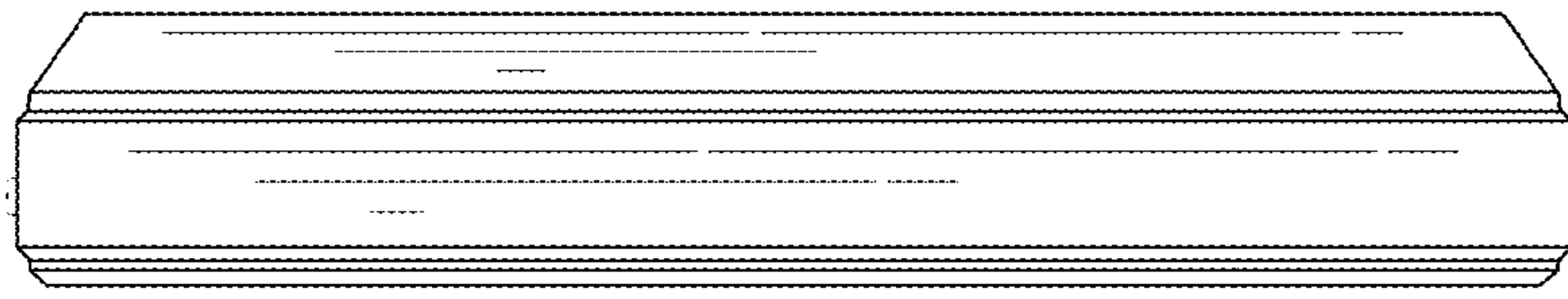

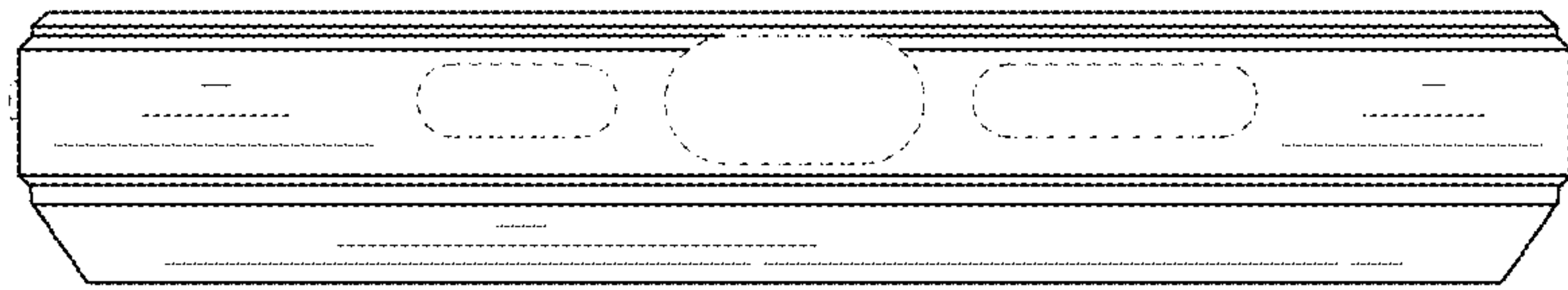

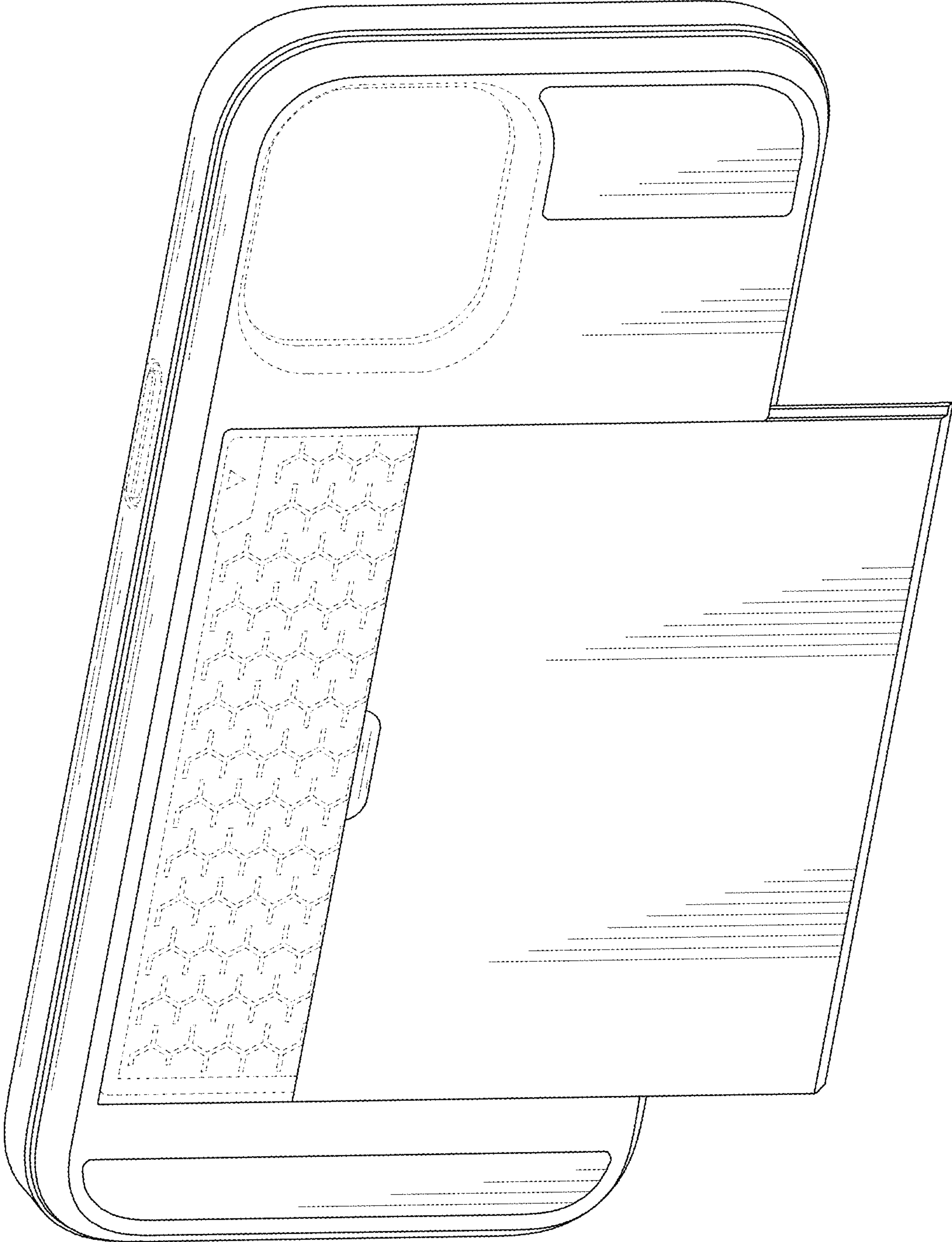

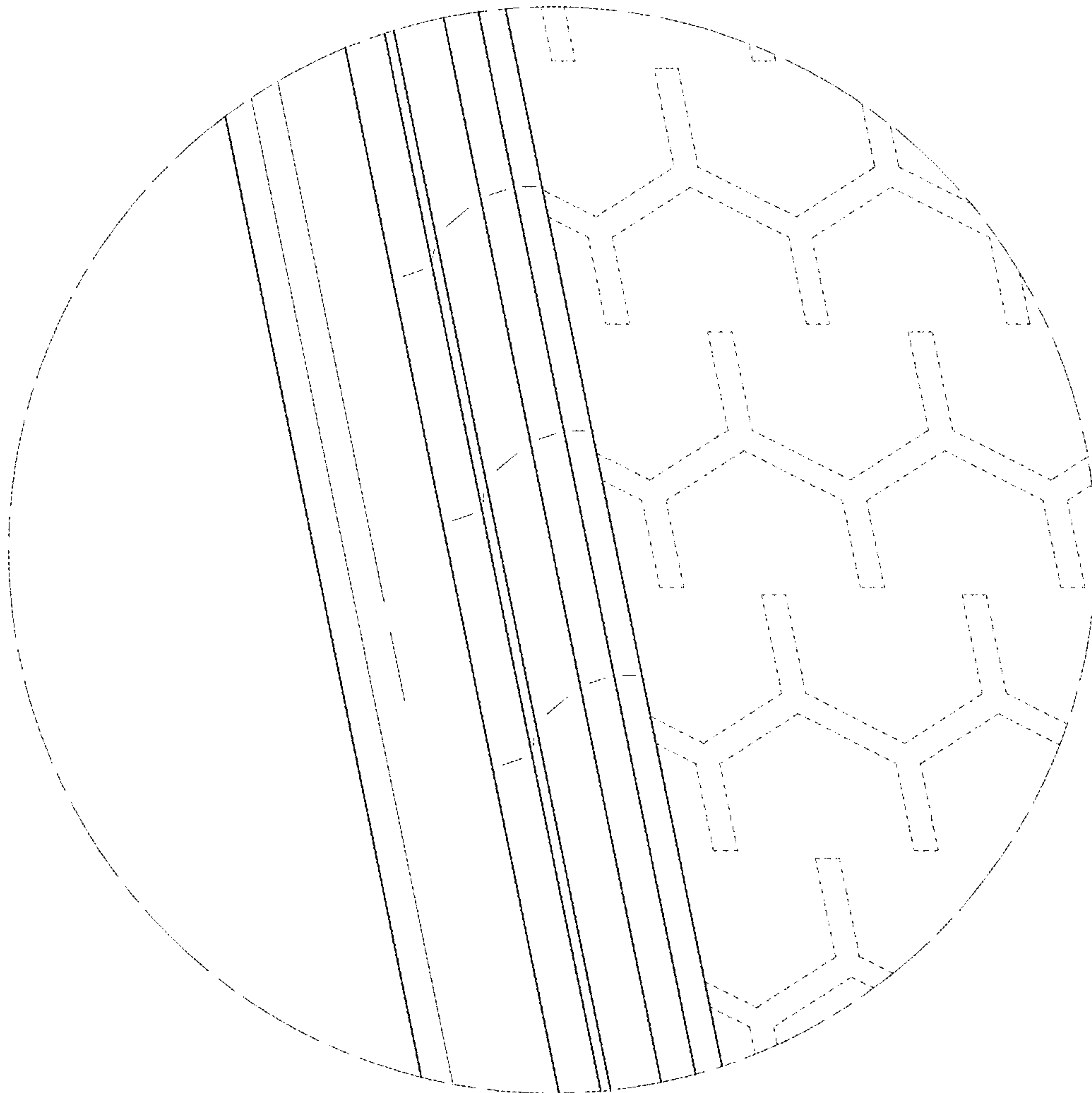
