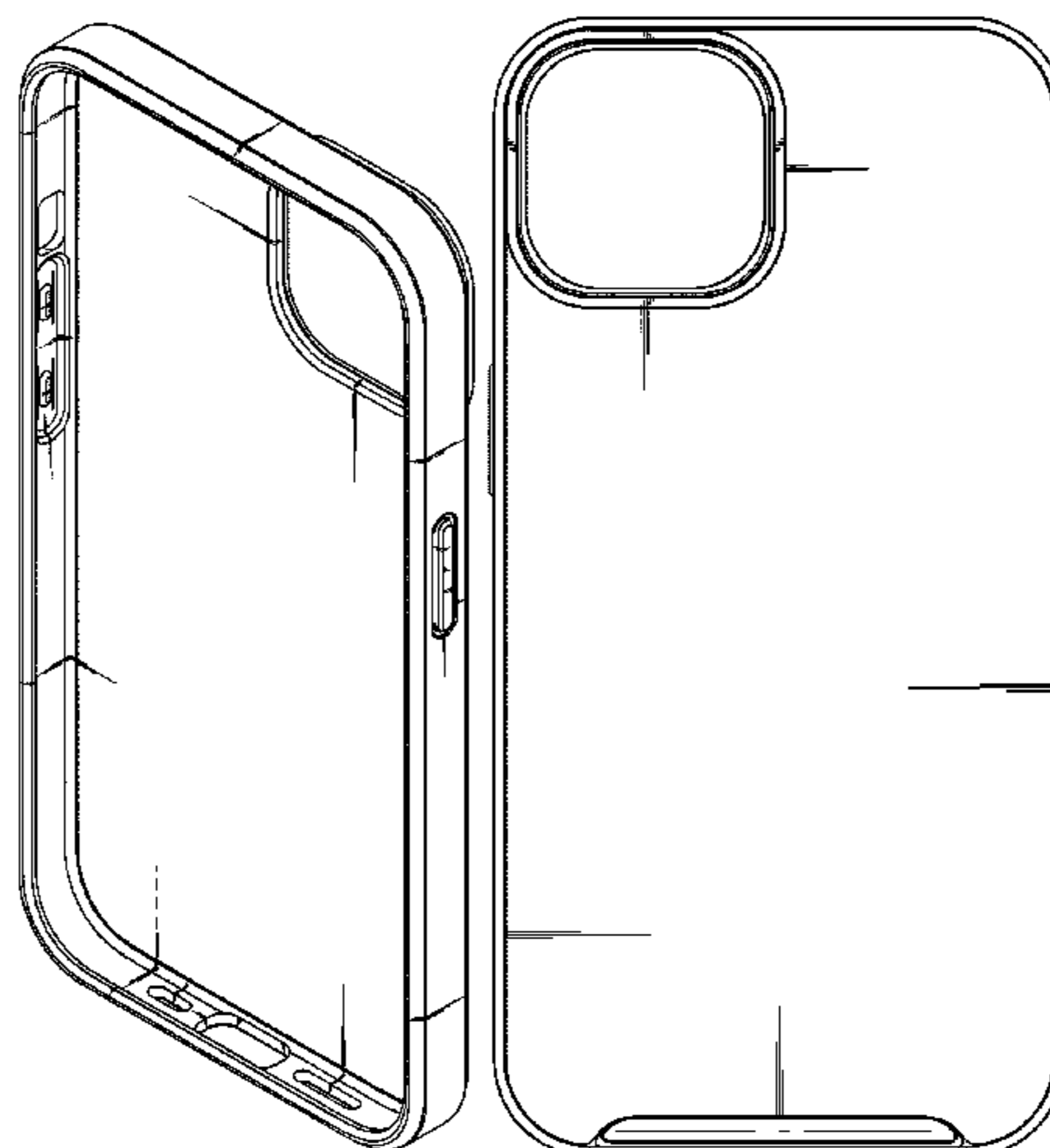


FIG. 29 is a back, top, and left side perspective view of the third embodiment;

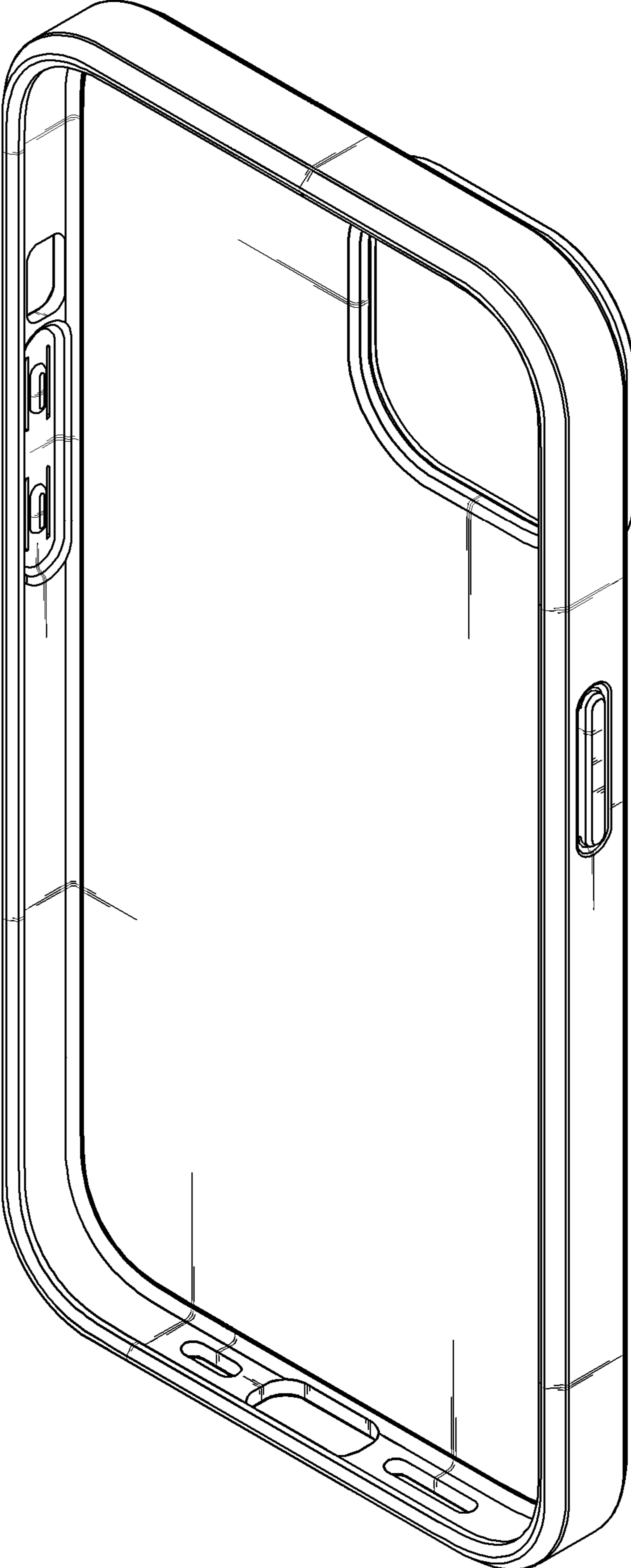

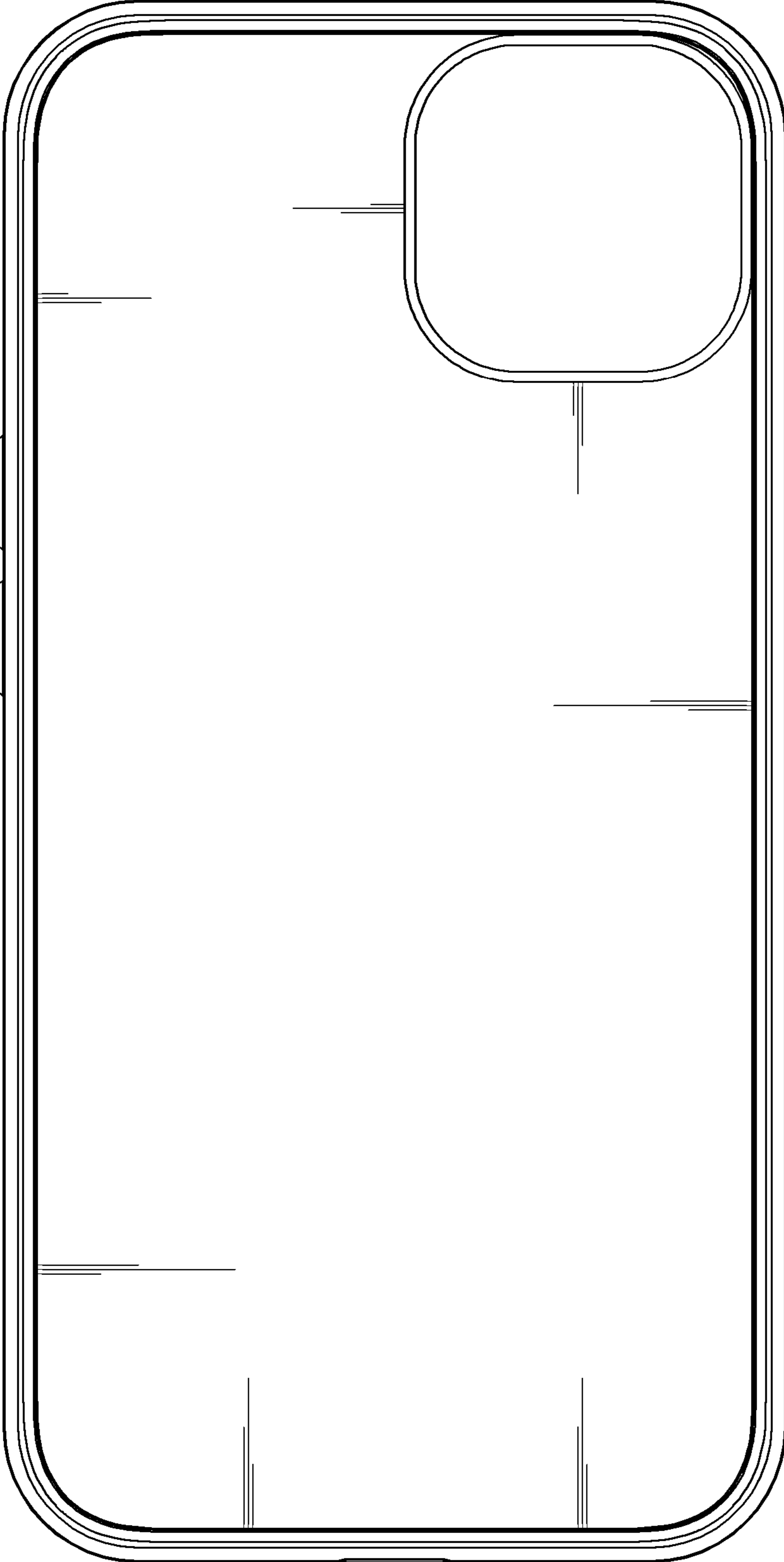

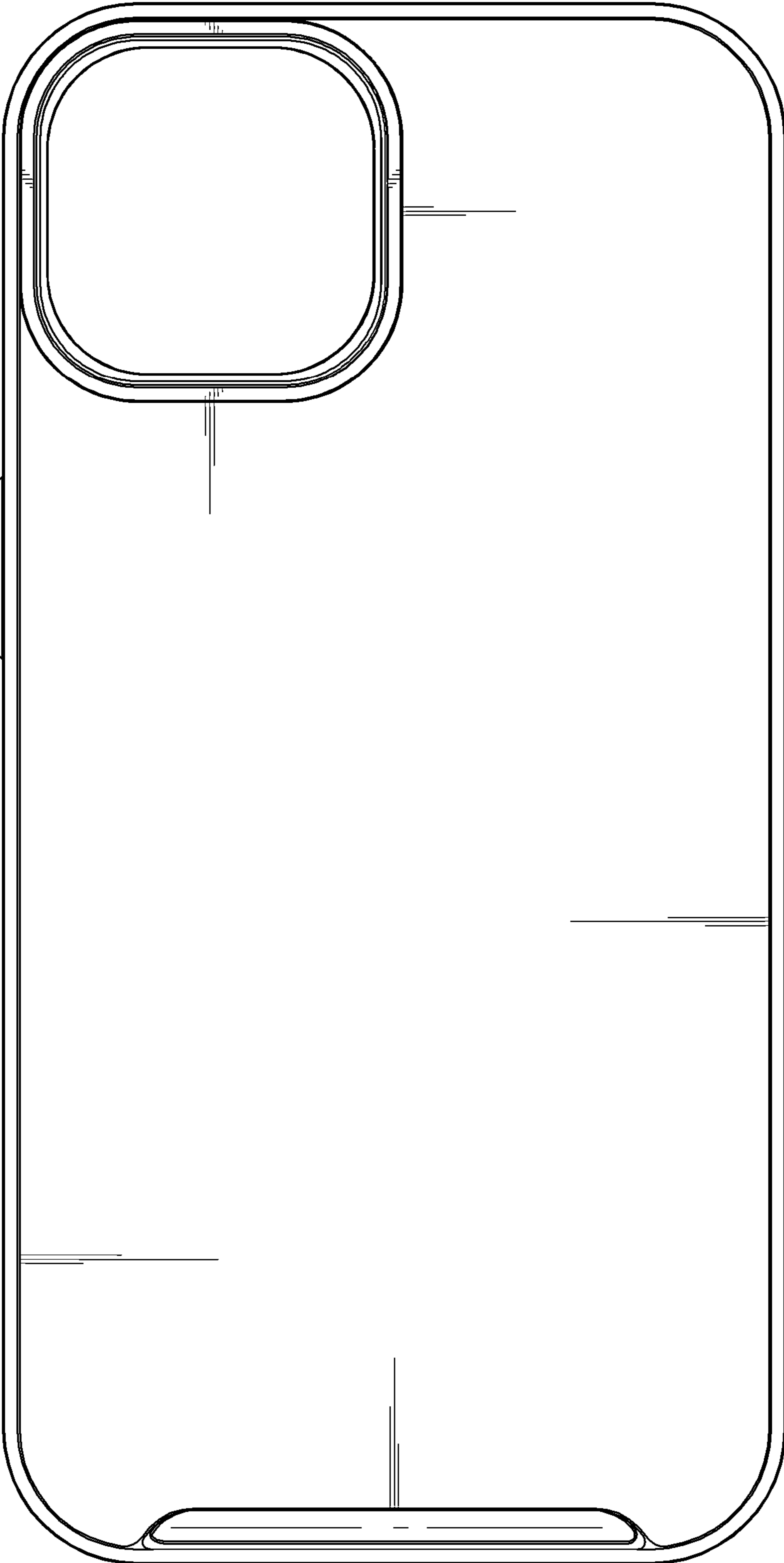

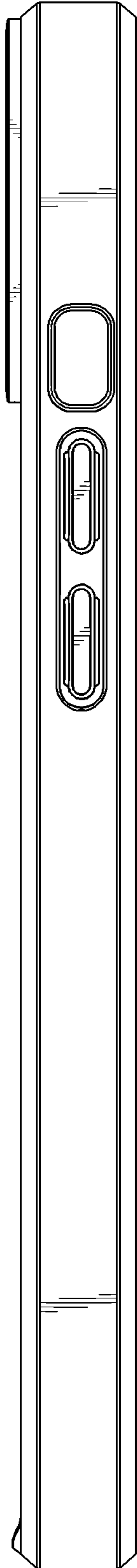

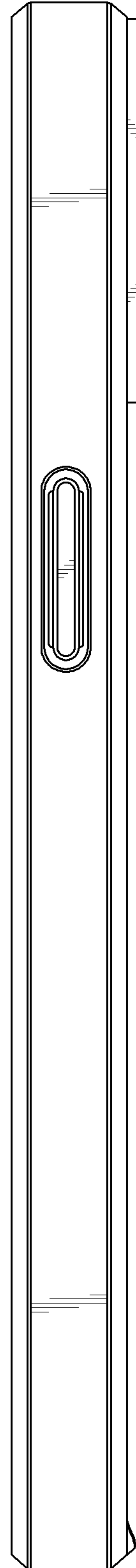

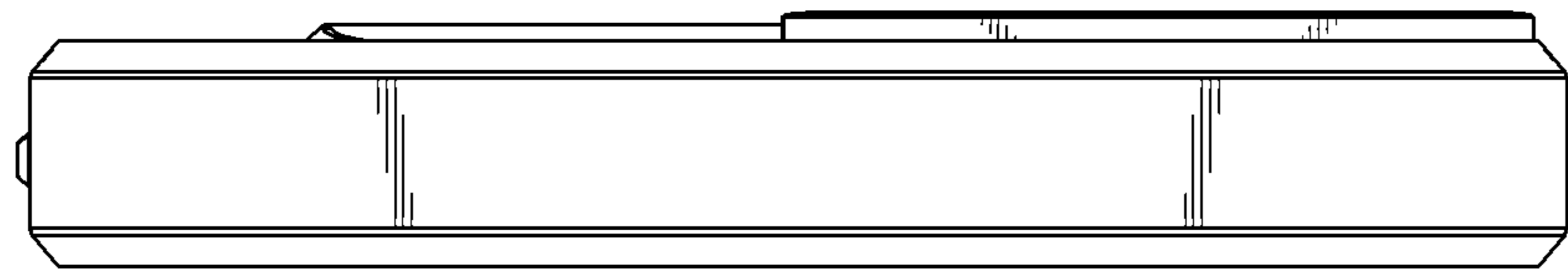

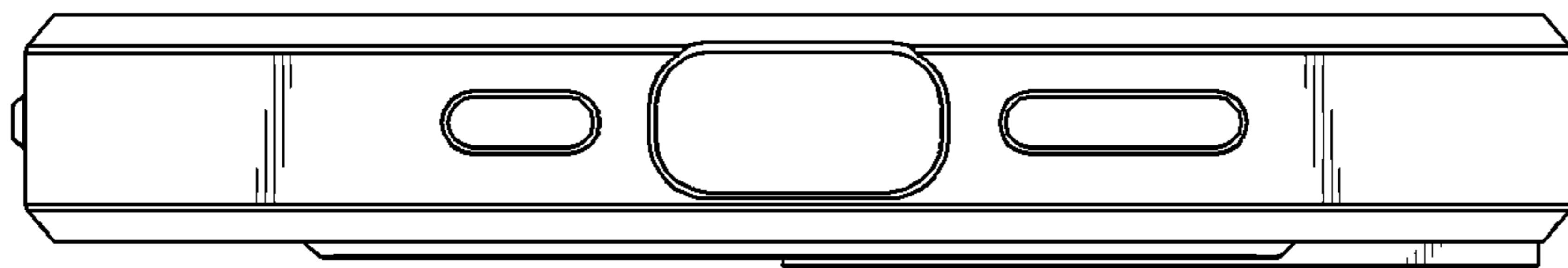

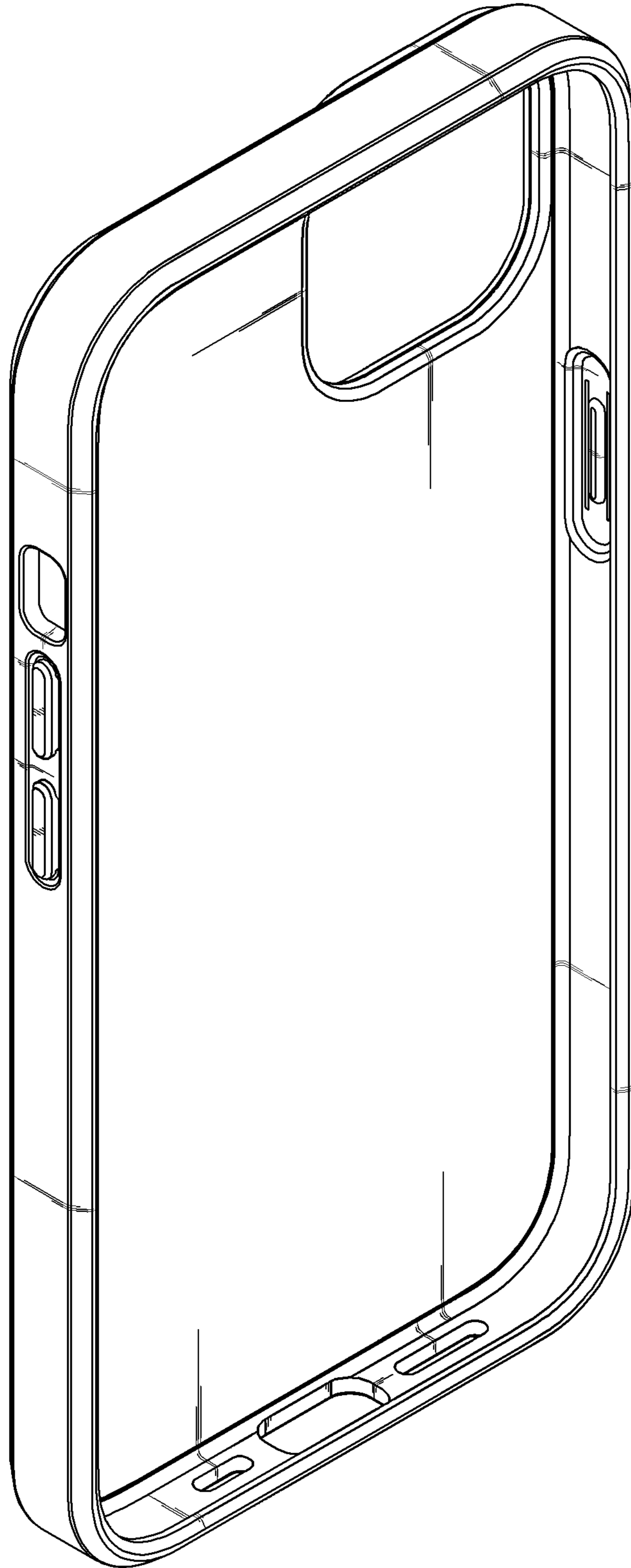

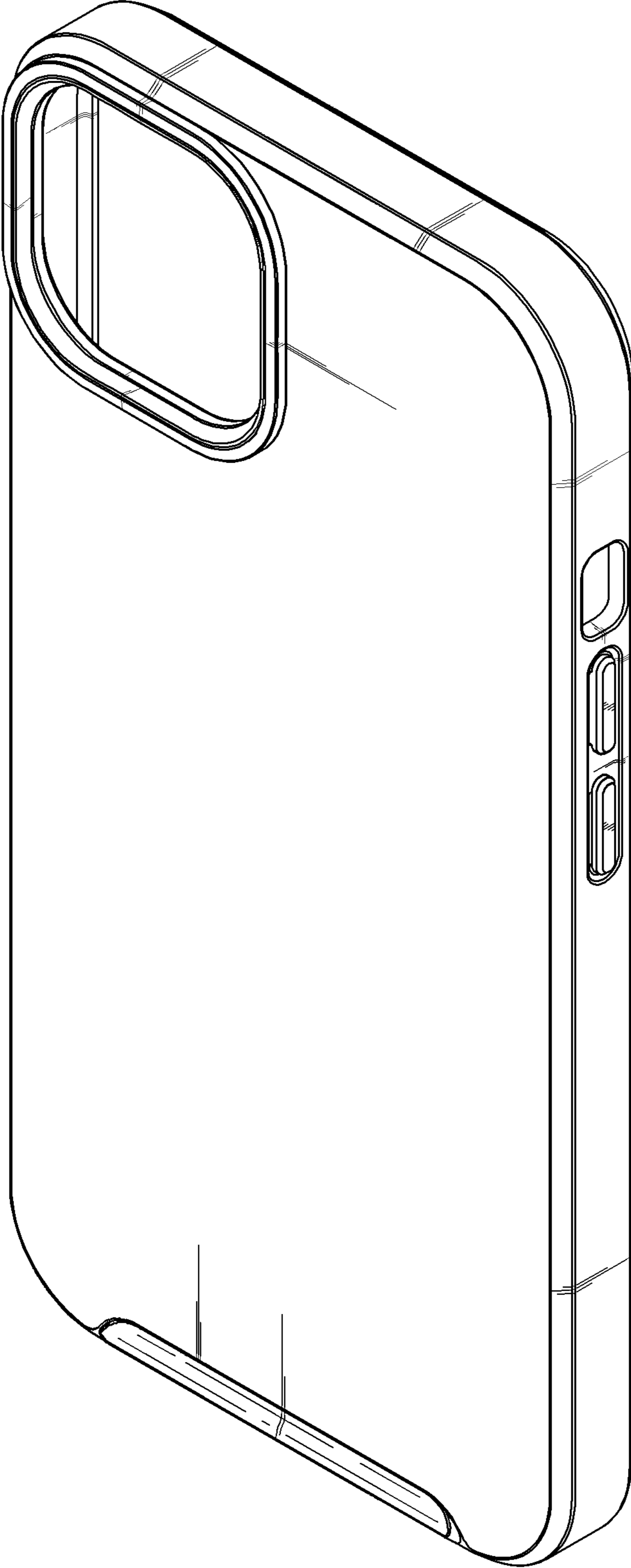

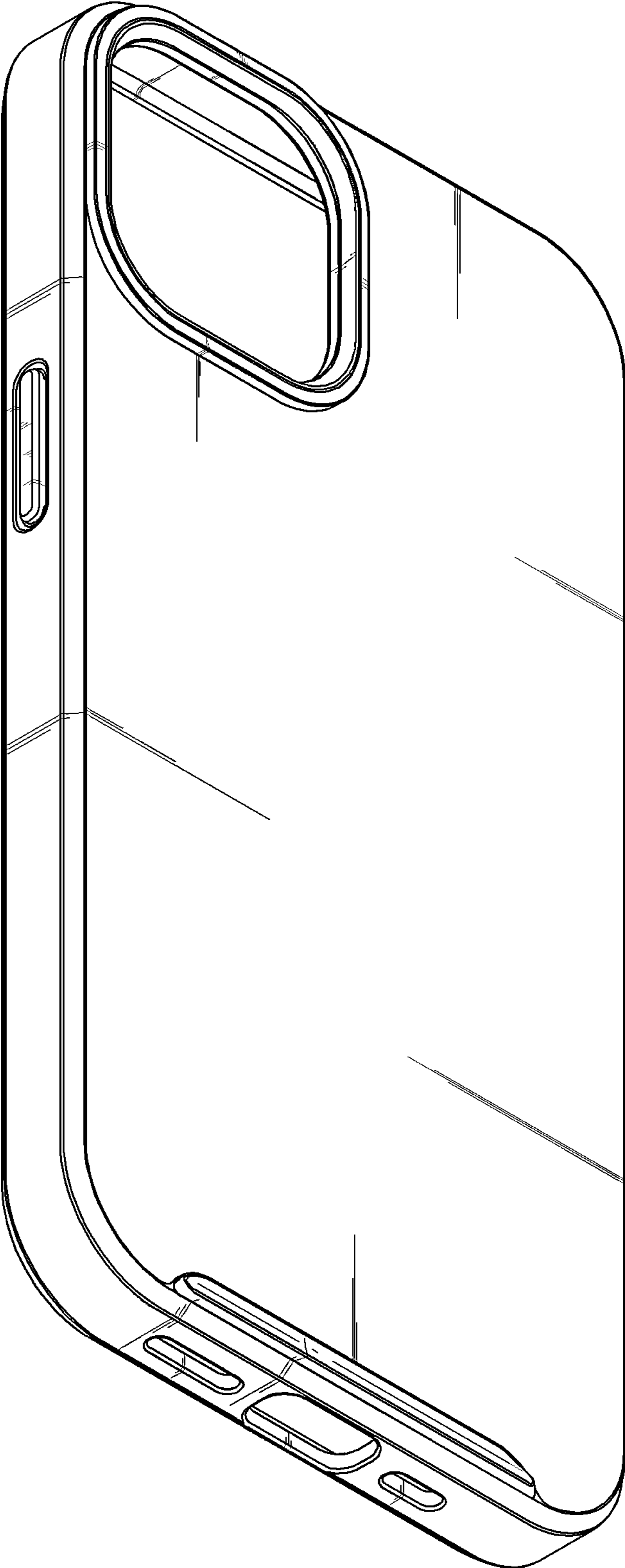

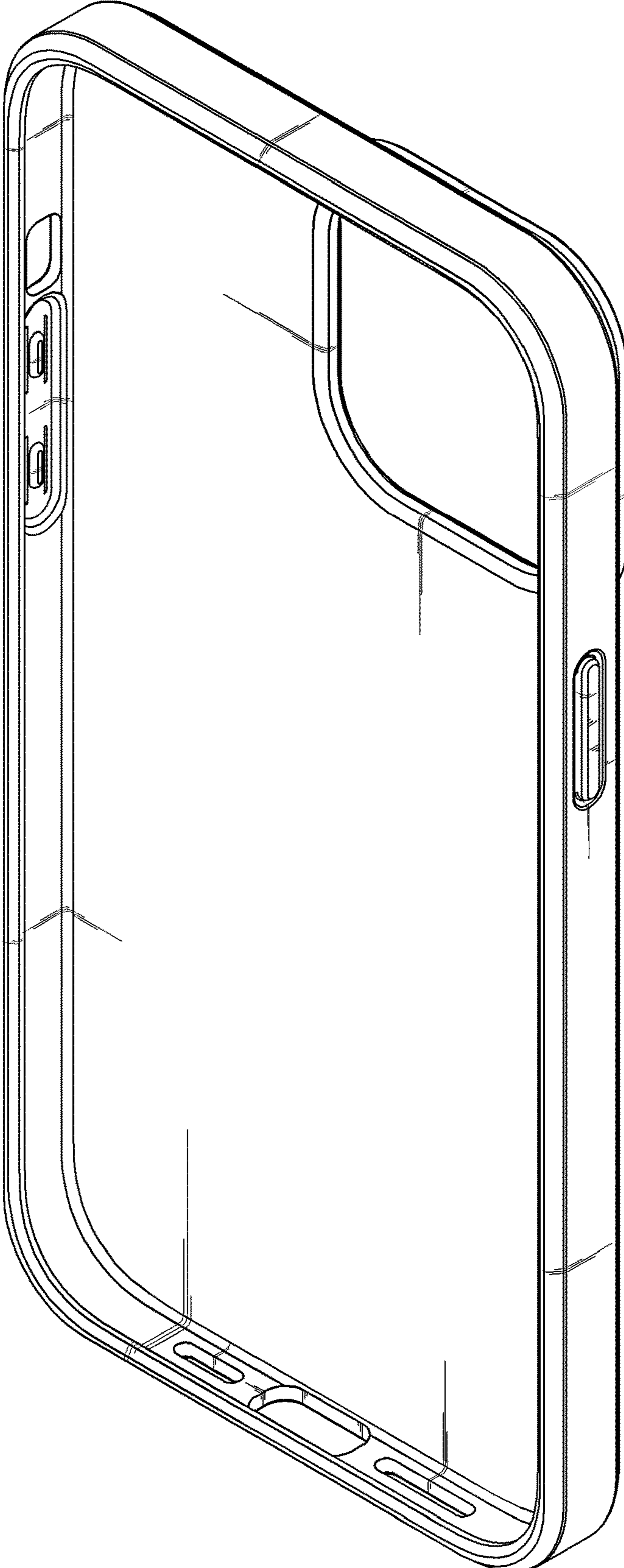

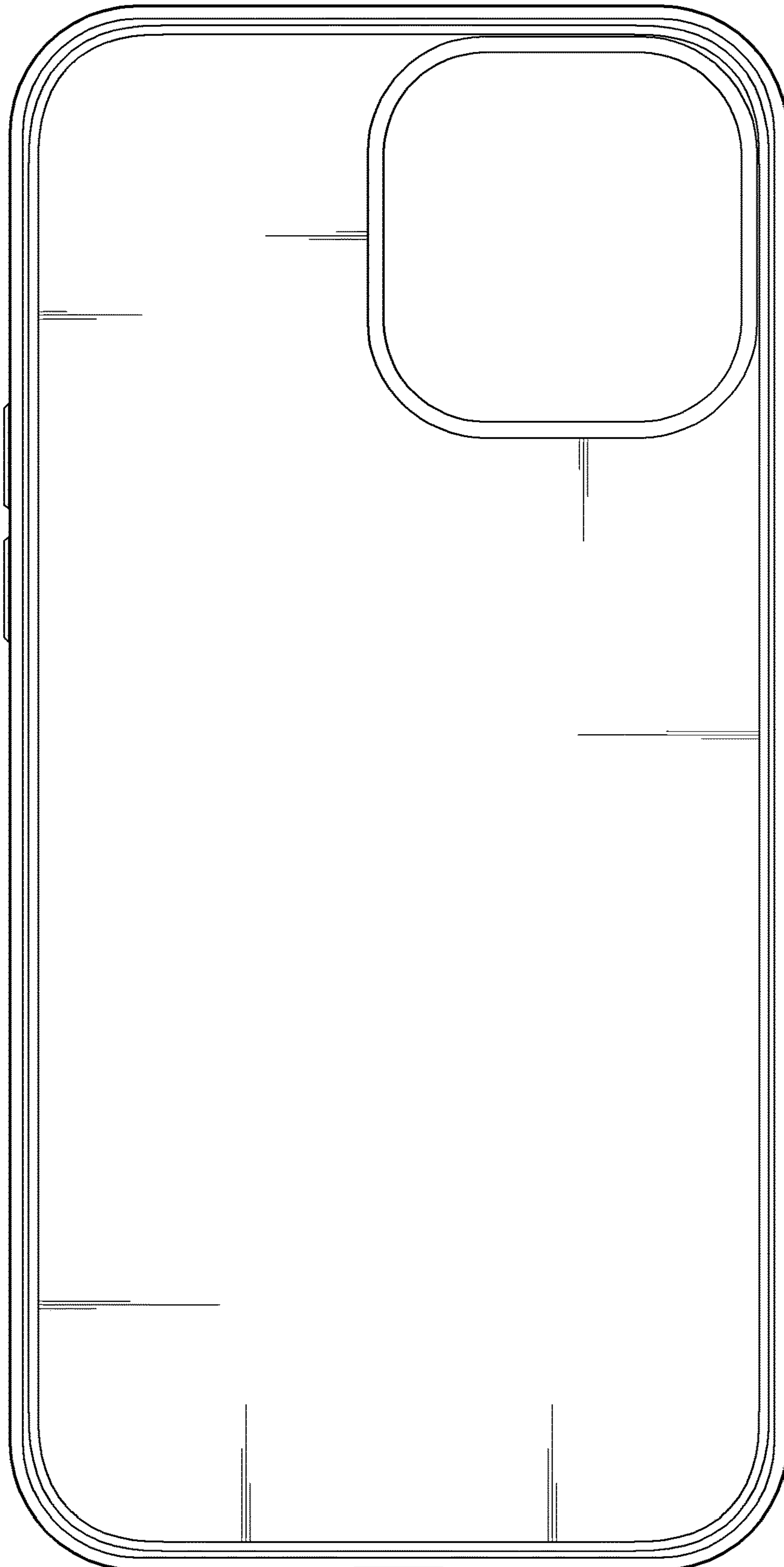

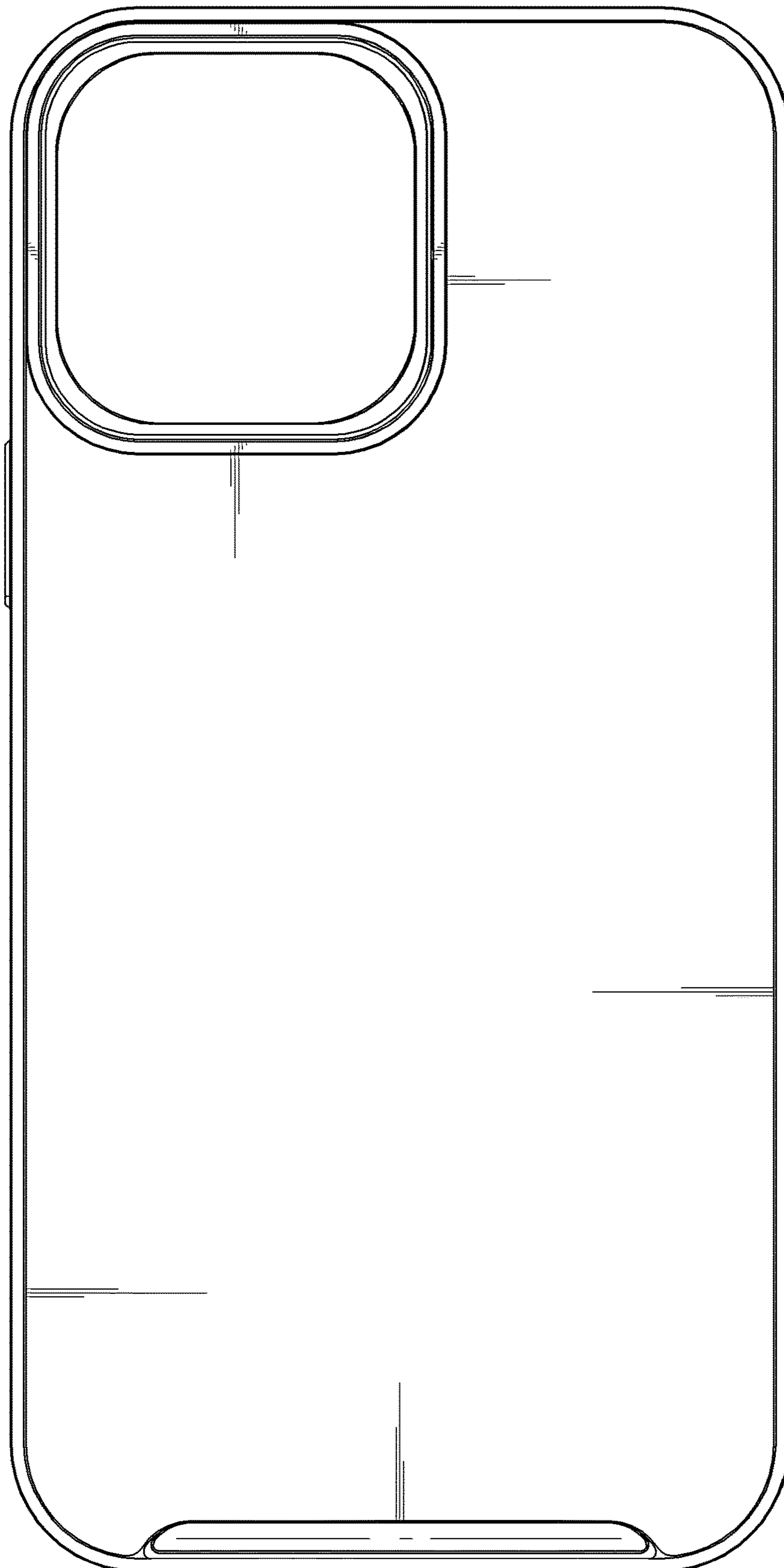

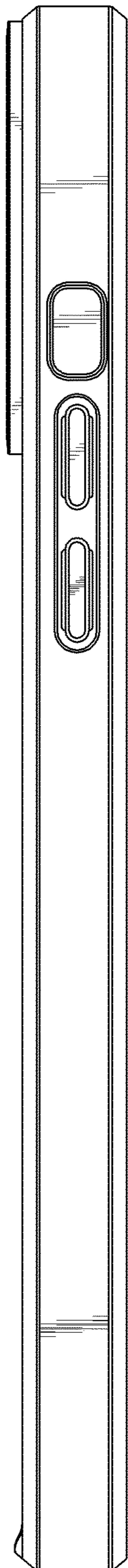

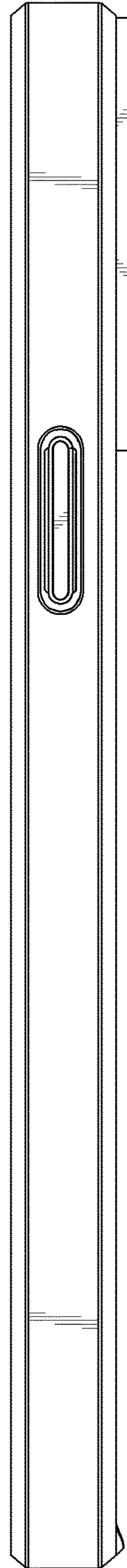

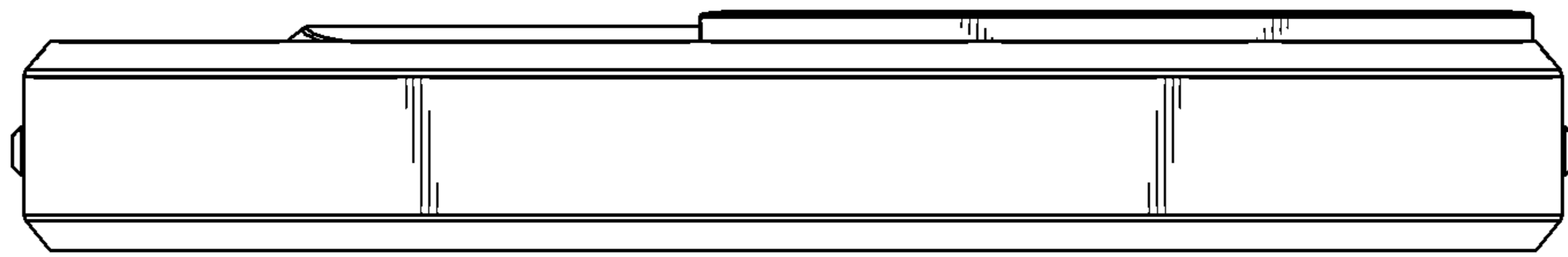

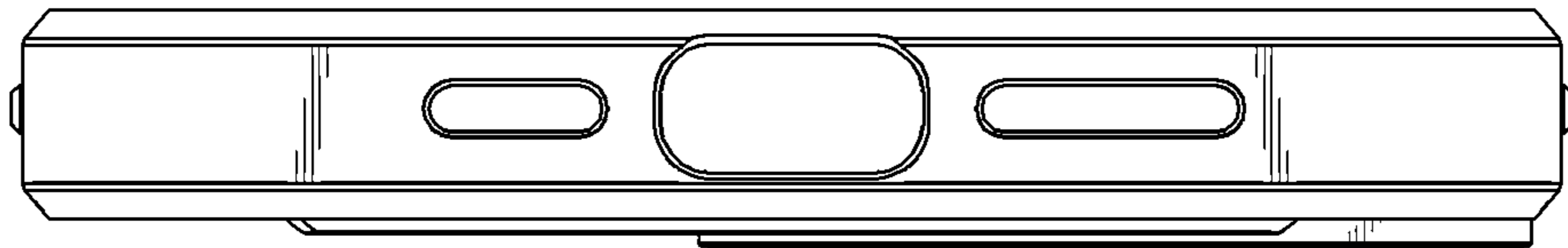

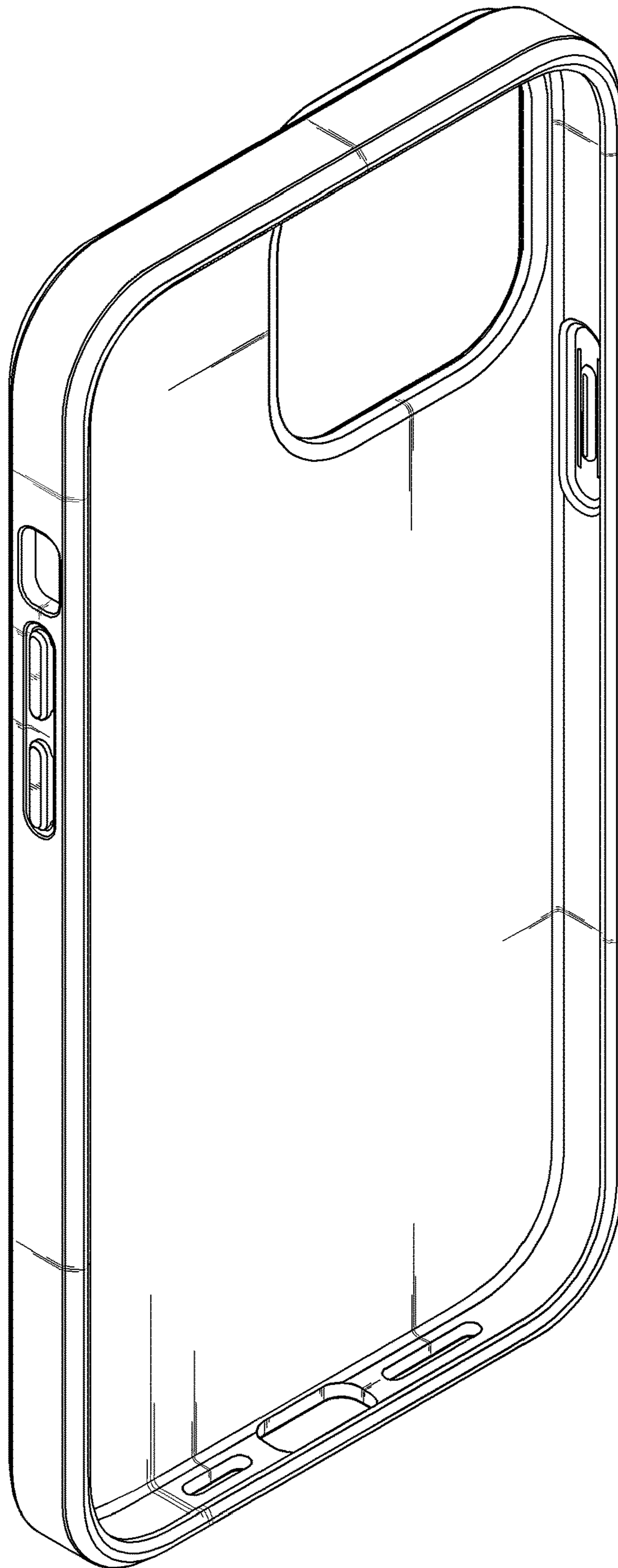

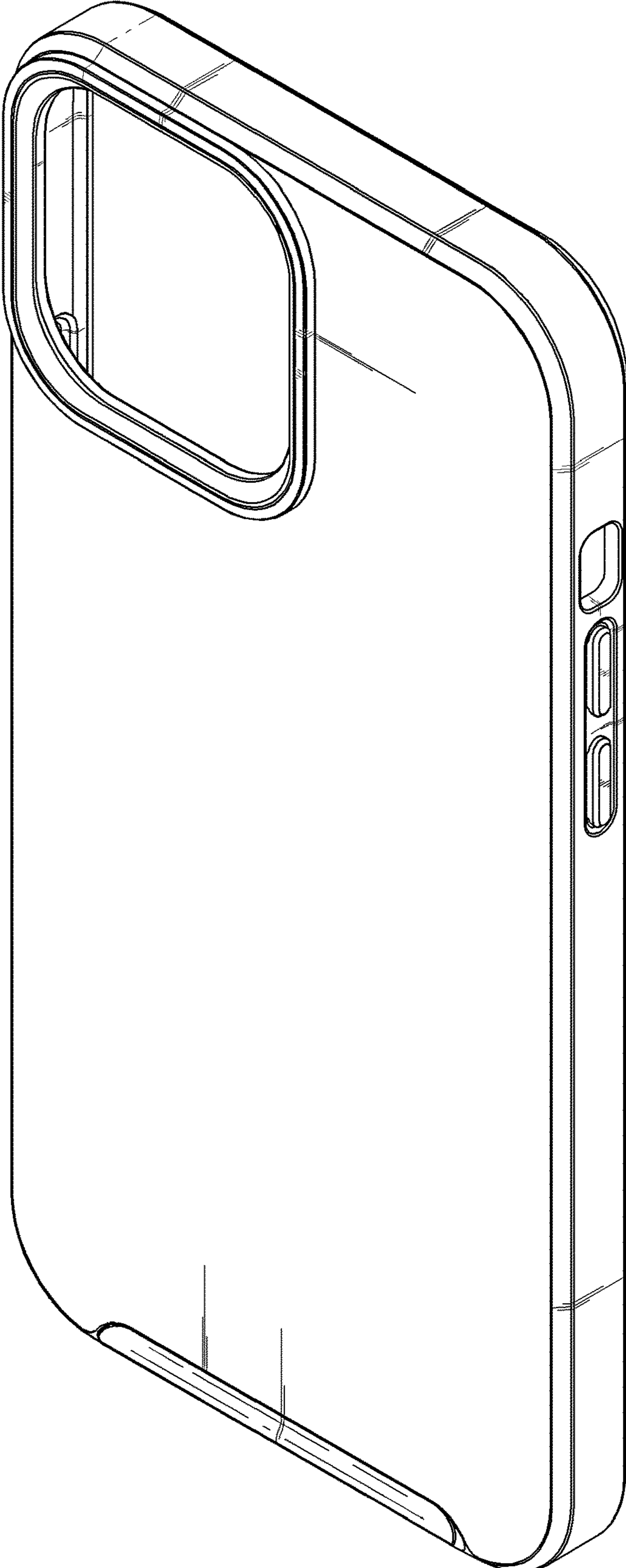

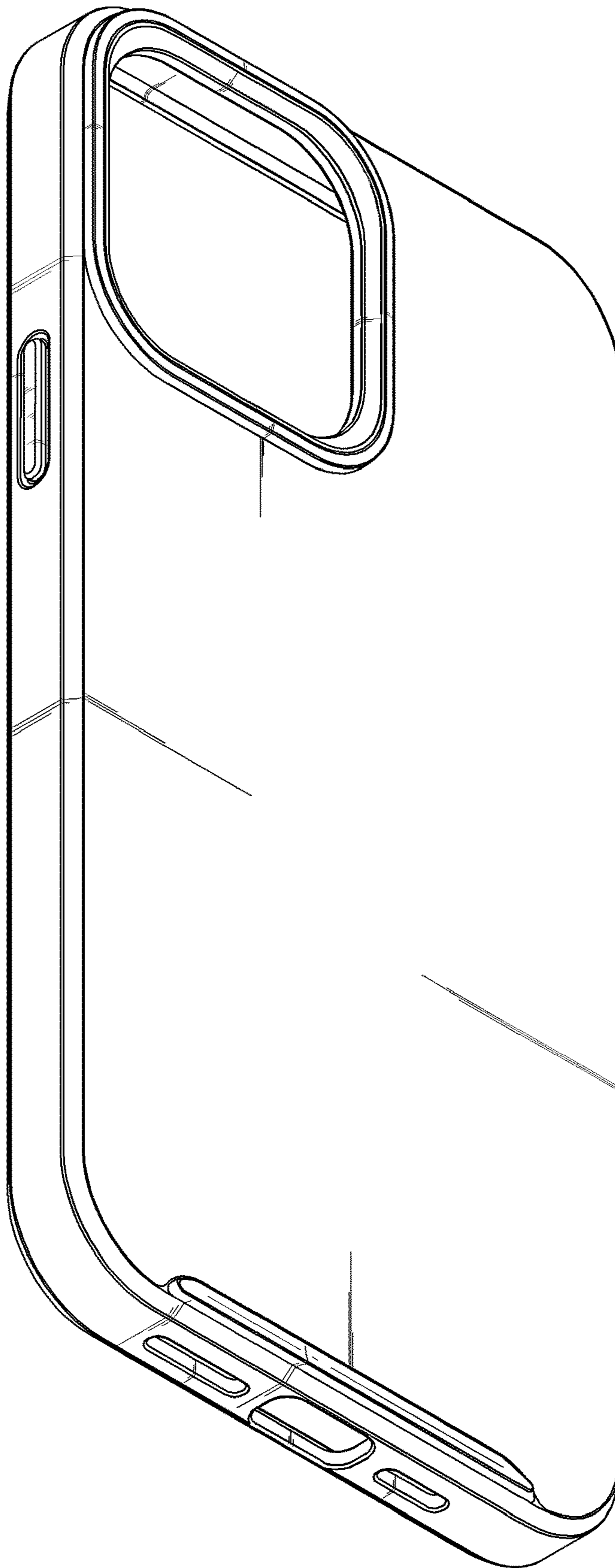

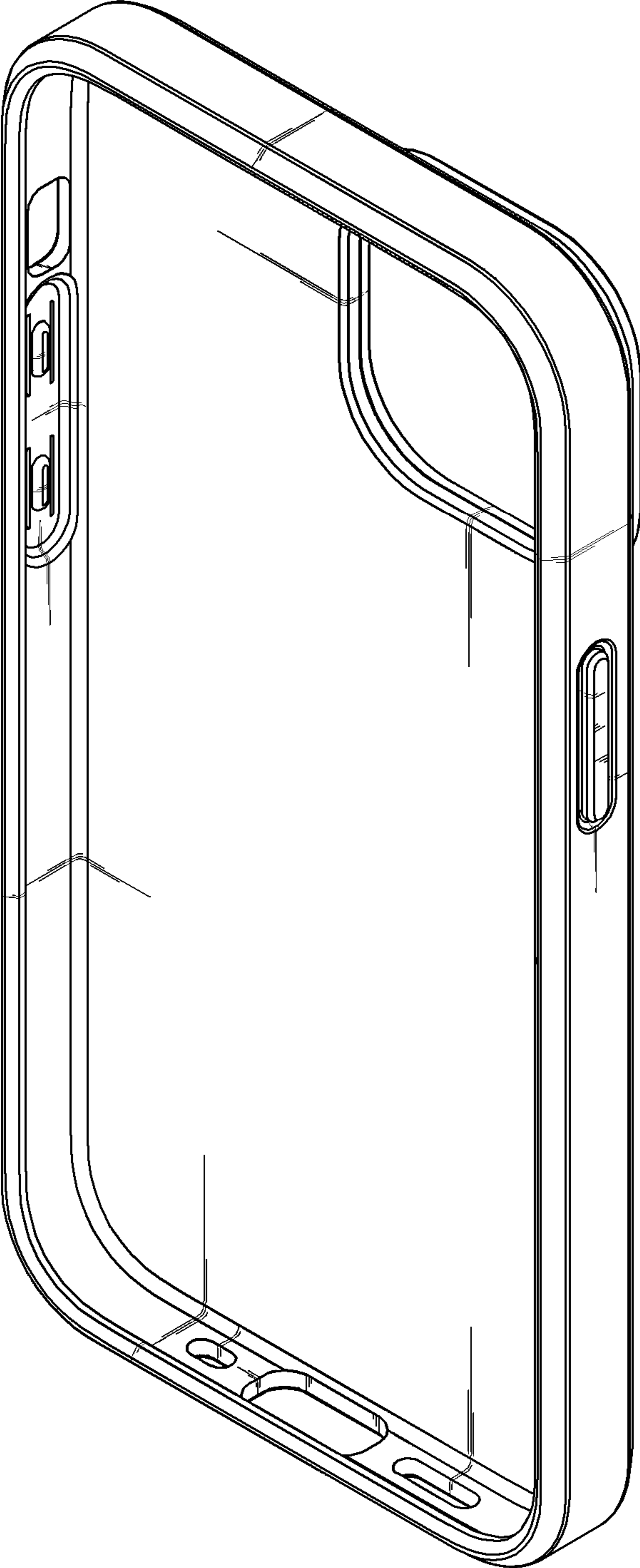

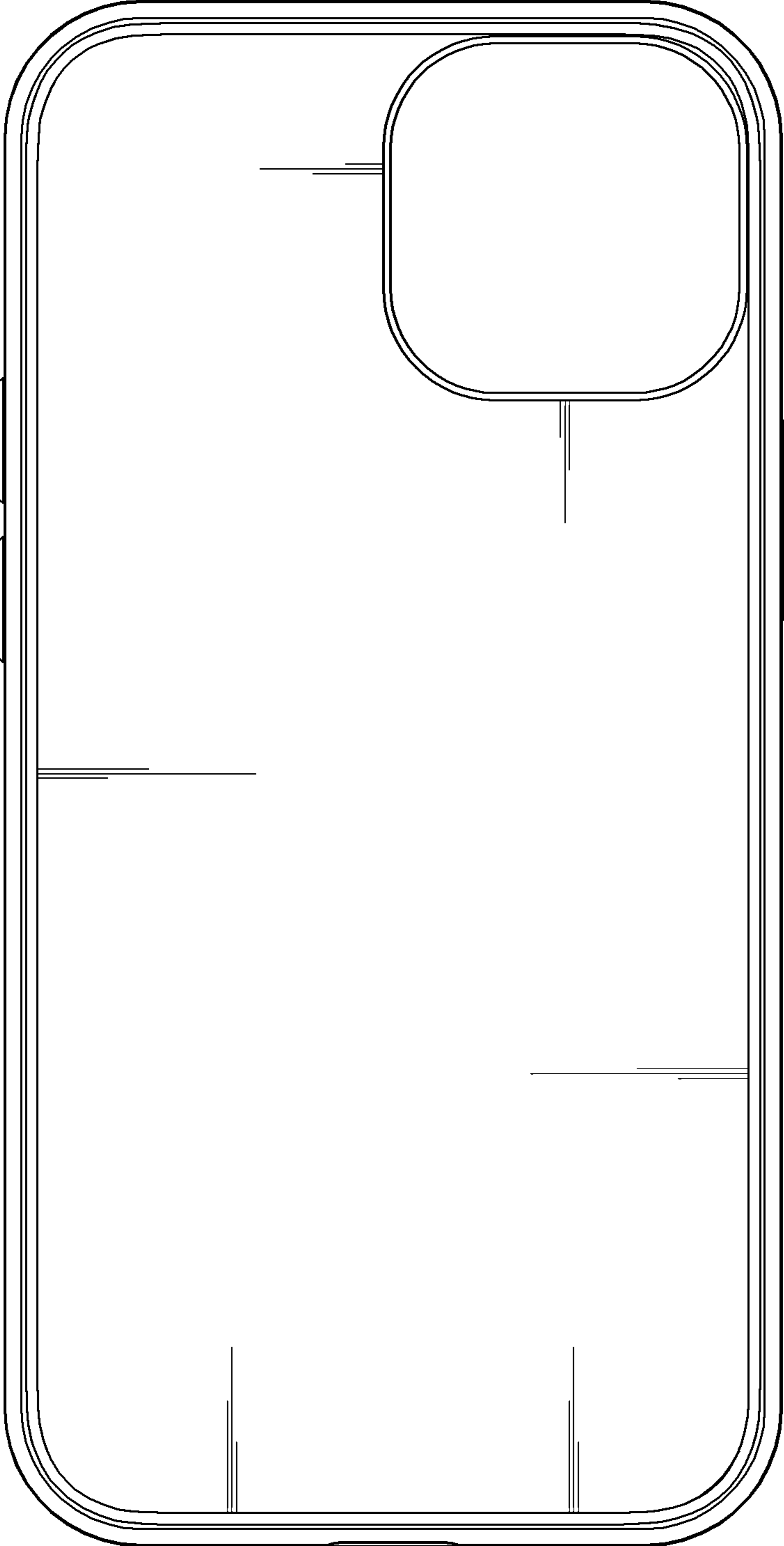

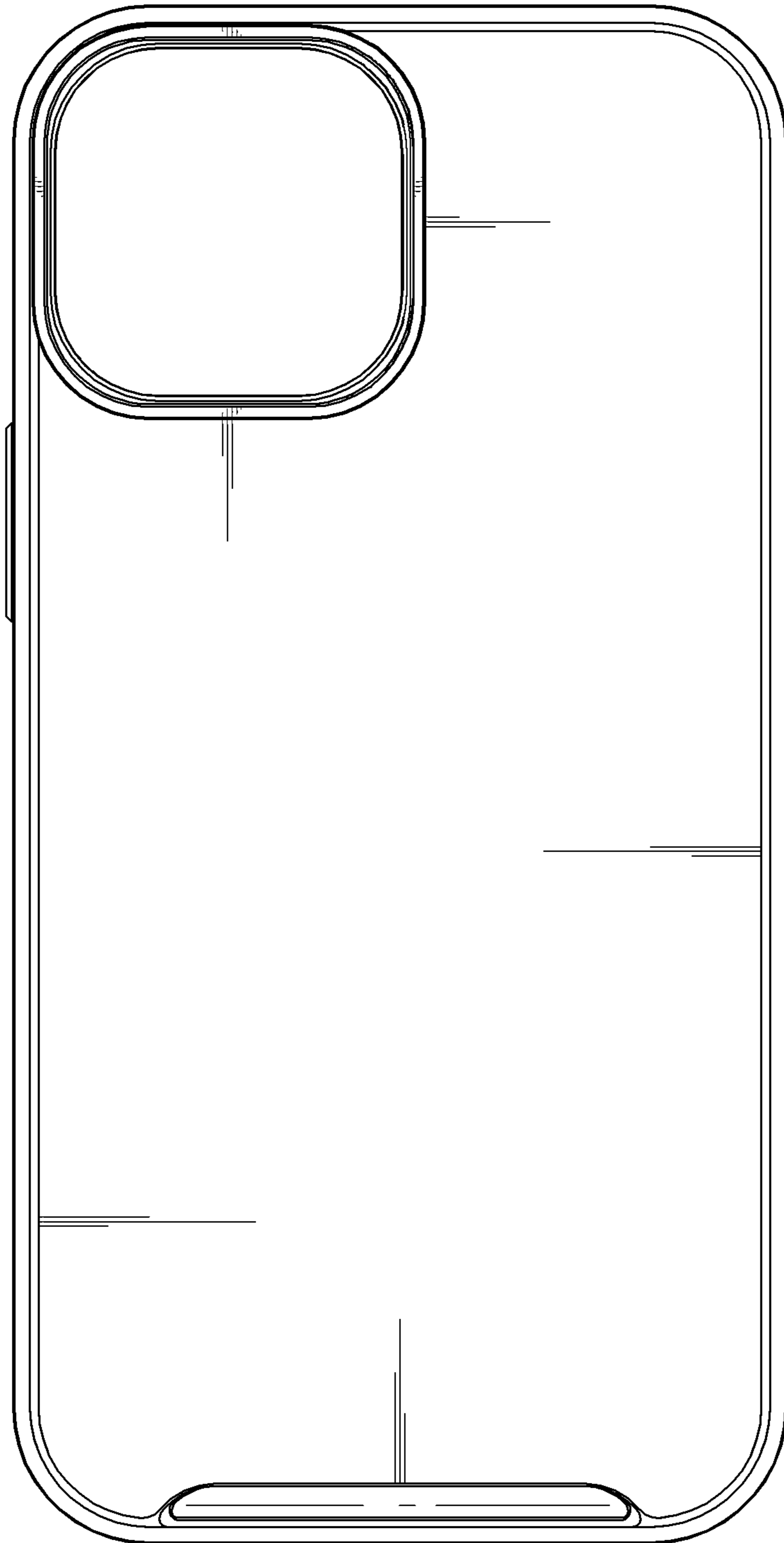

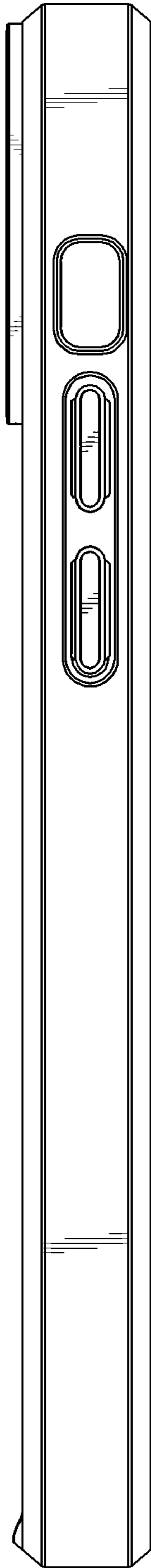

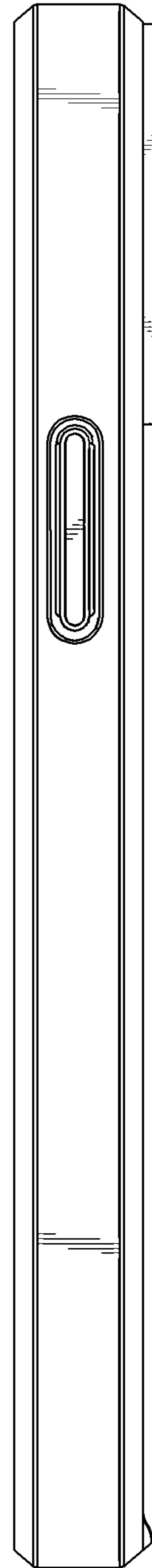

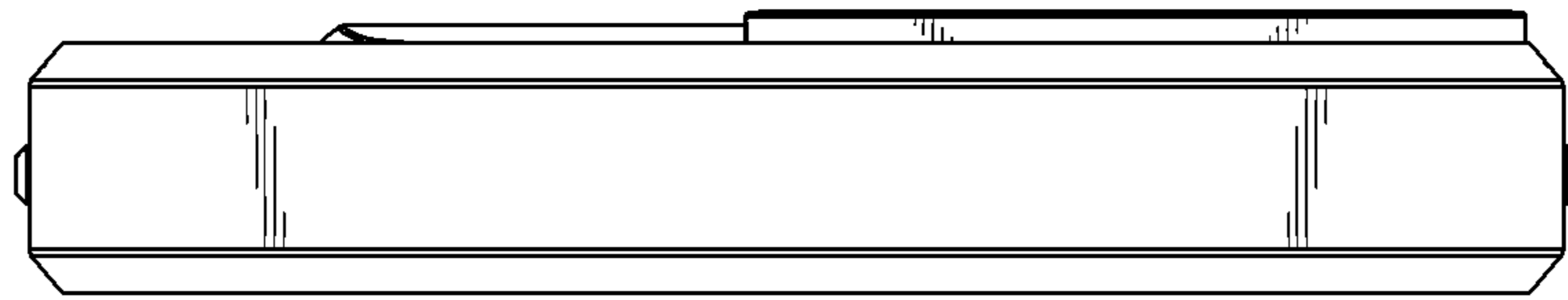

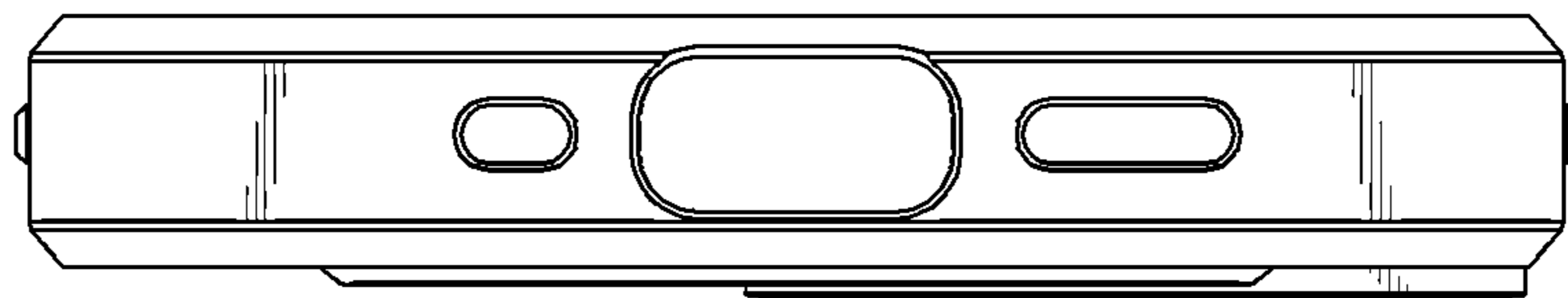

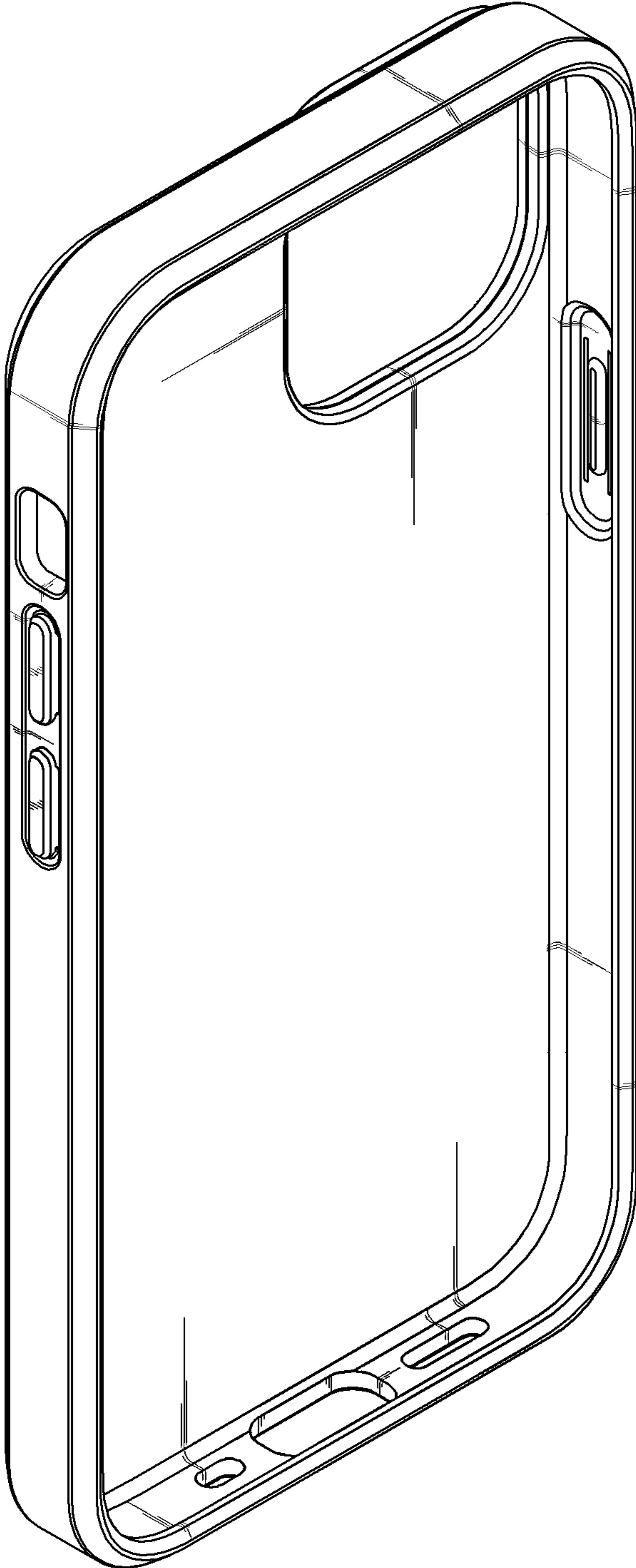

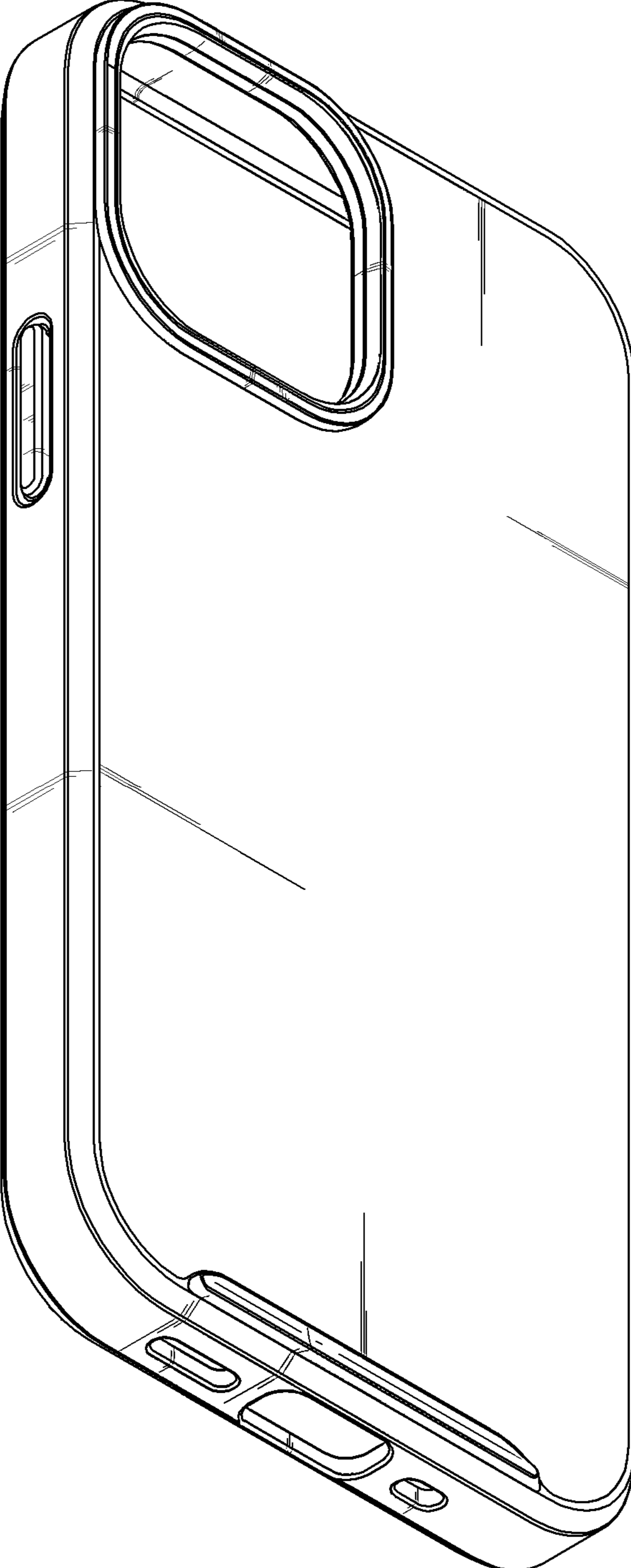

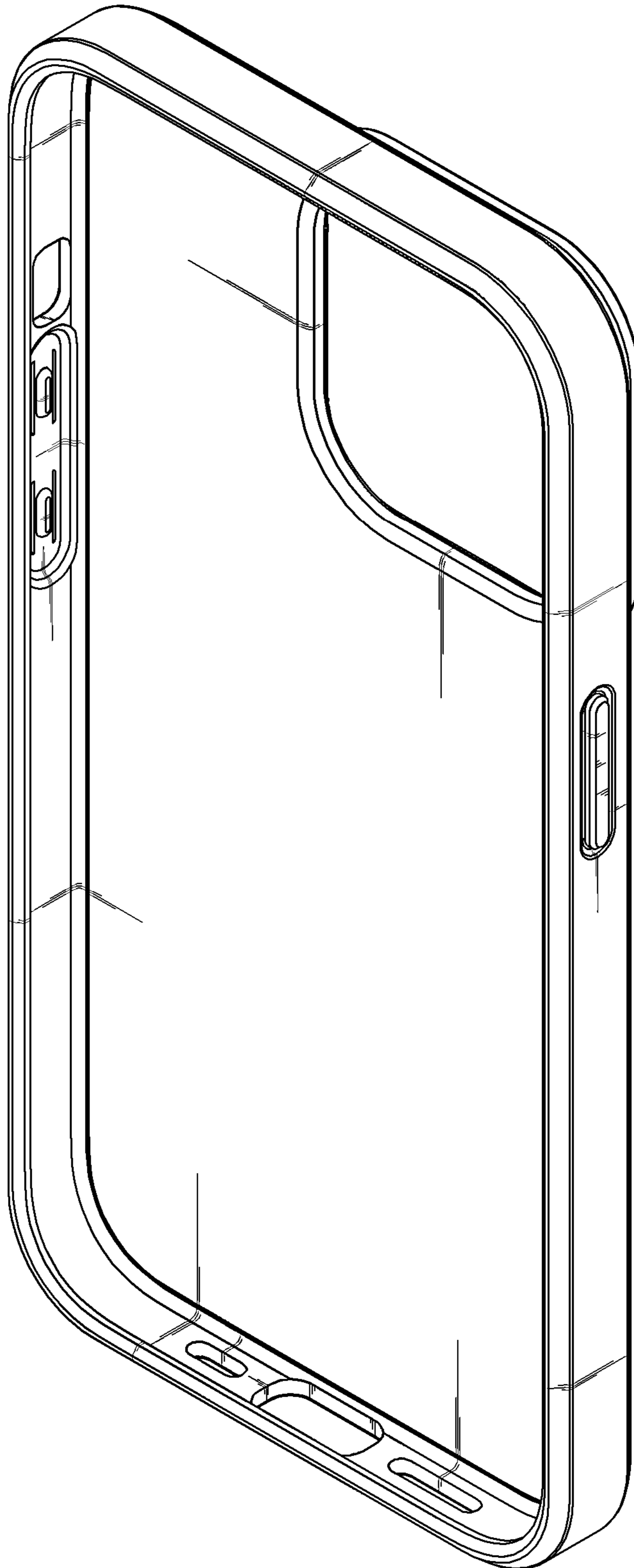

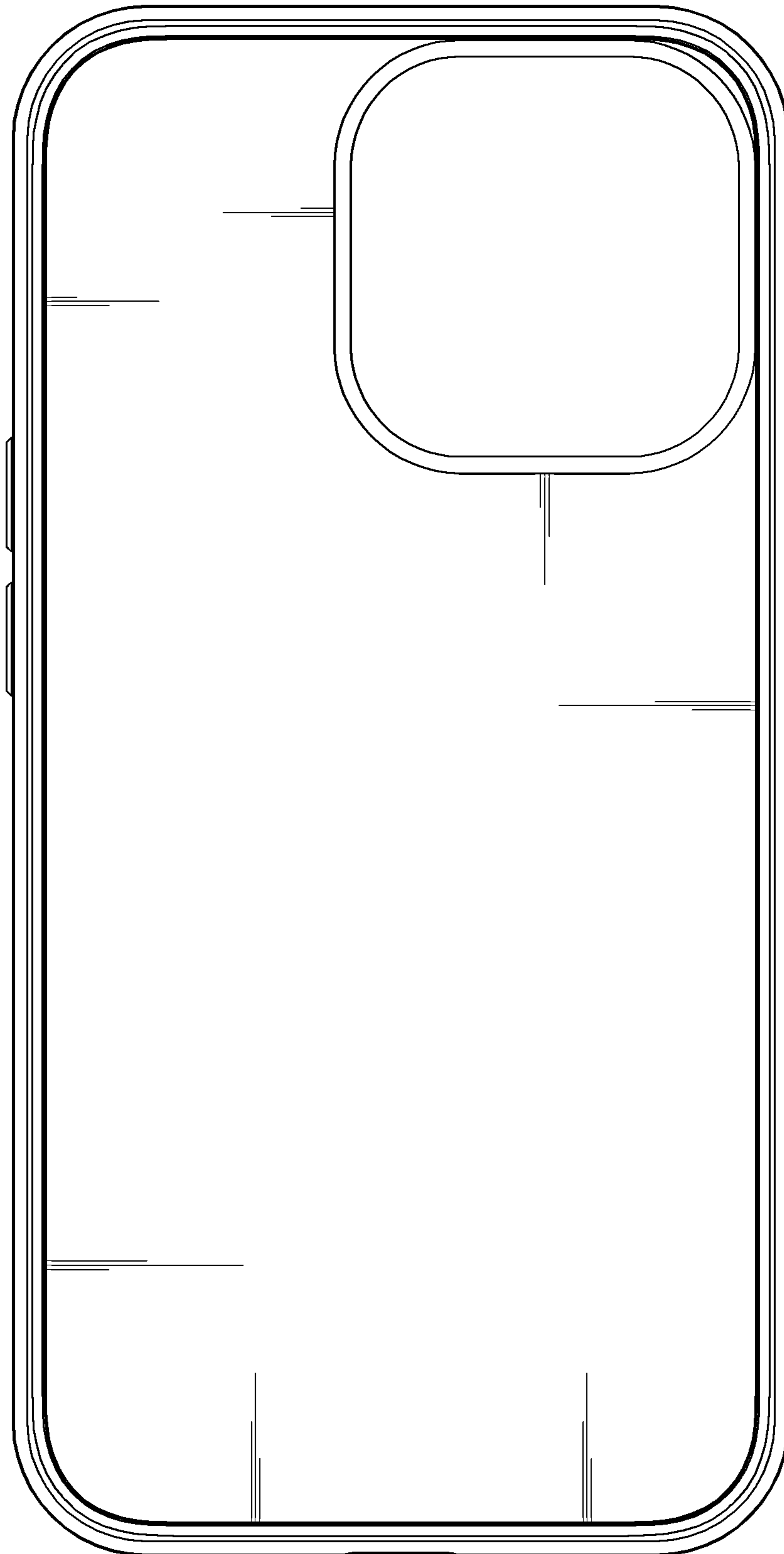

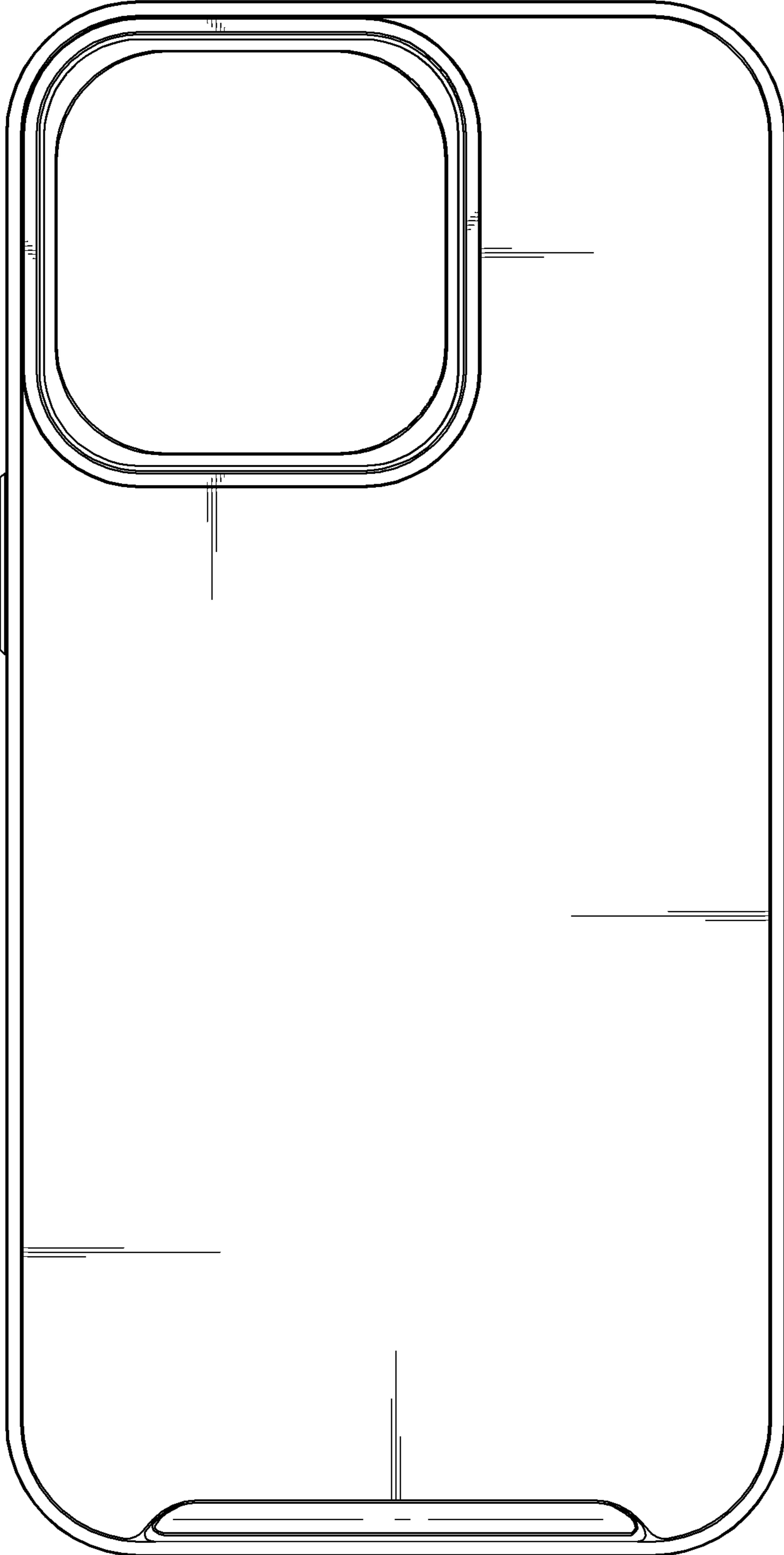

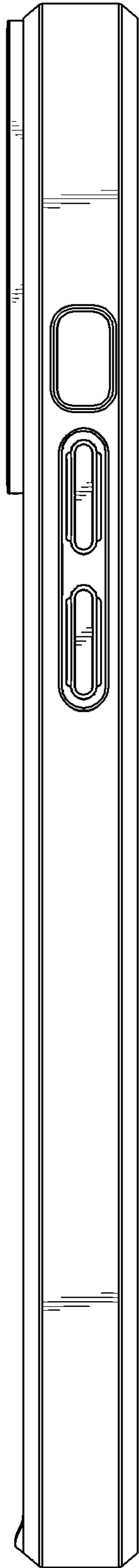

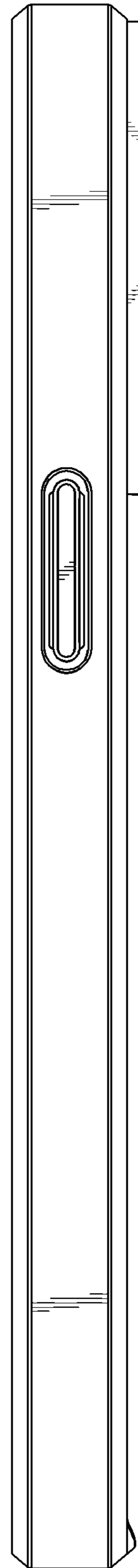

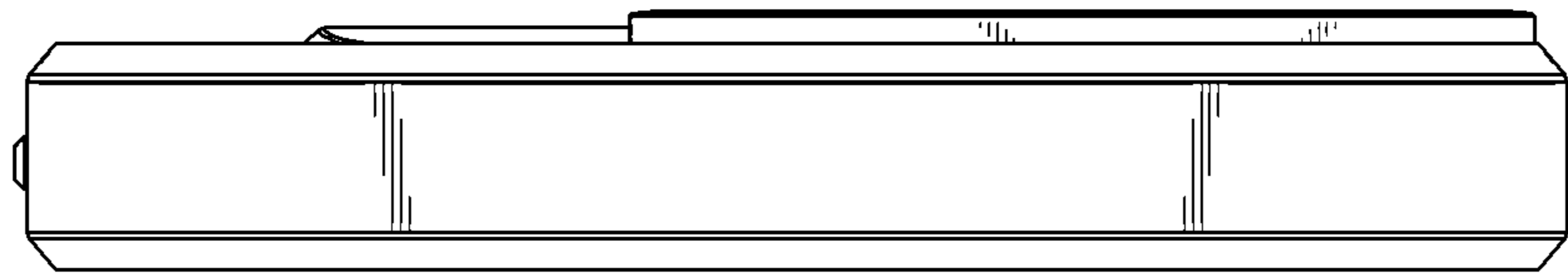

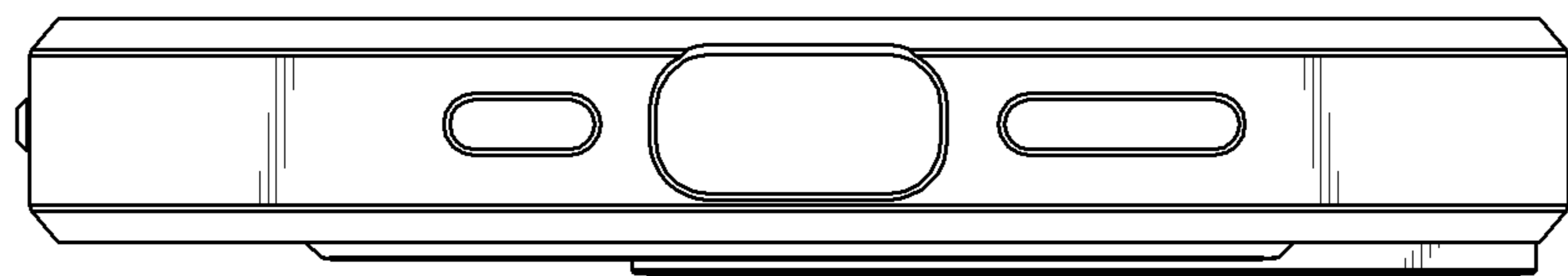

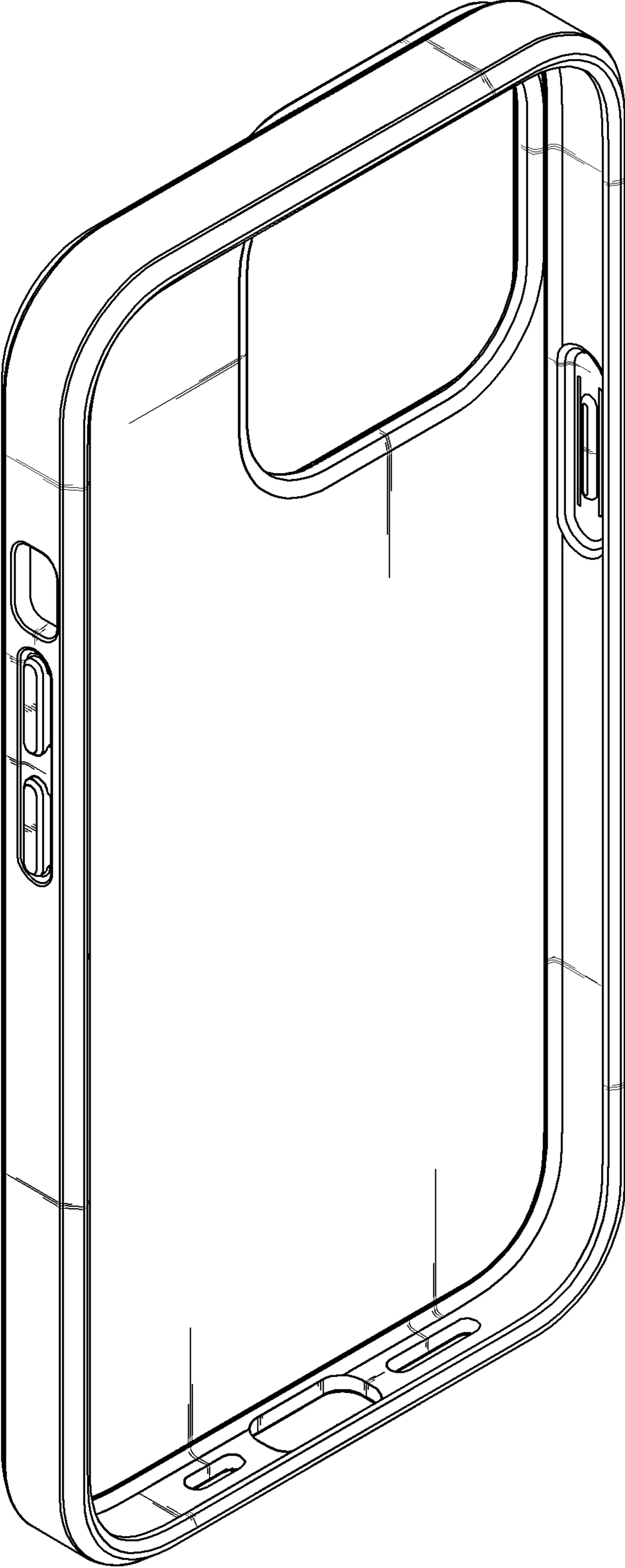

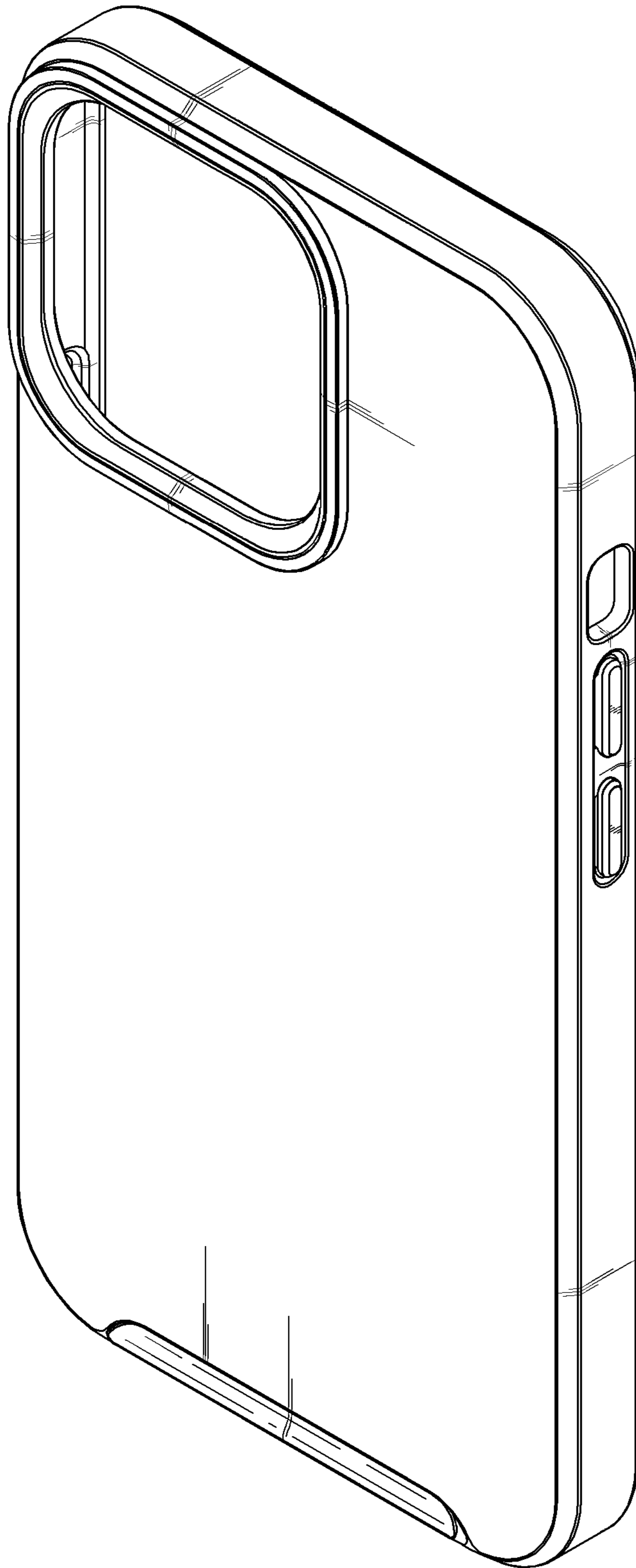
