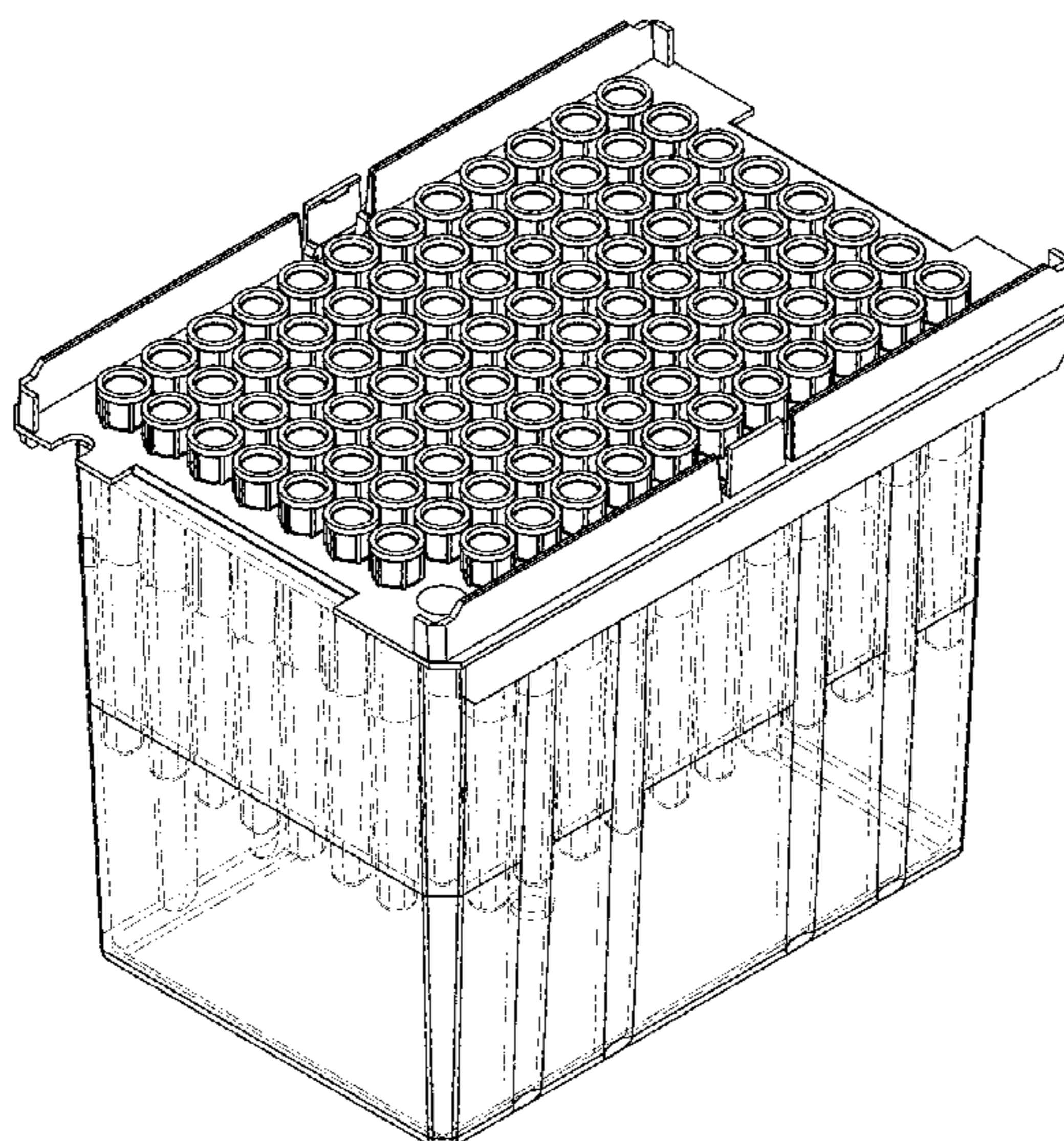

DESCRIPTION

FIG. 1 is a top perspective view of a pipette tip tray; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a first side view thereof; FIG. 4 is a second side view thereof; FIG. 5 is a third side view thereof; FIG. 6 is a fourth side view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof. 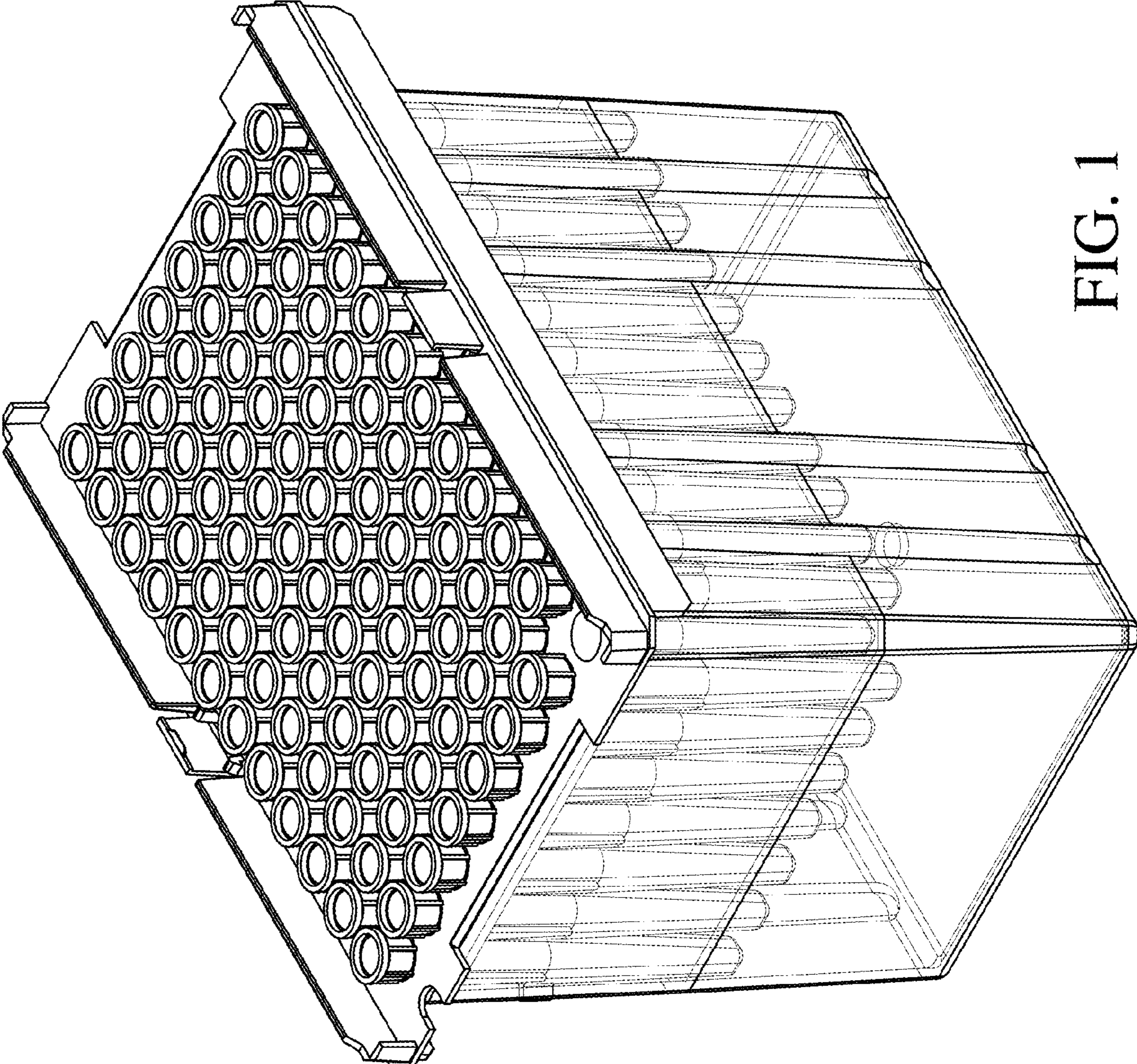

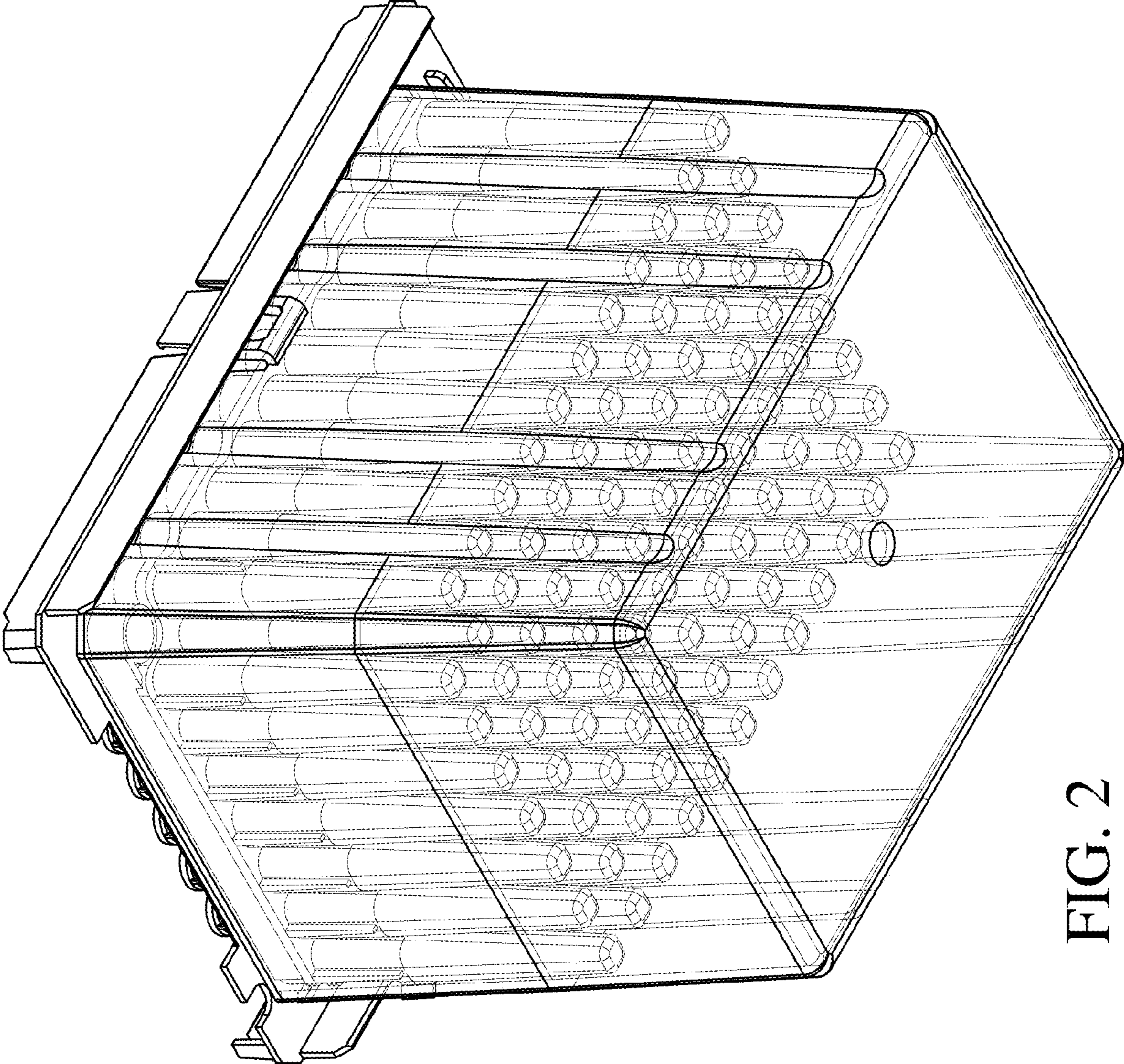

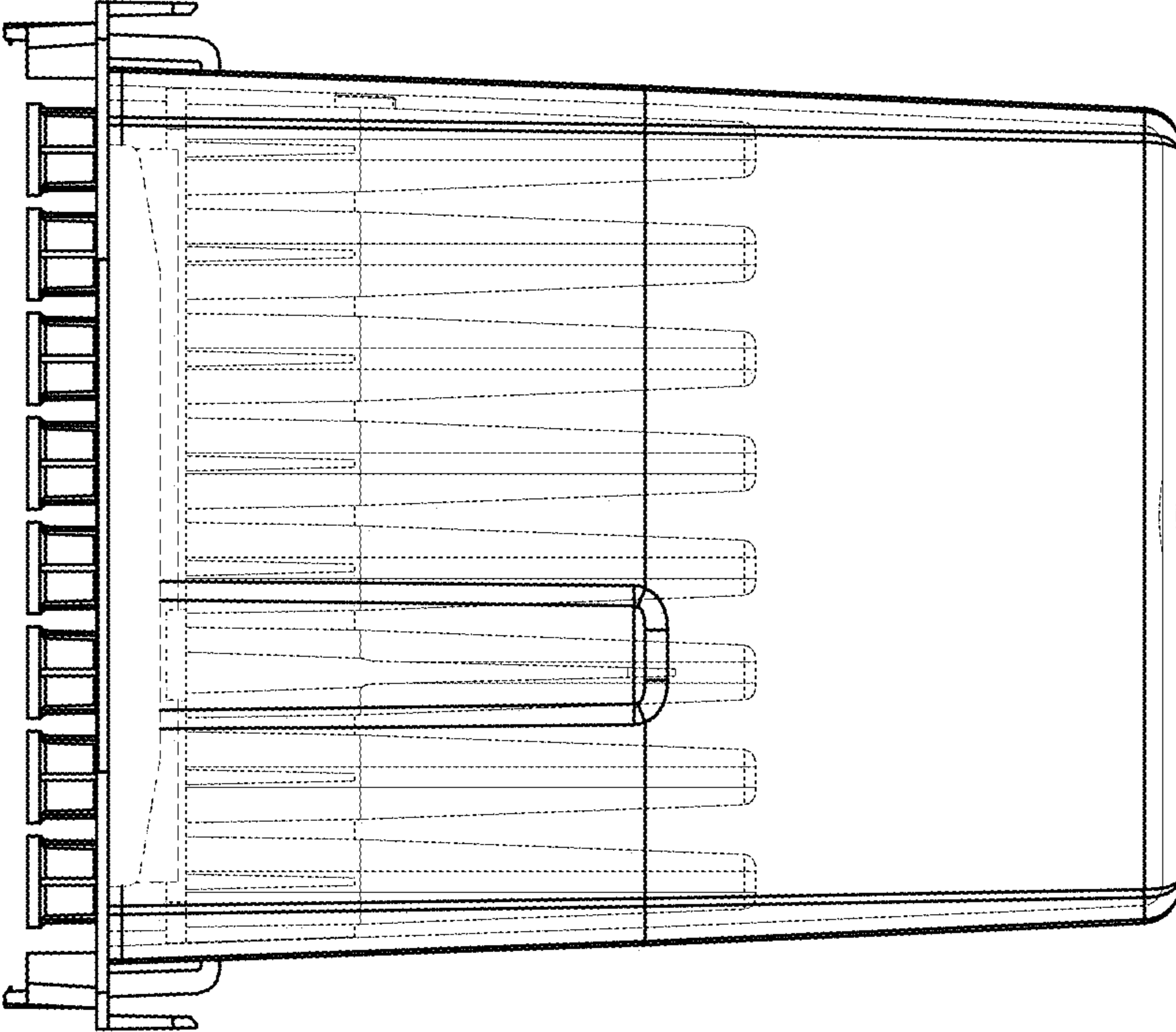

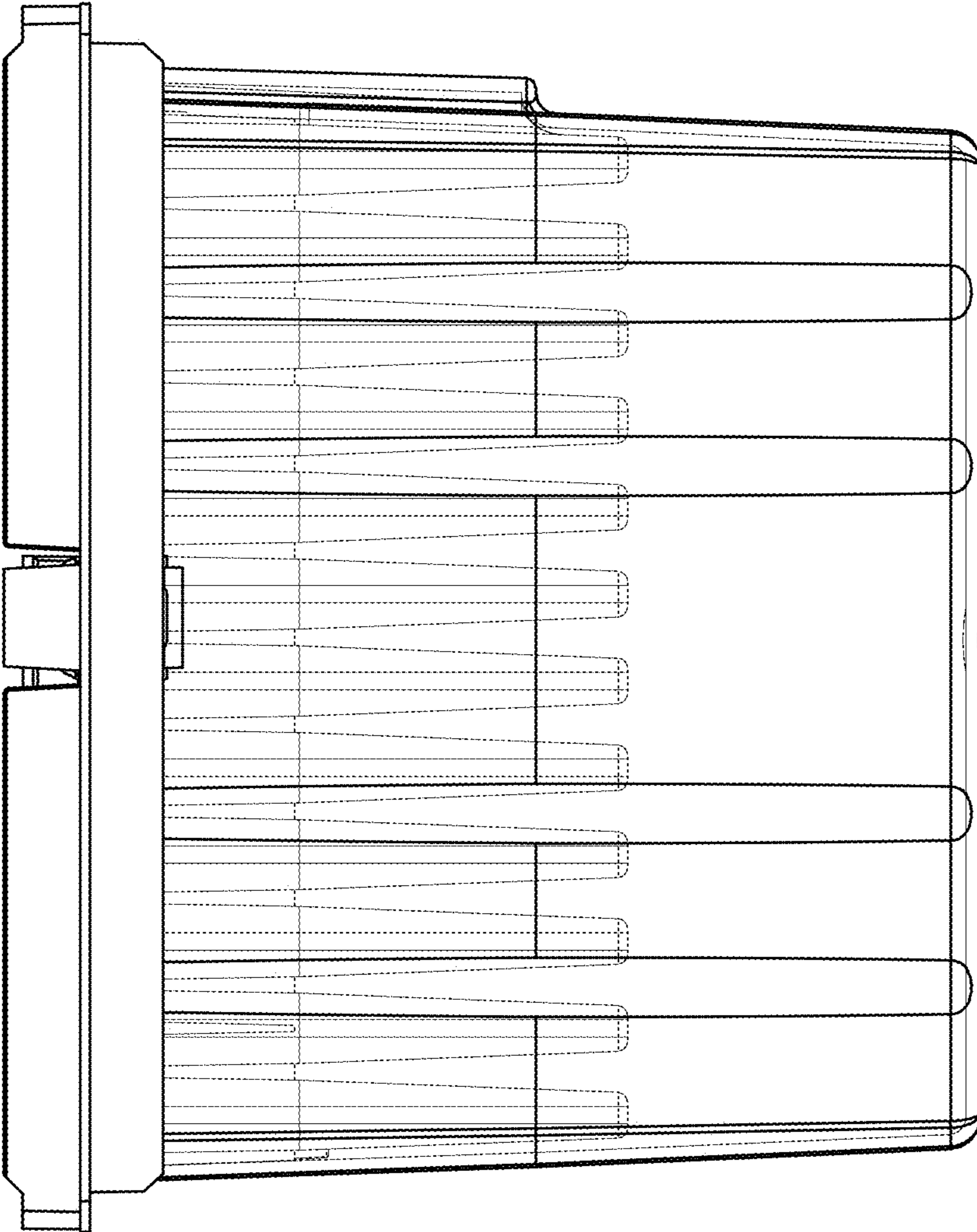

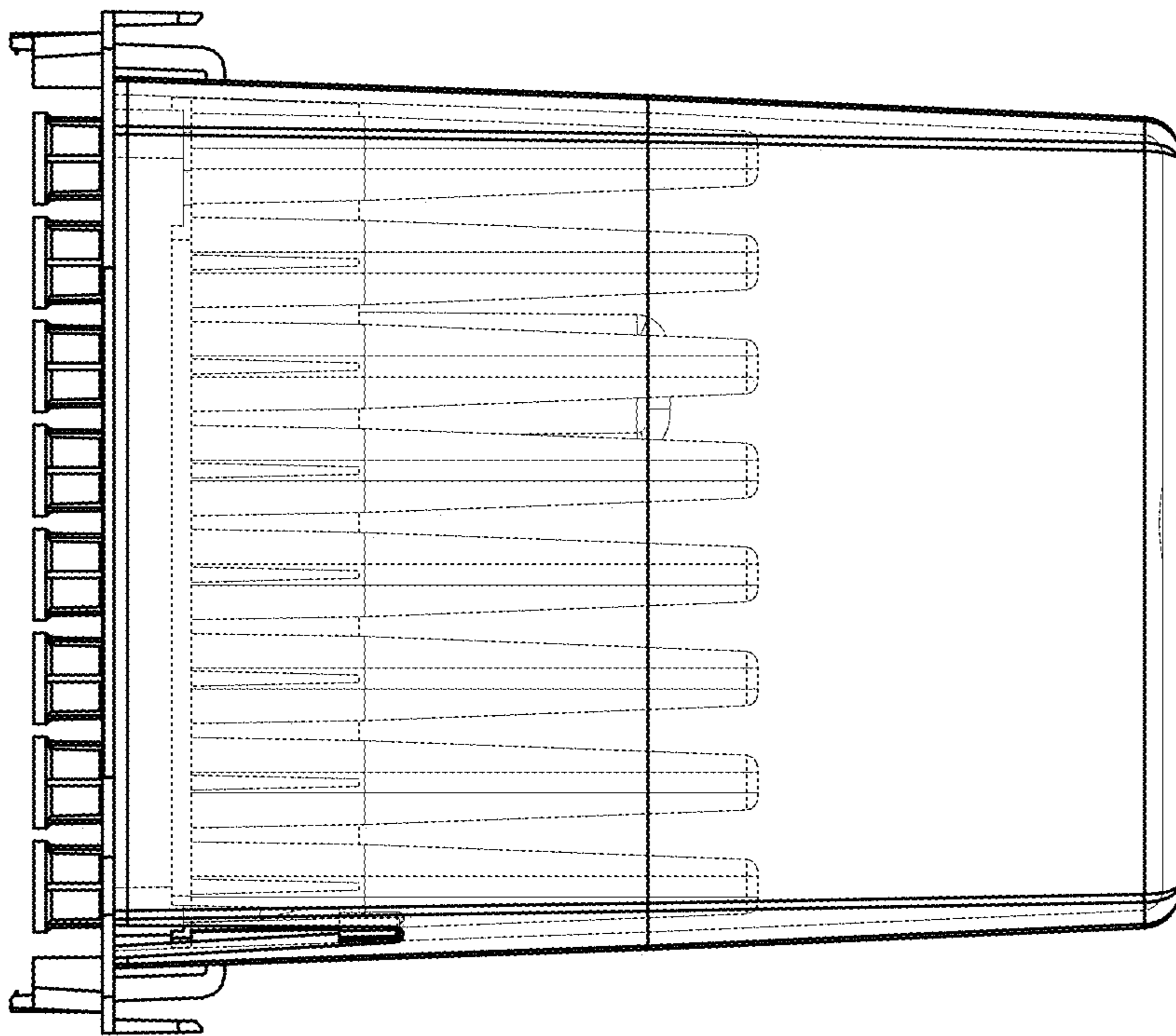

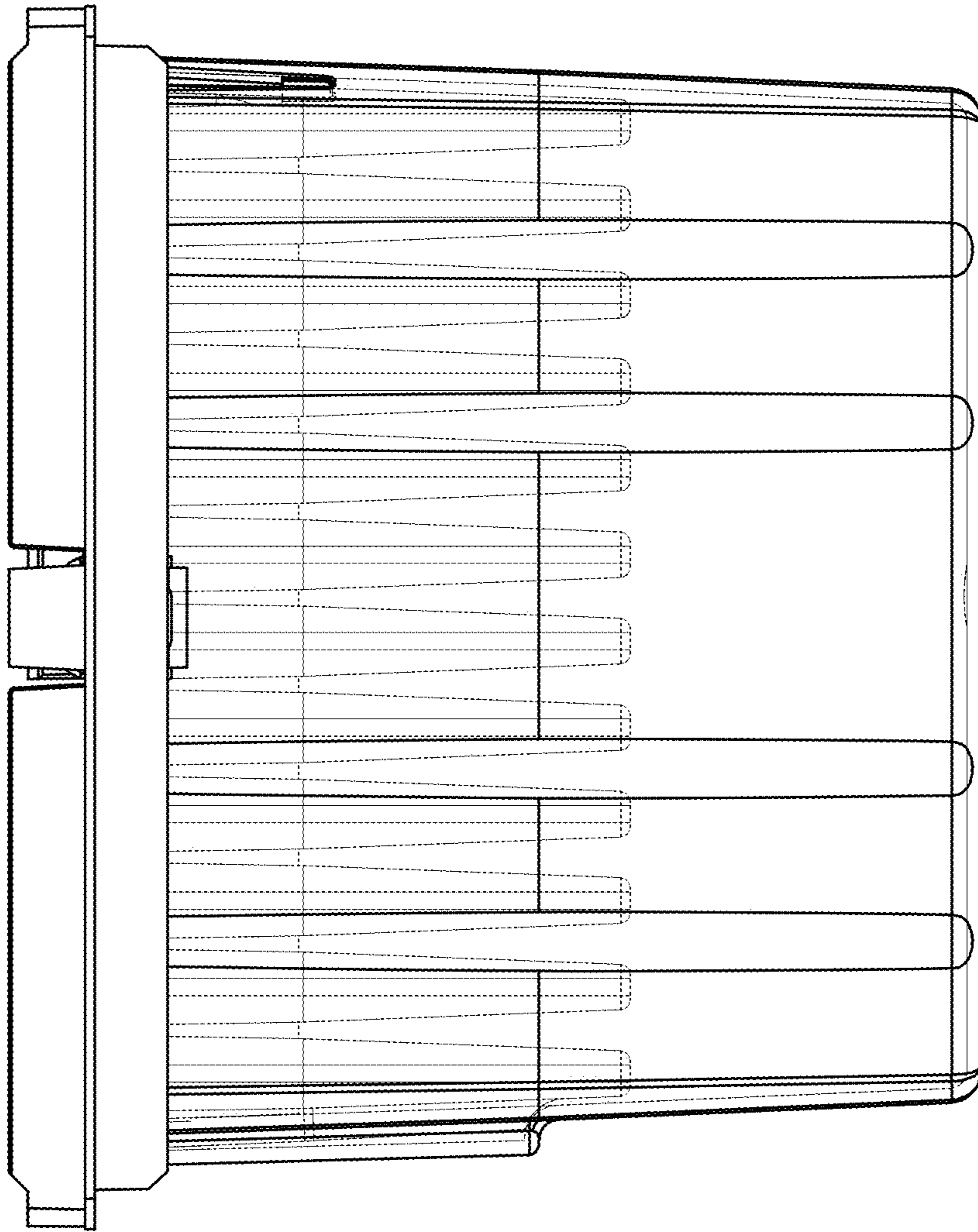

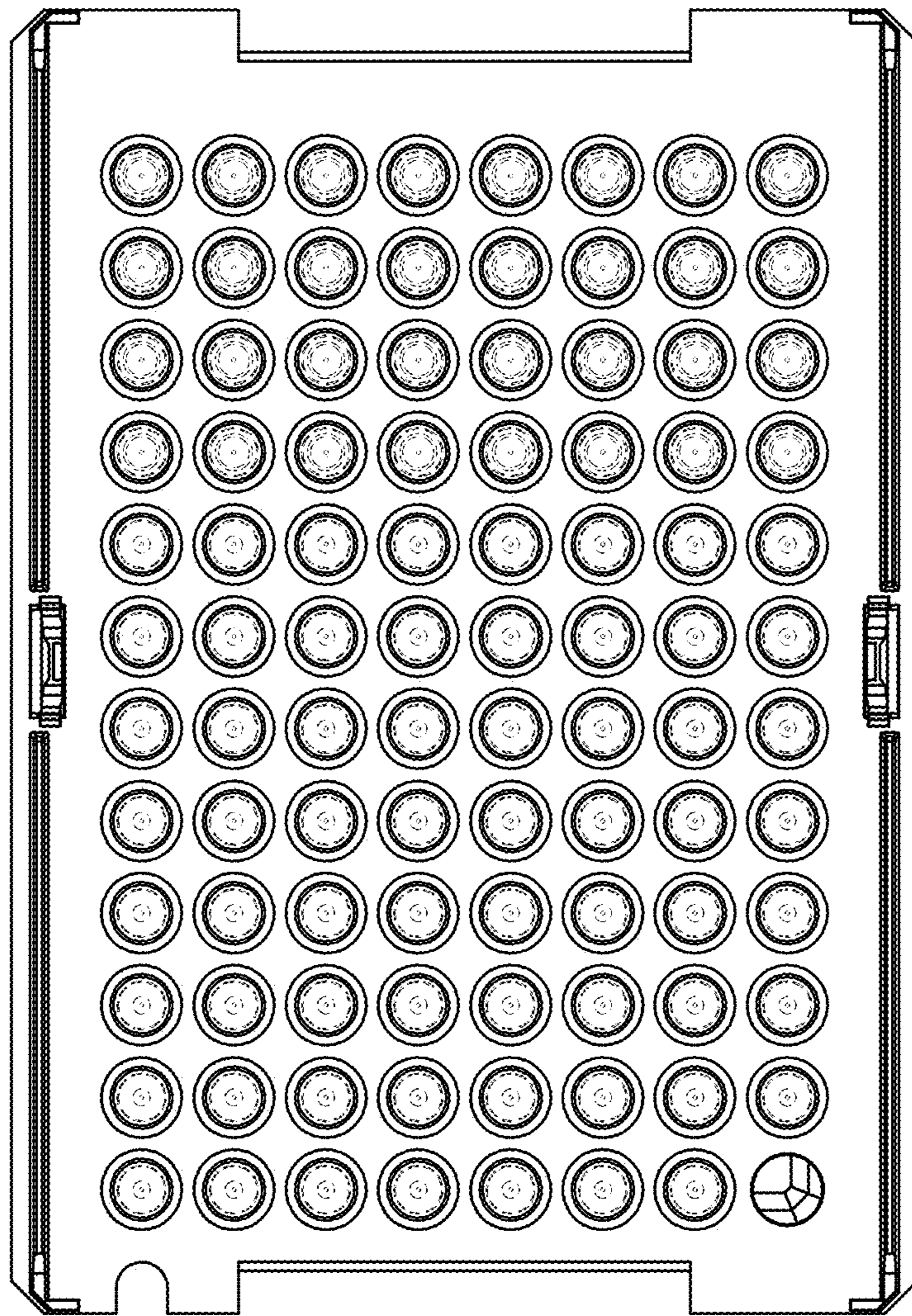

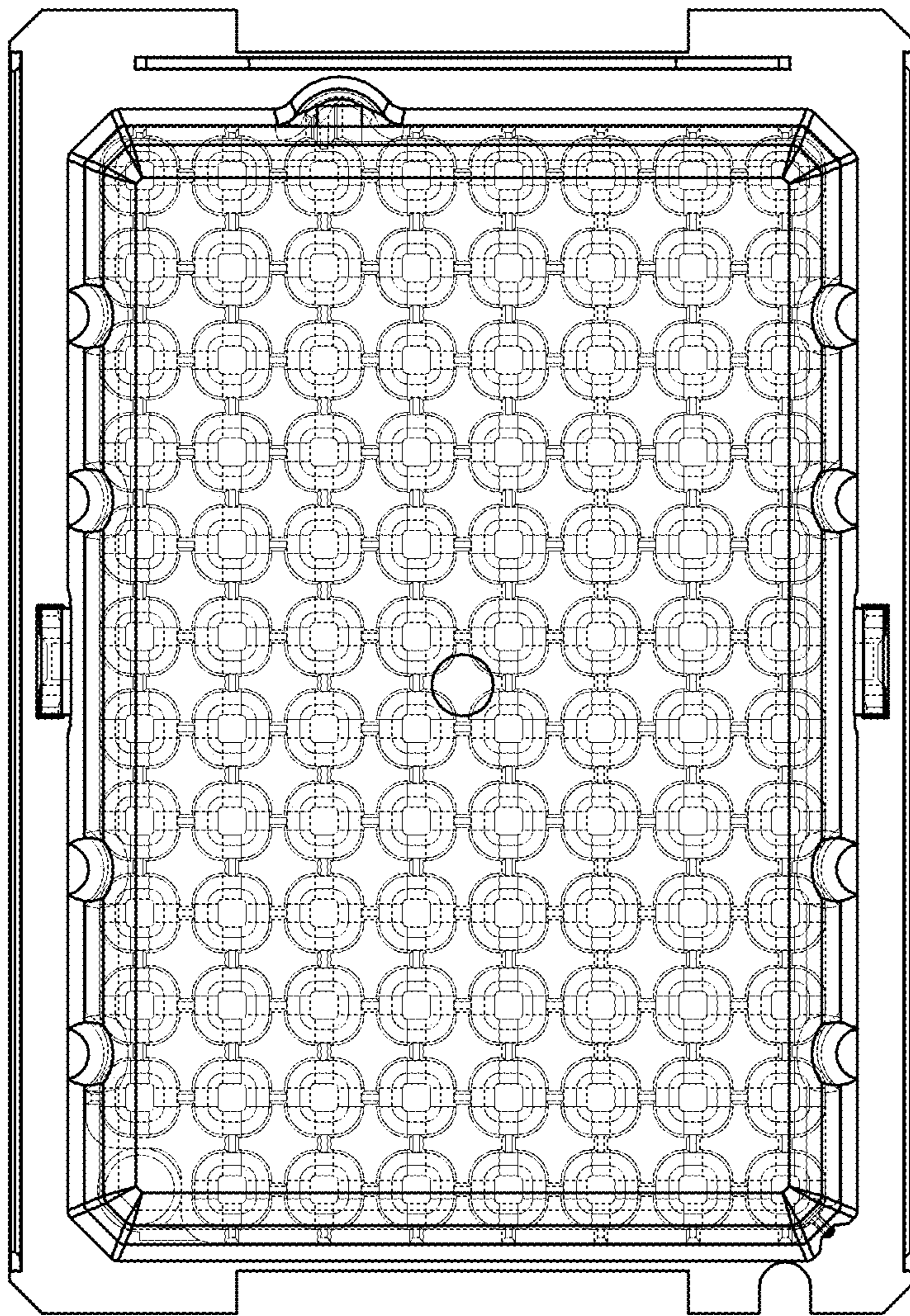
