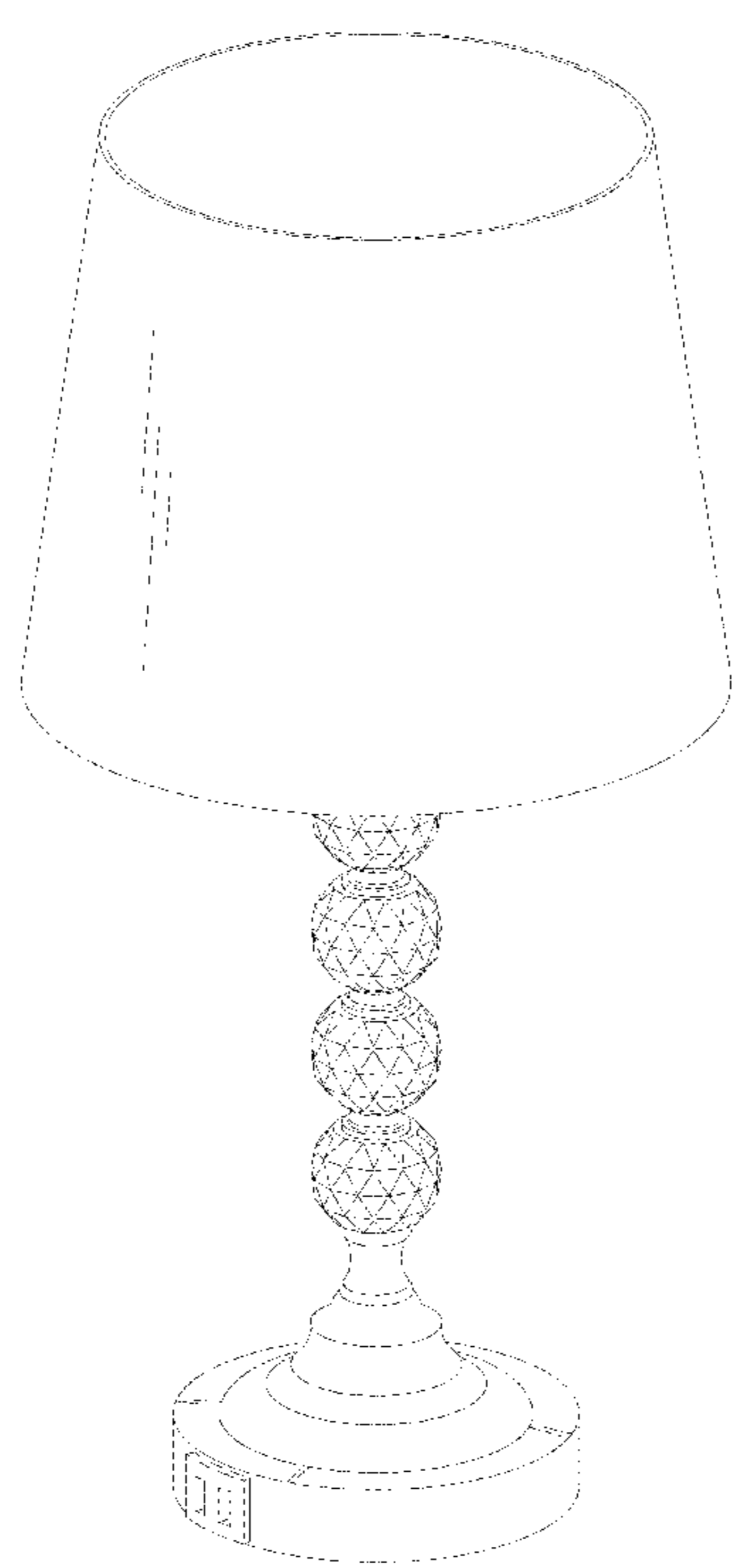

DESCRIPTION
FIG. 1 is a perspective view of a crystal lamp showing the claimed design;
FIG. 2 is a top plan view thereof;

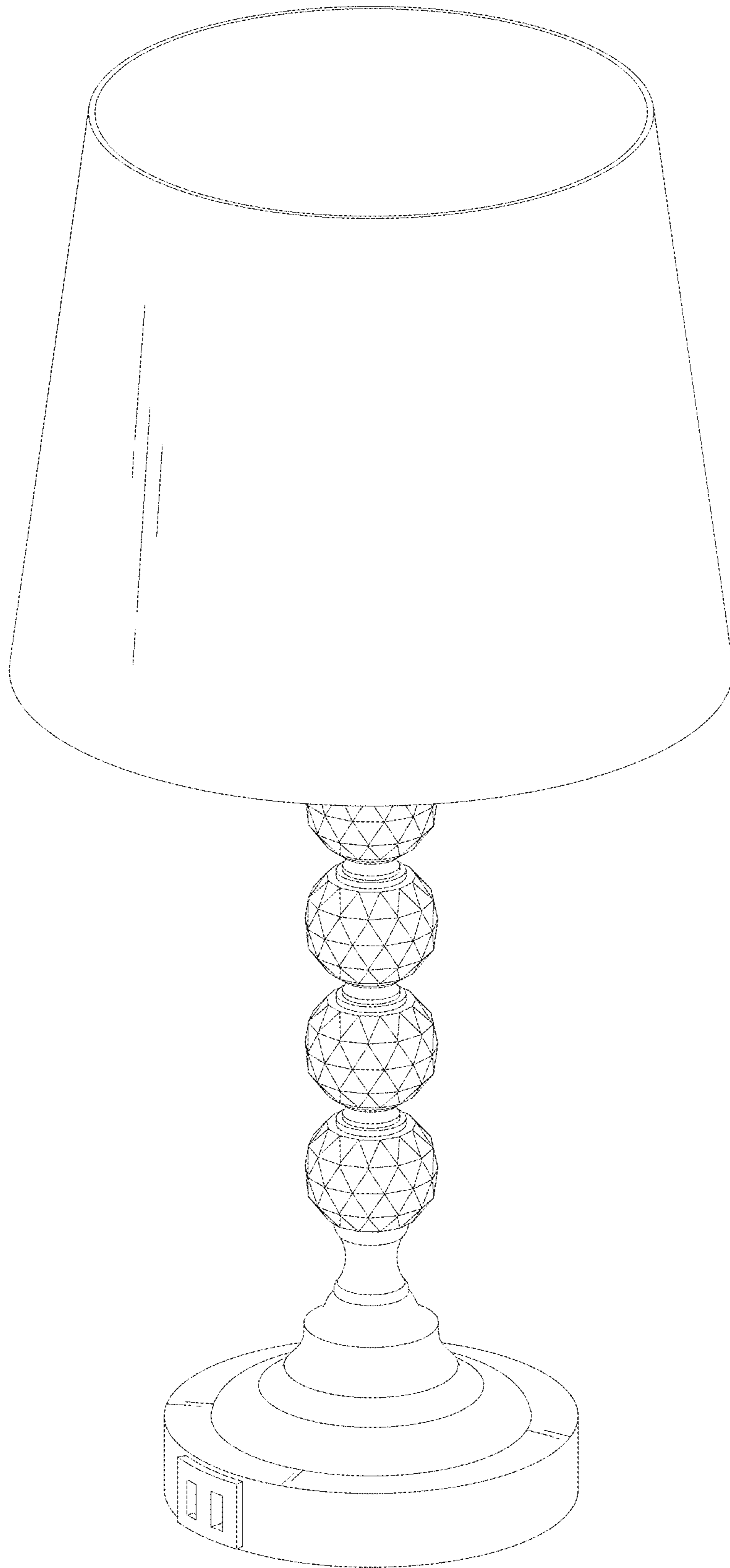

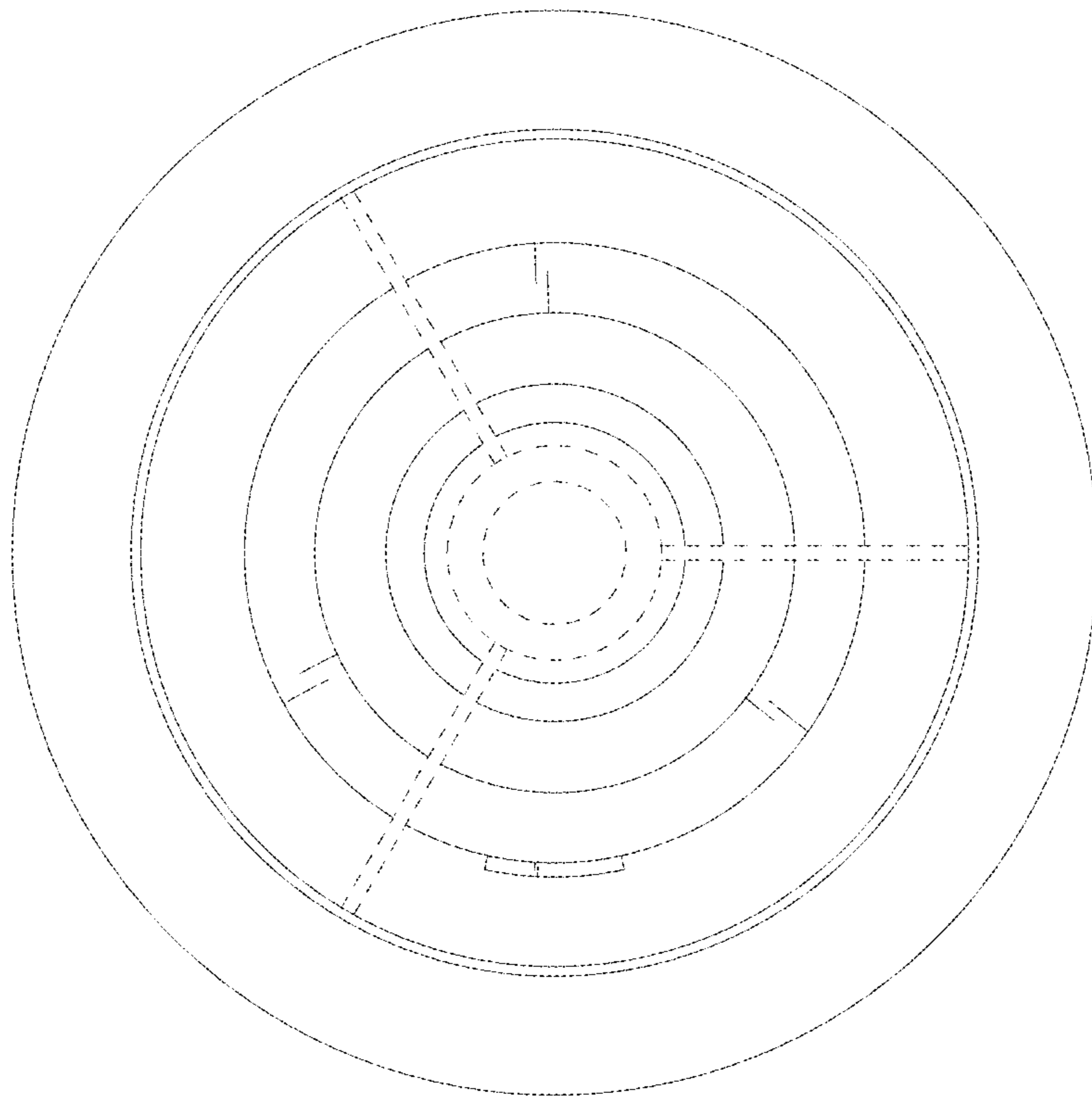

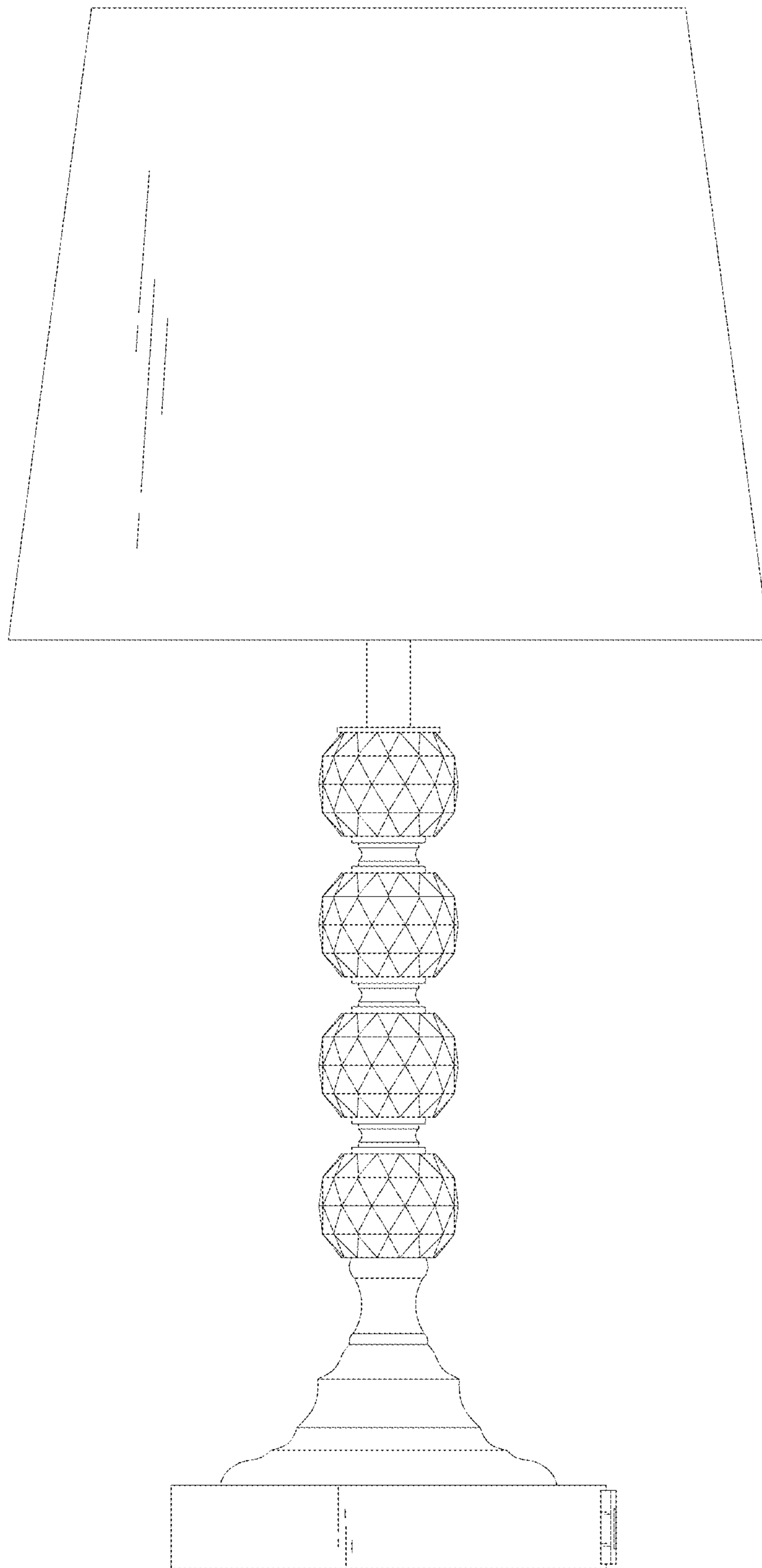

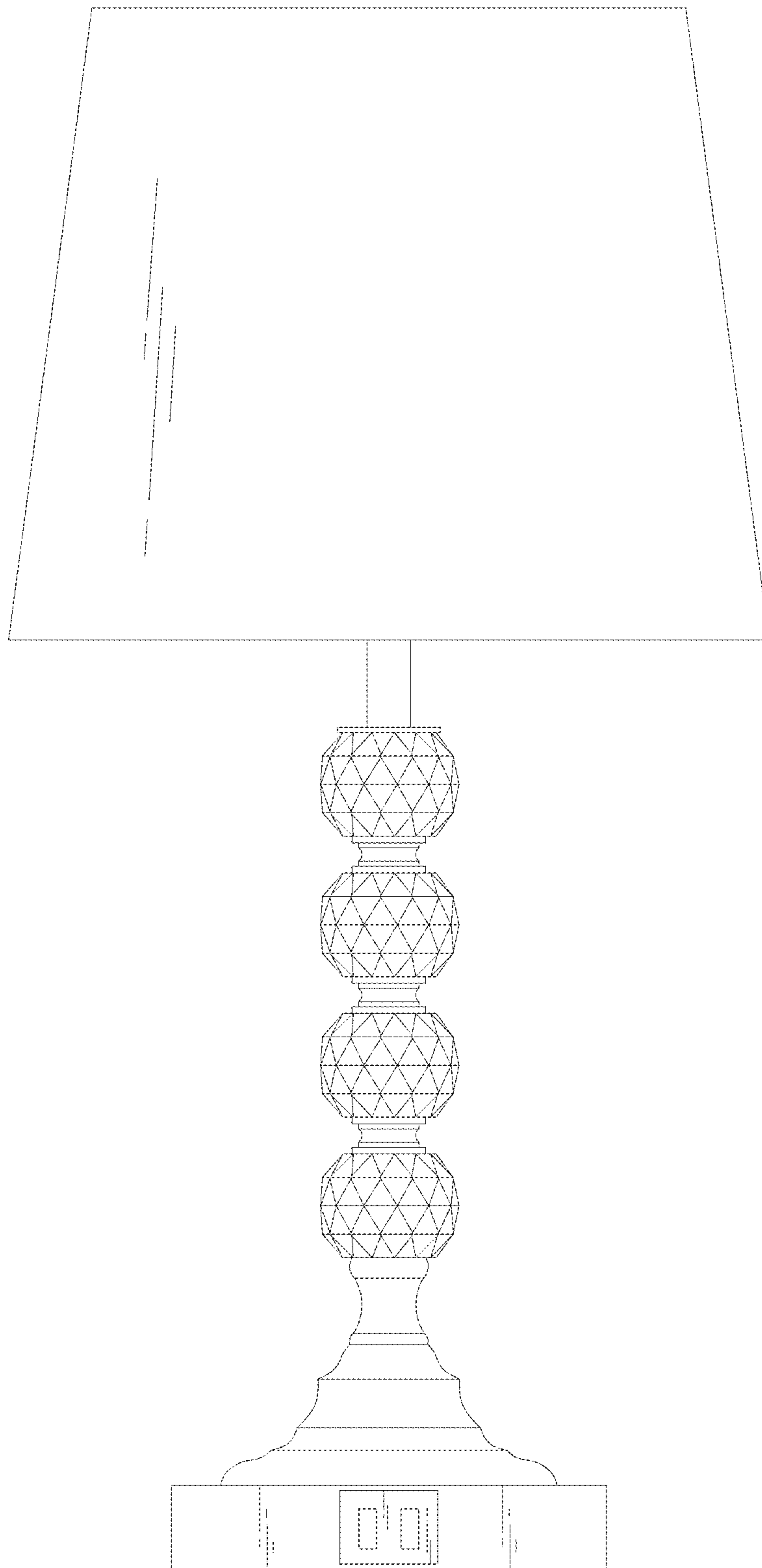

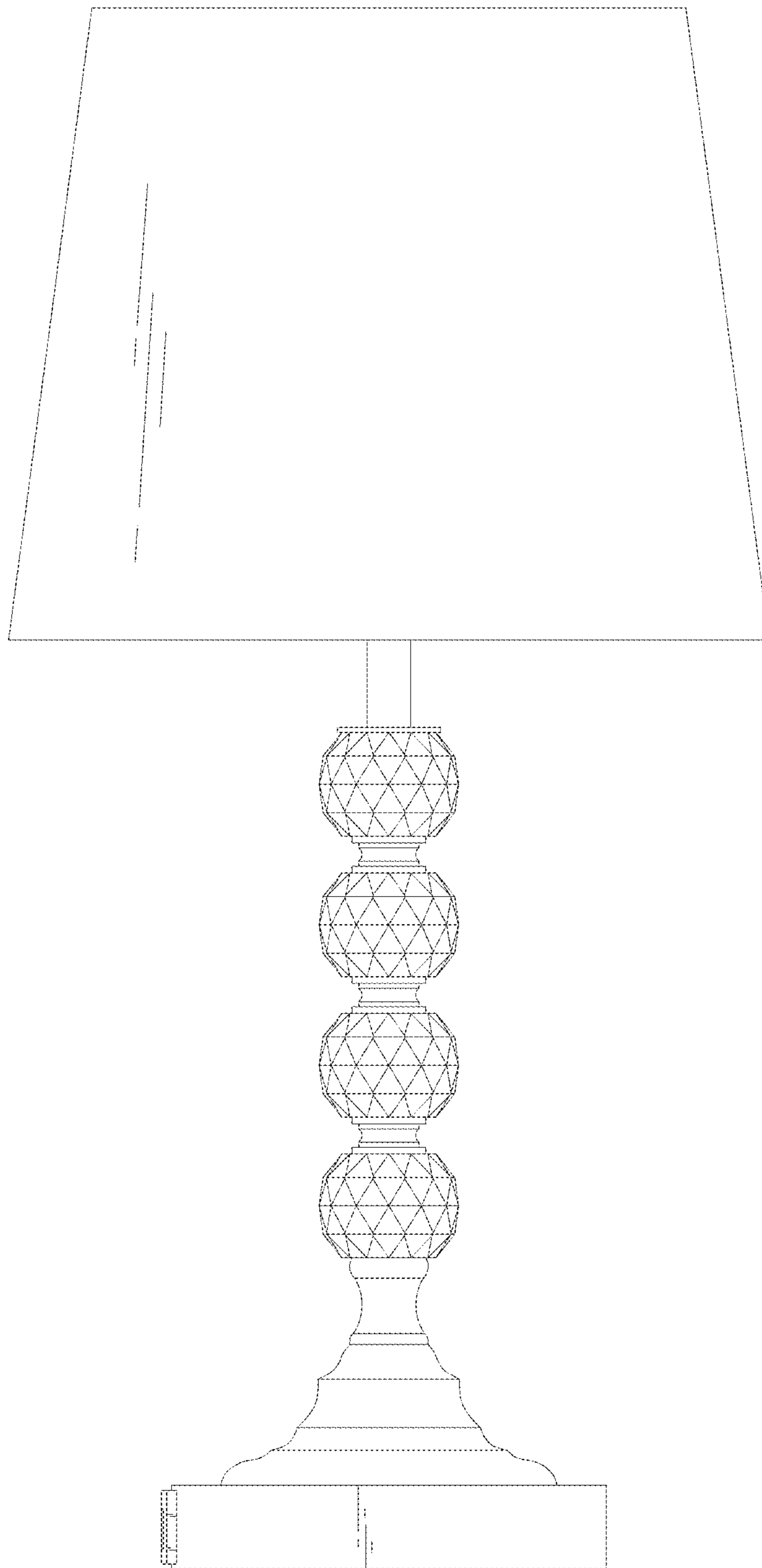

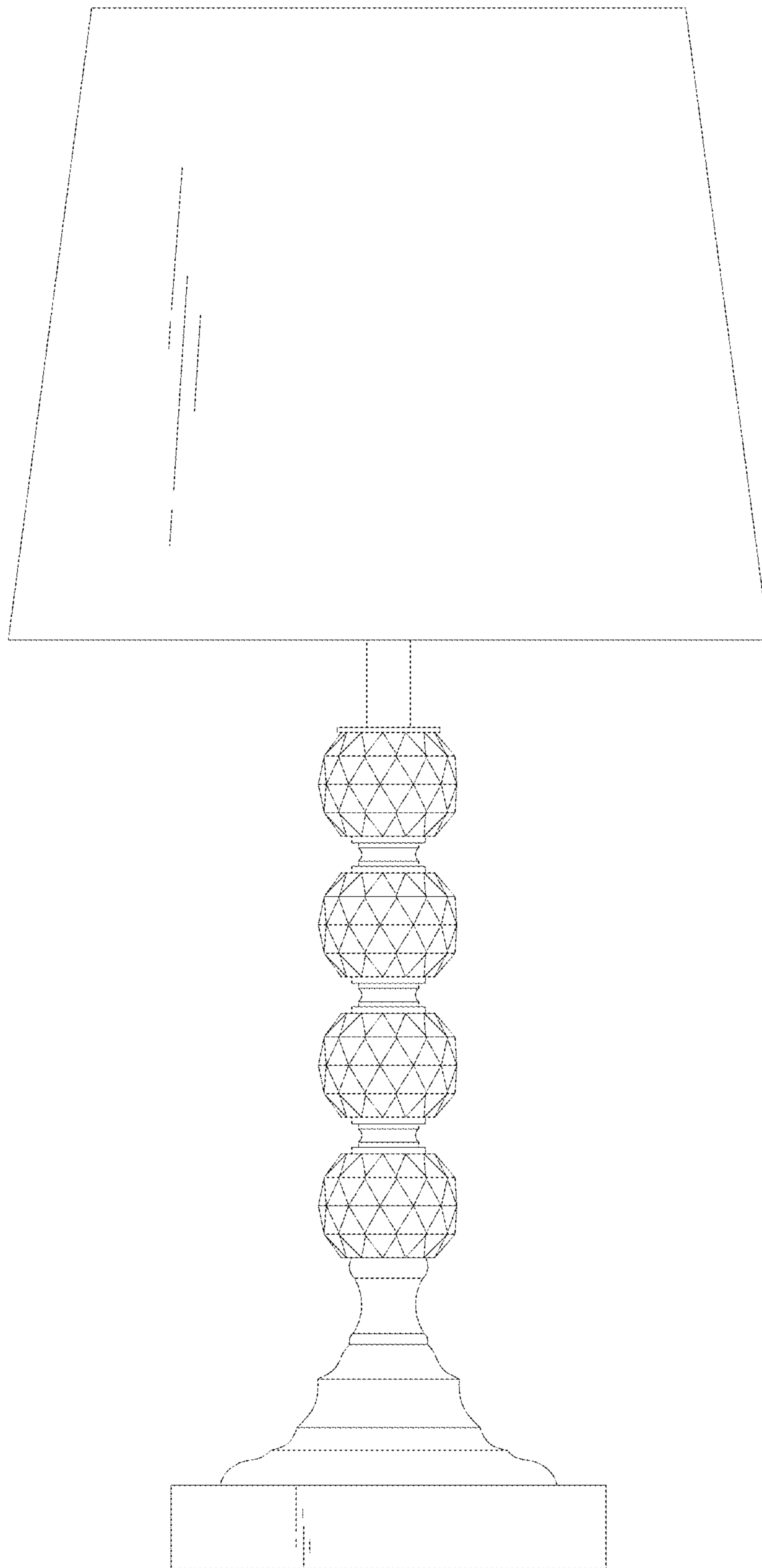

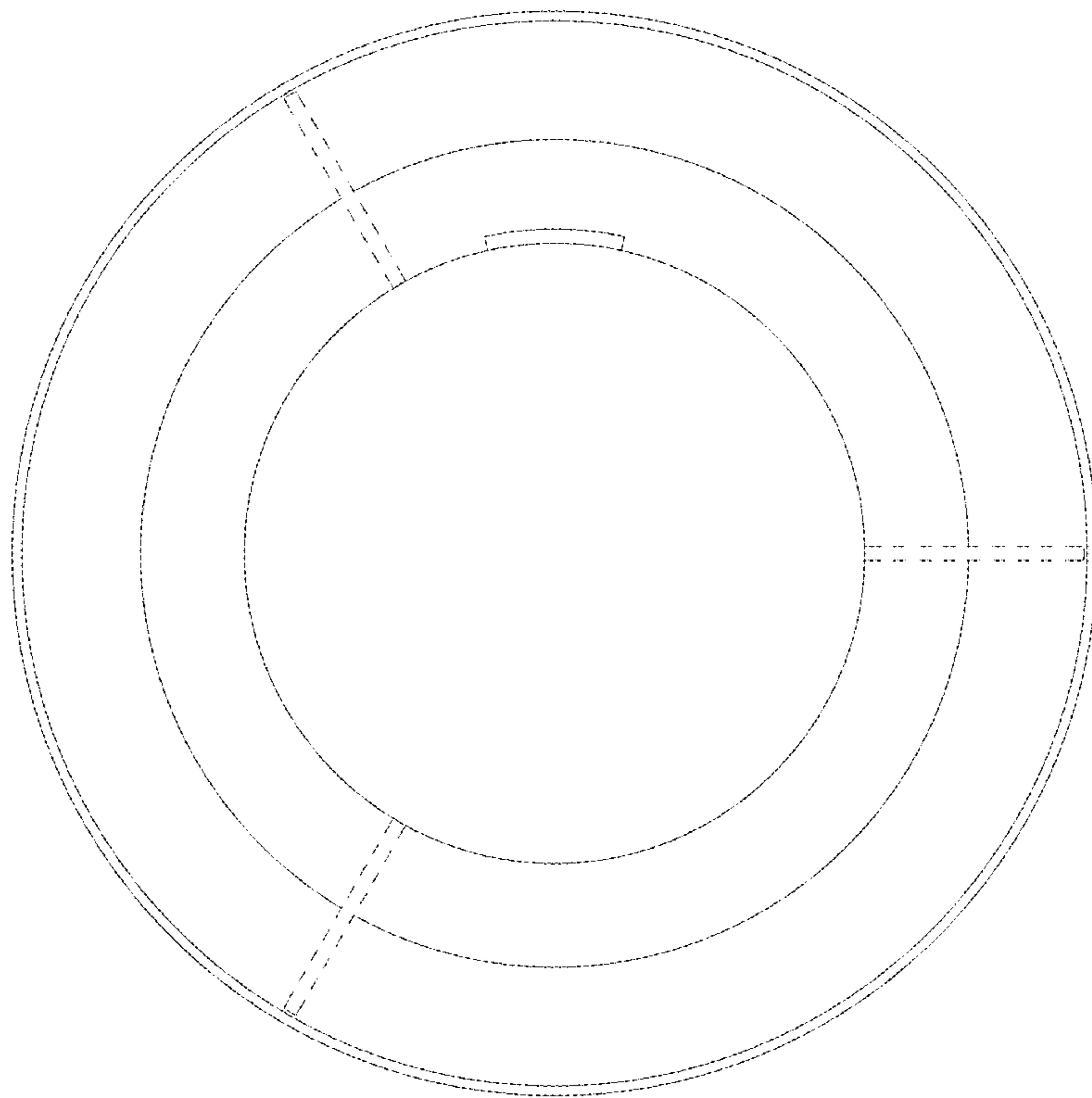
