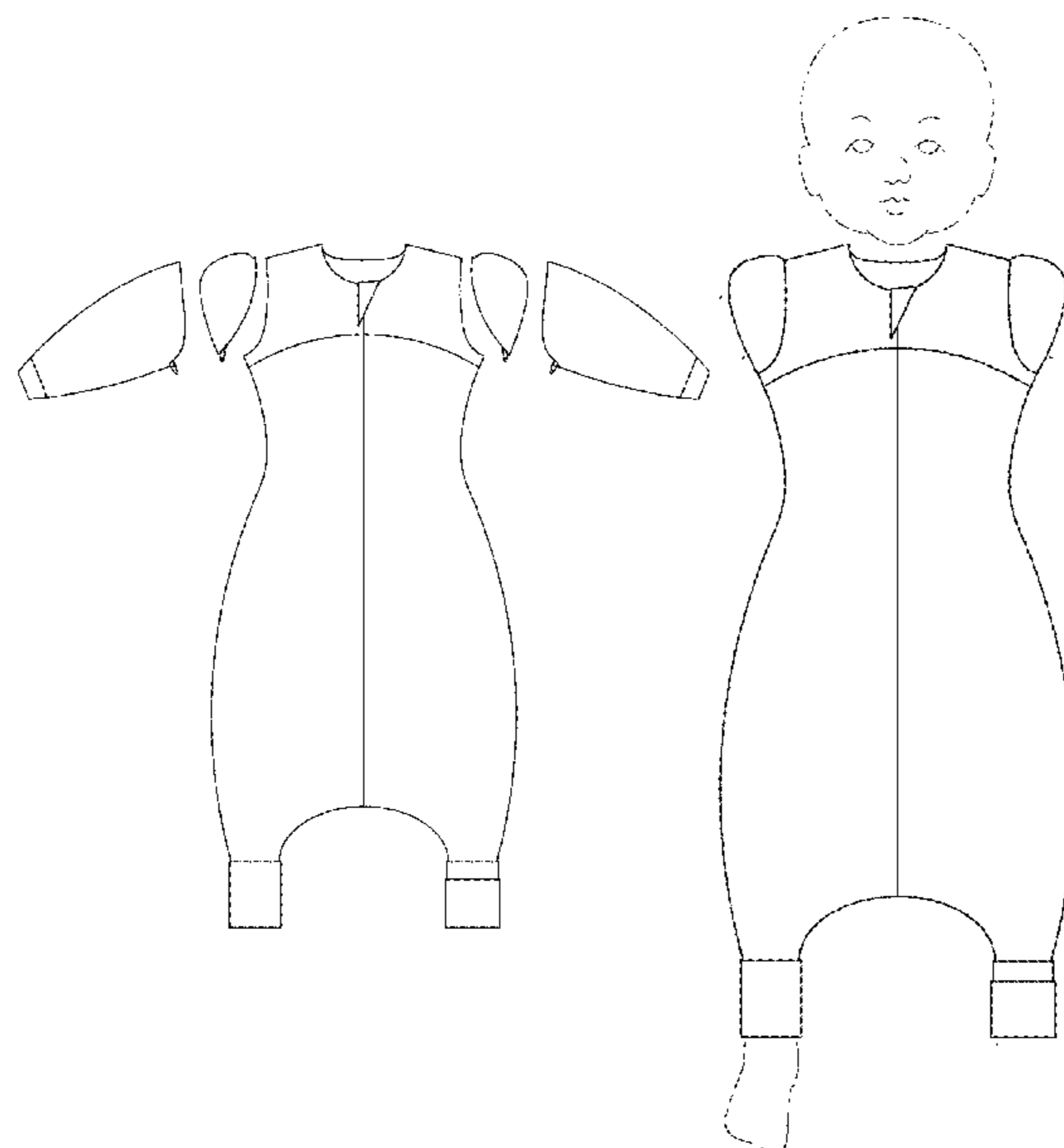
(57) **CLAIM**

The ornamental design for a transition garment, as shown and described.

DESCRIPTION

FIG. 1 is an exploded front elevational view of a transition garment, shown with the wings and sleeves detached; FIG. 2 is an exploded rear elevational view thereof; FIG. 3 is a front elevational view thereof, shown with both wings attached; FIG. 4 is a rear elevational view thereof; FIG. 5 is a front elevational view thereof, shown with one wing detached; FIG. 6 is a rear elevational view thereof; FIG. 7 is a front elevational view thereof, with one sleeve detached; FIG. 8 is a rear elevational view thereof; FIG. 9 is a front elevational view thereof, with both sleeves; and, FIG. 10 is a rear elevational view thereof. The broken lines shown in the drawings depict environment and form no part of the claimed design.

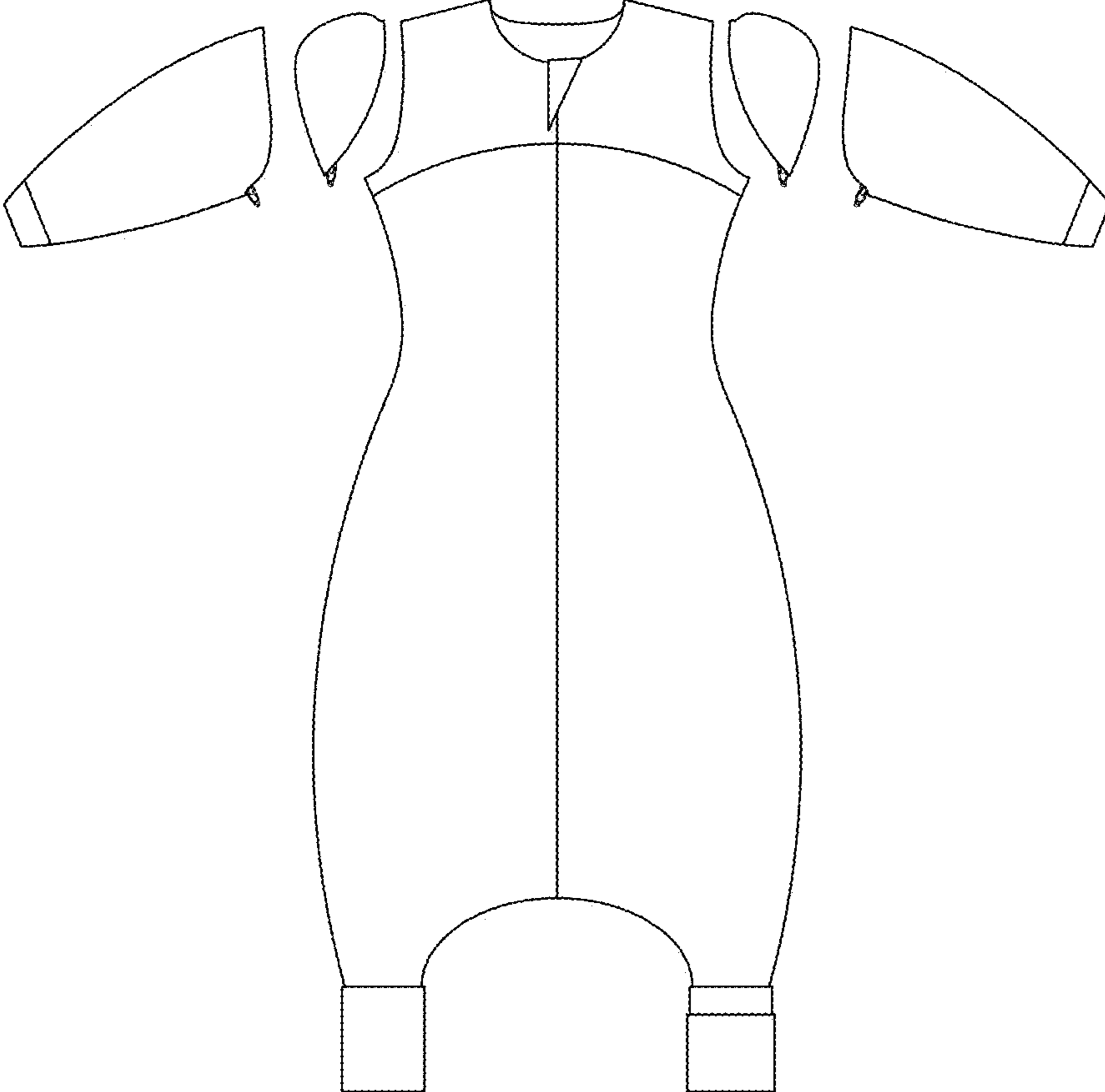

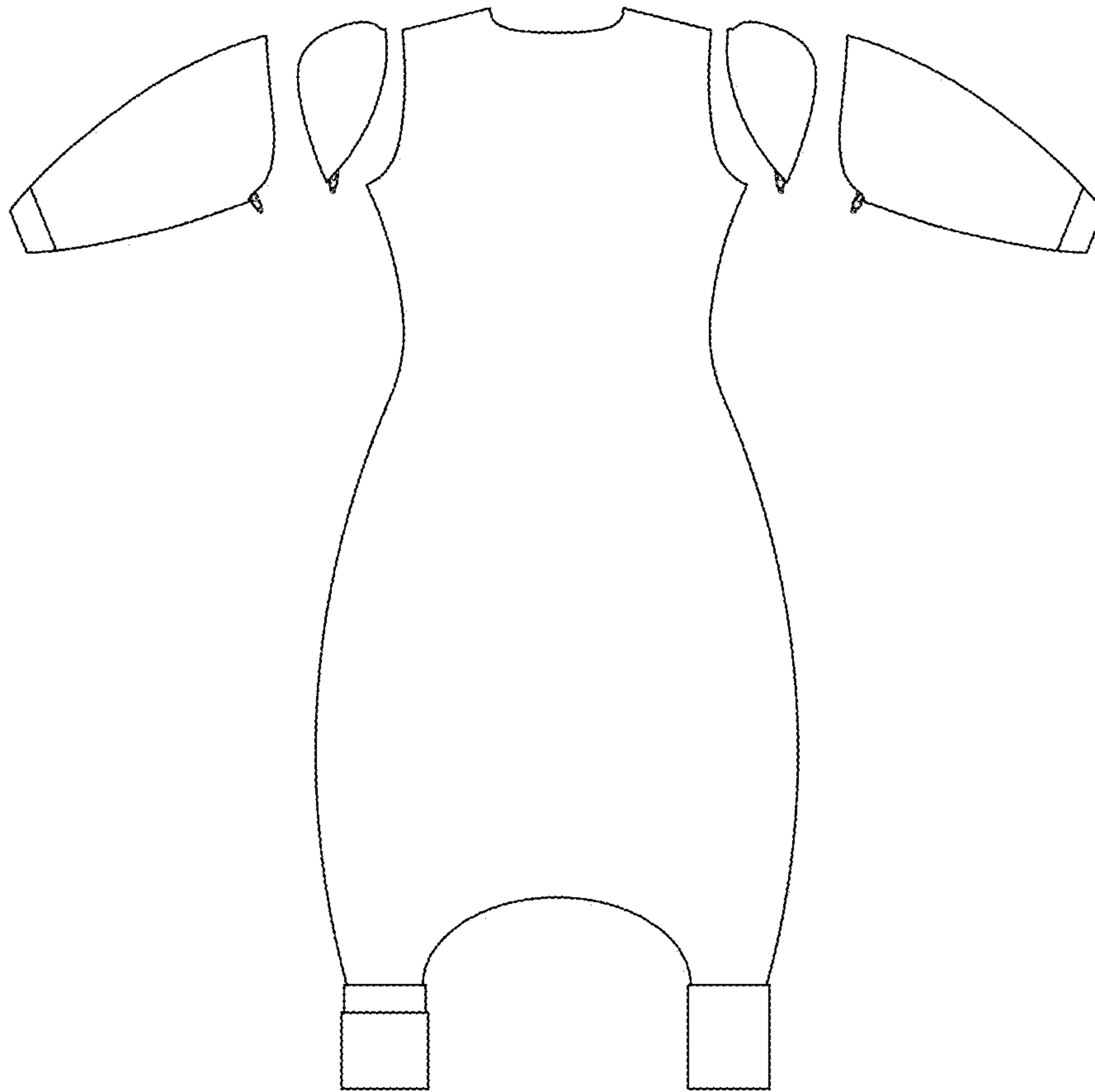

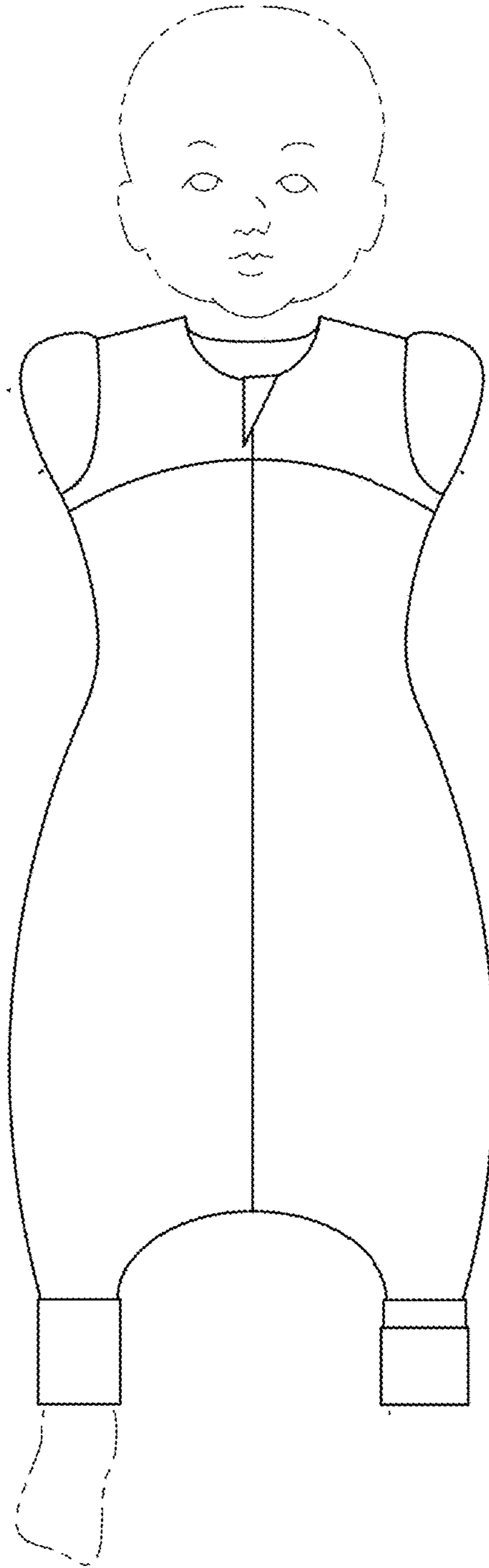

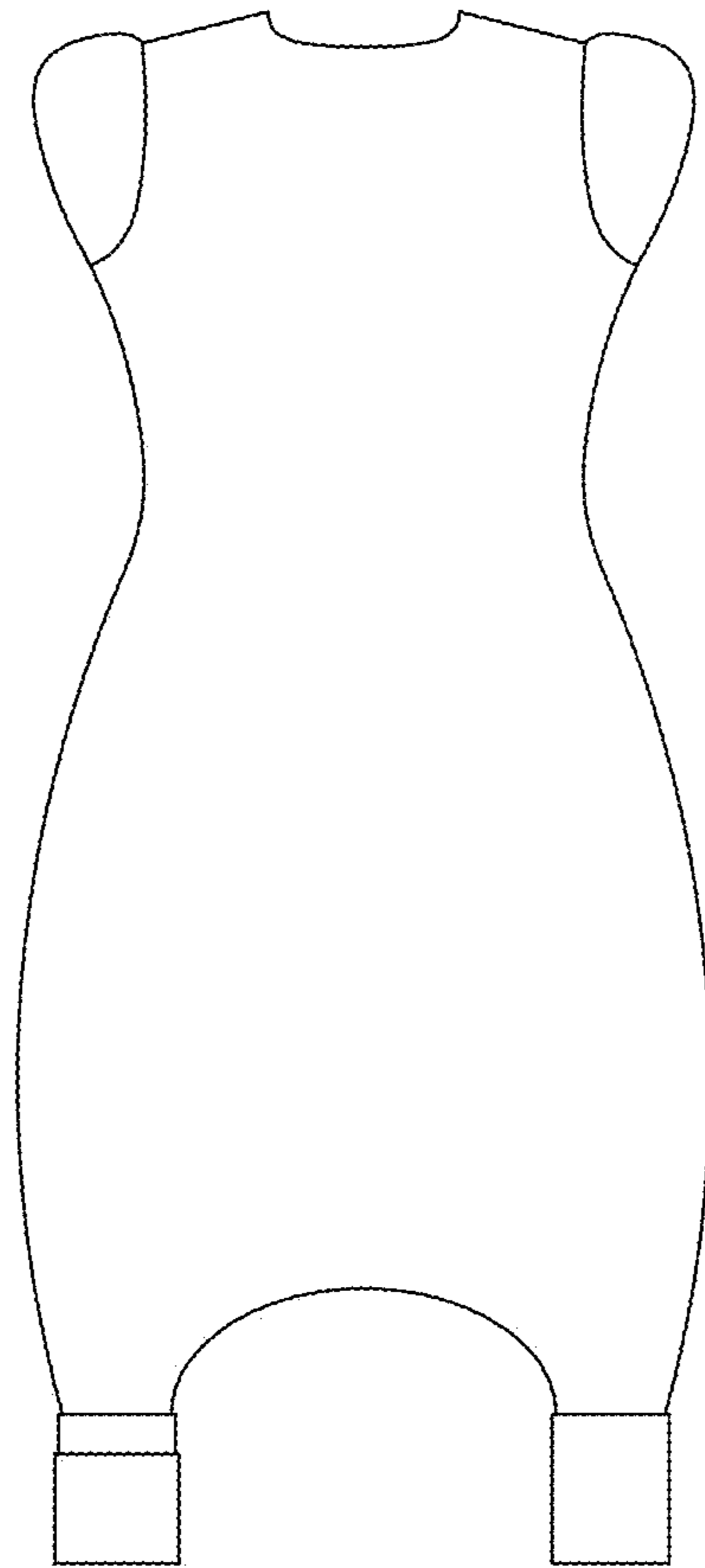

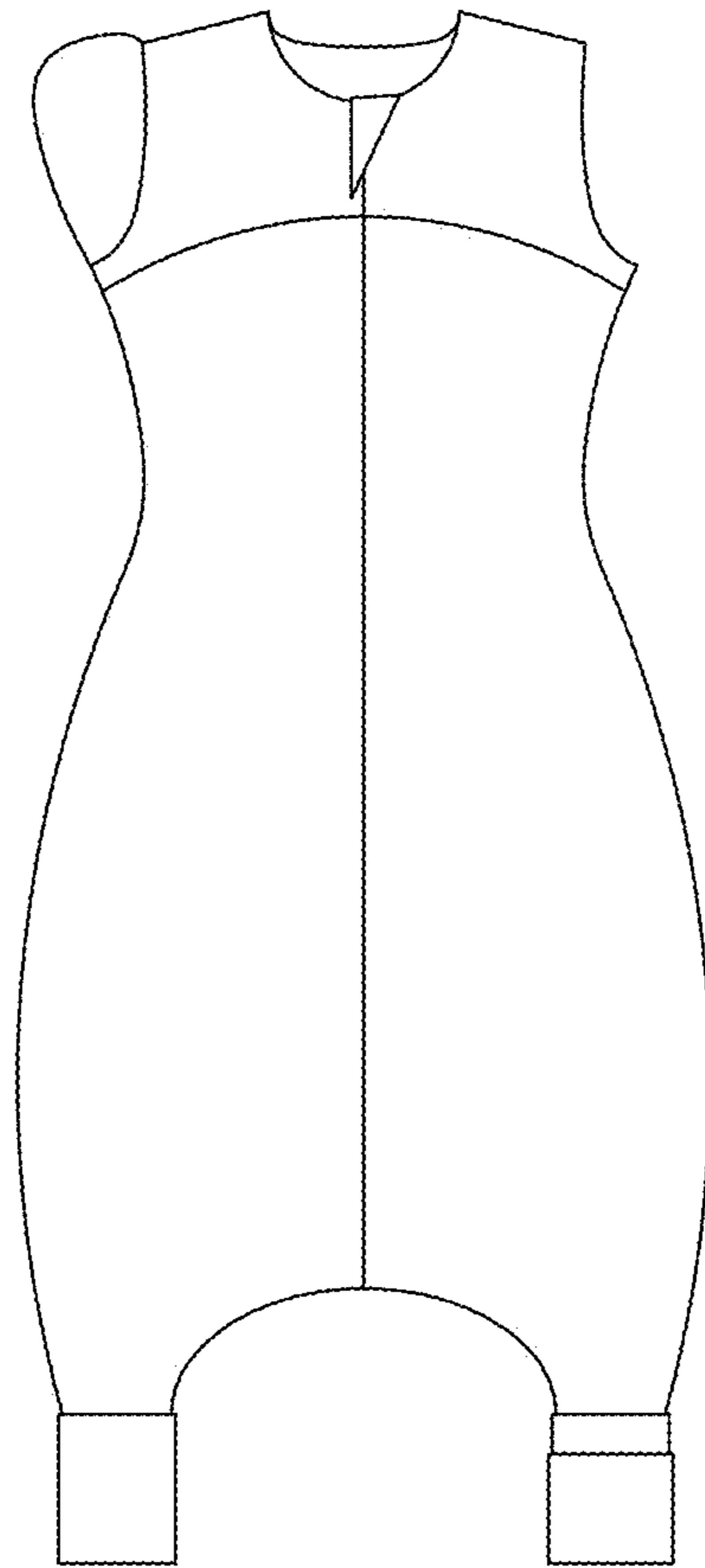

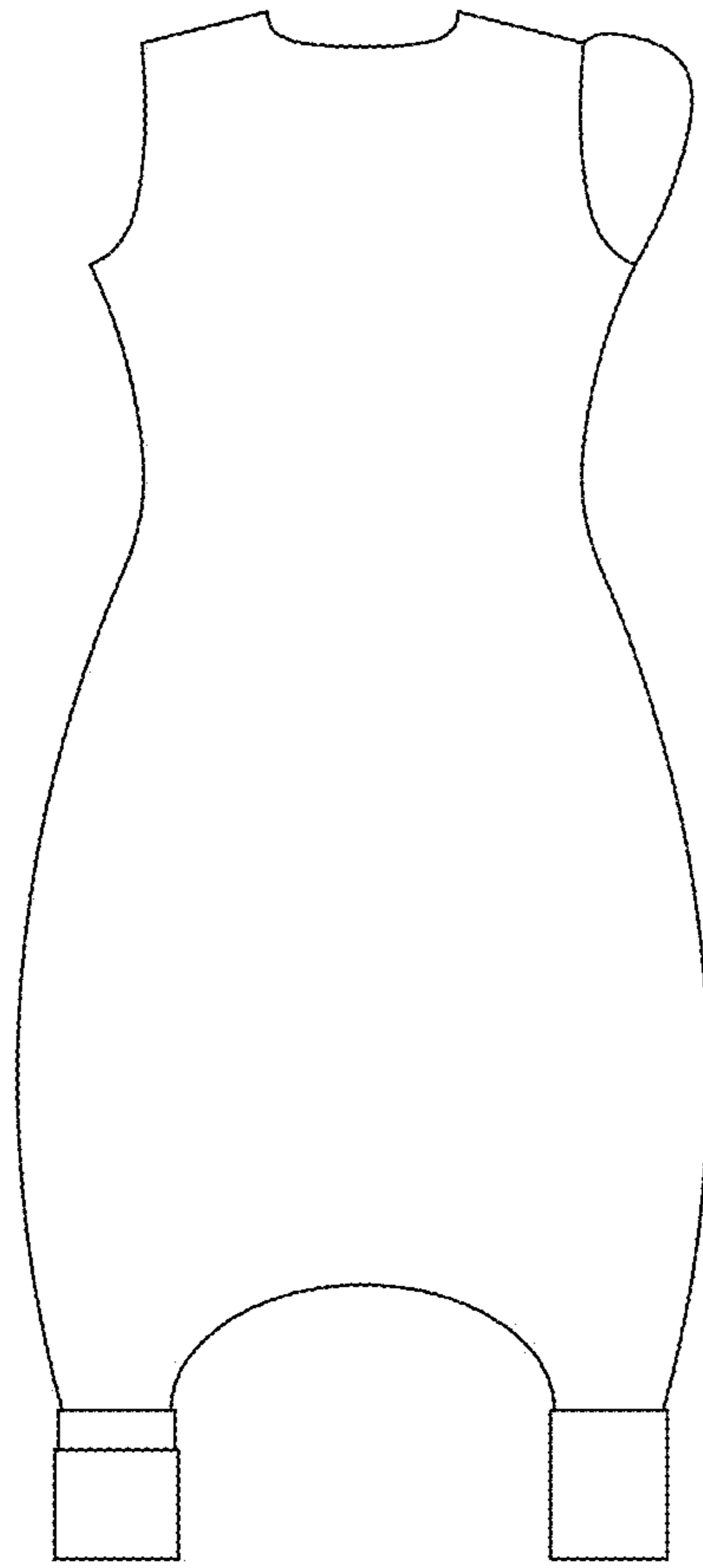

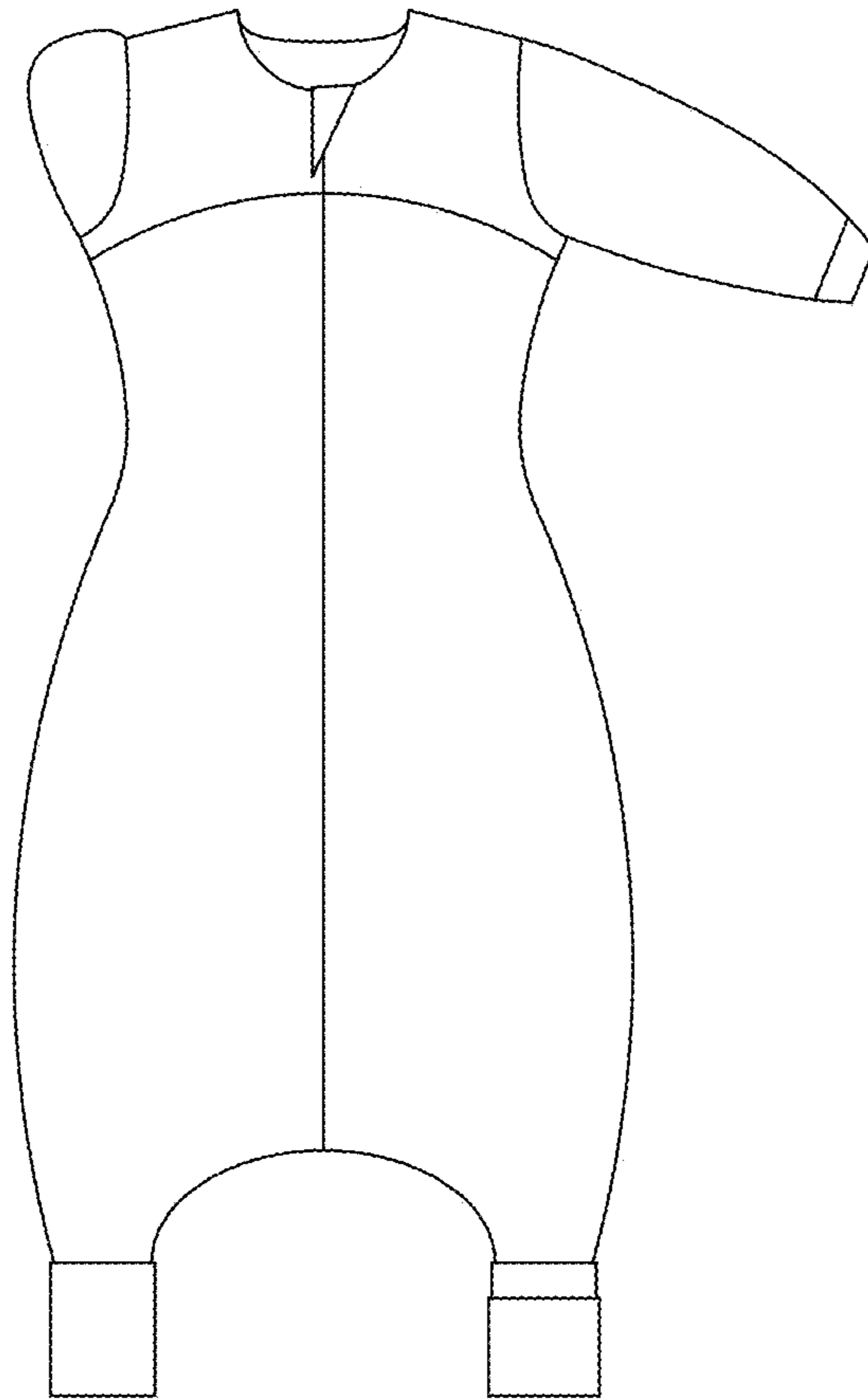

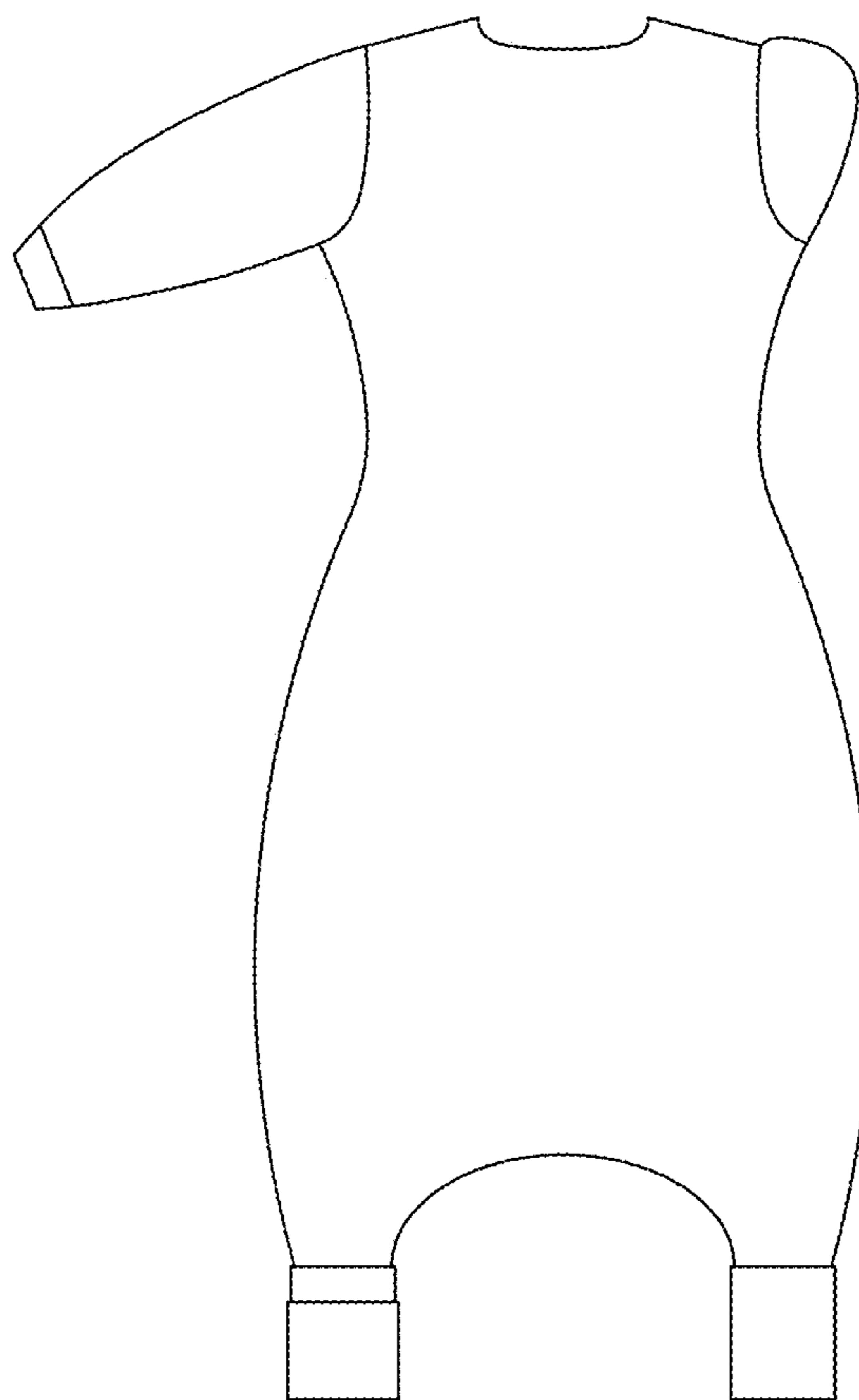

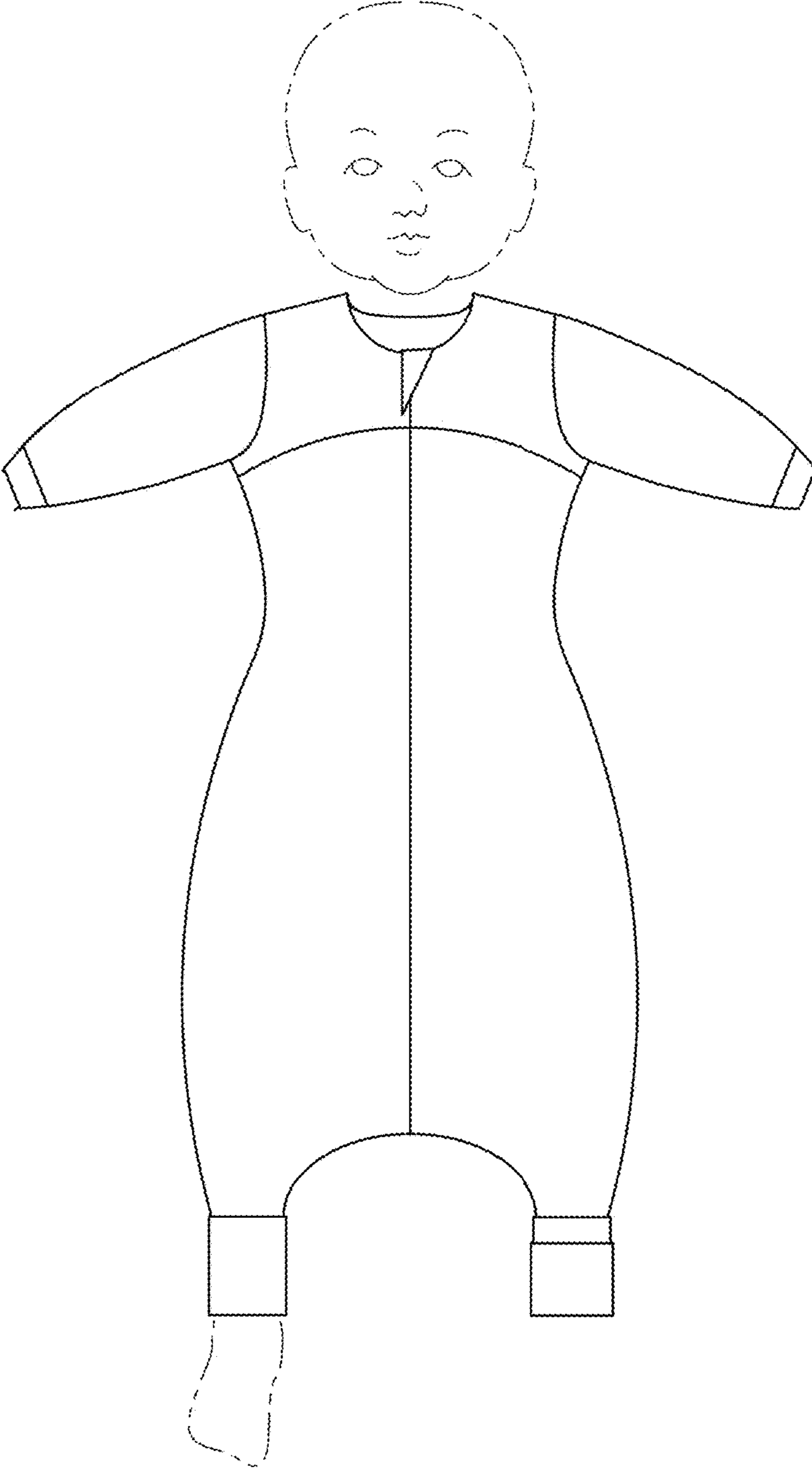

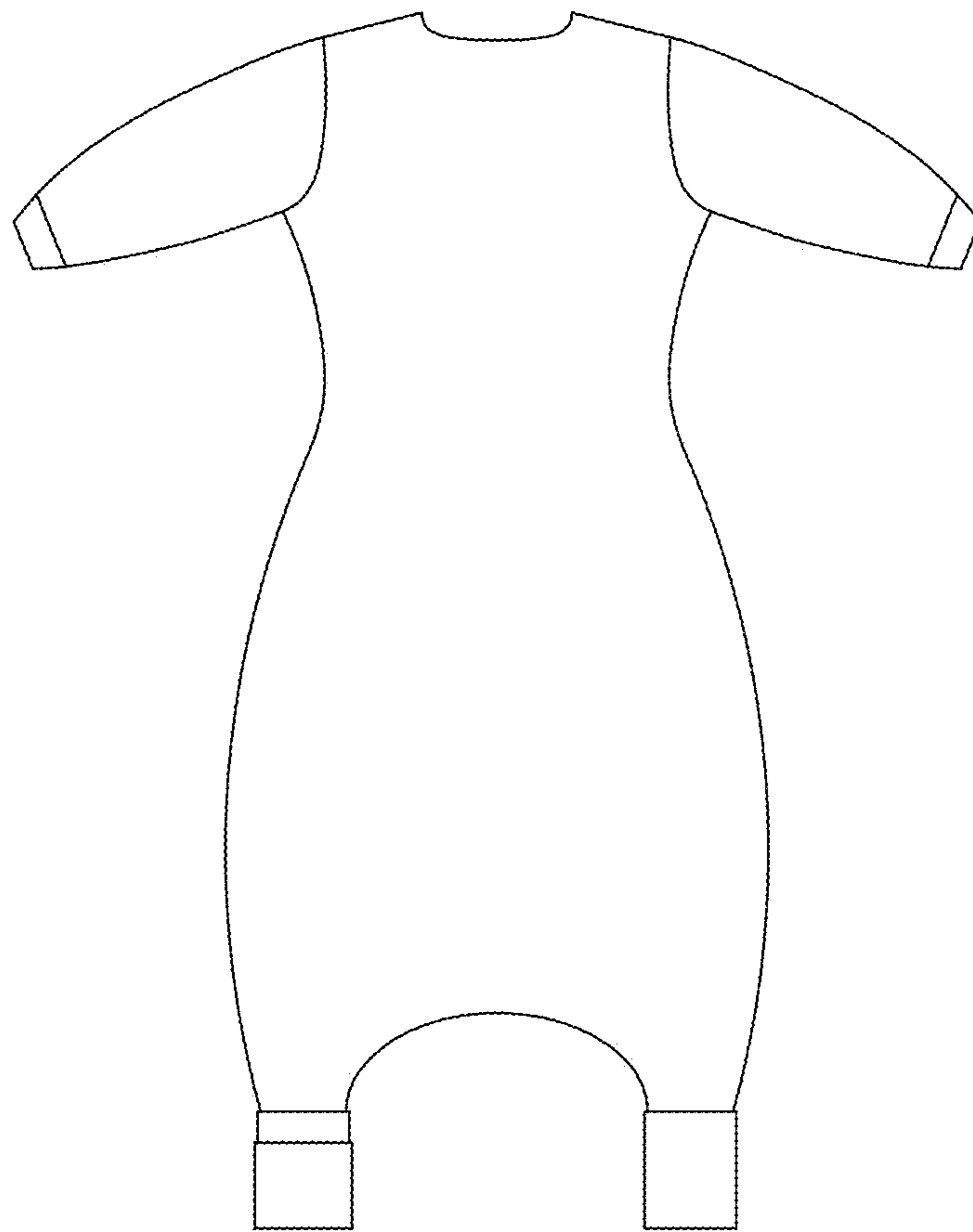
