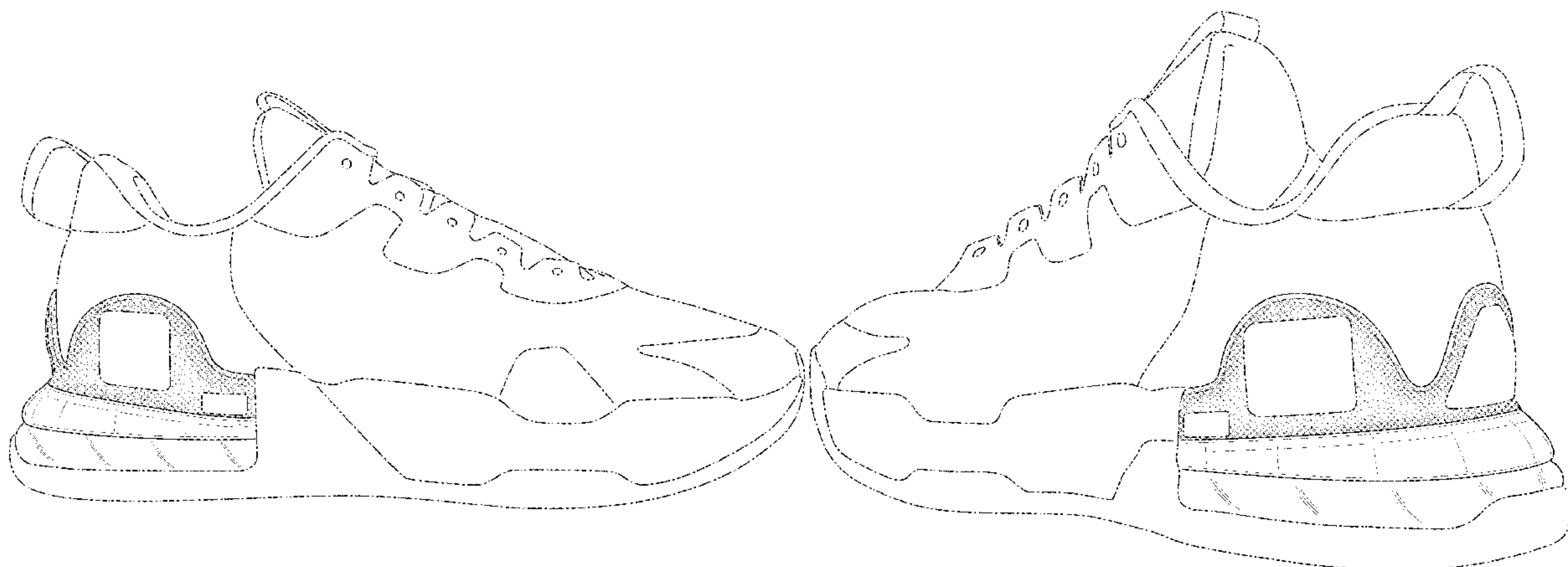
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a shoe showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a rear view thereof; FIG. 4 is an opposite side rear perspective view thereof; and, FIG. 5 is an opposite side view thereof. The broken lines immediately adjacent to the bottom and front edges of the shaded area define the bounds of the claimed design and form no part thereof. The broken line showing of the five unshaded regions within the shaded area form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

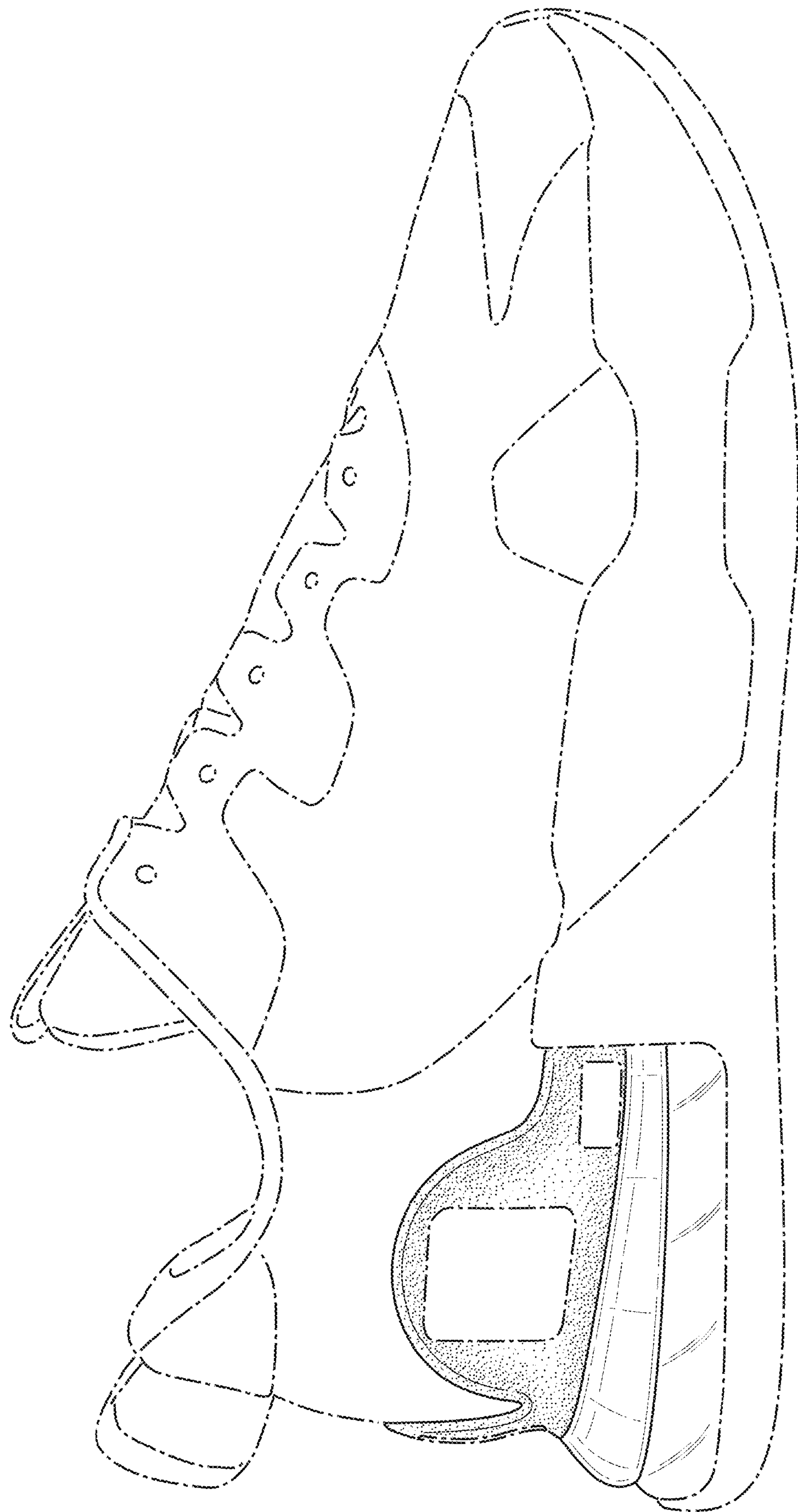

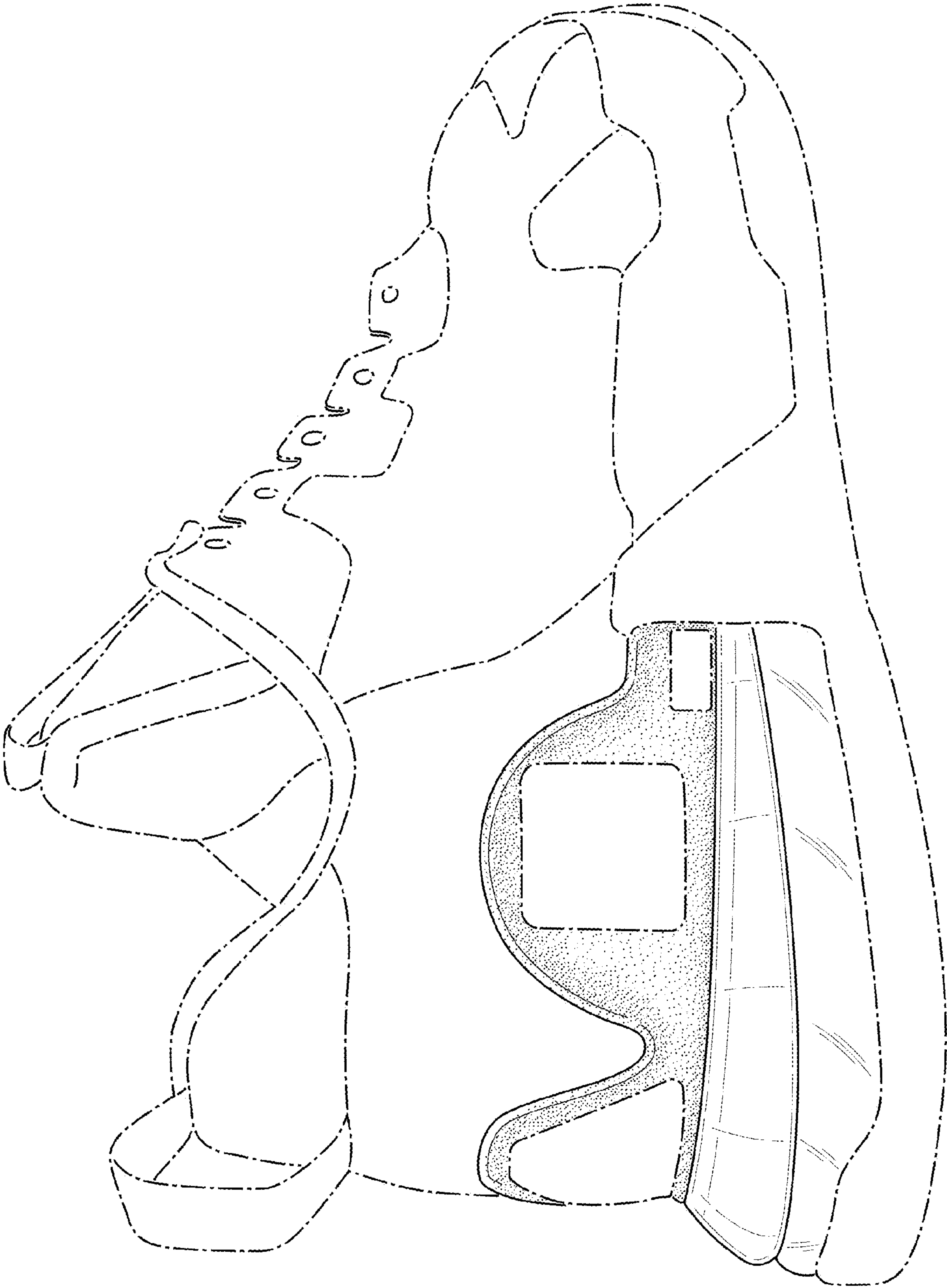

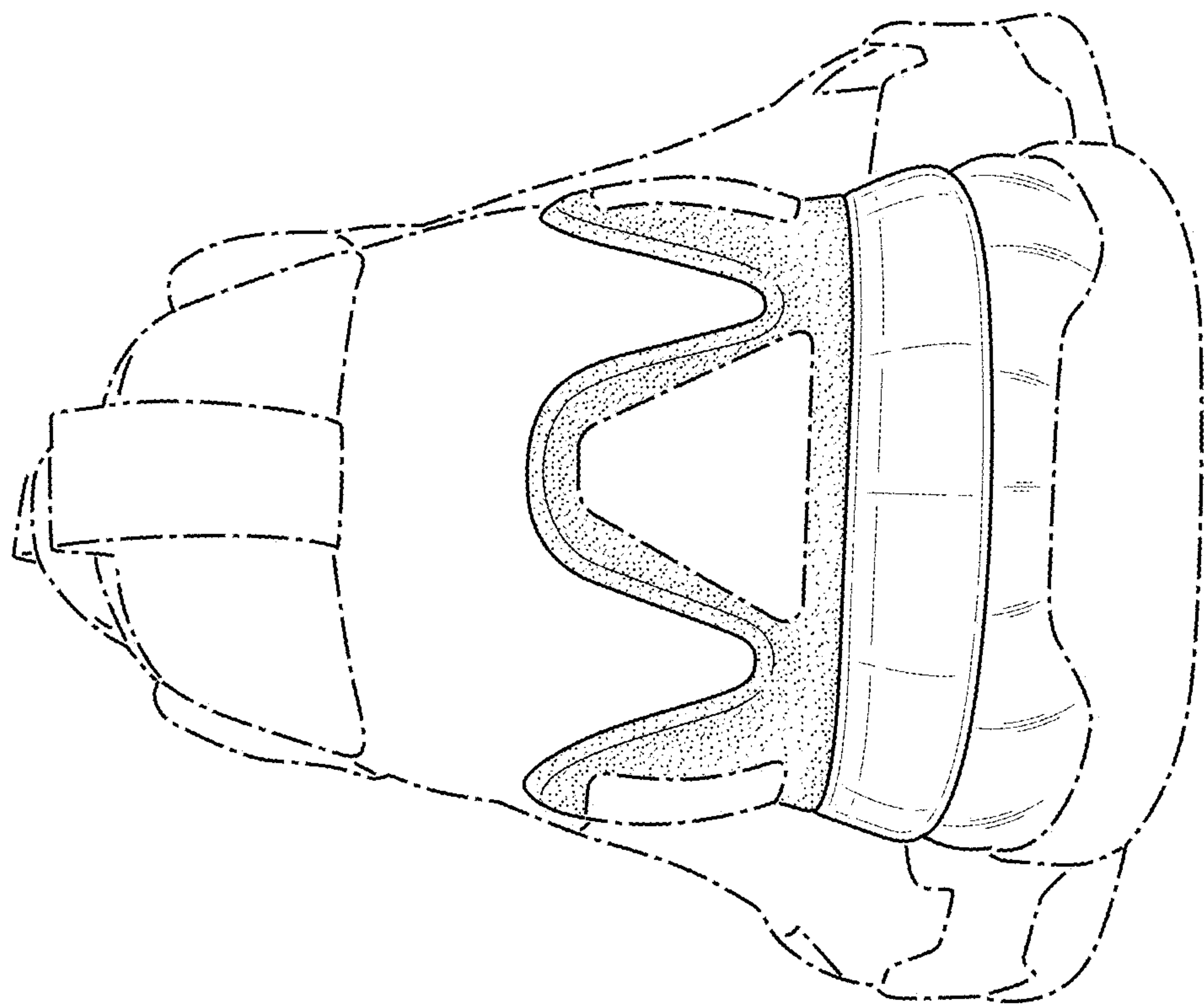

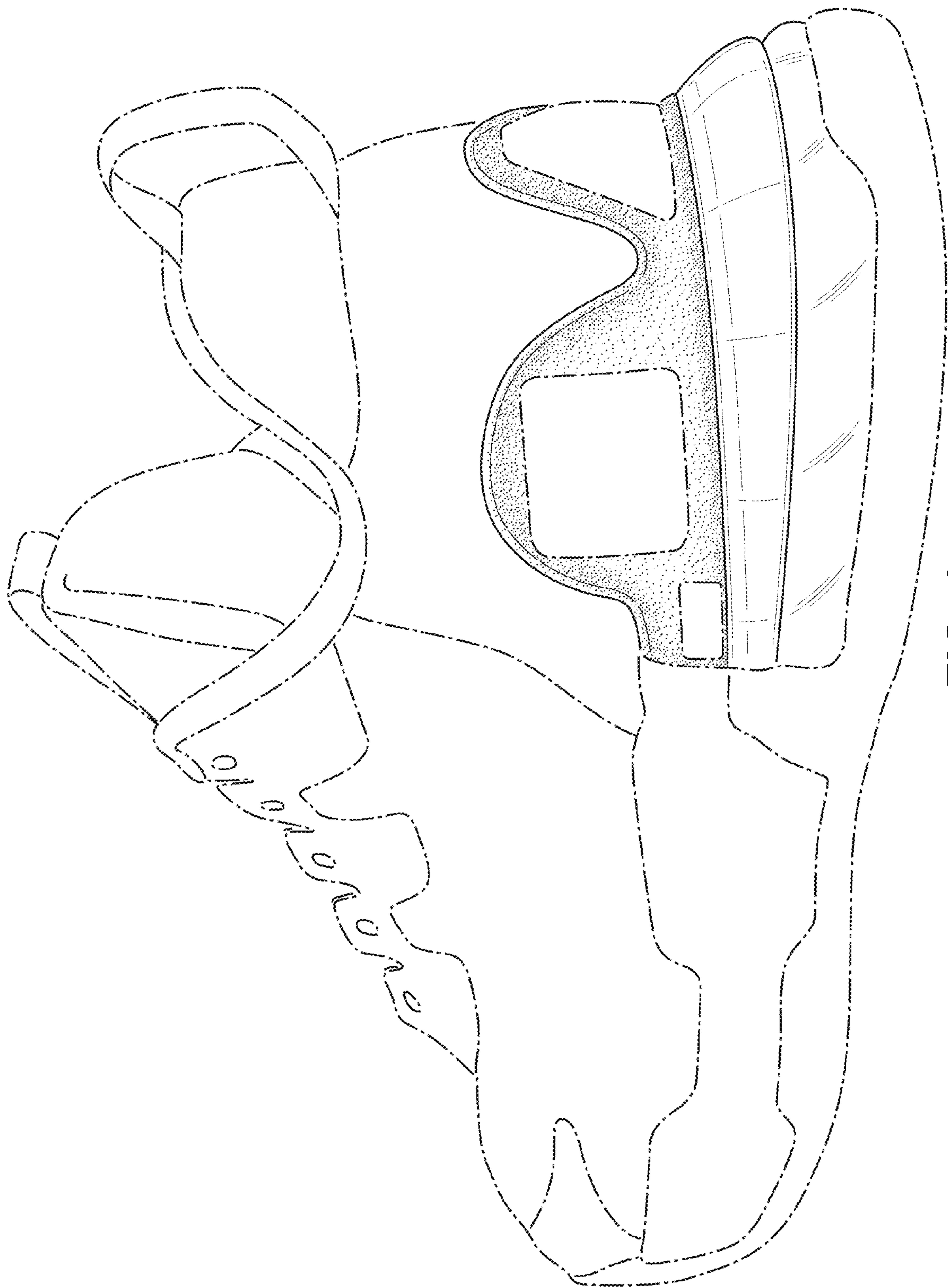

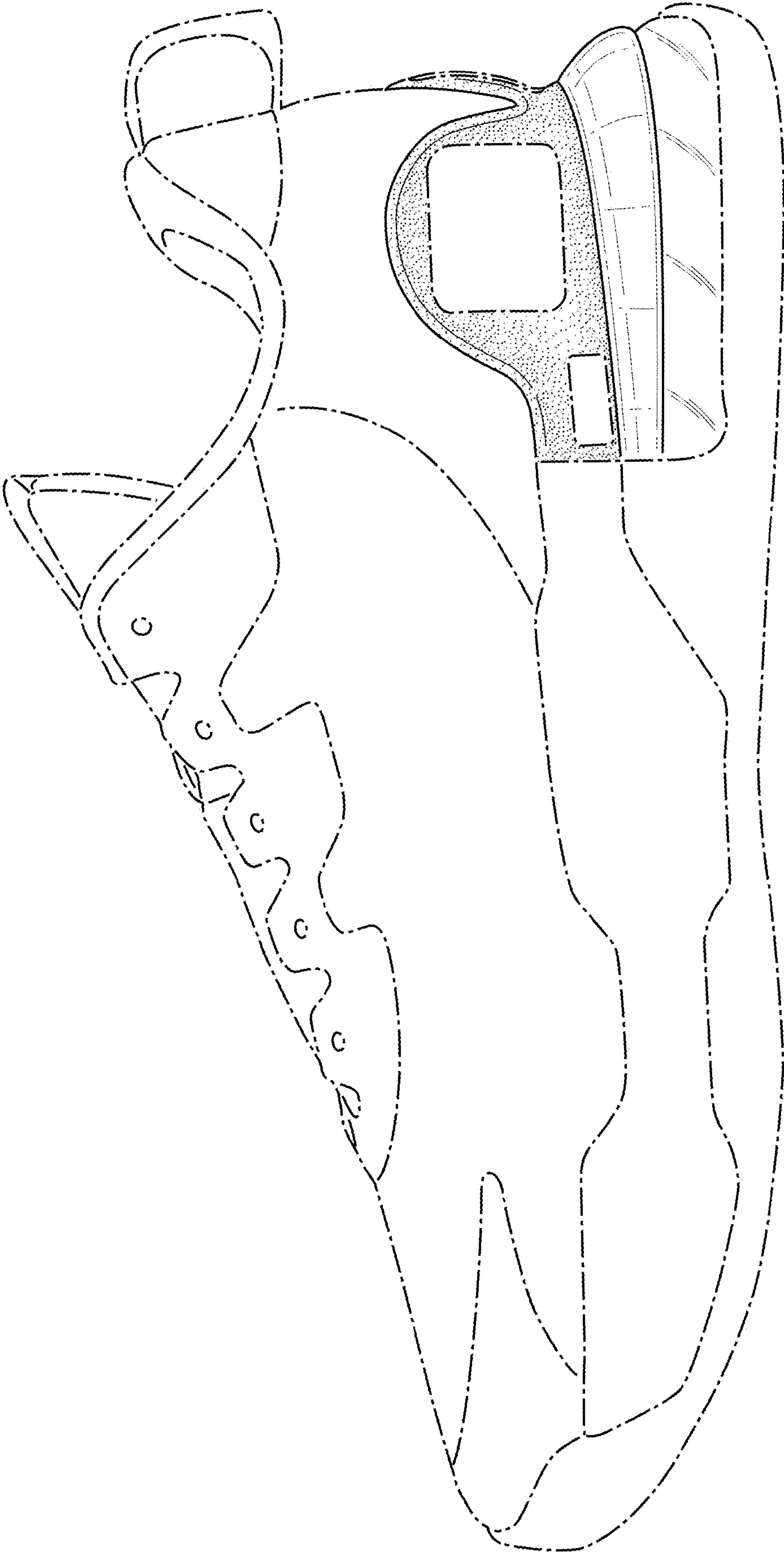
