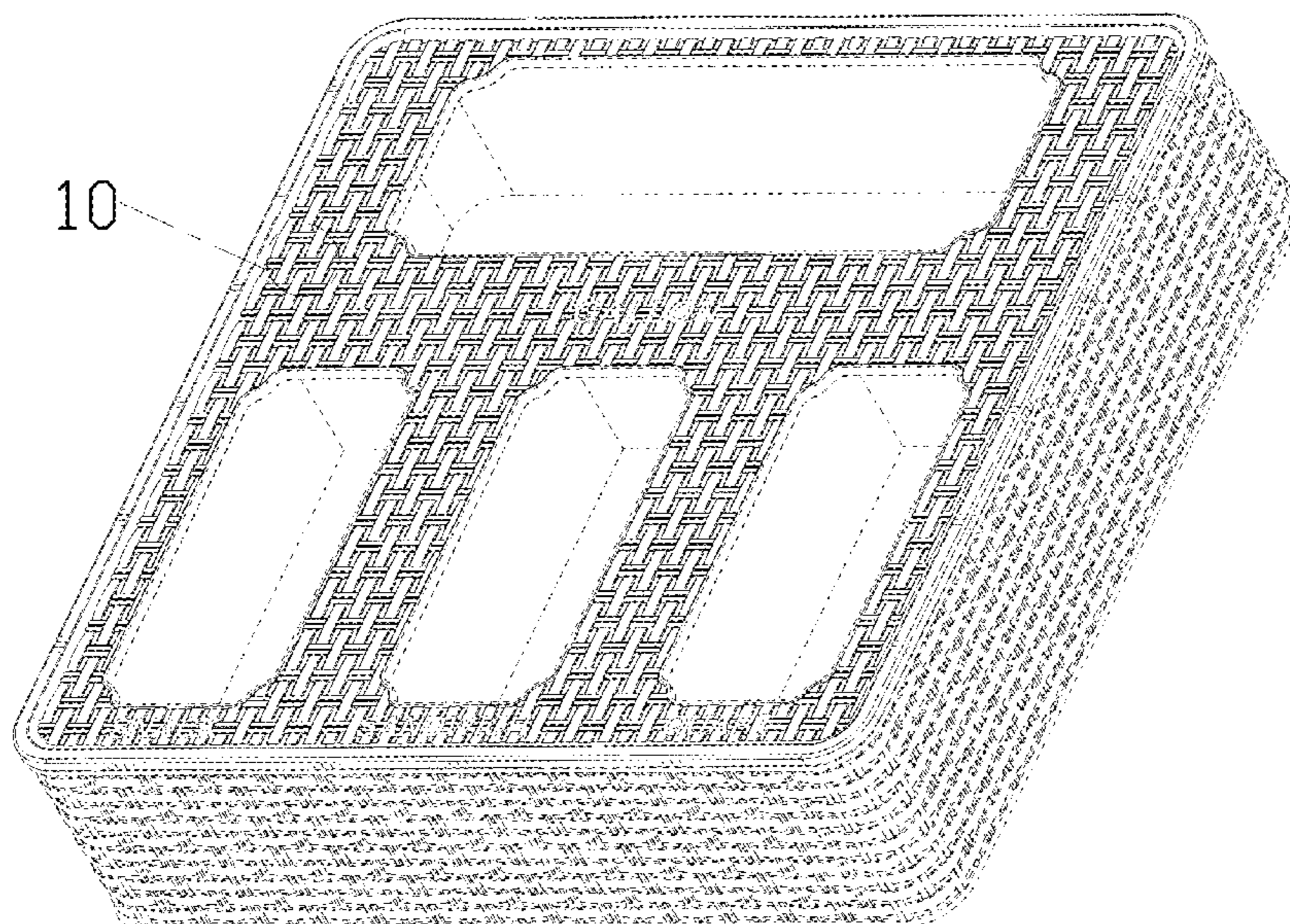
FIG. 1 is a front and top perspective view of a storage box, showing my new design;

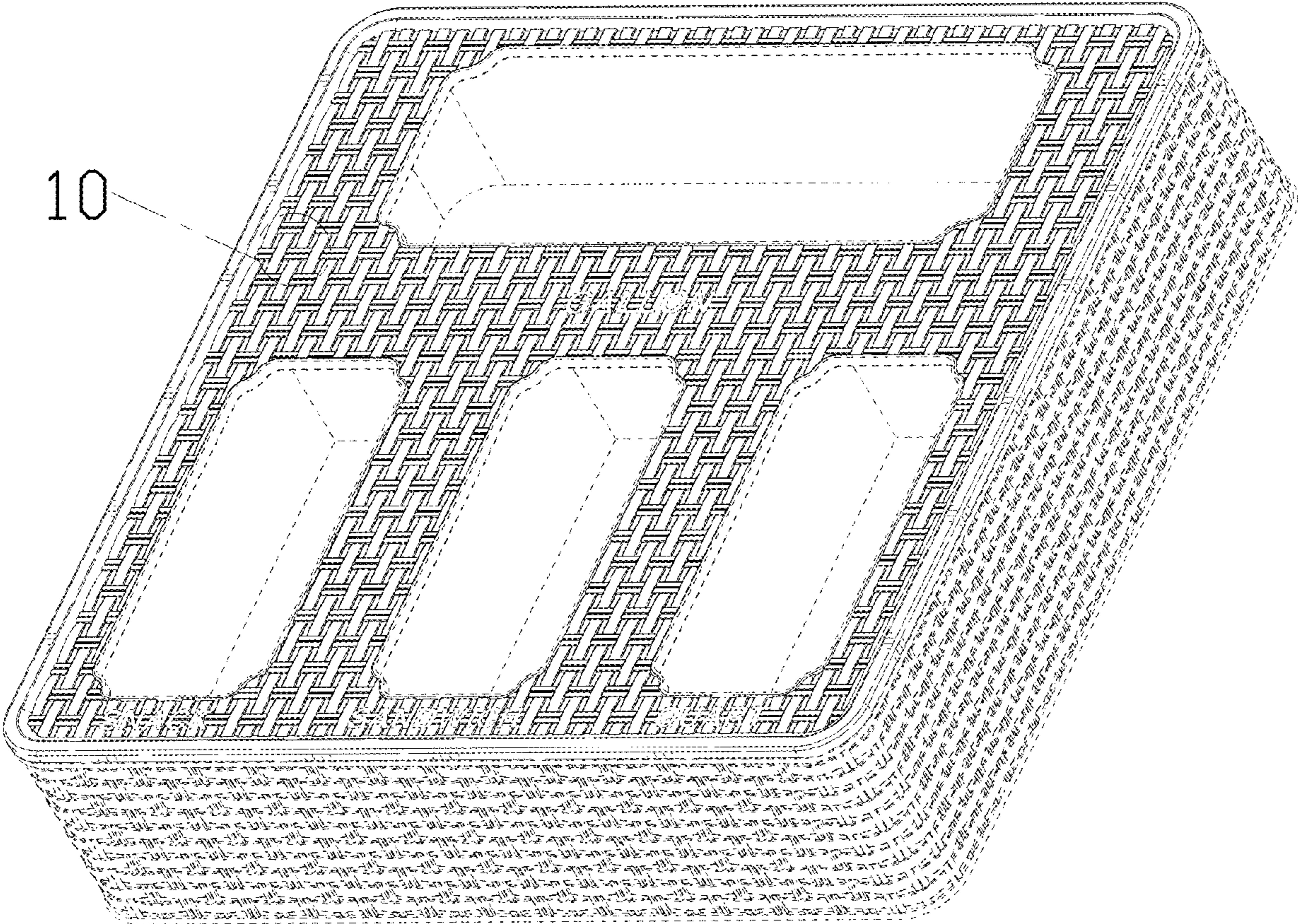

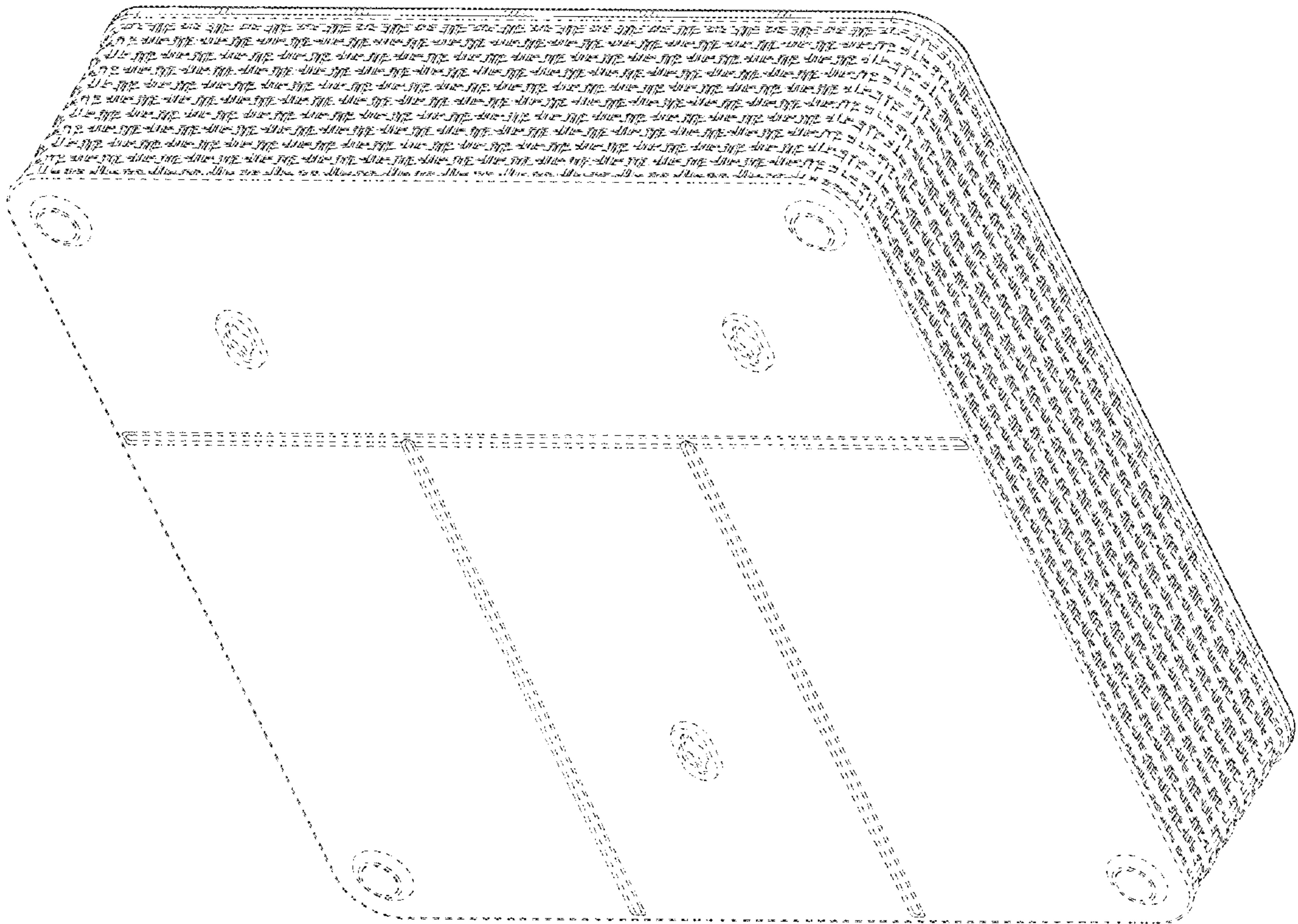

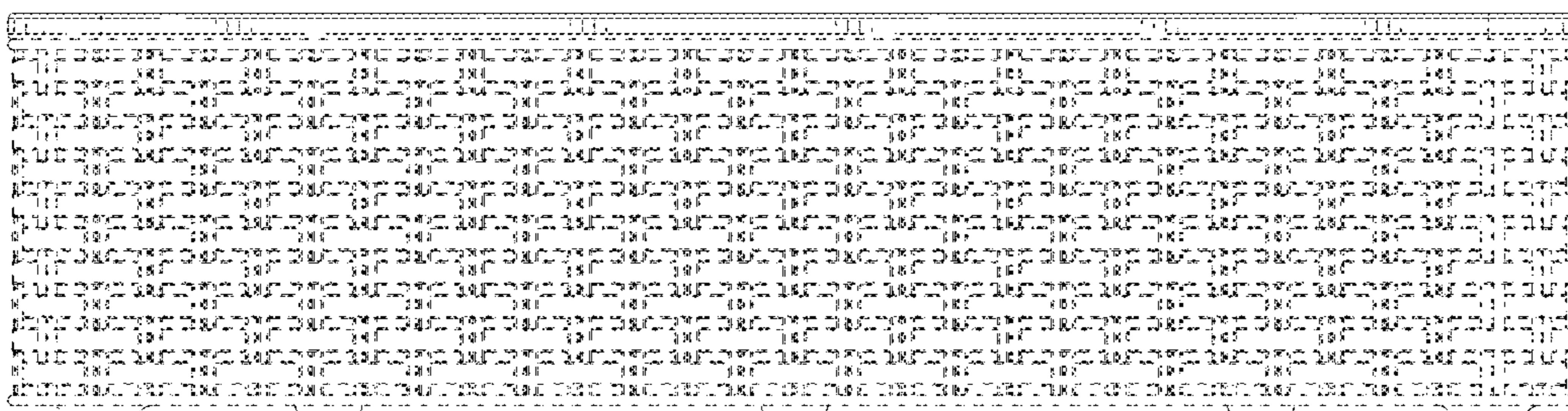

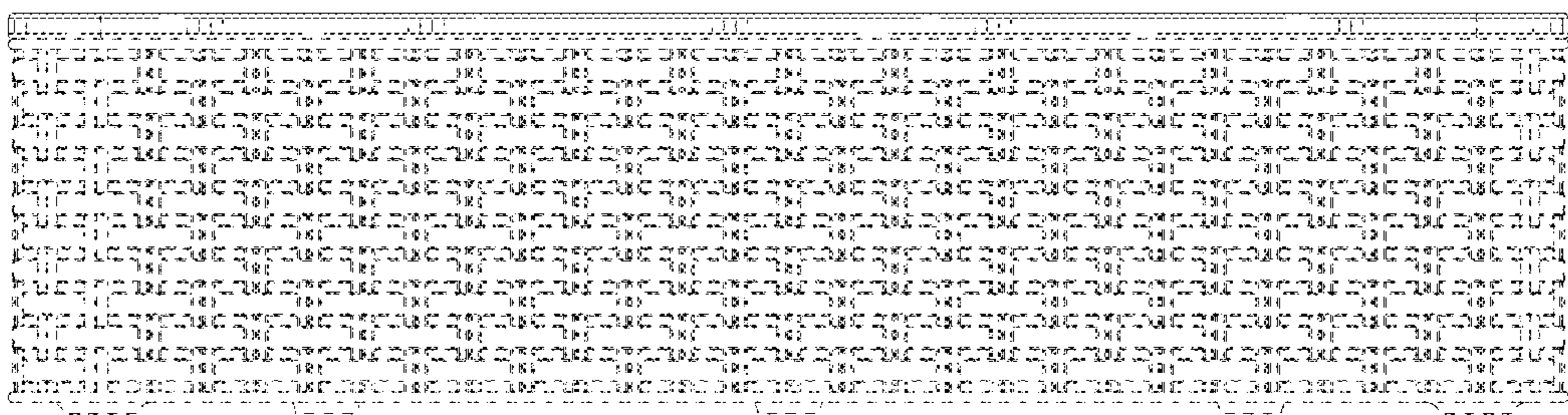

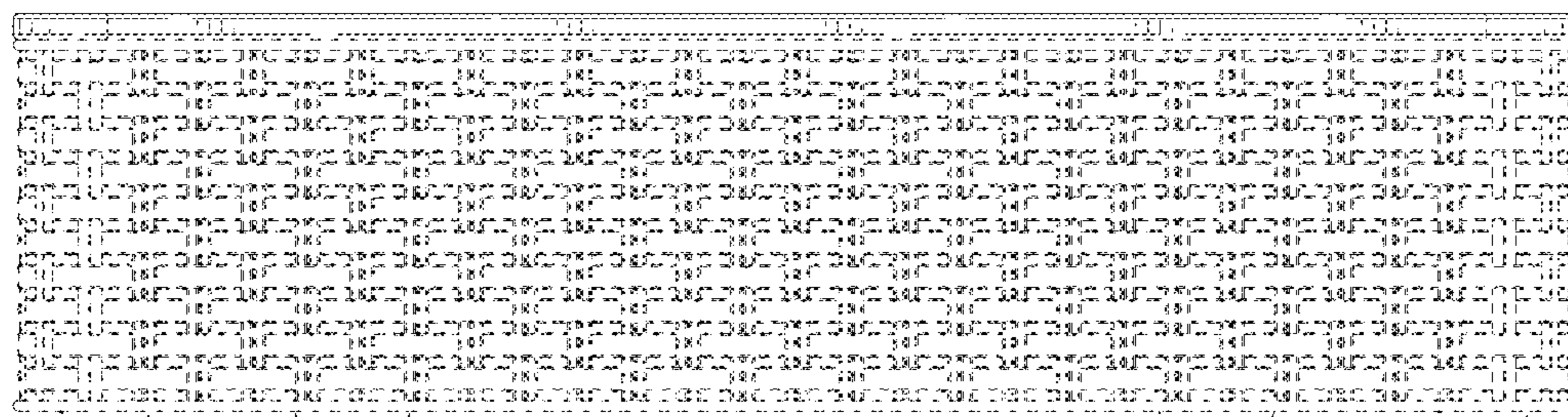

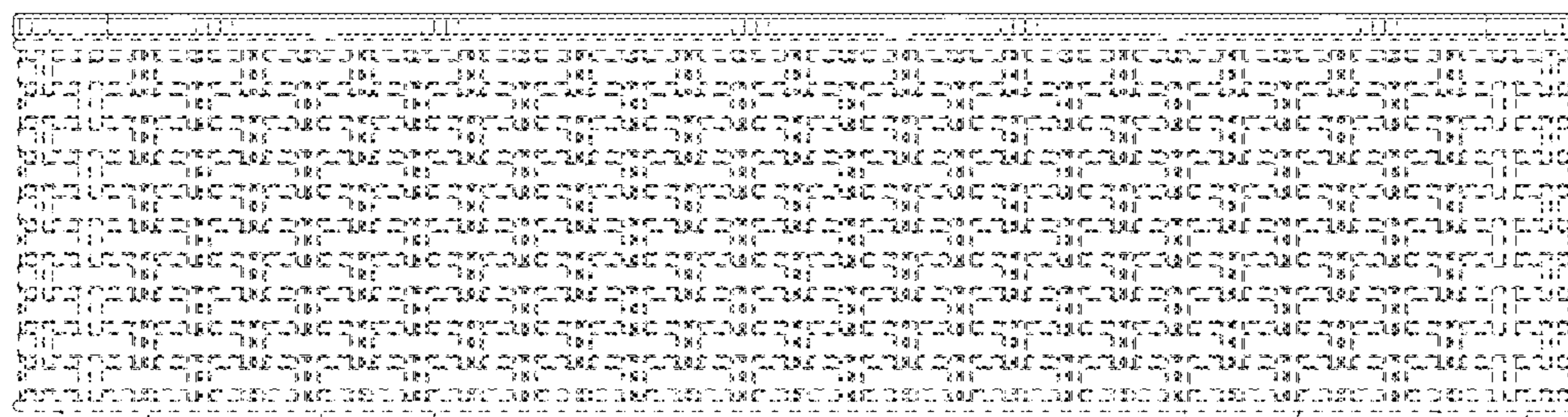

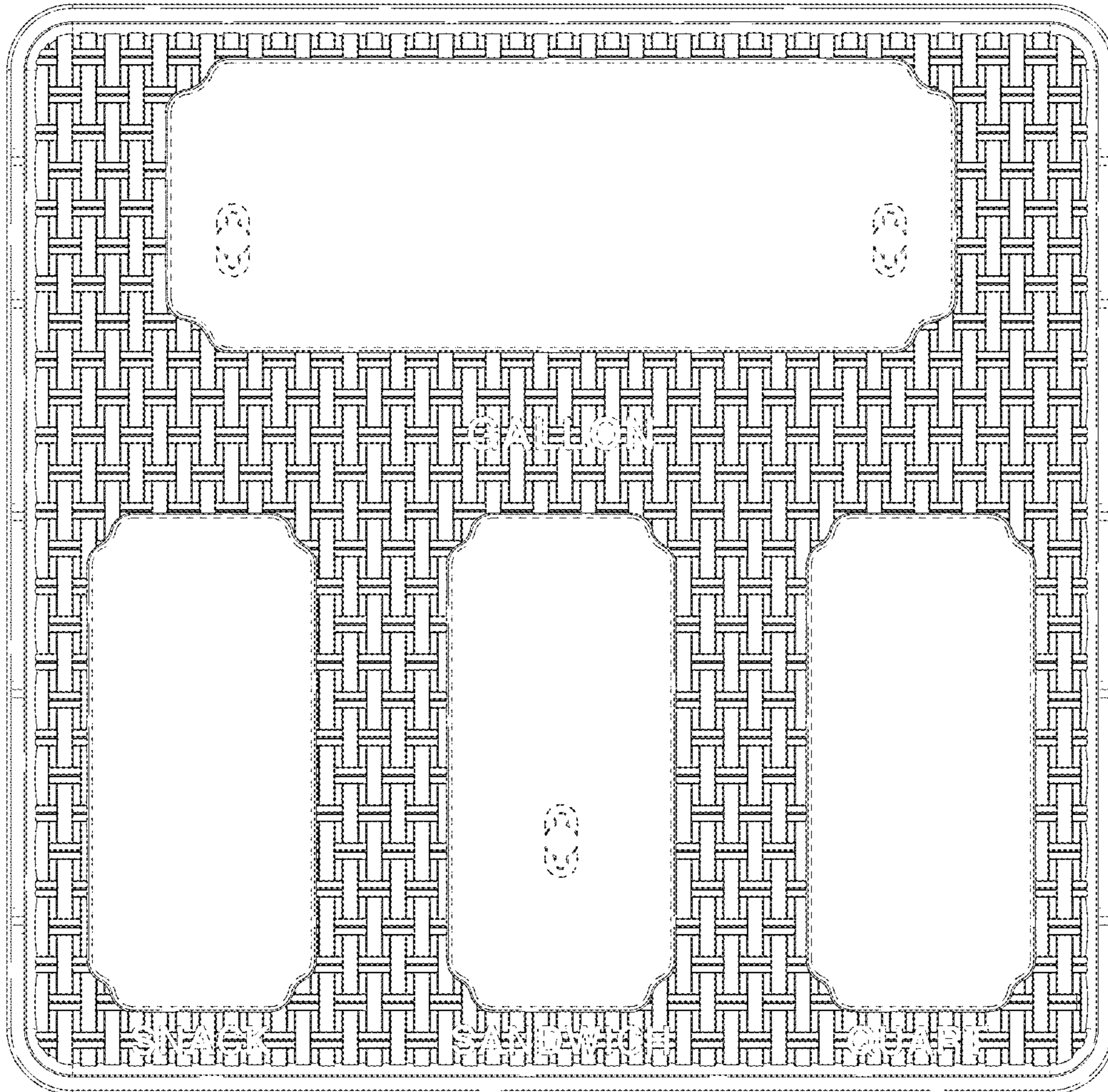

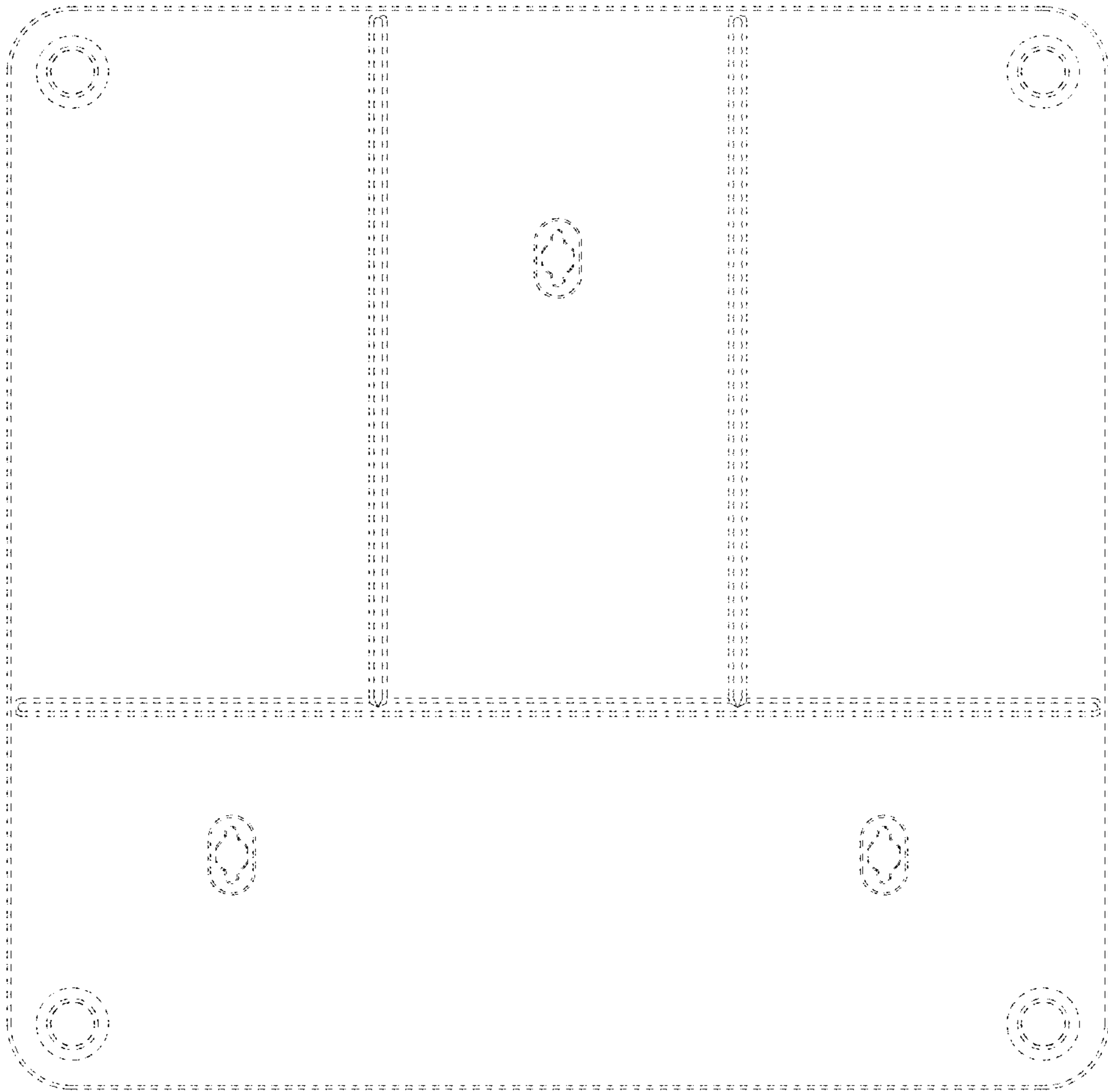

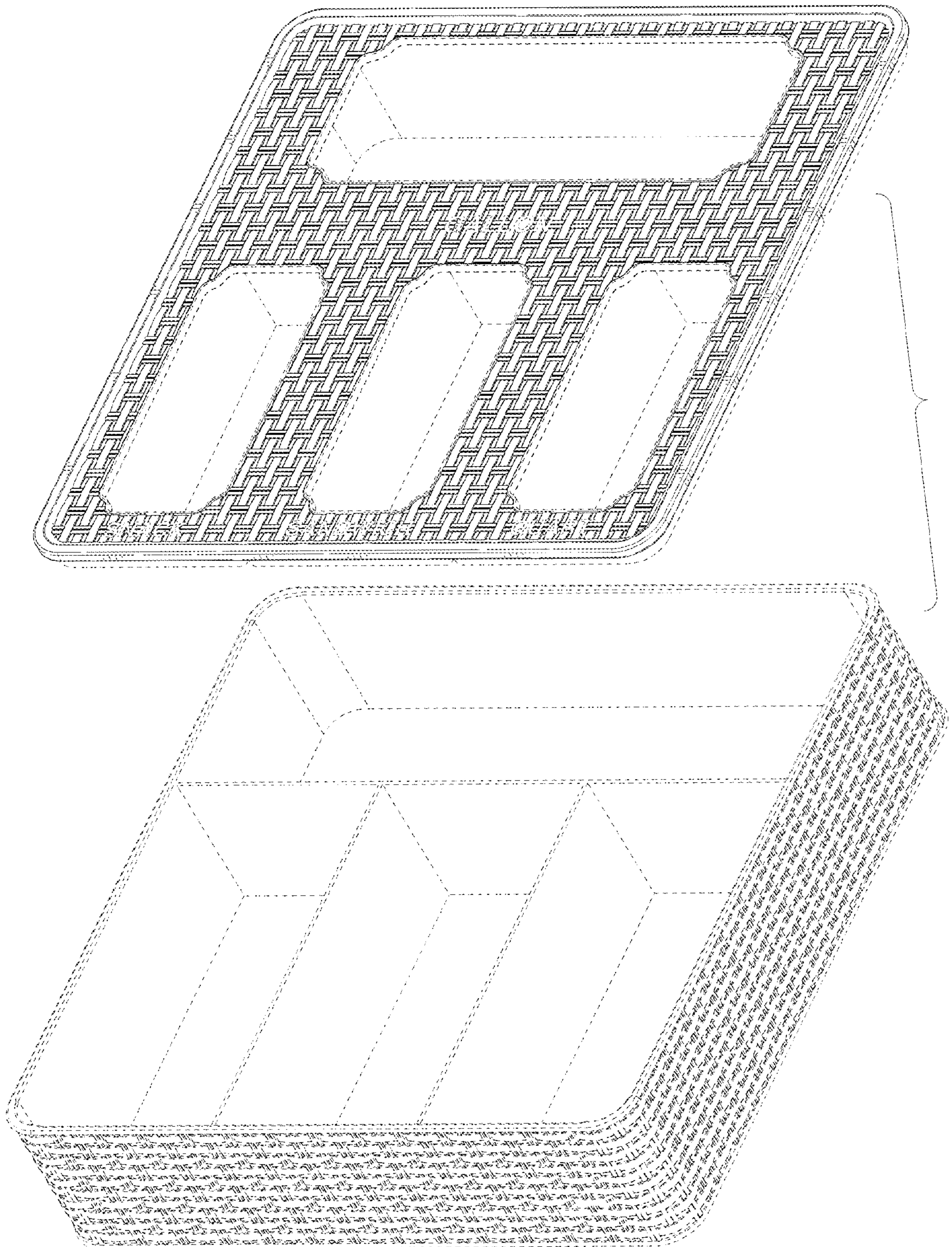

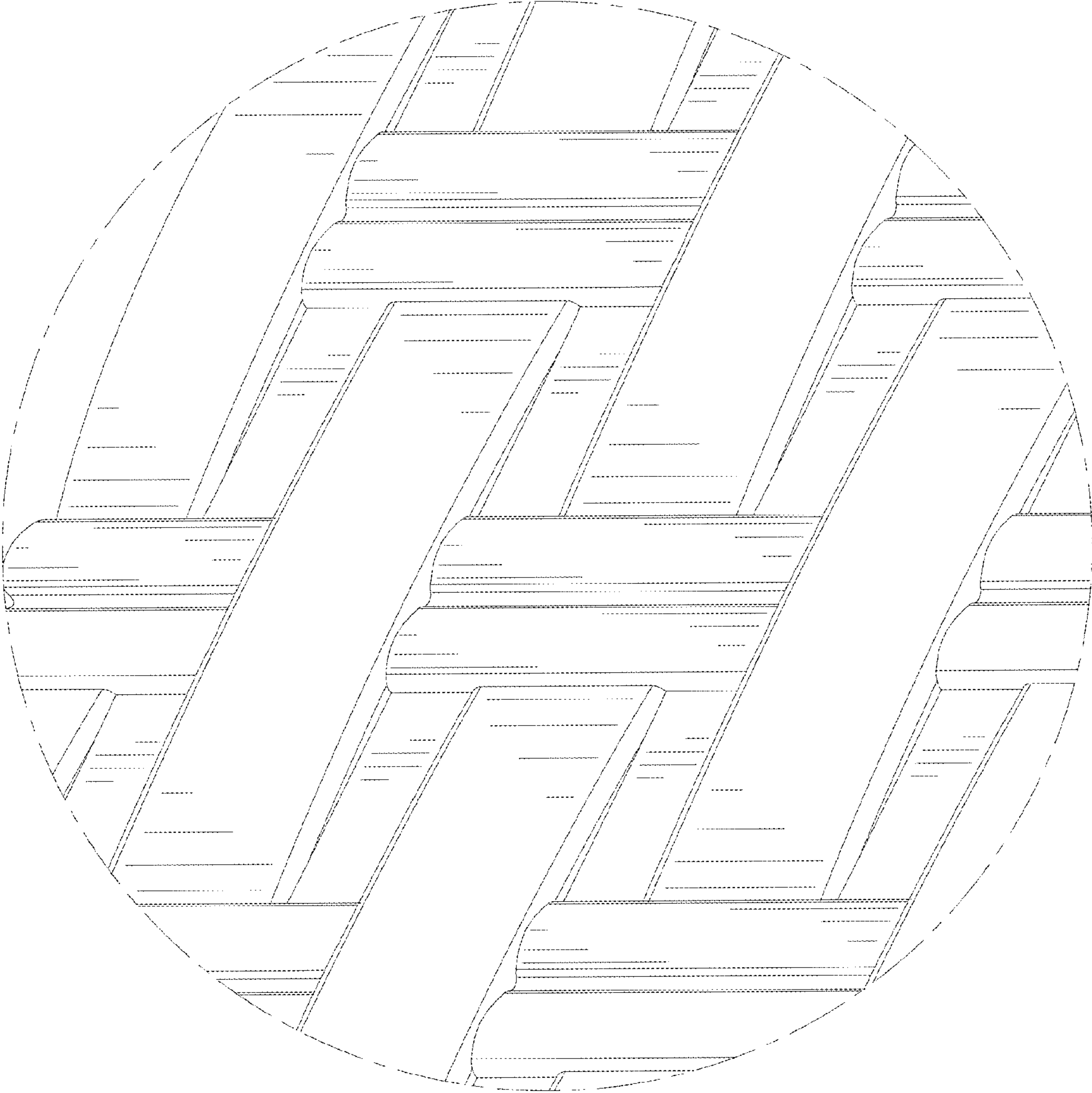
