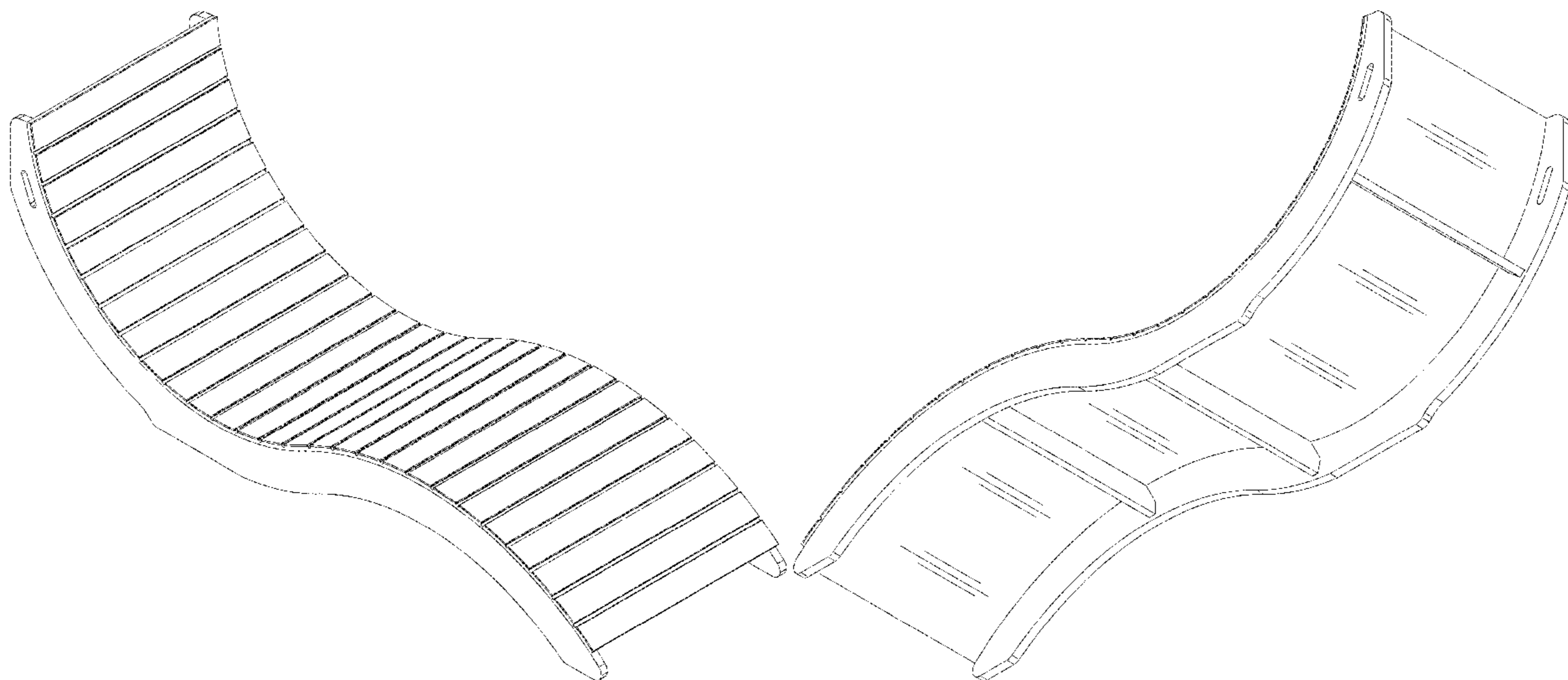
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the chaise lounge.
FIG. 2 is a bottom perspective view of the chaise lounge.

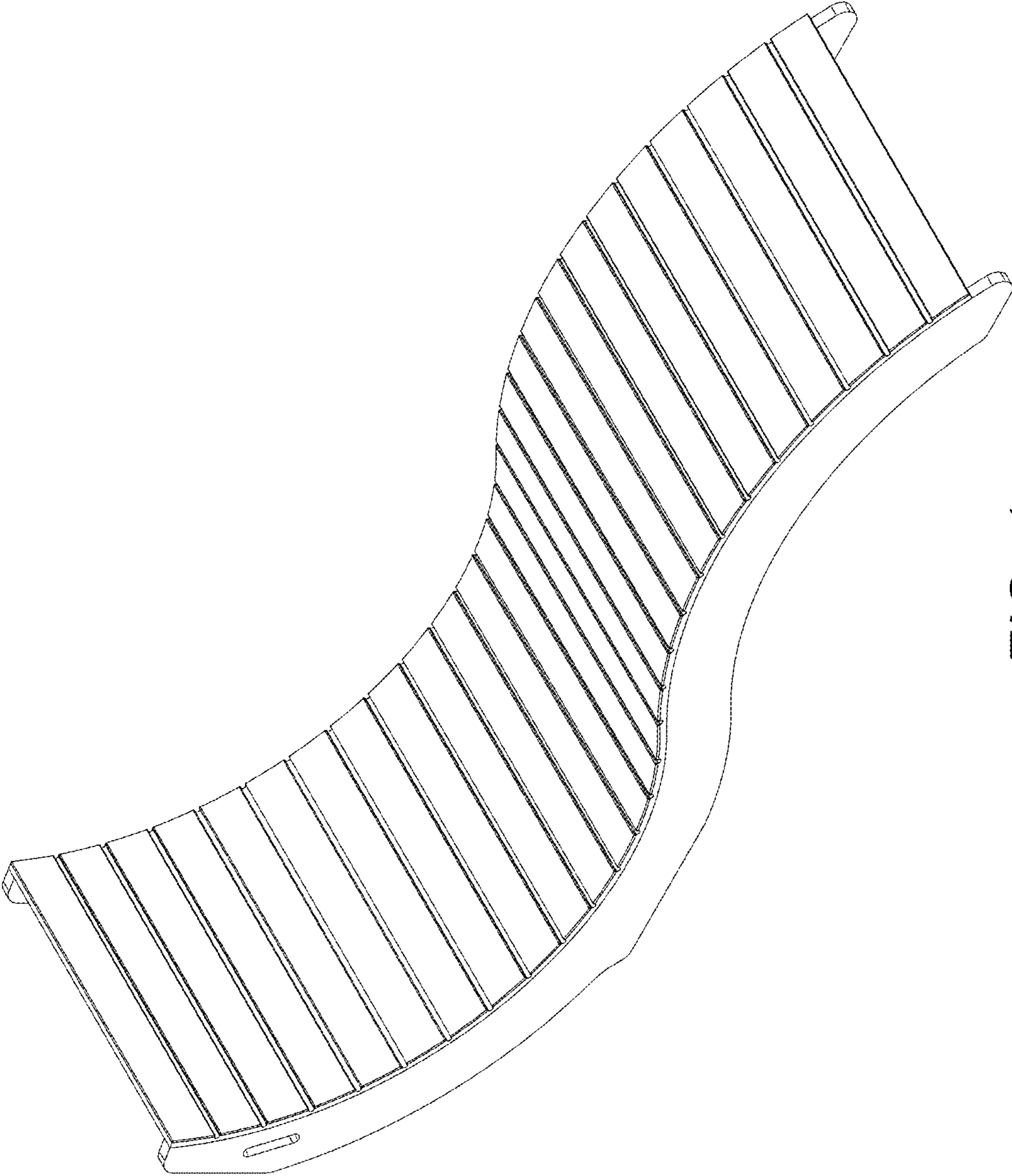

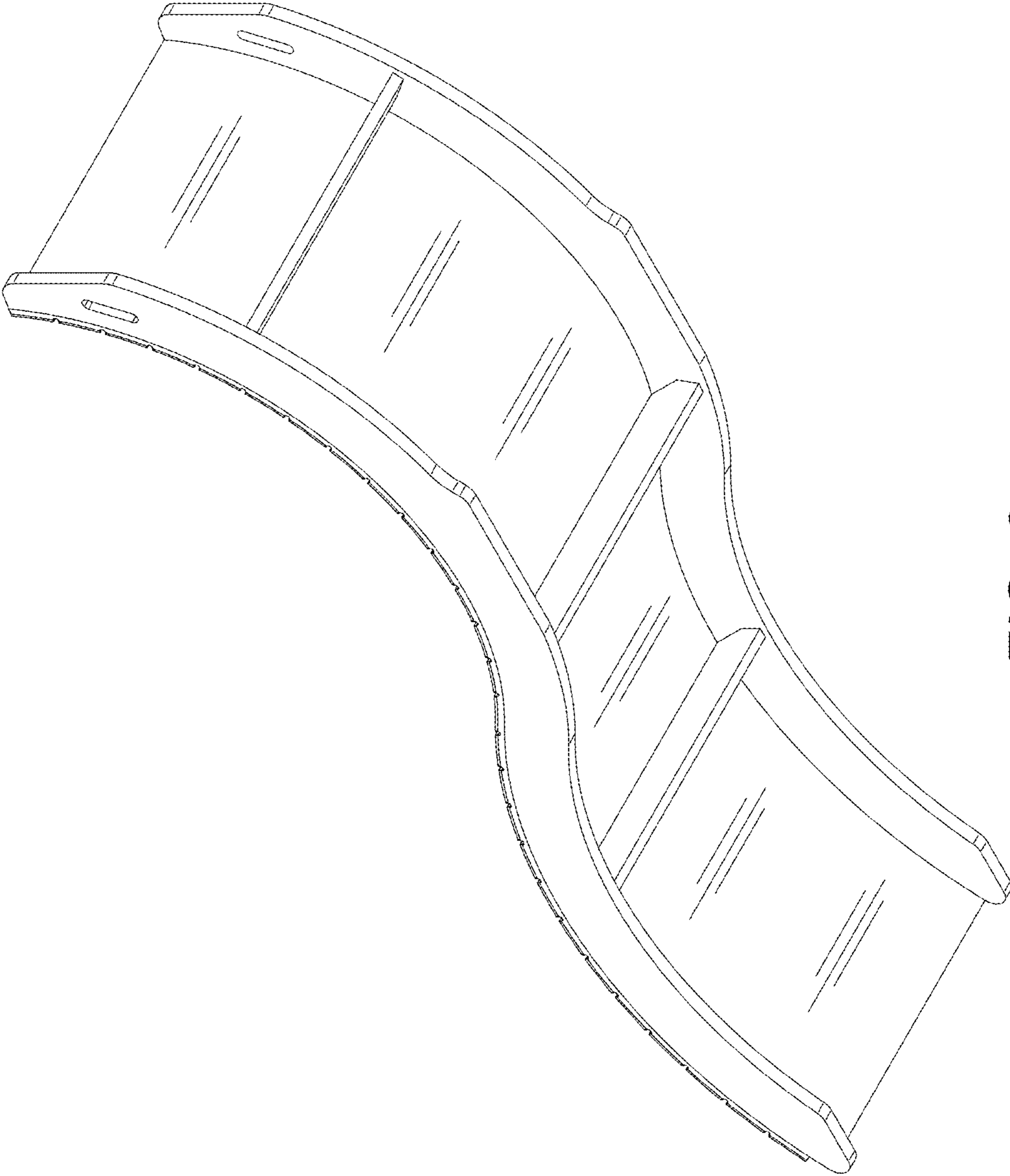

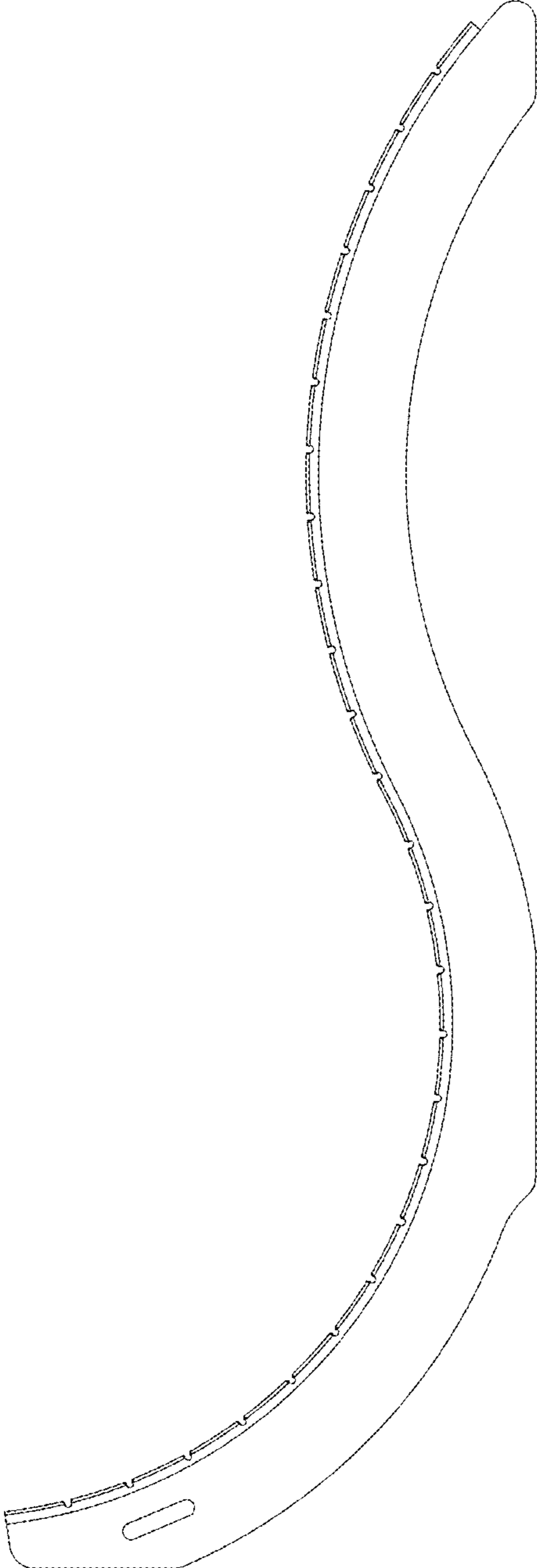

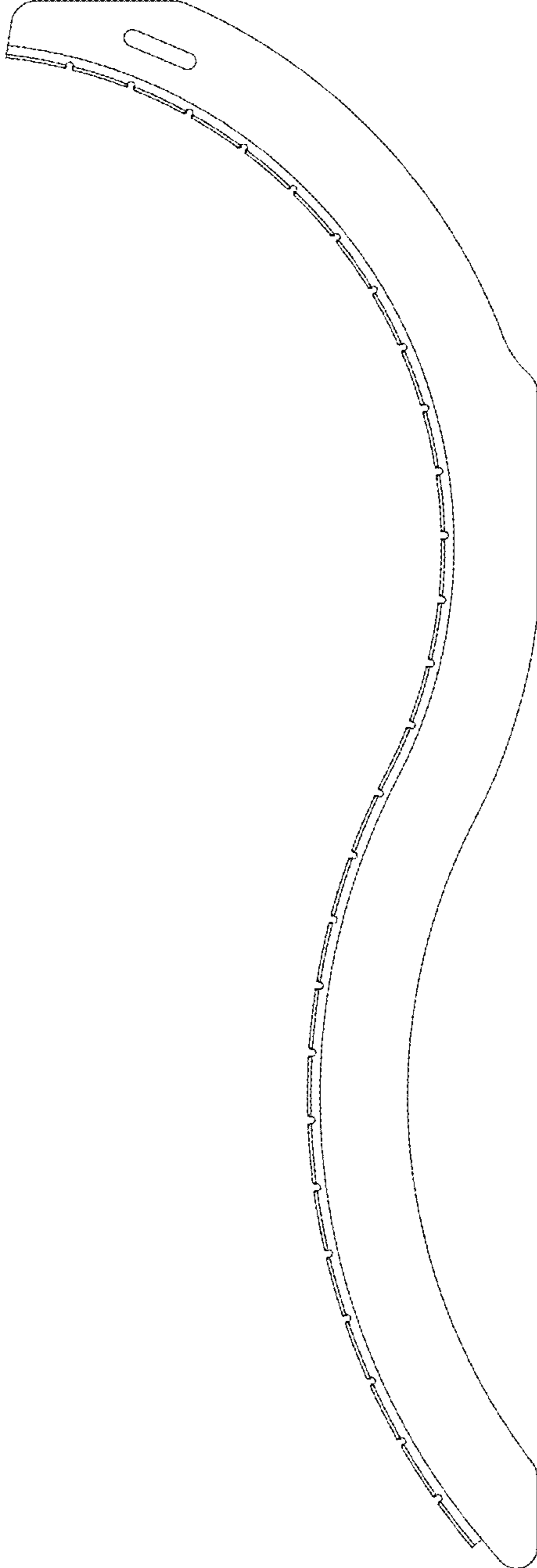

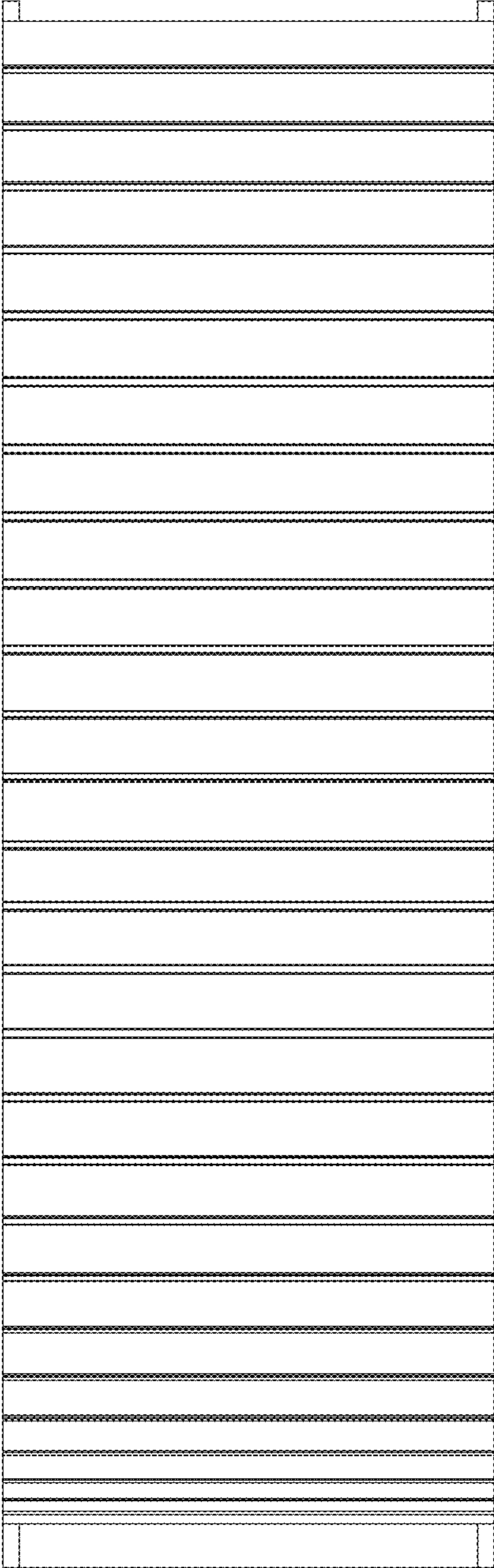

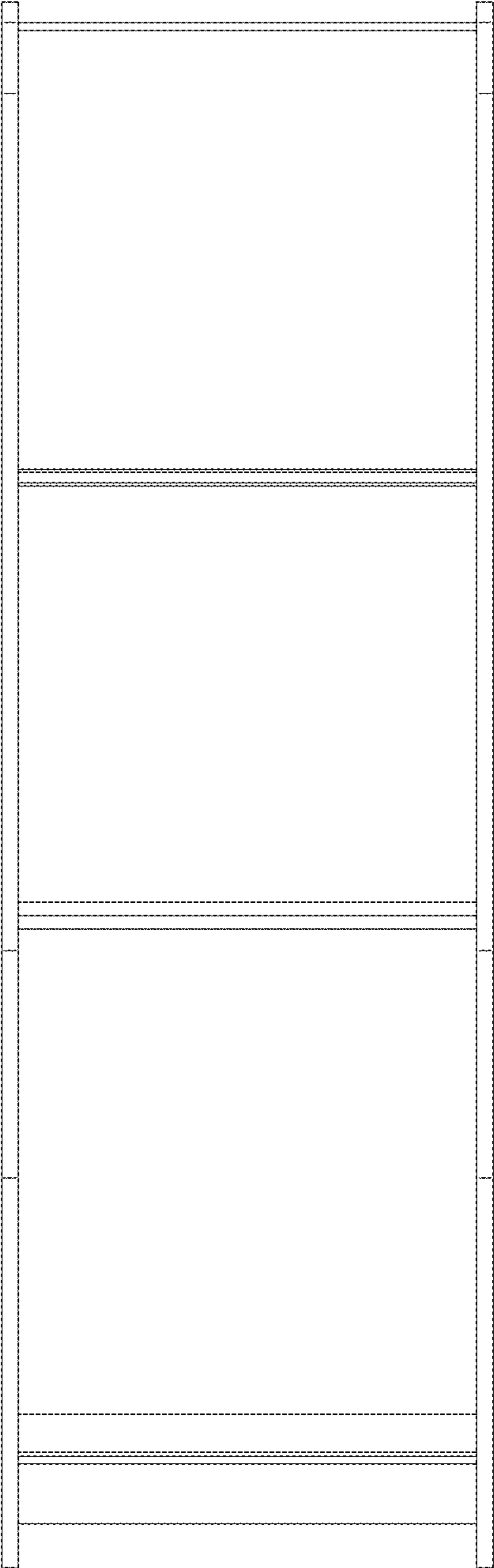

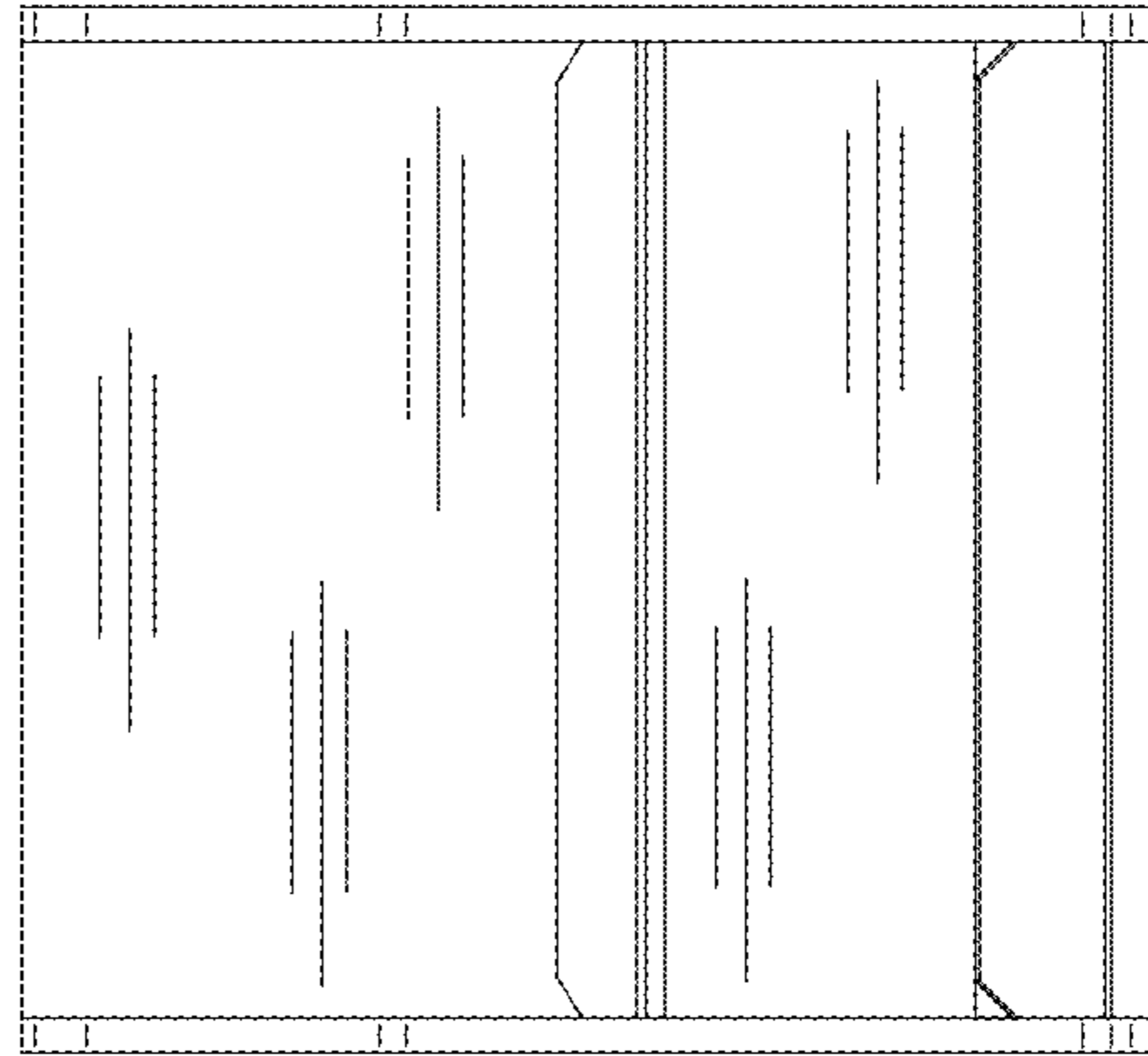

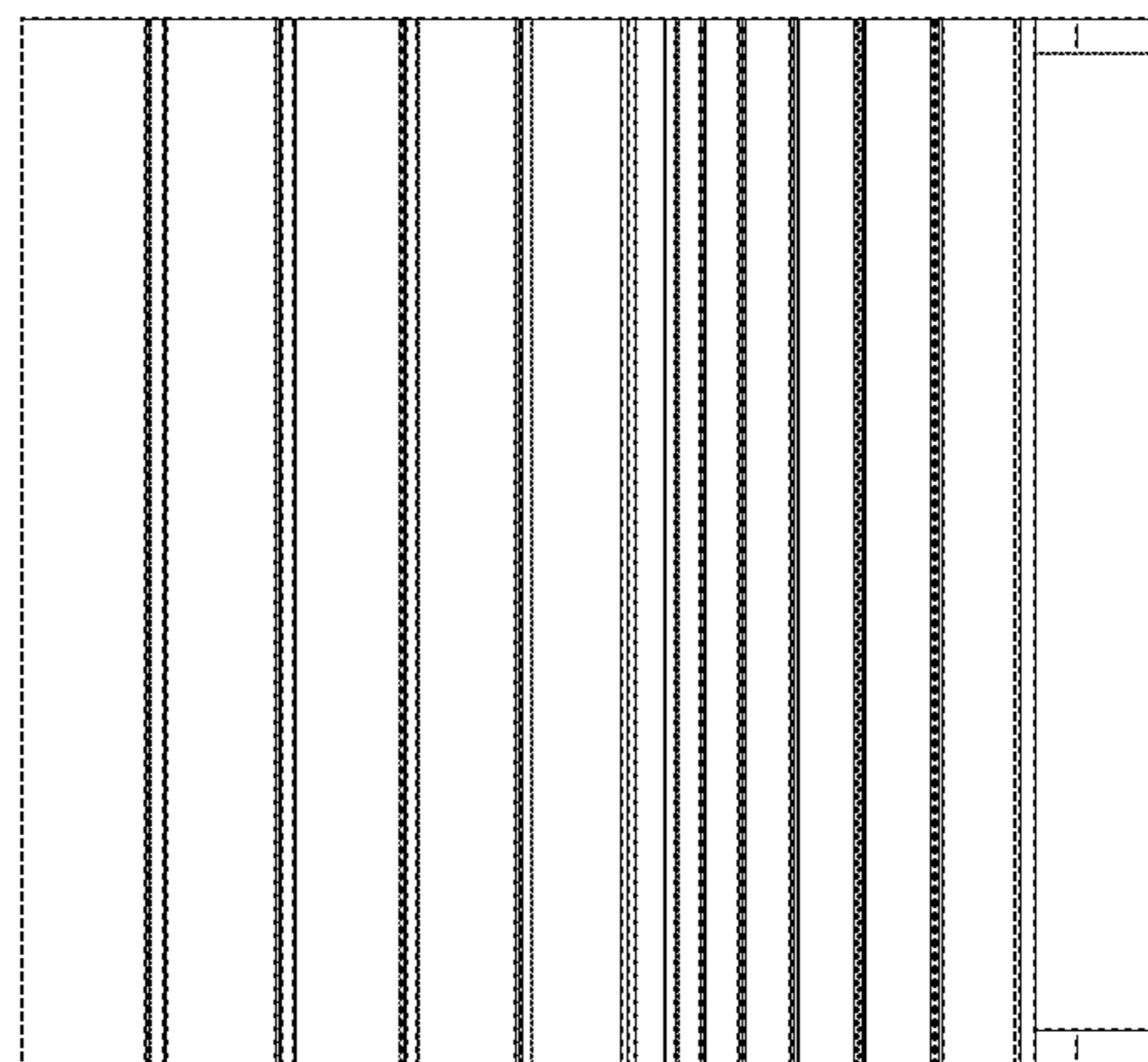
