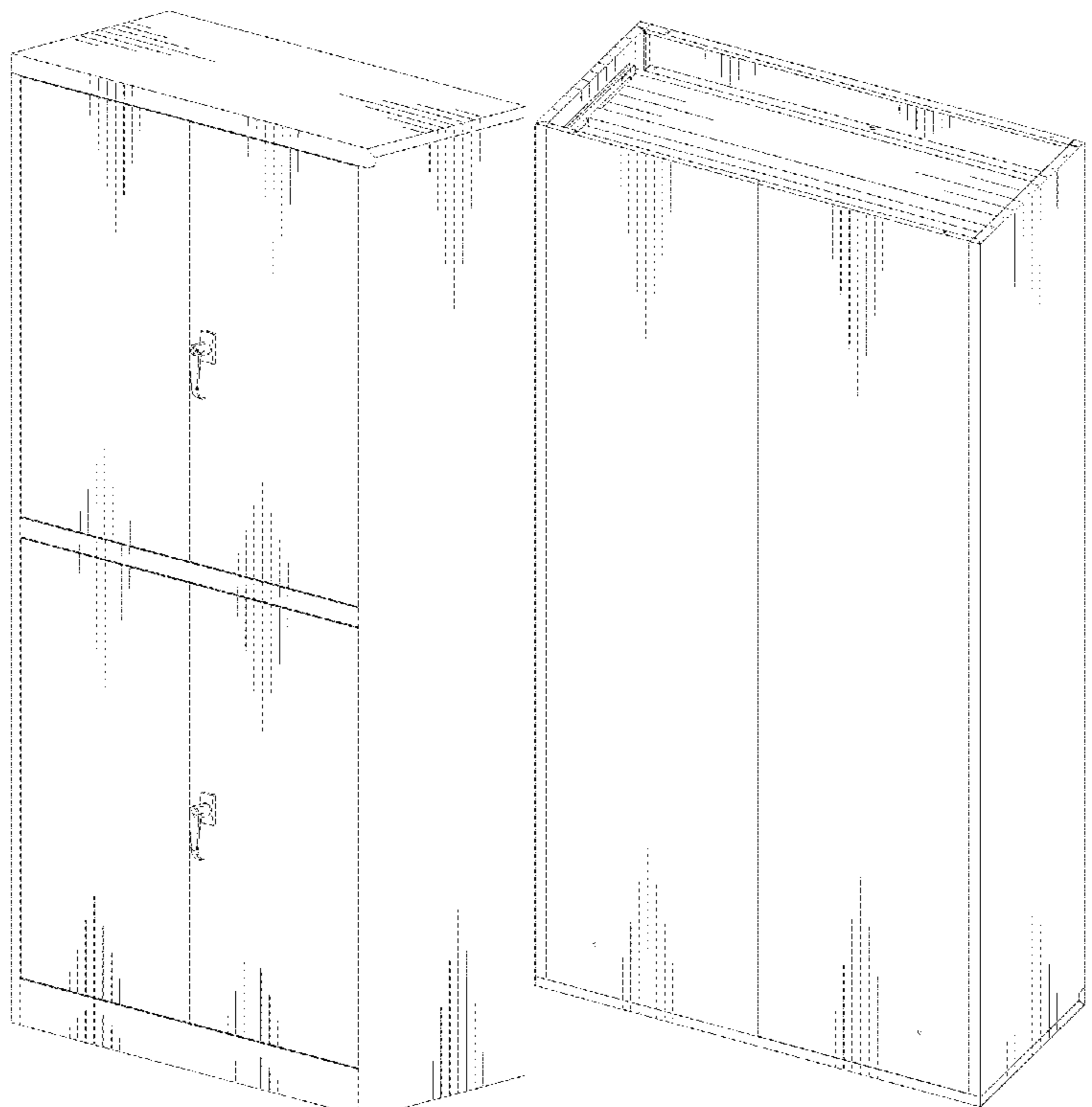
The ornamental design for a file cabinet, as shown and described.

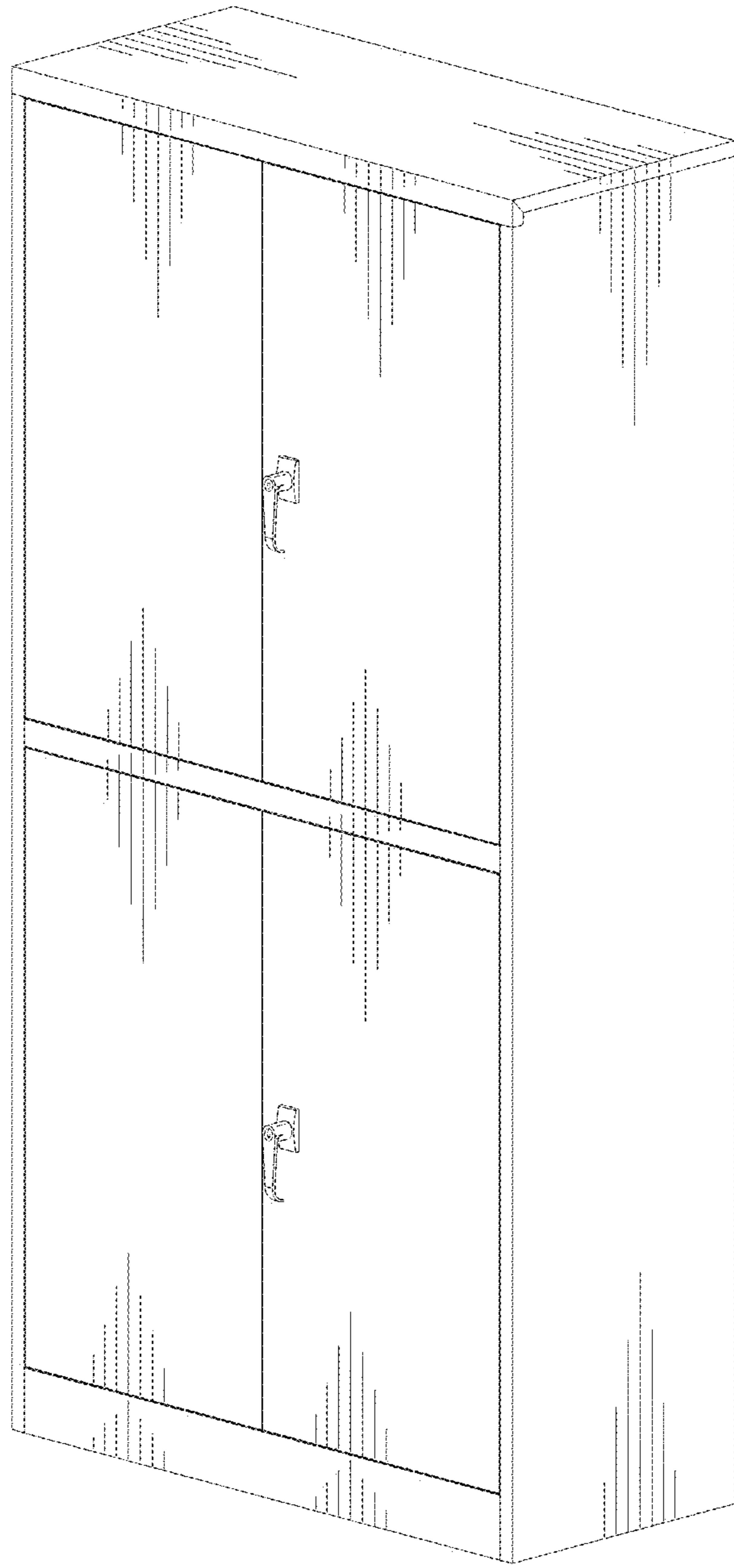

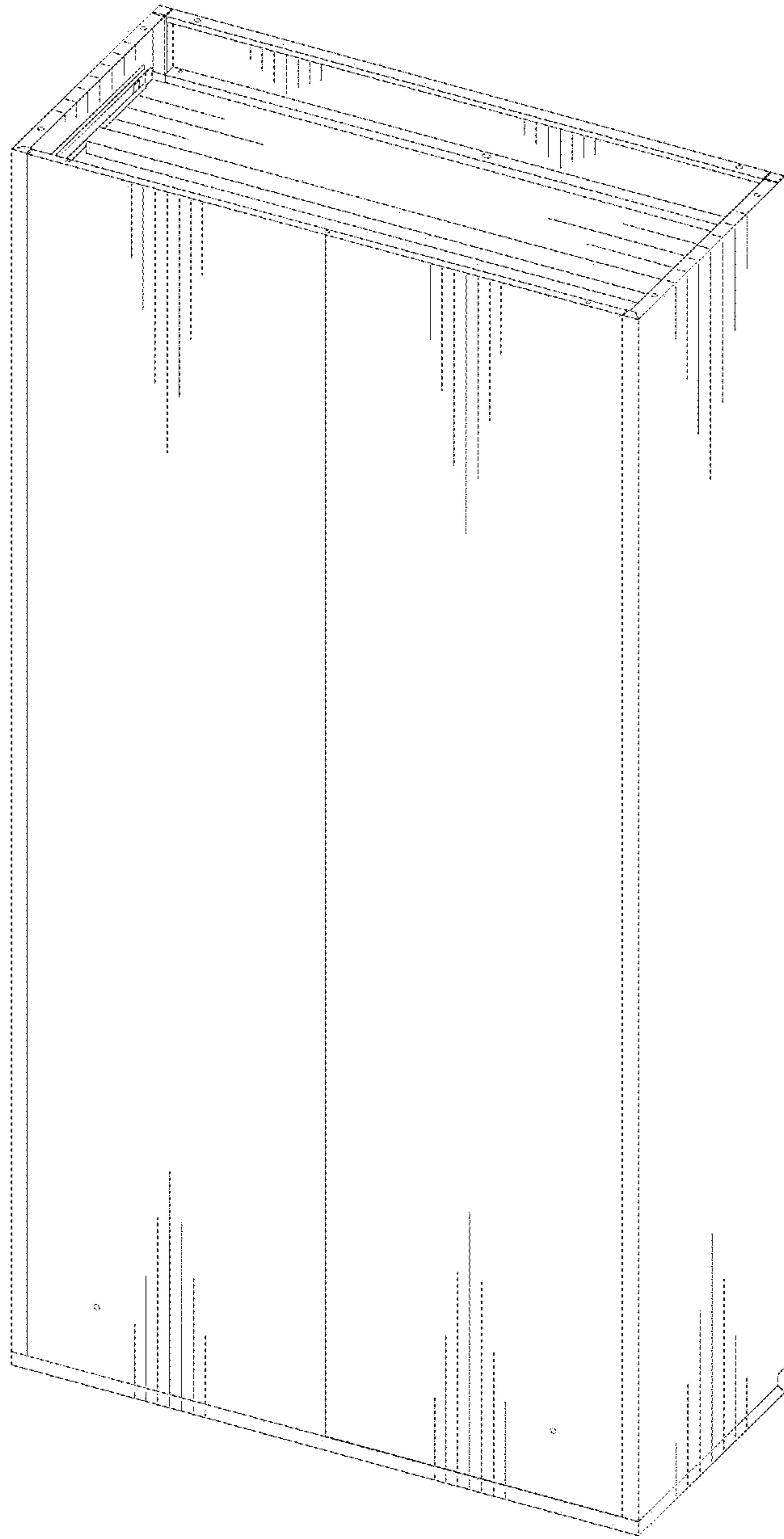

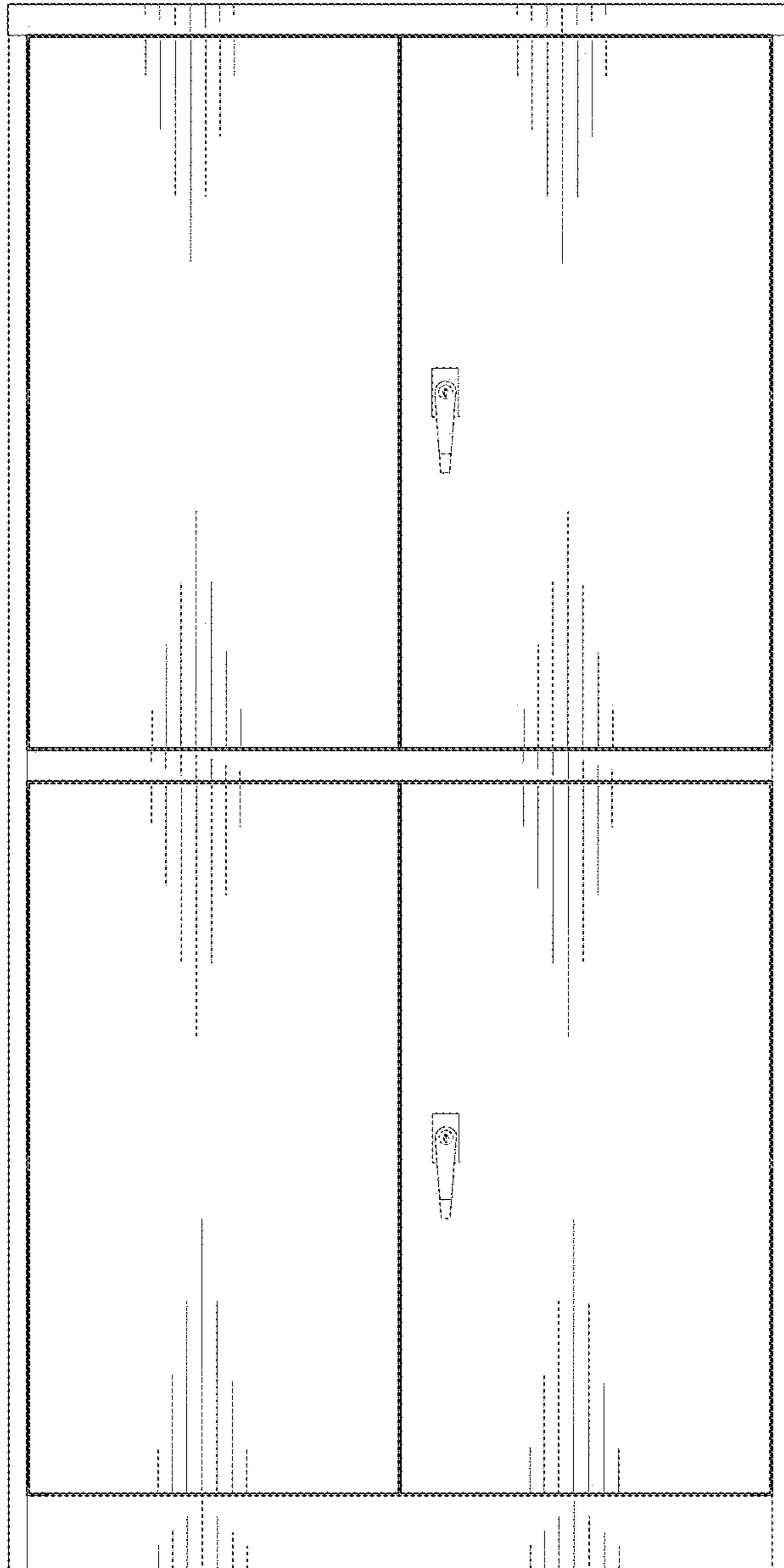

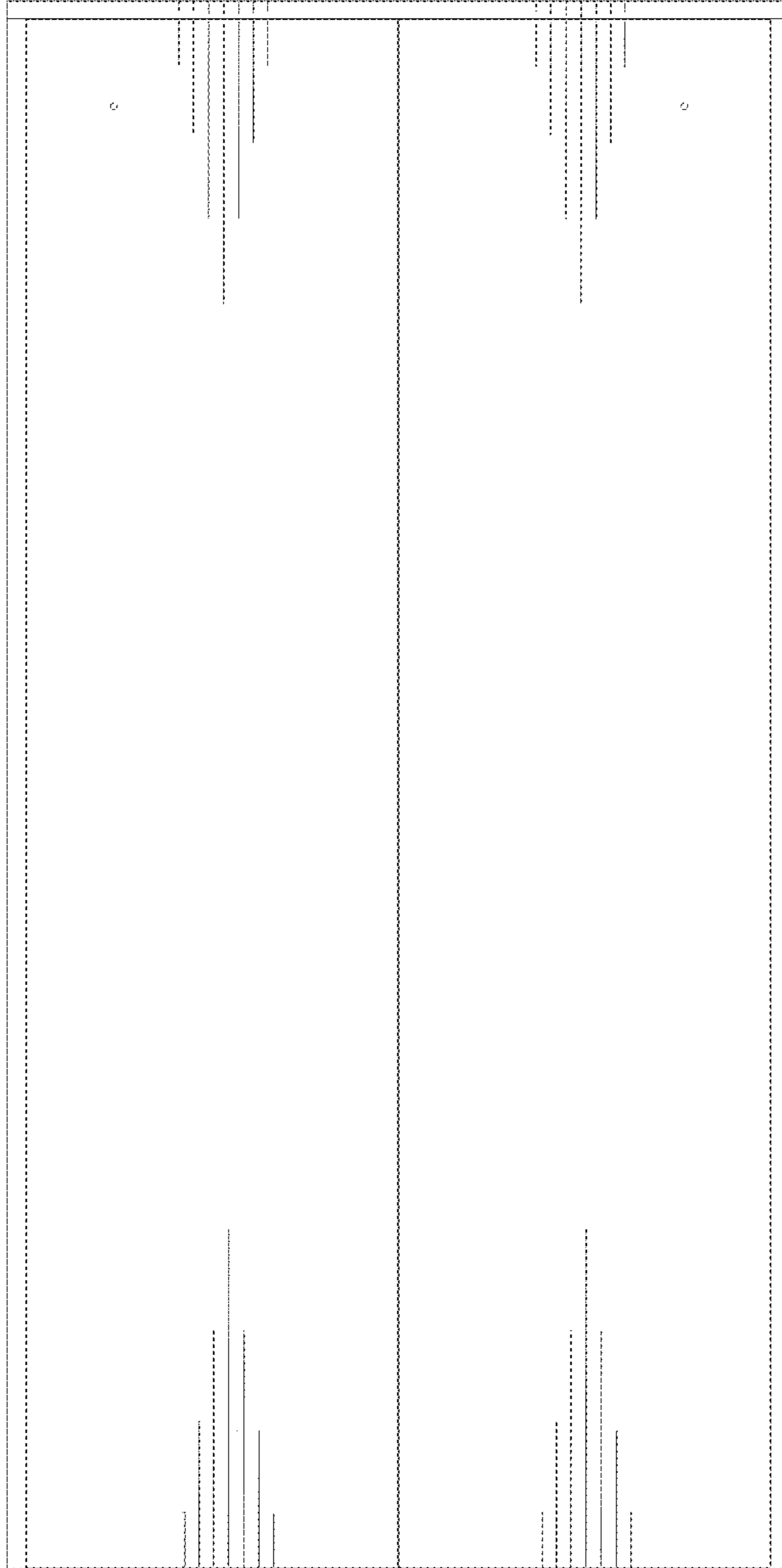

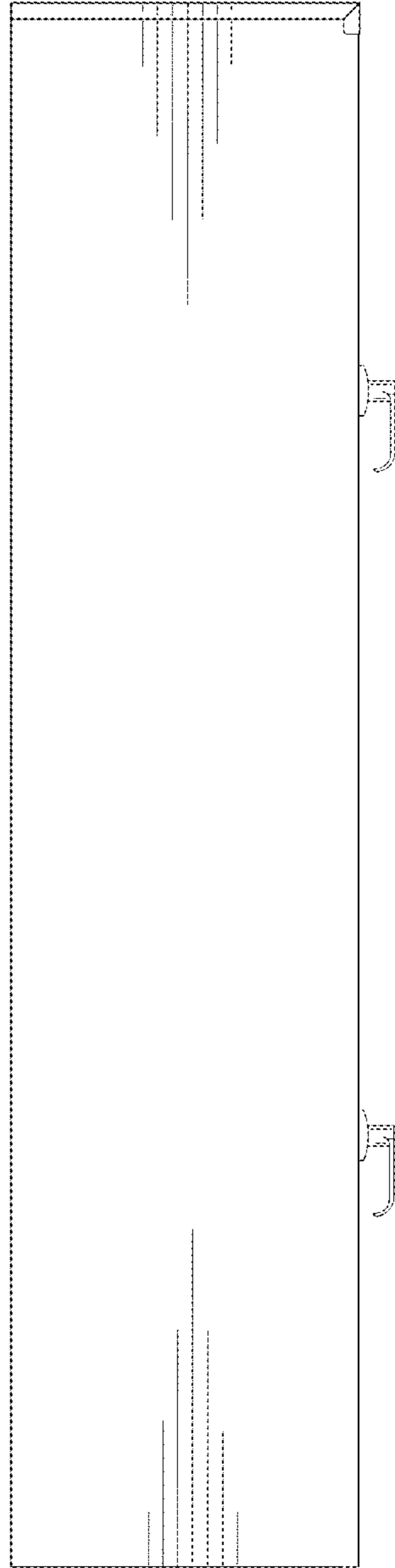

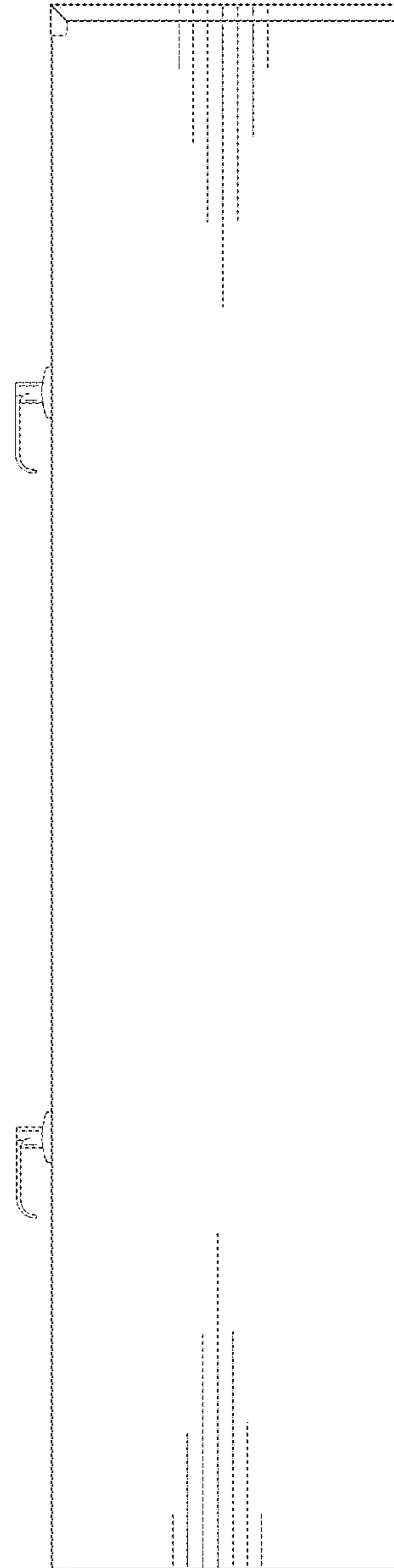

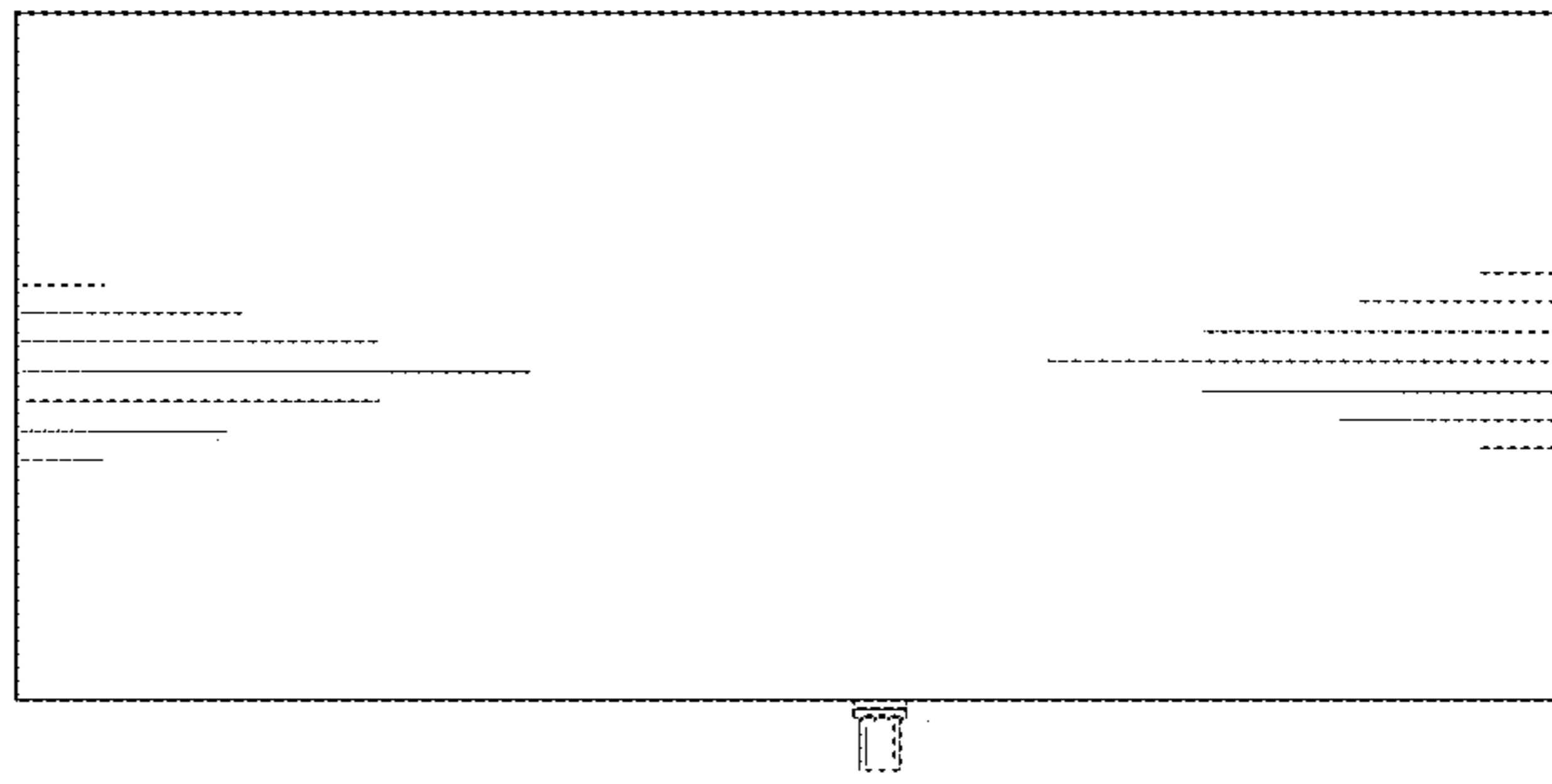

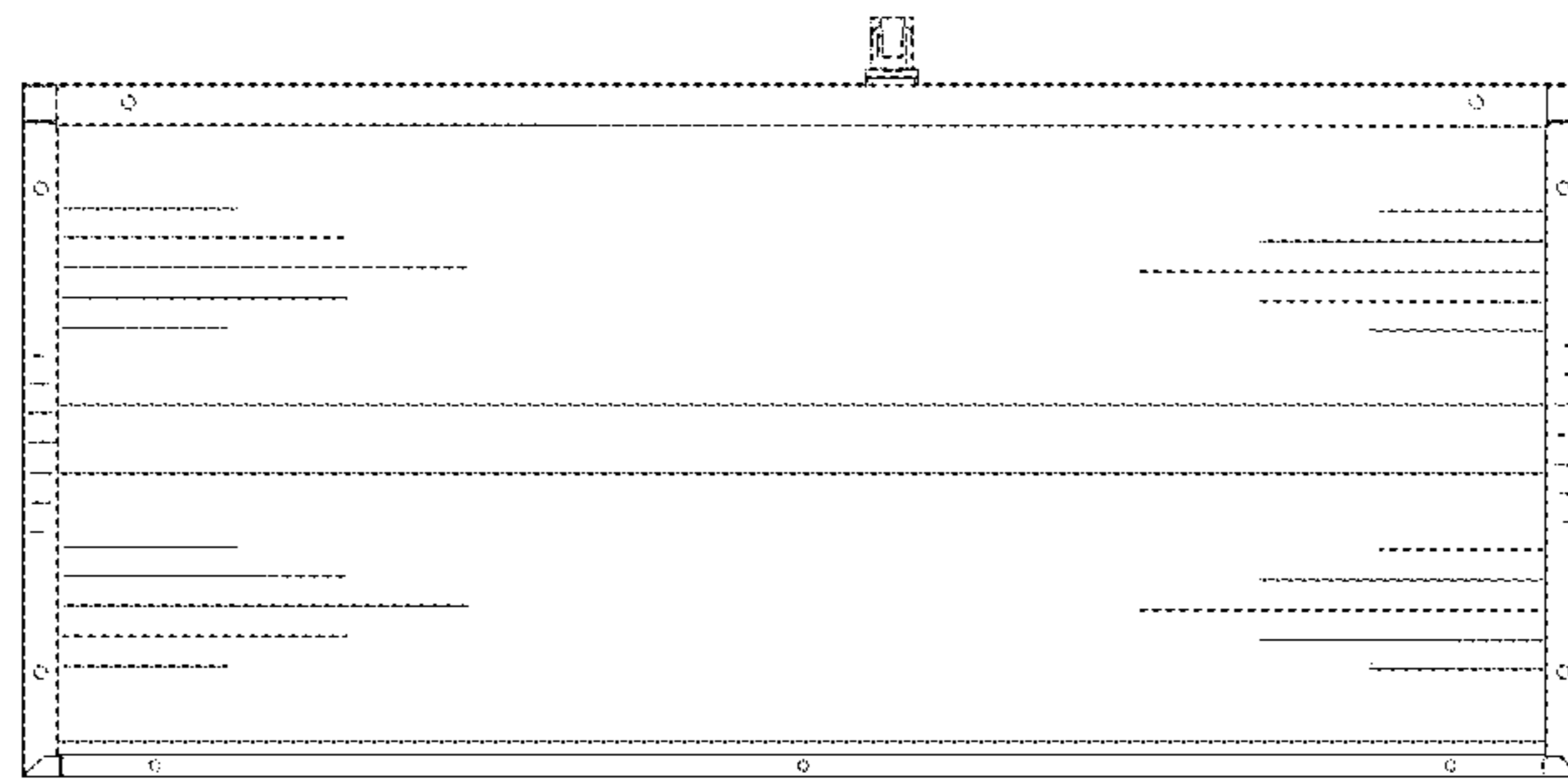
