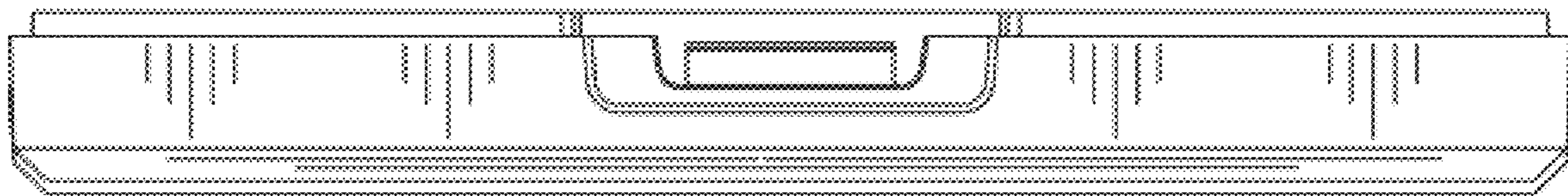

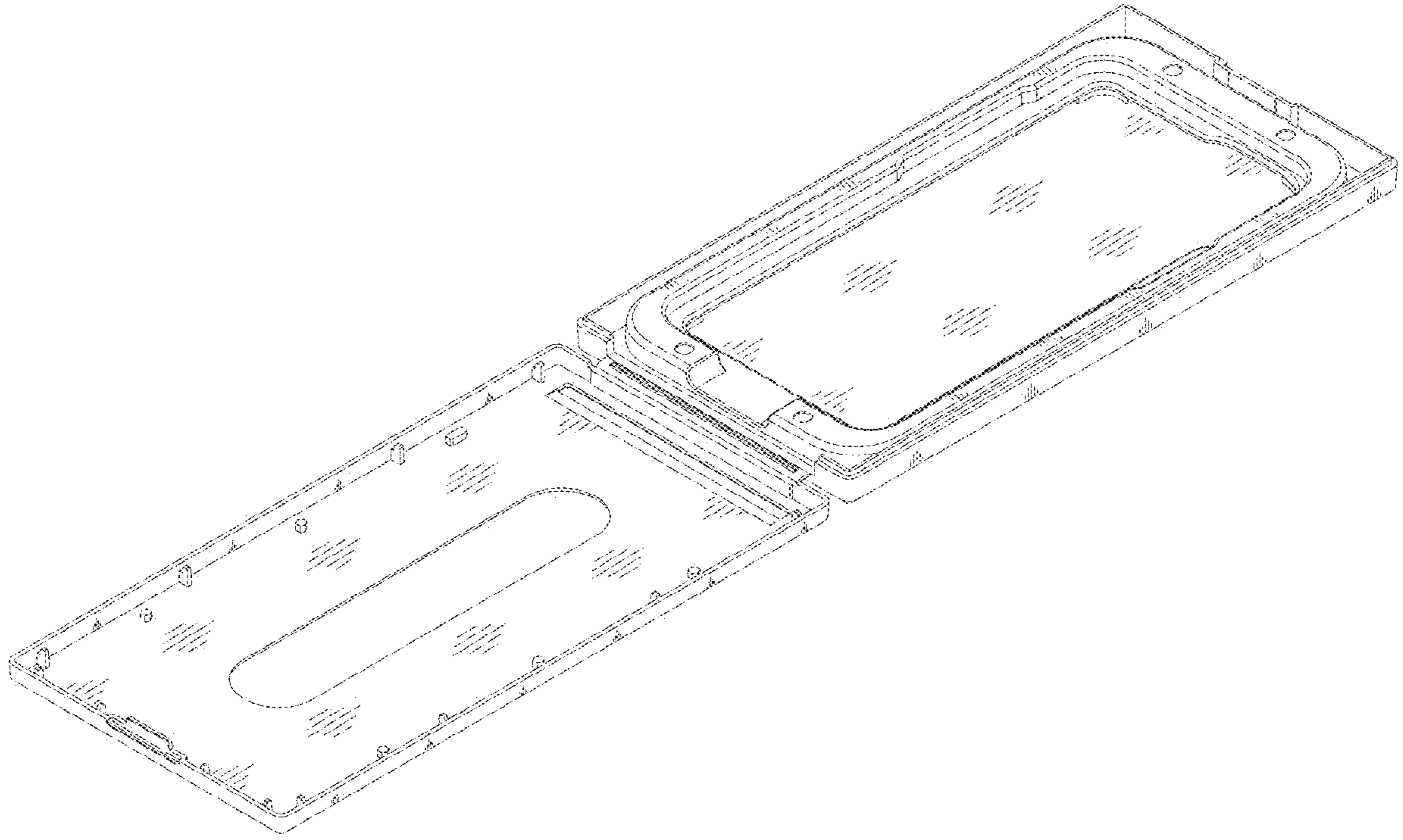
The ornamental design for a film applicator, substantially as shown and described.

**DESCRIPTION**

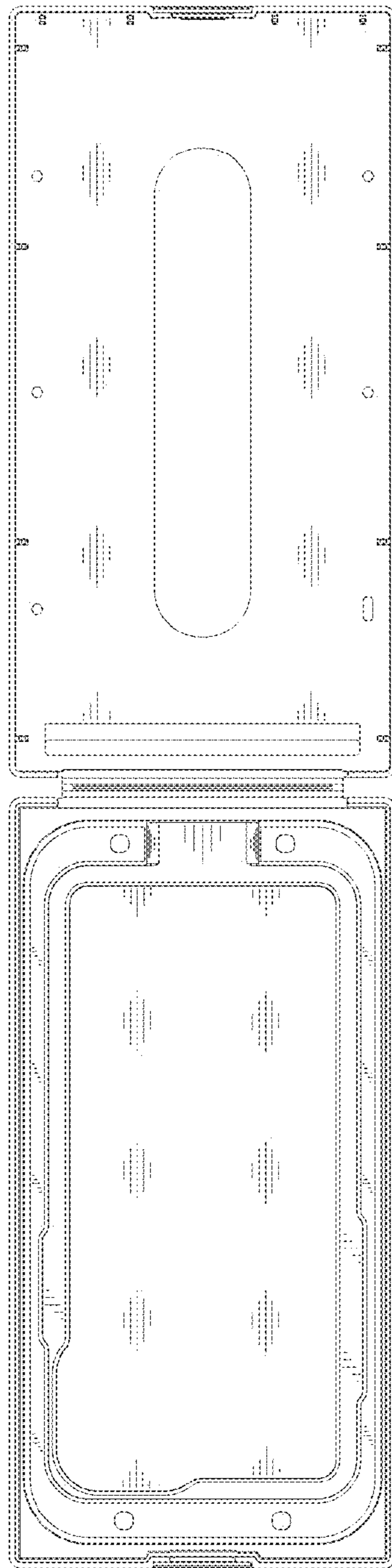
FIG. 1 is a bottom, front and right side perspective view of a film applicator, showing my new design;

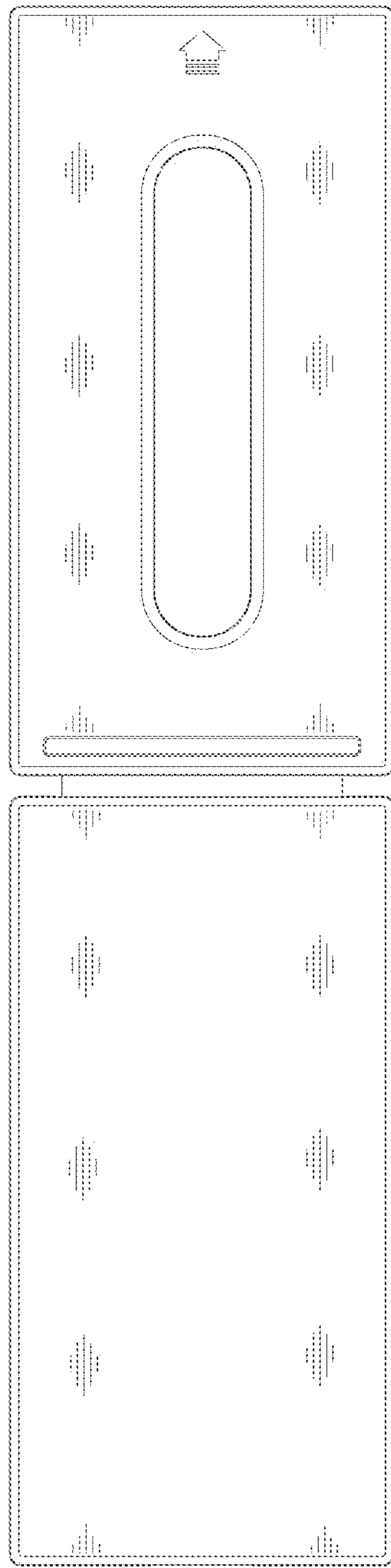

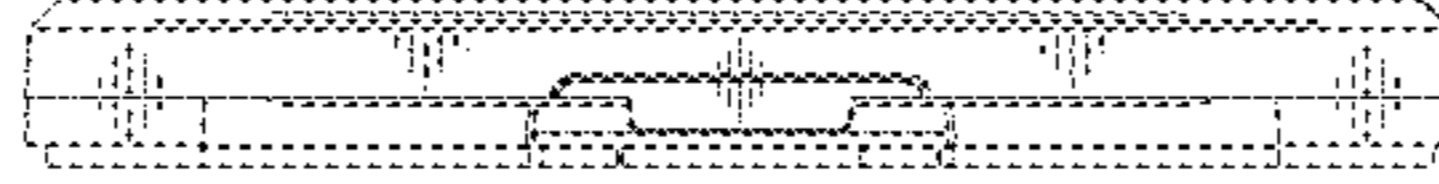
