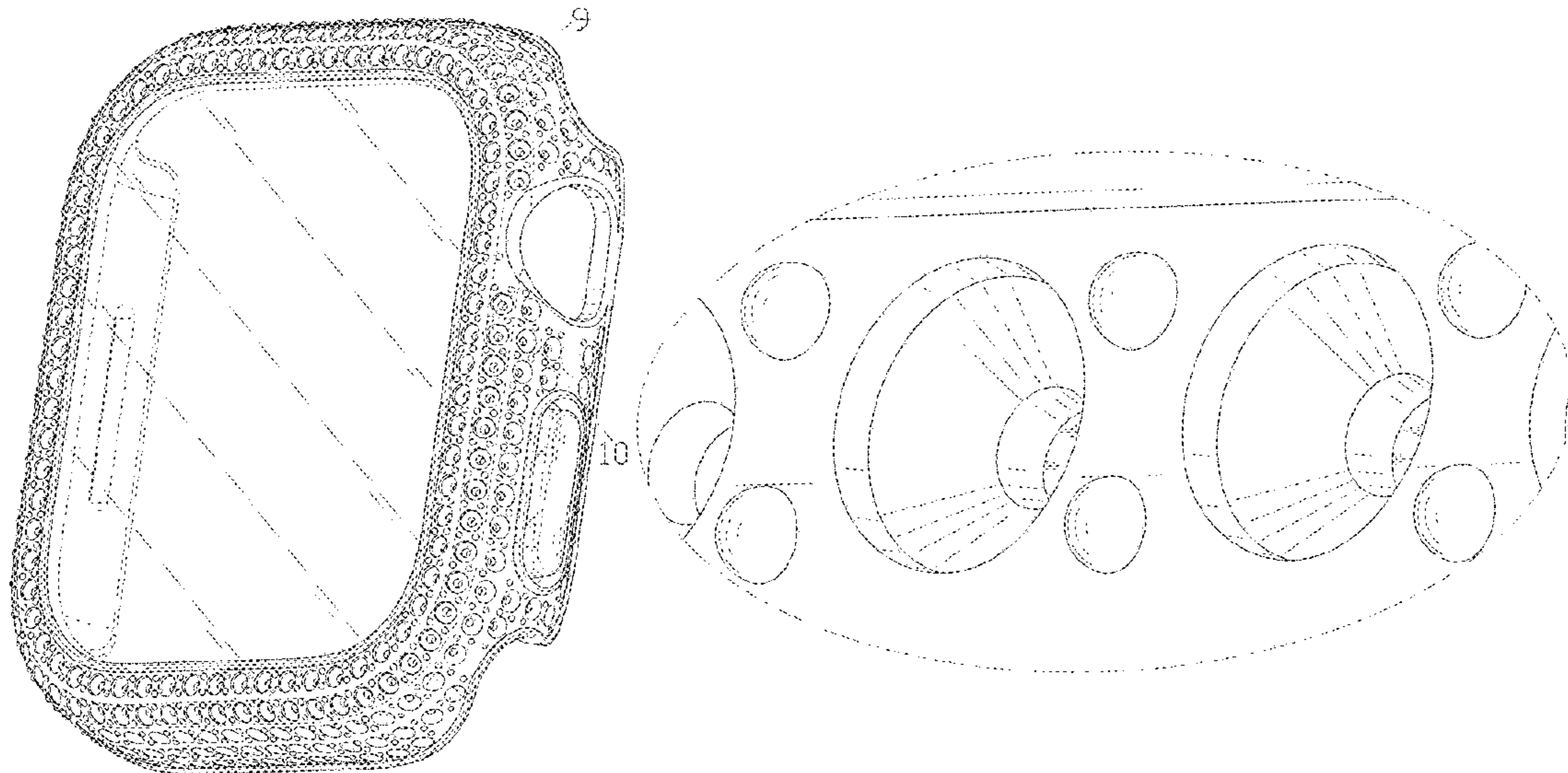
(57) **CLAIM**

The ornamental design for a protective case for a watch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a protective case for a watch showing my new design;
 FIG. 2 is another perspective view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is a bottom plan view thereof;
 FIG. 9 is an enlarged view of the protective case for a watch shown within the area designated as 9 in FIG. 1;
 FIG. 10 is an enlarged view of the protective case for a watch shown within the area designated as 10 in FIG. 1; and,
 FIG. 11 is an enlarged view of the protective case for a watch shown within the area designated as 11 in FIG. 1.
 The broken lines in the drawings are for the purpose of illustrating portions of the protective case for a watch that form no part of the claimed design. The dot-dashed broken line in FIGS. 9-11 shows the boundary of the enlarged view and forms no part of the claimed design.

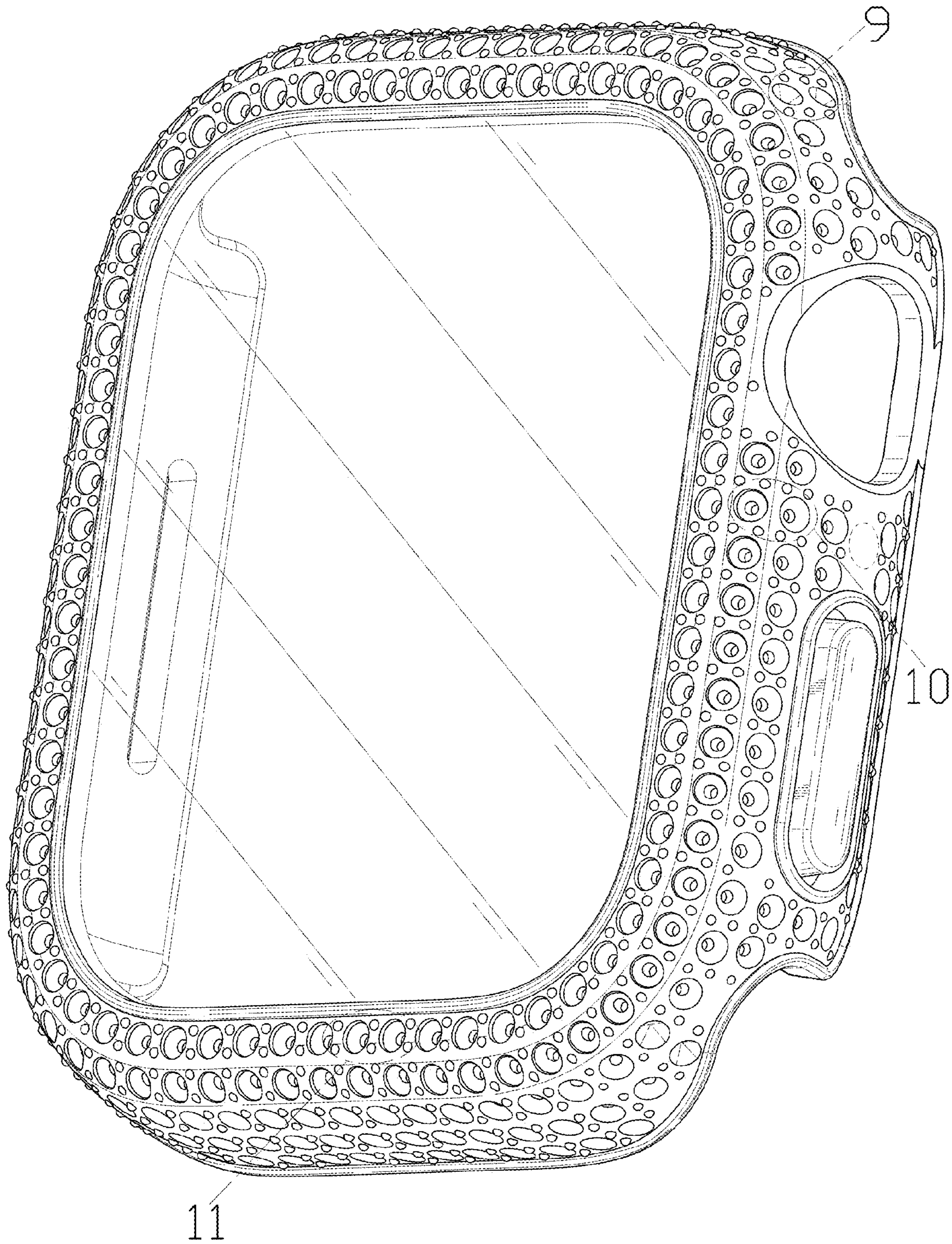

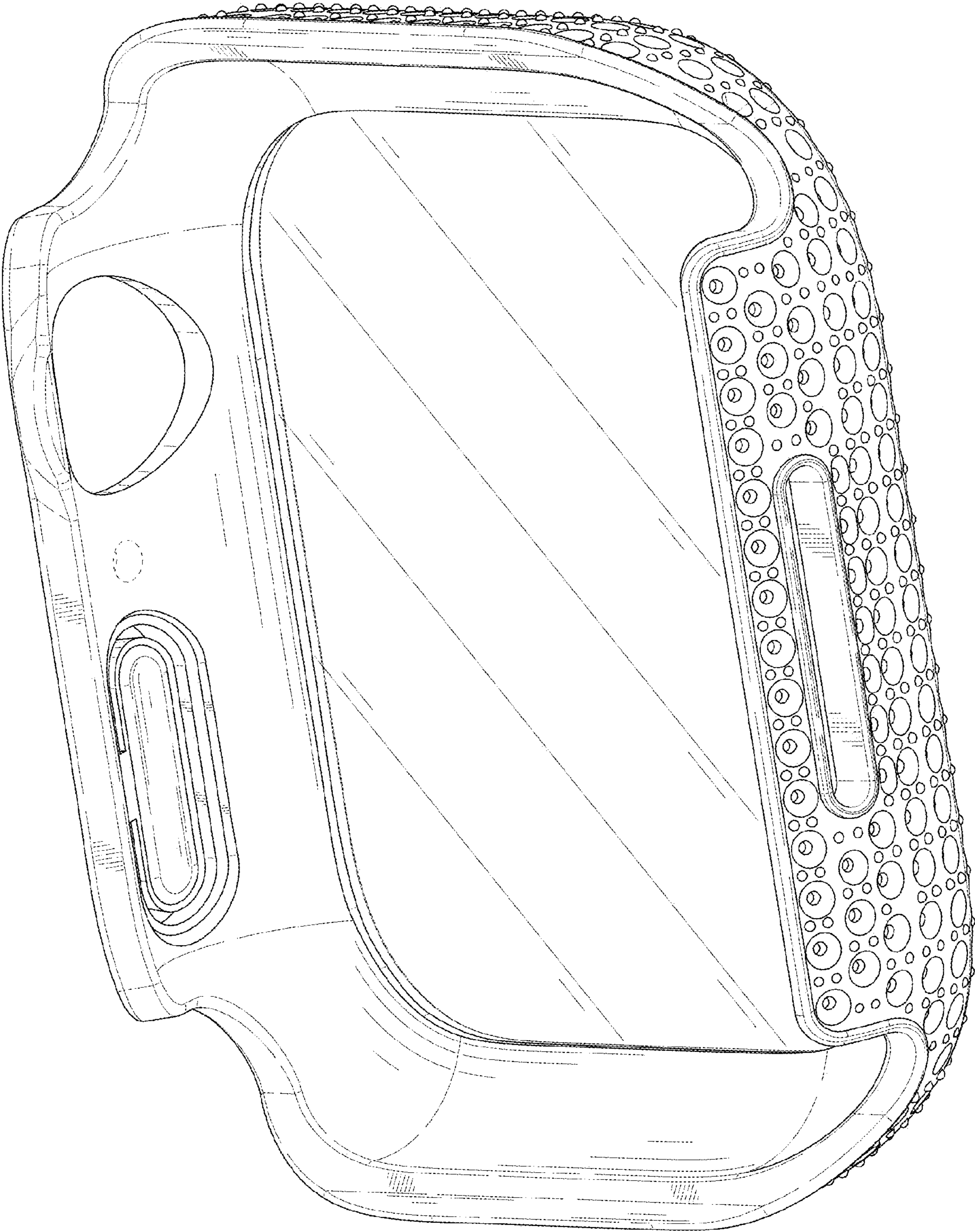

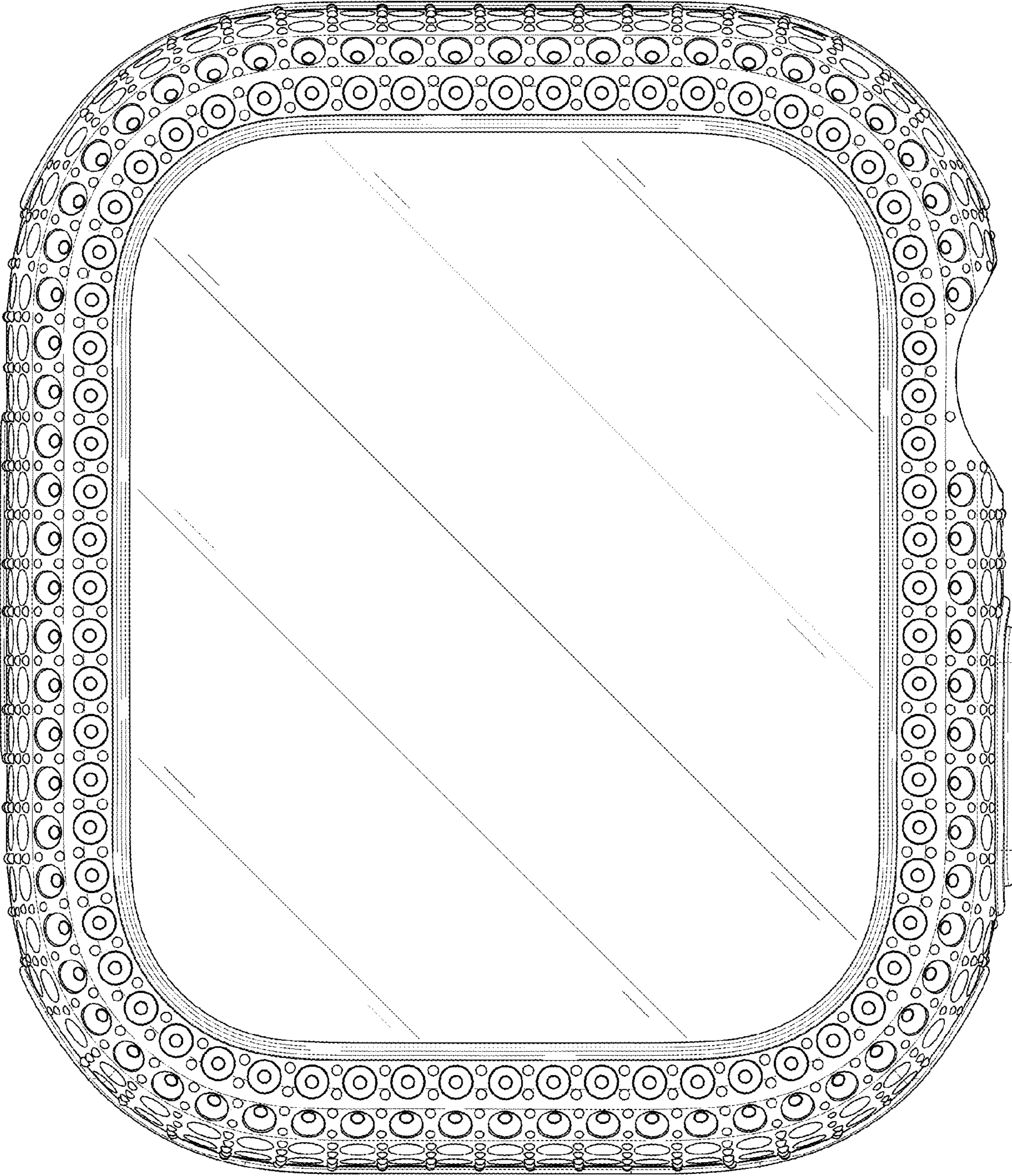

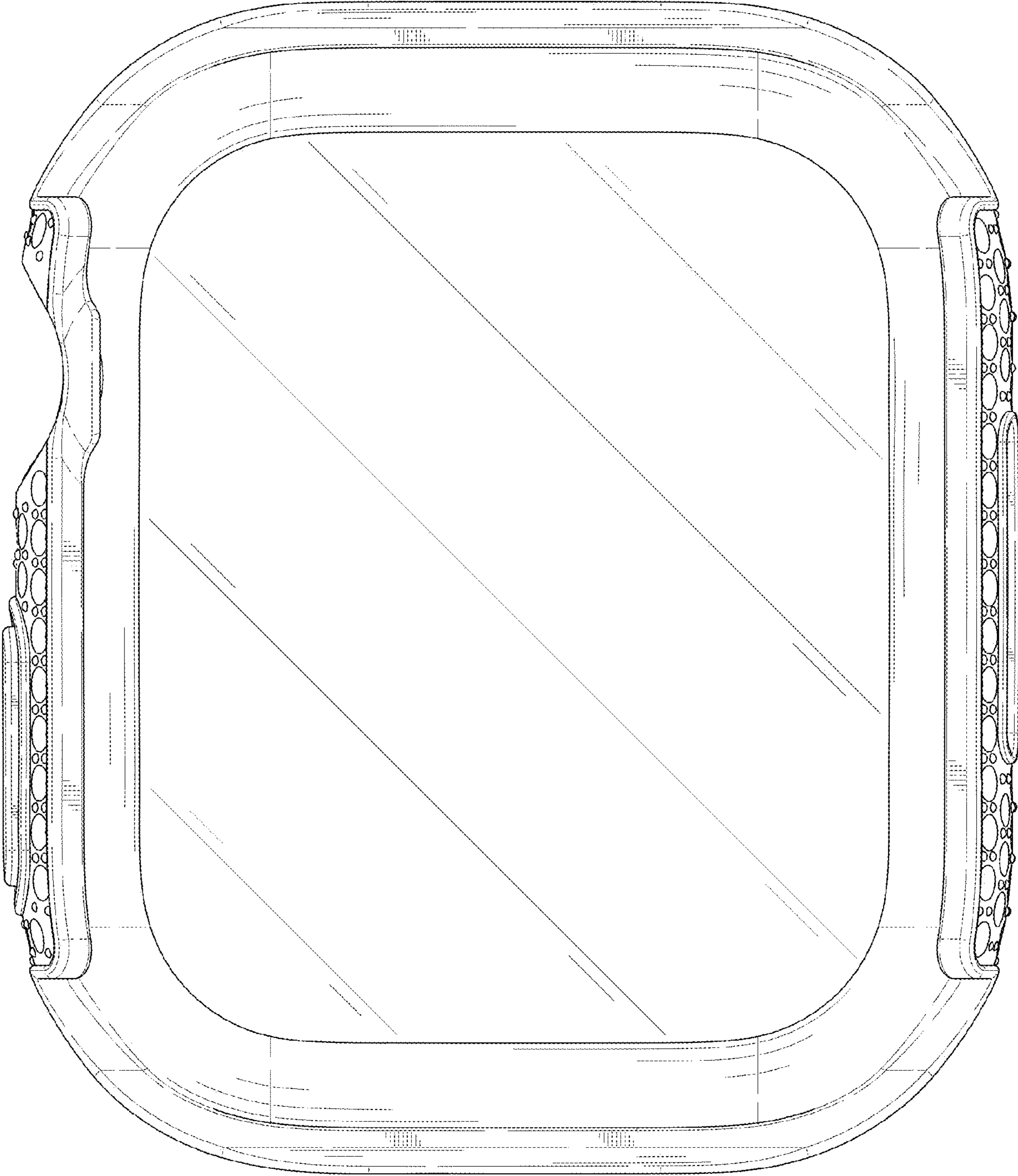

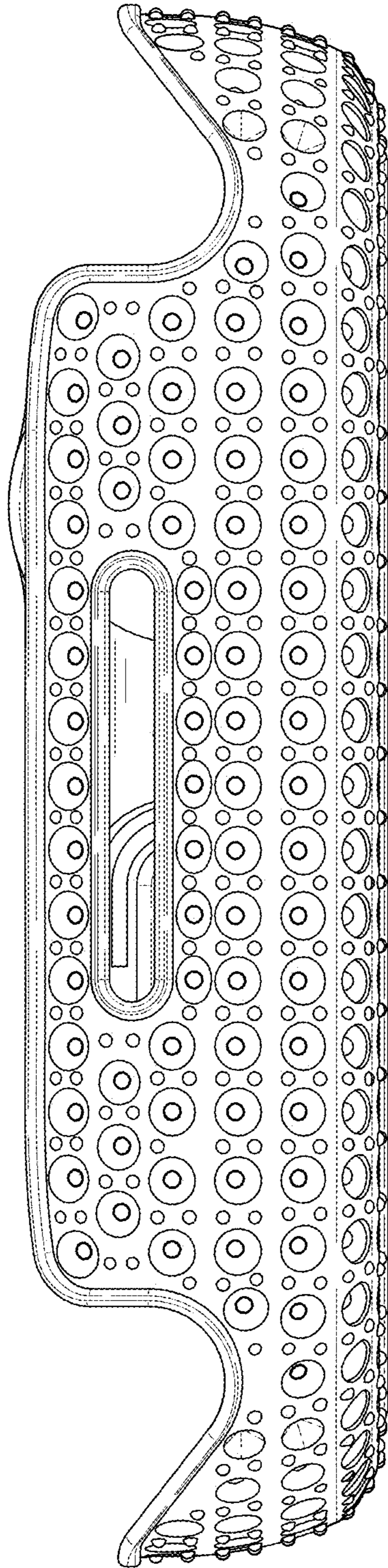

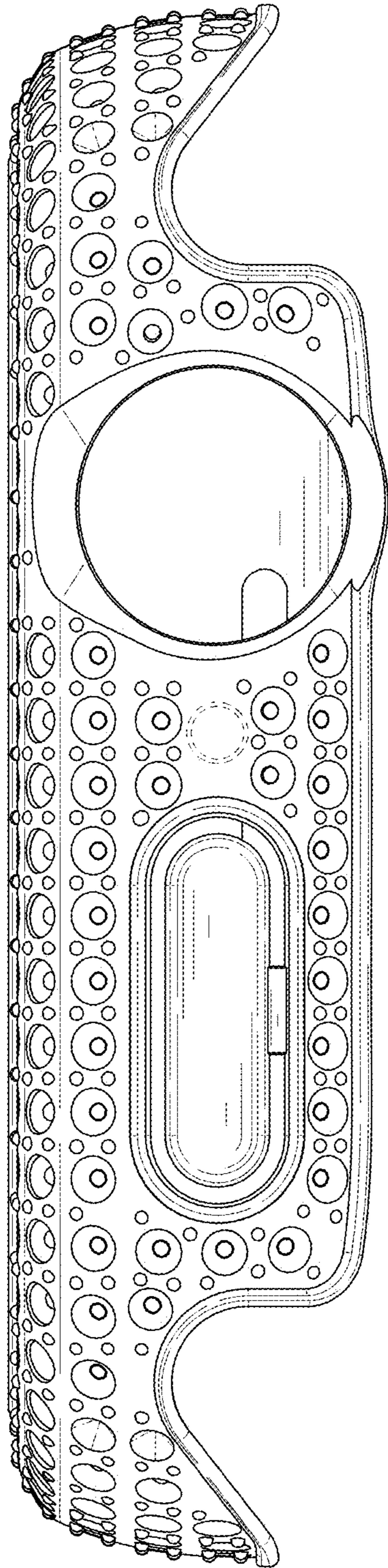

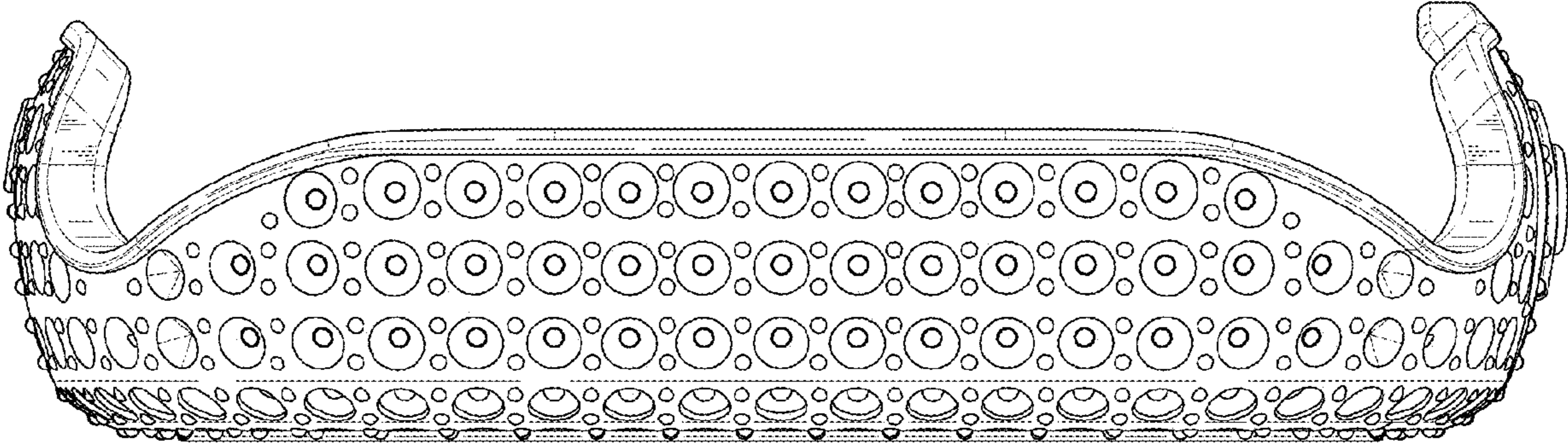

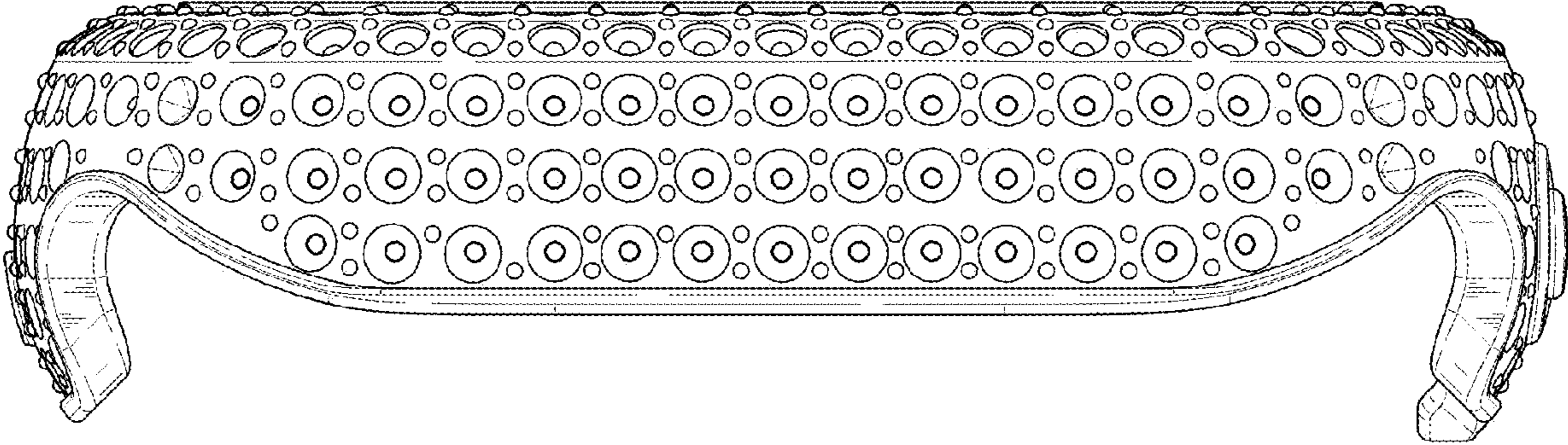

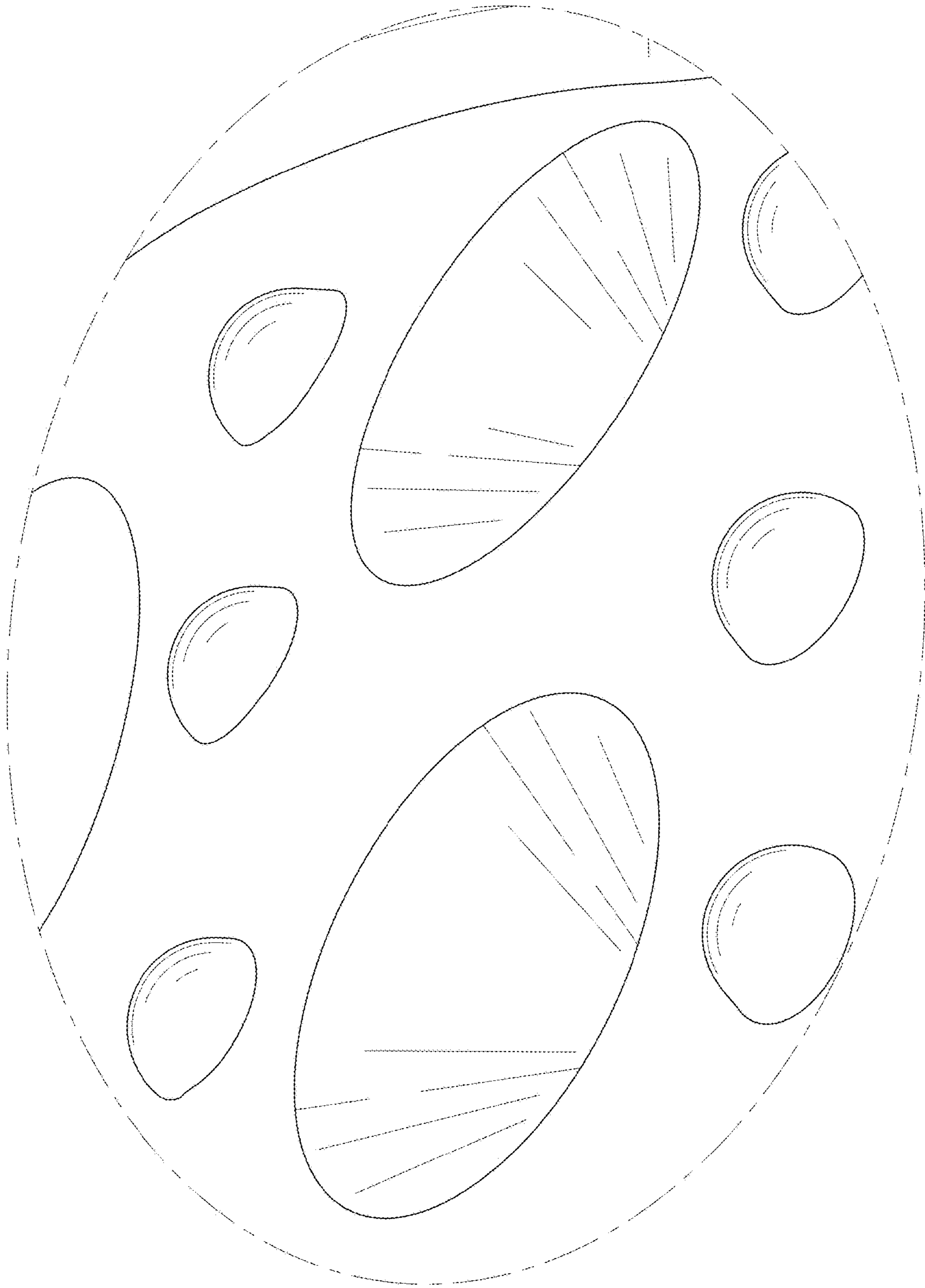

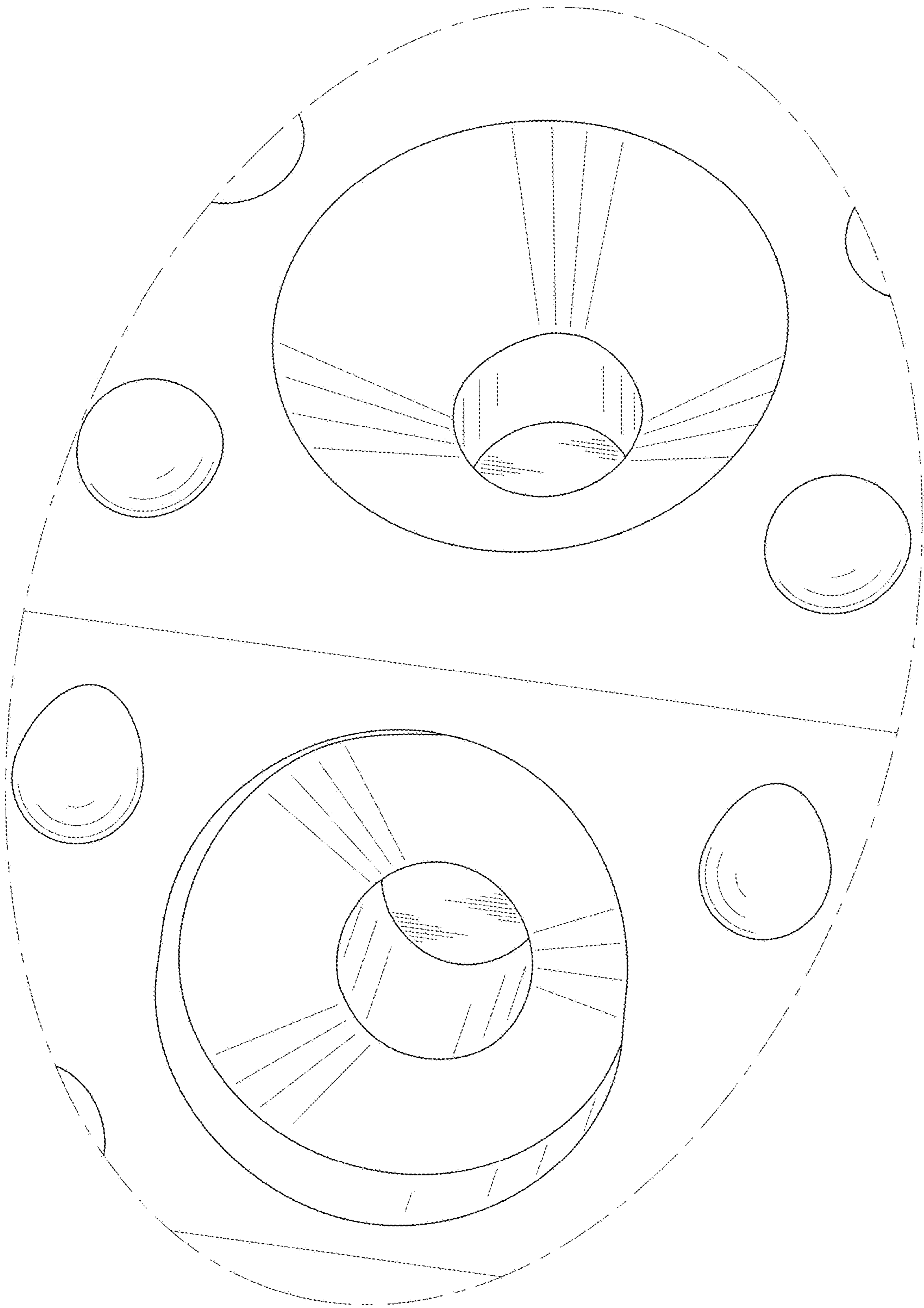

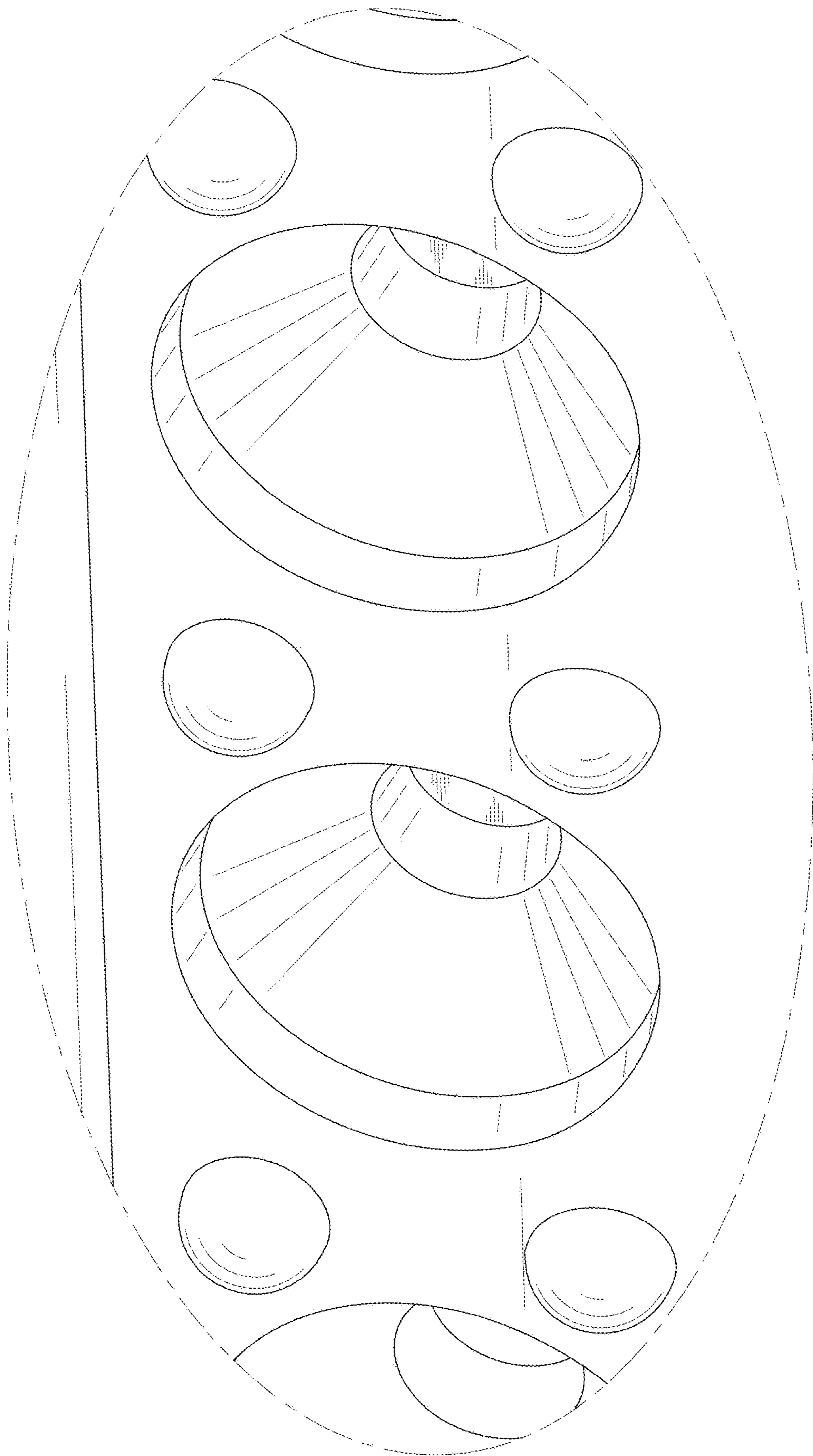
