DESCRIPTION

FIG. 1 is a perspective view of a tire showing our new design;

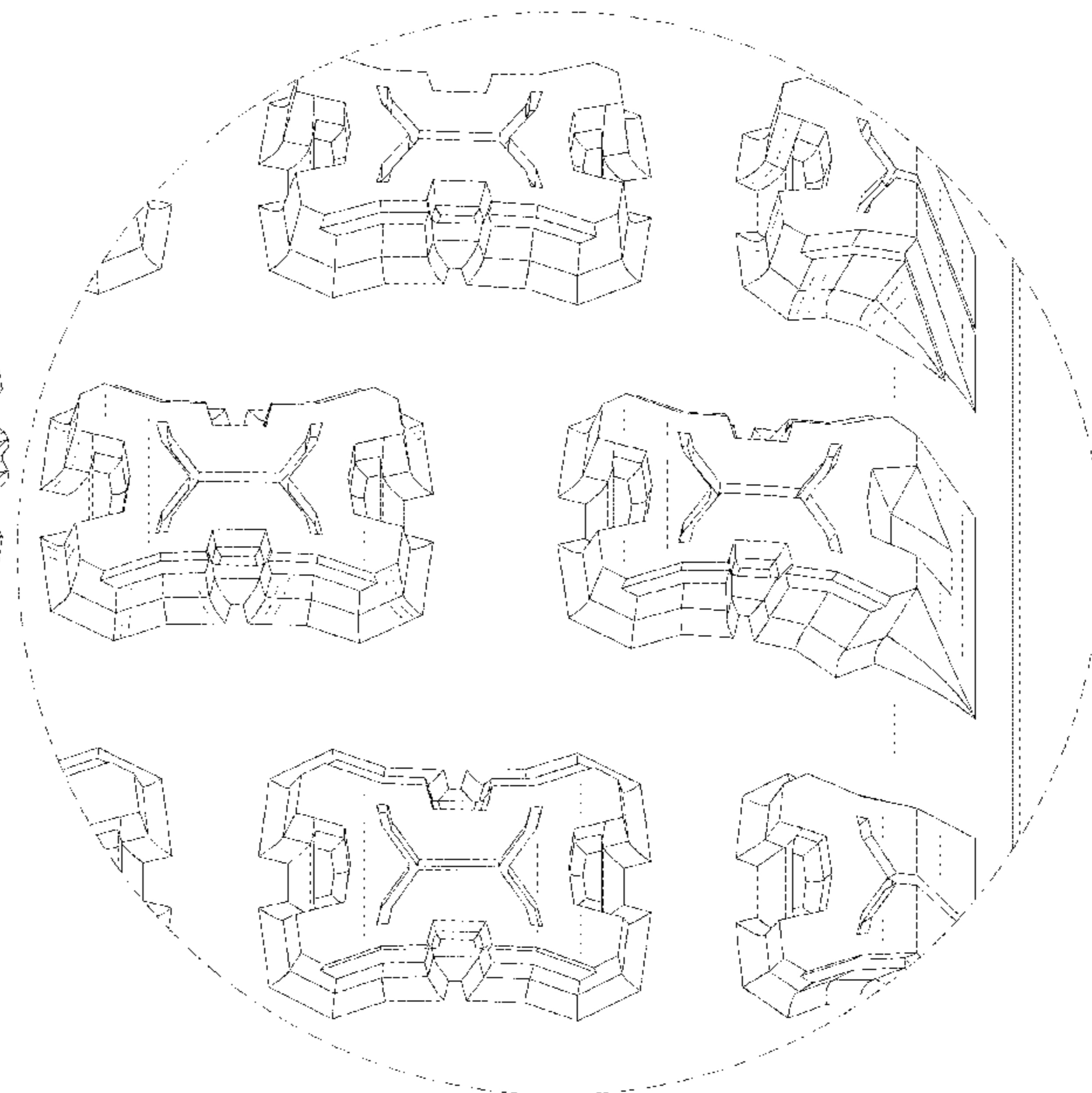
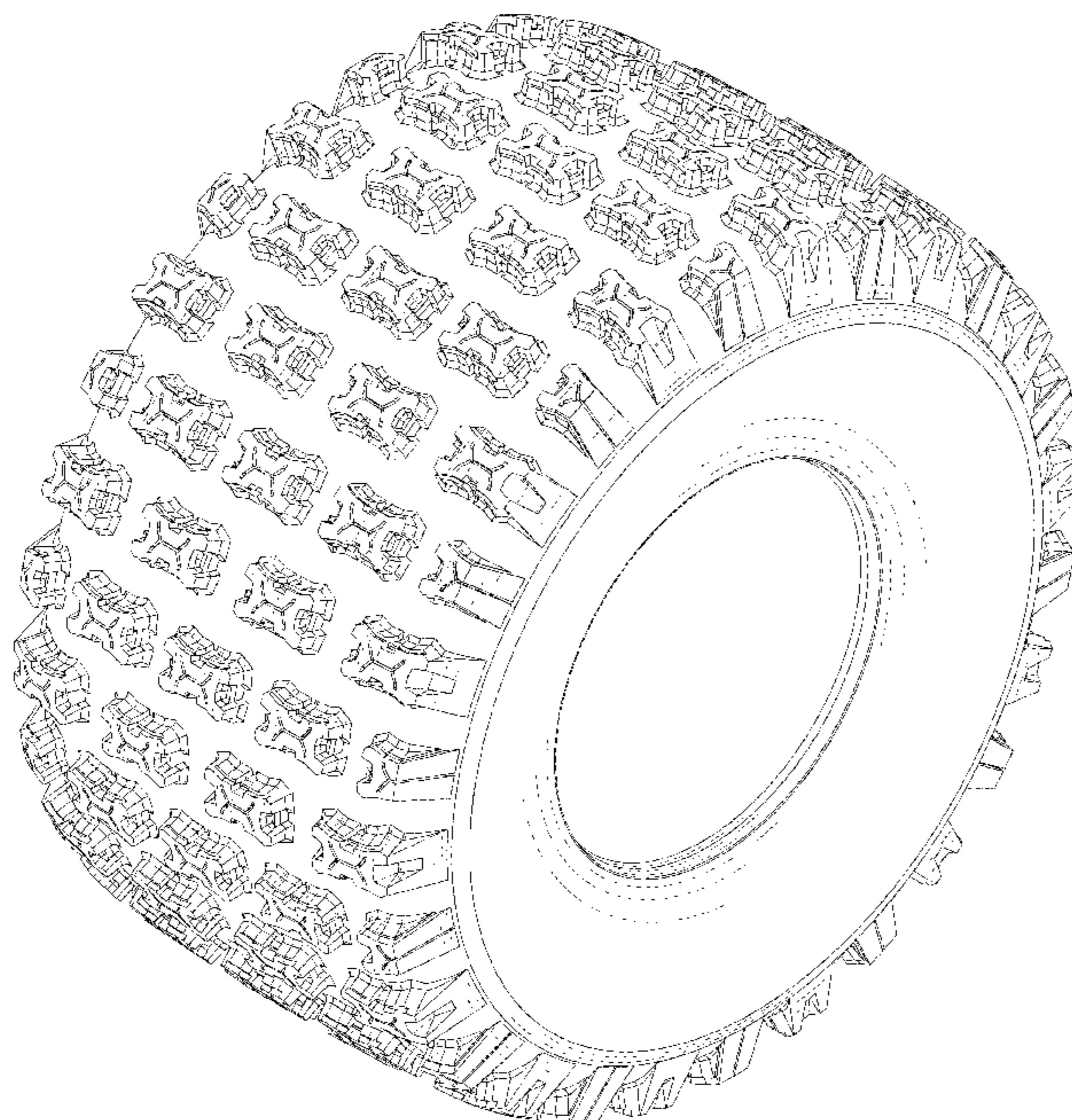

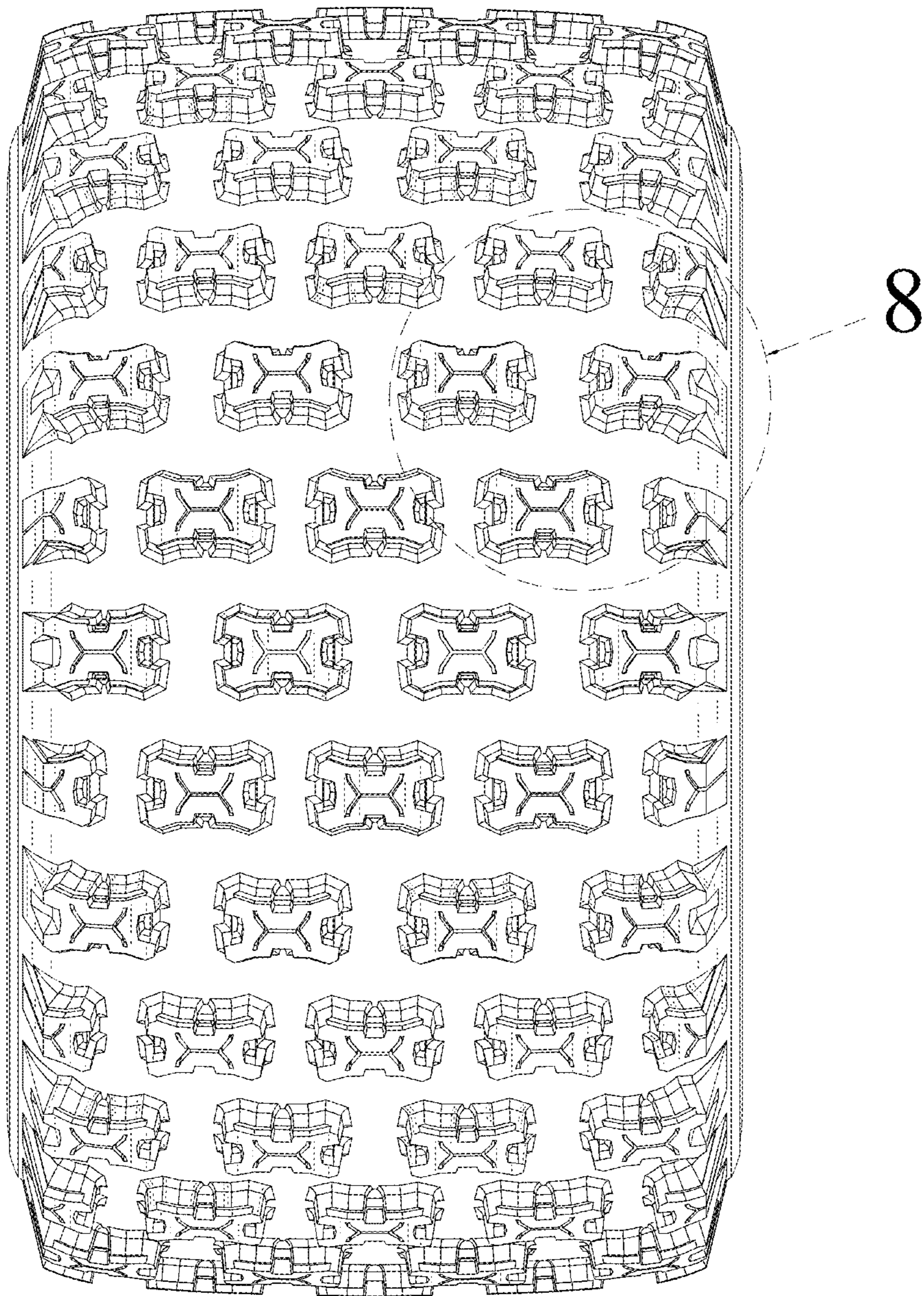

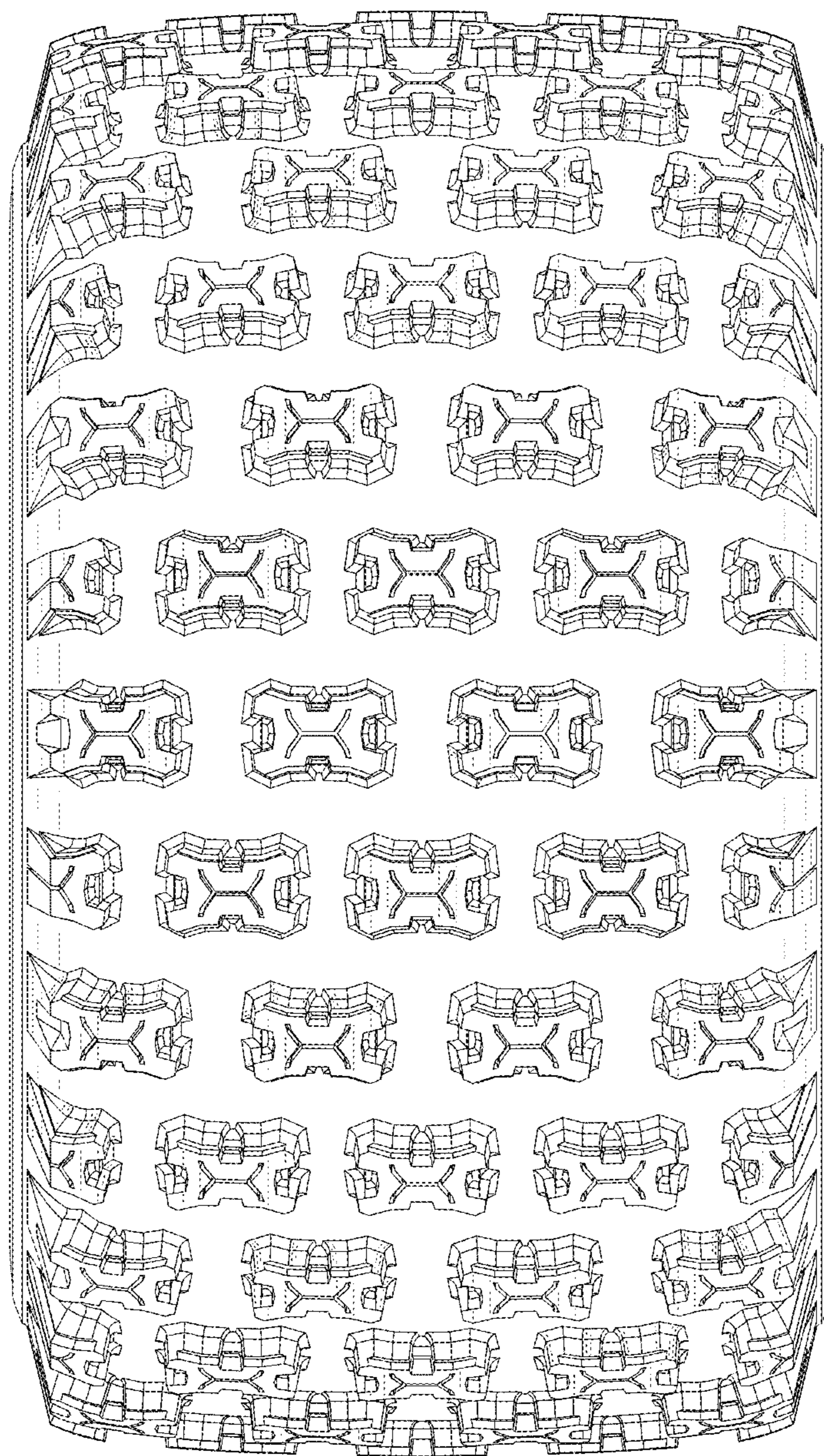

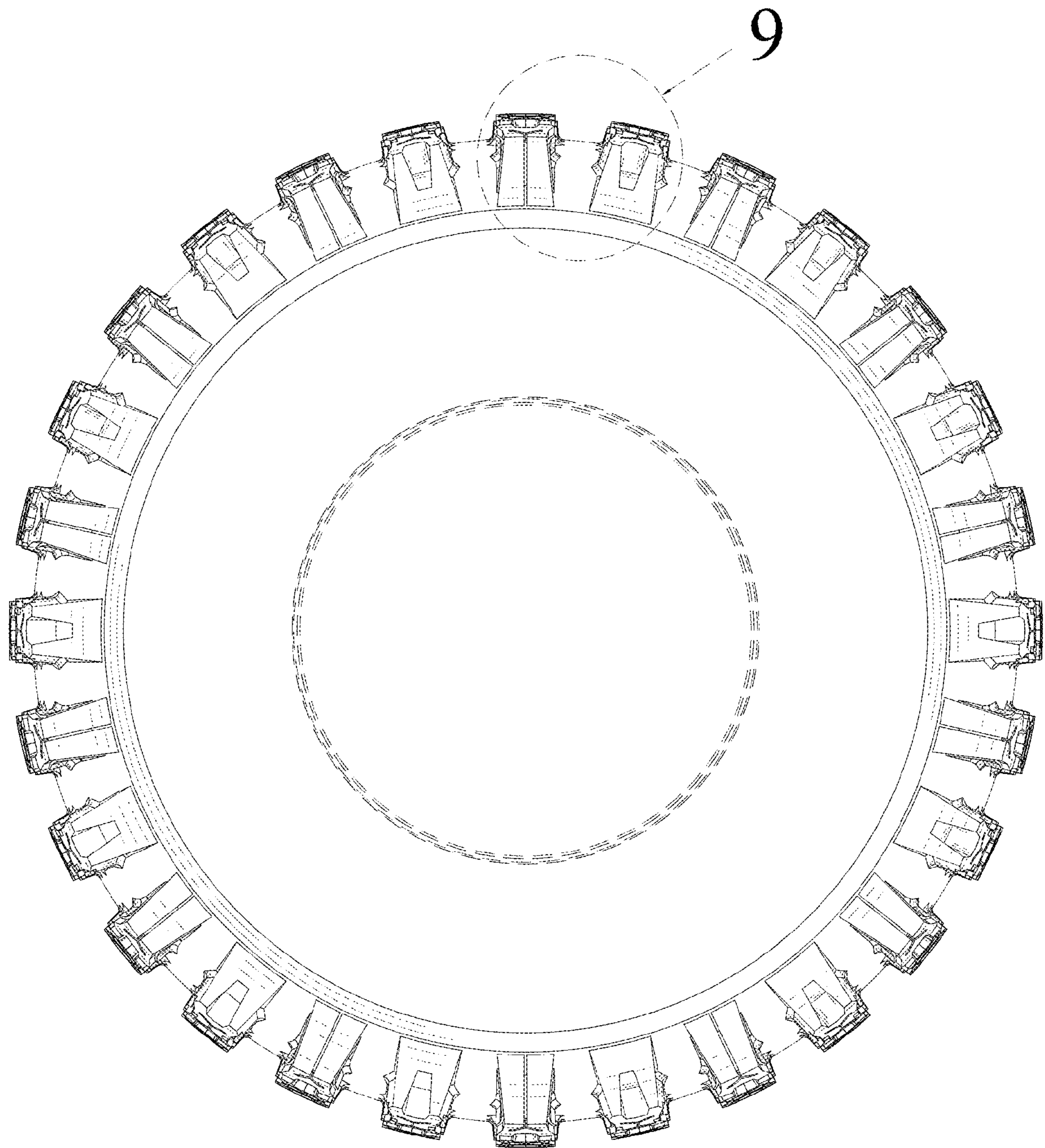

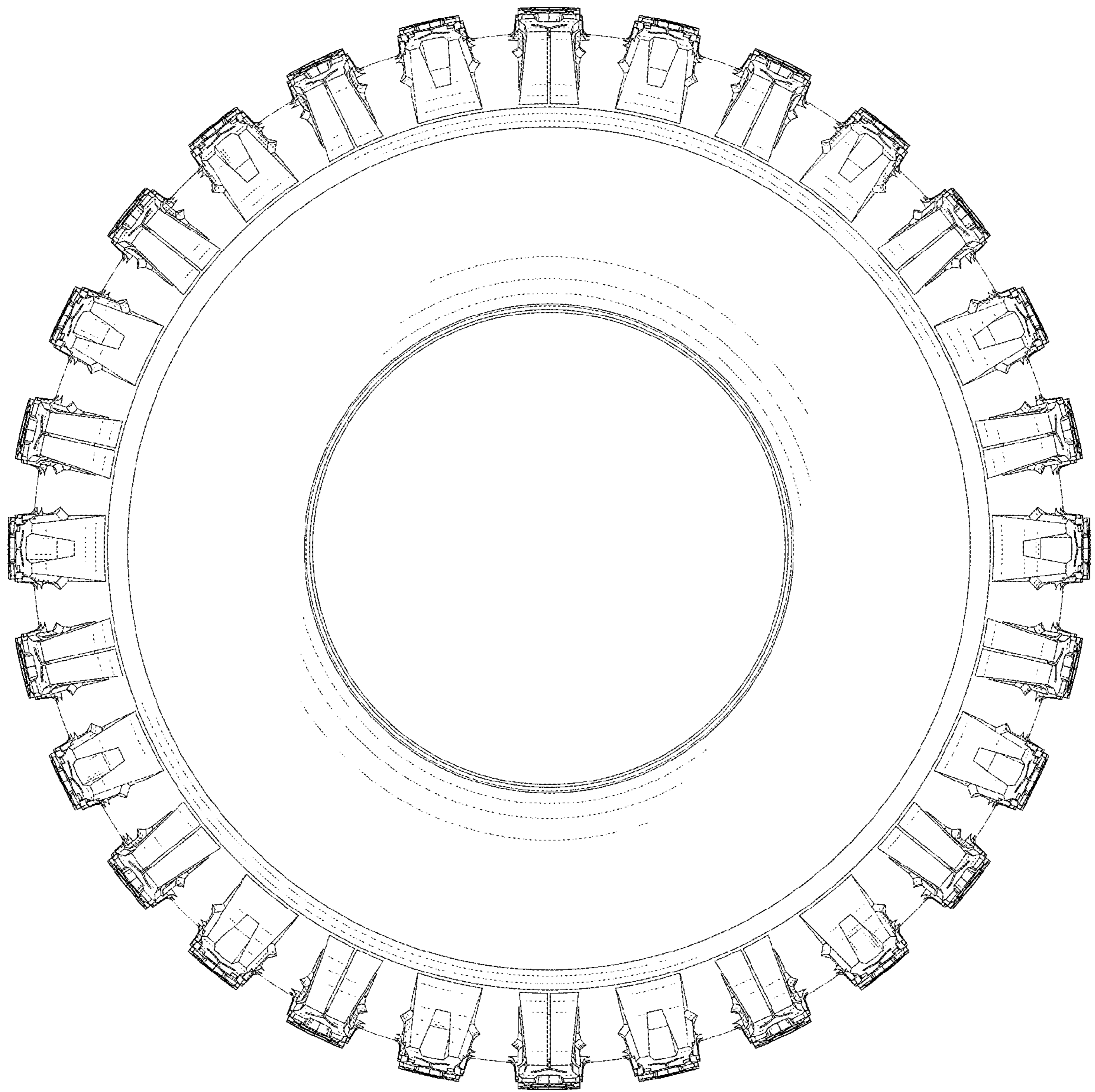

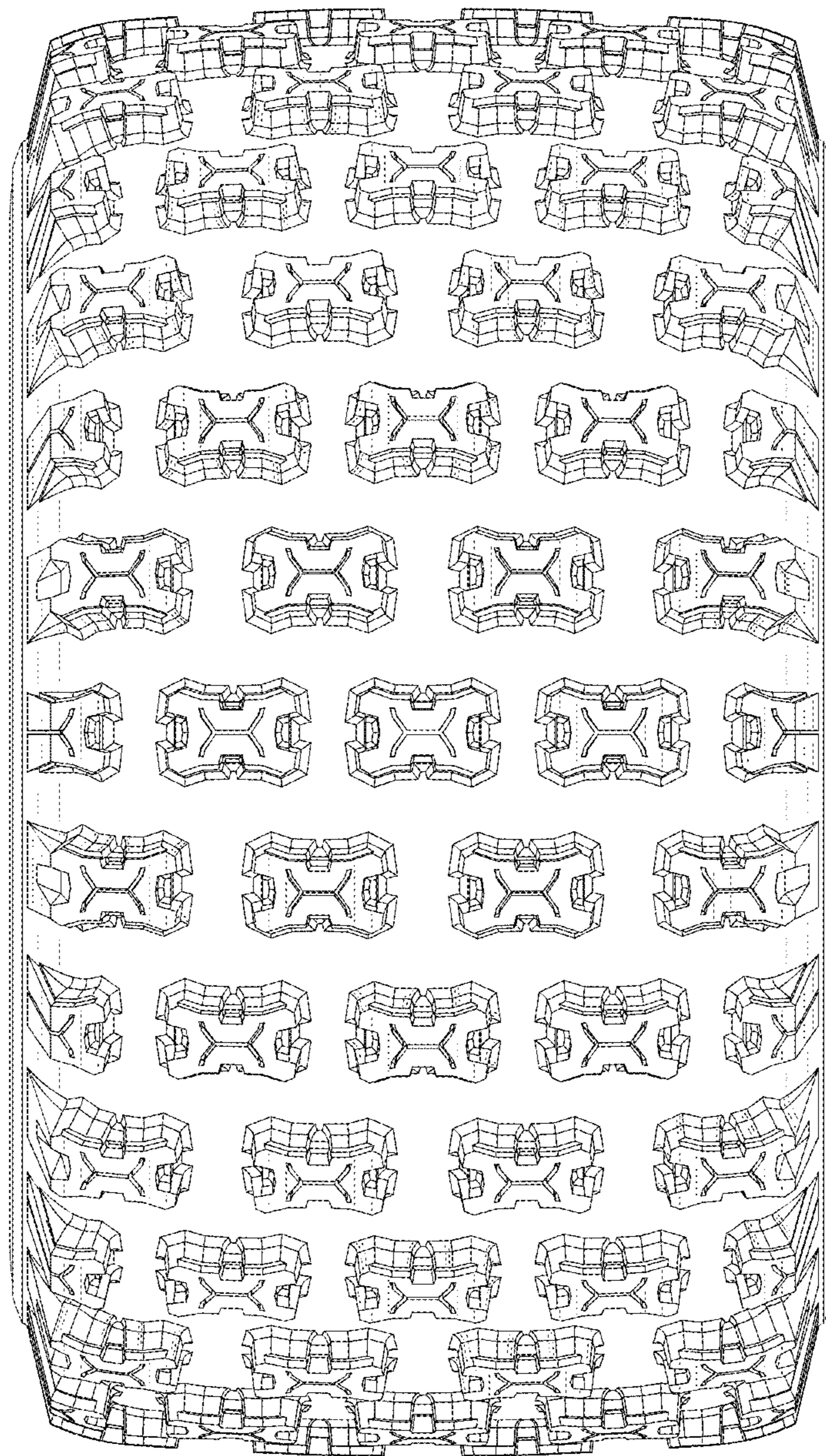

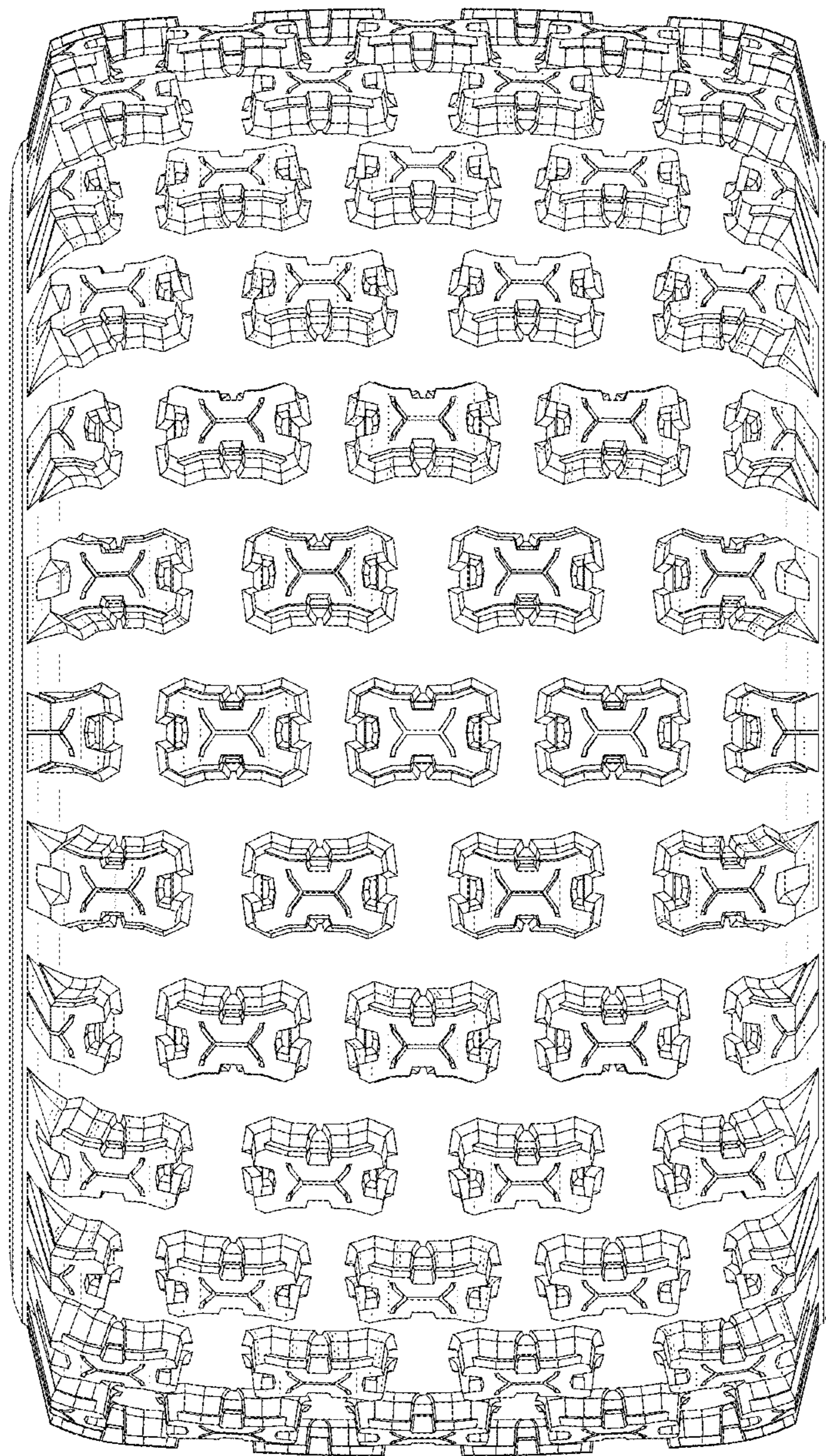

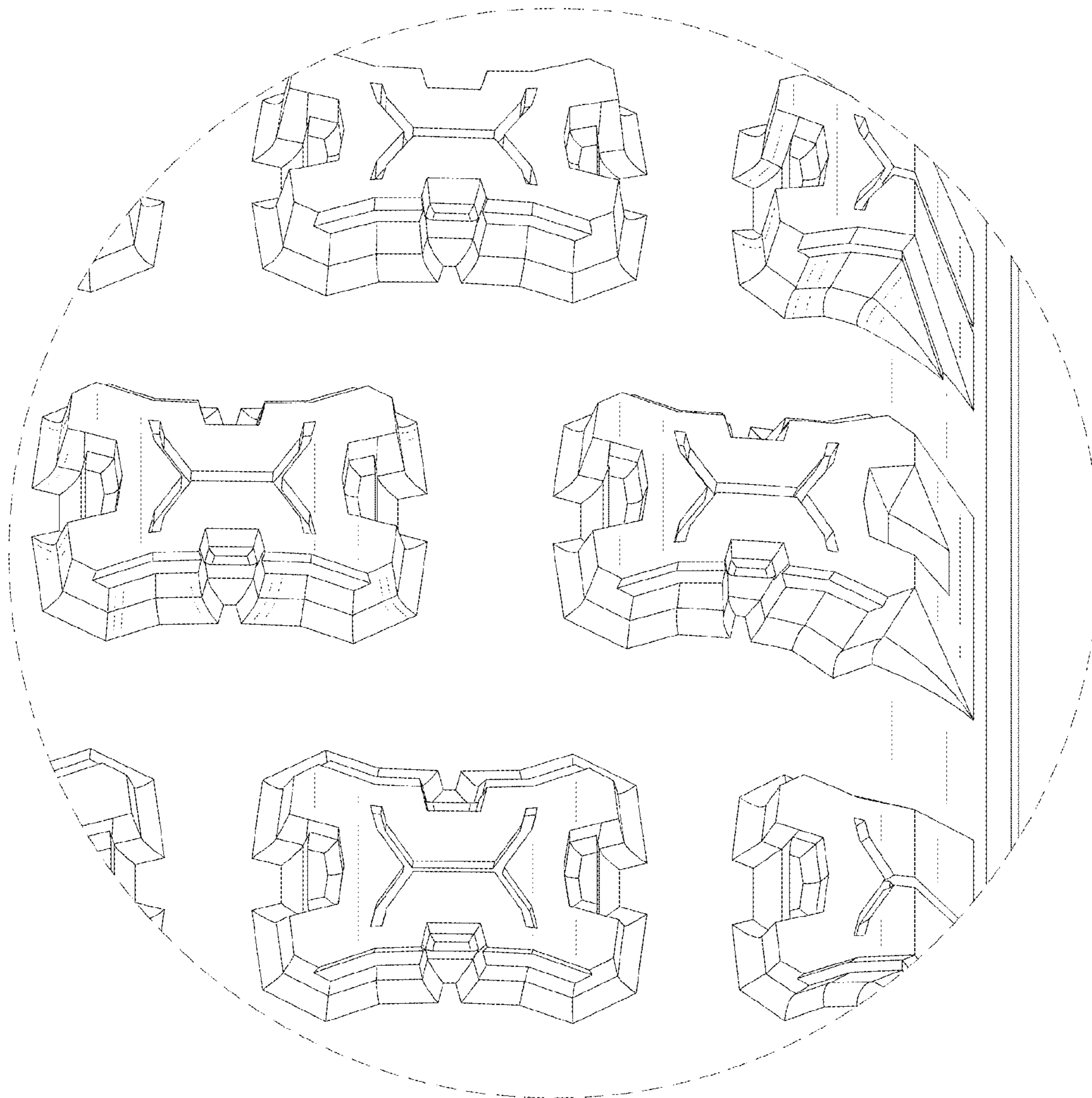

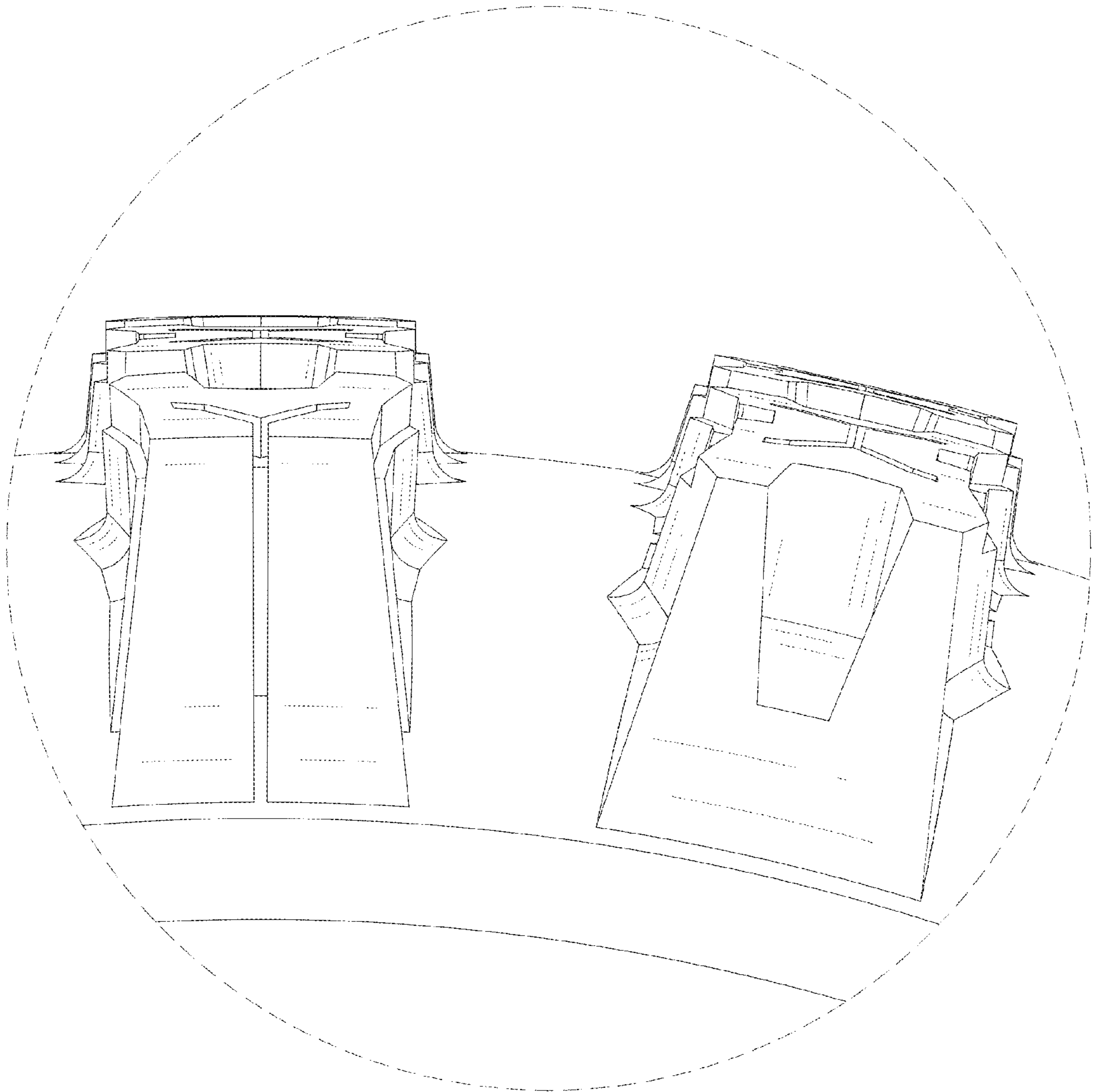
