(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is the first image in a sequence for a display screen or portion thereof with animated graphical user interface showing our new design in accordance with a first embodiment;

FIG. 2 is the second image thereof;

FIG. 3 is the first image in a sequence for a display screen or portion thereof with animated graphical user interface showing our new design in accordance with a second embodiment;

FIG. 4 is the second image thereof;

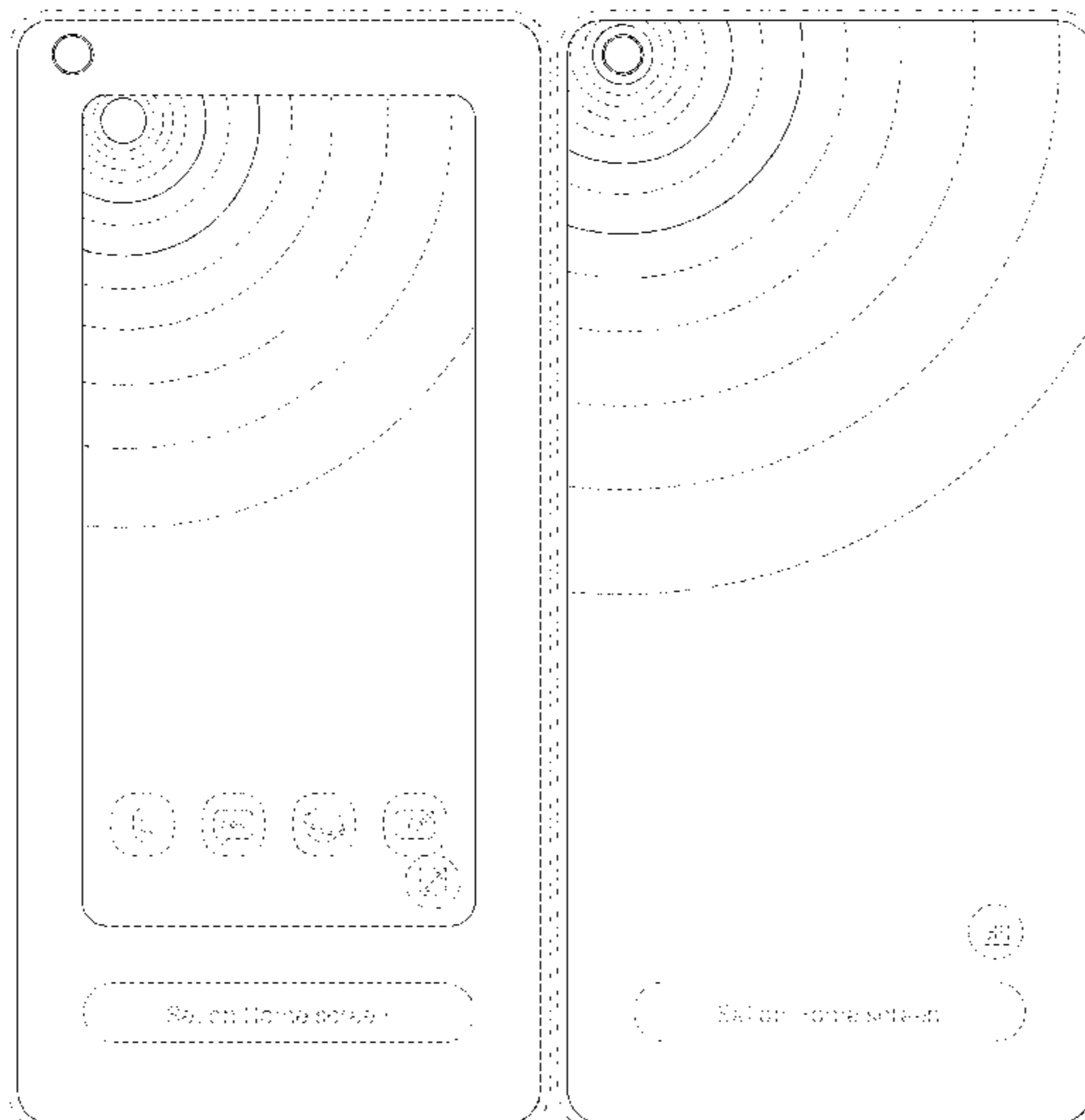
FIG. 5 is the first image in a sequence for a display screen or portion thereof with animated graphical user interface showing our new design in accordance with a third embodiment; and,

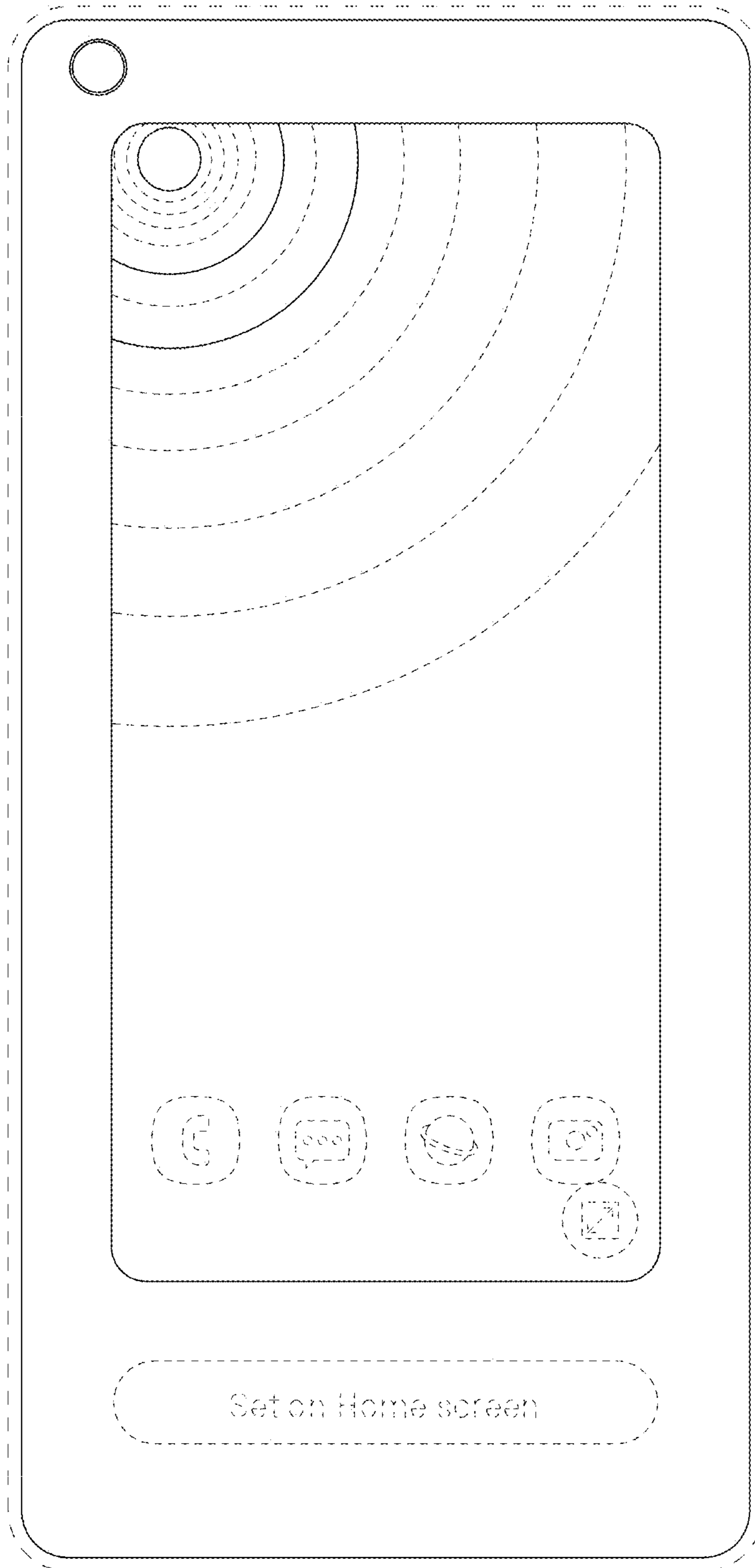

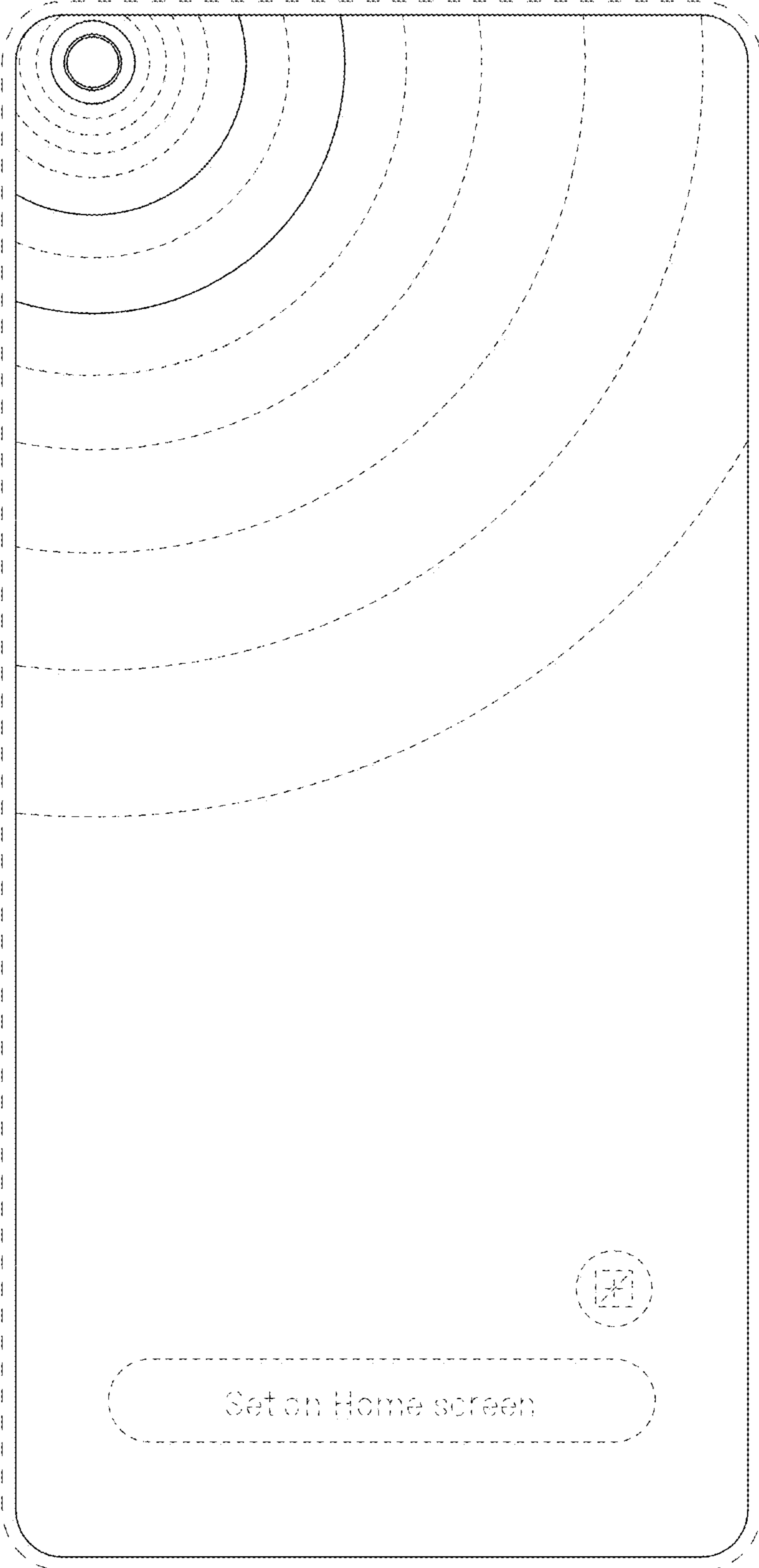

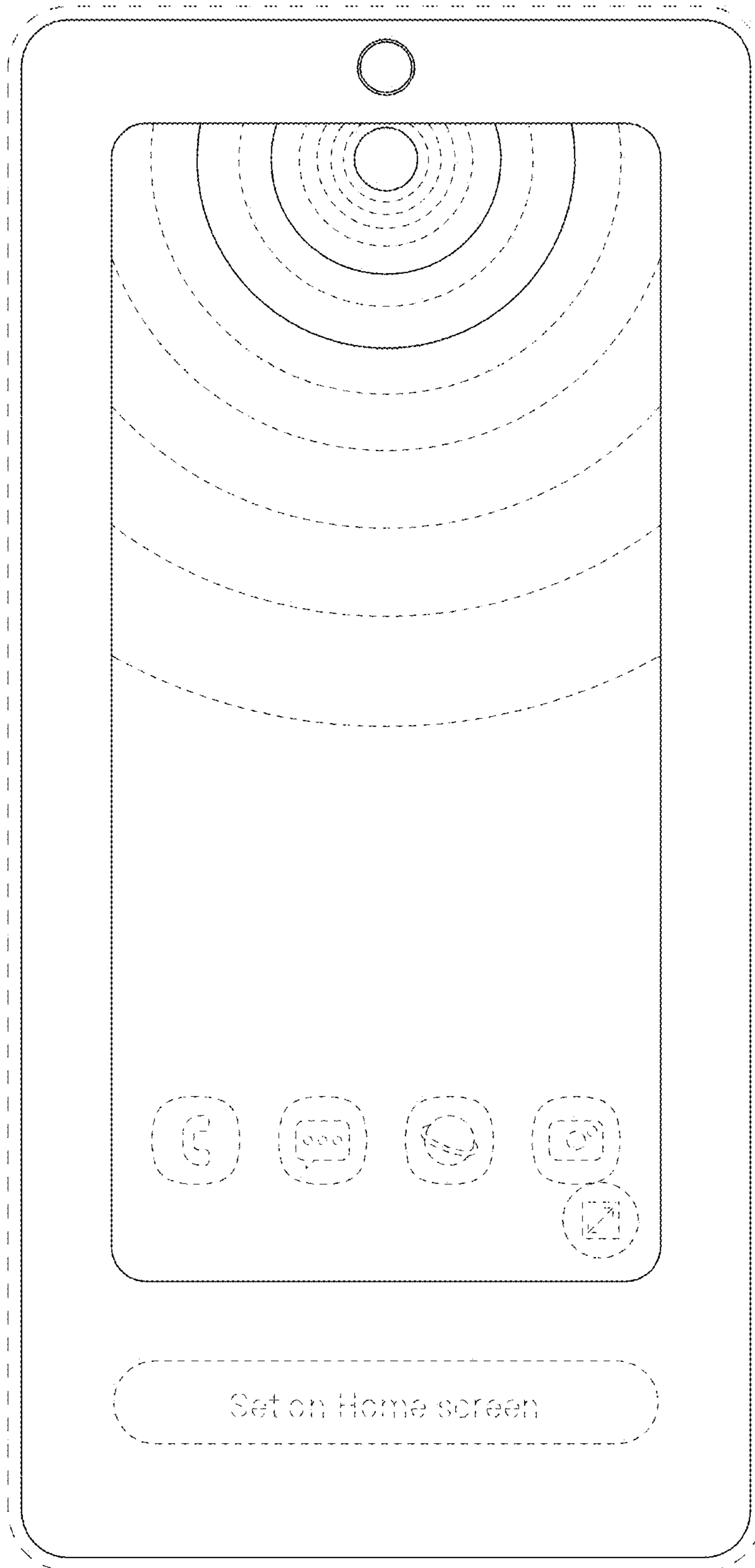

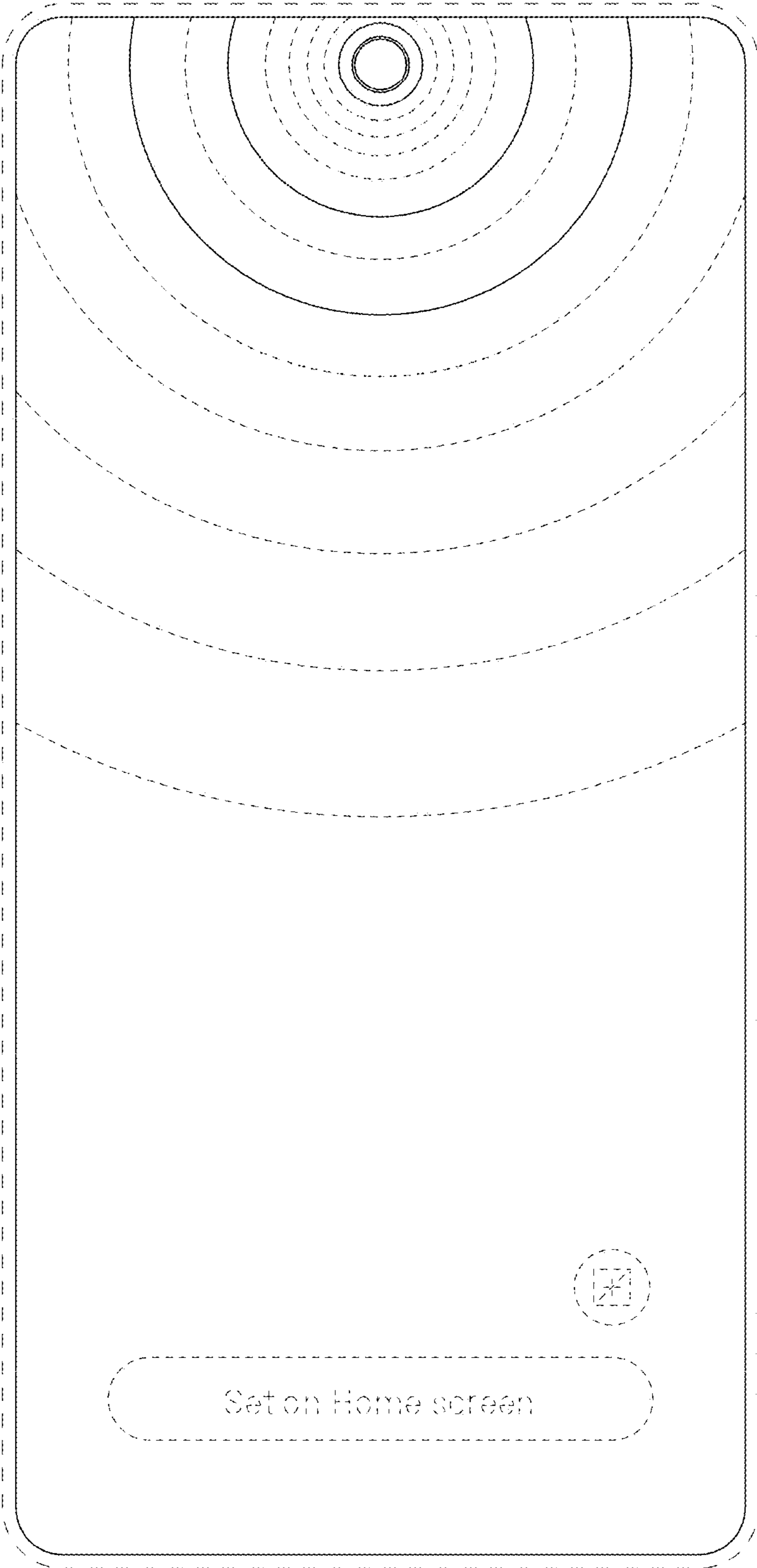

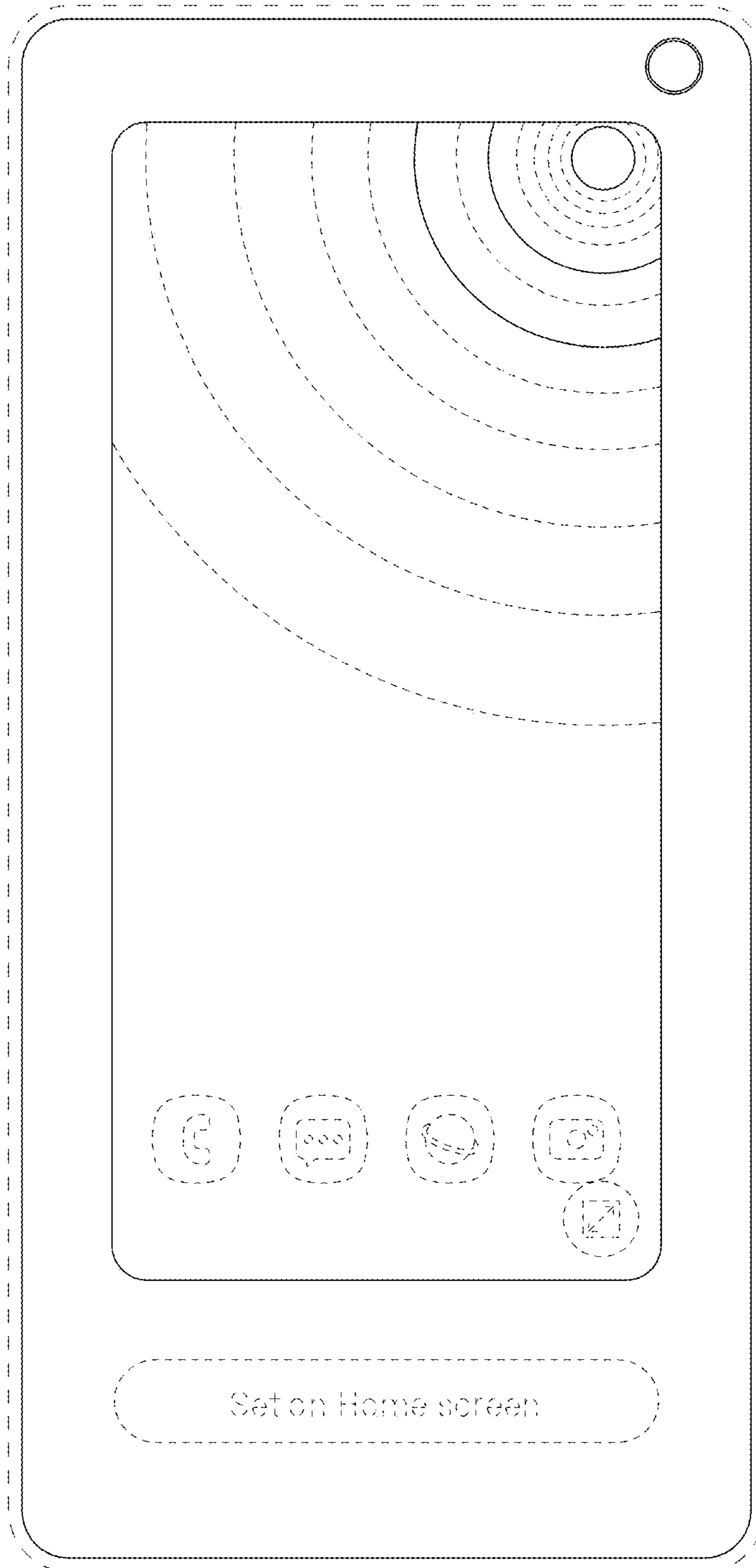
