(57) **CLAIM**

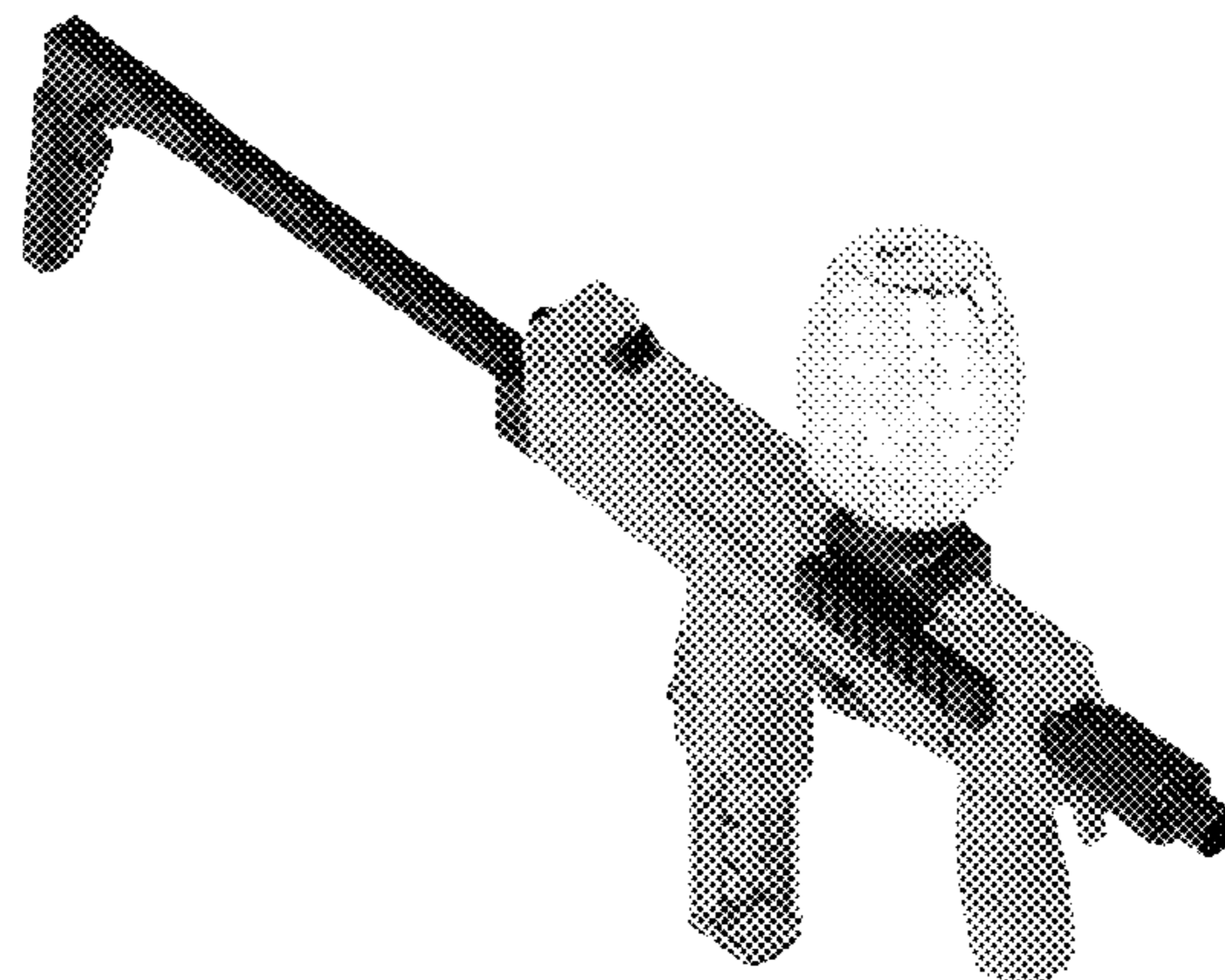
The ornamental design for a toy gun set, as shown and described.

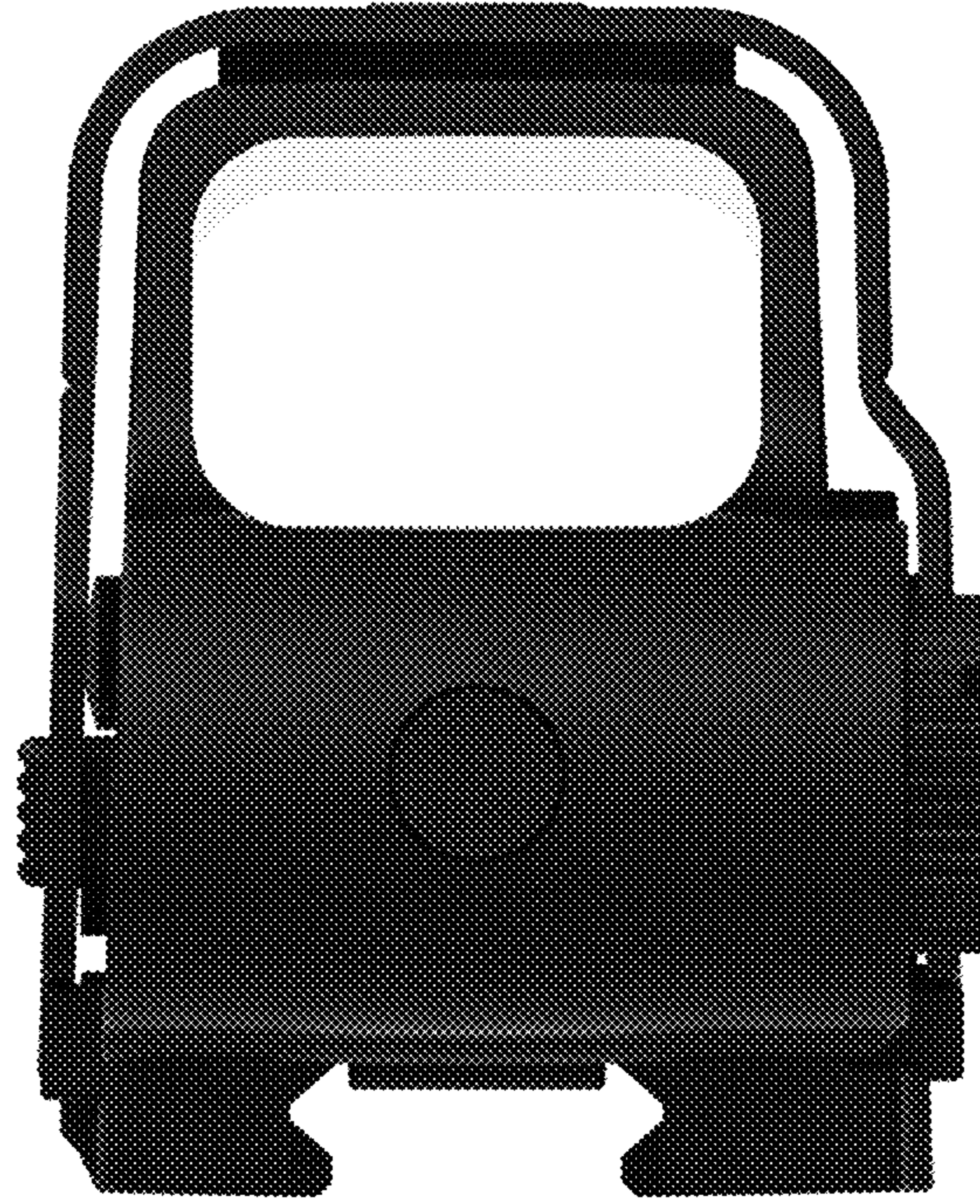

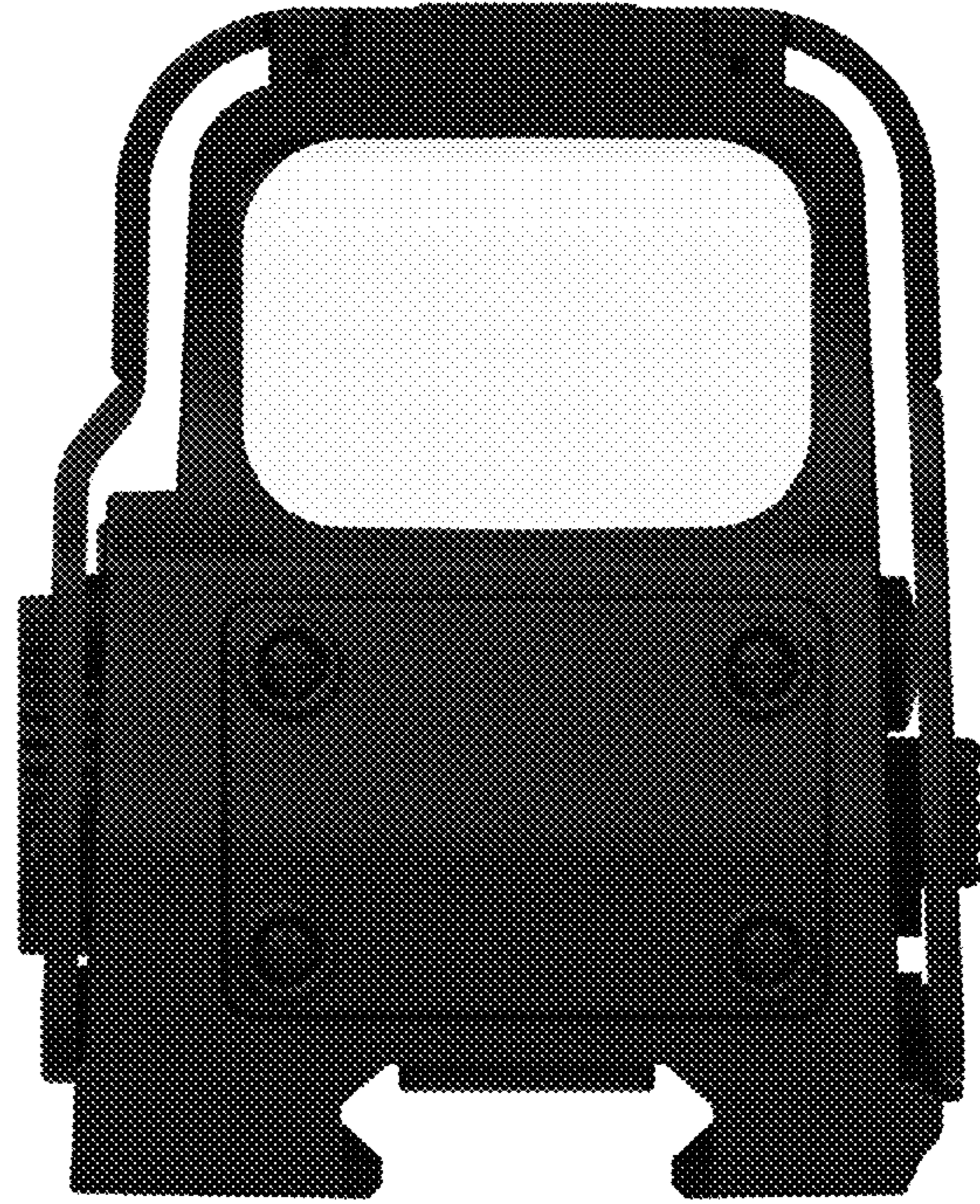

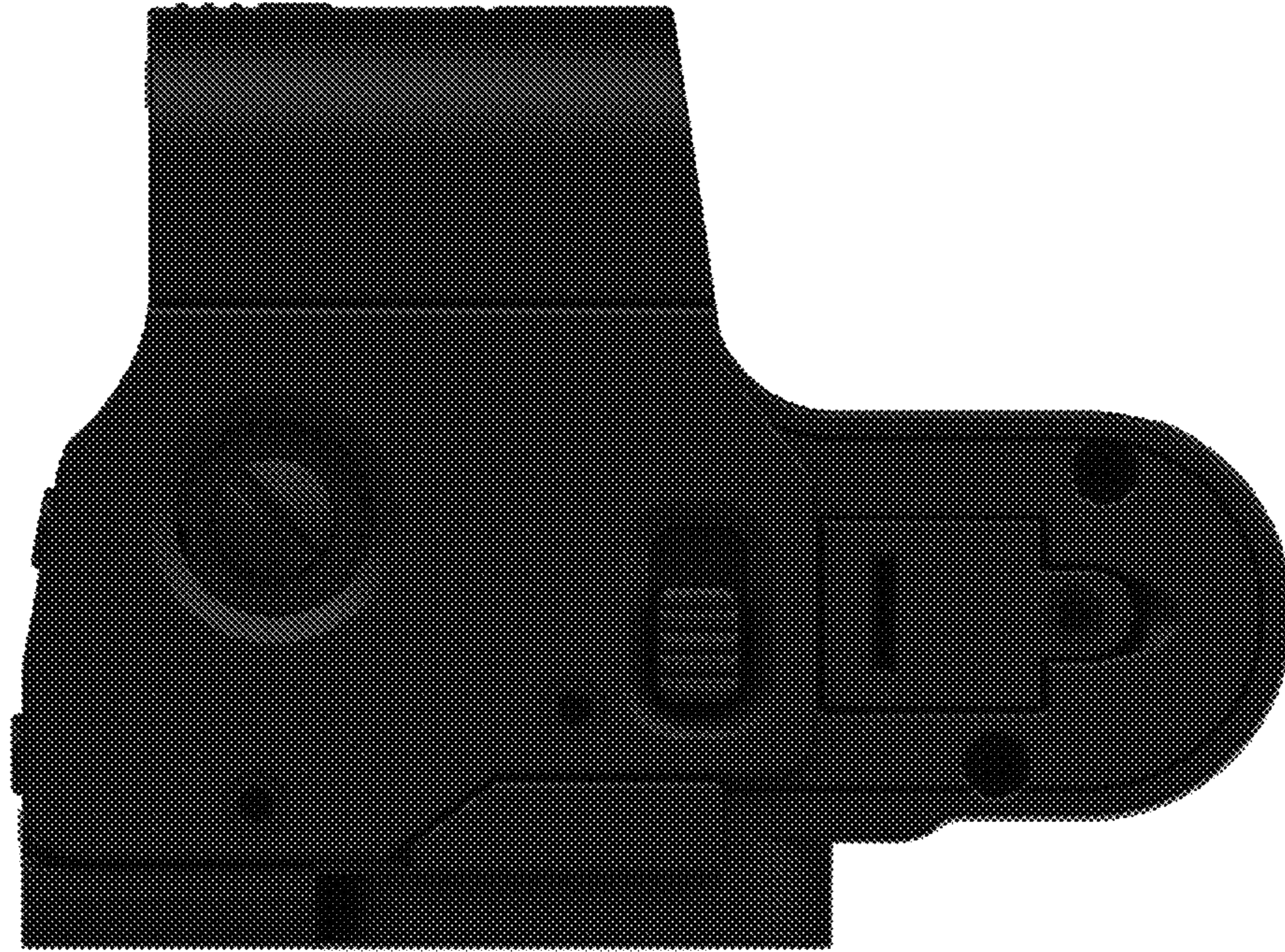

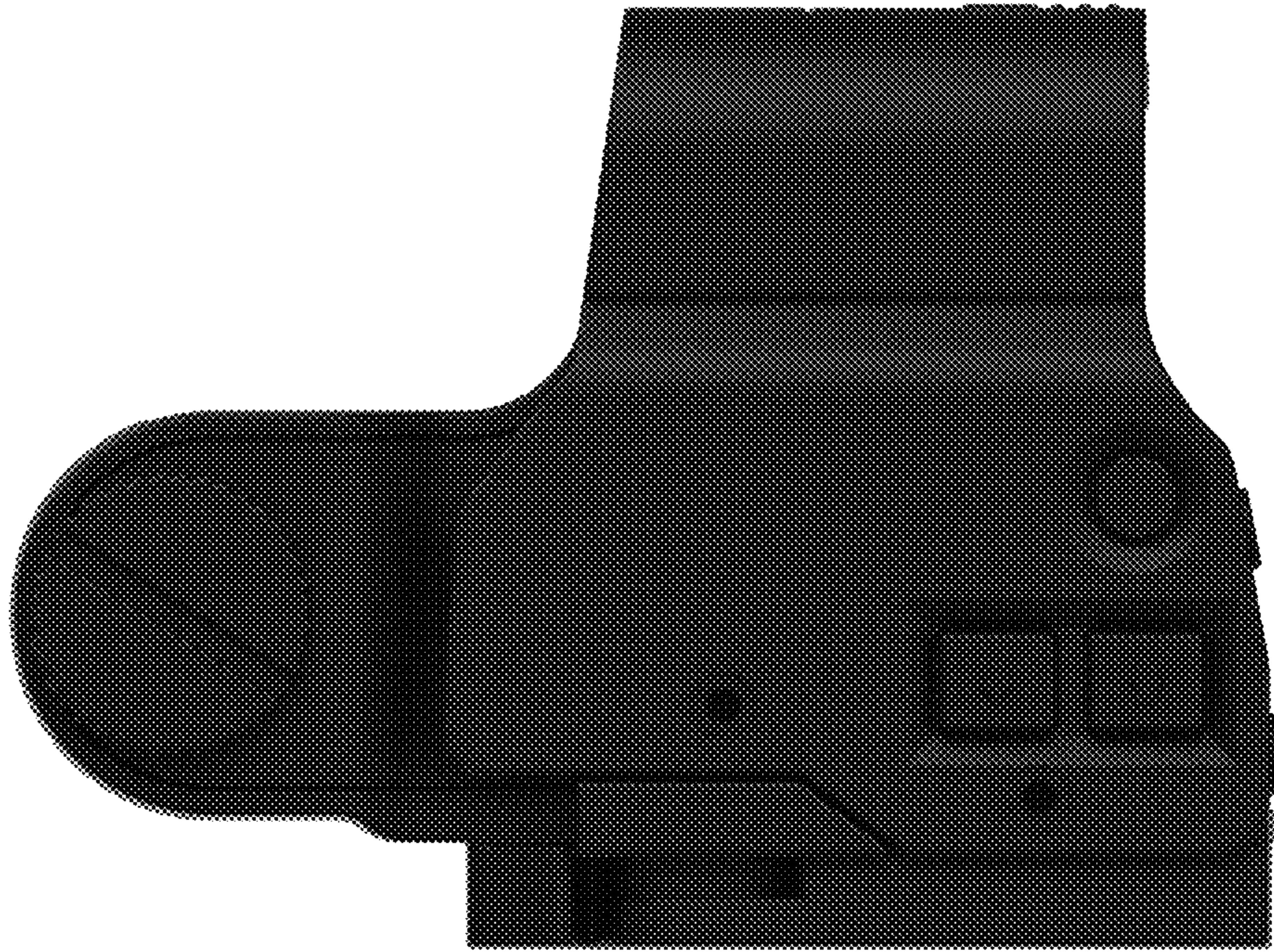

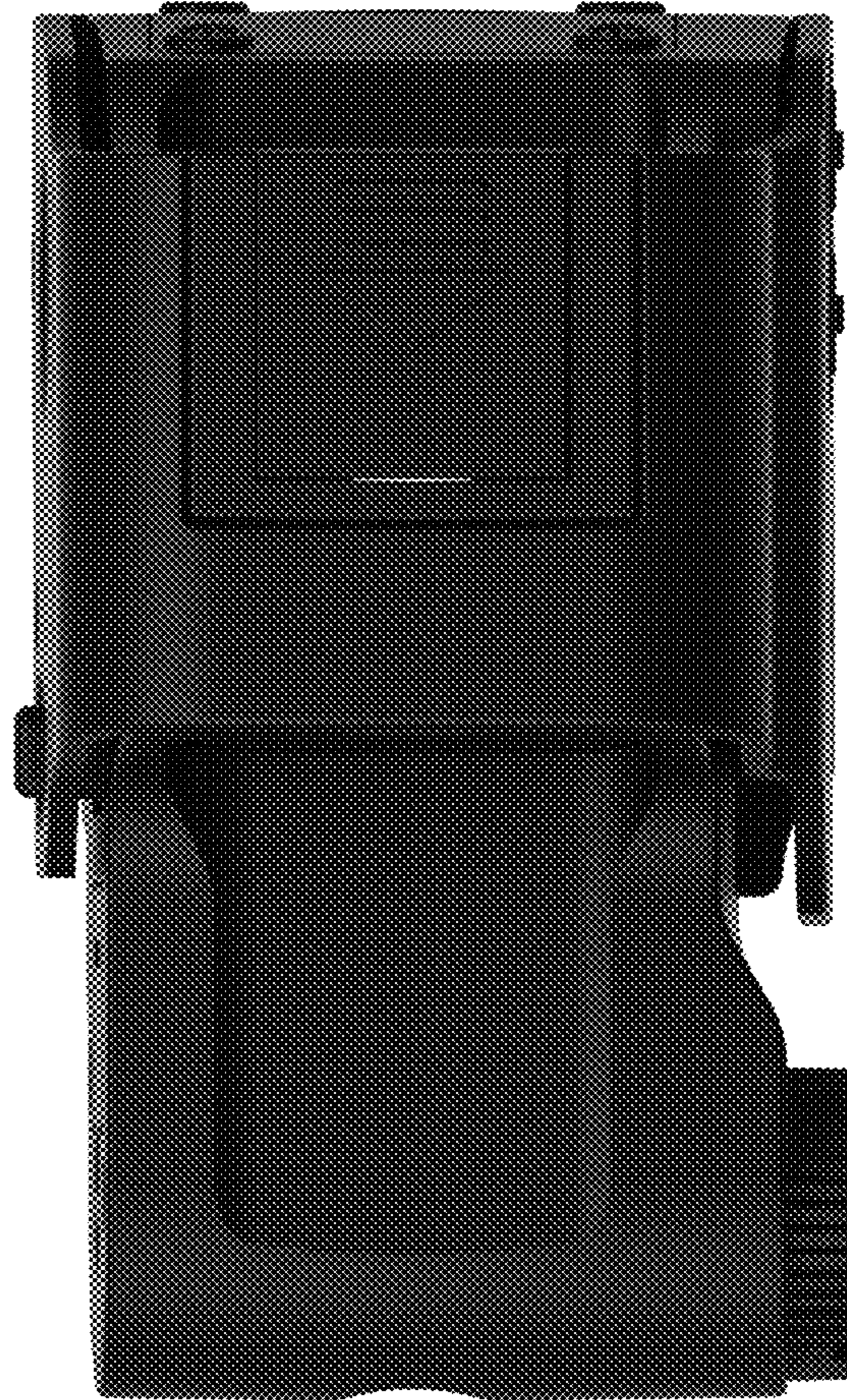

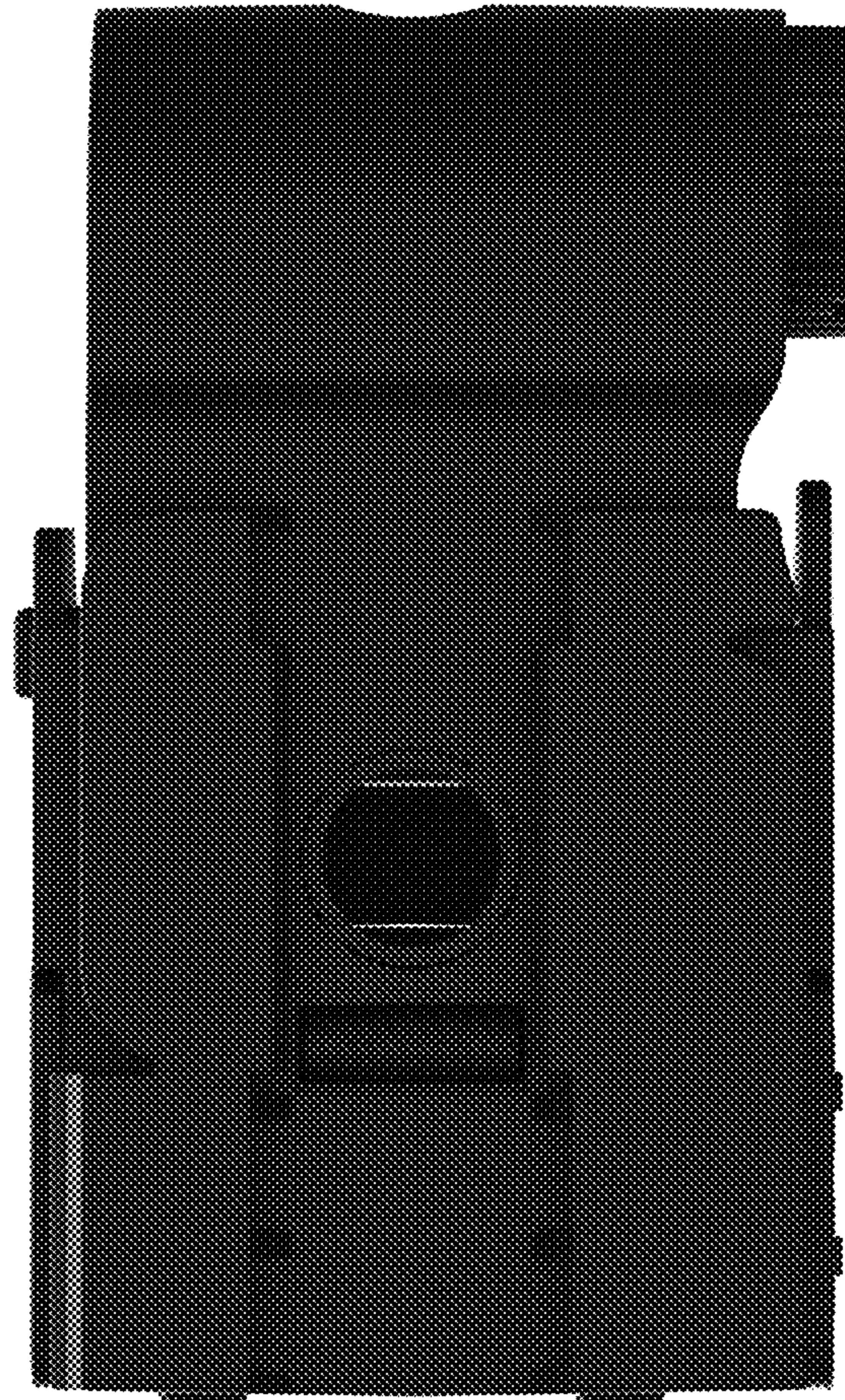

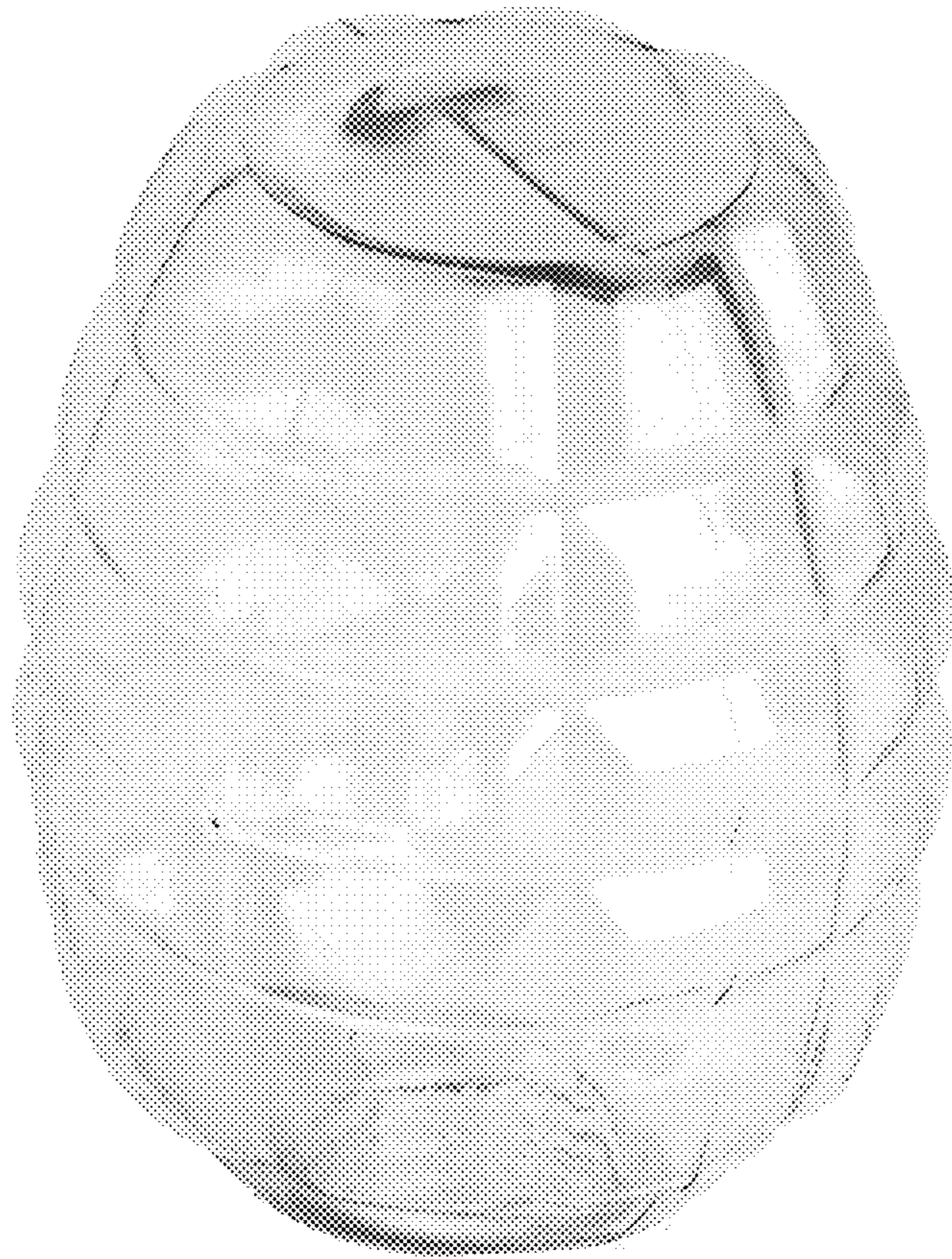

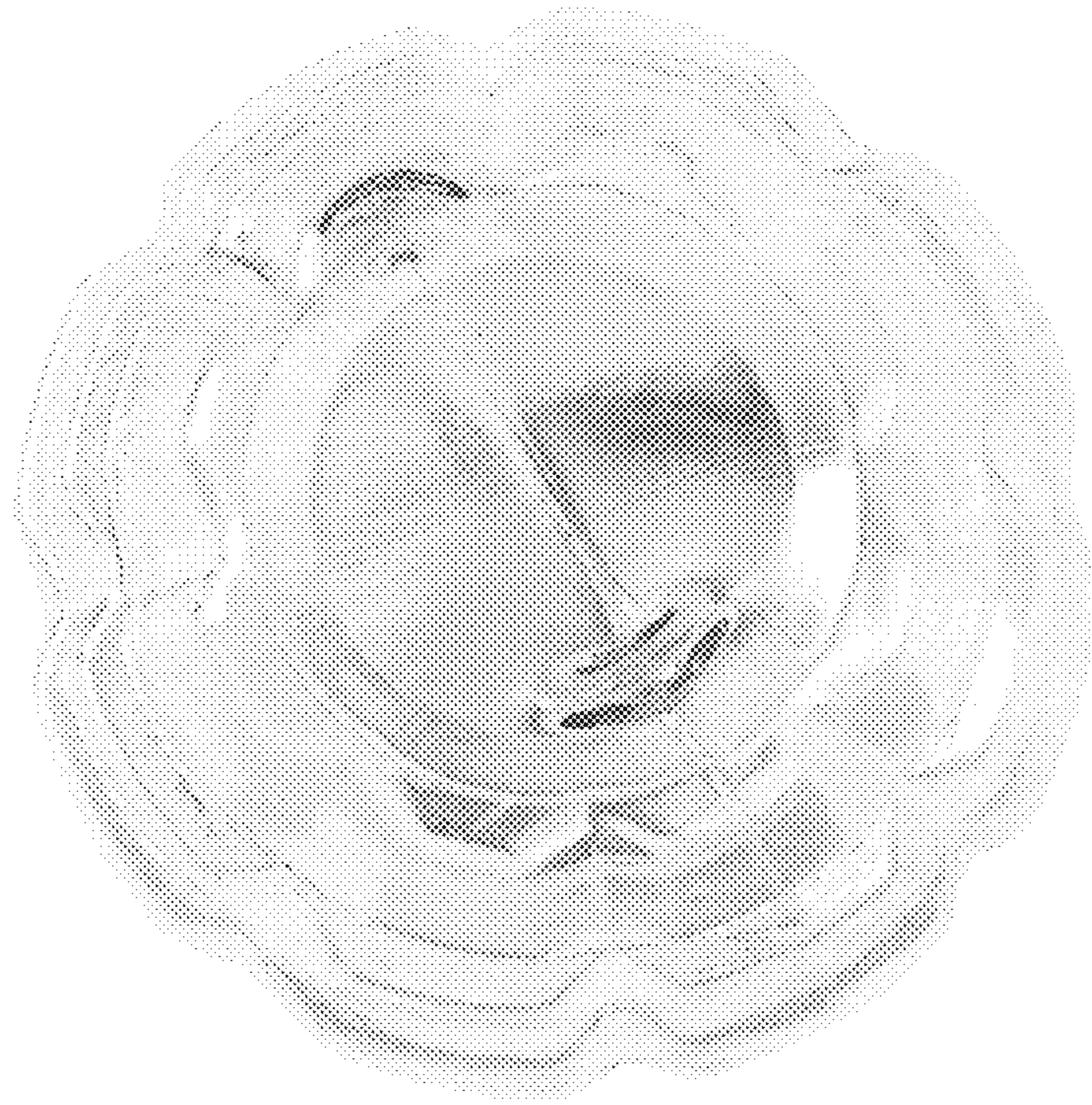

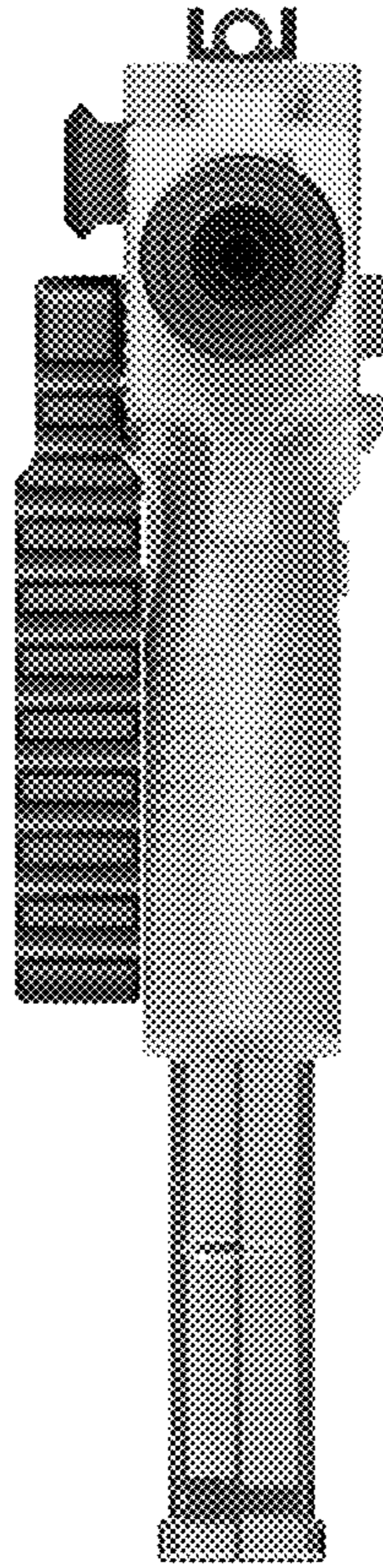

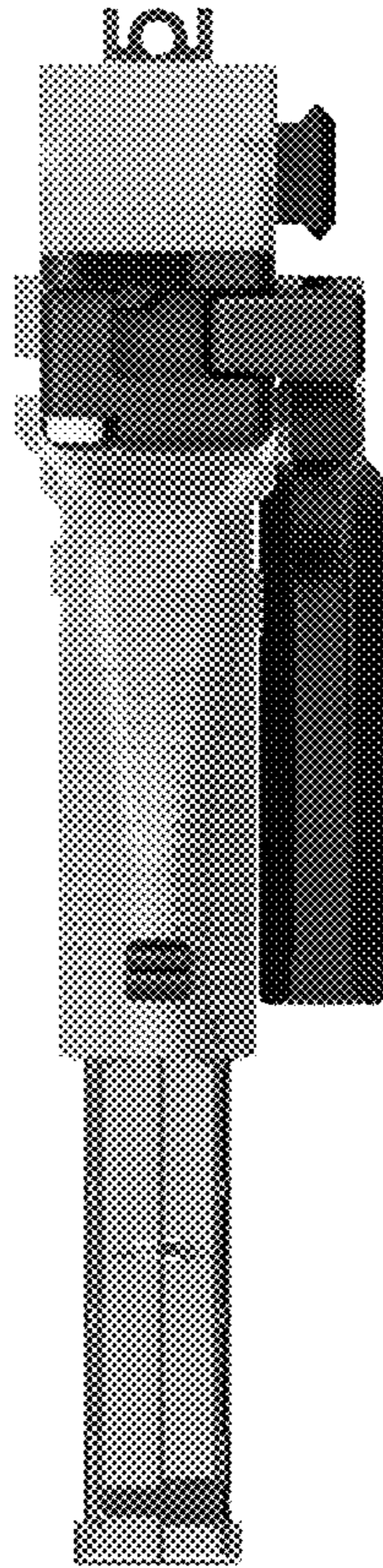

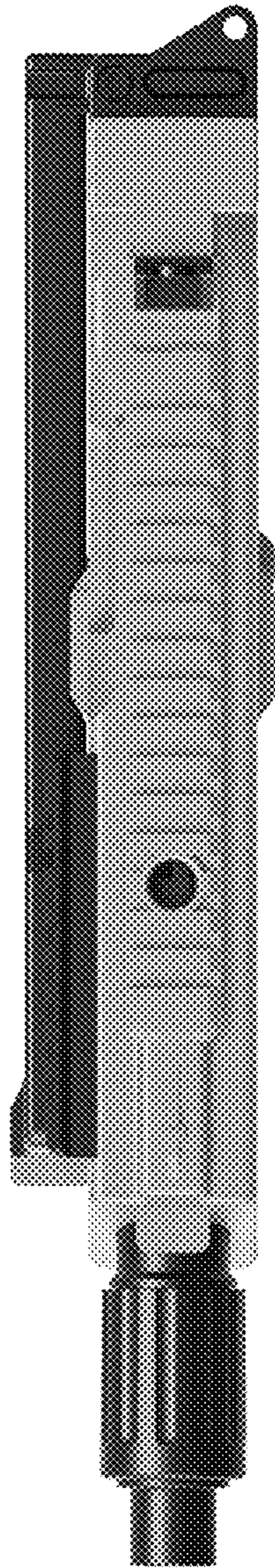

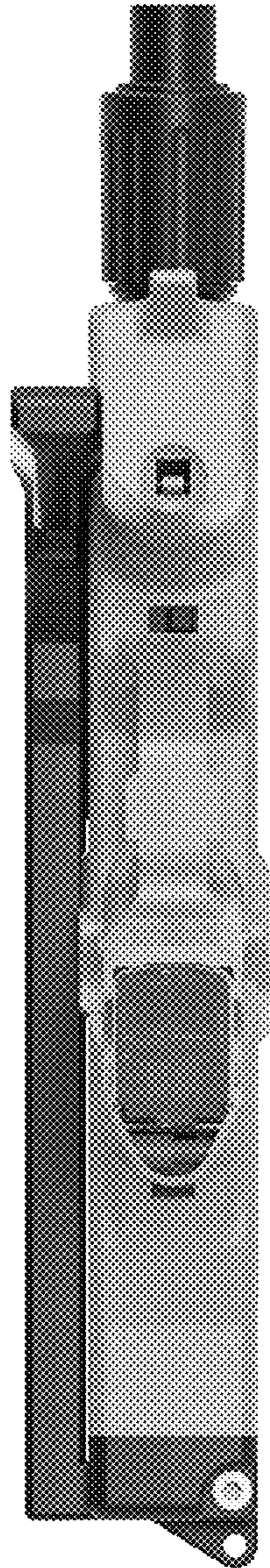

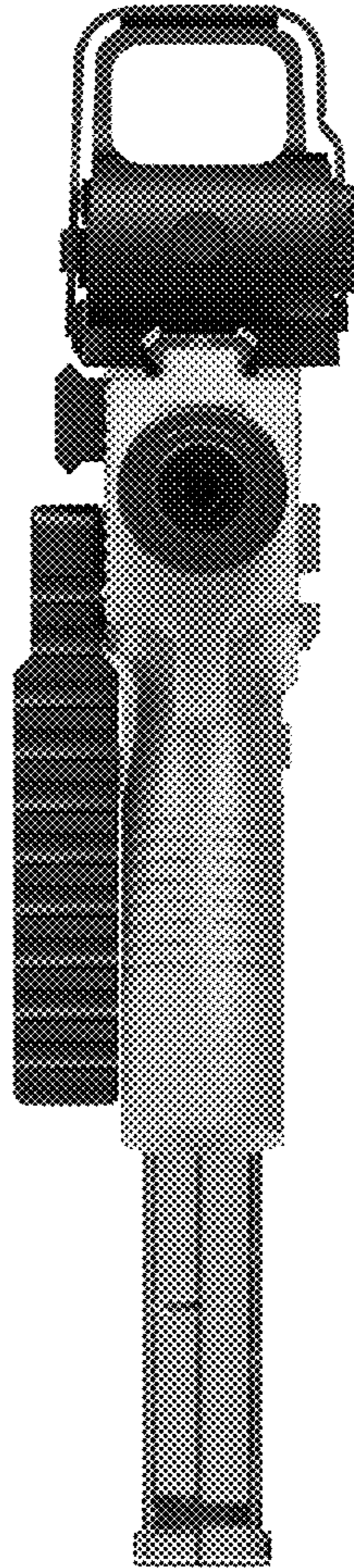

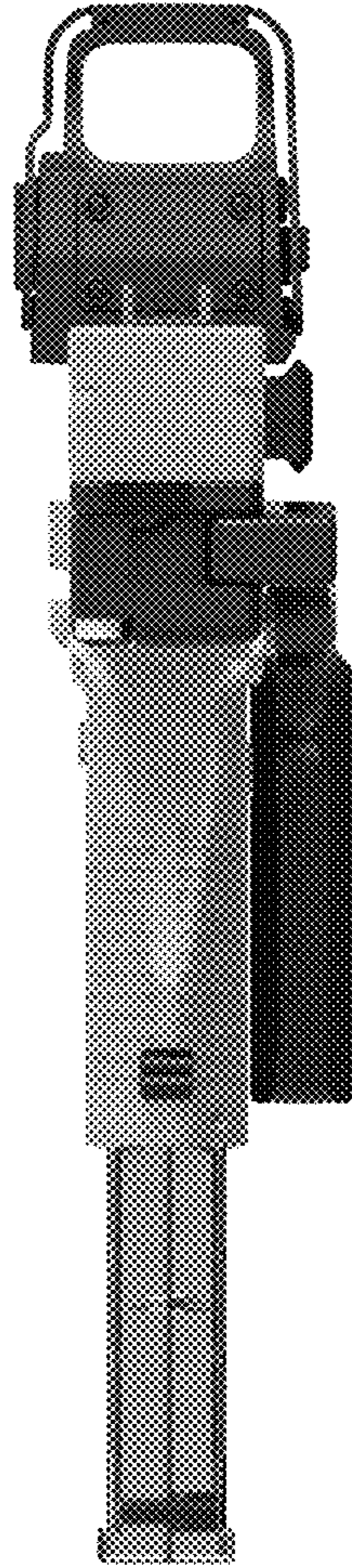

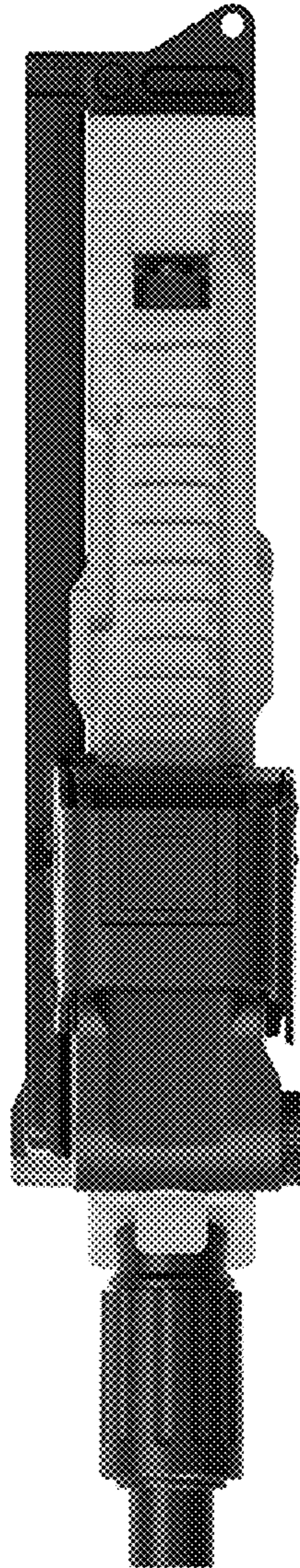

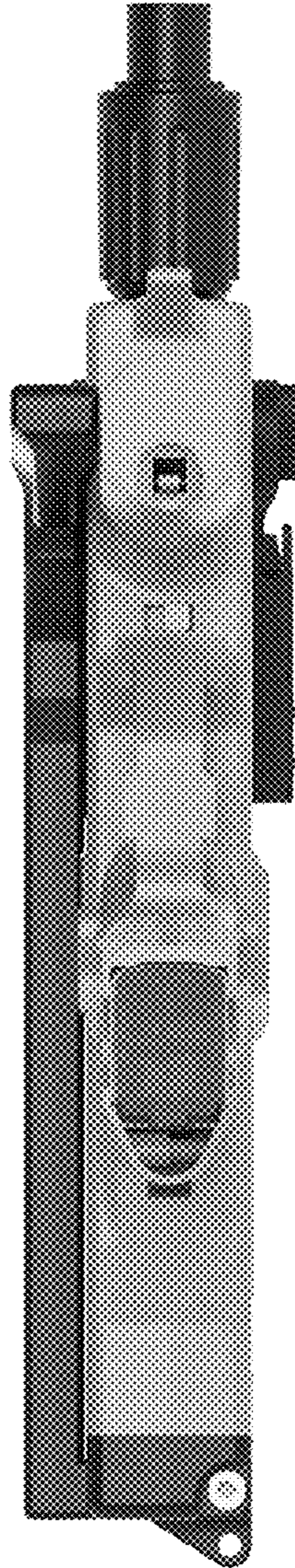

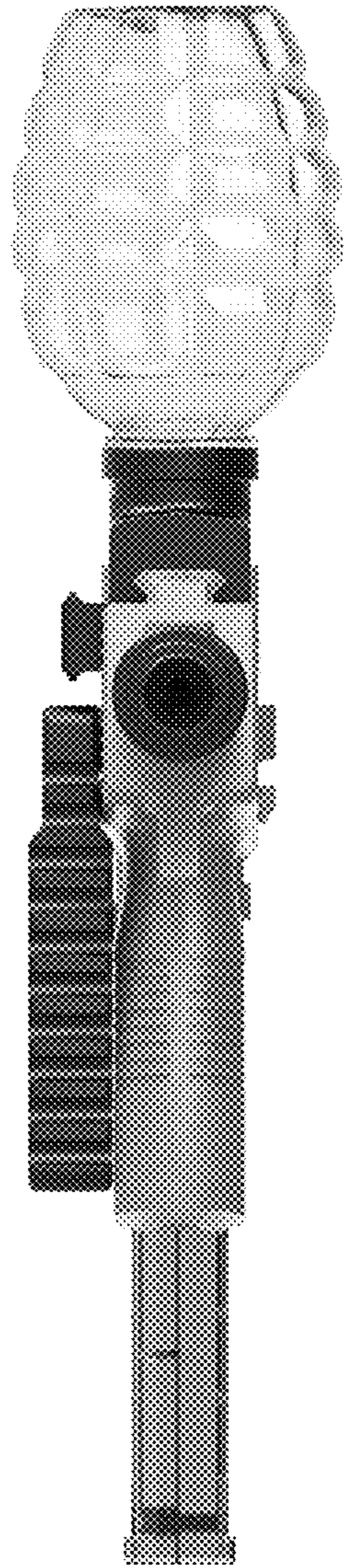

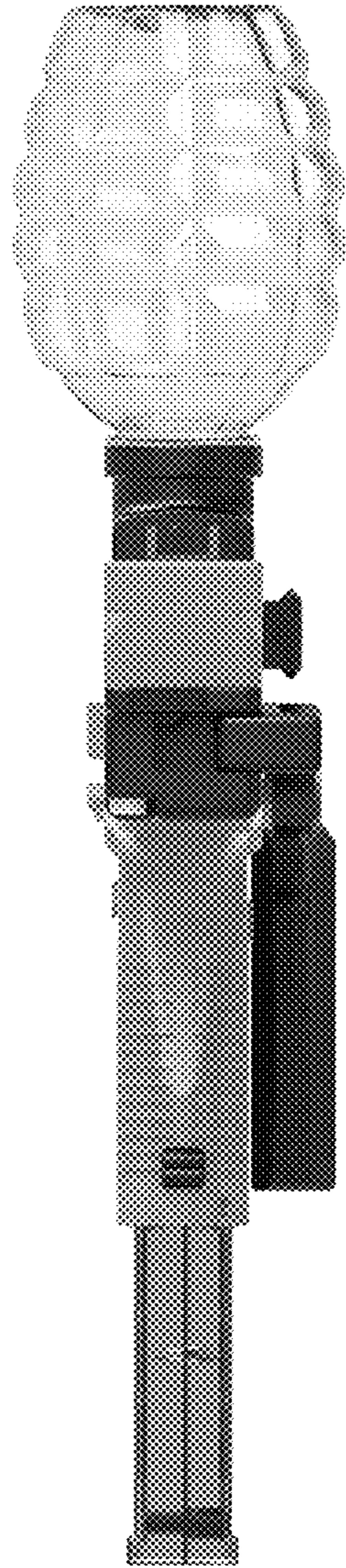

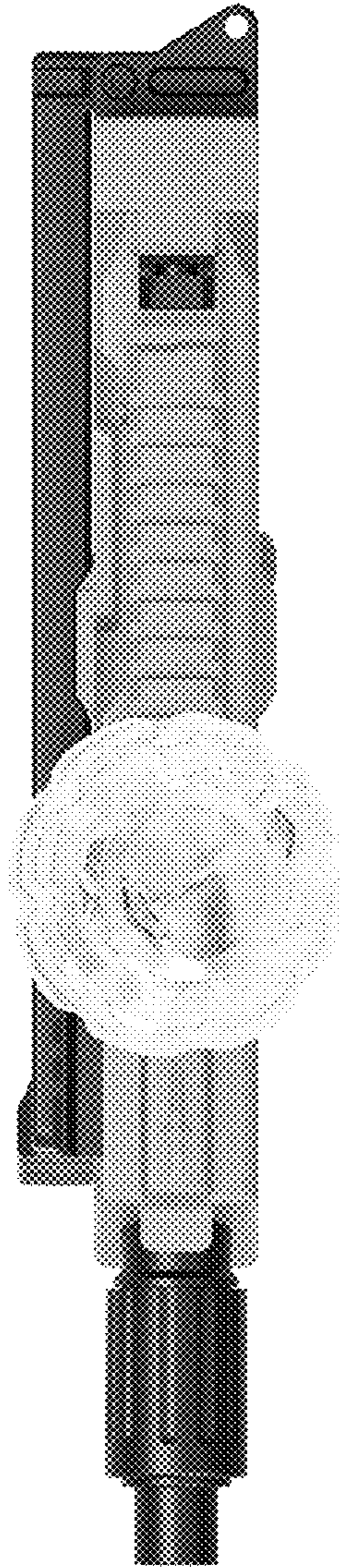

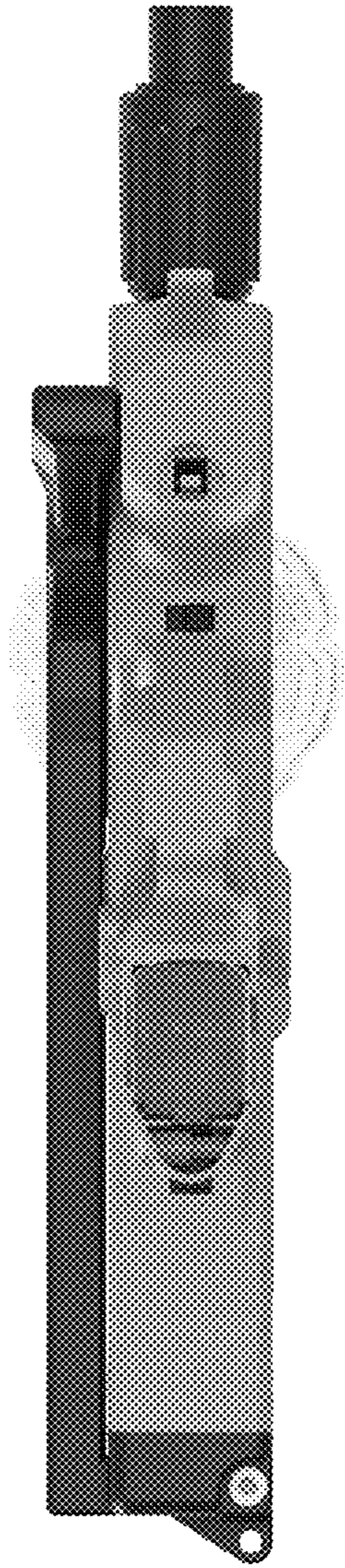
