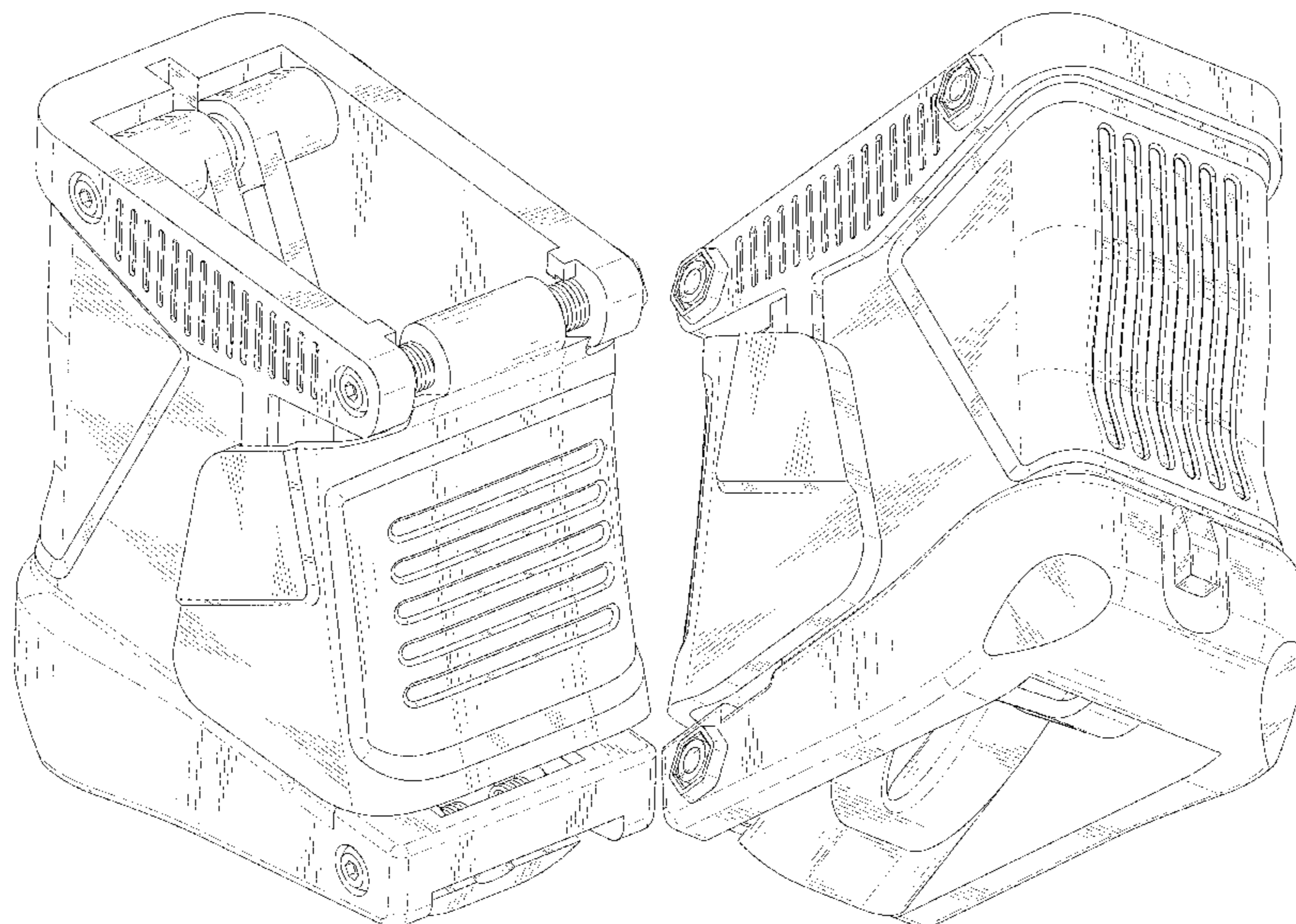
(57) **CLAIM**

The ornamental design for a magazine speed loader, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a magazine speed loader showing my new design;

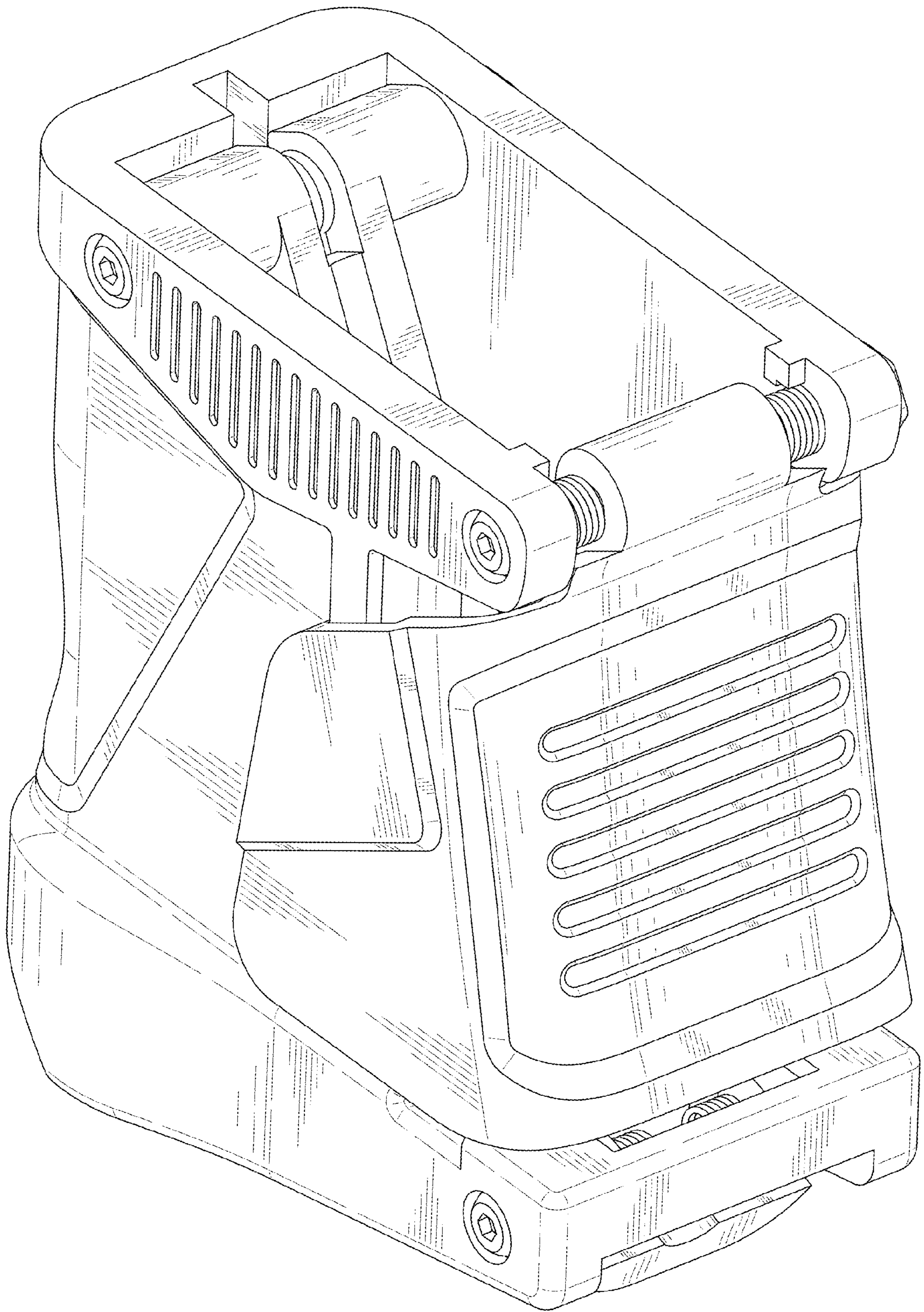

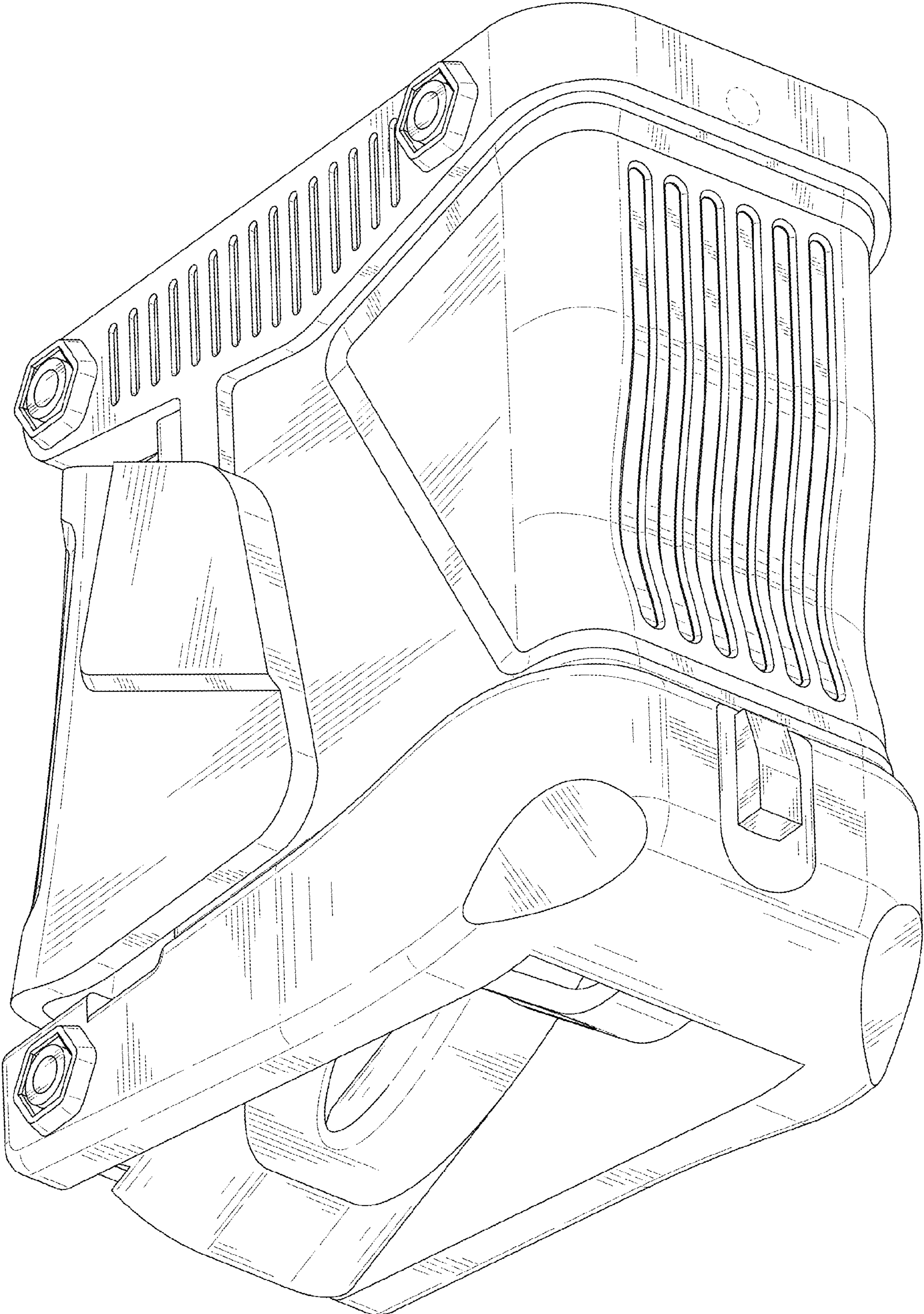

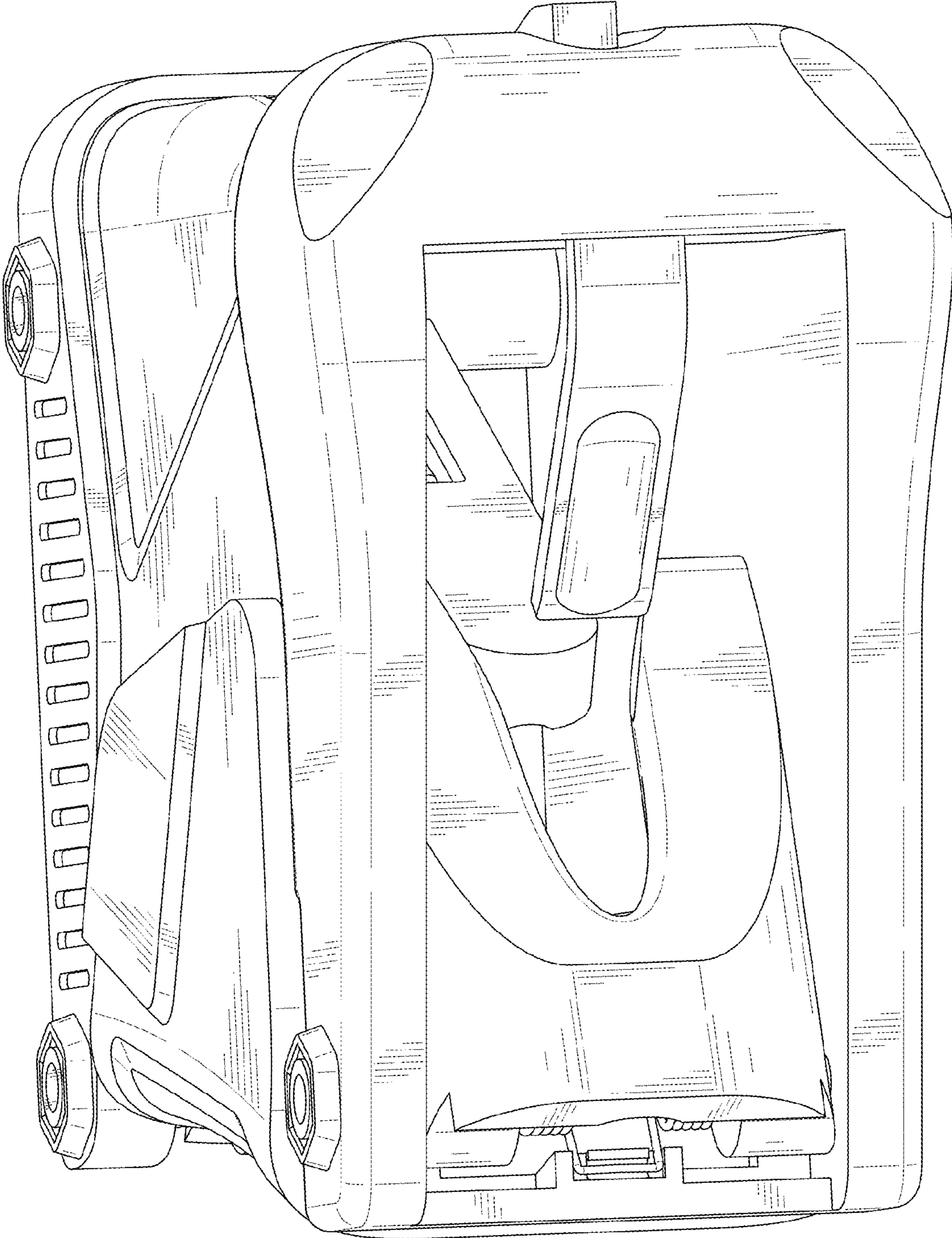

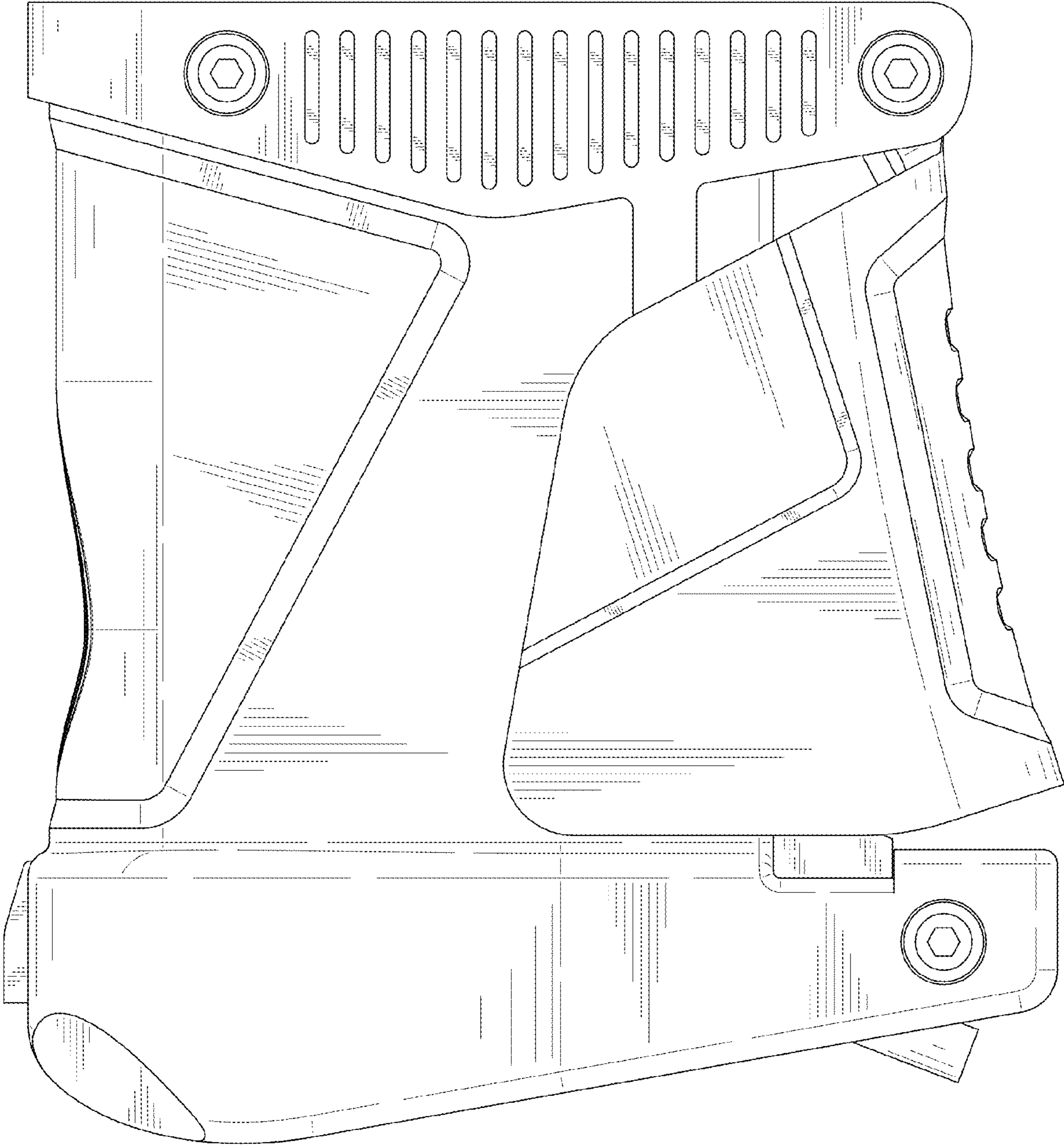

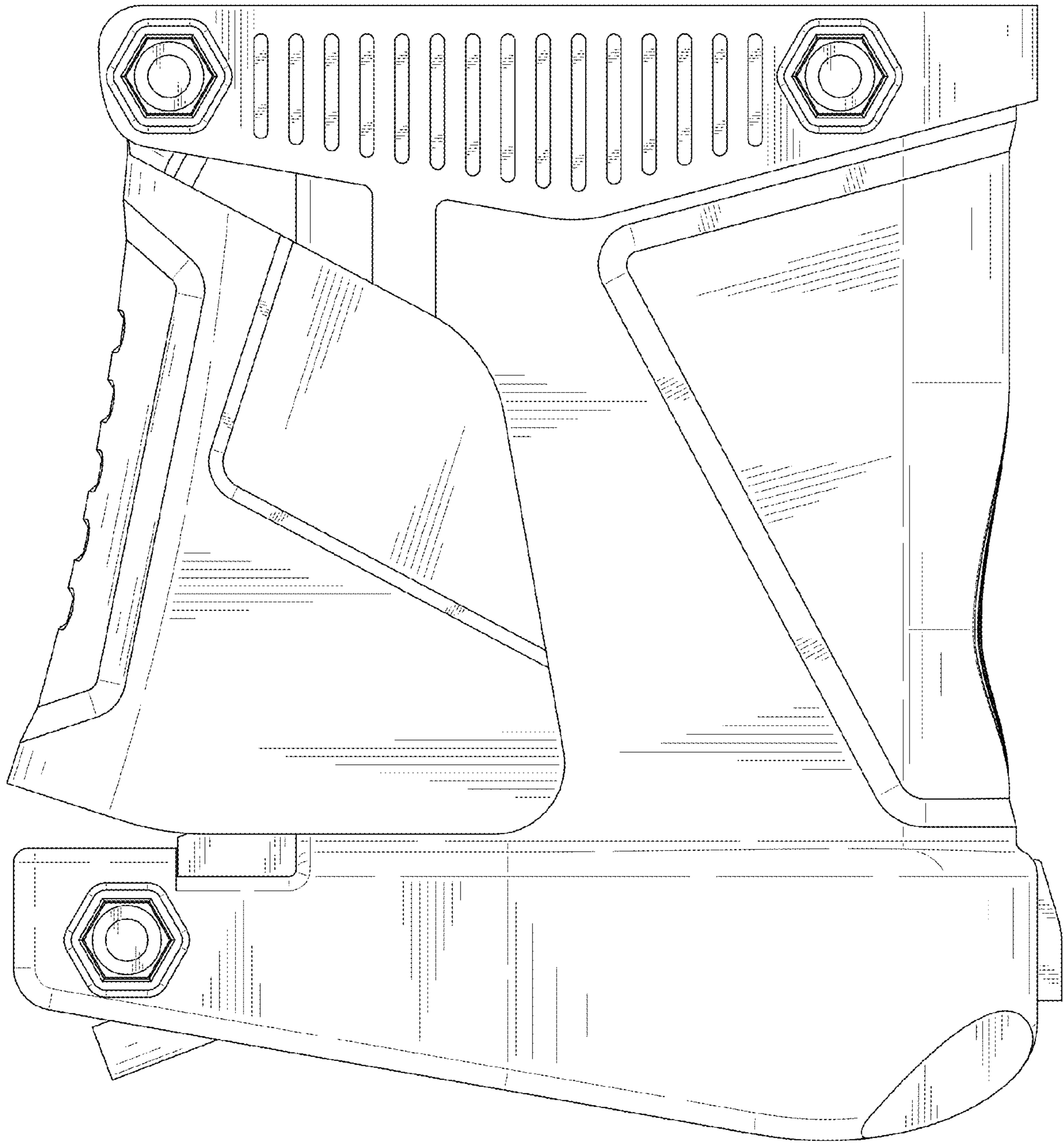

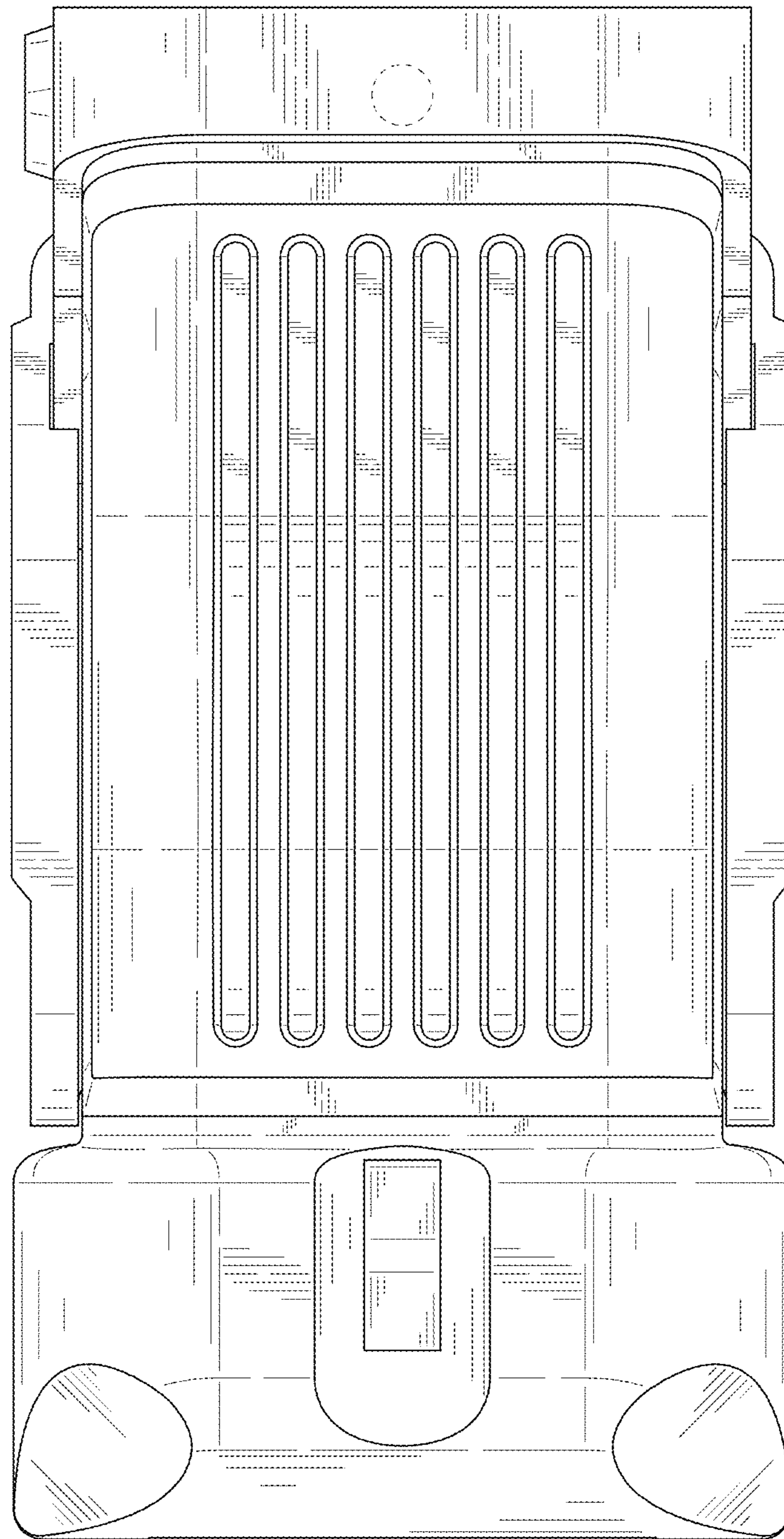

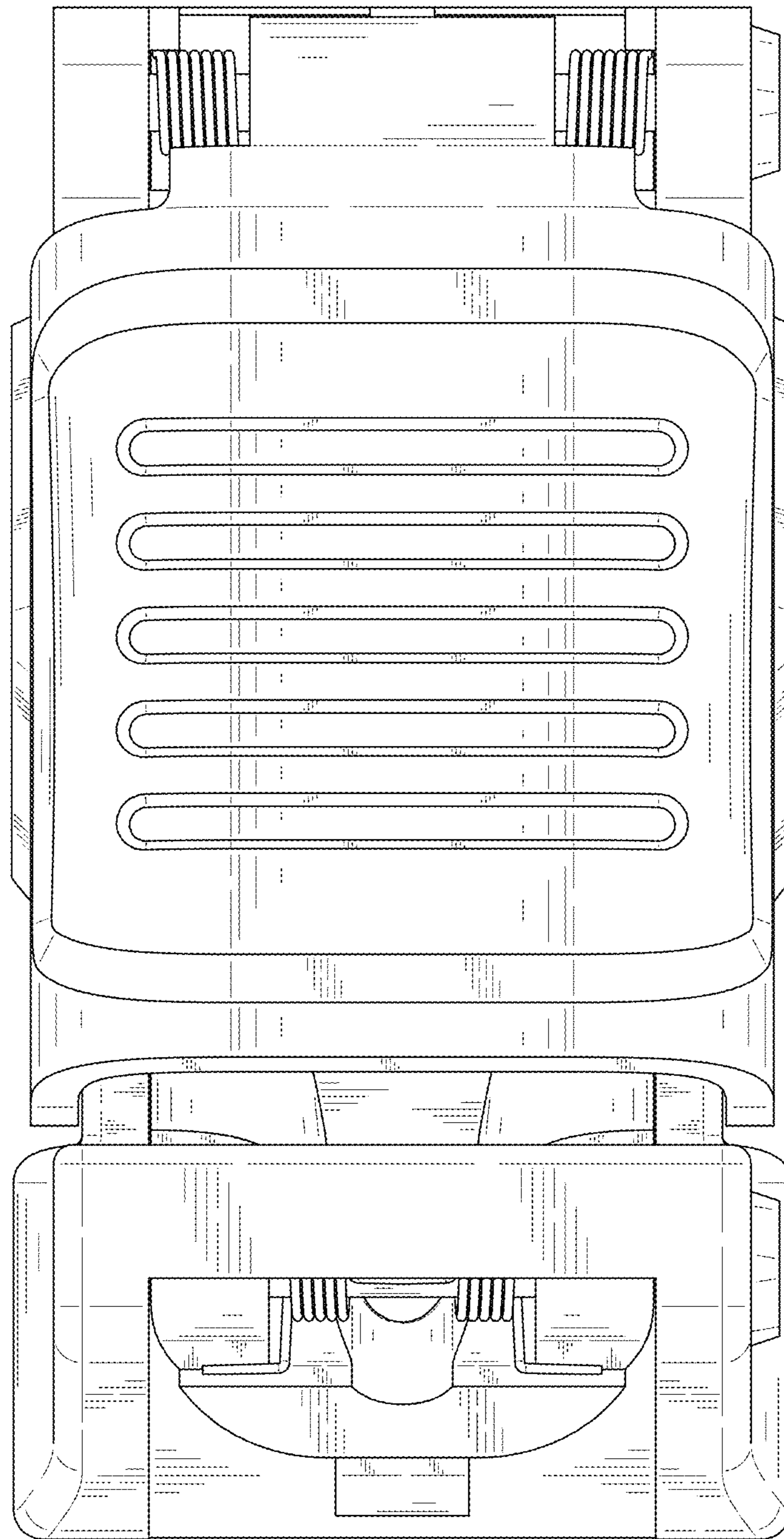

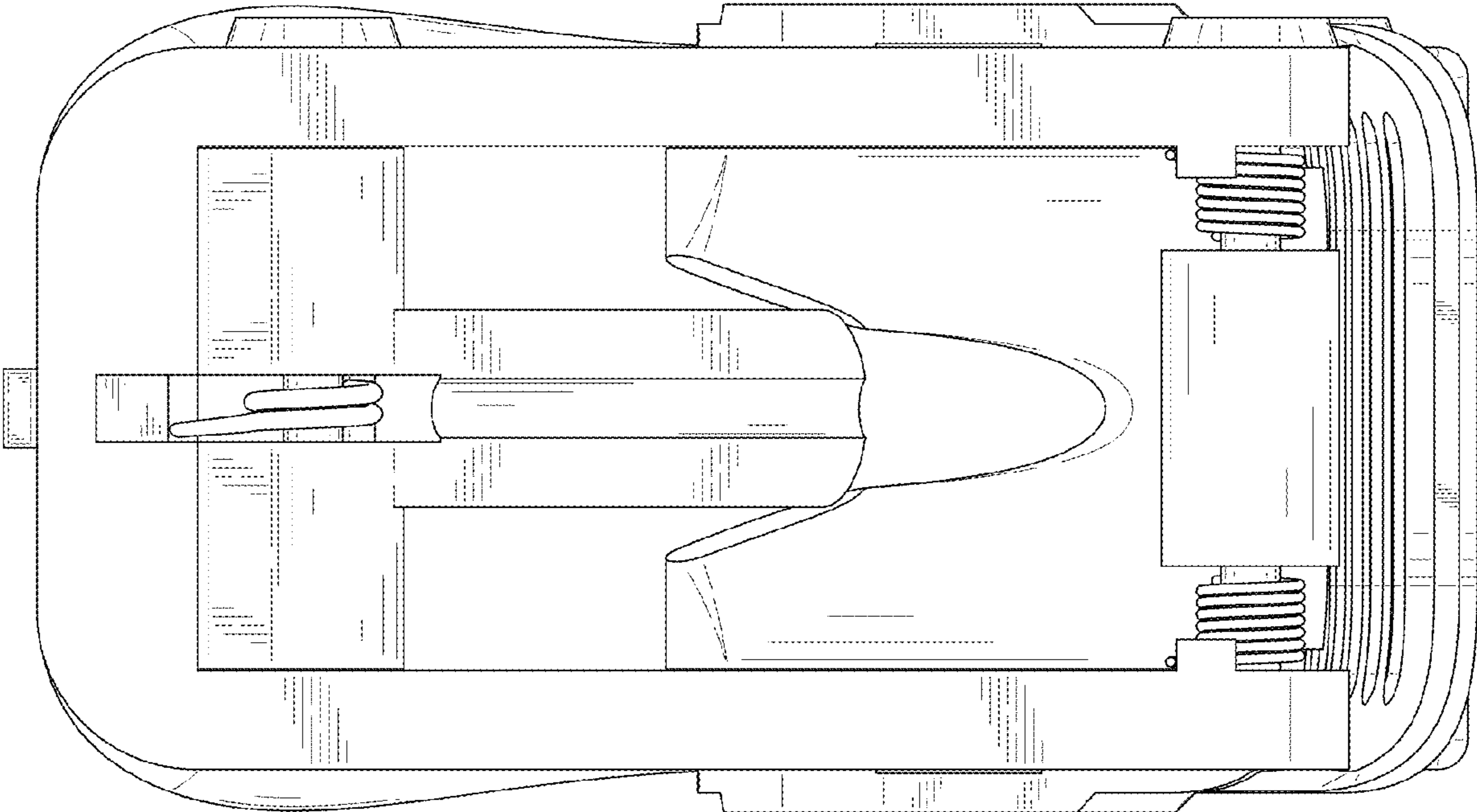

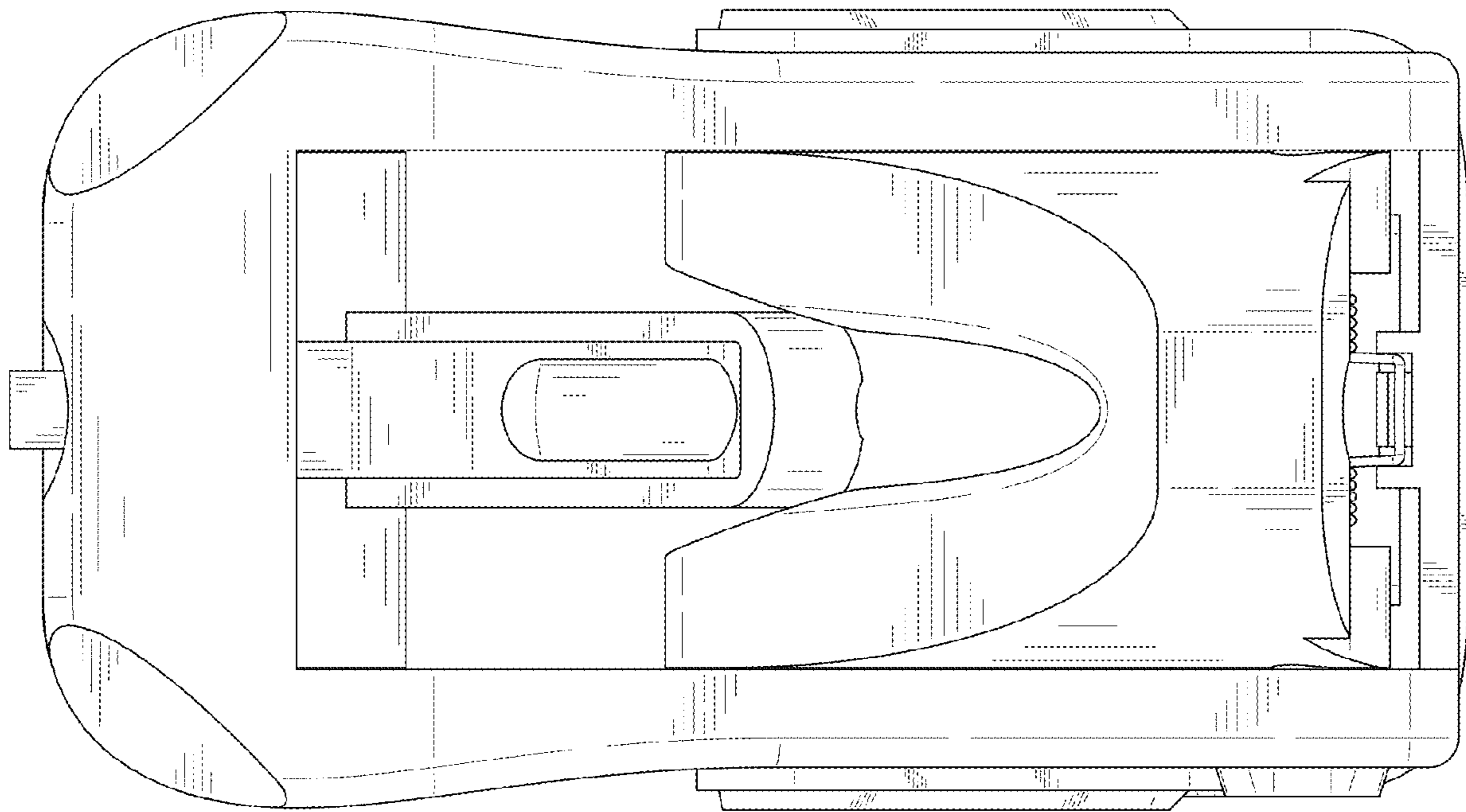
