(57) **CLAIM**

The ornamental design for a surgical forceps, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and right side perspective view of a surgical forceps in a fully opened position showing my new design.

FIG. 2 is an enlarged front elevation view of the surgical forceps of FIG. 1.

FIG. 3 is an enlarged rear elevation view of the surgical forceps of FIG. 1.

FIG. 4 is a left side elevation view of the surgical forceps of FIG. 1.

FIG. 5 is a right side elevation view of the surgical forceps of FIG. 1.

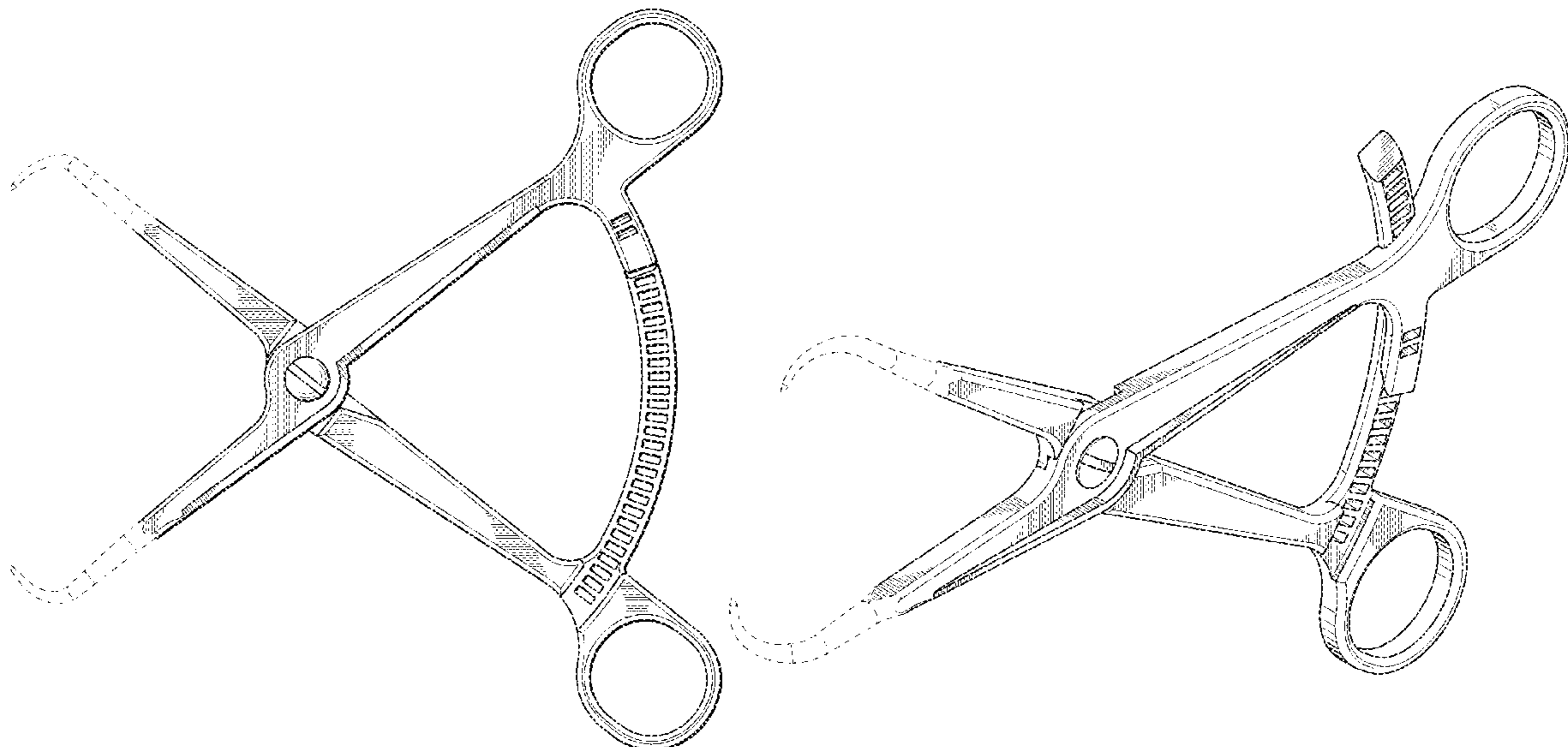
FIG. 6 is an enlarged top plan view of the surgical forceps of FIG. 1.

FIG. 7 is an enlarged bottom plan view of the surgical forceps of FIG. 1; and,

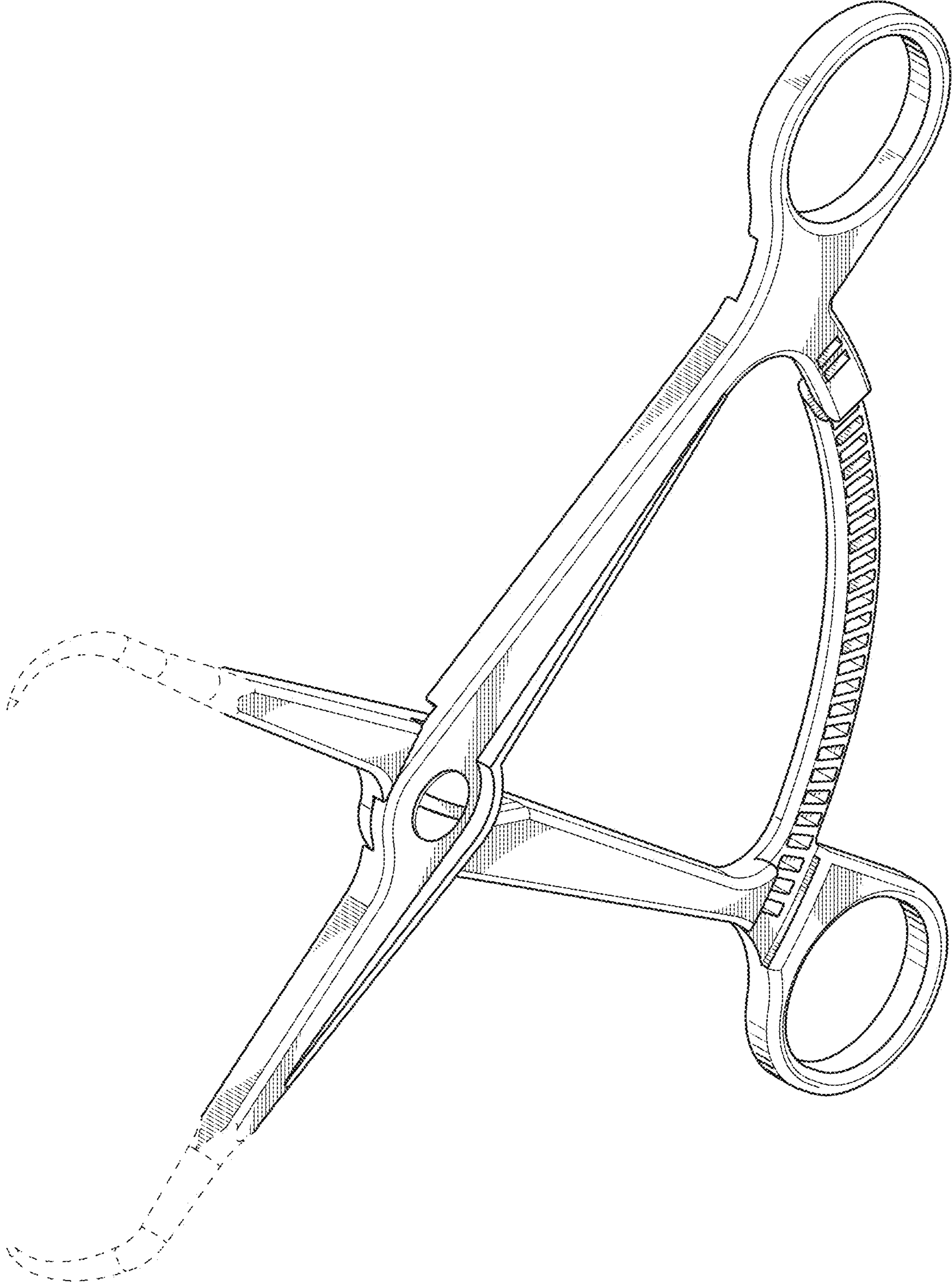

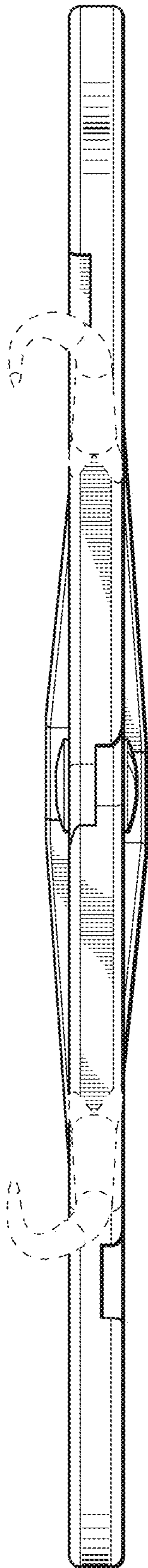

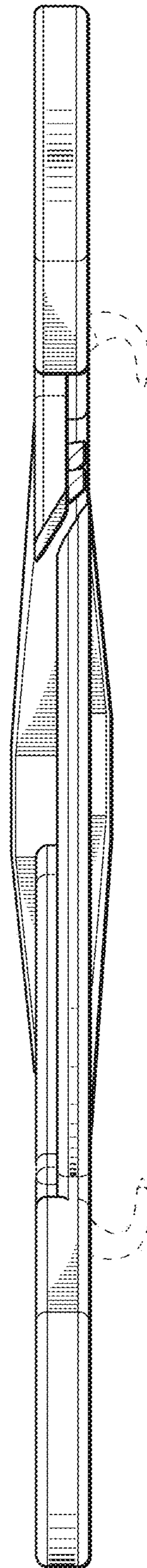

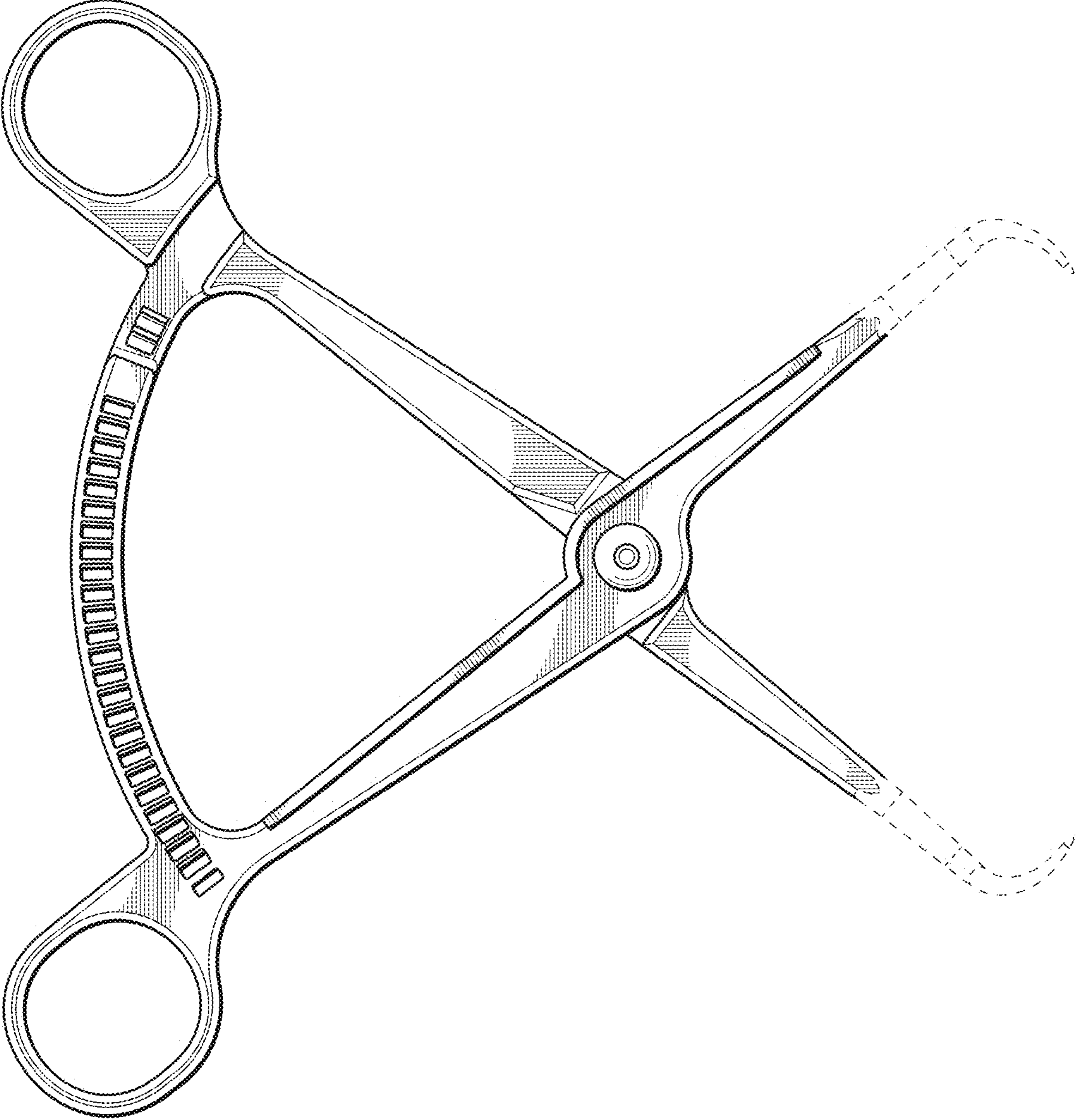

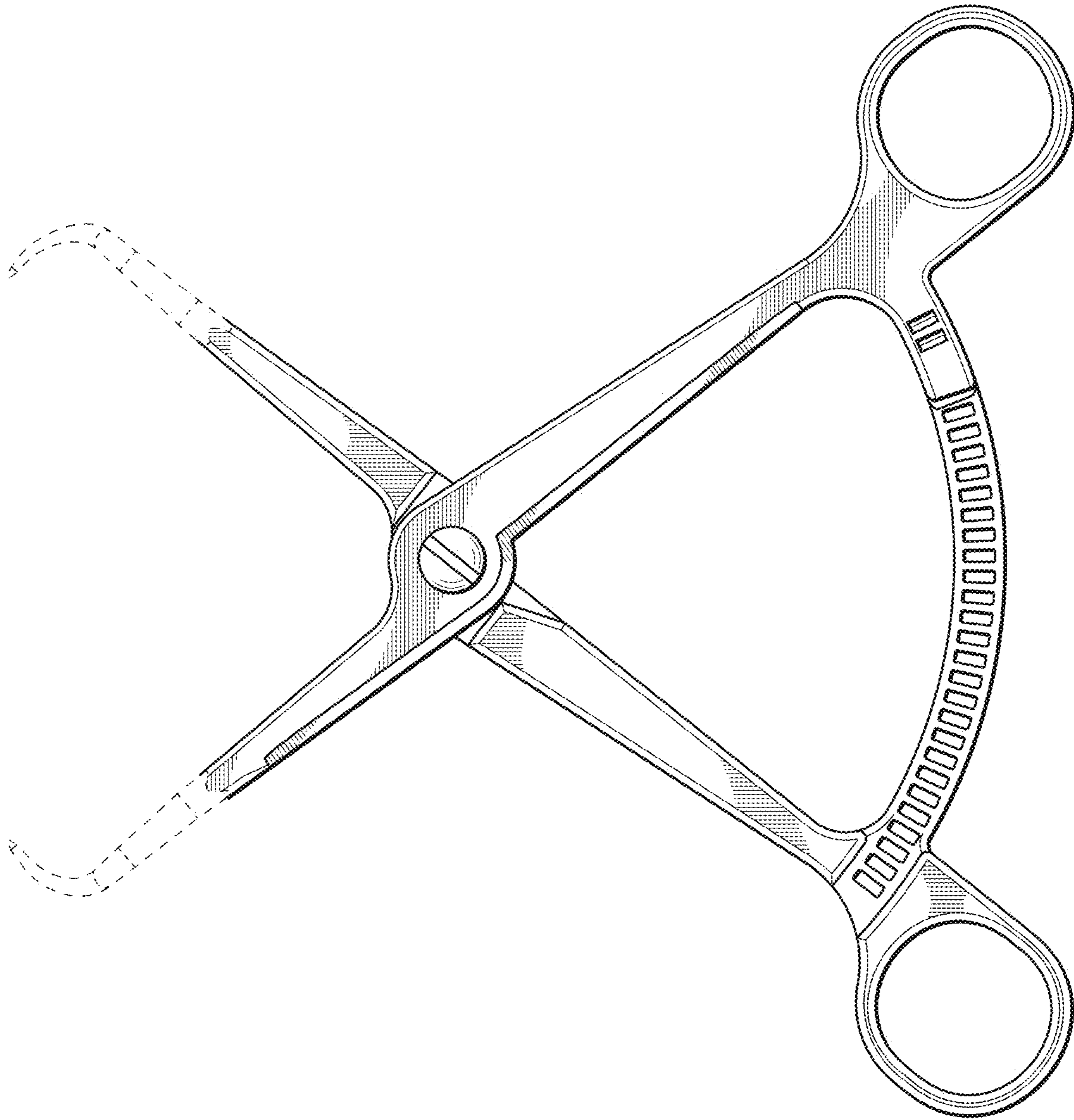

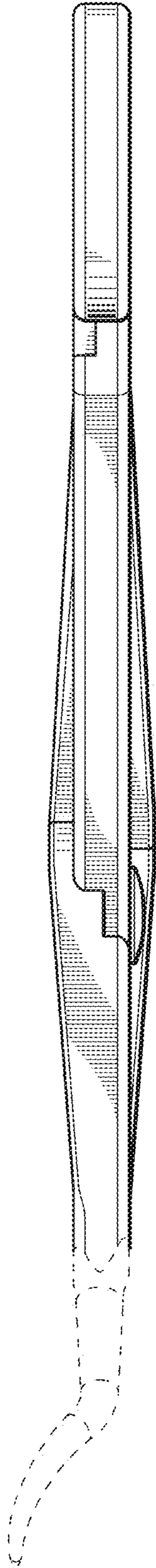

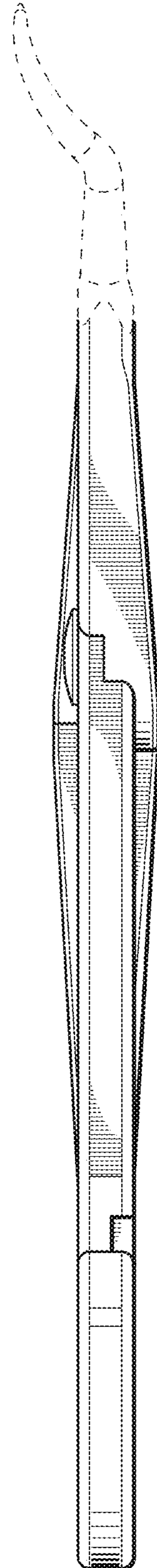

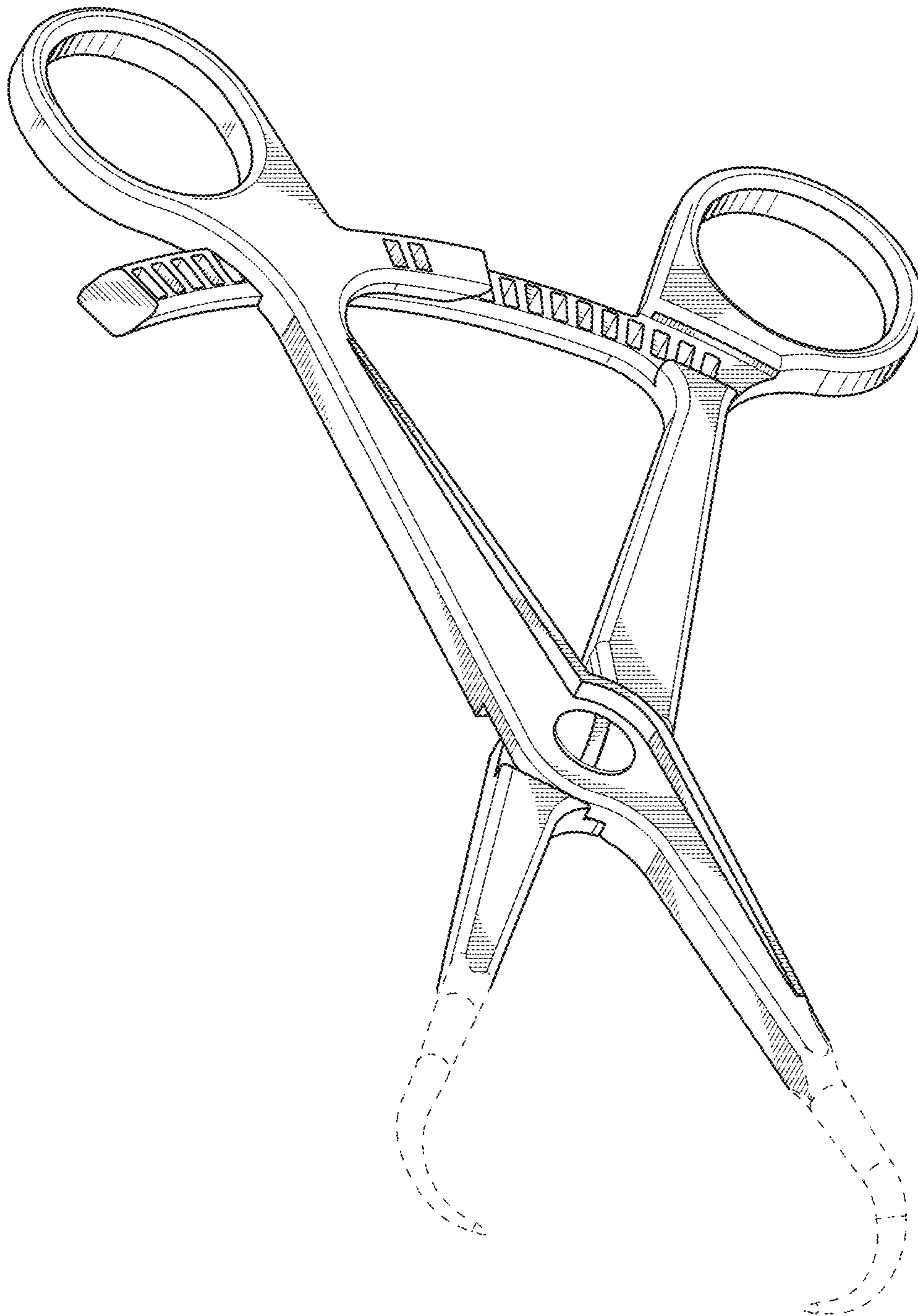
