DESCRIPTION

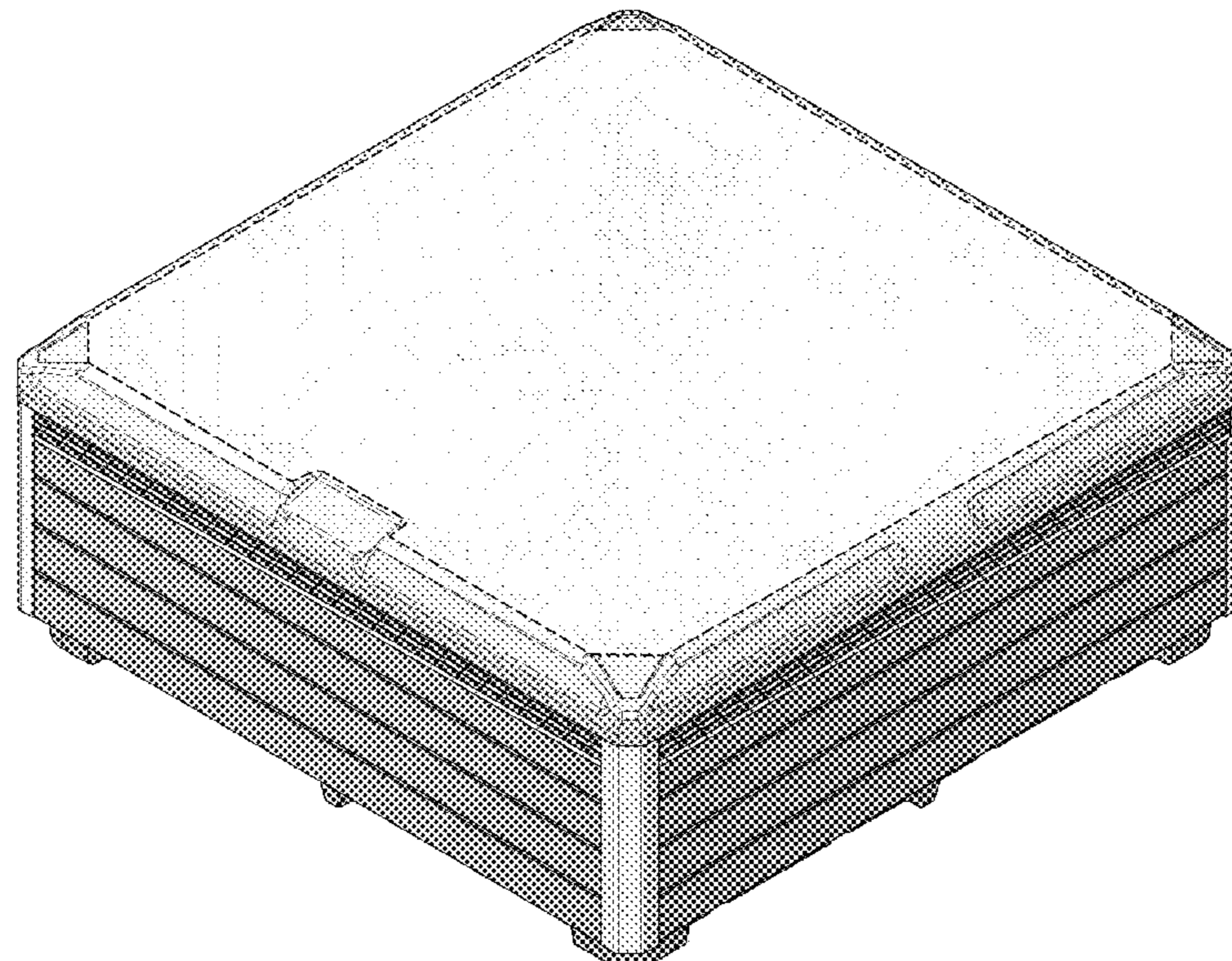
FIG. 1 is a front right top perspective view of a spa according to the present invention.

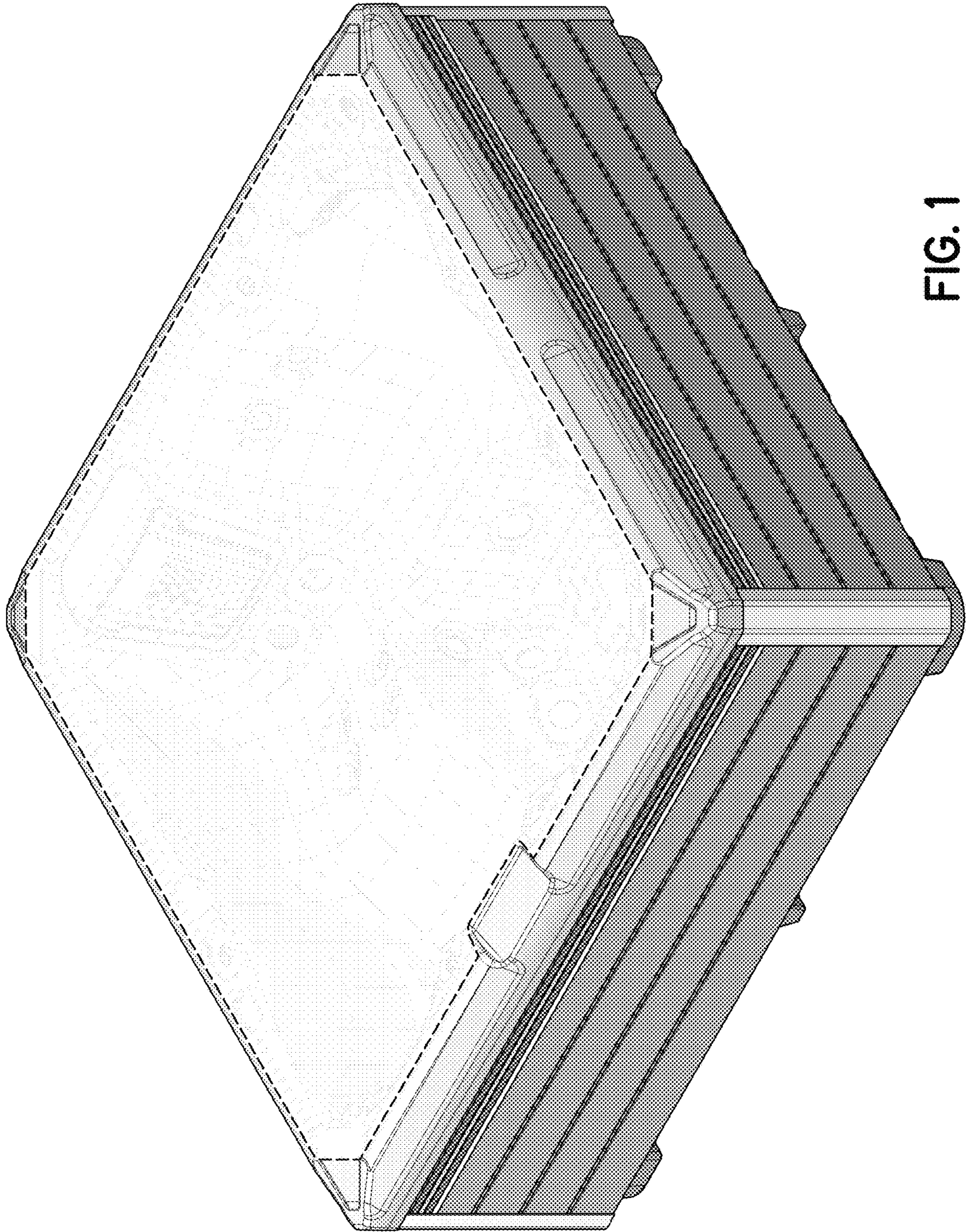

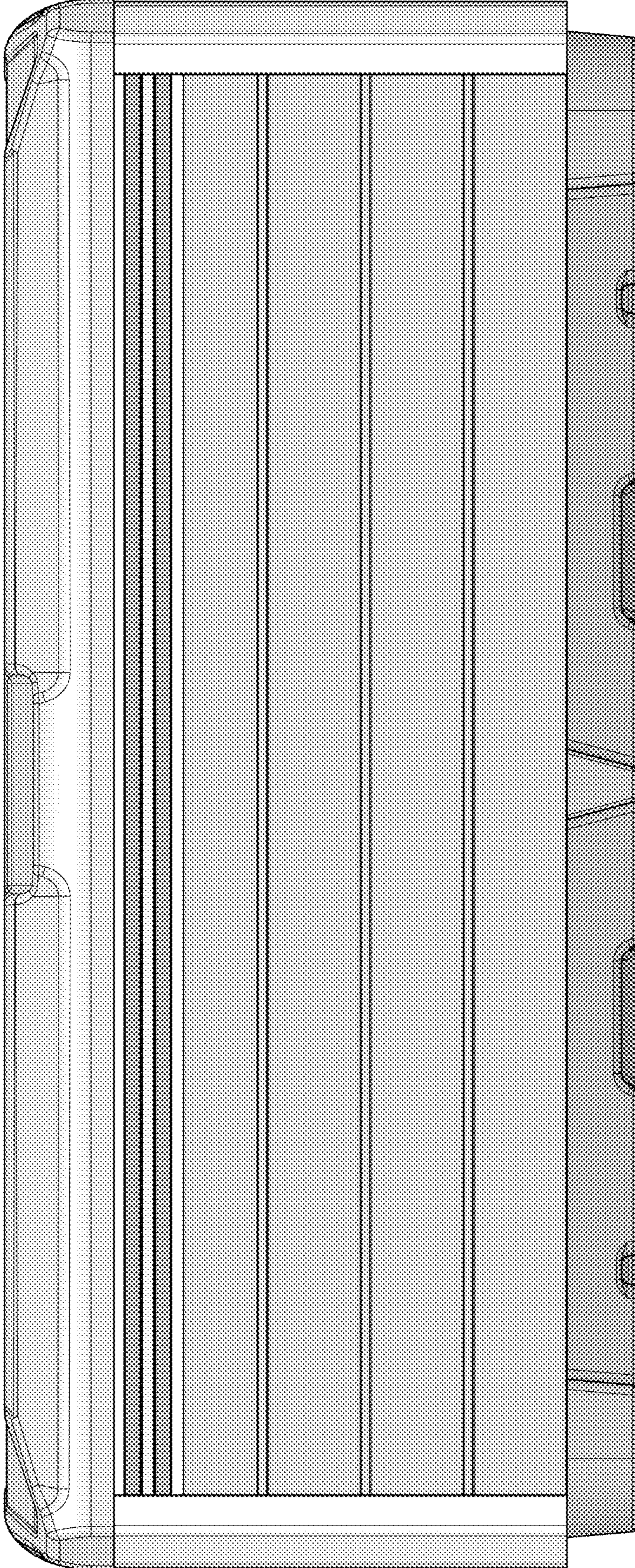

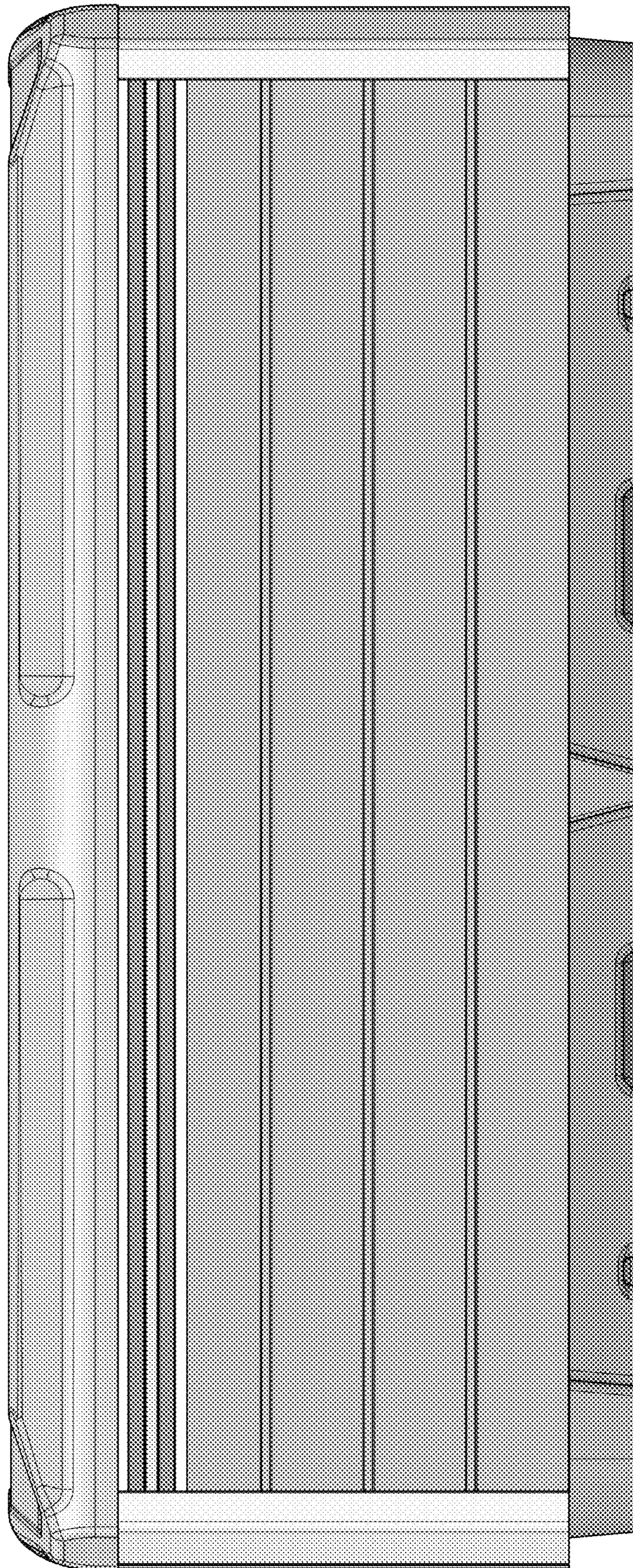

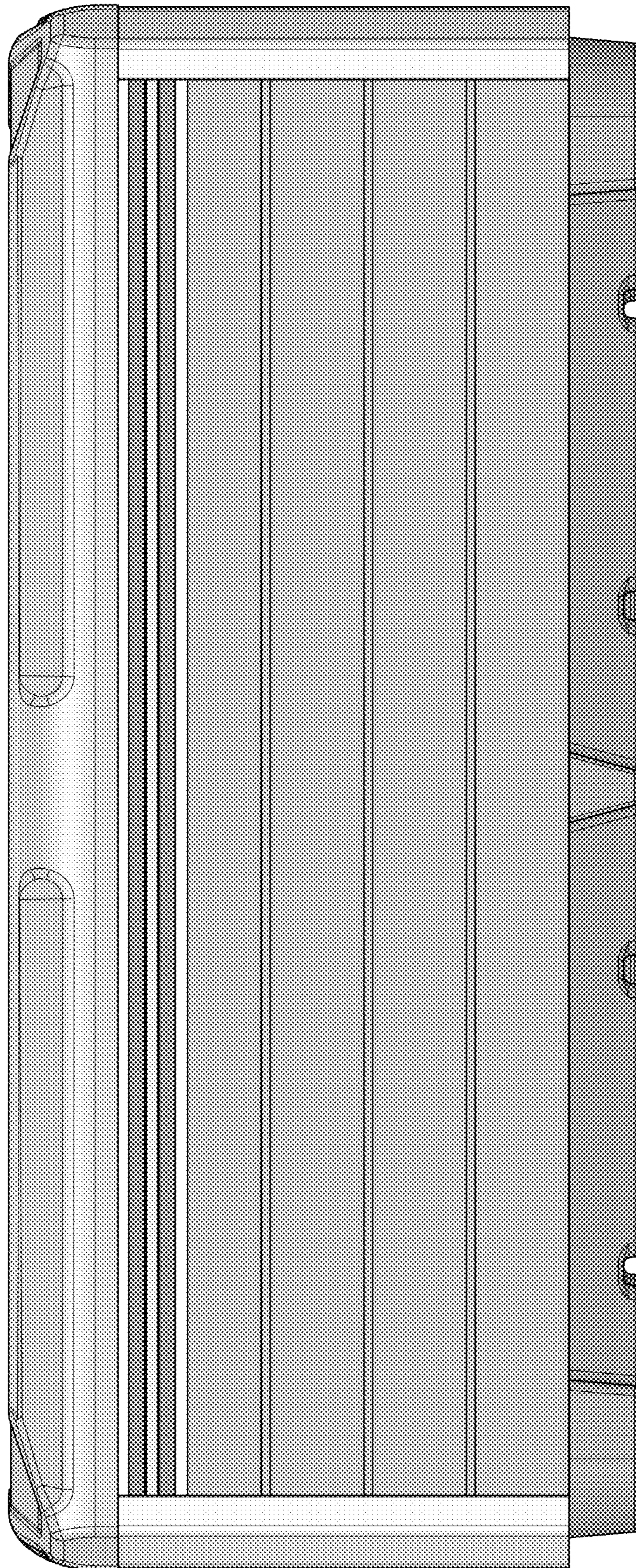

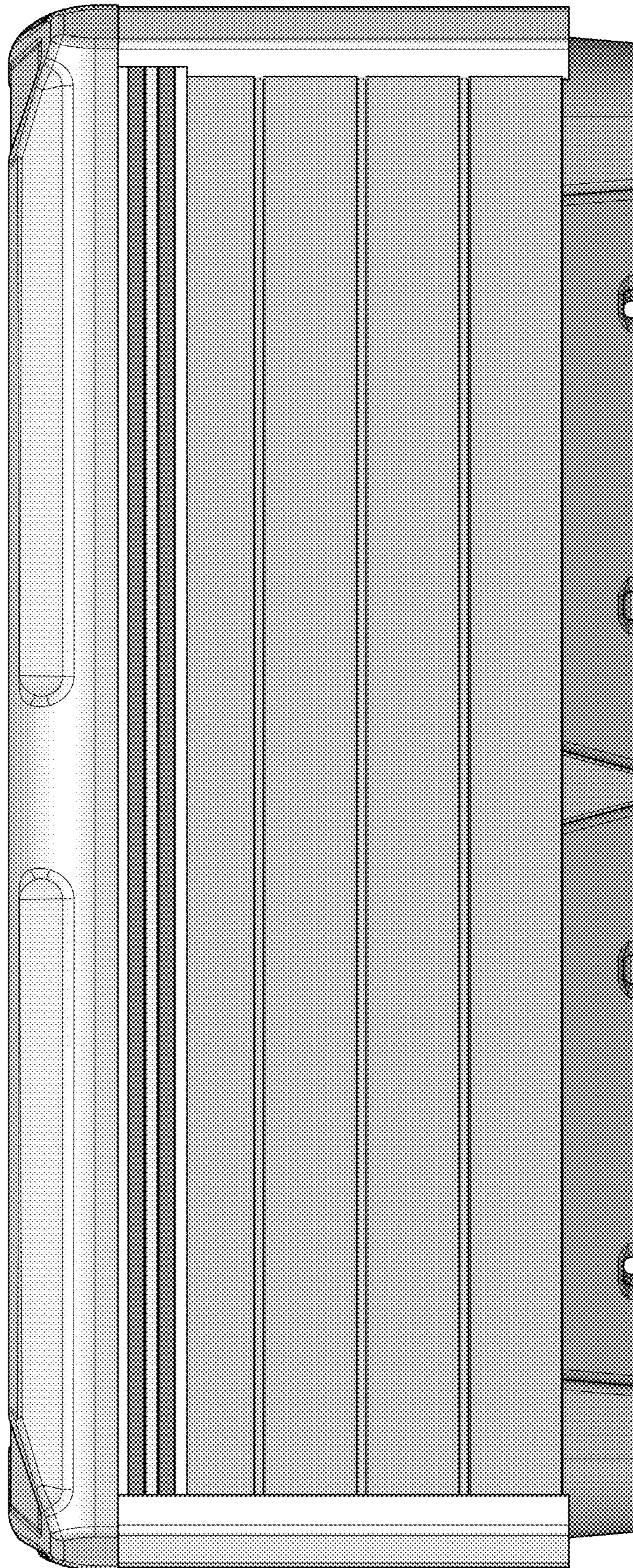

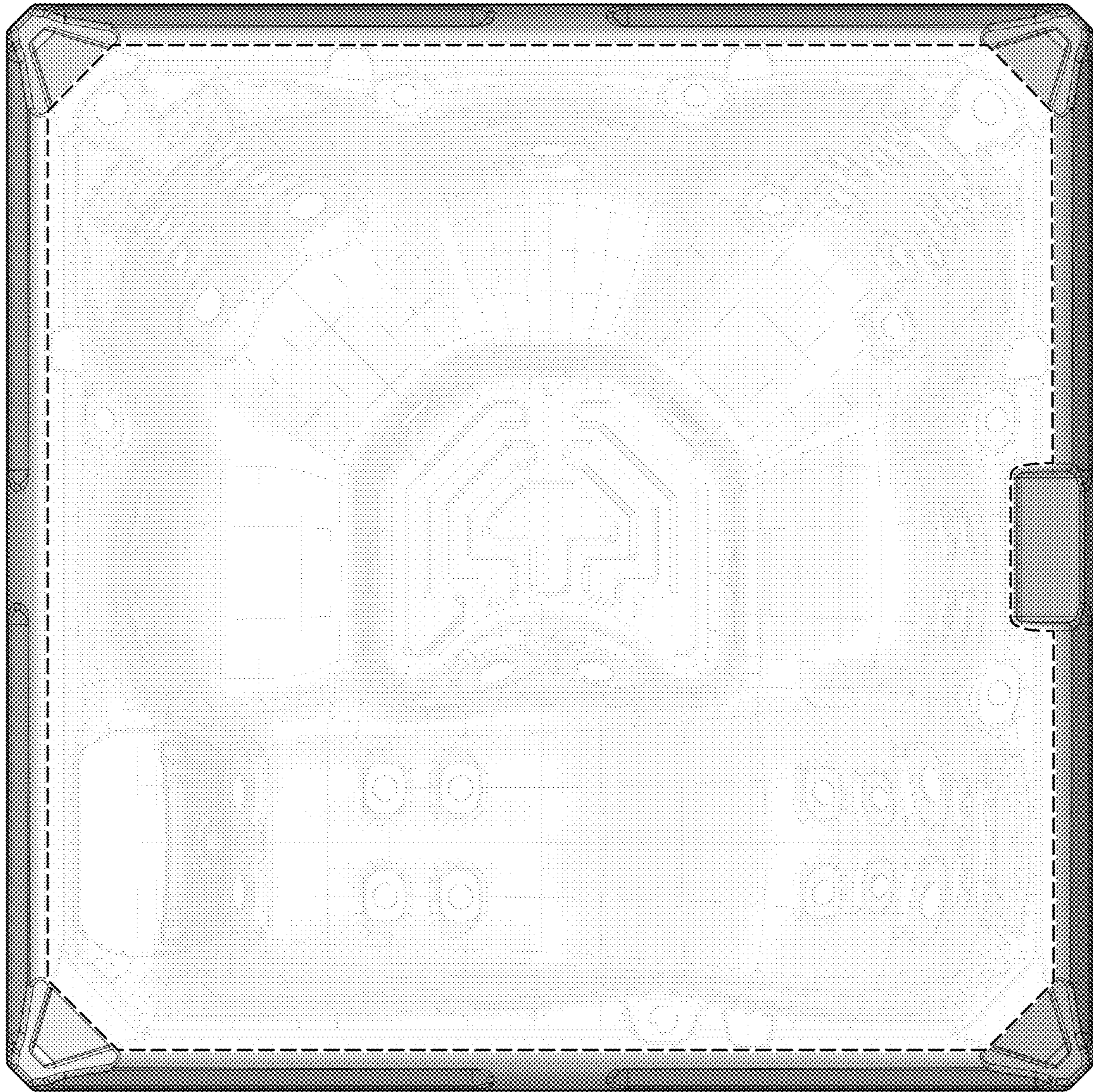

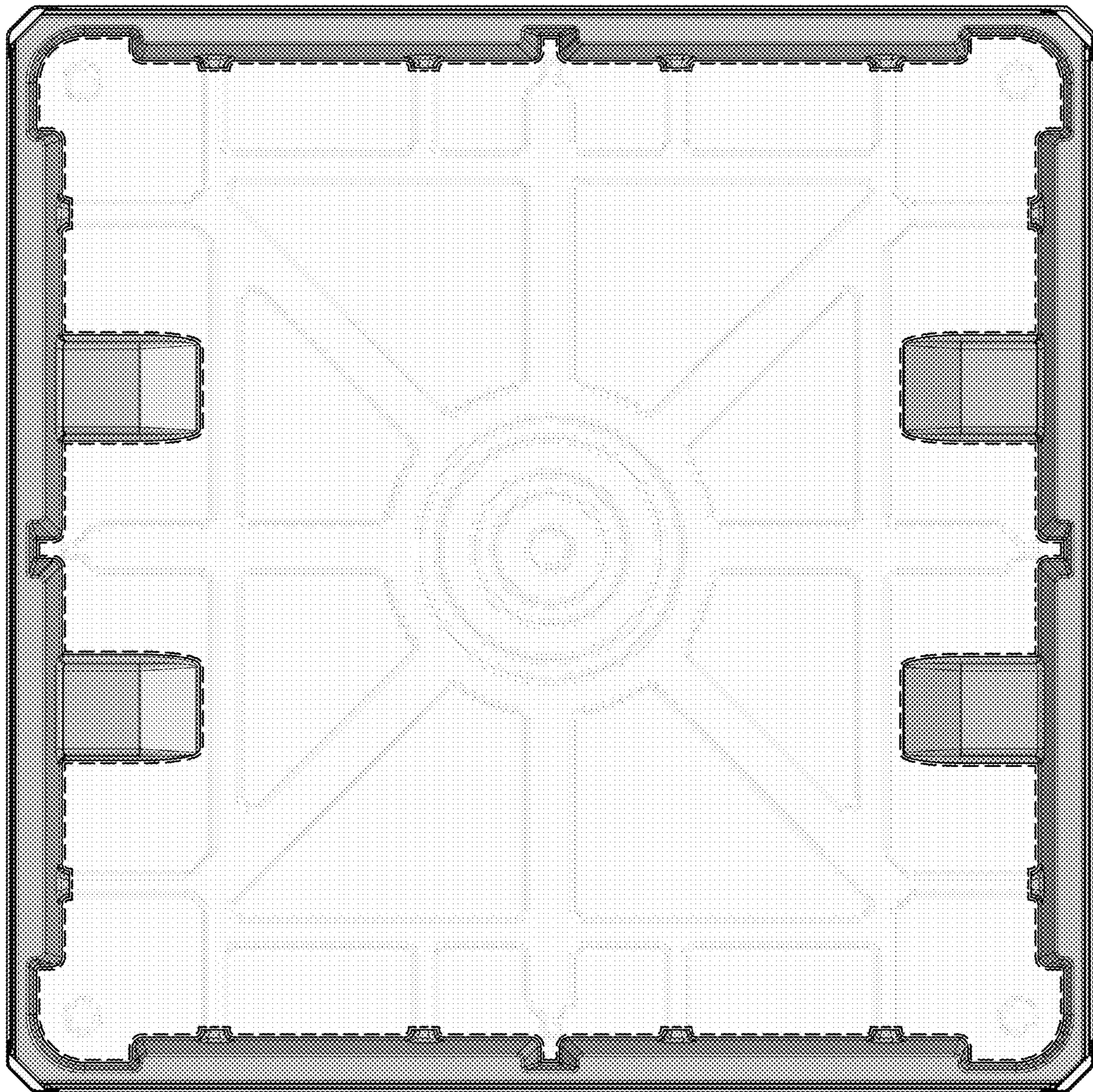
