FIG. 11 is a first end profile view of the light showing my design in a second configuration.

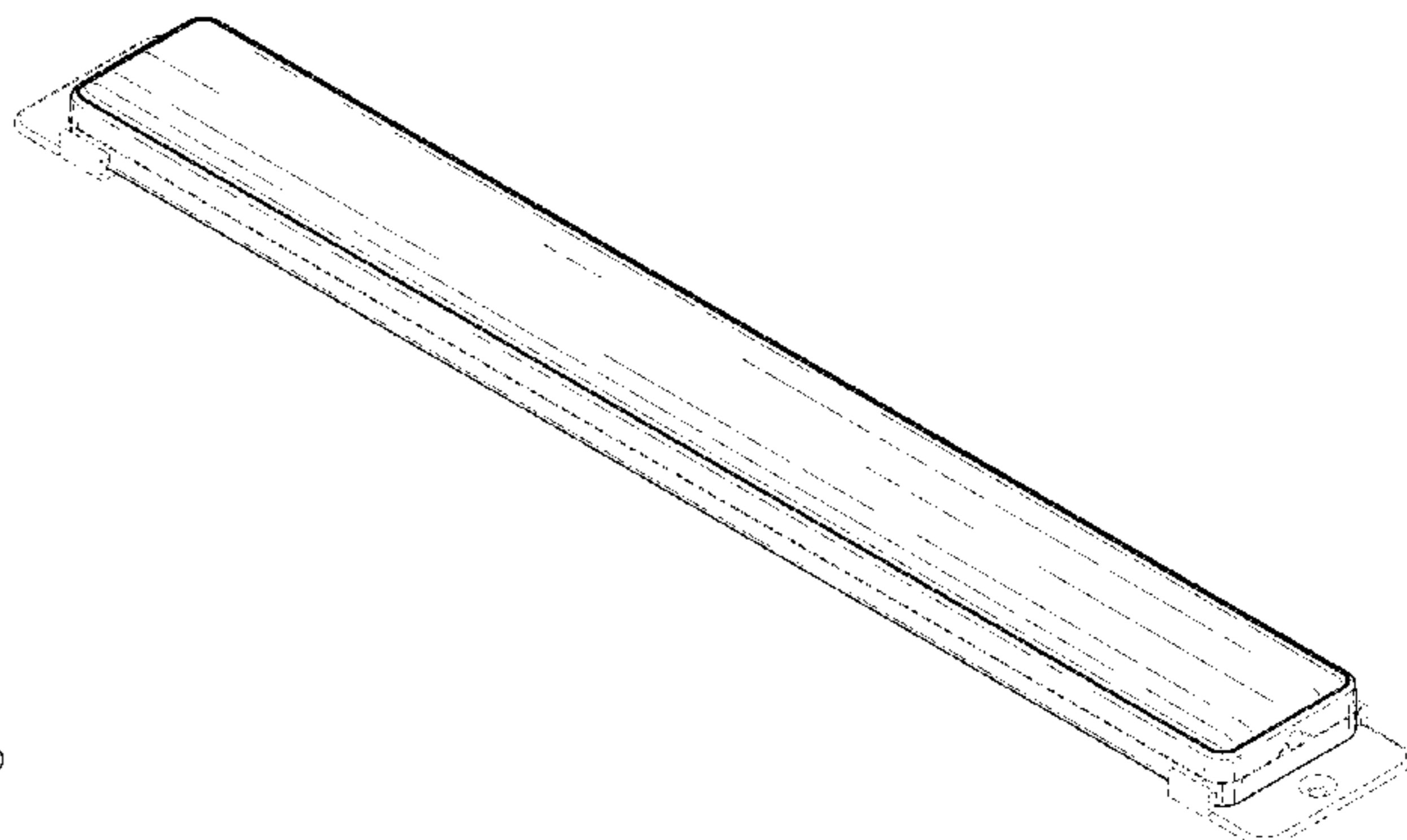
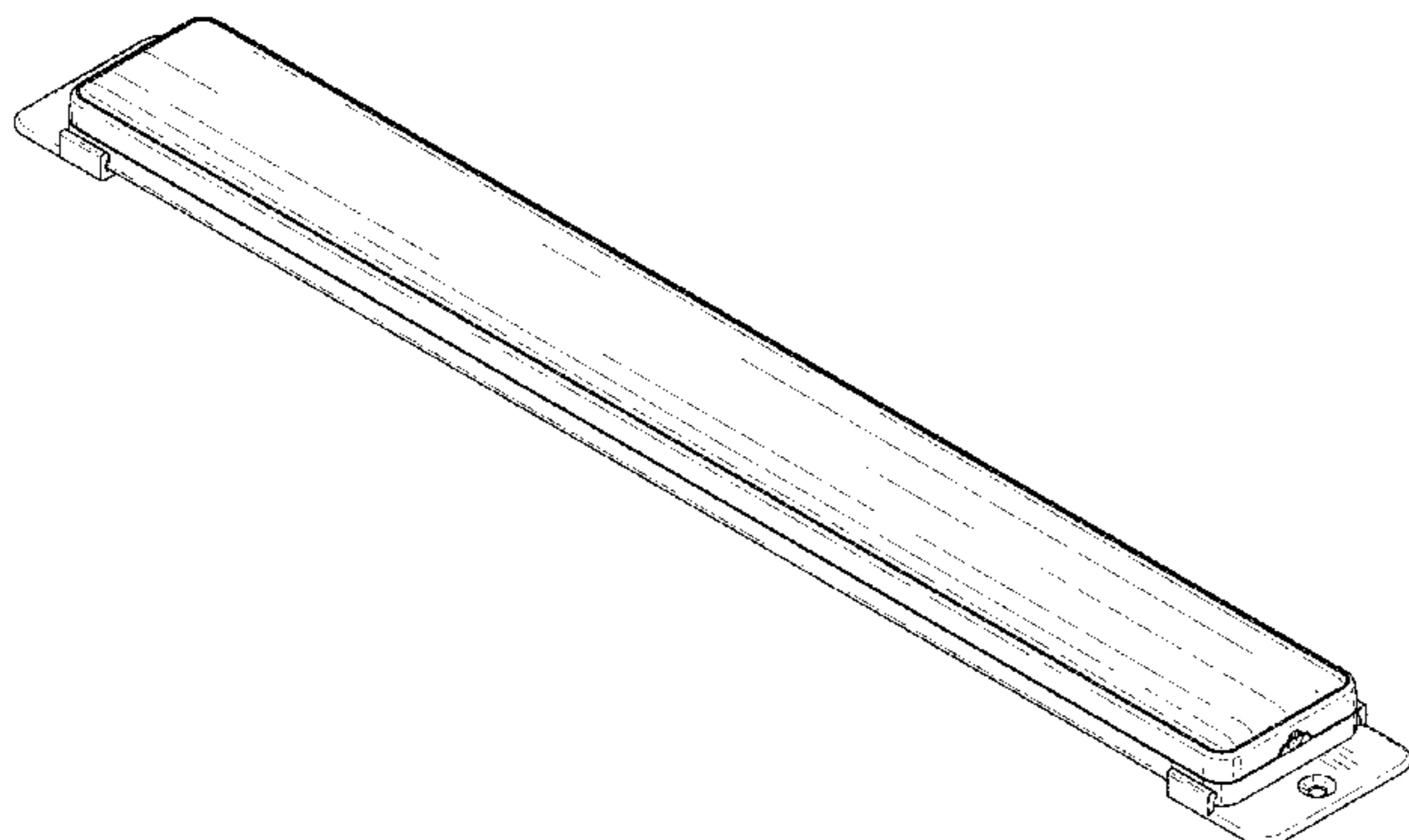
FIG. 12 is a second end profile view of the light showing my design in a second configuration.

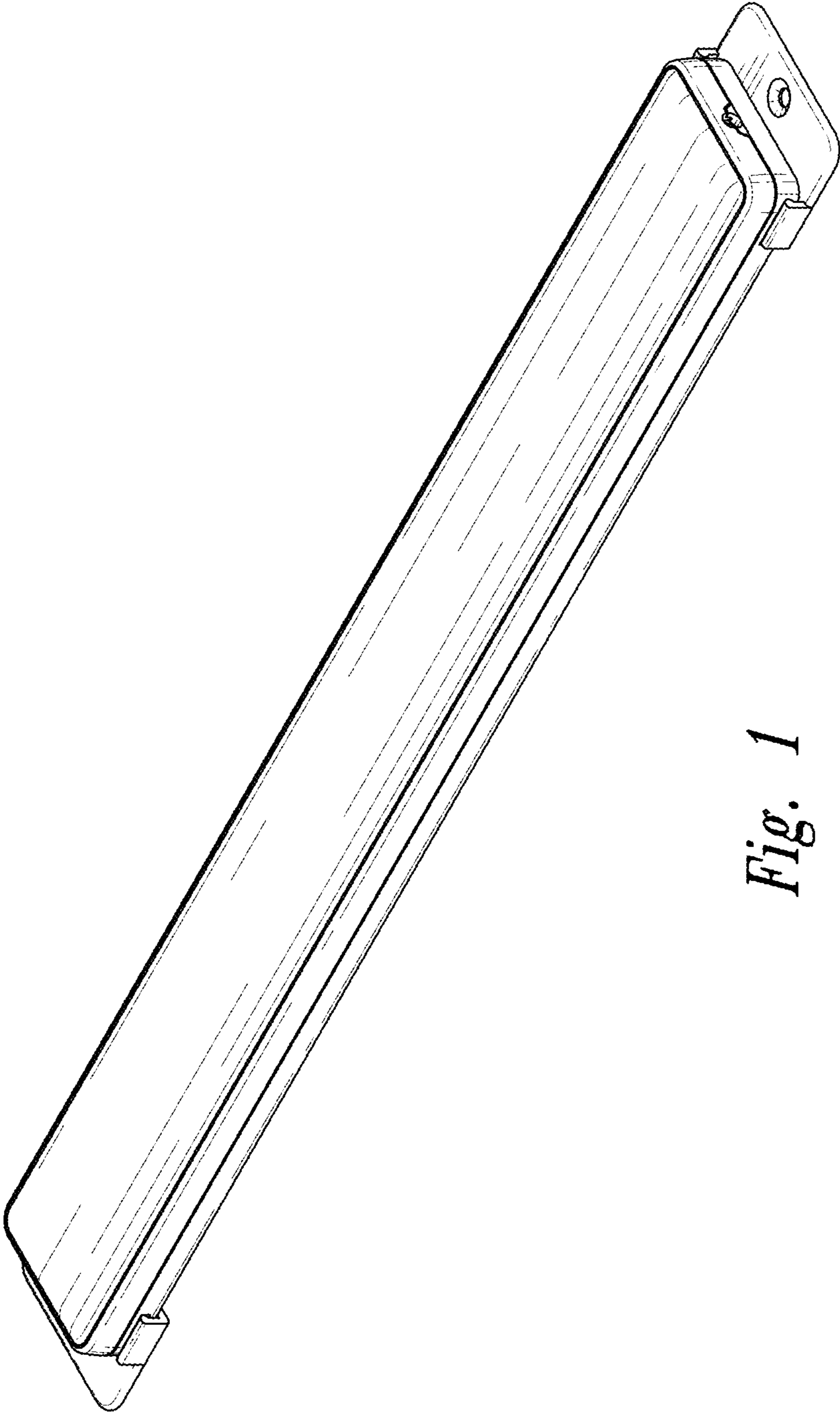
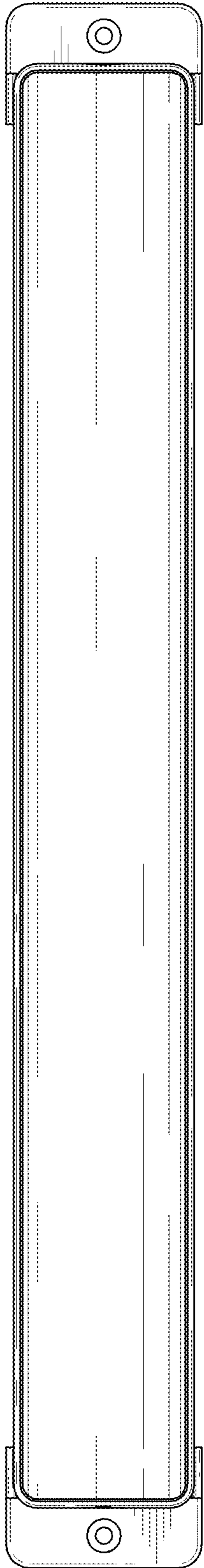
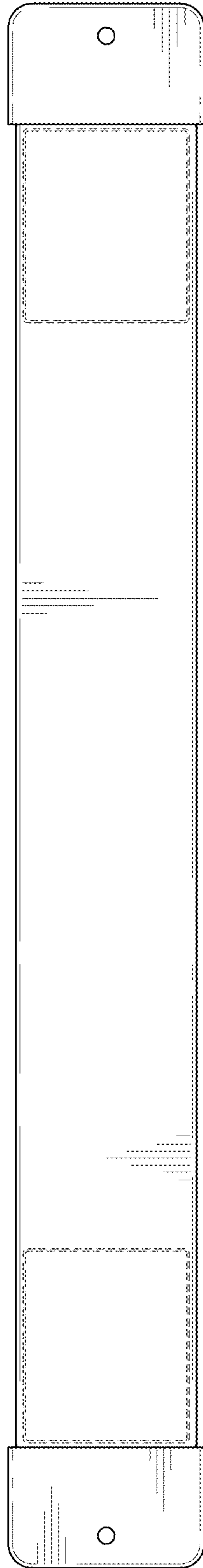


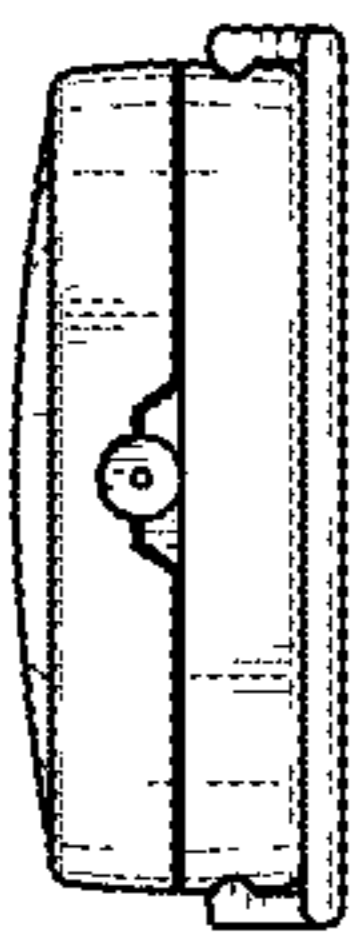

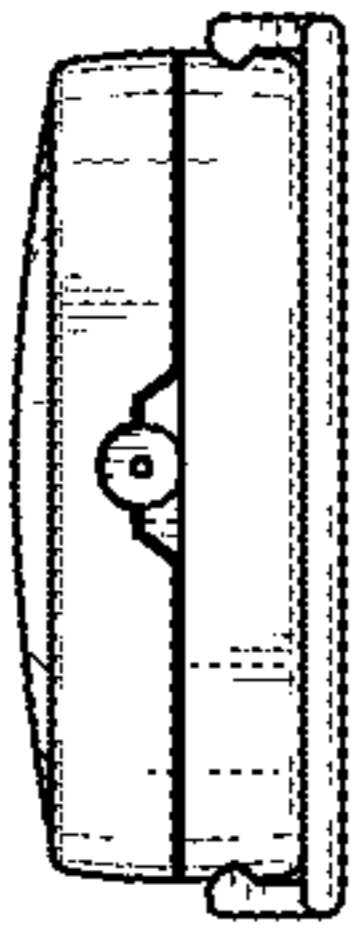

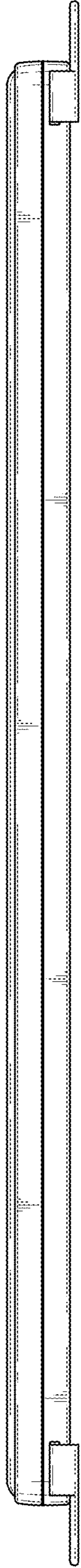

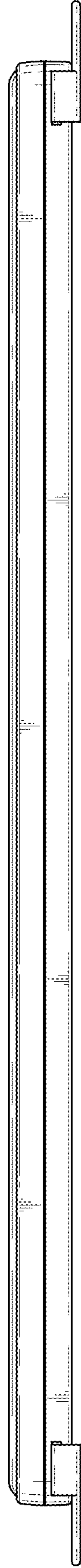

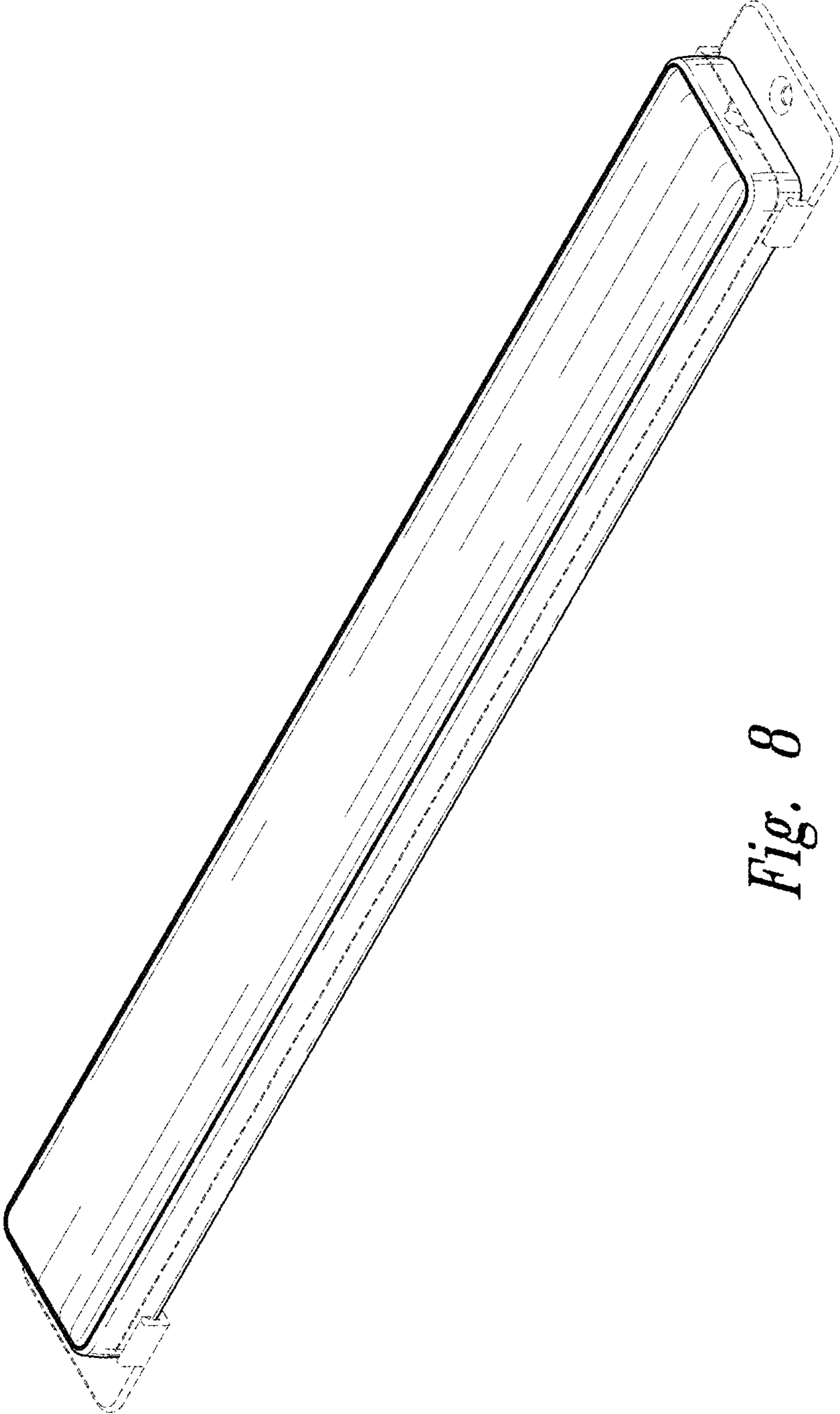
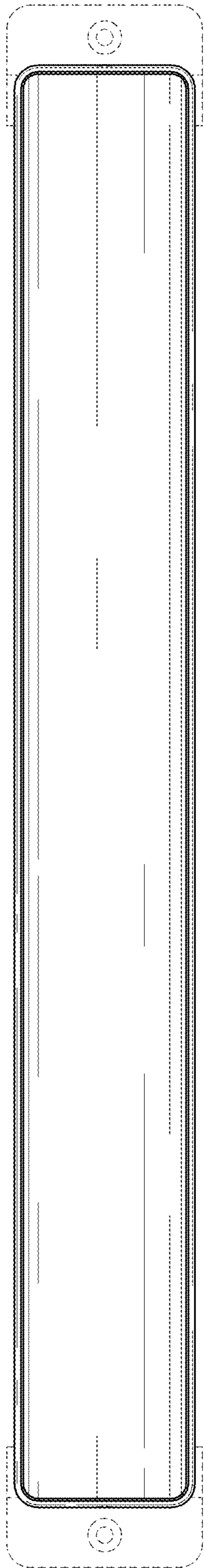
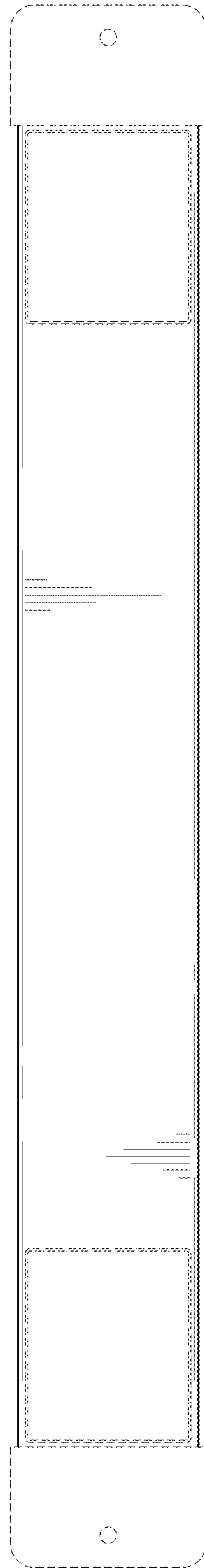

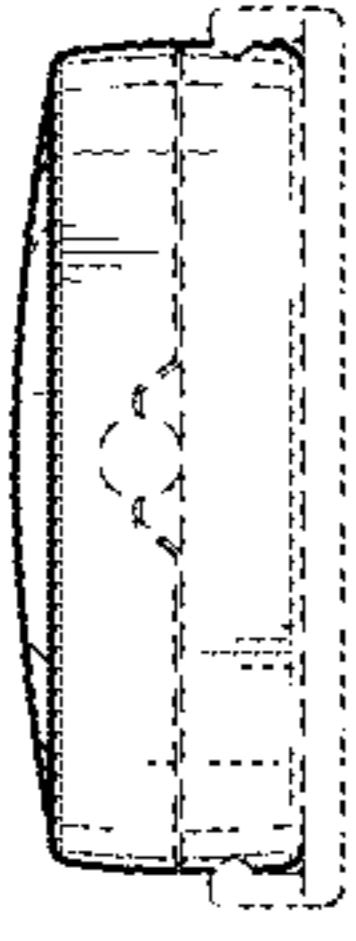

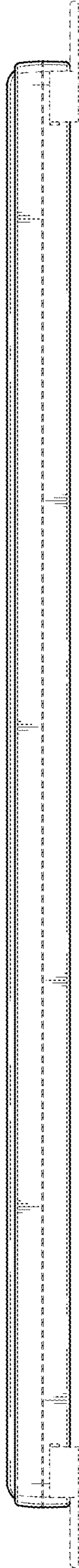

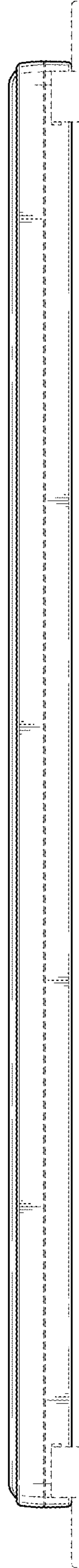
