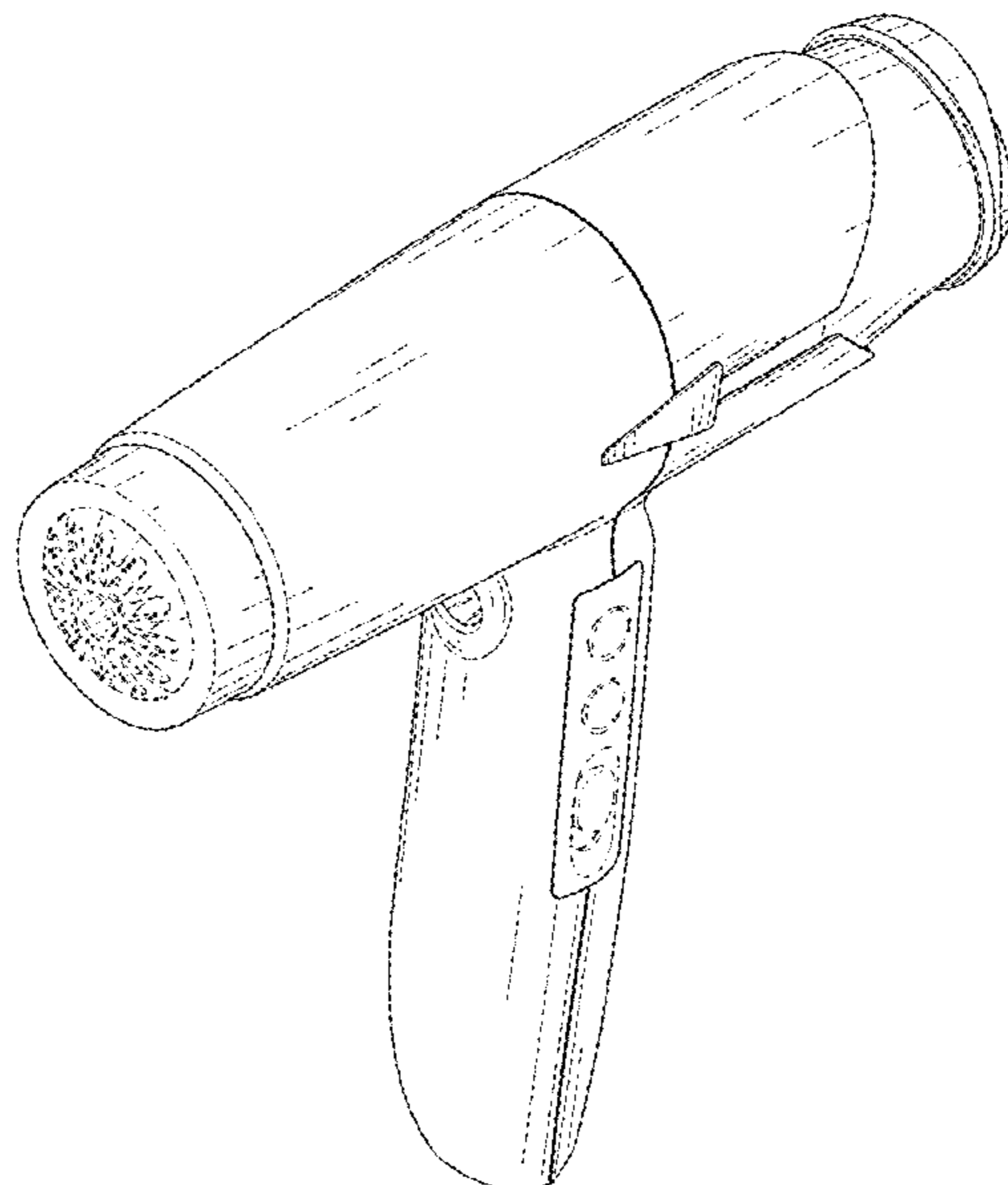

The ornamental design for a hair dryer, as shown and described.

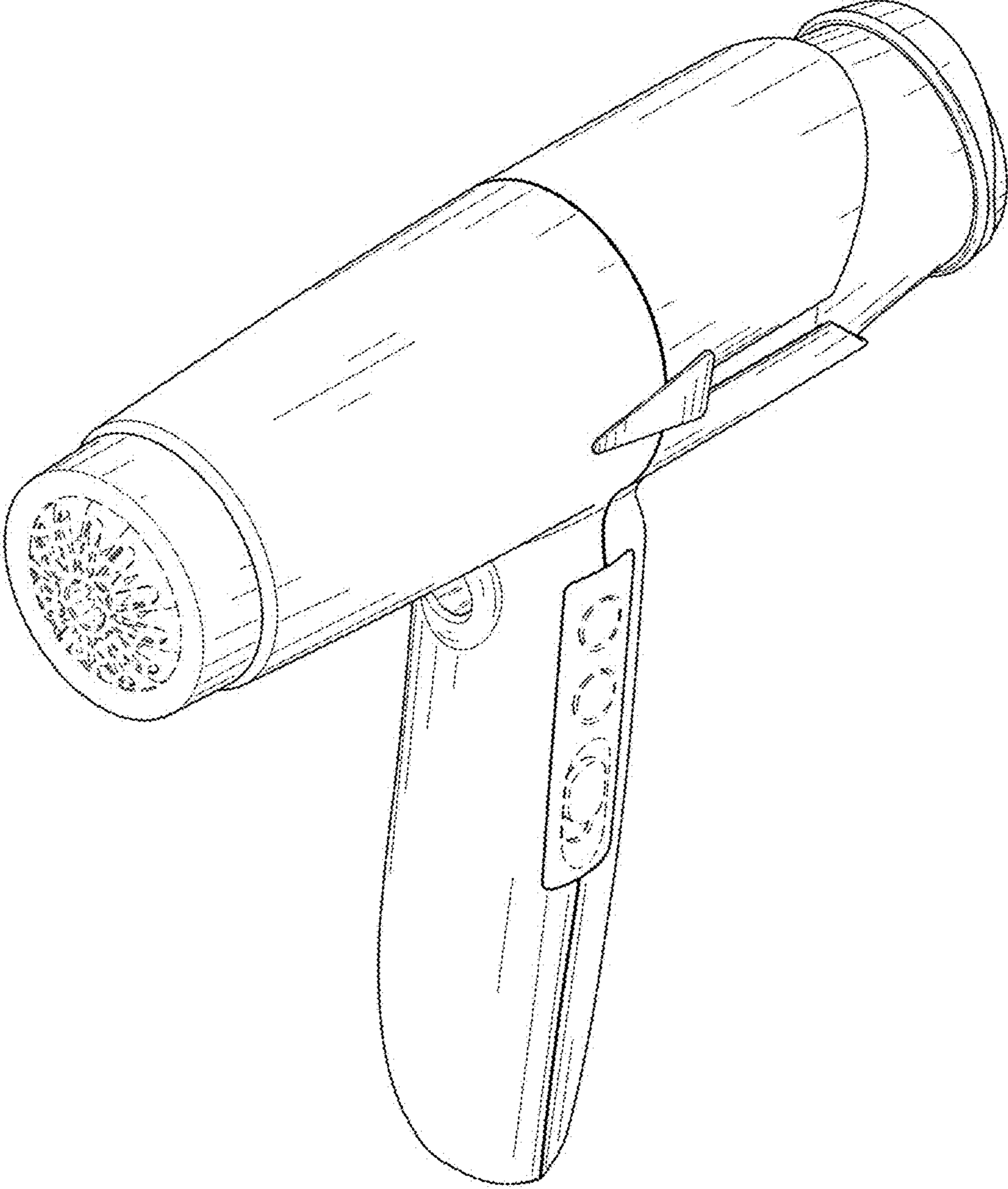
DESCRIPTION

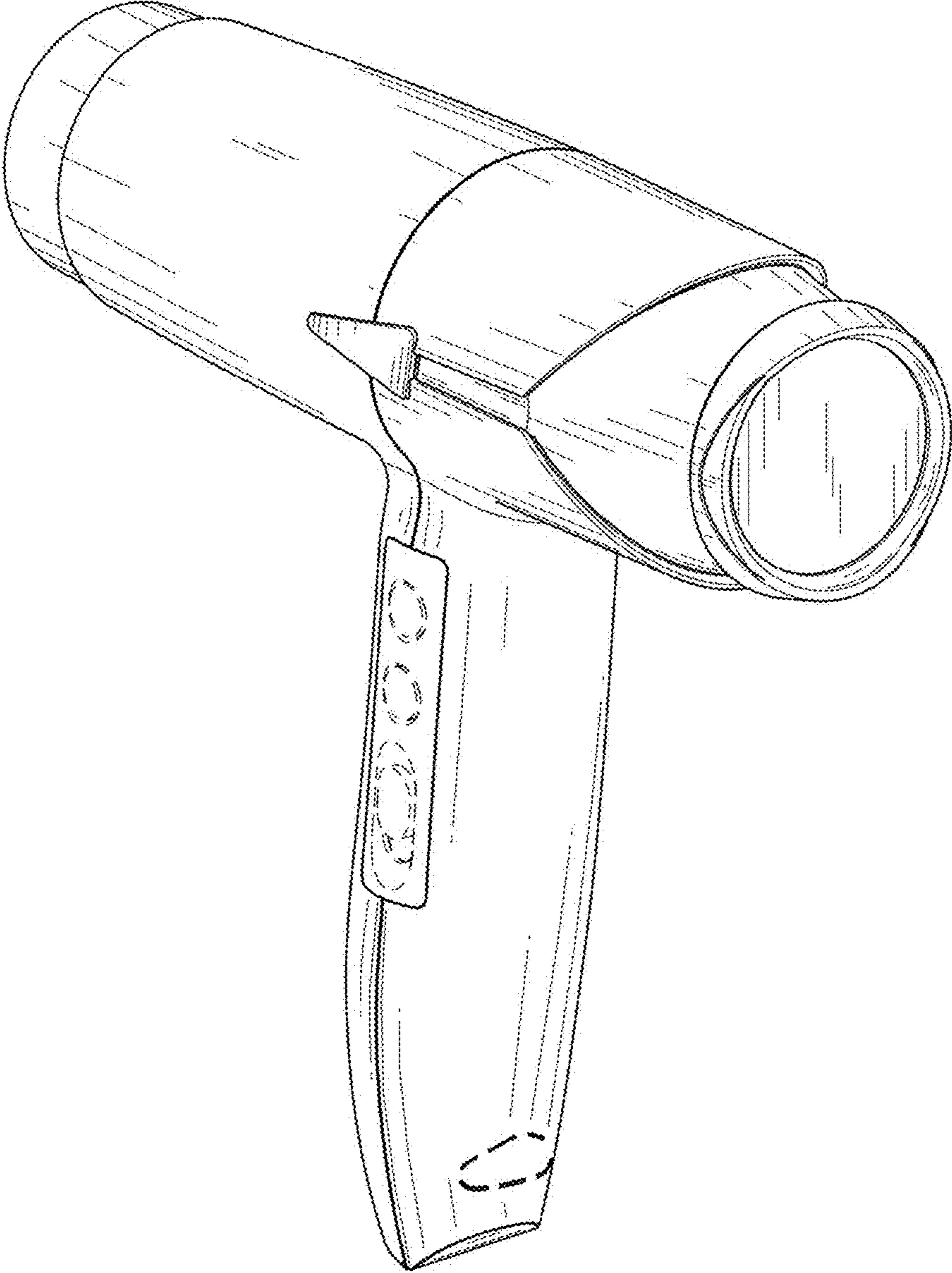

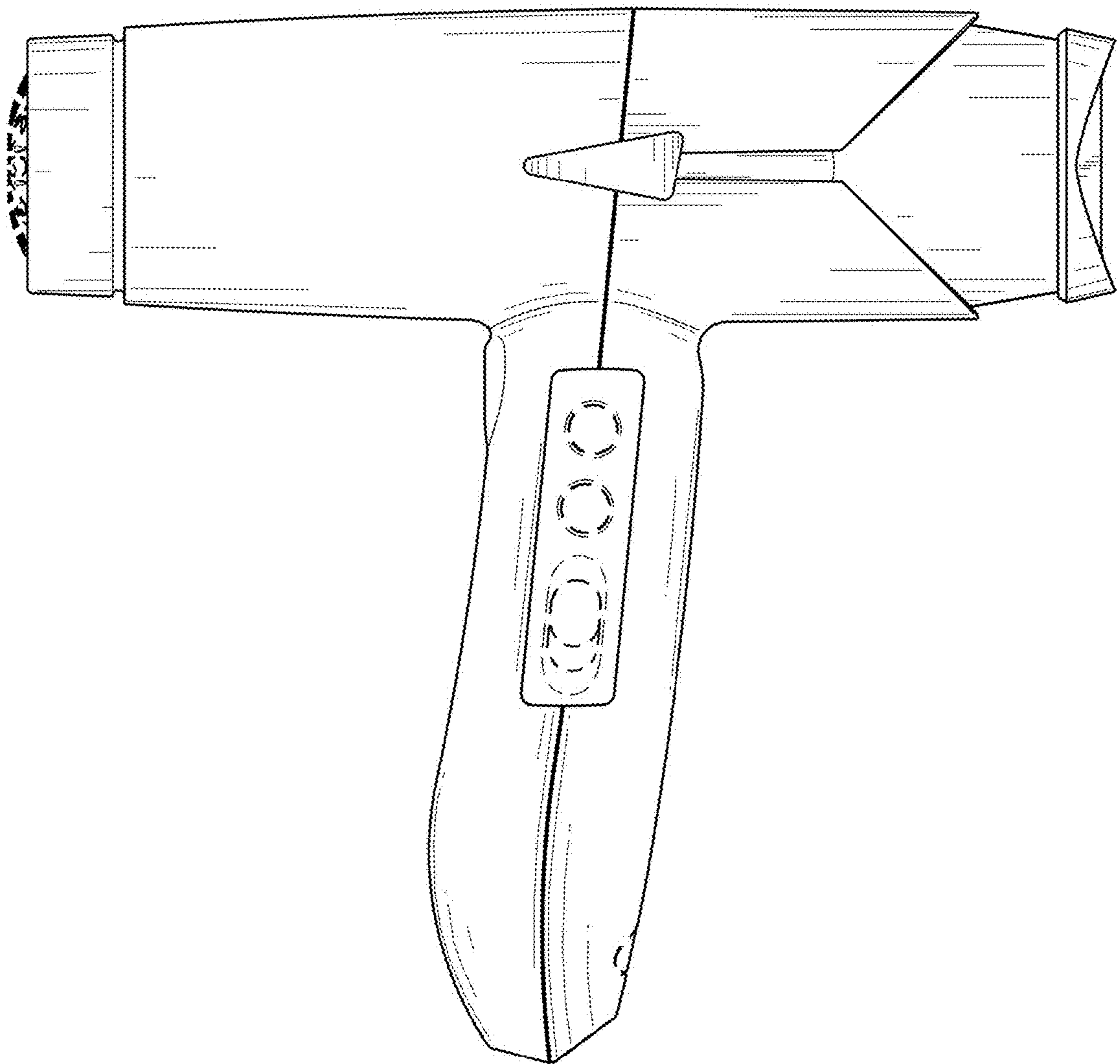

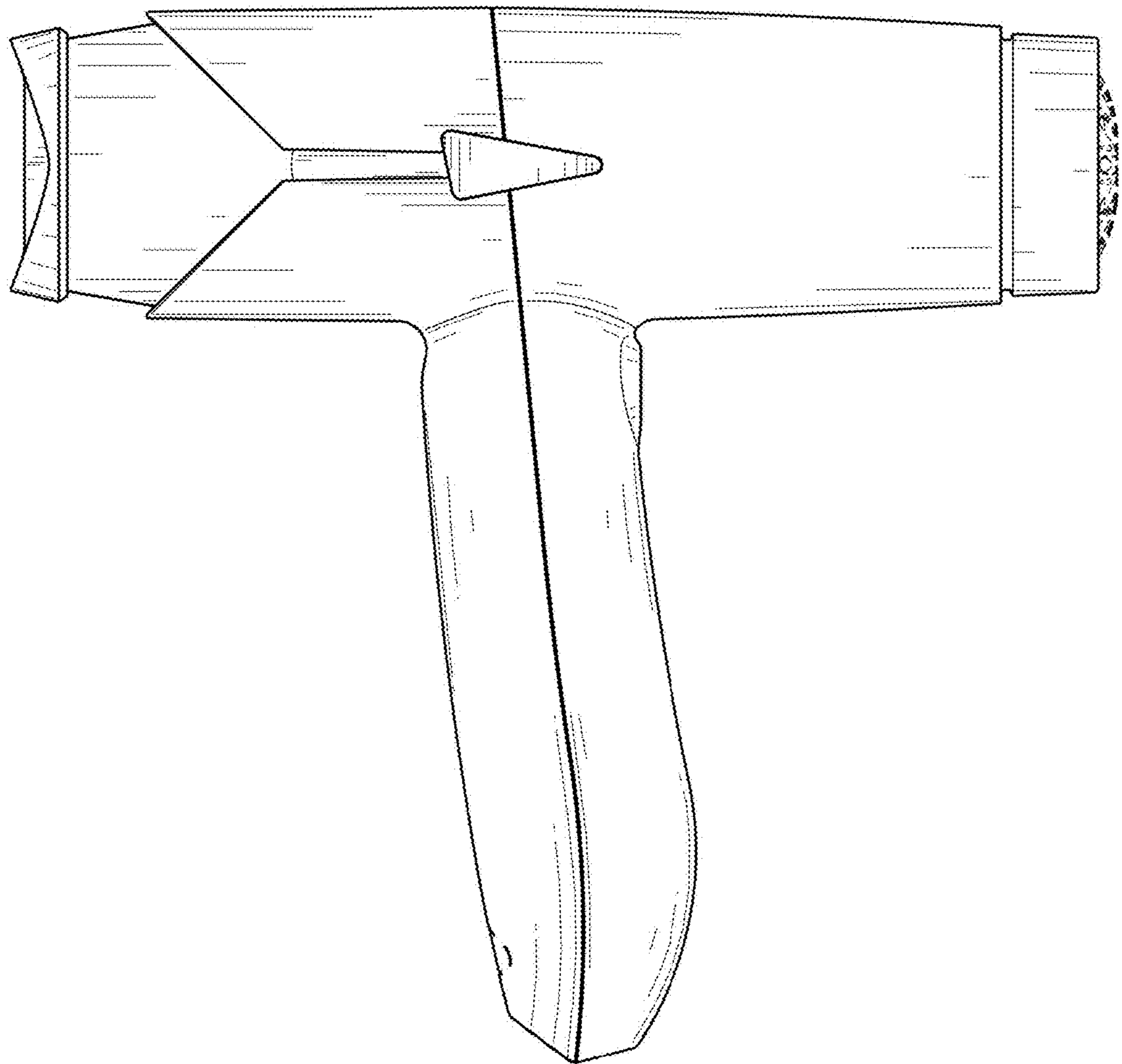

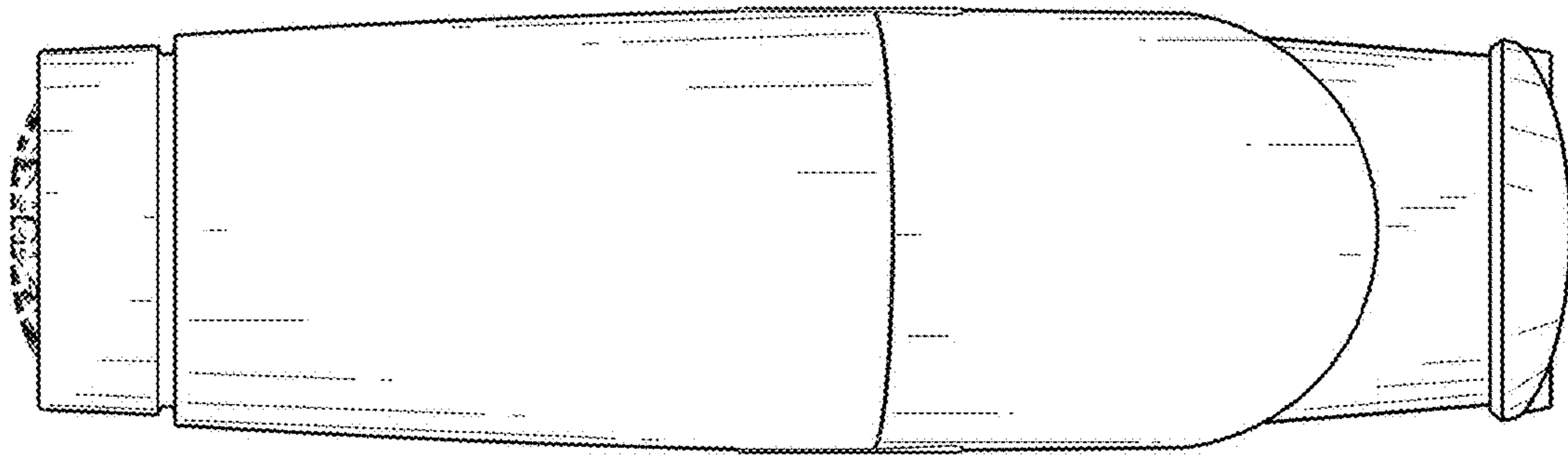

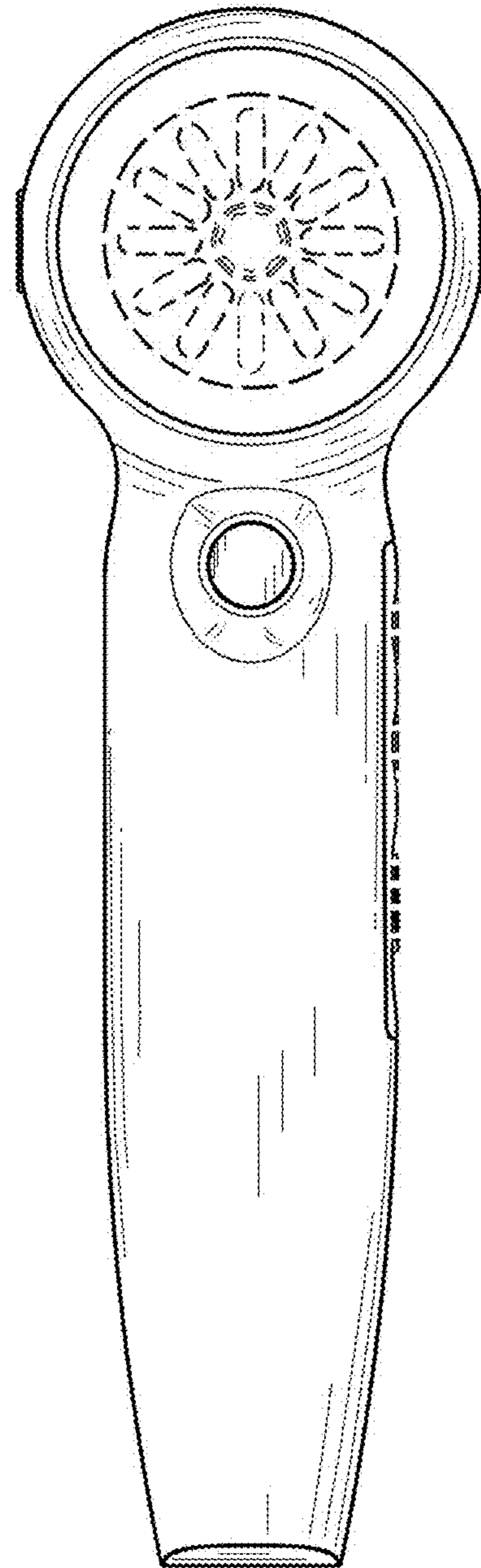
