**DESCRIPTION**

FIG. 1 is a perspective view of a leather suspender showing my new design;

FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a right side elevational view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.  
The broken lines in the drawings depict portions of the leather suspender that form no part of the claimed design.

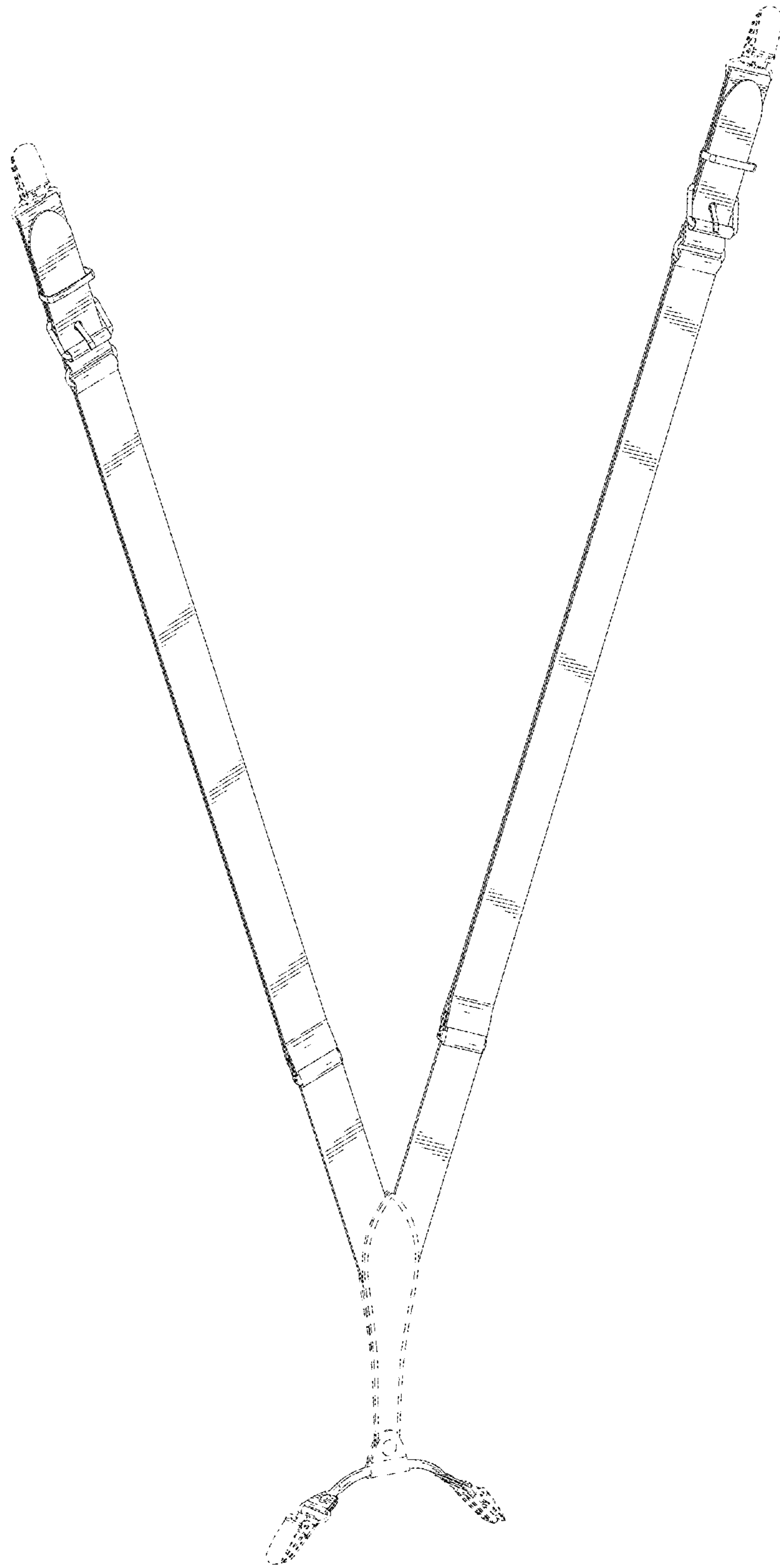

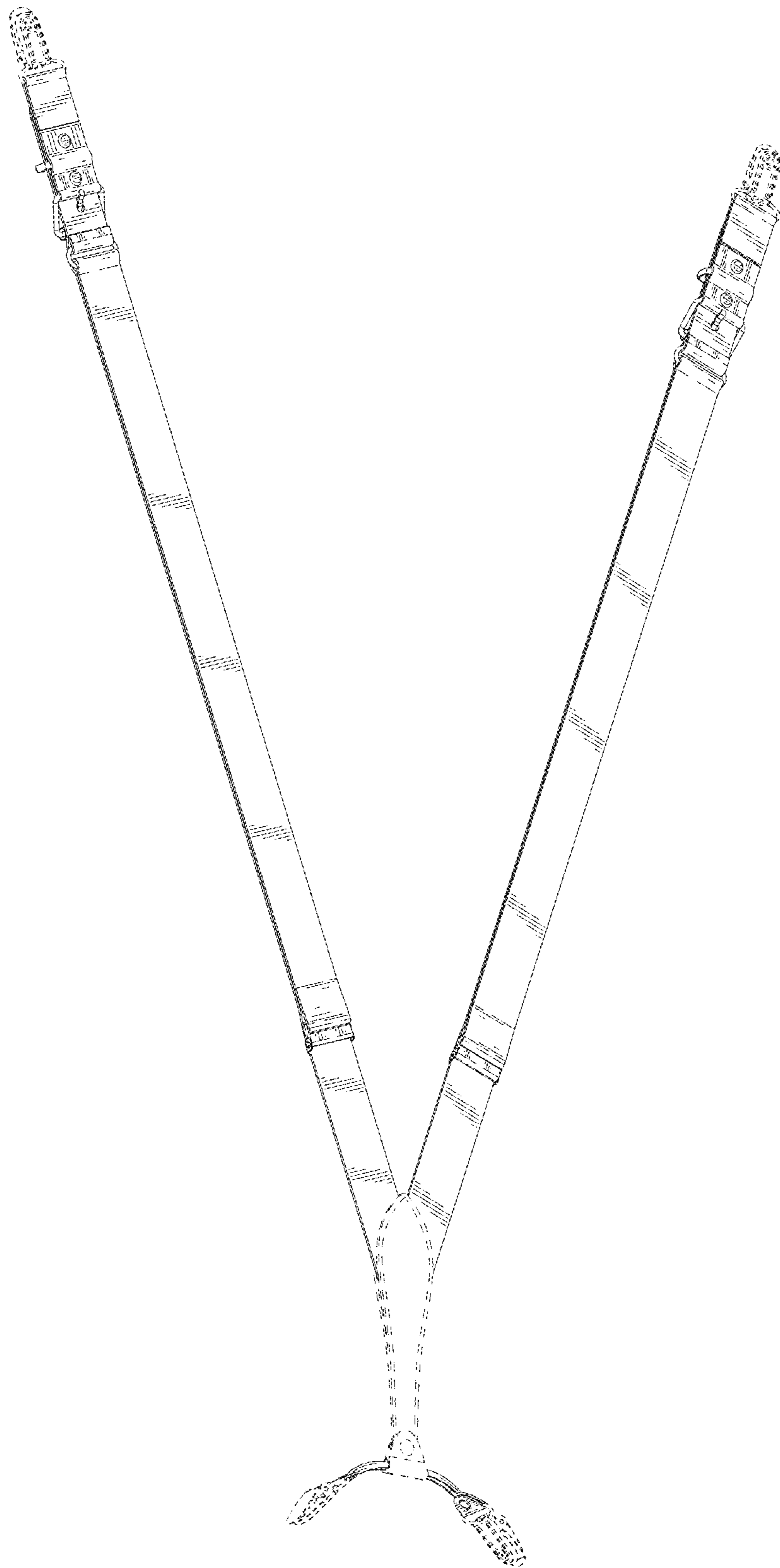

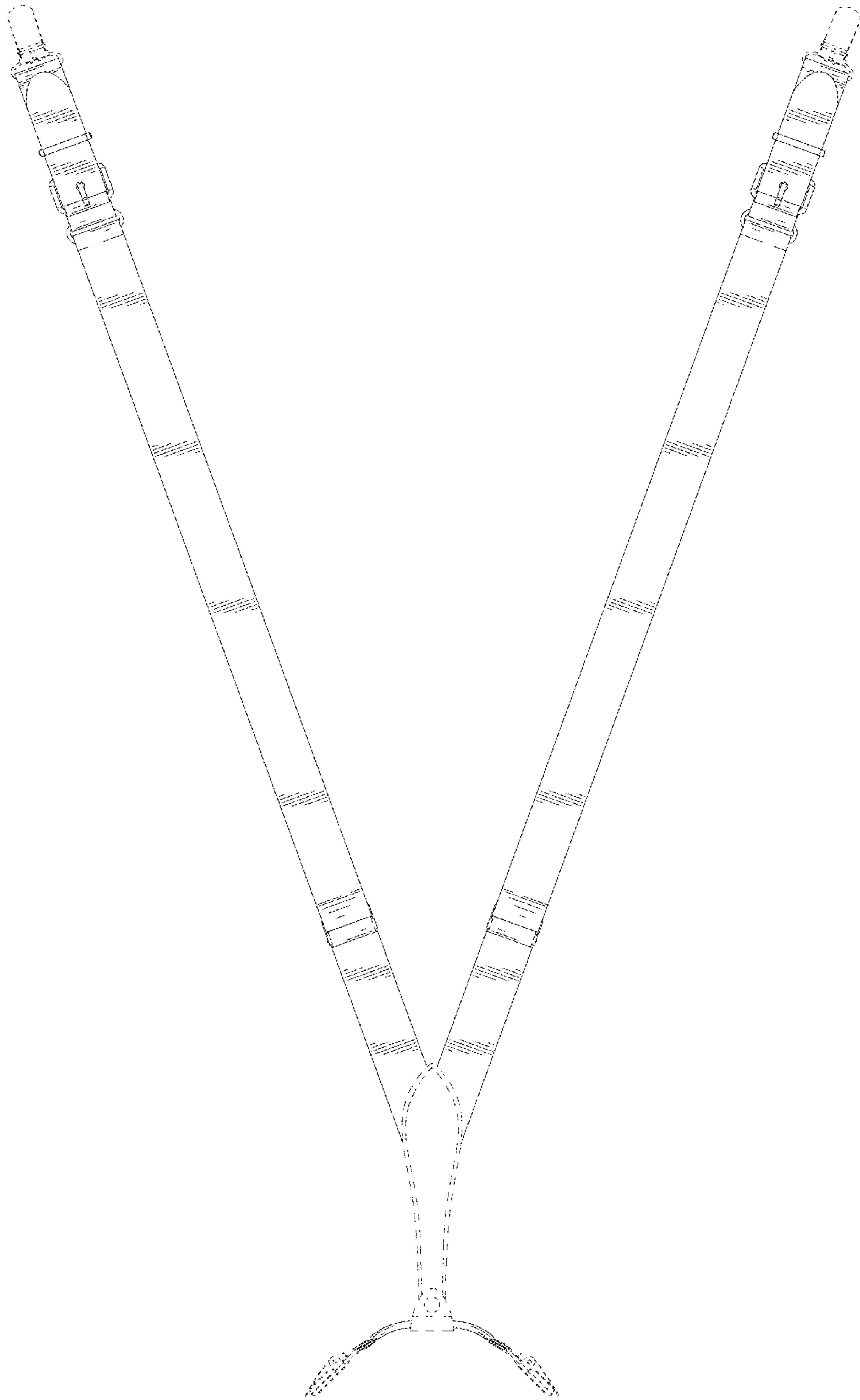

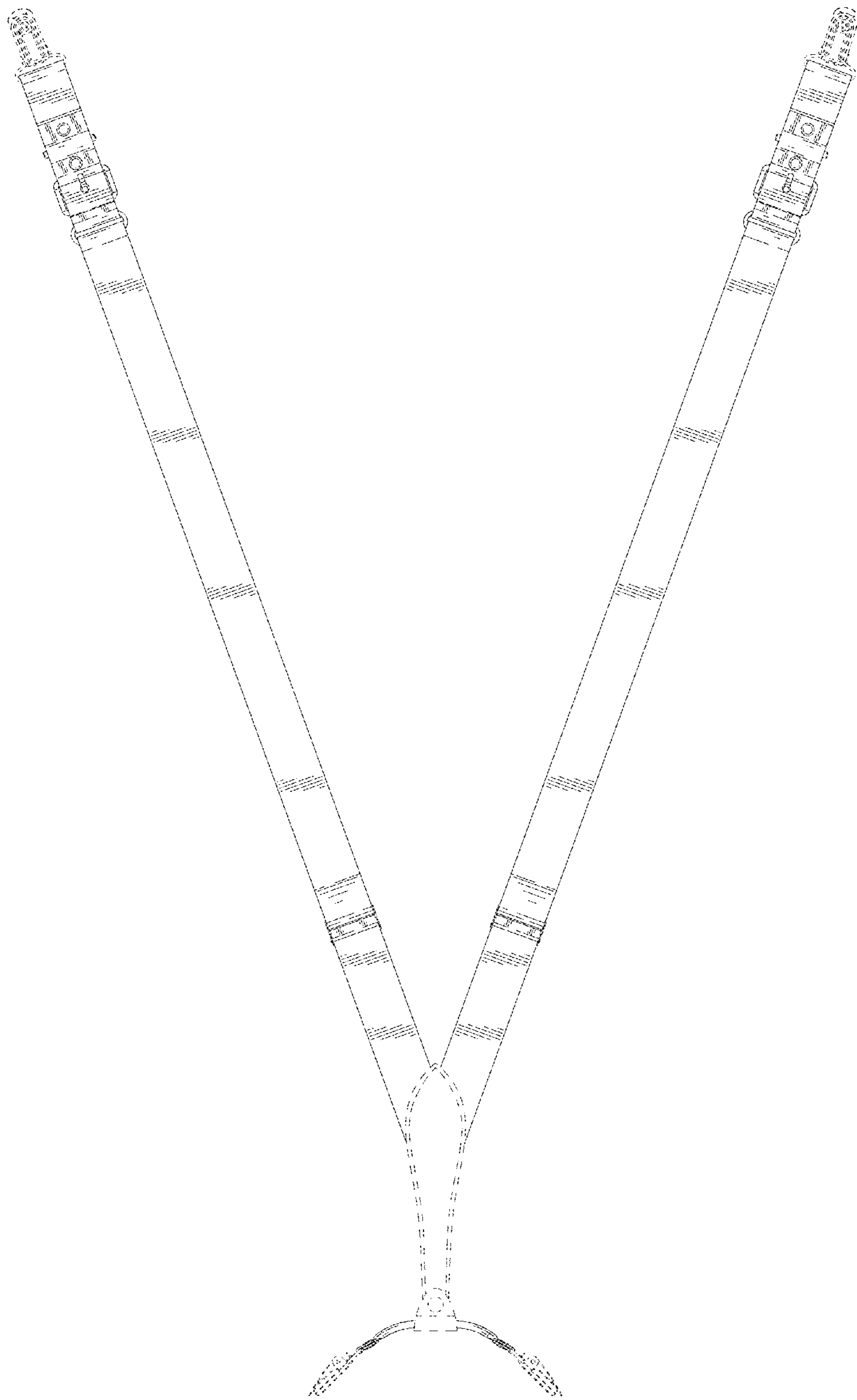

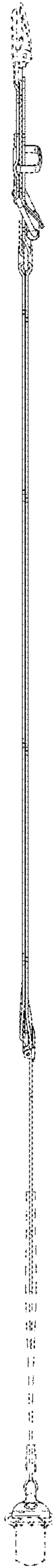

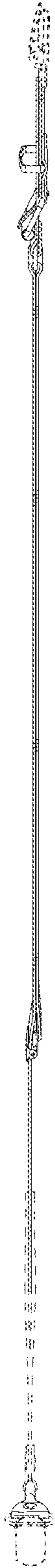

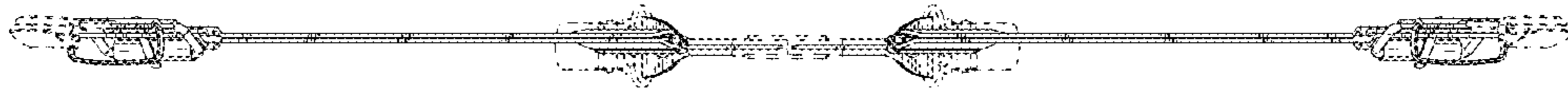

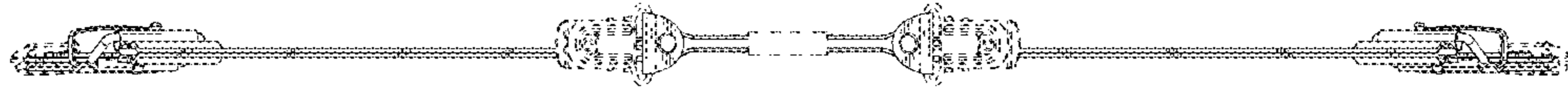
