We claim the ornamental design for a footwear with a reel based closure device substantially, as shown and described.

FIG. 4.4 is a first side view of the footwear with a reel based closure device;

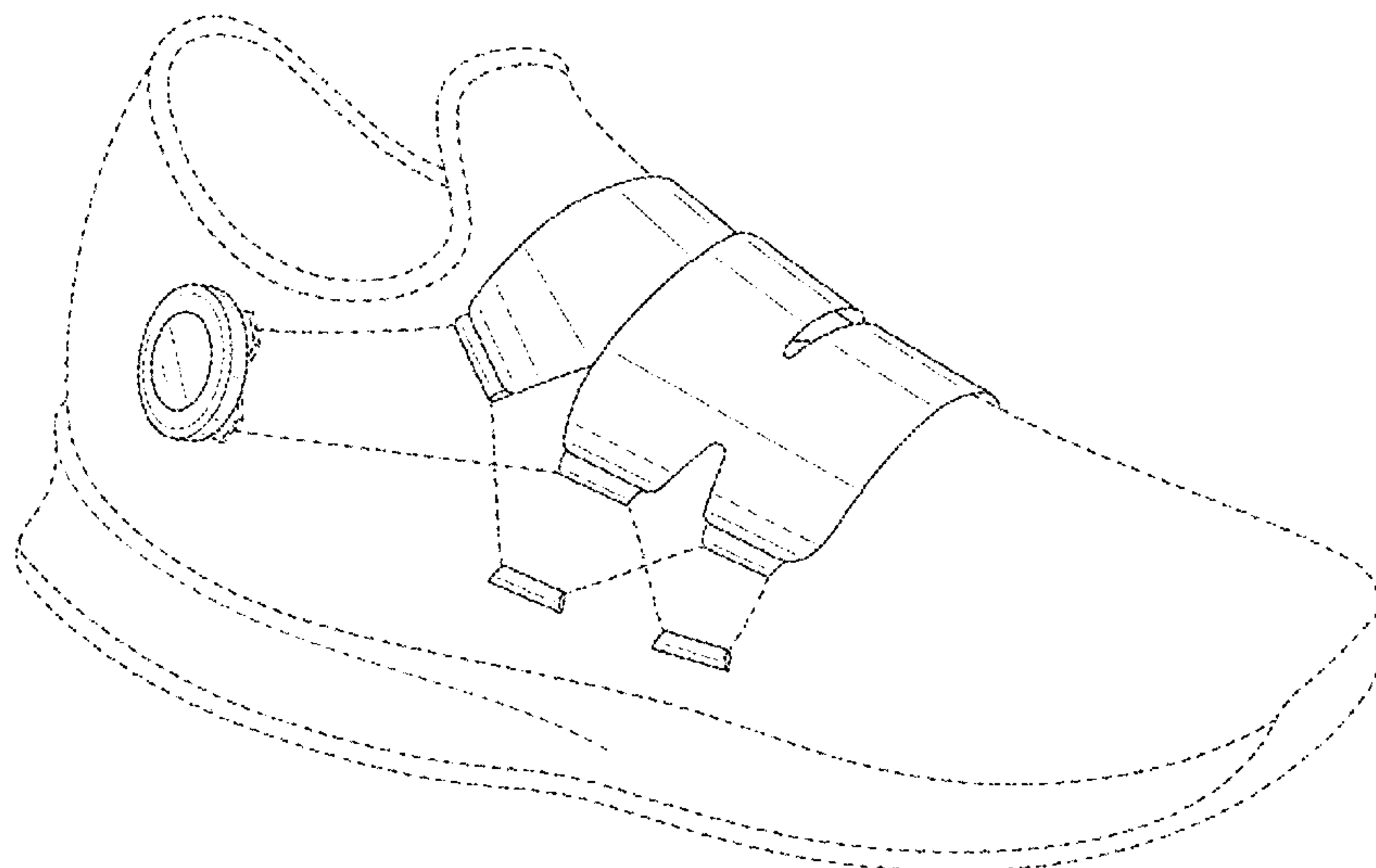
FIG. 4.5 is a second side view of the footwear with a reel based closure device;

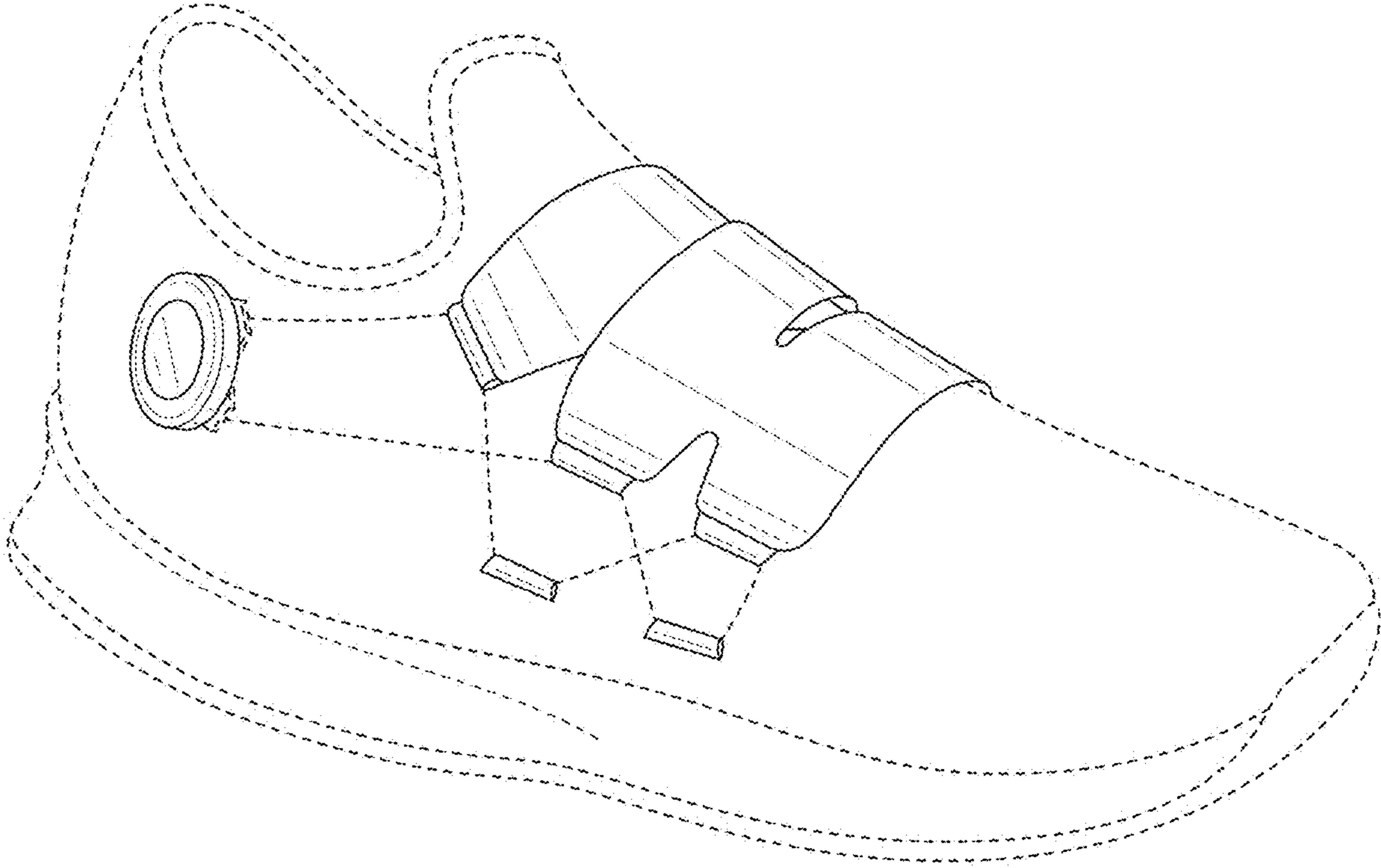

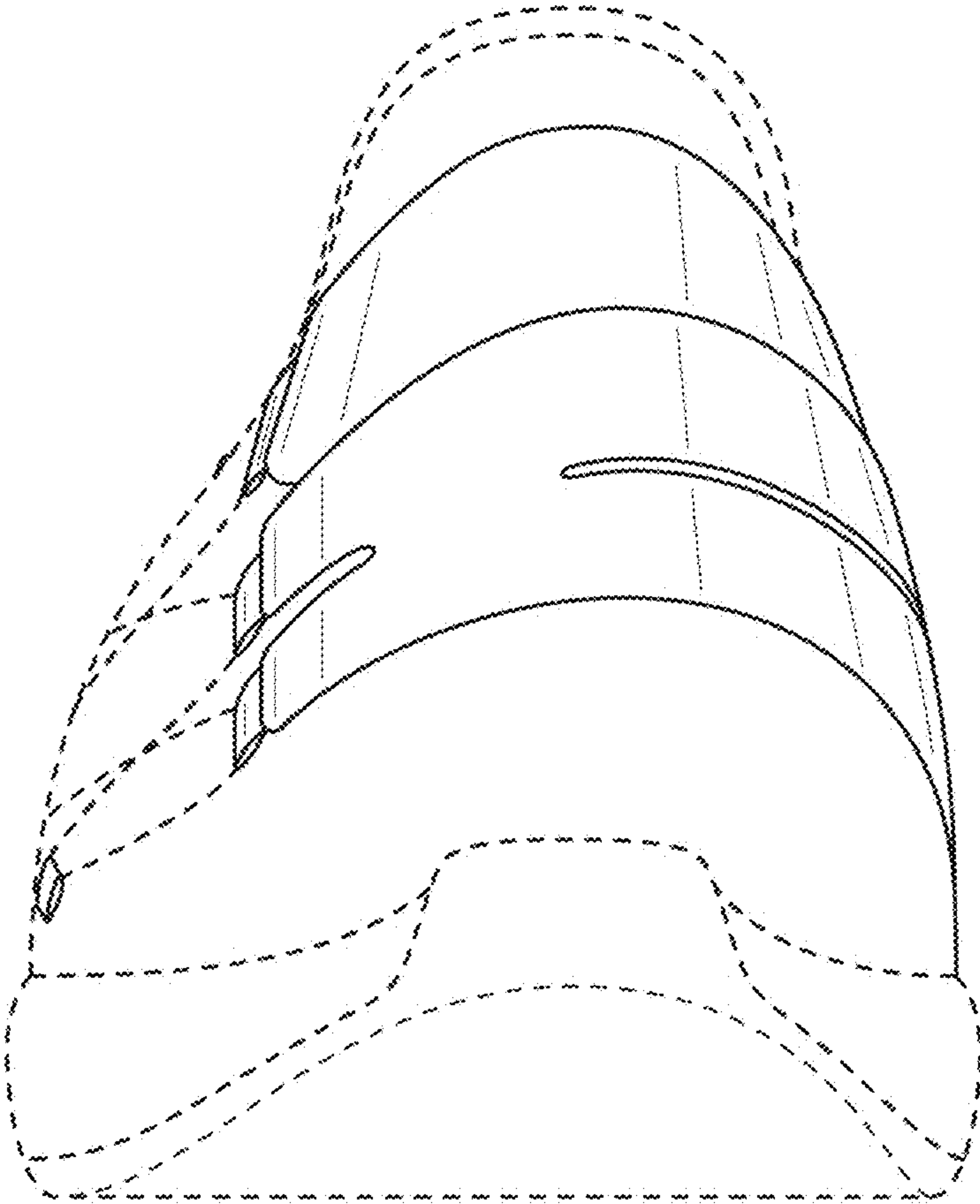

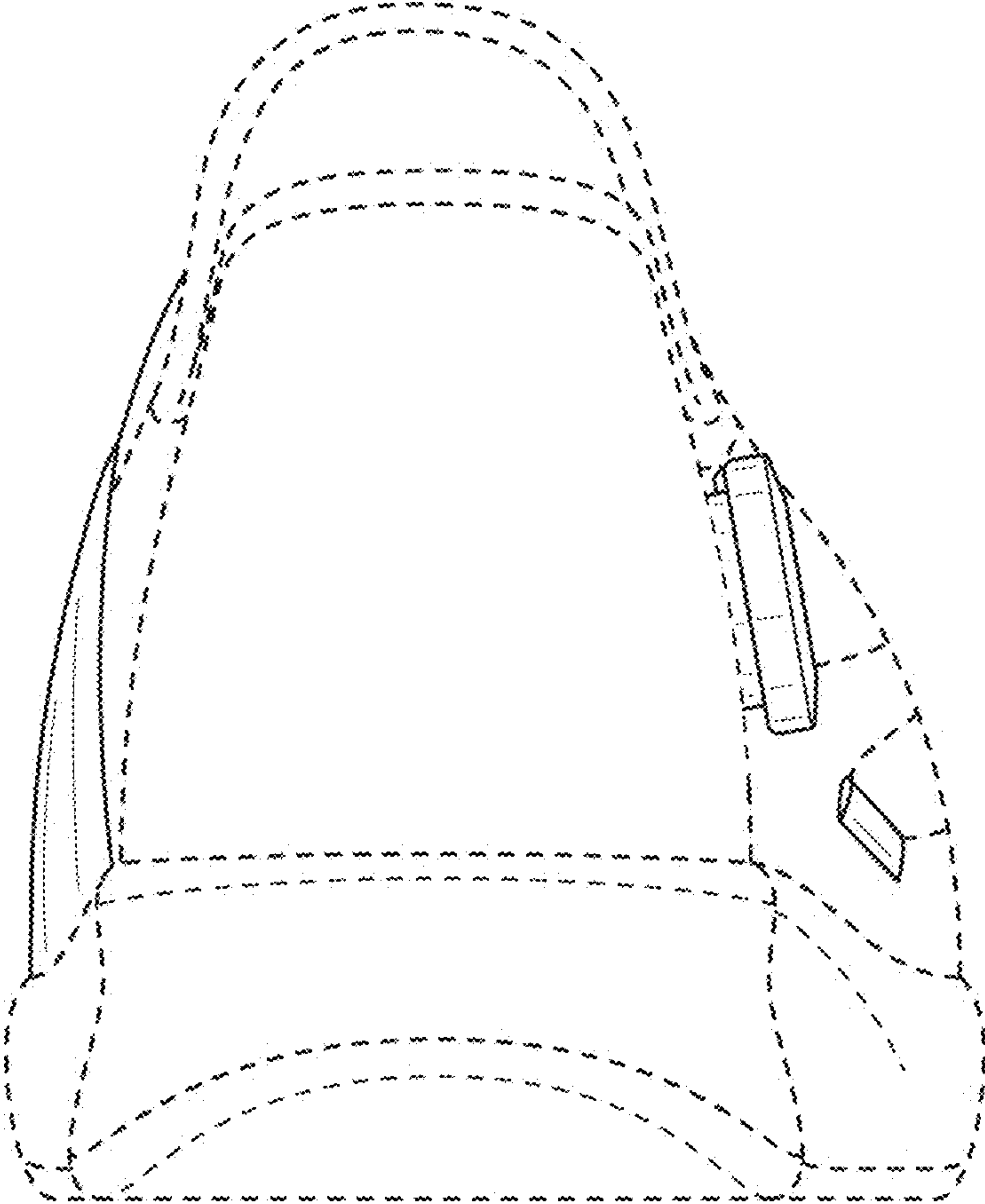

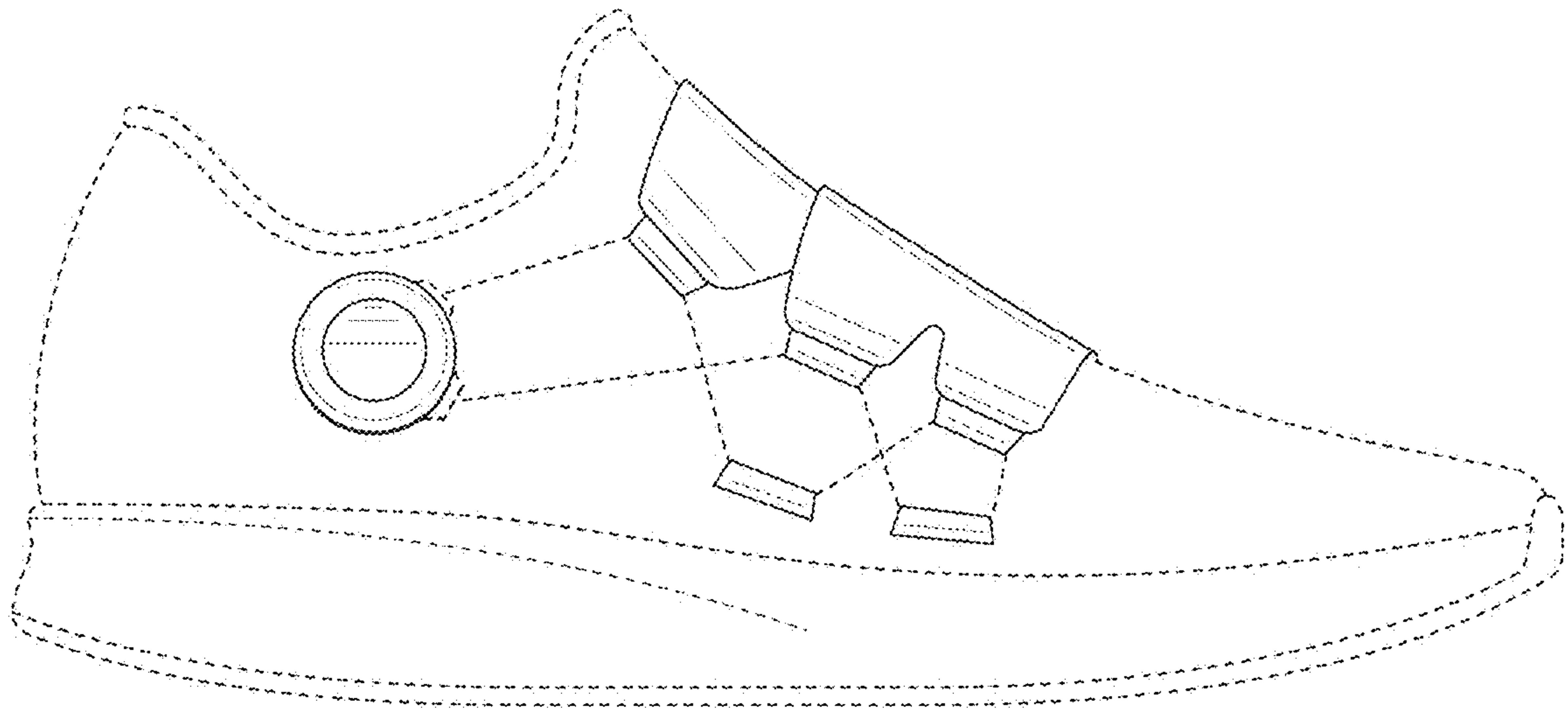

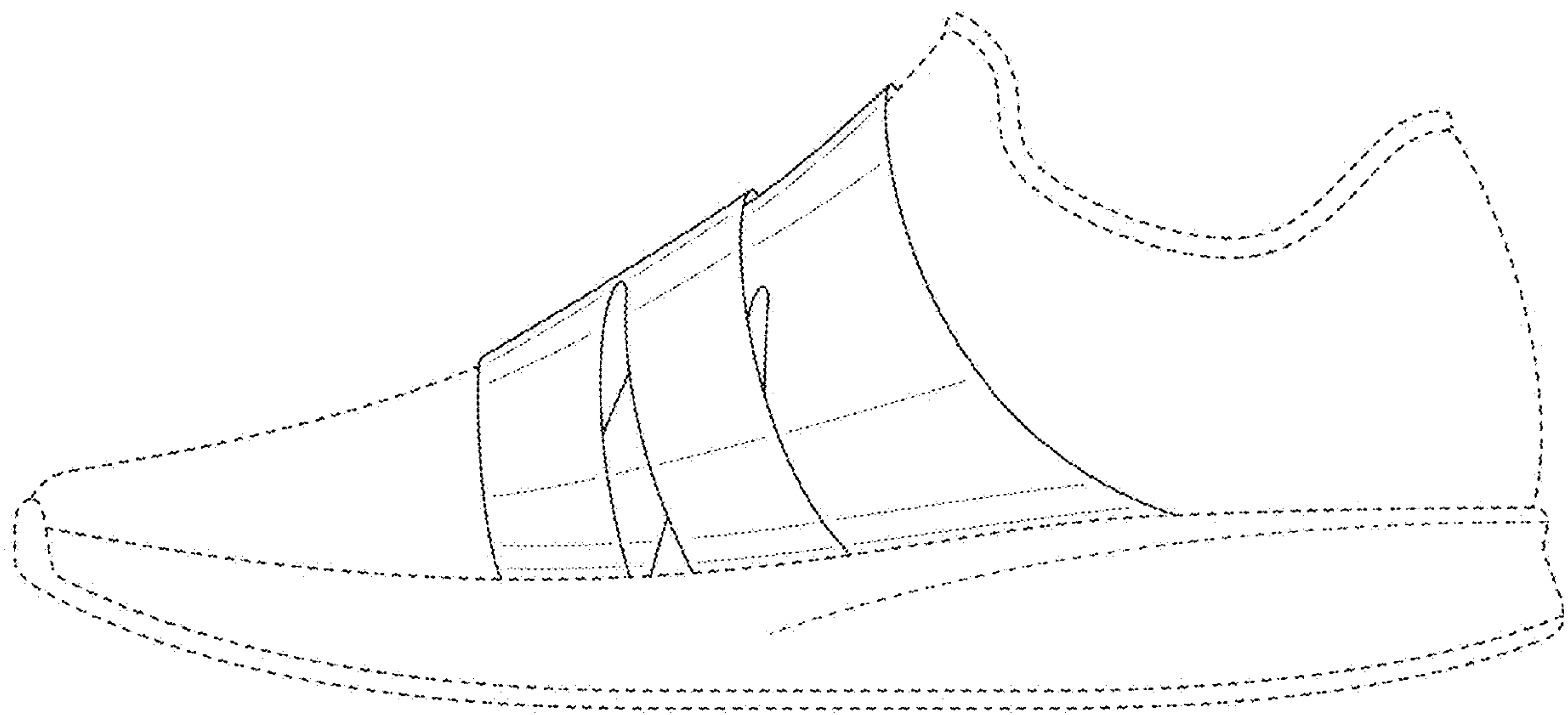

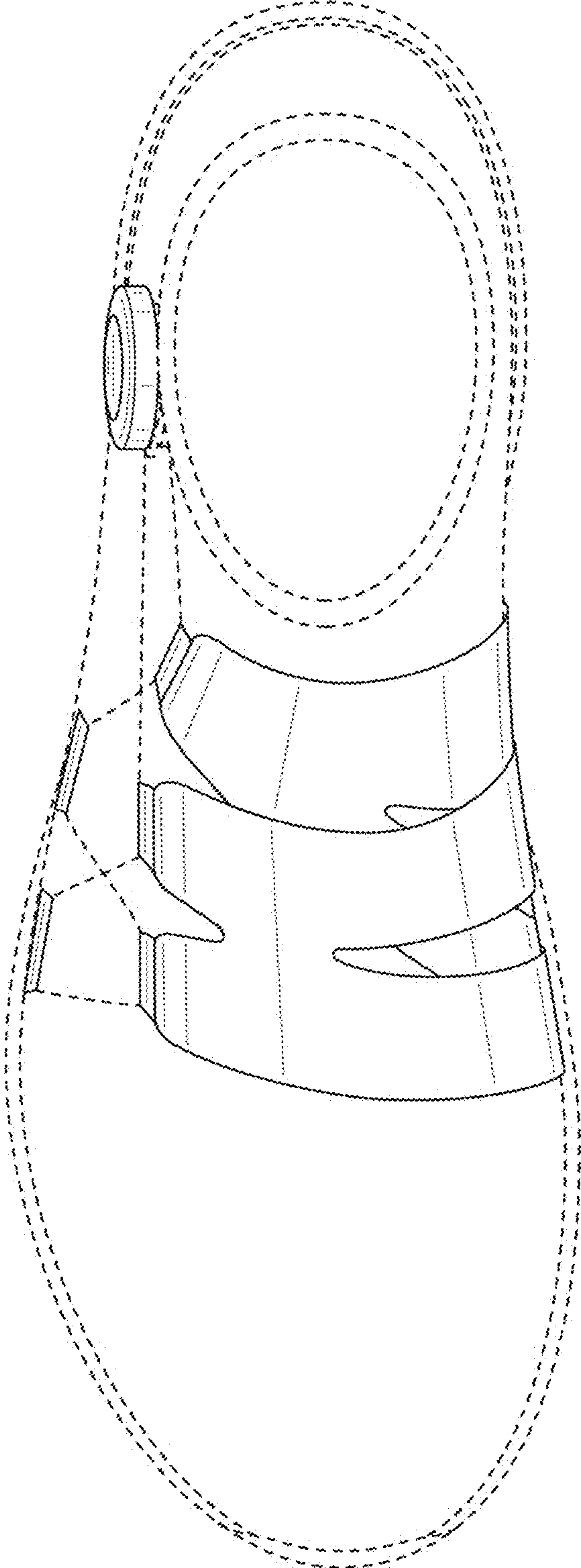
