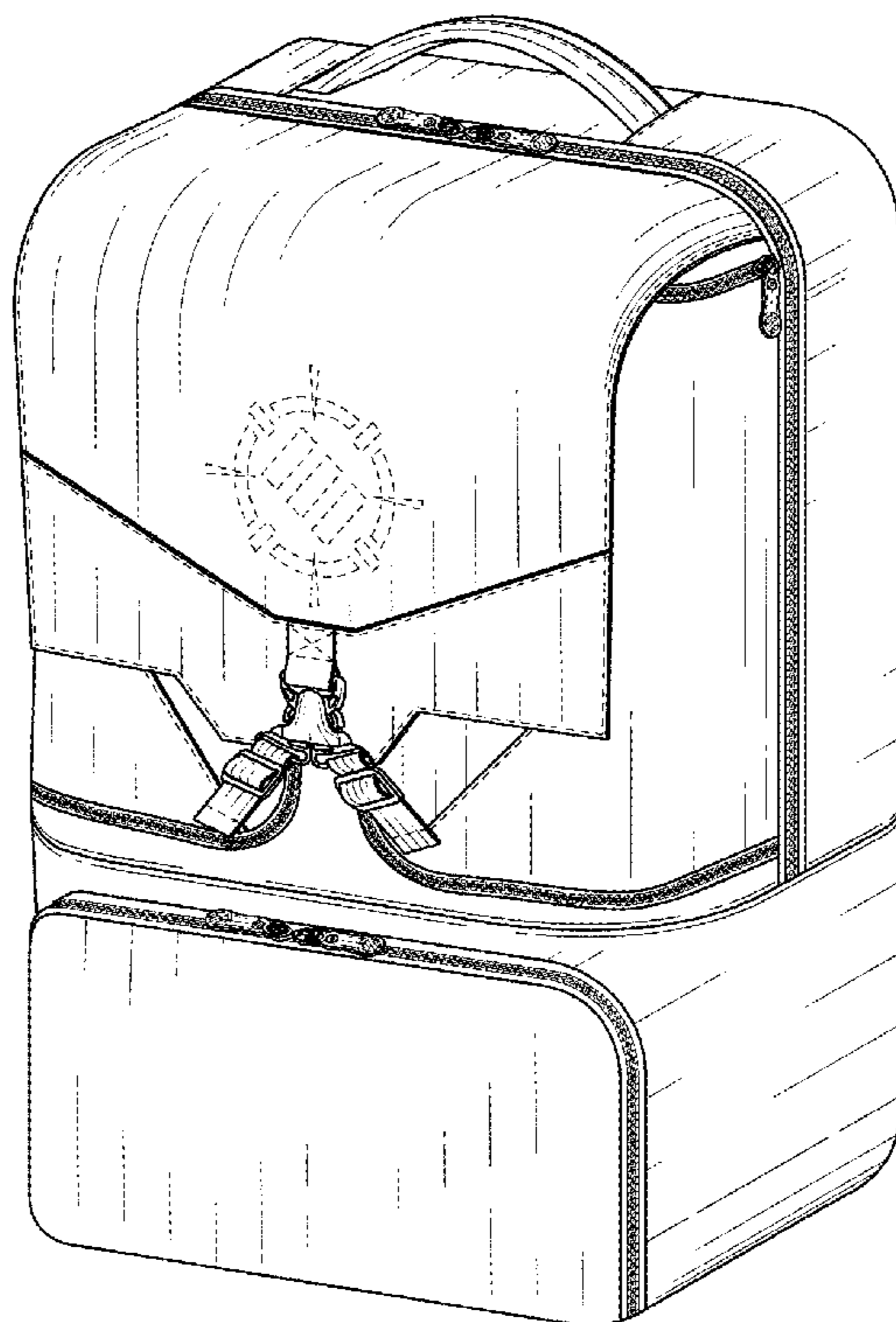
(57) **CLAIM**

The ornamental design for a backpack, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a backpack, showing my new design in a closed configuration; FIG. 2 is a rear perspective view of FIG. 1; FIG. 3 is a front elevational view of FIG. 1; FIG. 4 is a rear elevational view of FIG. 1; FIG. 5 is a left-side elevational view of FIG. 1; FIG. 6 is a right-side elevational view of FIG. 1; FIG. 7 is a top plan view of FIG. 1; FIG. 8 is a bottom plan view of FIG. 1; FIG. 9 is an exploded front perspective view thereof, illustrated in an open configuration; and, FIG. 10 is an exploded rear perspective view of FIG. 9. The broken lines showing a logo in the figures depict environmental matter and form no part of the claimed design. The remaining broken lines represent stitching, and are part of the claimed design.

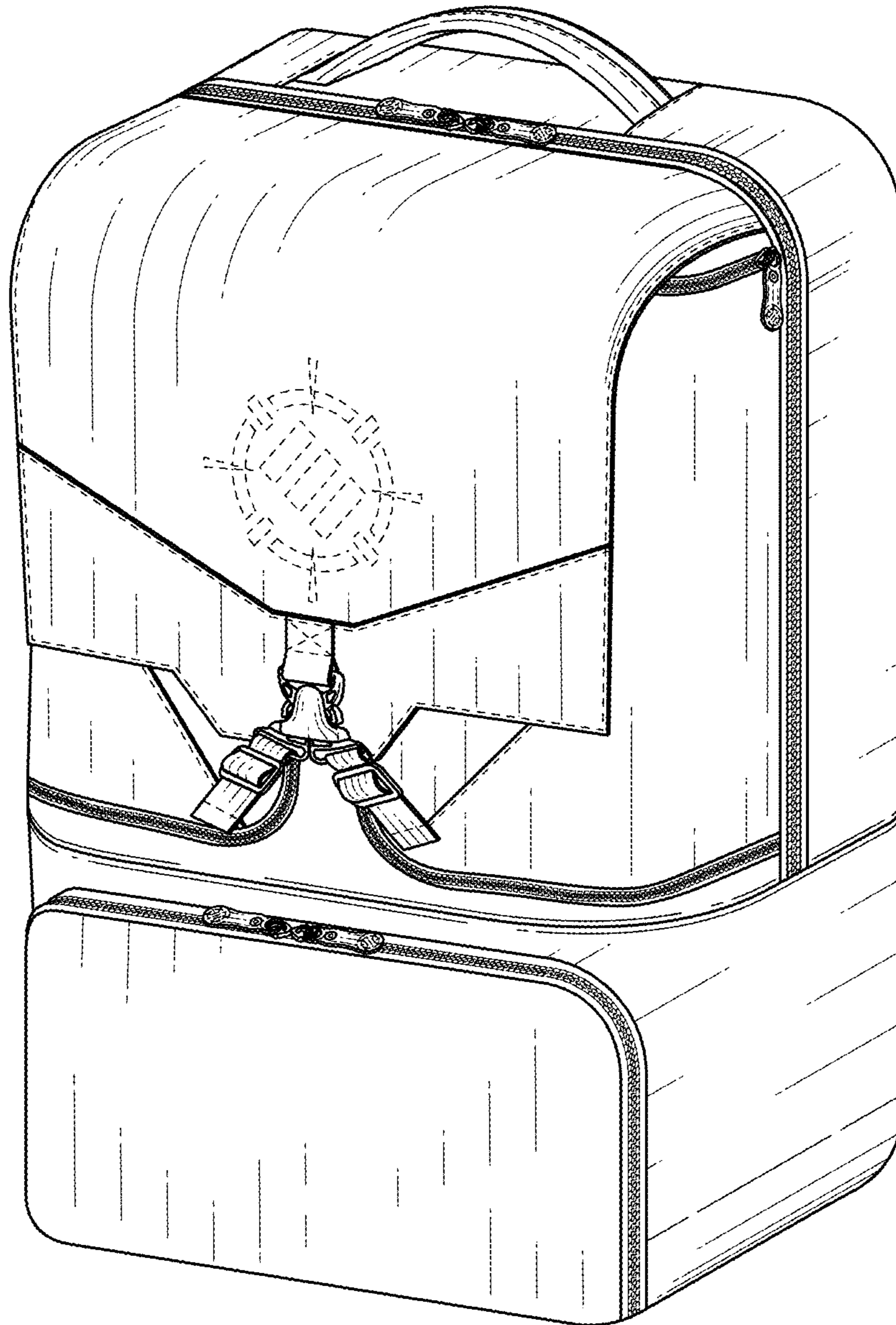

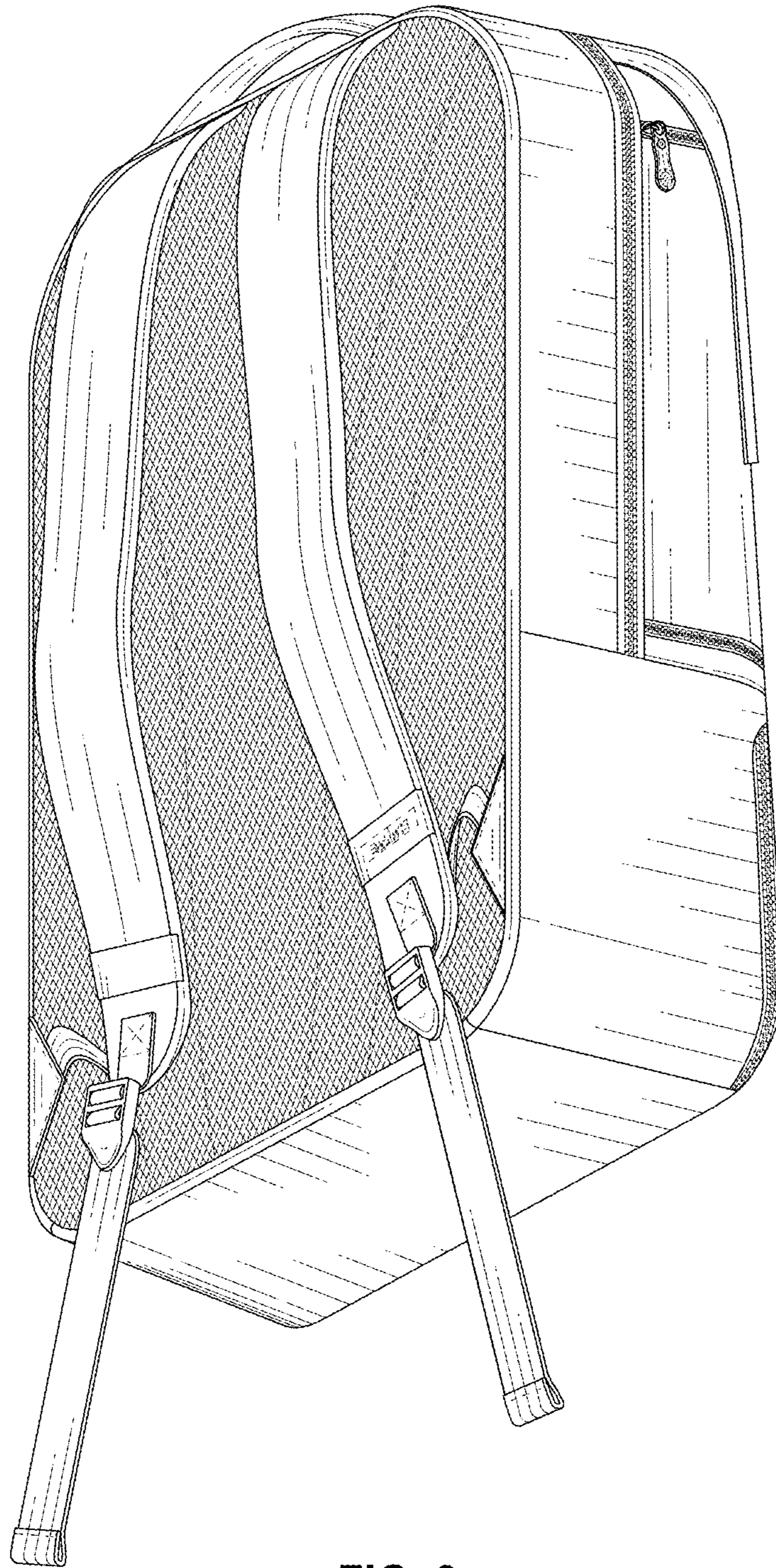

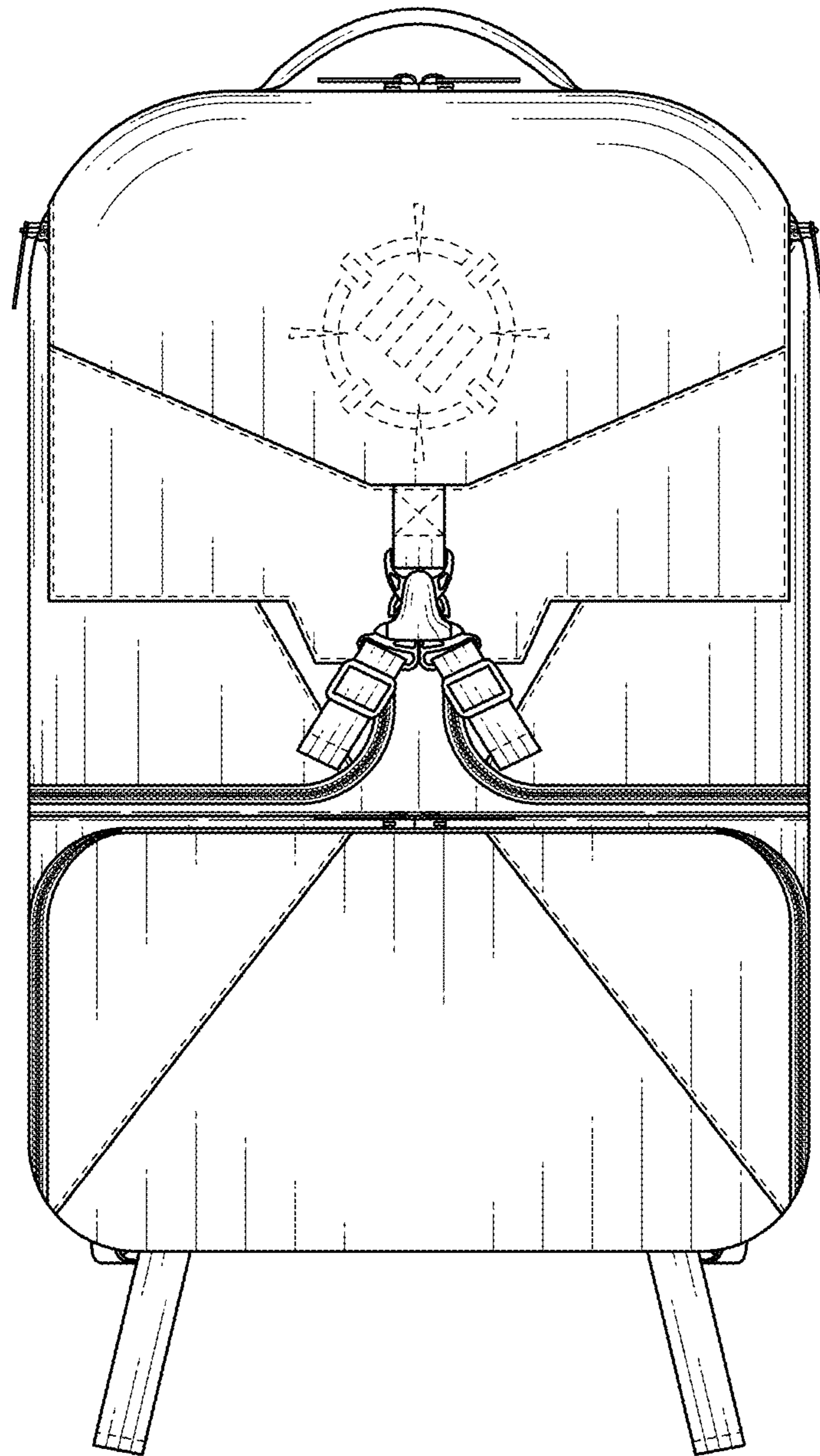

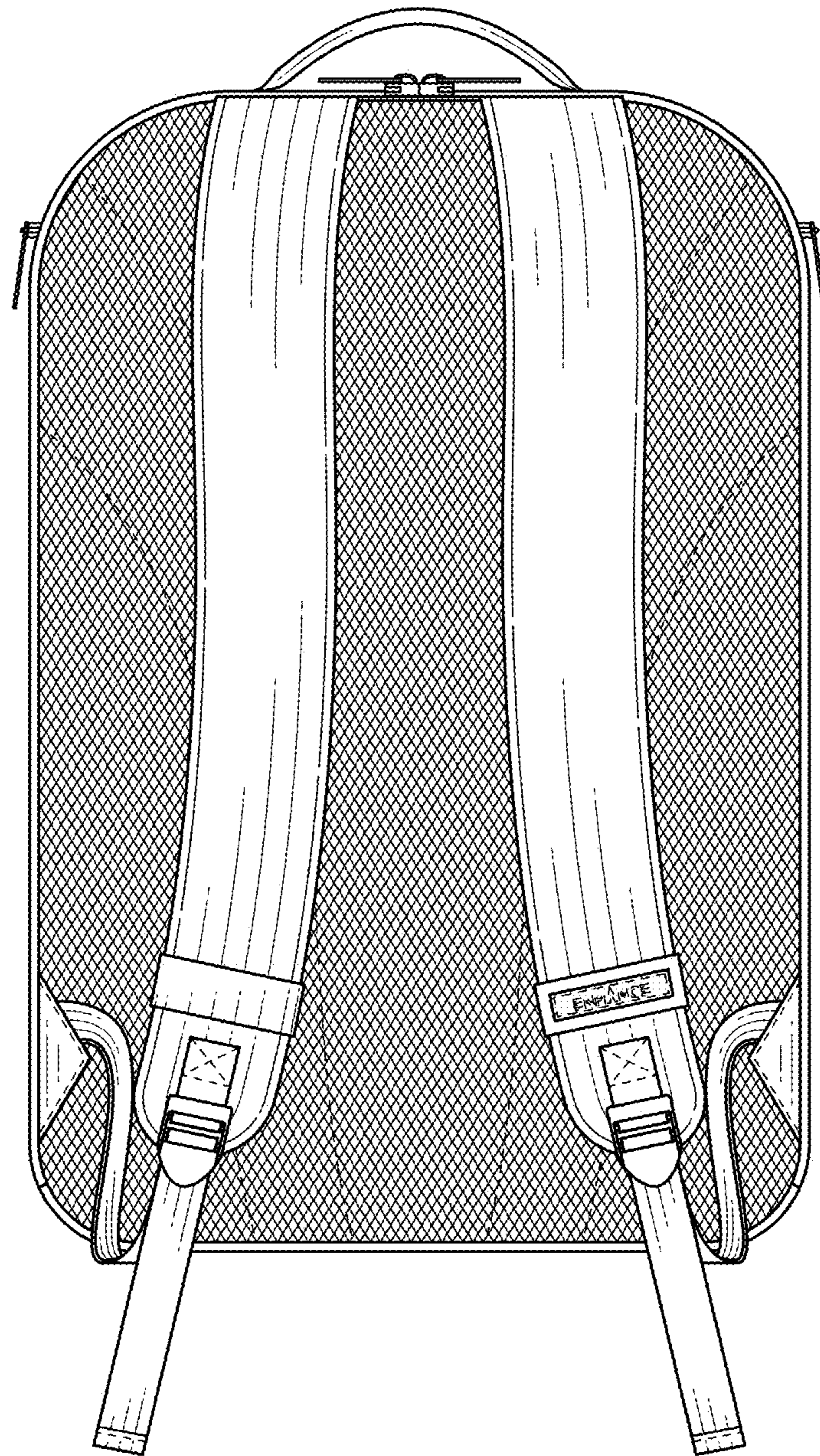

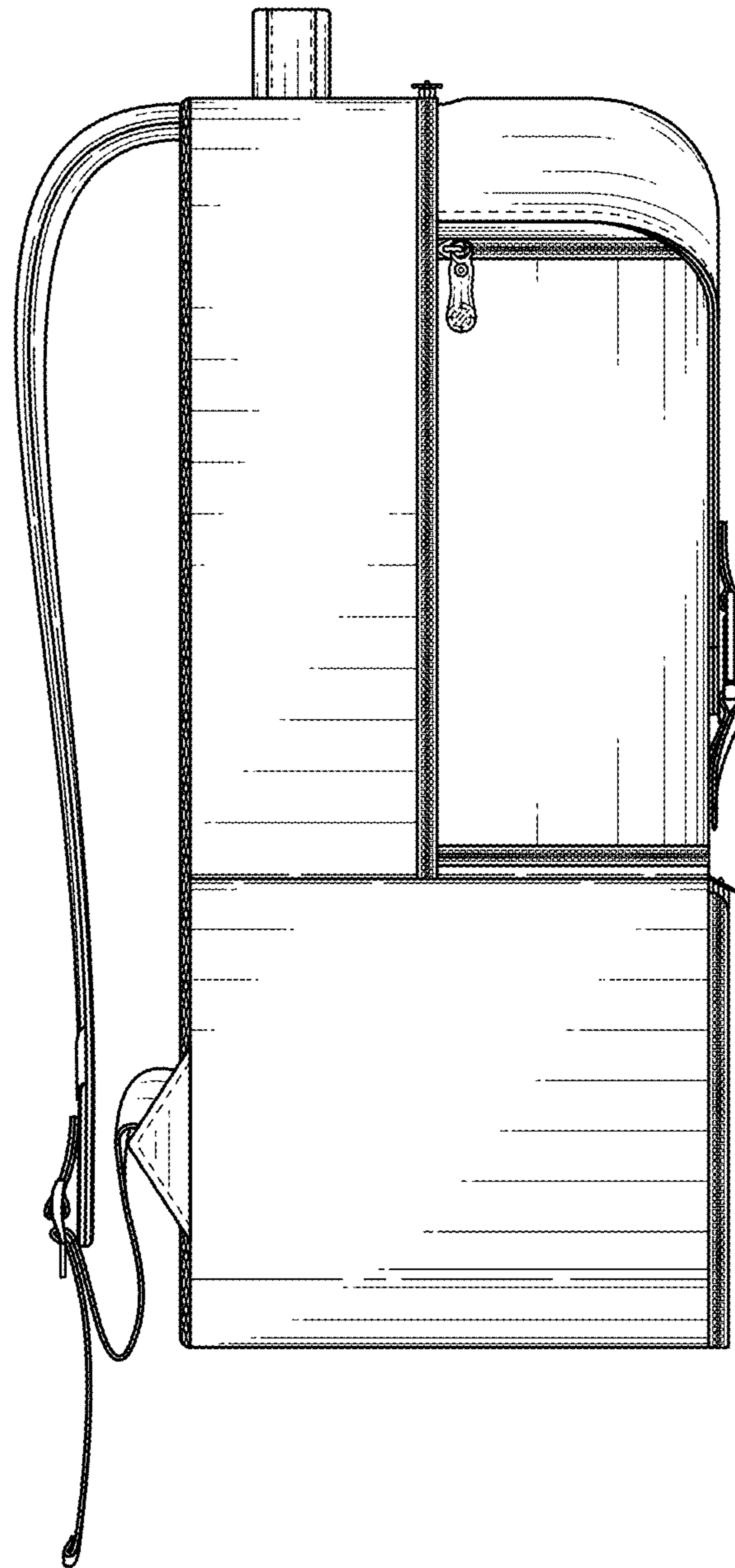

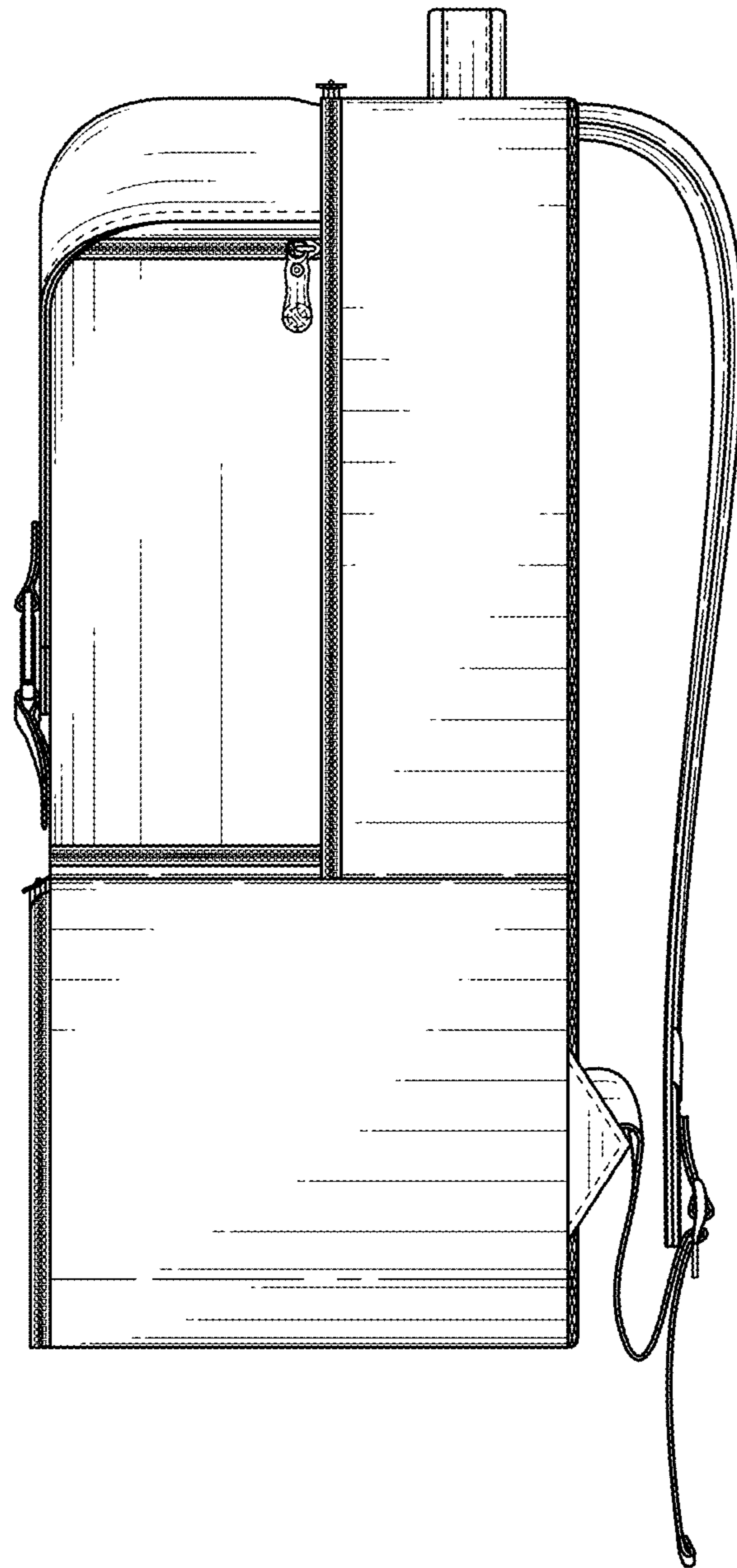

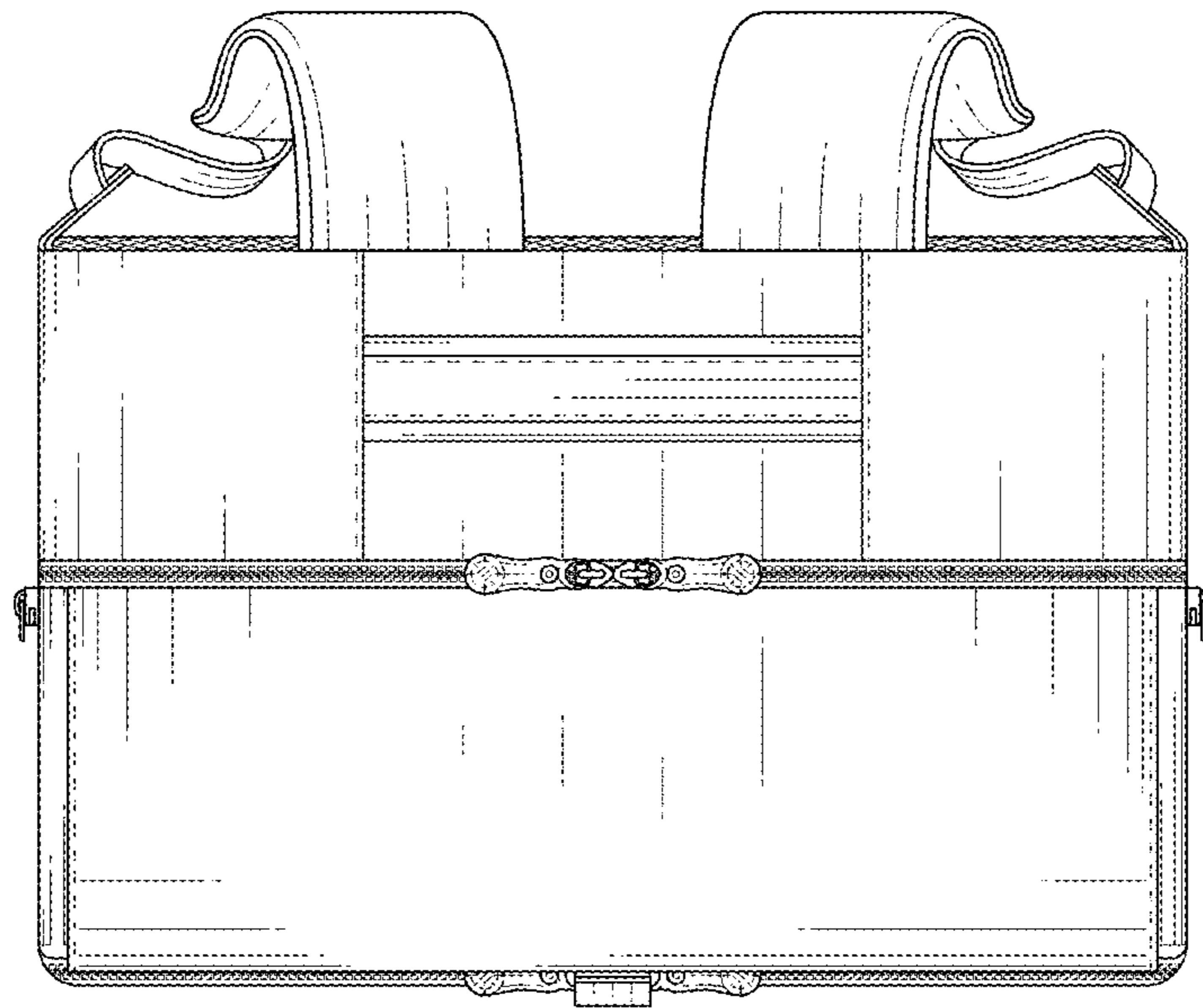

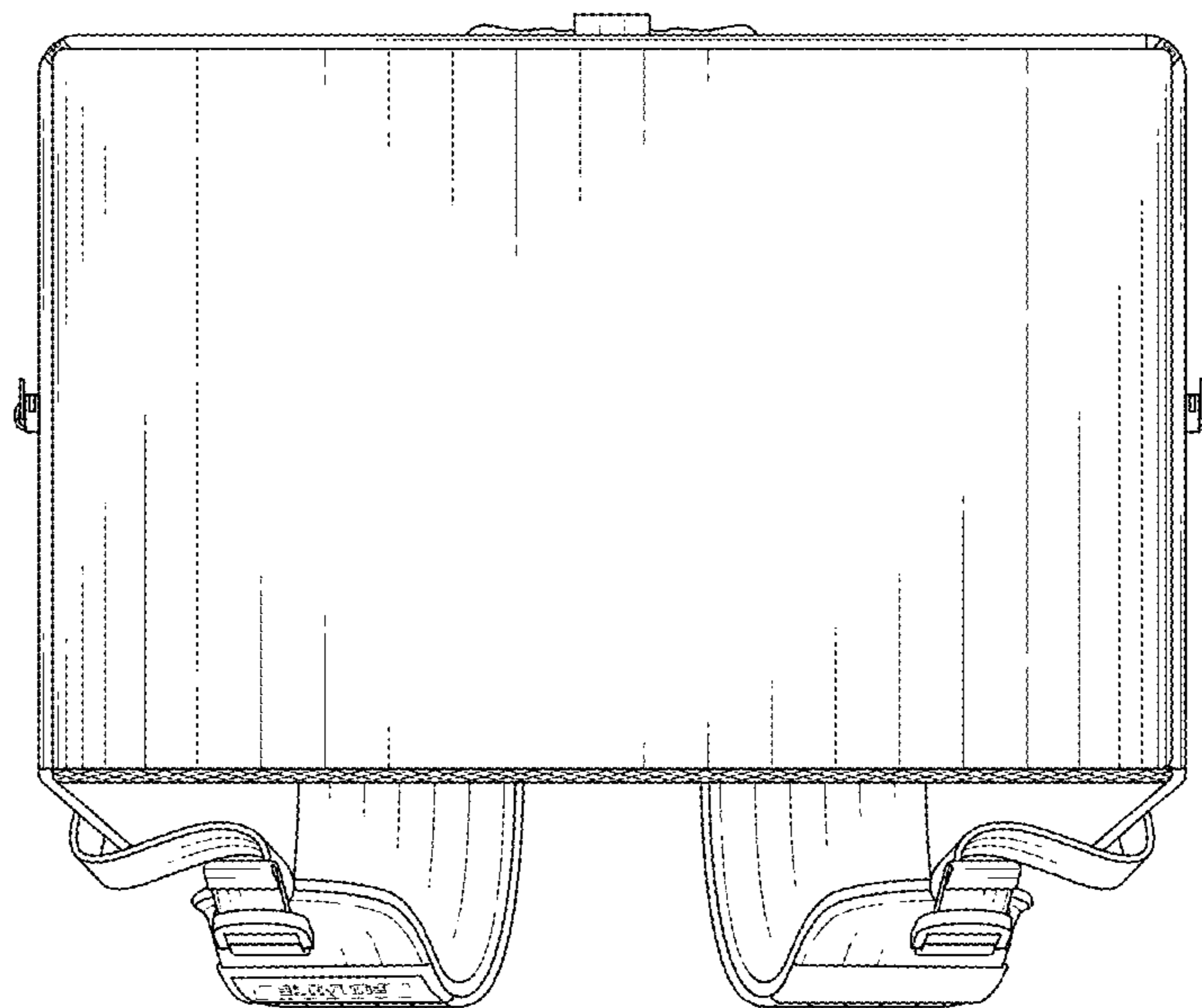

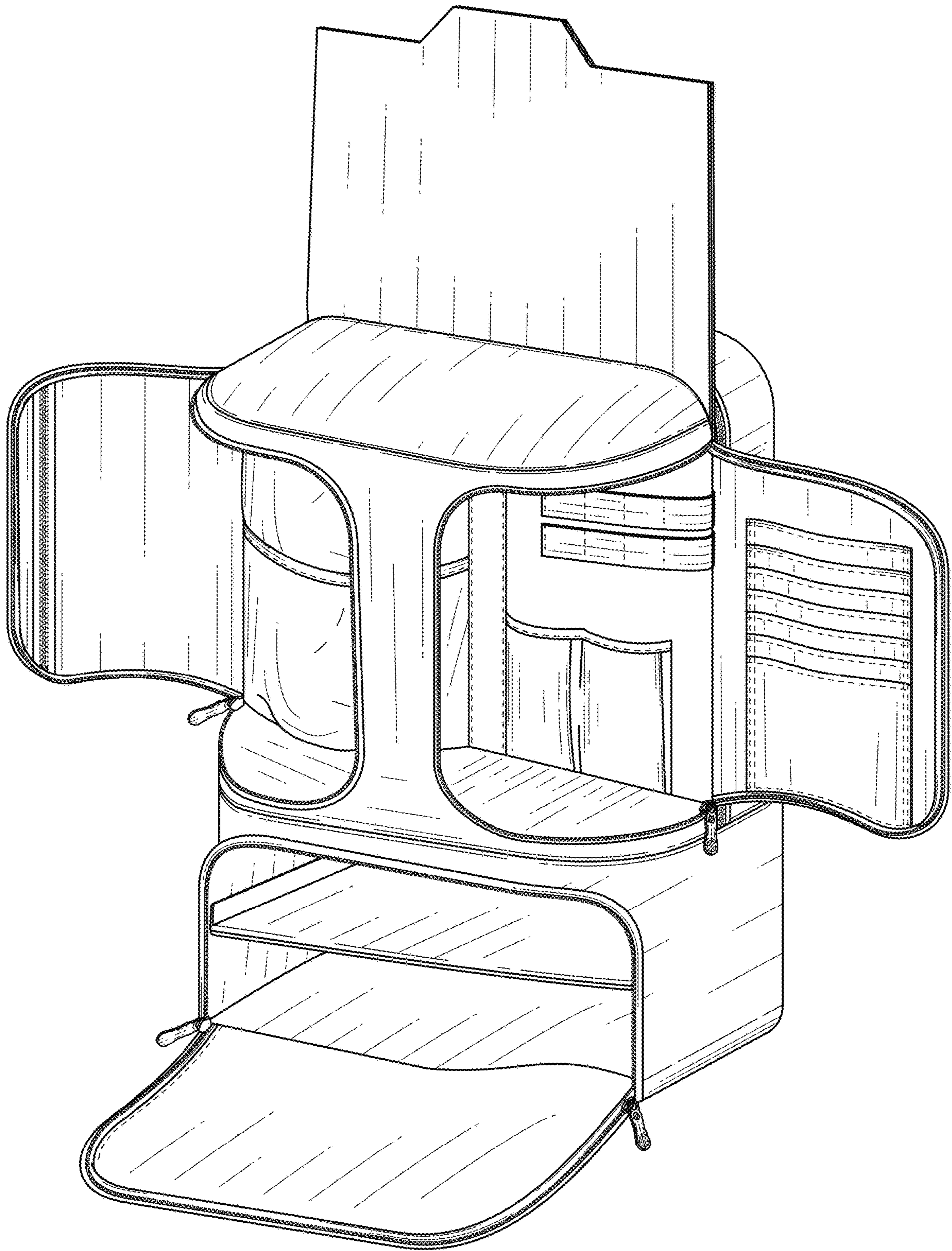

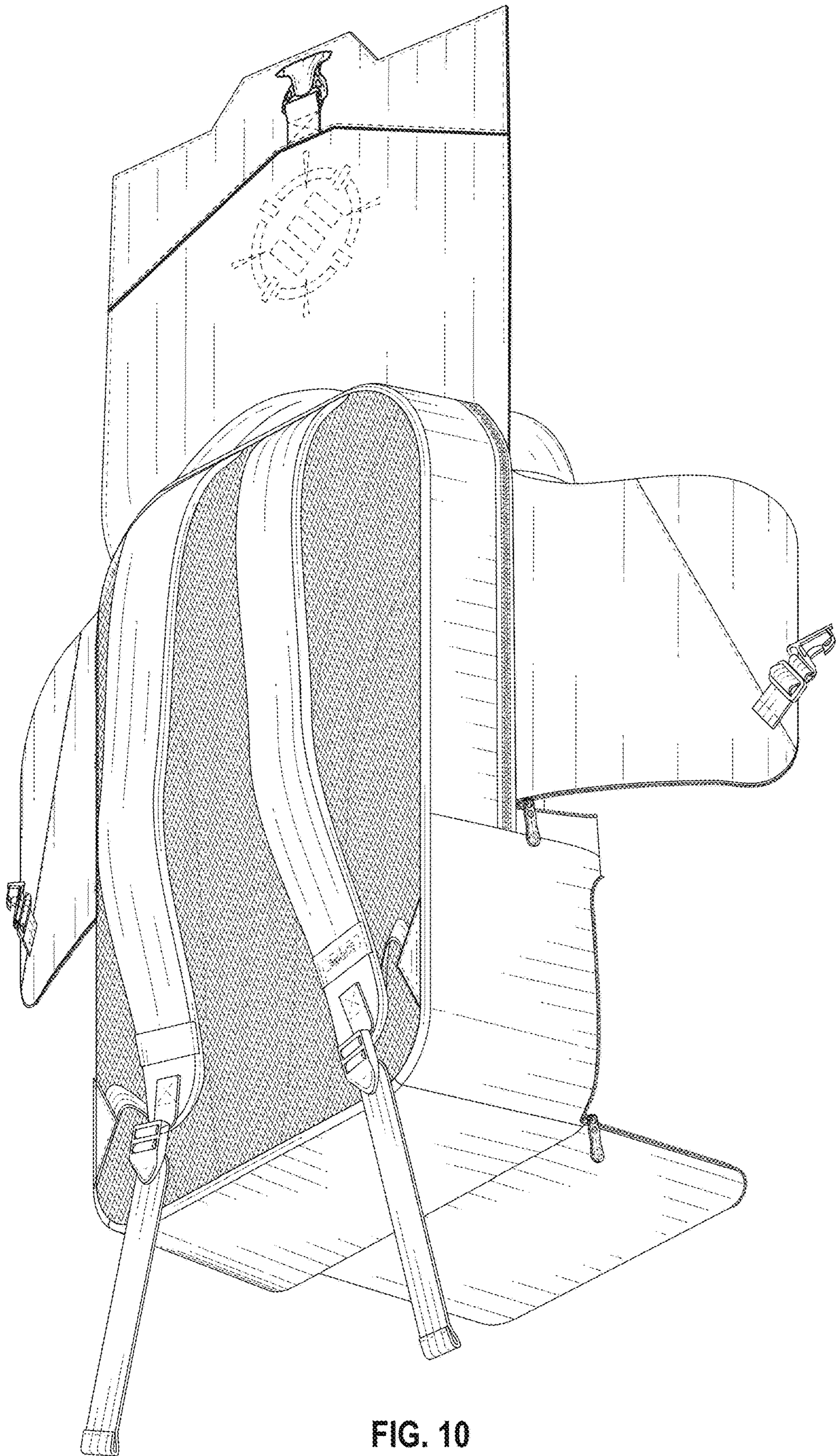
