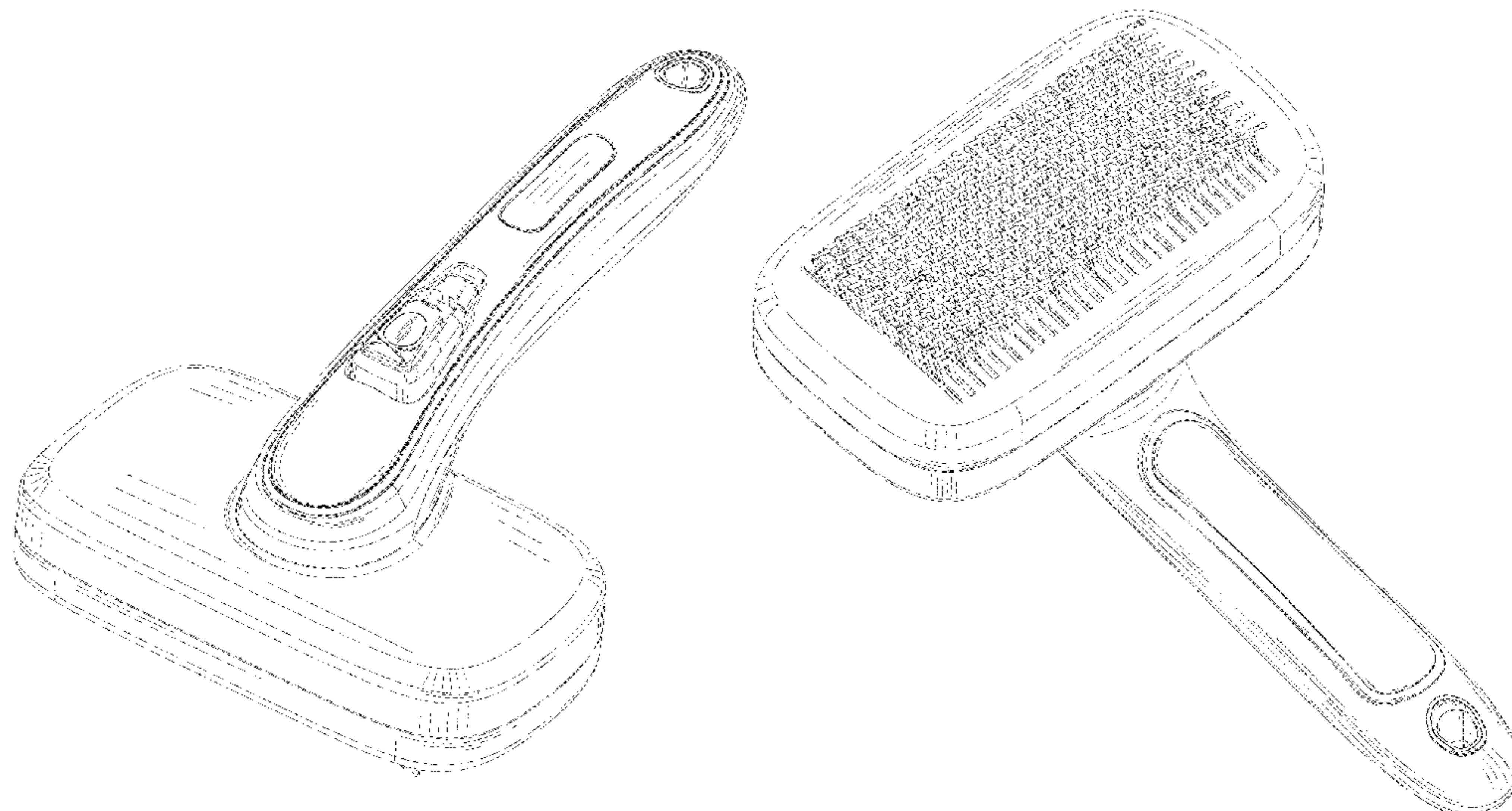
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a retractable needle comb showing my new design;  
 FIG. 2 is a back, bottom and left side perspective view thereof.  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a back elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a right side elevational view thereof;  
 FIG. 7 is a top plan view thereof; and,  
 FIG. 8 is a bottom plan view thereof.

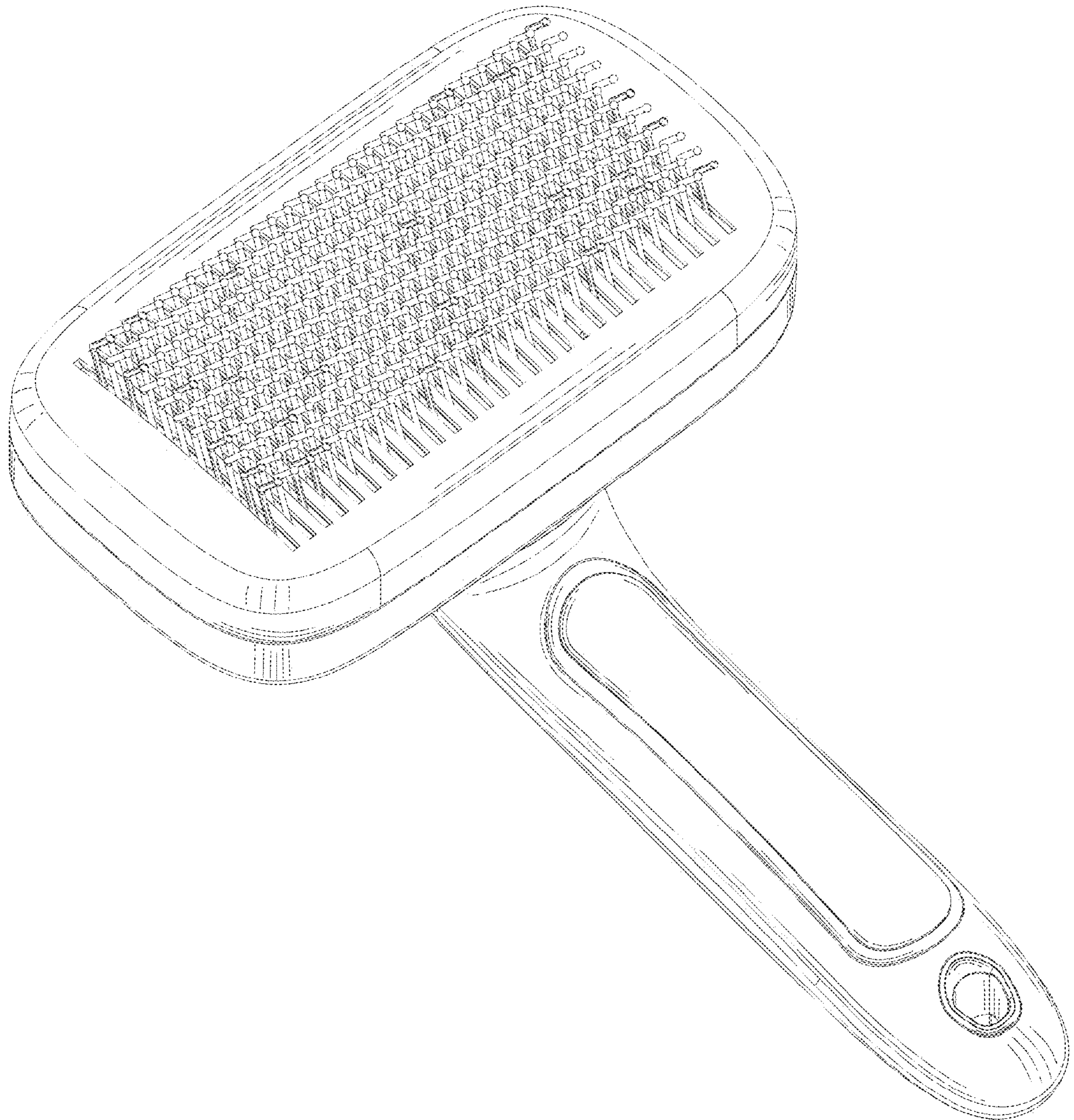

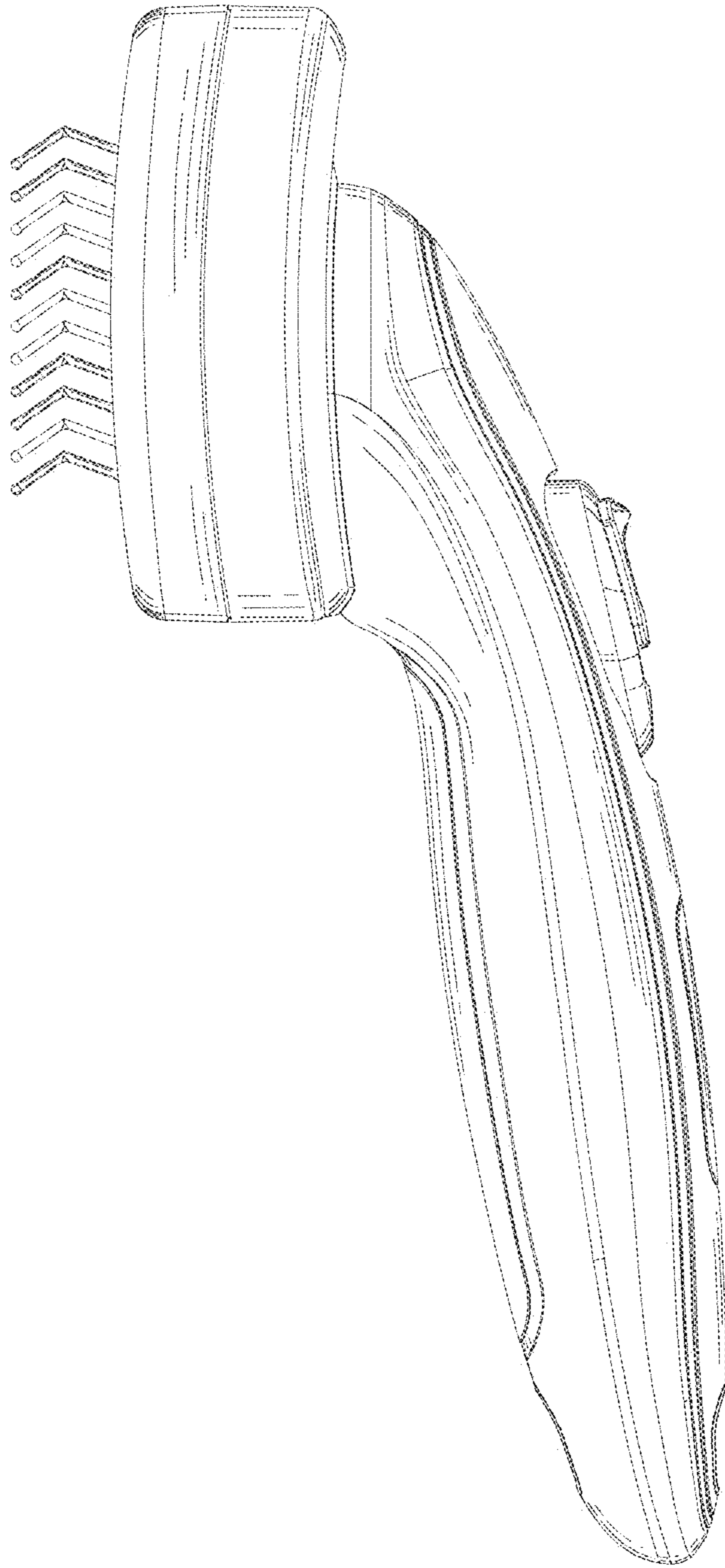

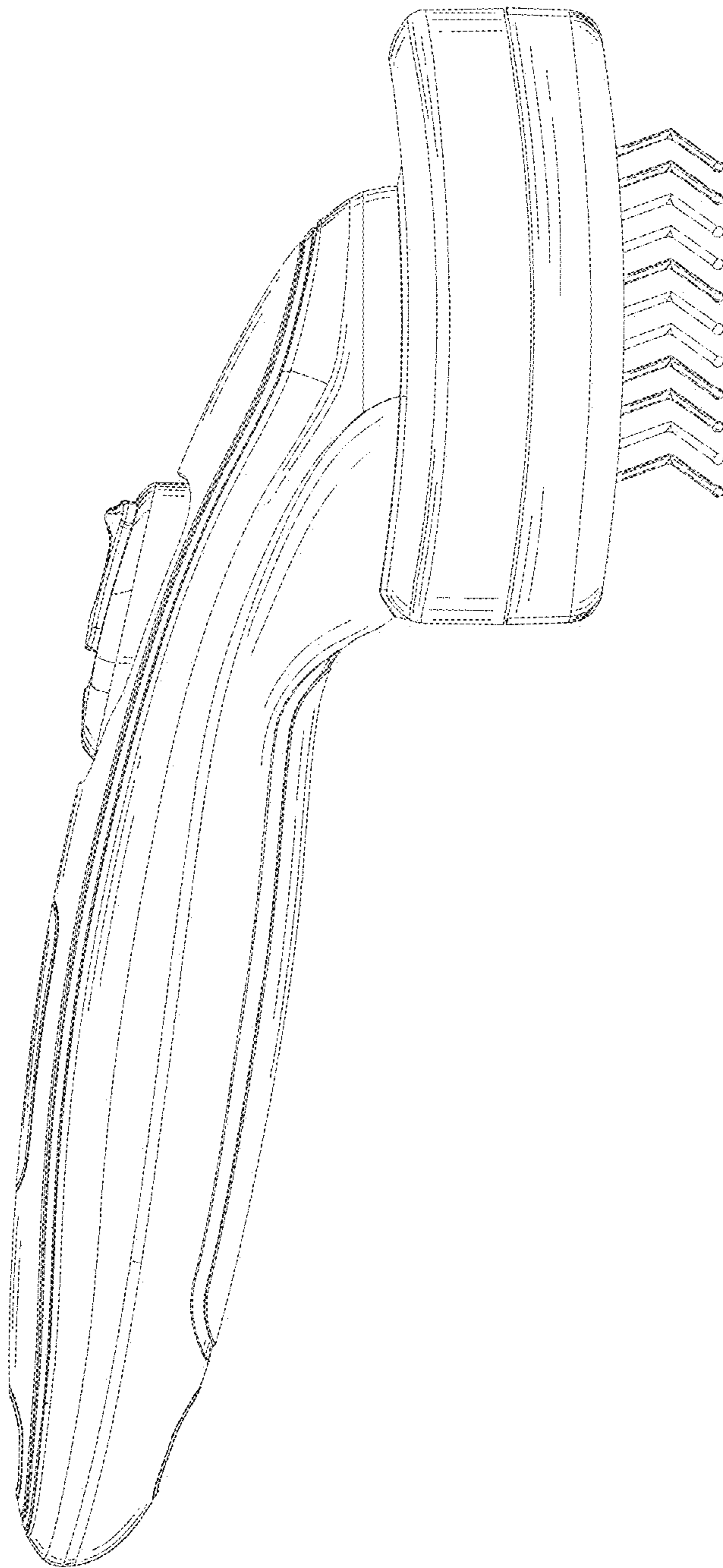

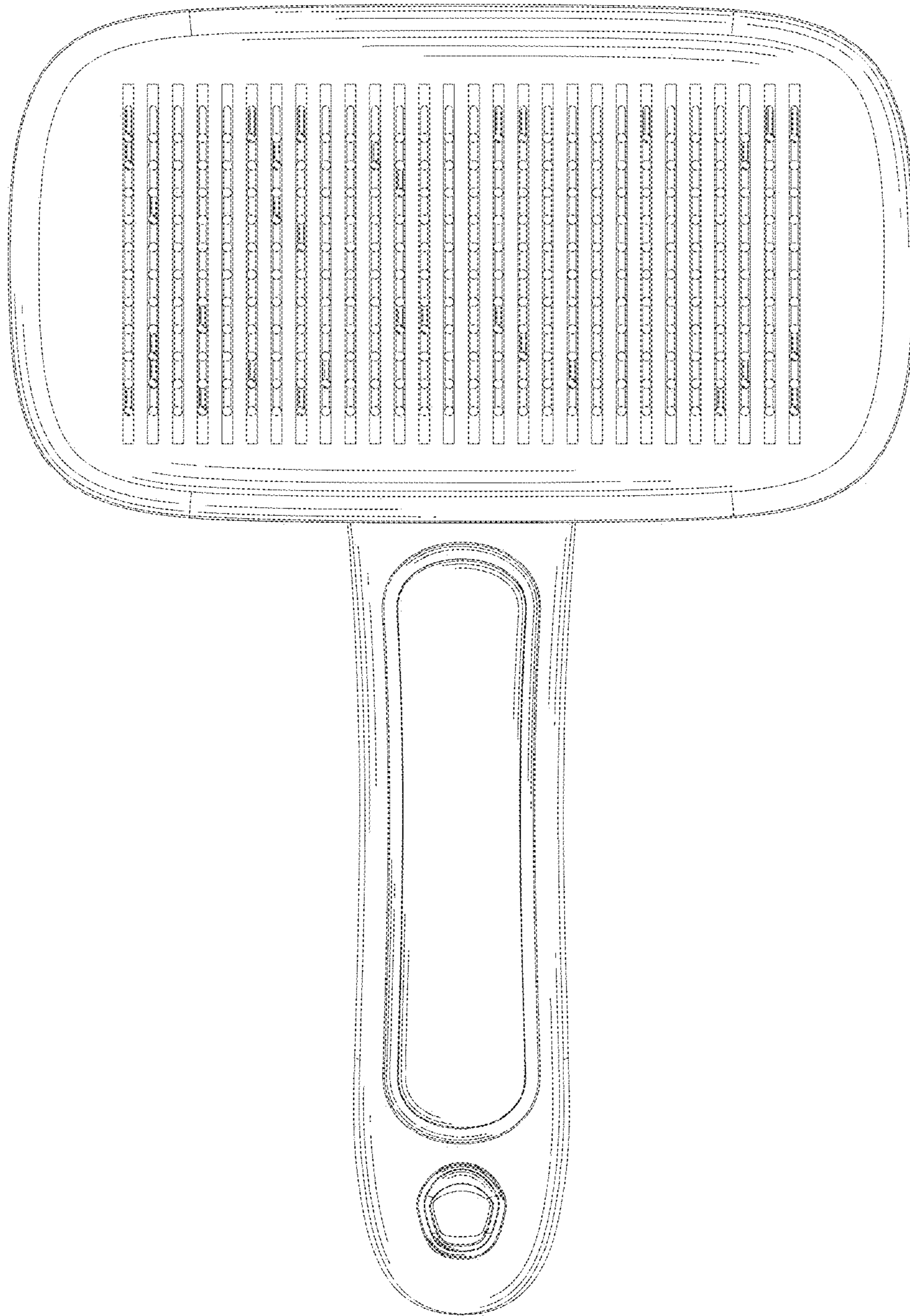

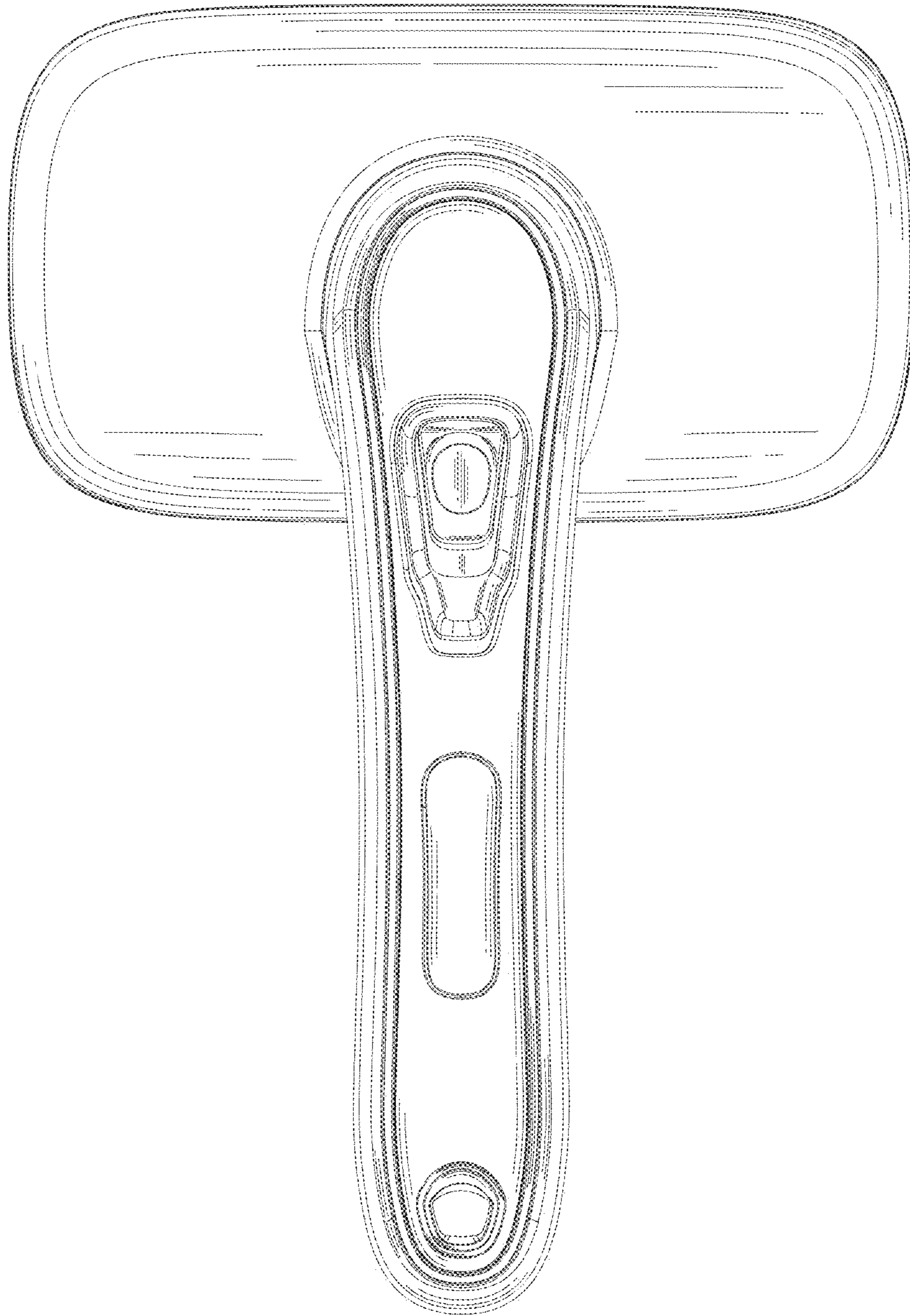

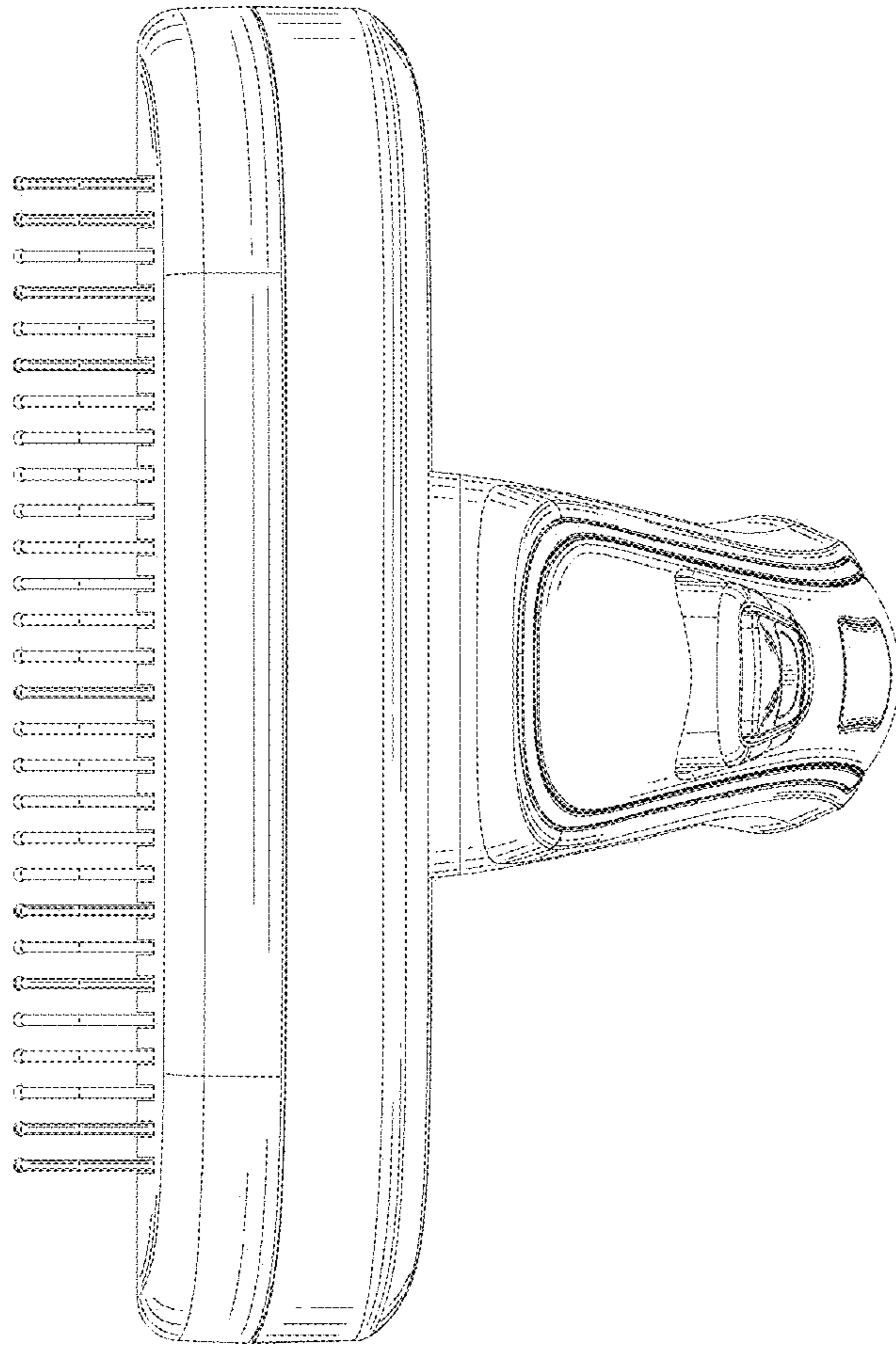

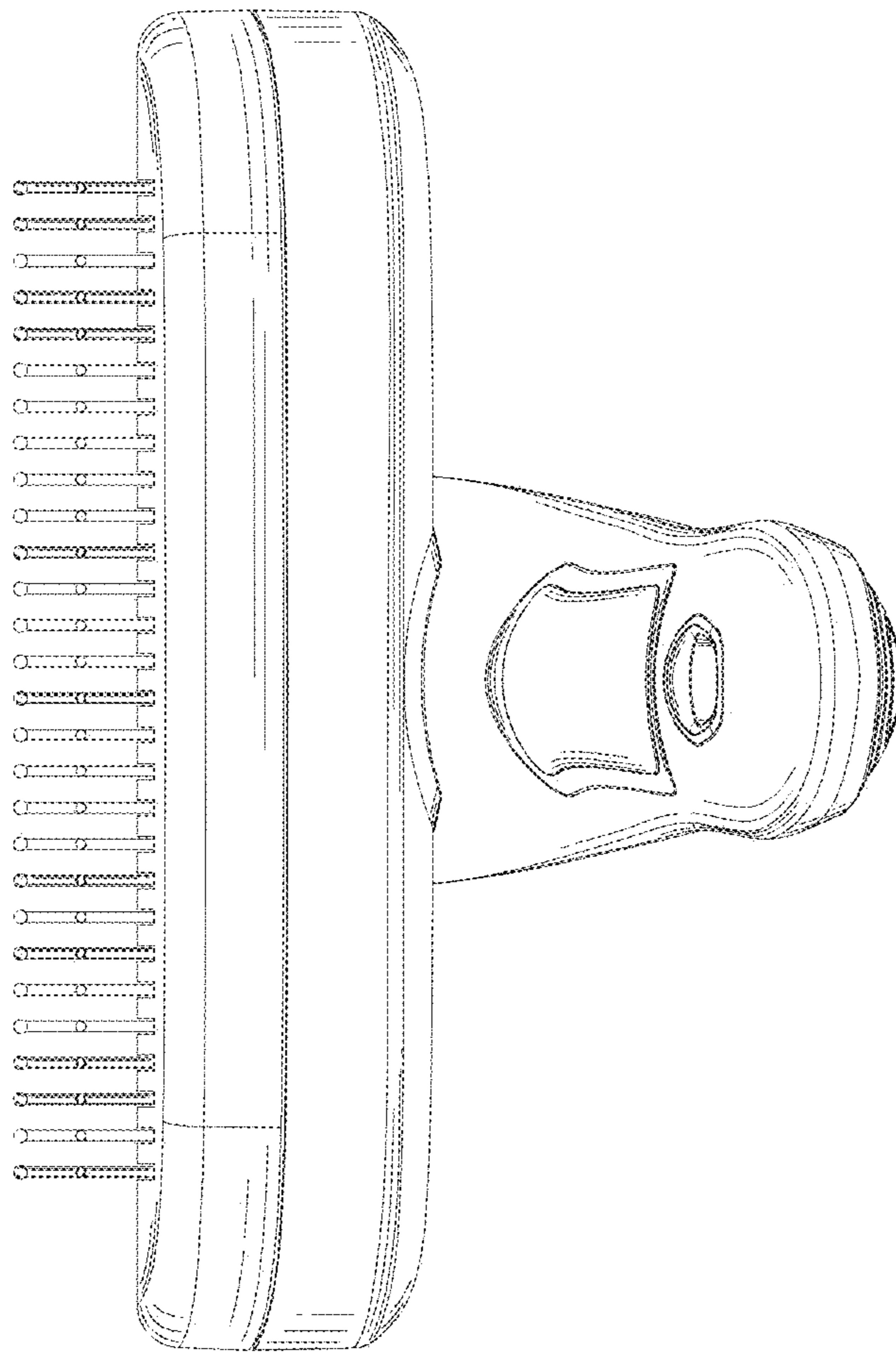
