**DESCRIPTION**

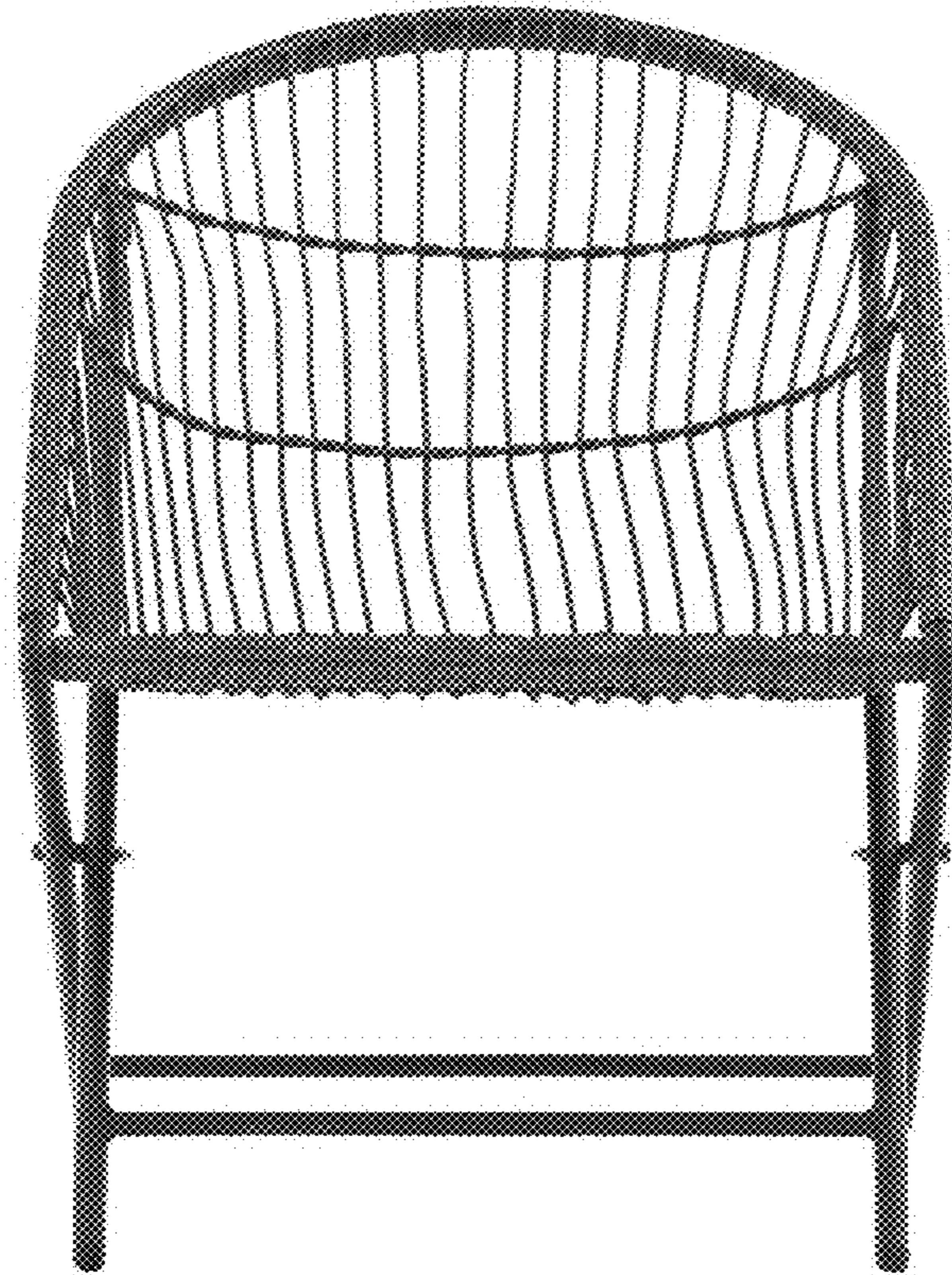

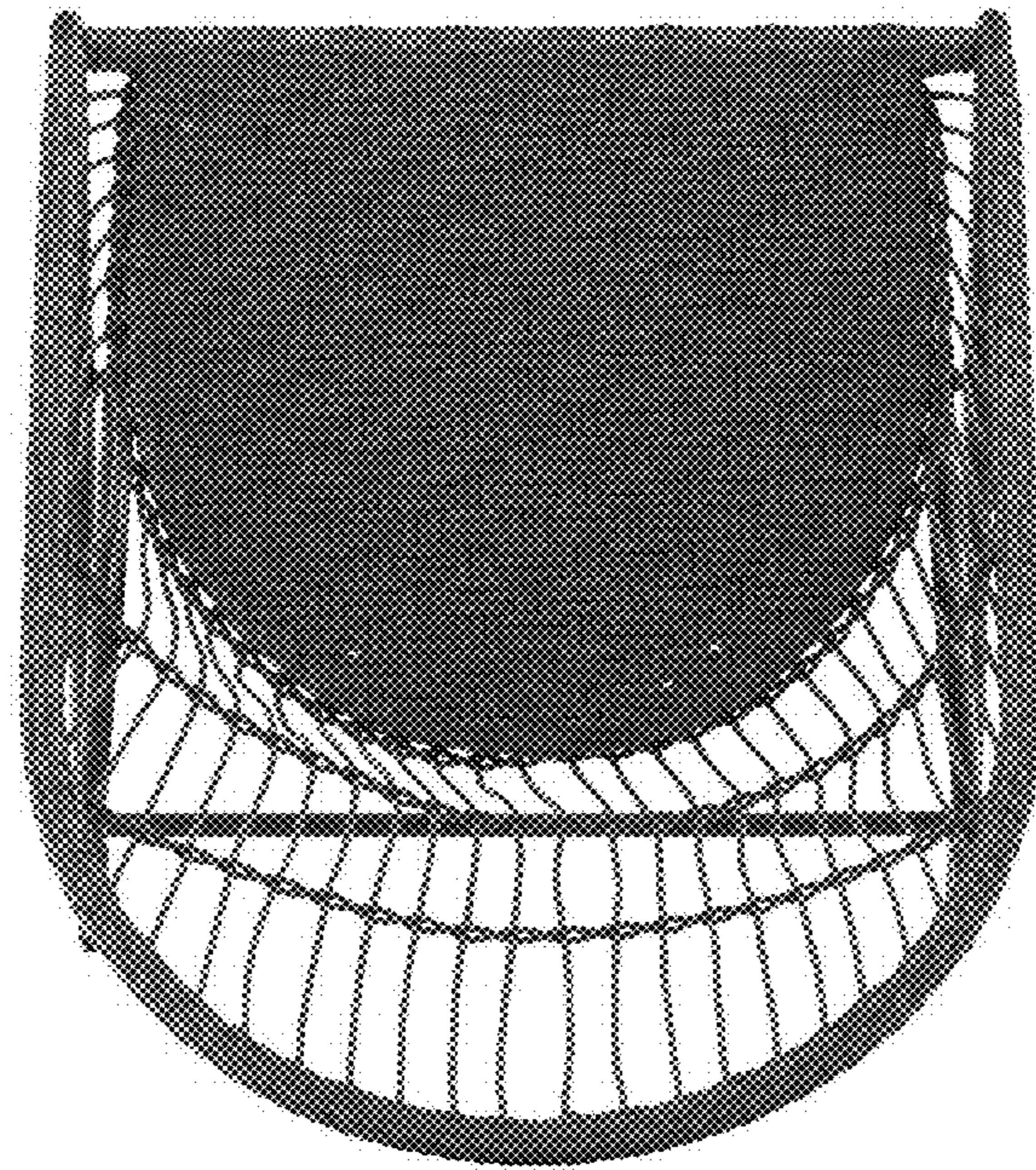

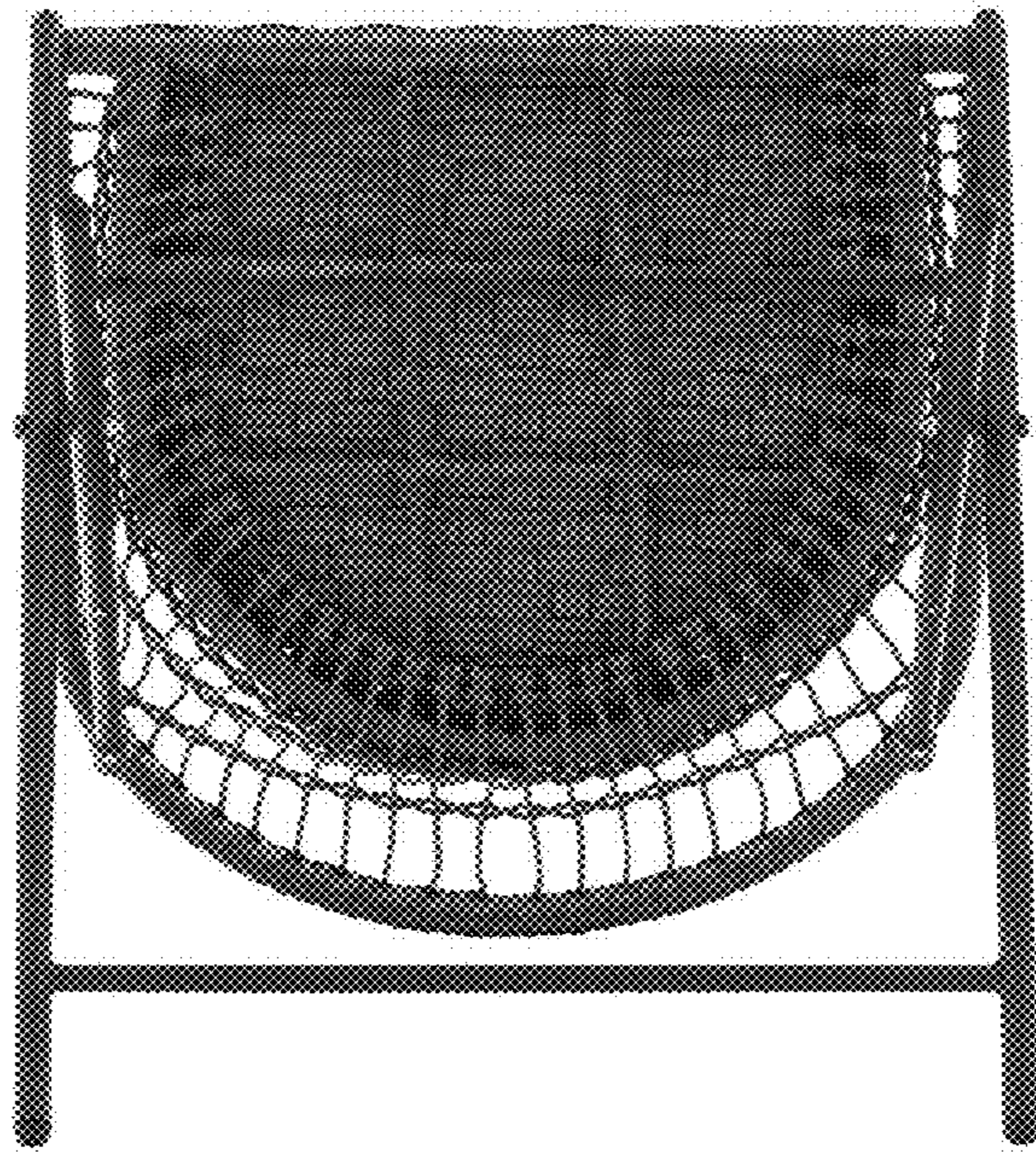

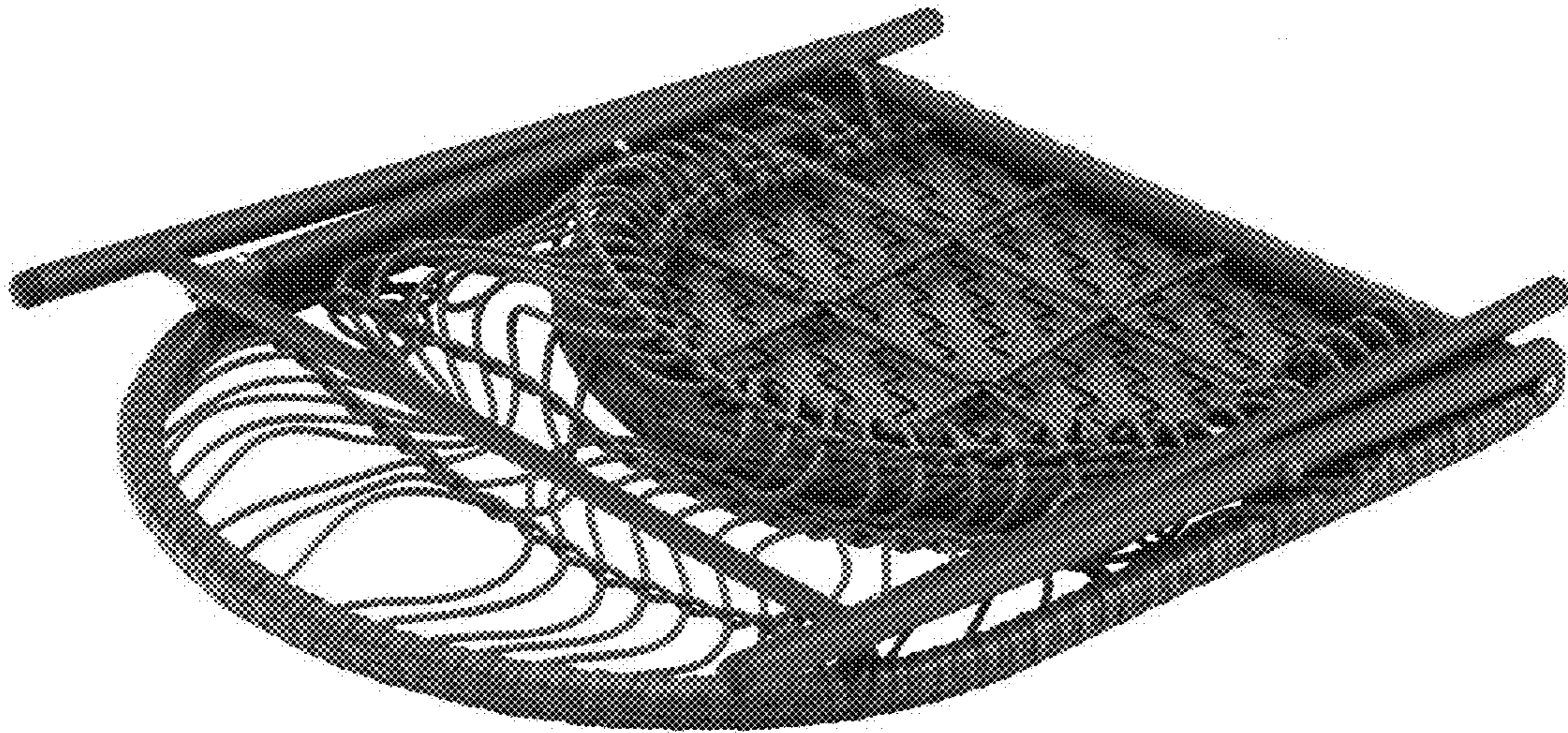
