The ornamental design for a jewelry rack, as shown and described.

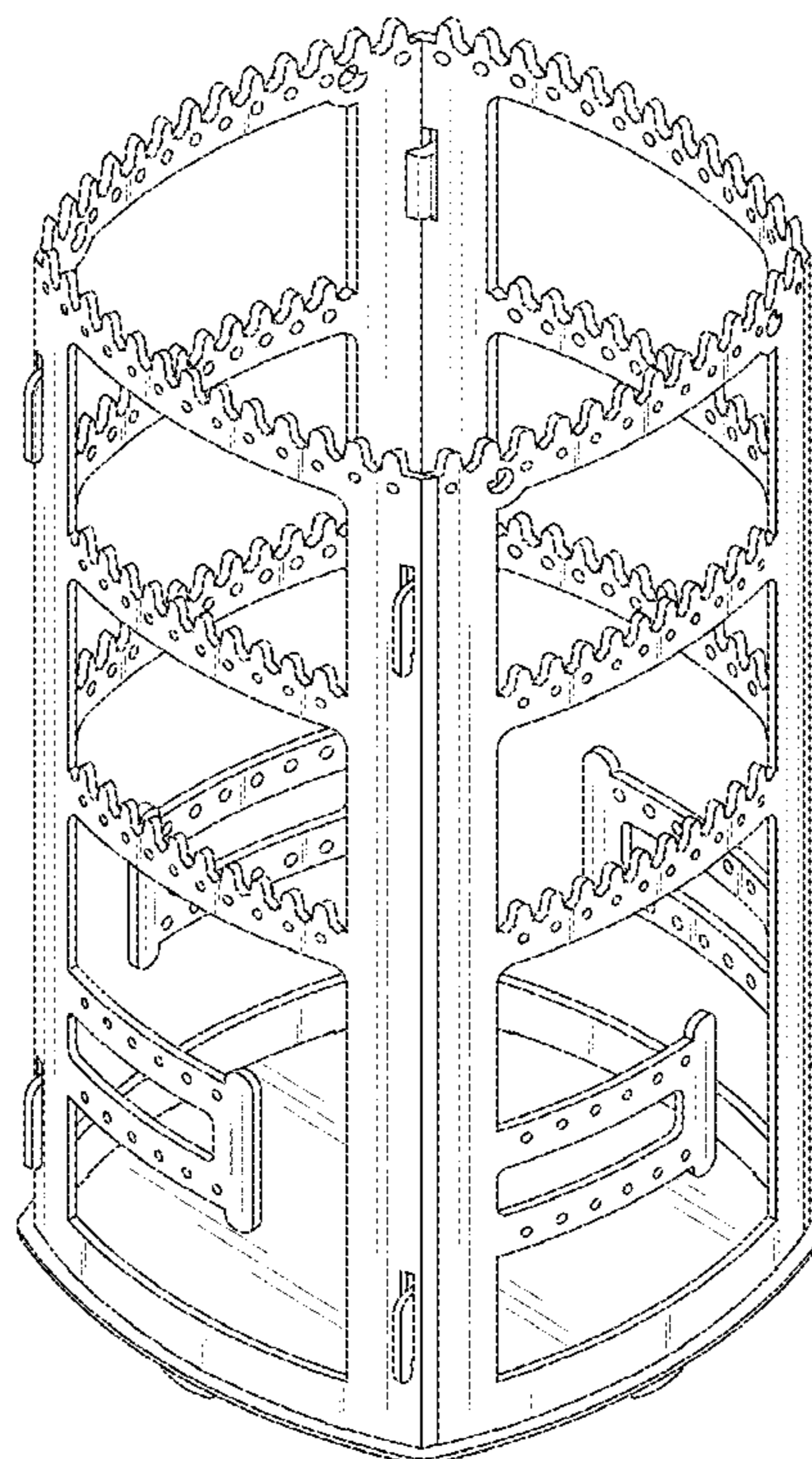
DESCRIPTION

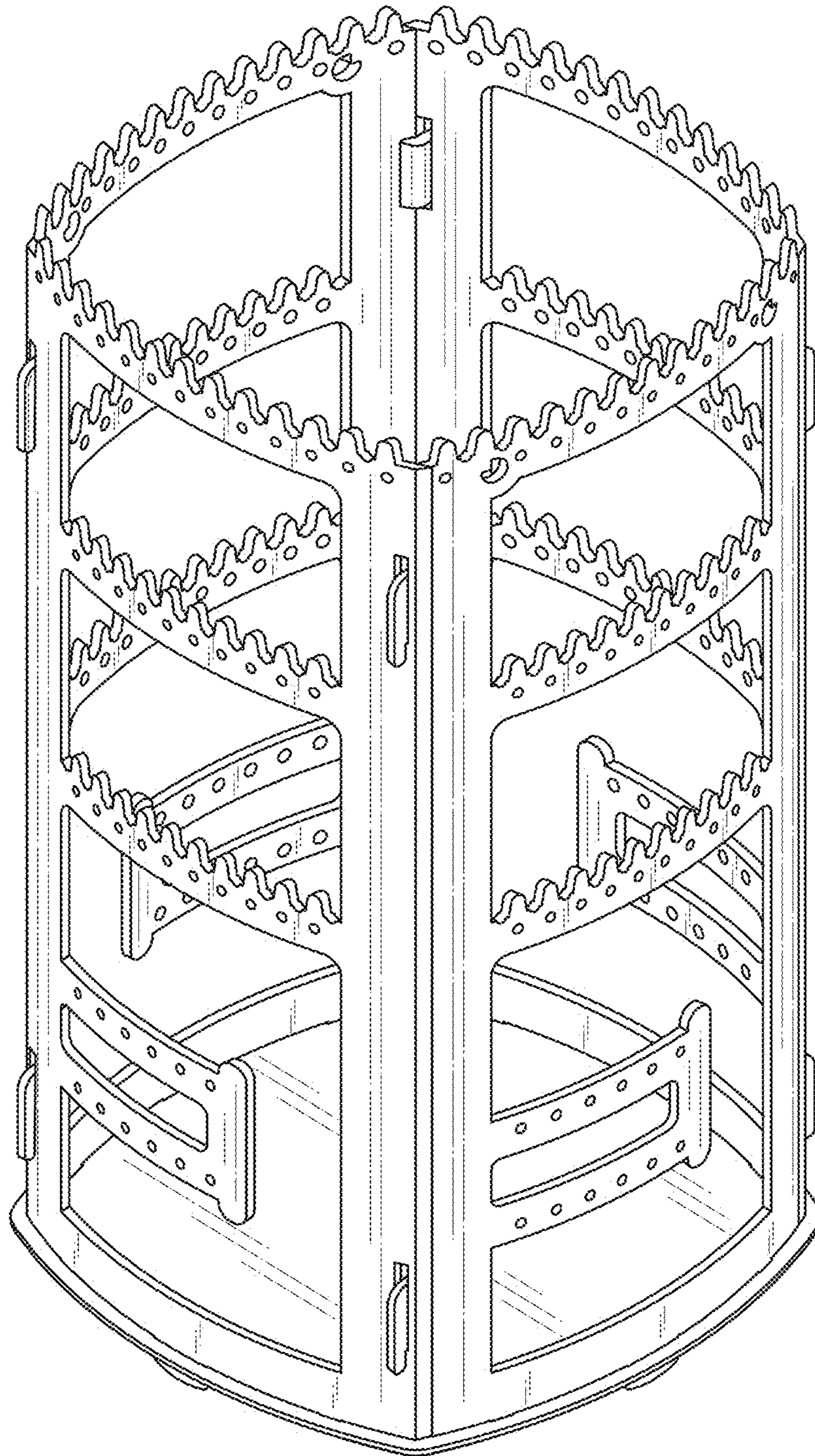

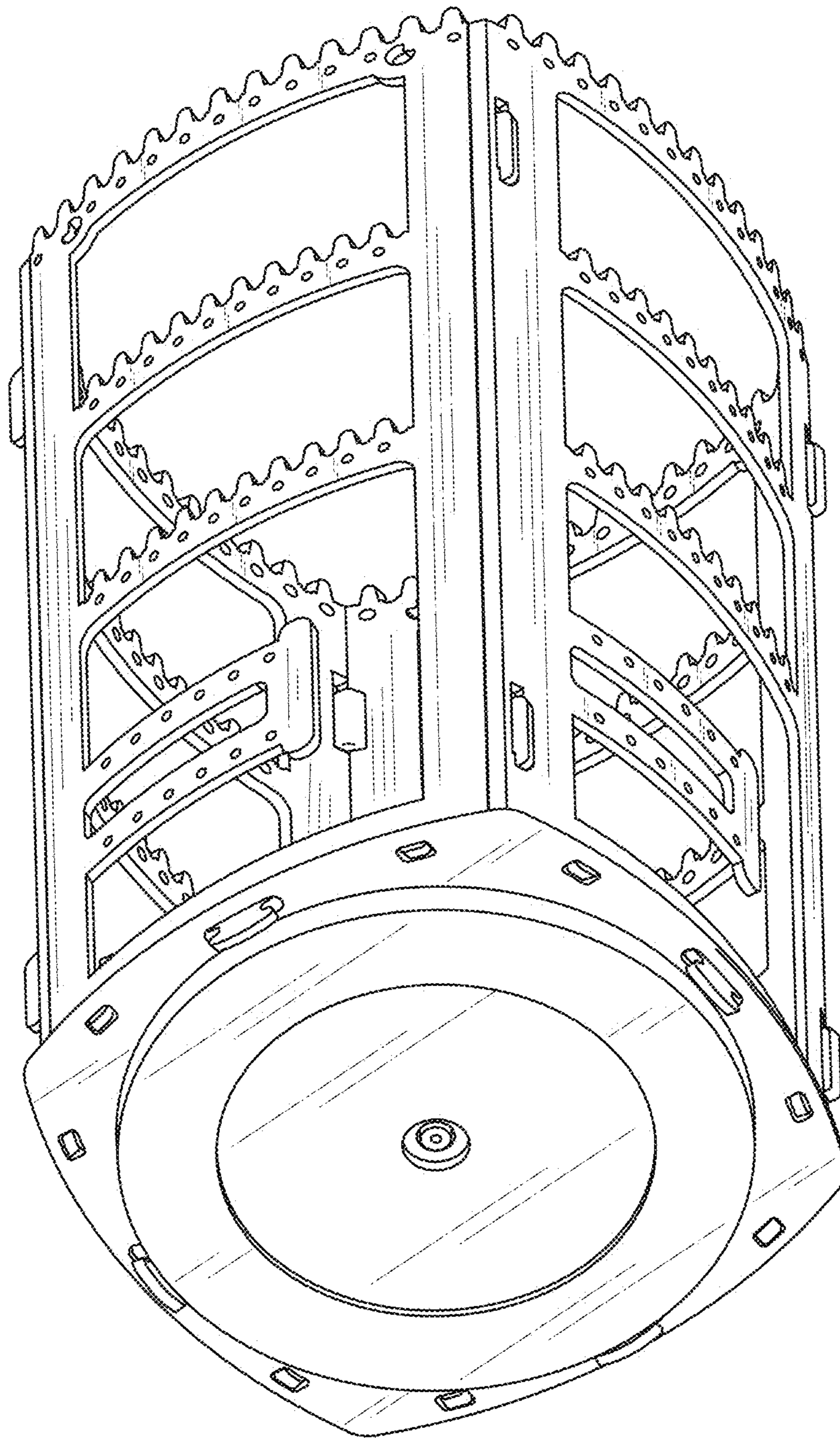

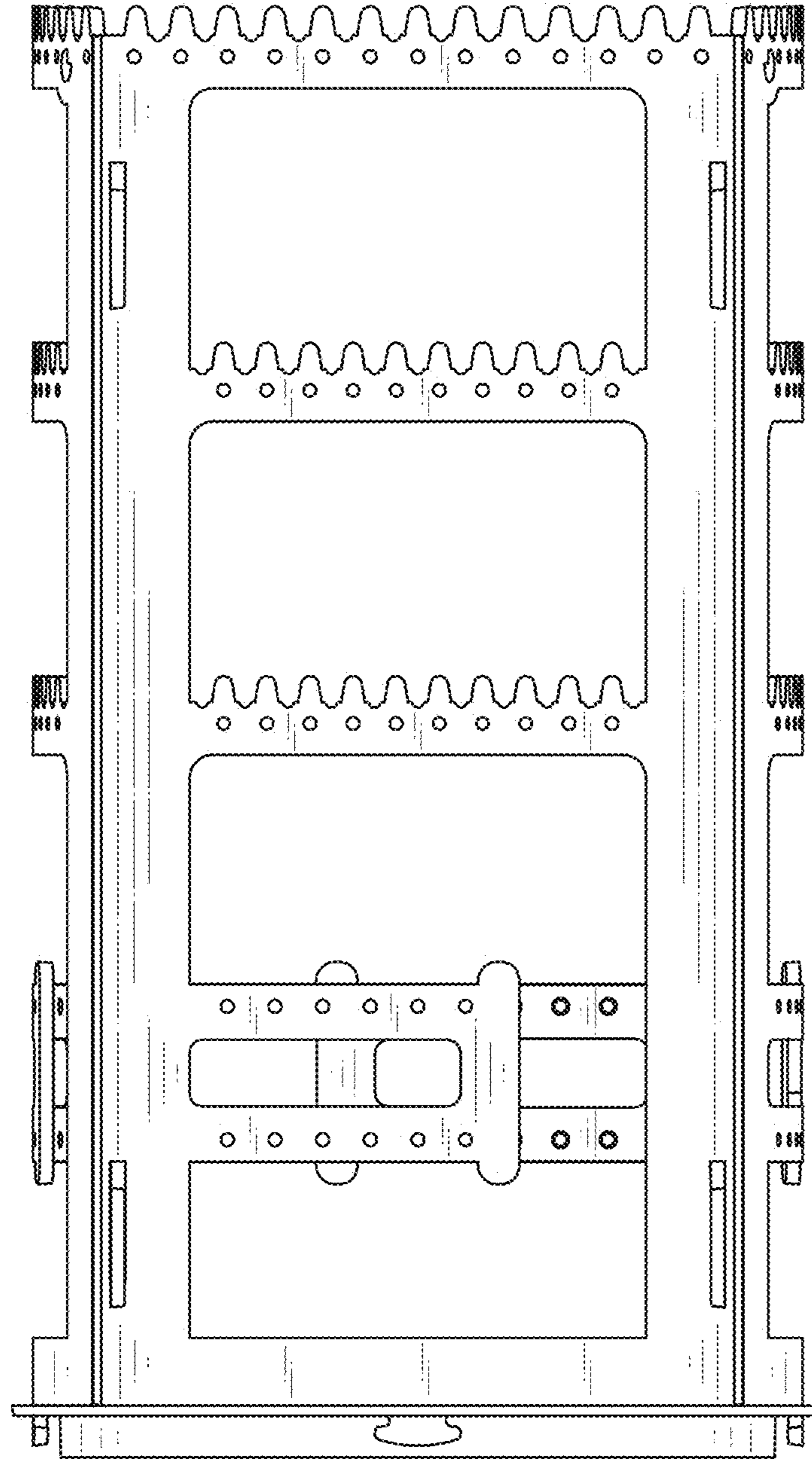

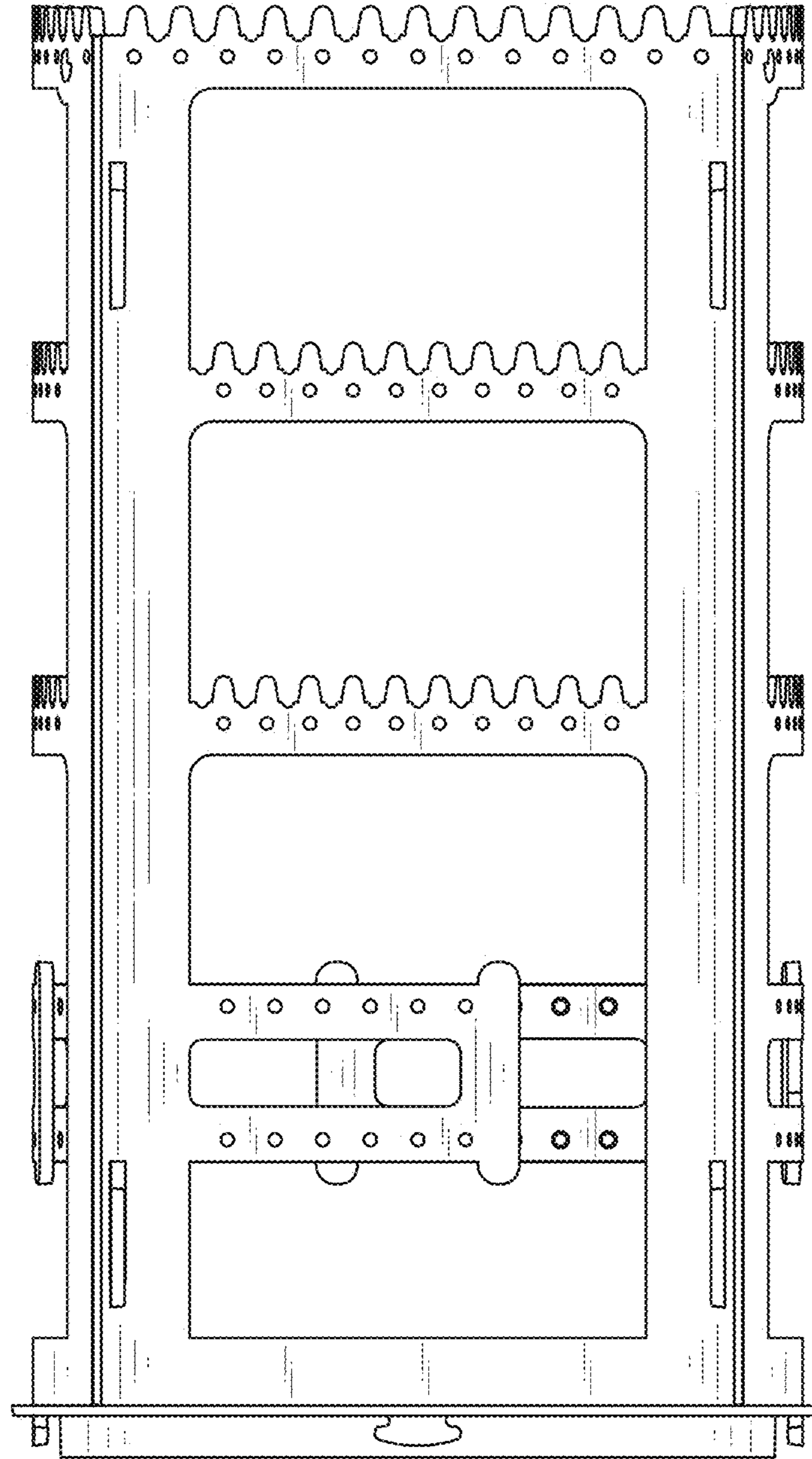

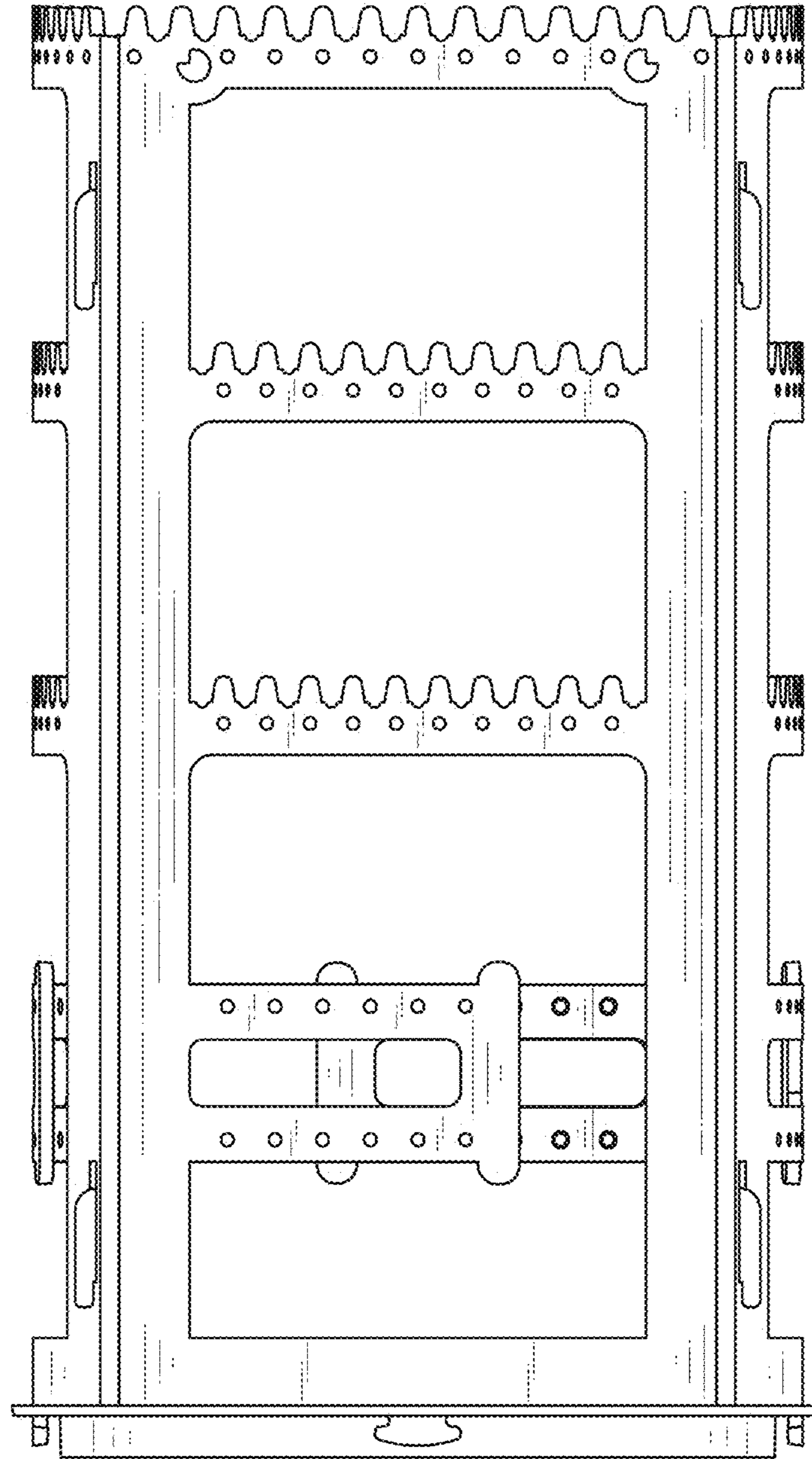

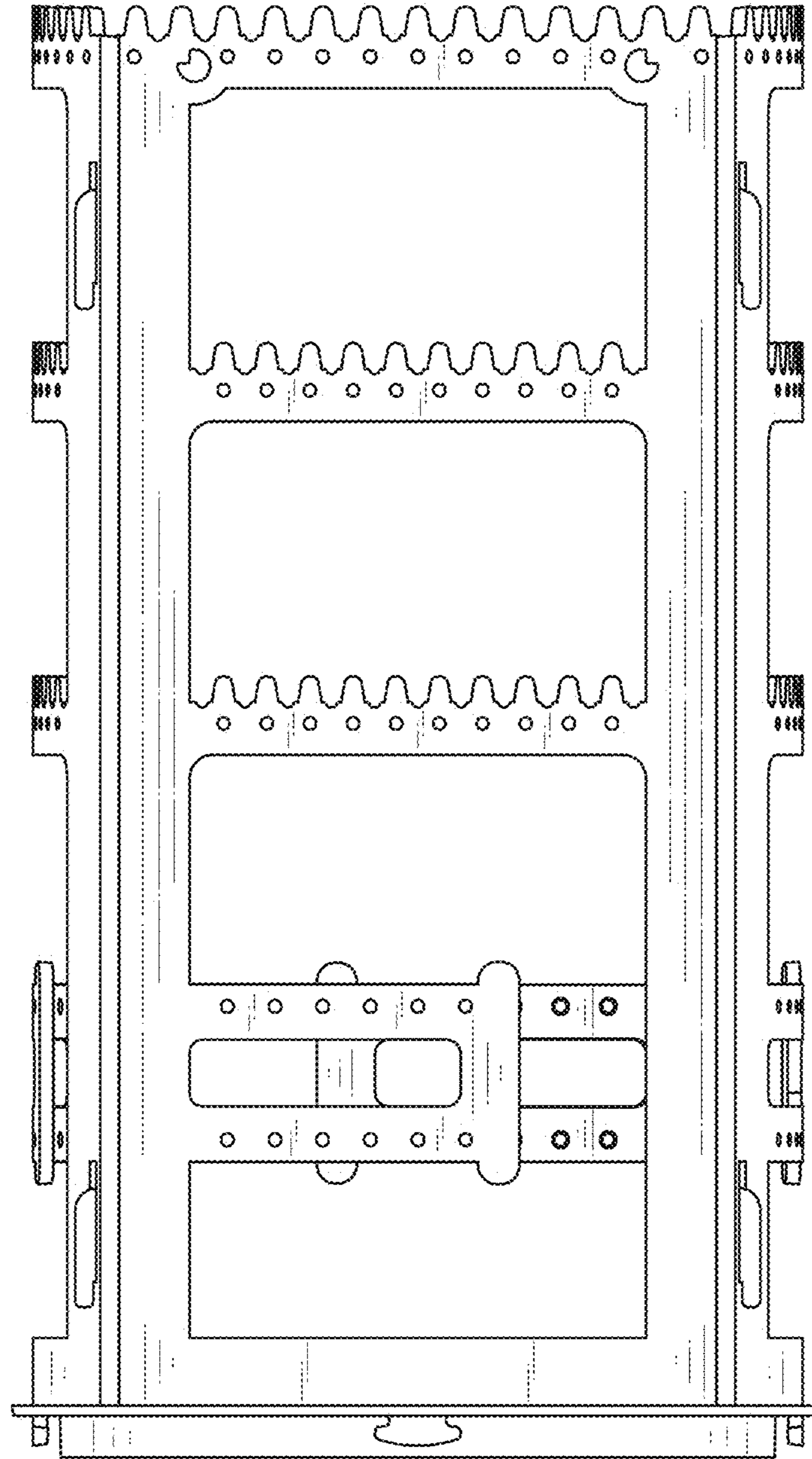

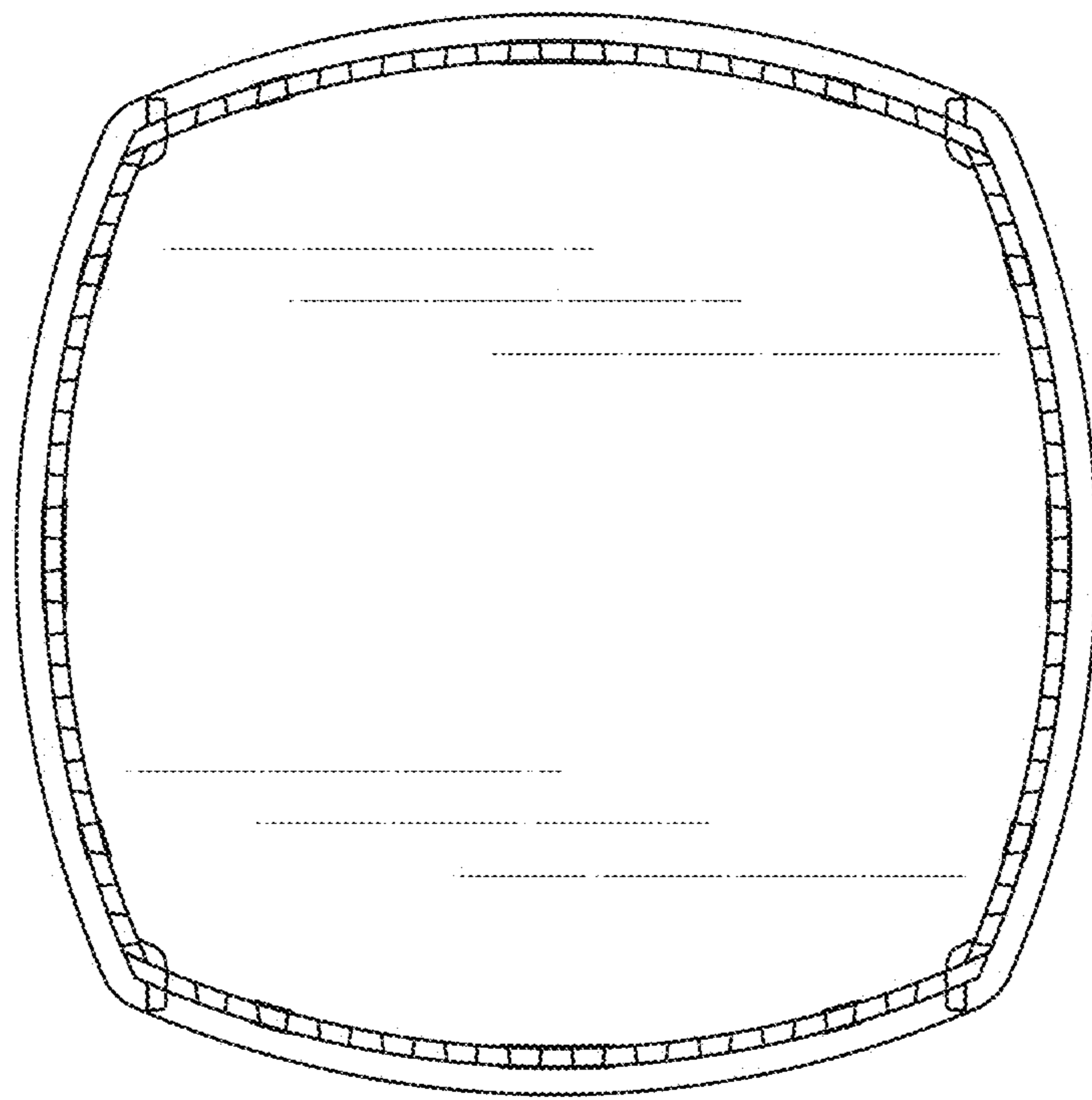

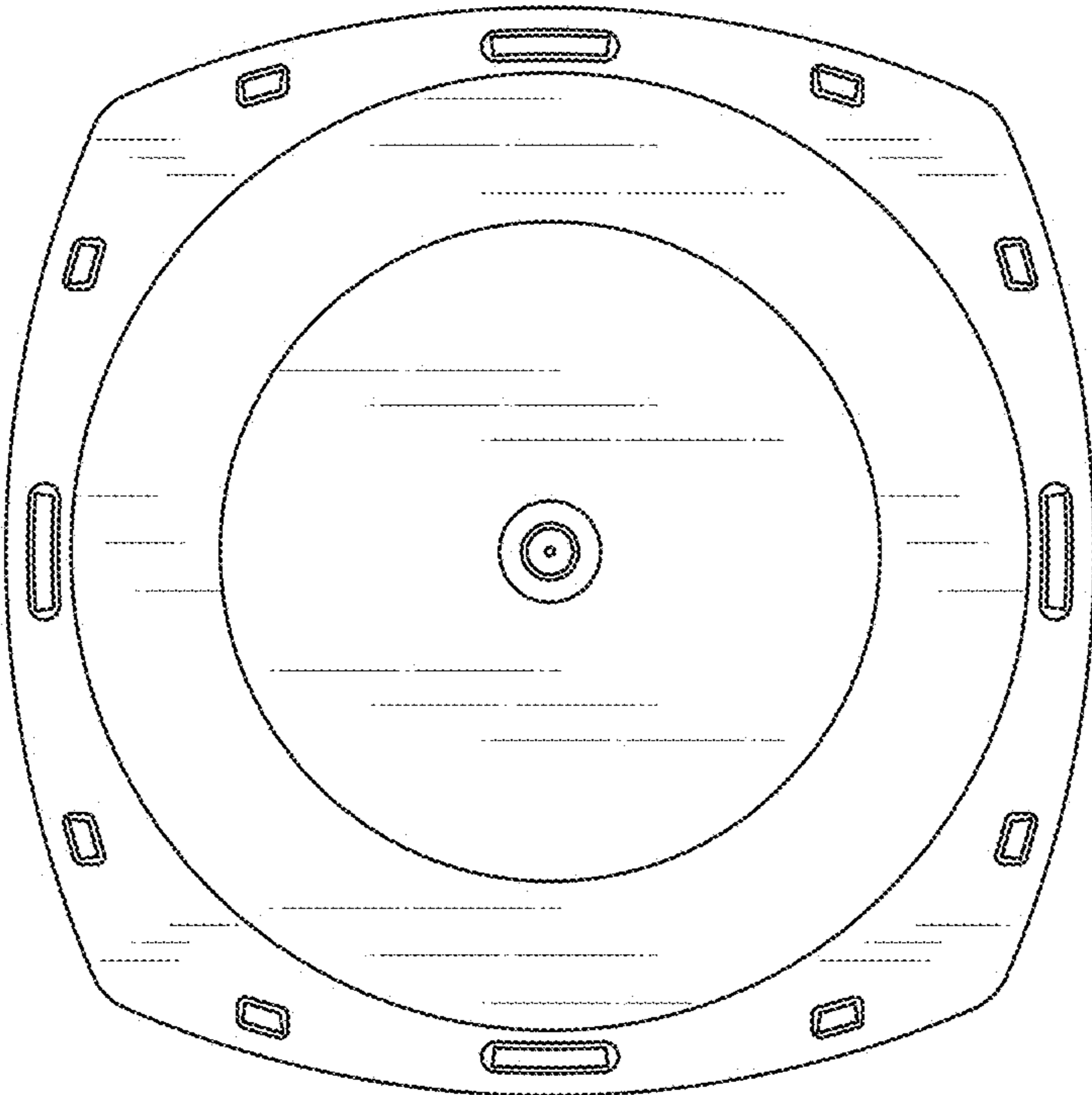
