FIG. 5 shows a side view thereof, the opposite side view being a mirror image thereof.

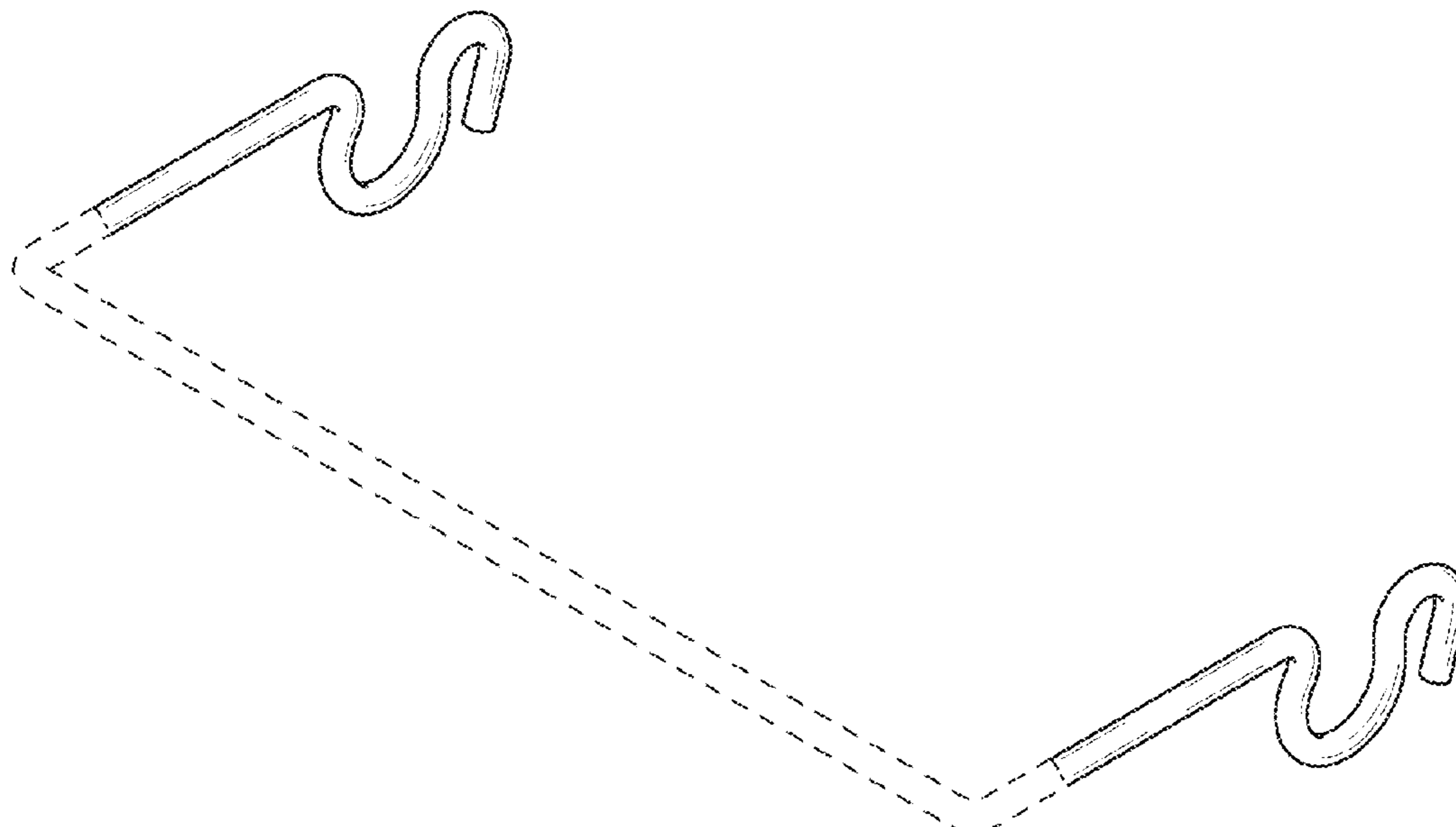
FIG. 6 shows a second side view thereof; and,

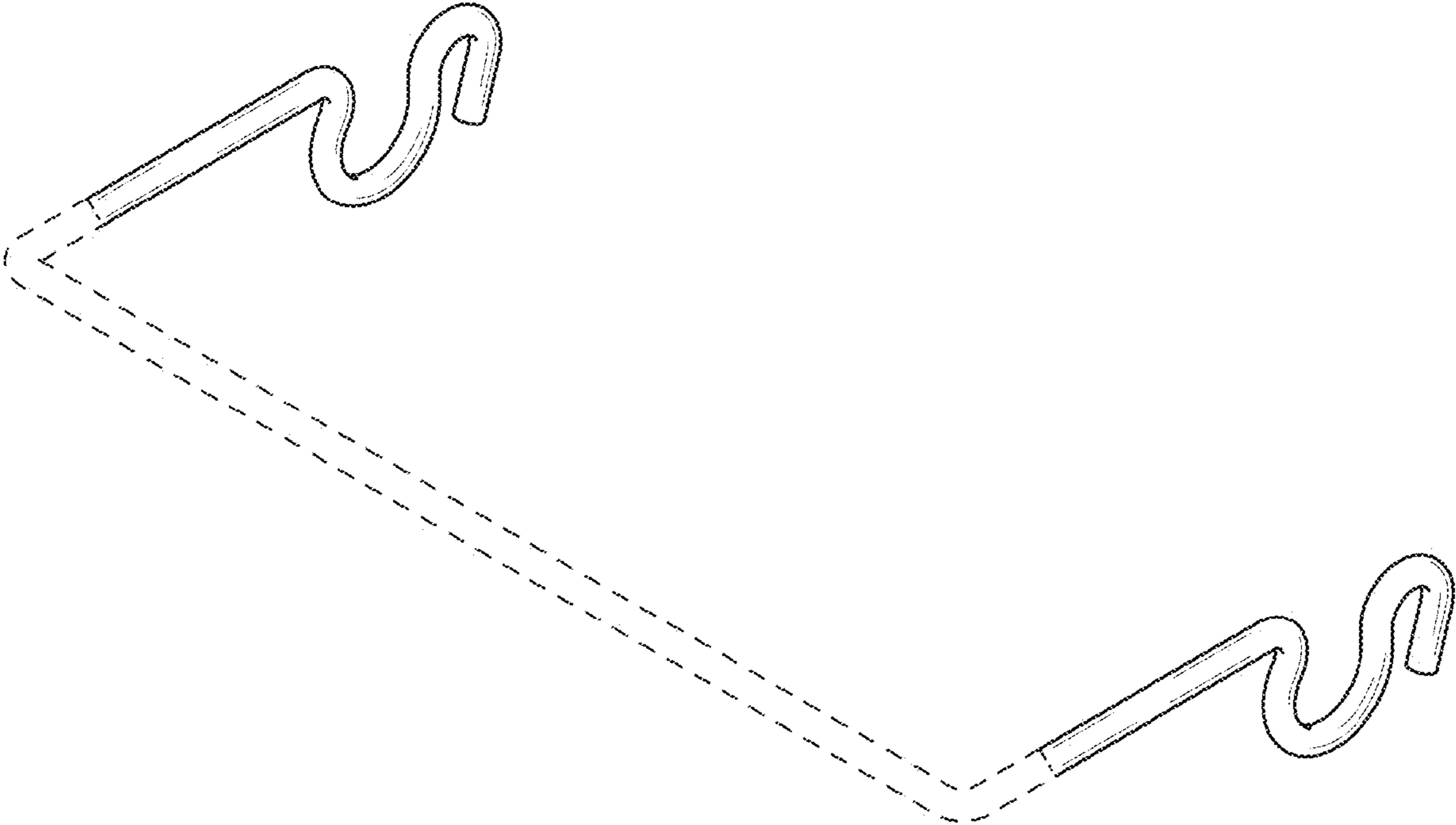

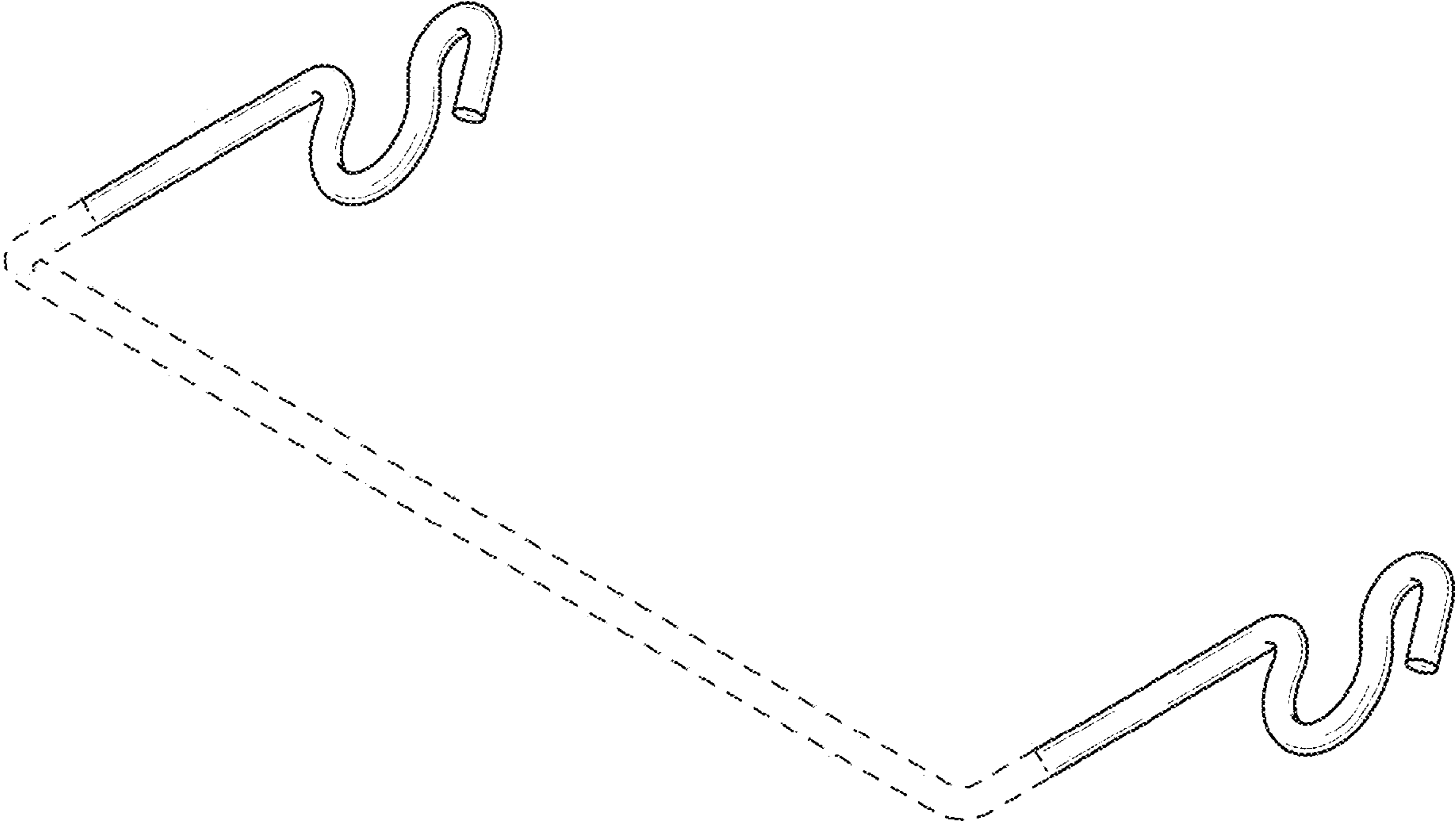

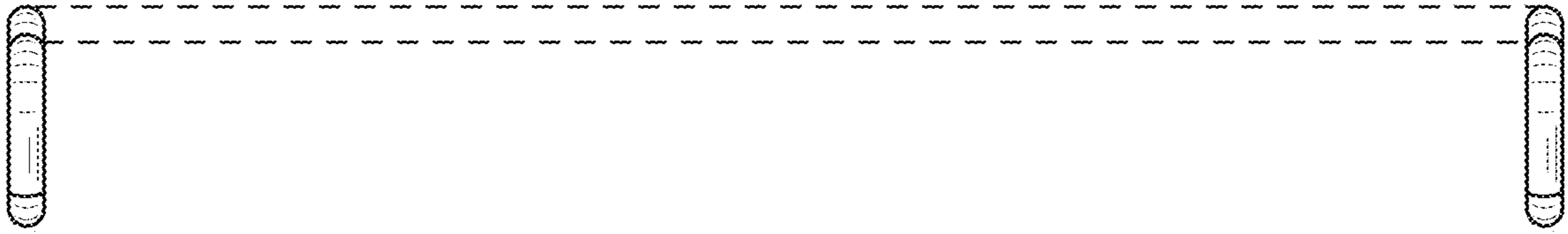

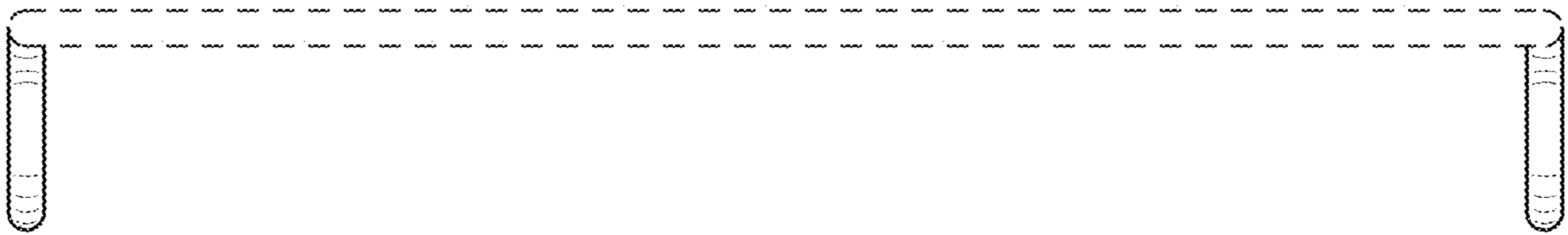

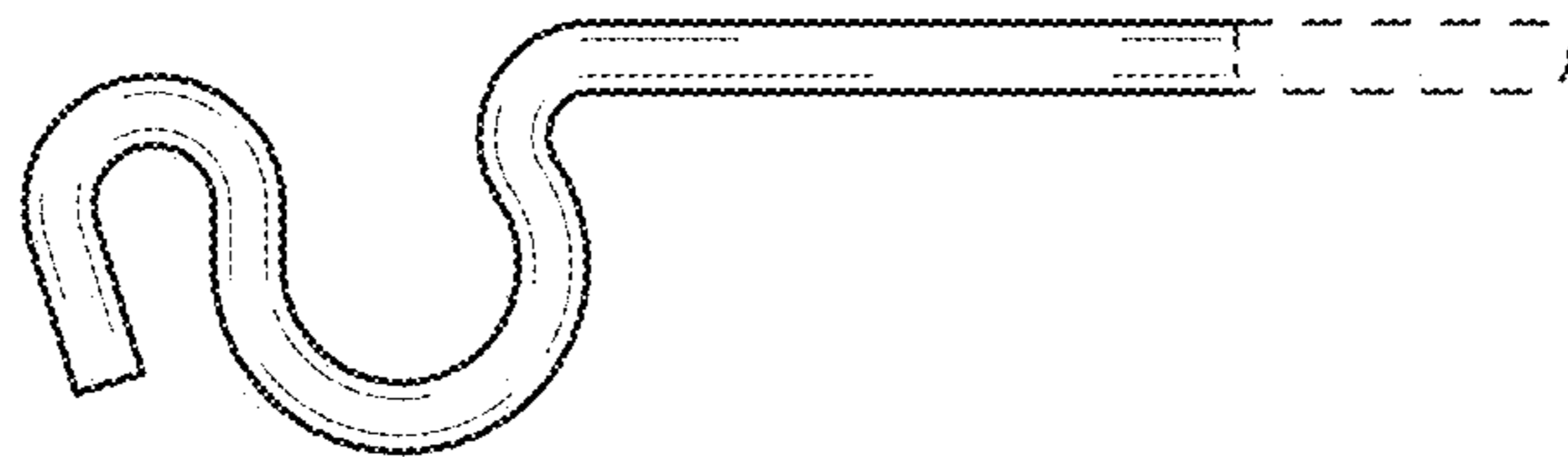

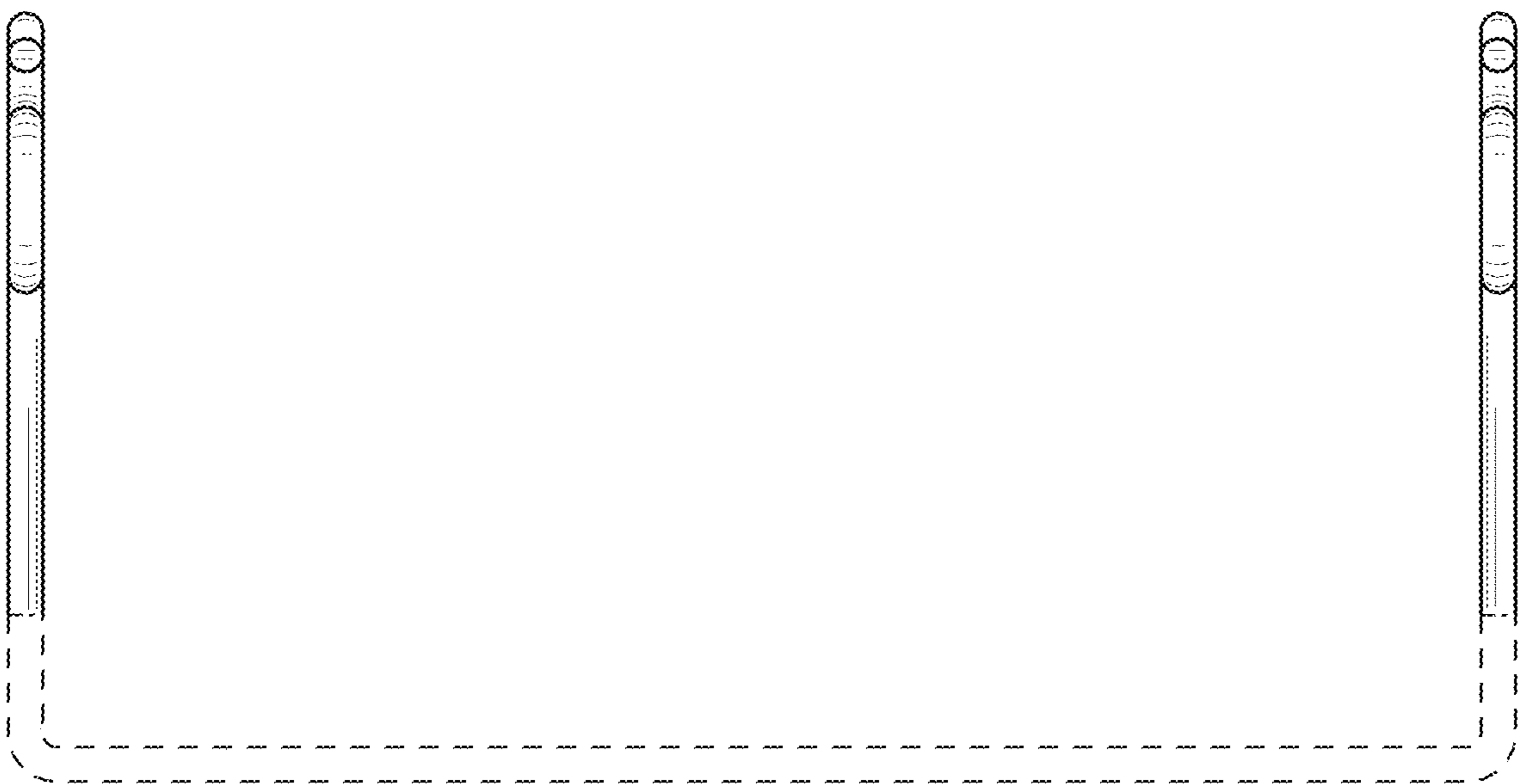
