The ornamental design for a sunscreen measuring cup, as shown and described.

**DESCRIPTION**

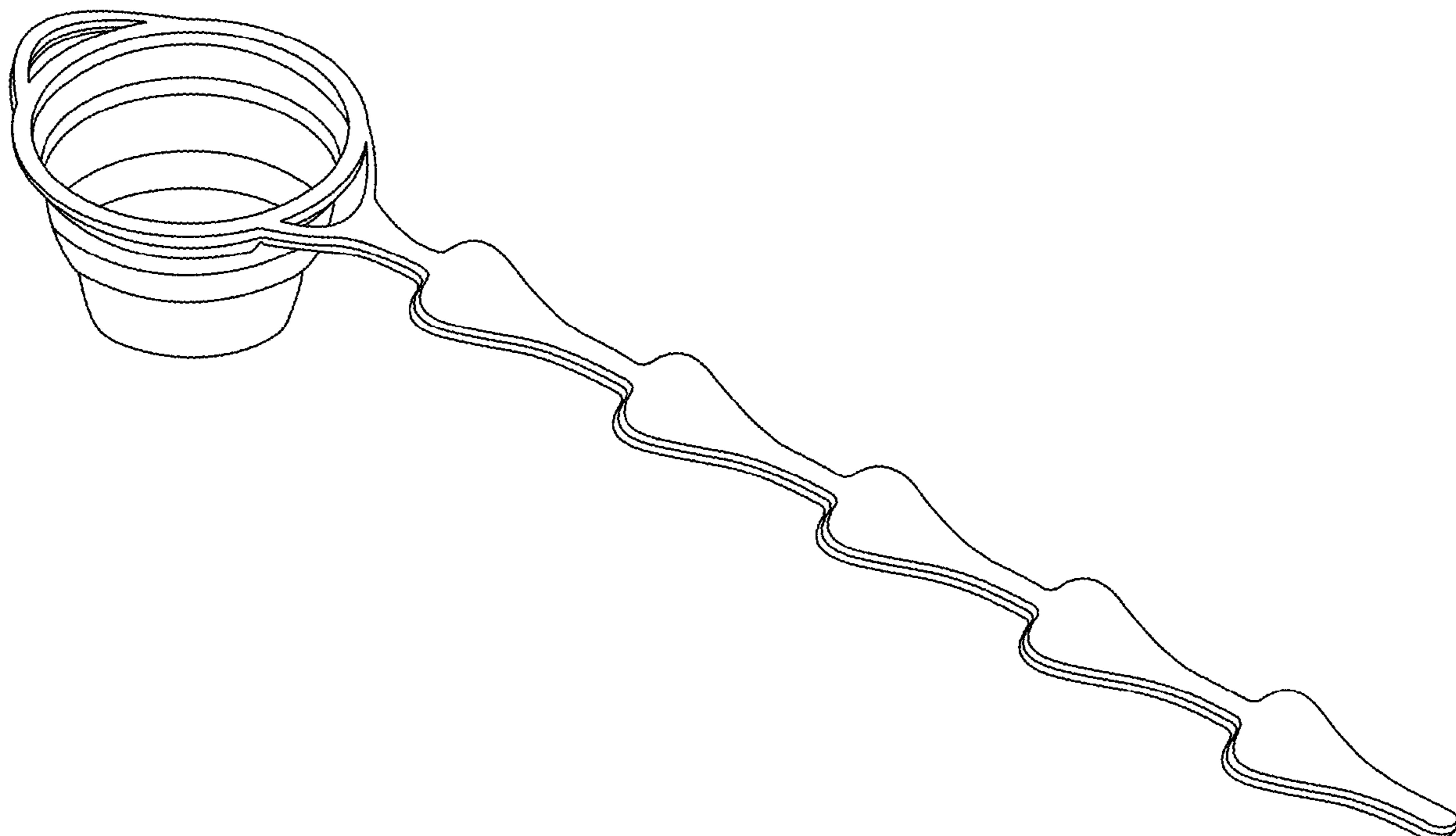

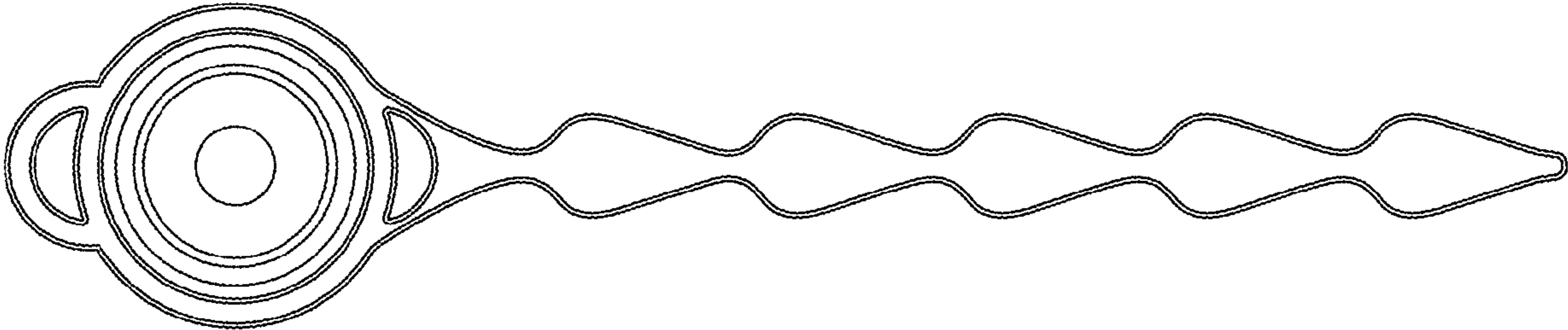

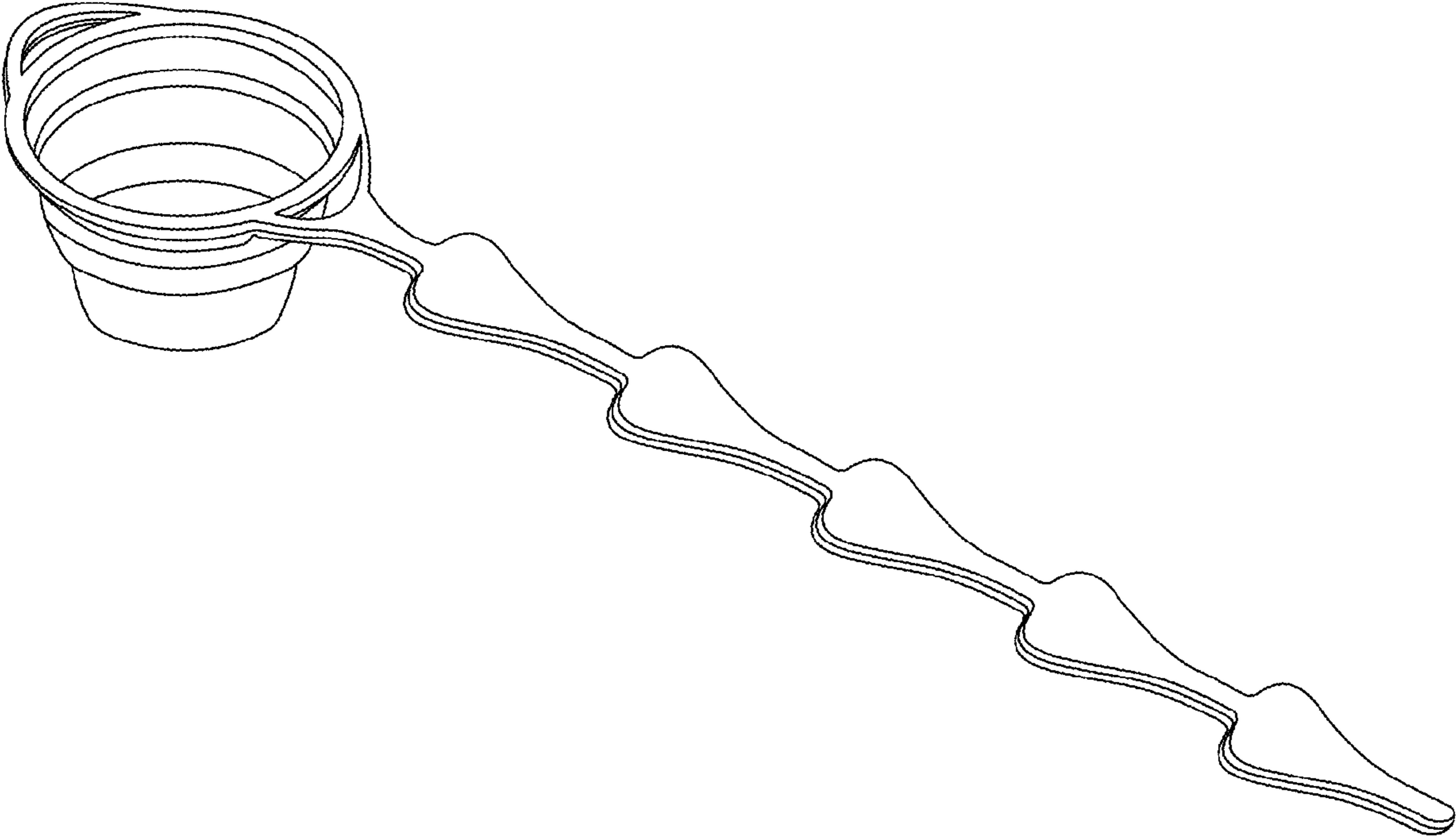

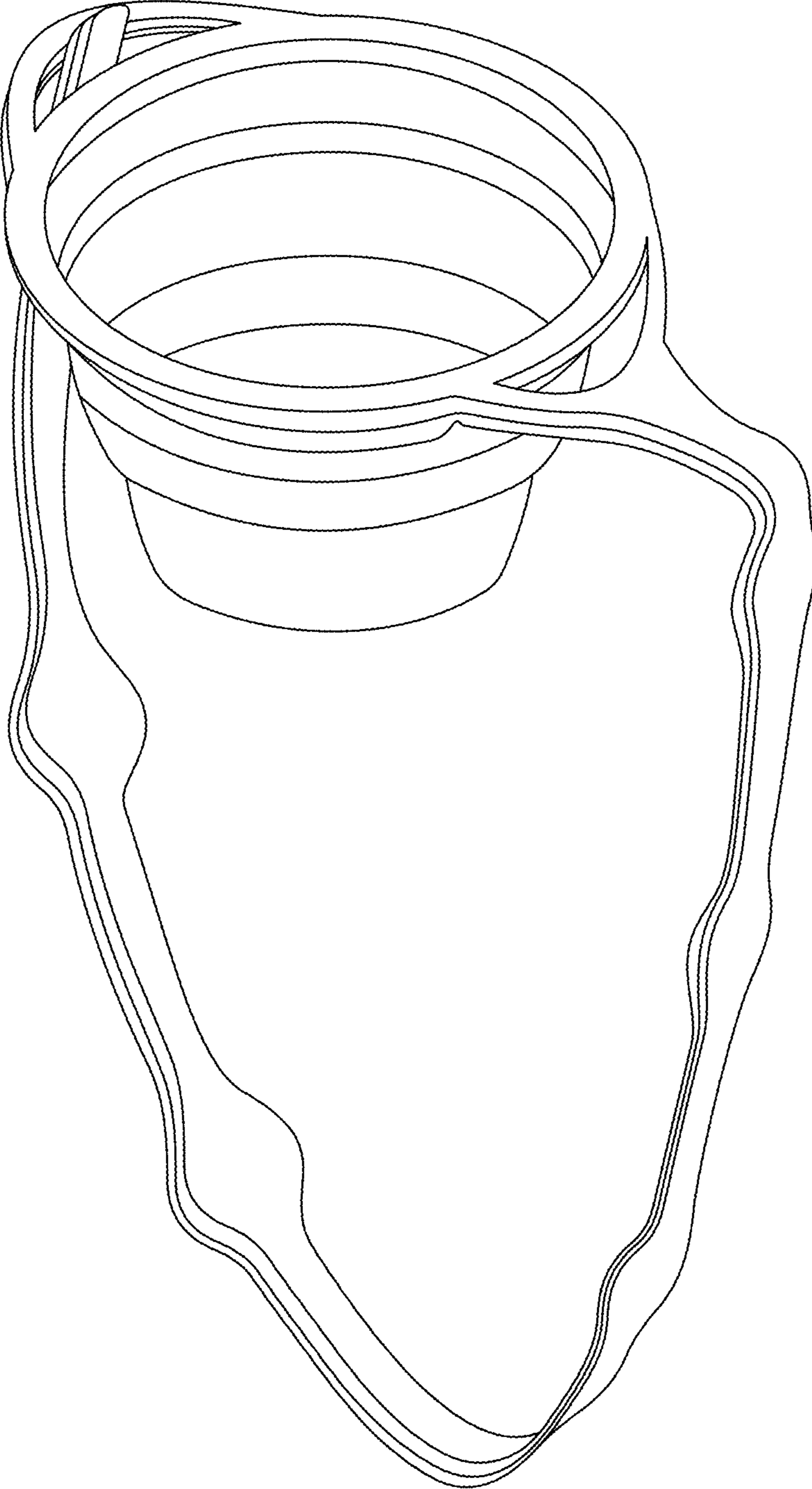

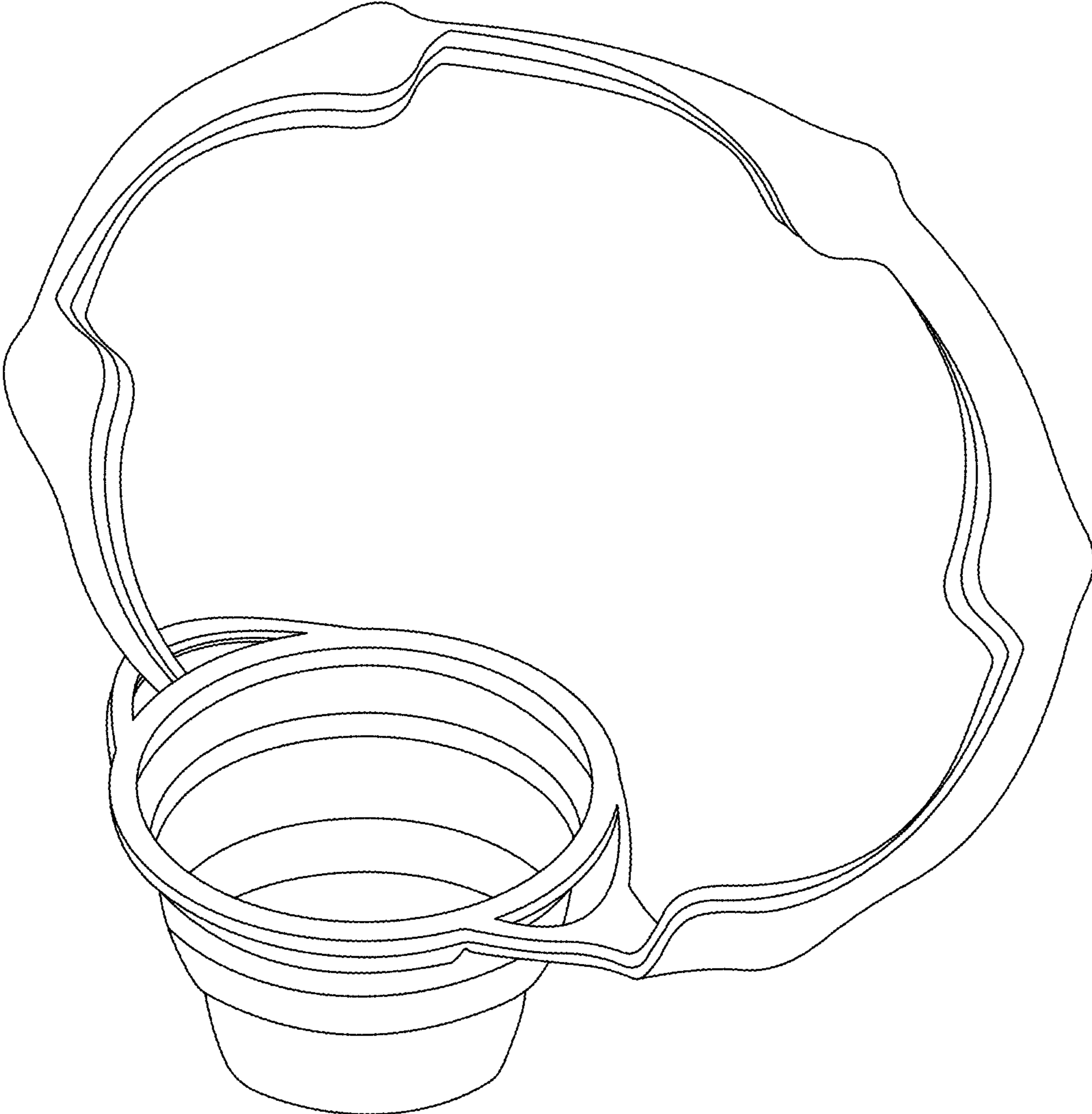

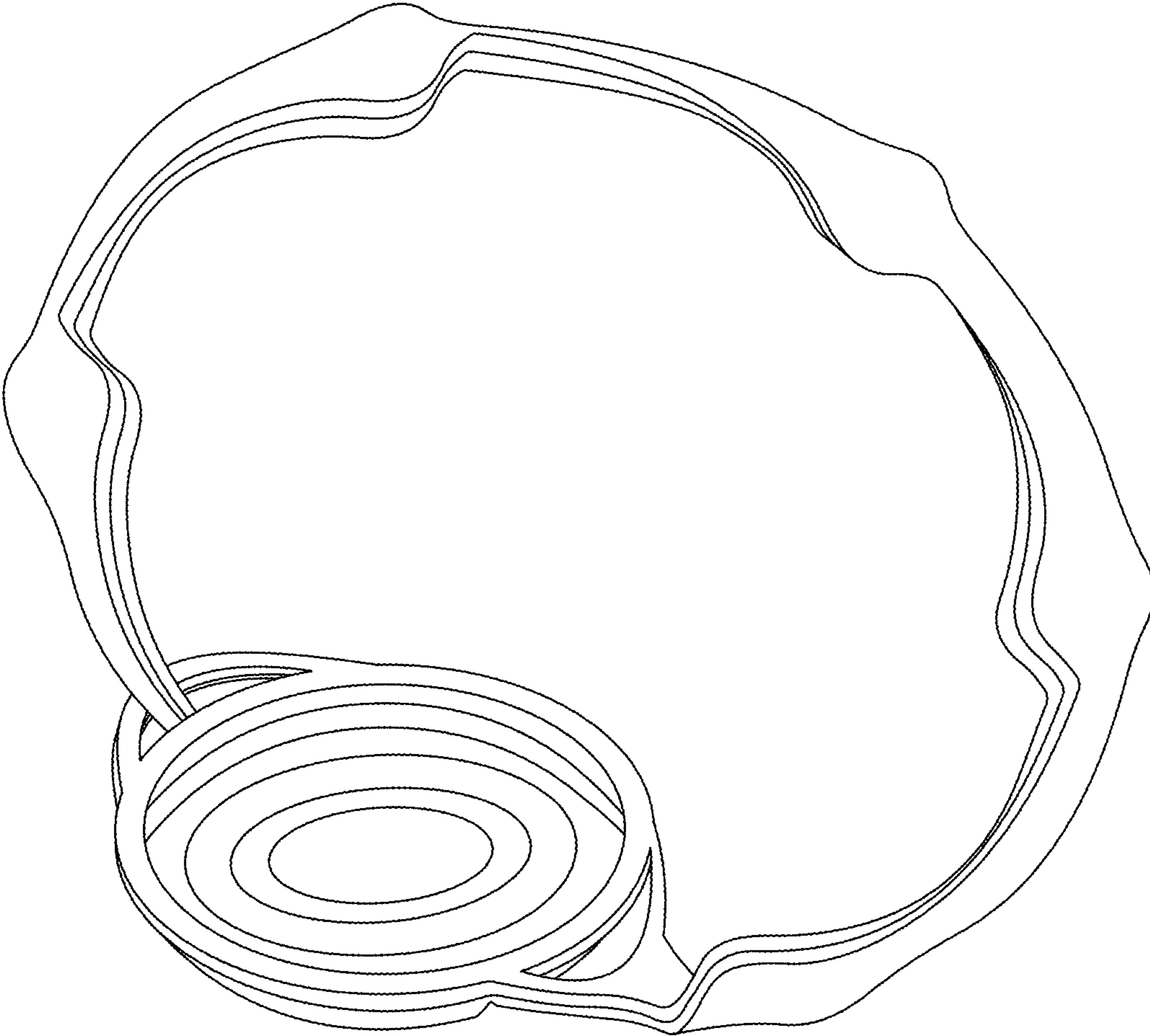
