(57) **CLAIM**

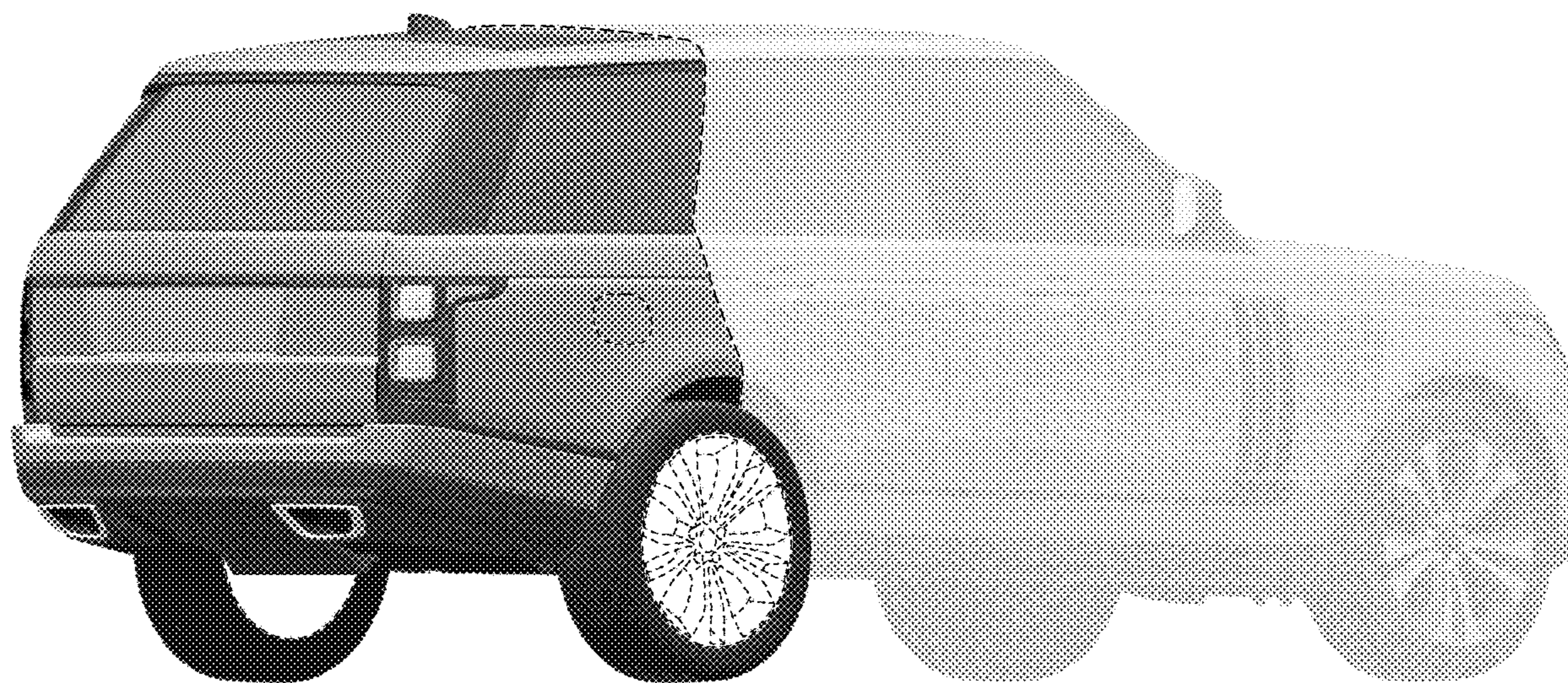
The ornamental design for a vehicle rear end, as shown and described.

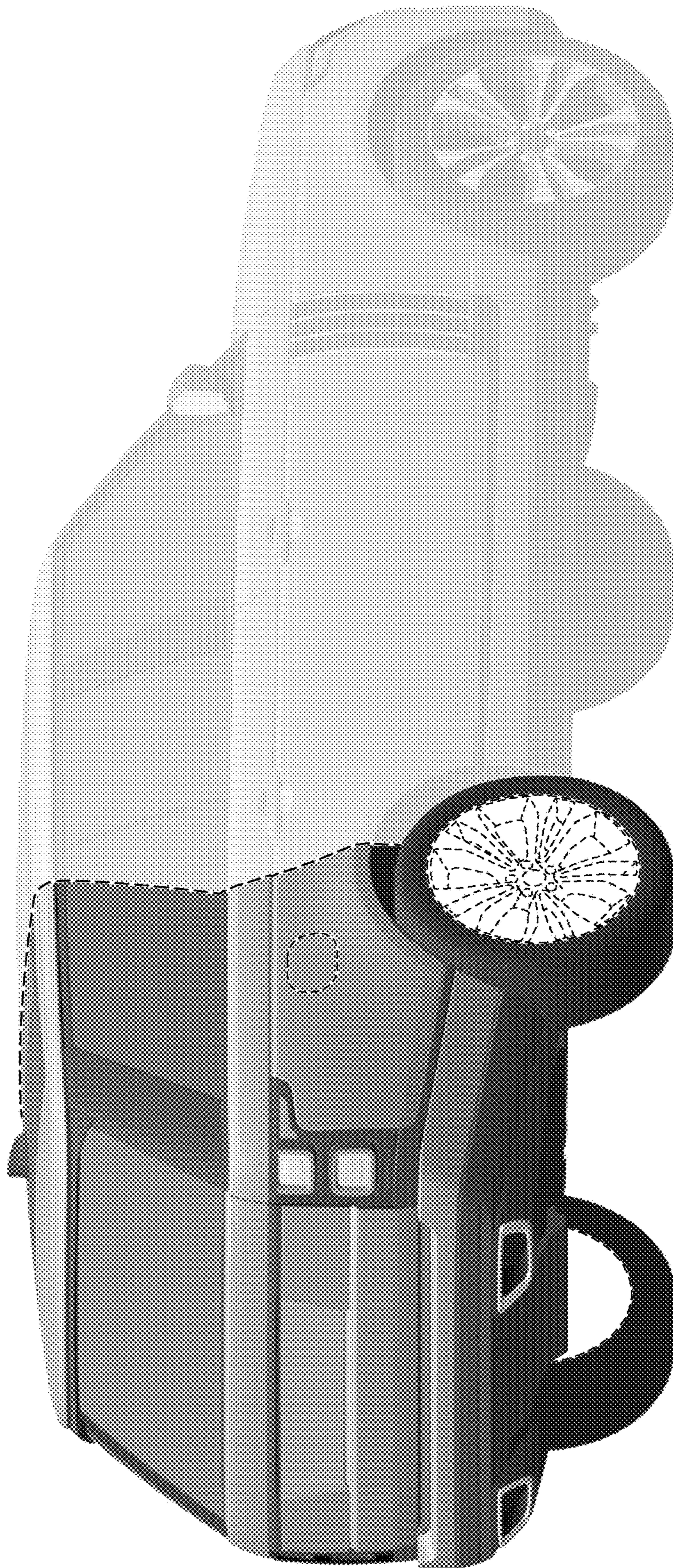

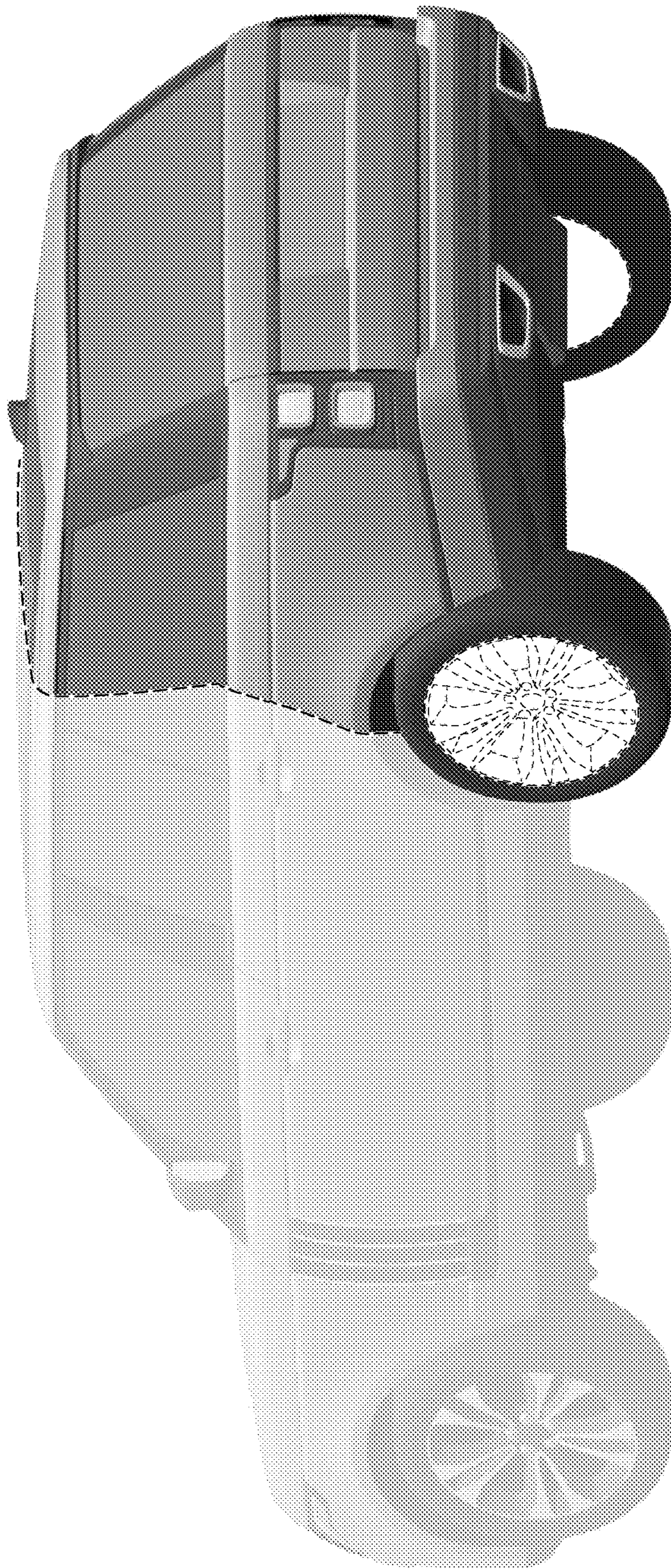

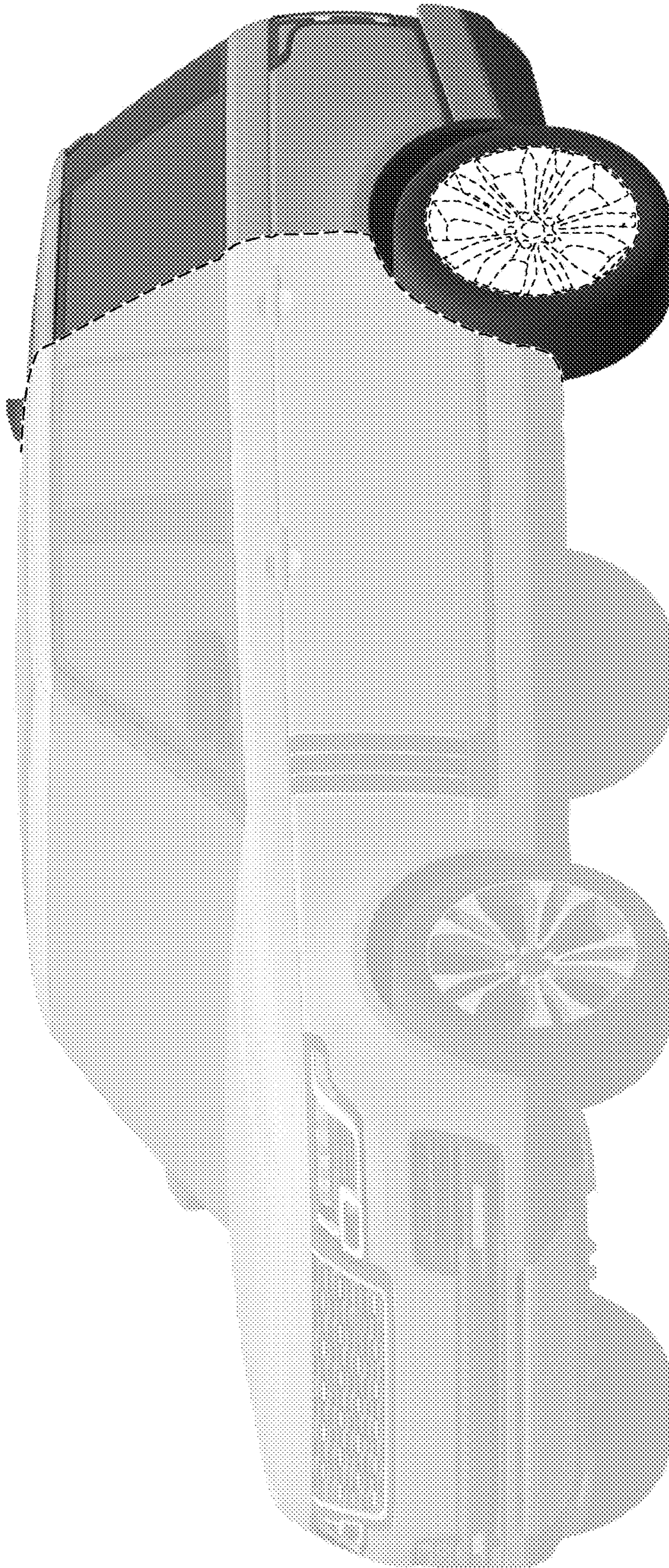

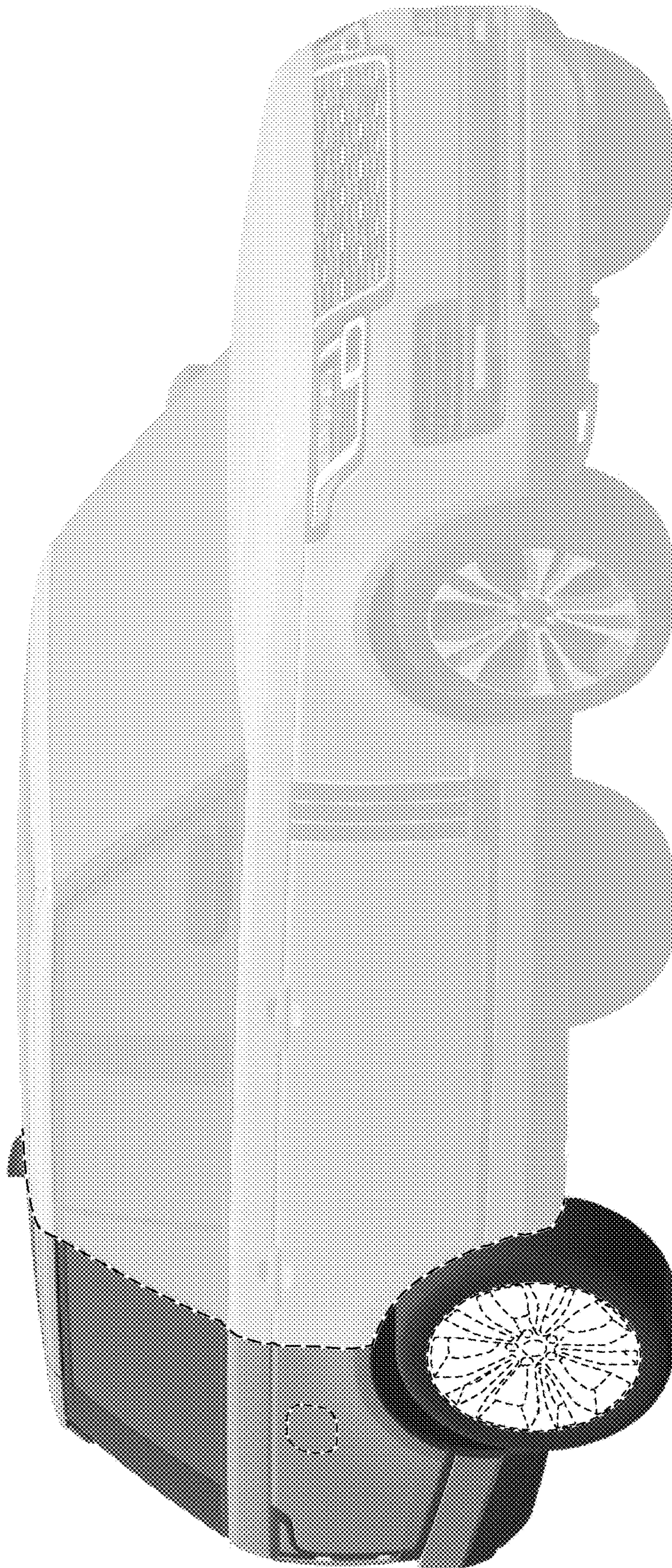

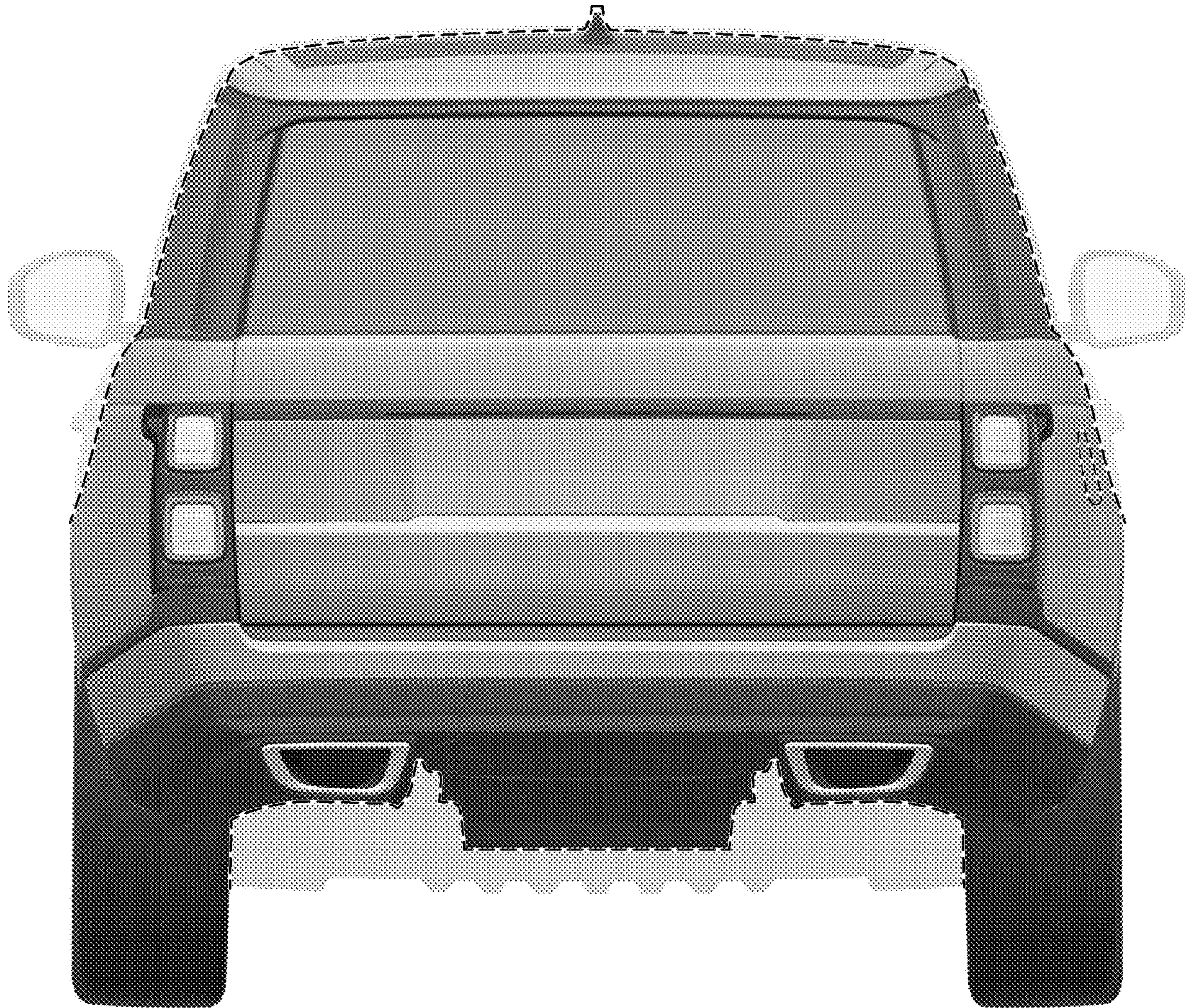

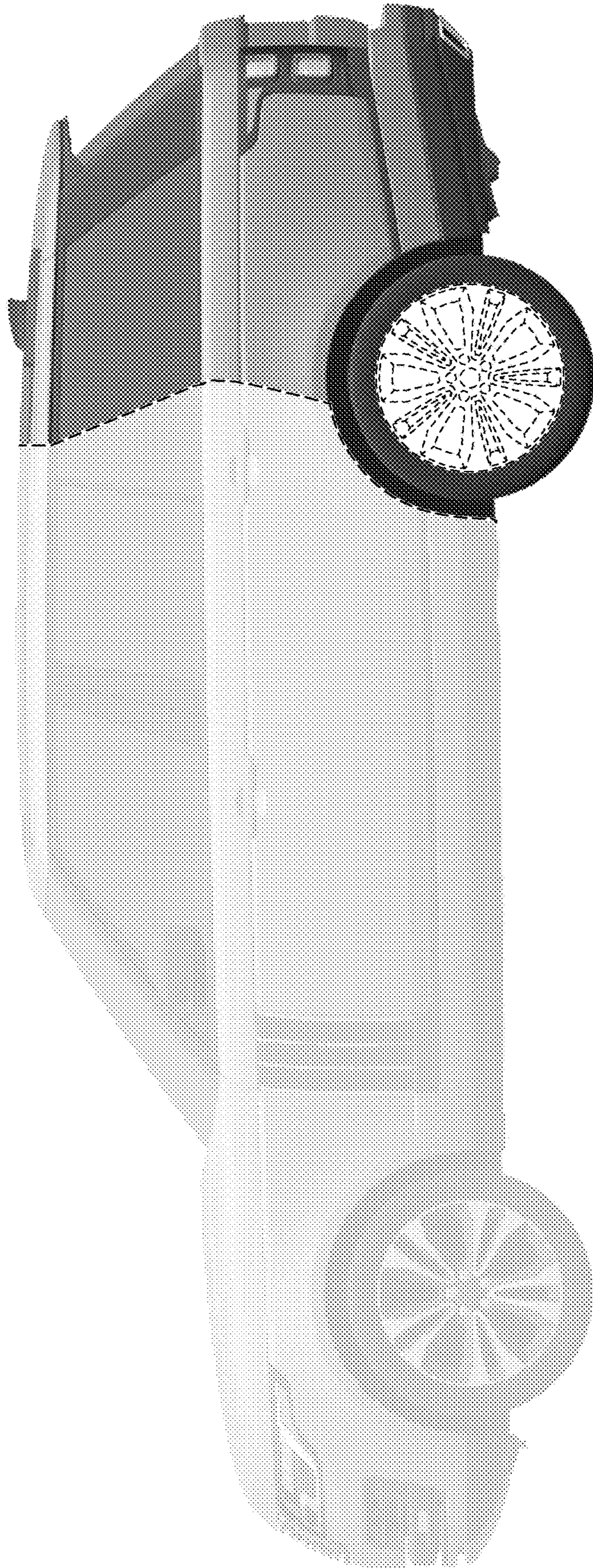
