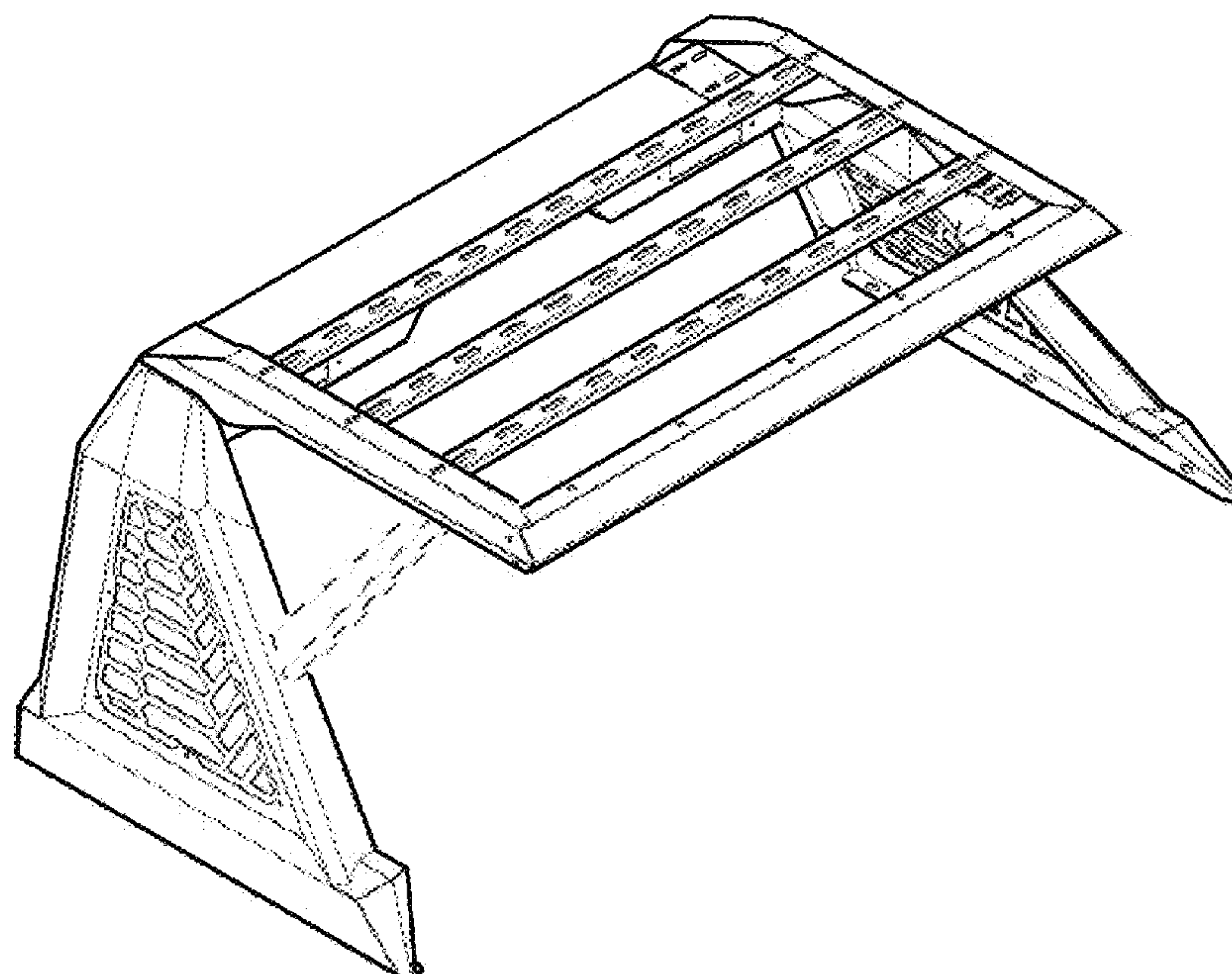
(57) **CLAIM**

The ornamental design for a two-directional chase rack for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a two-directional chase rack for a vehicle in a first position;  
 FIG. 2 is a top perspective view in a second position thereof;  
 FIG. 3 is a top plan view in the first position thereof;  
 FIG. 4 is a top plan view in the second position thereof;  
 FIG. 5 is a rear elevation view in the second position thereof;  
 FIG. 6 is a front elevation view in the first position thereof;  
 FIG. 7 is a right-side elevation in the first position view, the left side elevation view being a mirror image thereof;  
 FIG. 8 is a right-side elevation in the second position view, the left side elevation view being a mirror image thereof;  
 FIG. 9 is a left sectional view in the second position taken along lines 9-9 from FIG. 6 thereof;  
 FIG. 10 is a bottom view in the first position thereof;  
 FIG. 11 is a bottom view in the second position thereof;  
 FIG. 12 is a bottom perspective view in the first position thereof;  
 FIG. 13 is a bottom perspective view in the second position thereof;  
 FIG. 14 is a top perspective view in a first position in an environment of use thereof; and,  
 FIG. 15 is a top perspective view in a second position in an environment of use thereof.  
 The broken lines in FIG. 1, FIG. 3, FIG. 6, FIG. 7, FIG. 9, FIG. 10, FIG. 12, FIG. 14 and FIG. 15 depict environmental subject matter and form no part of the claimed design.

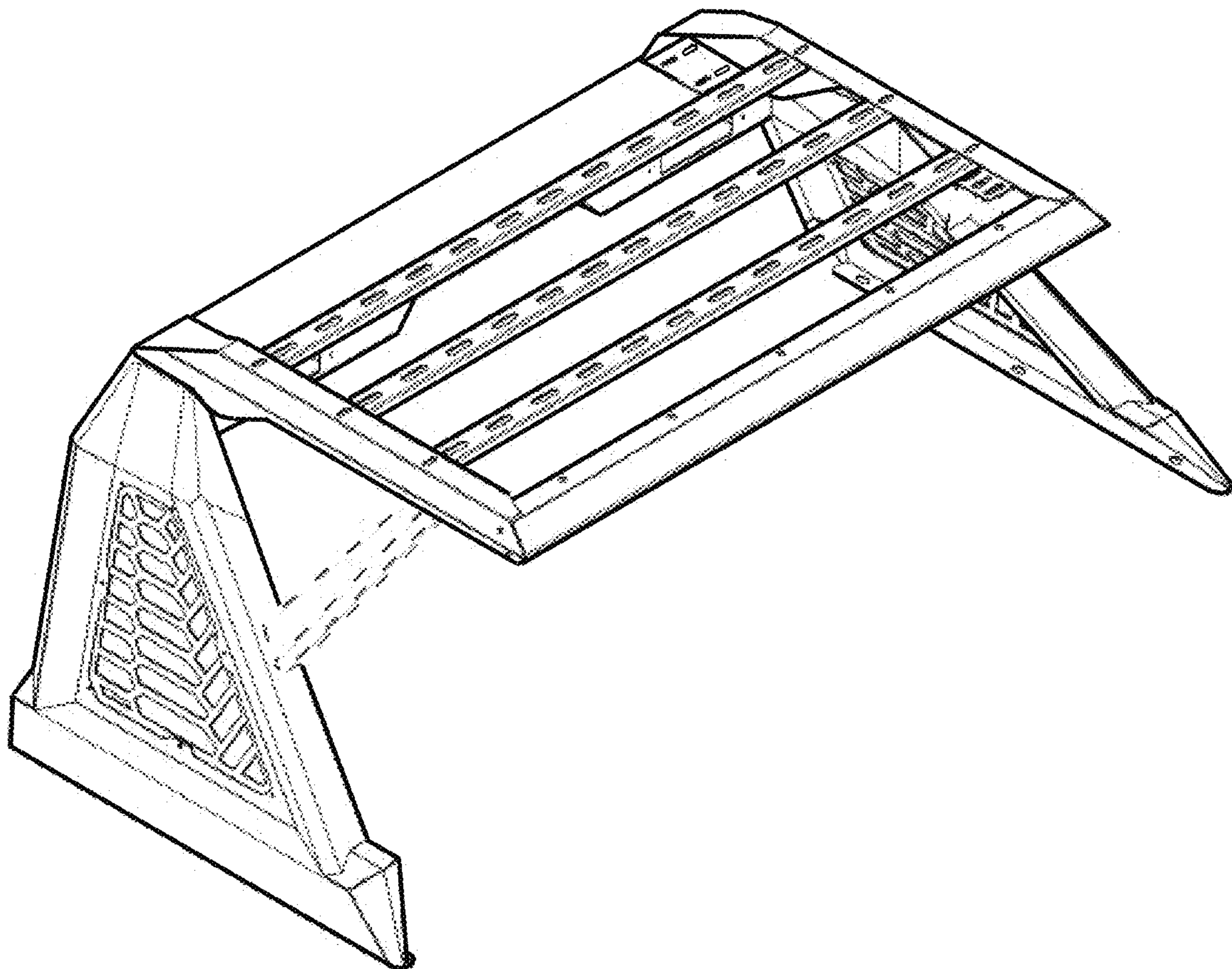

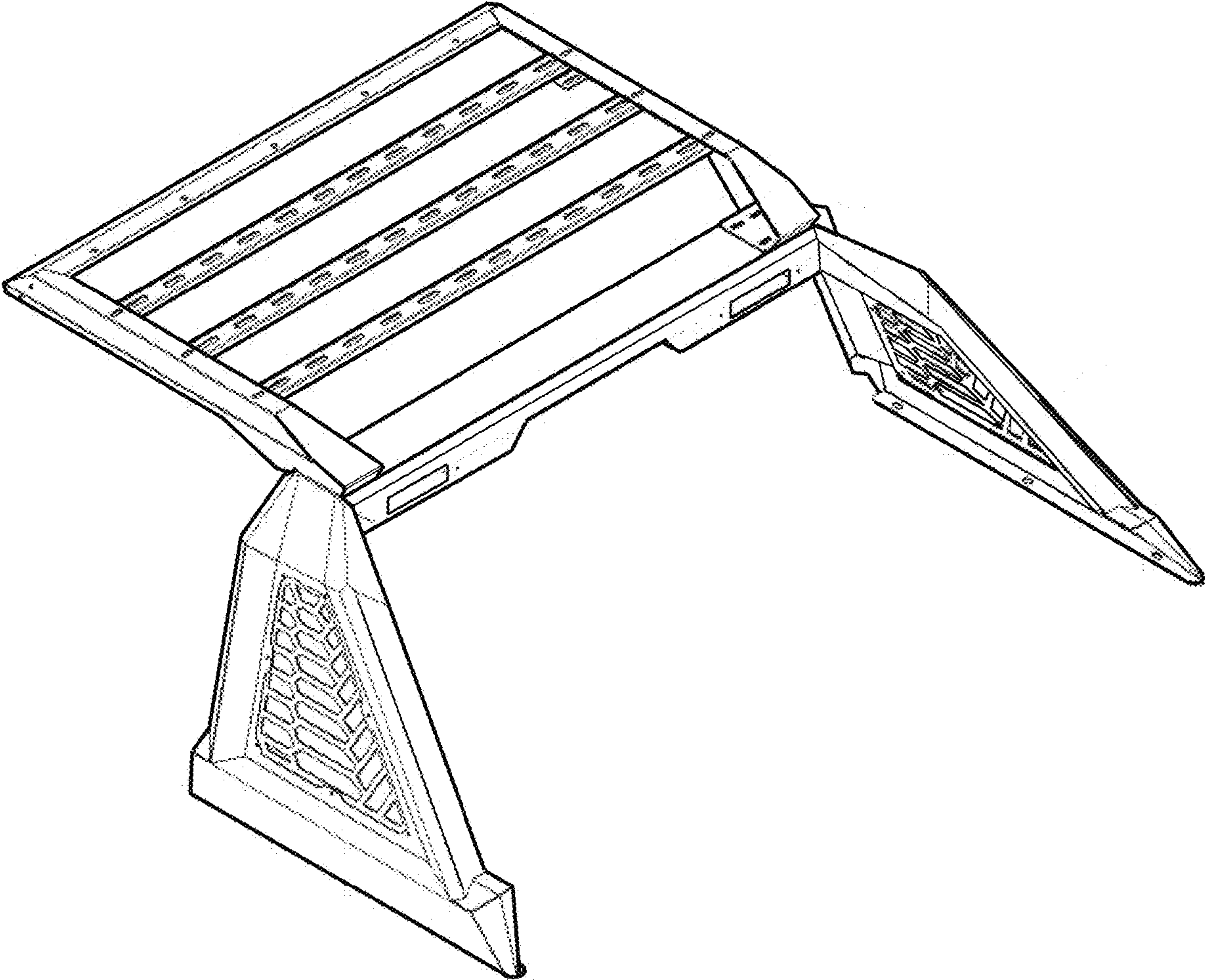

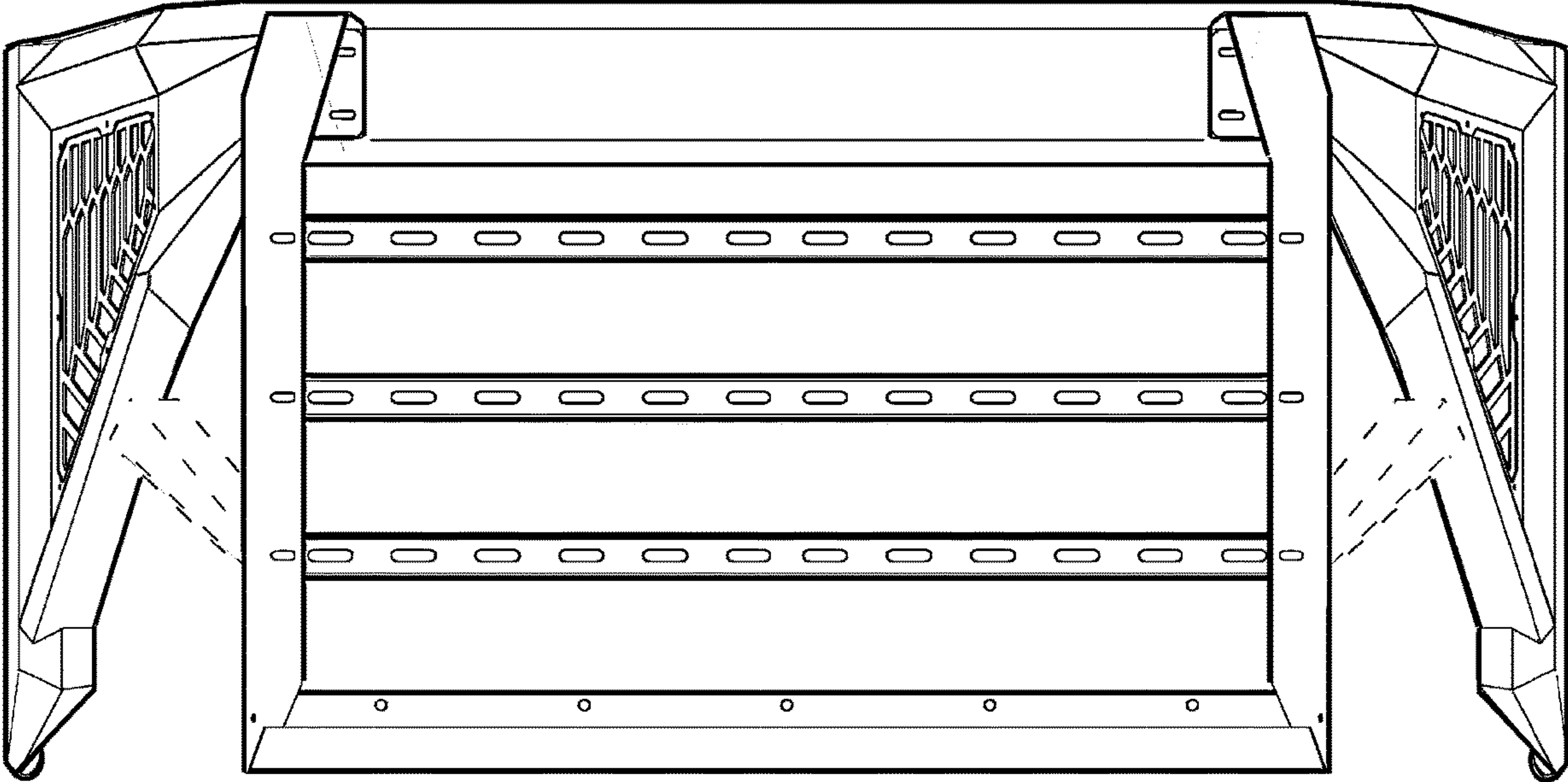

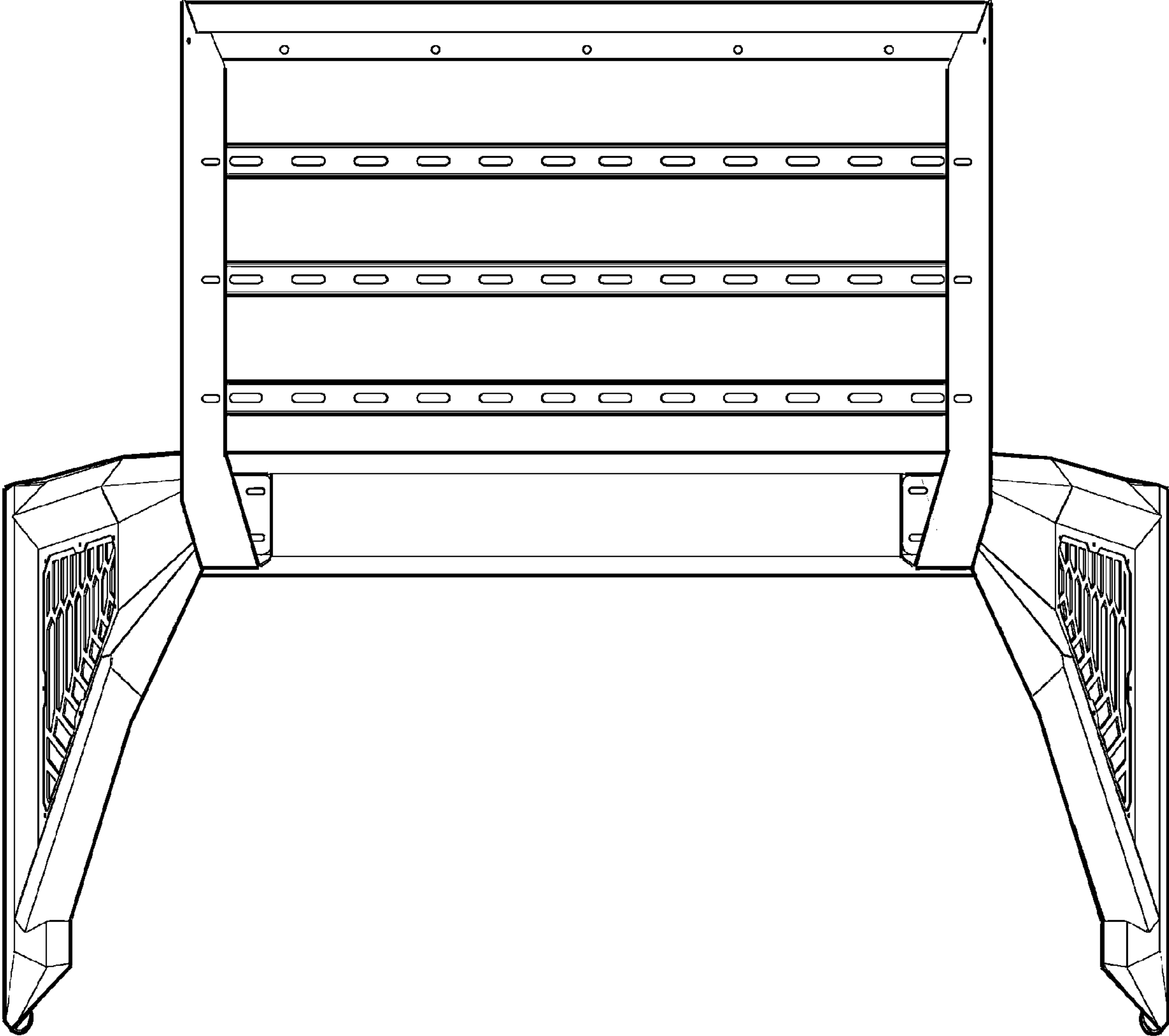
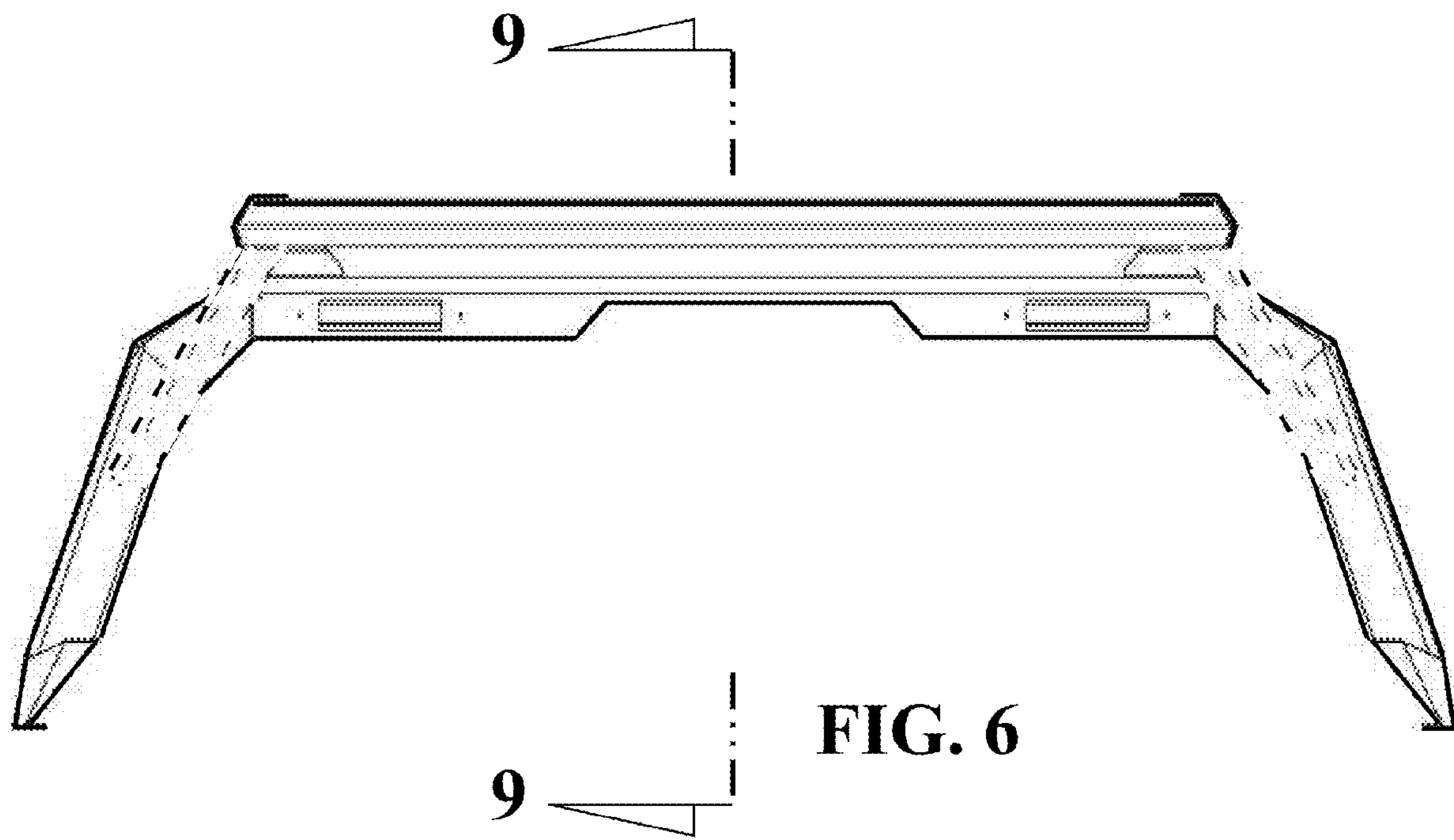
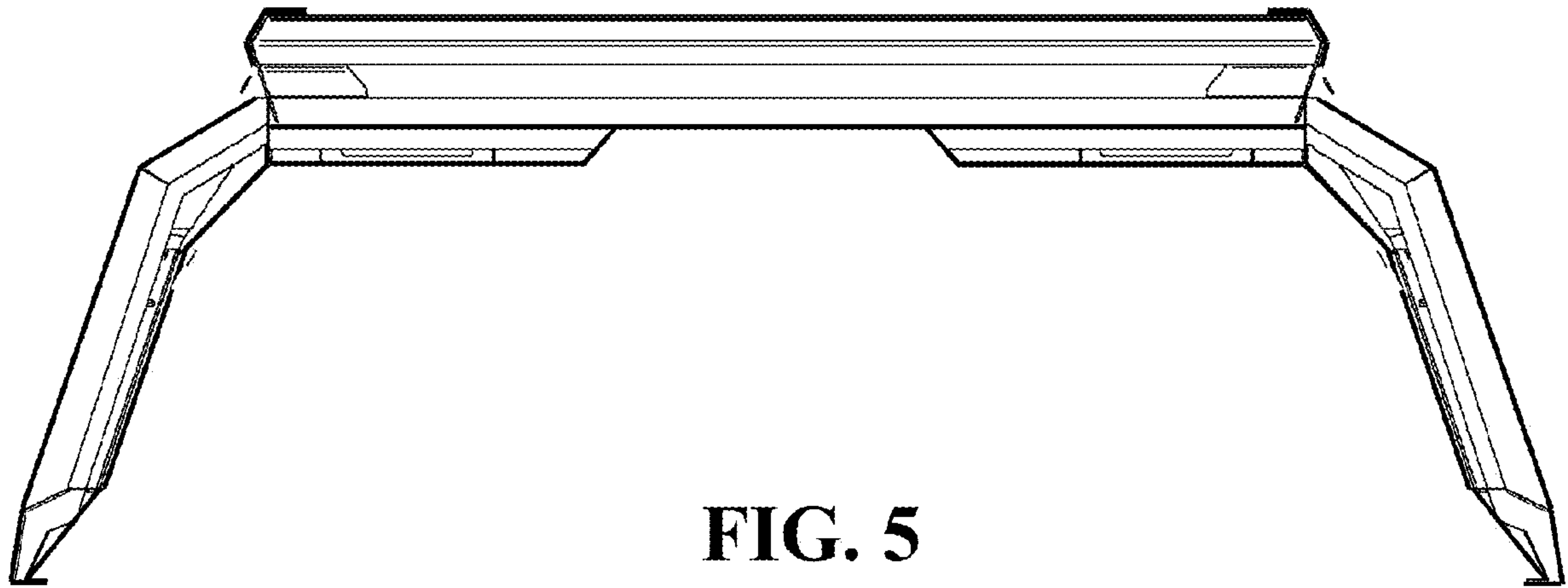
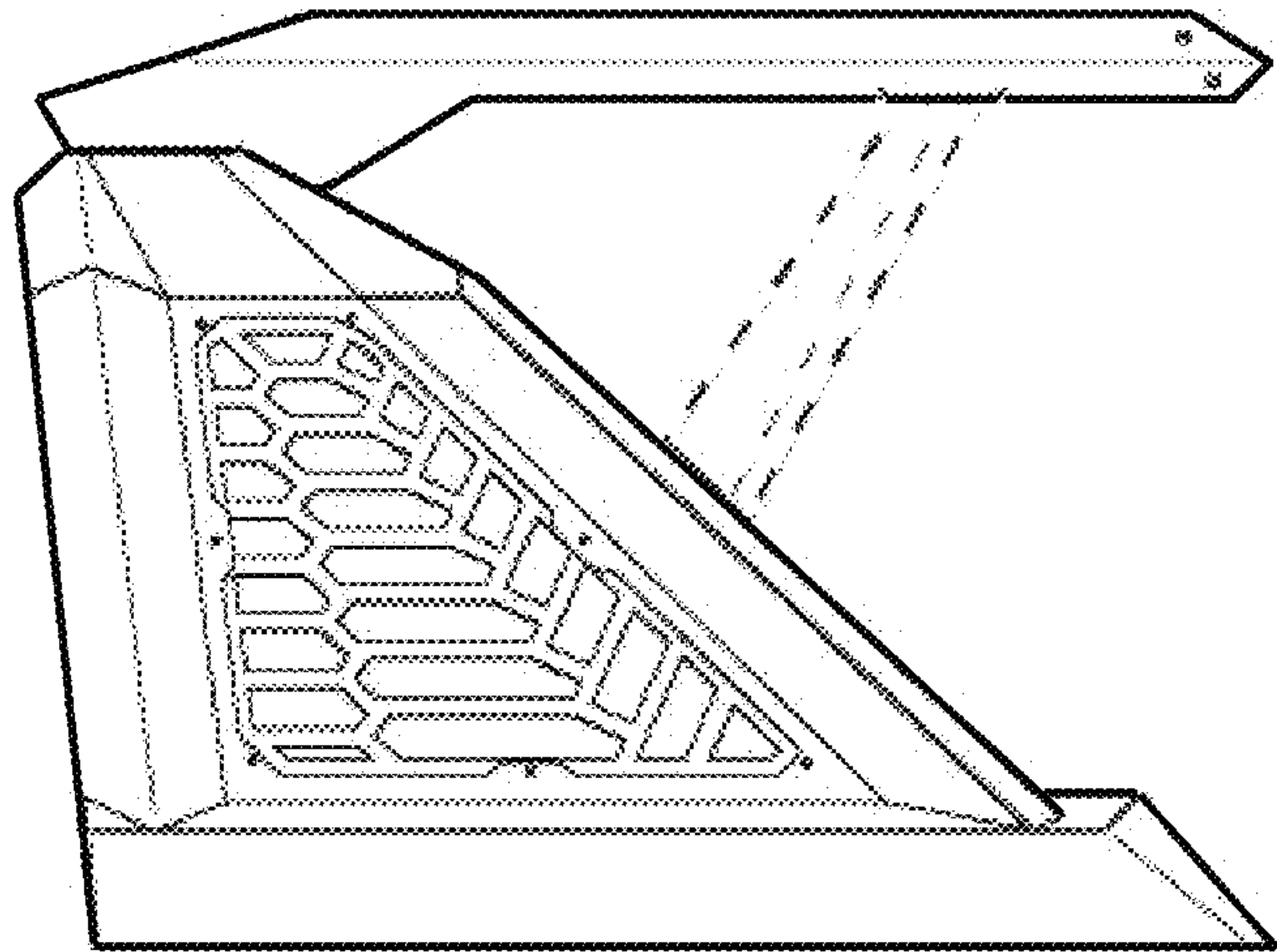
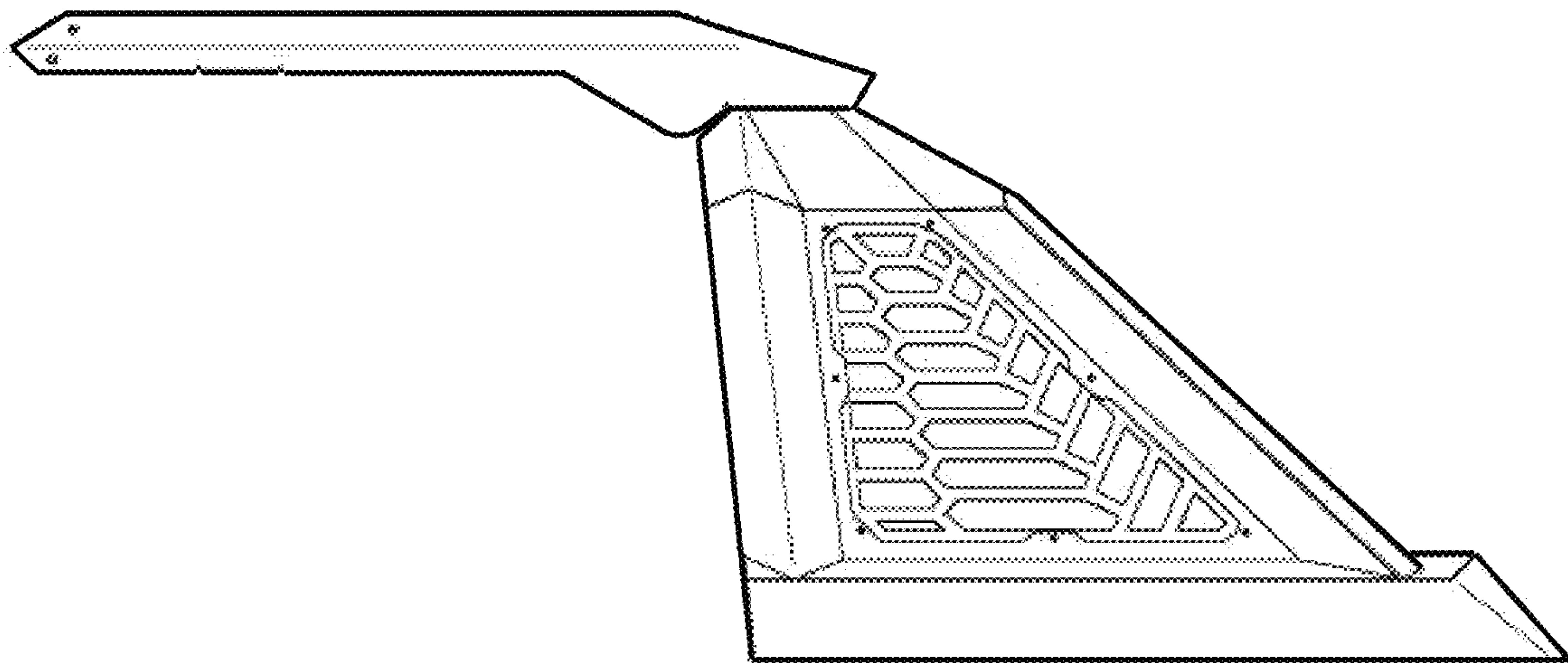

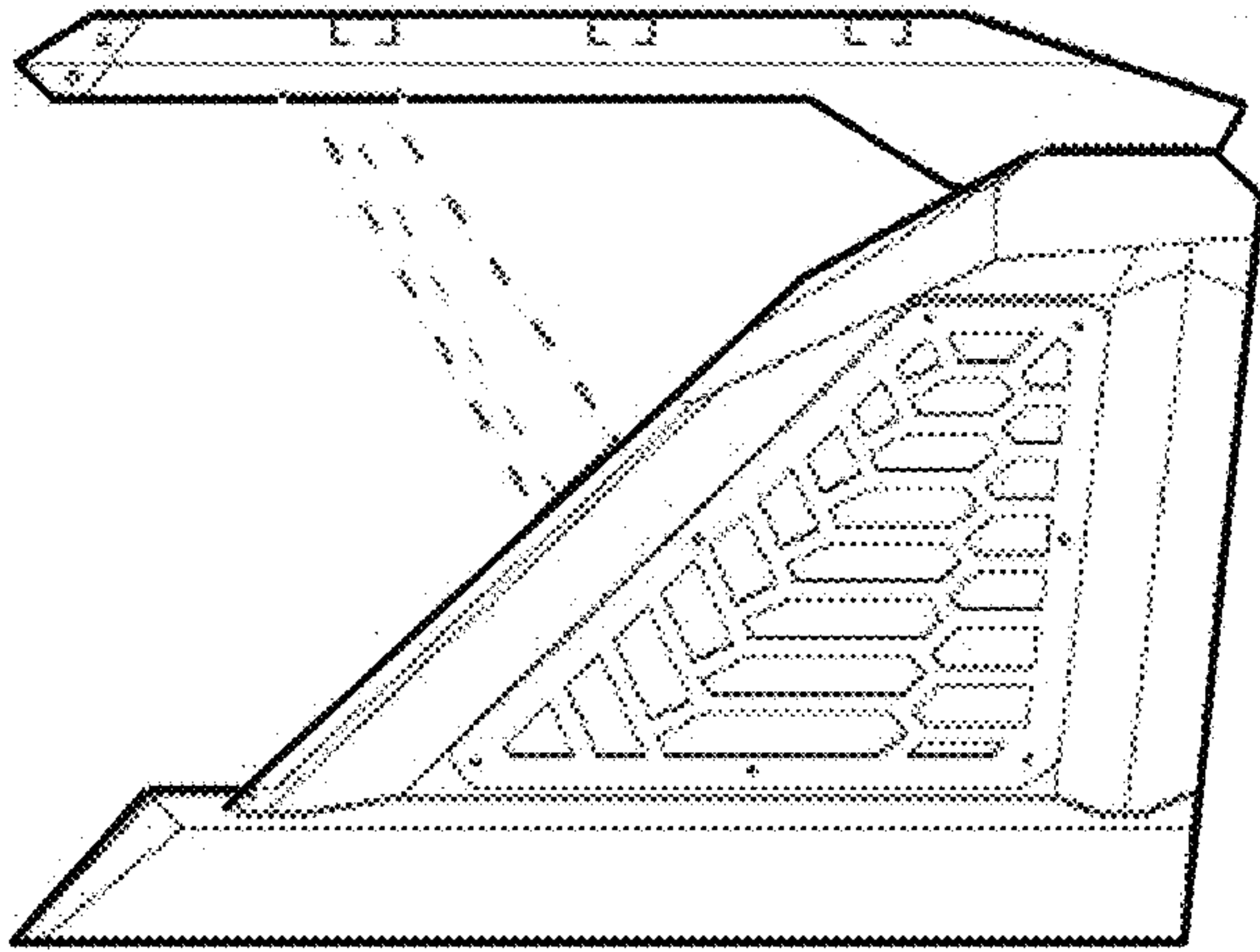

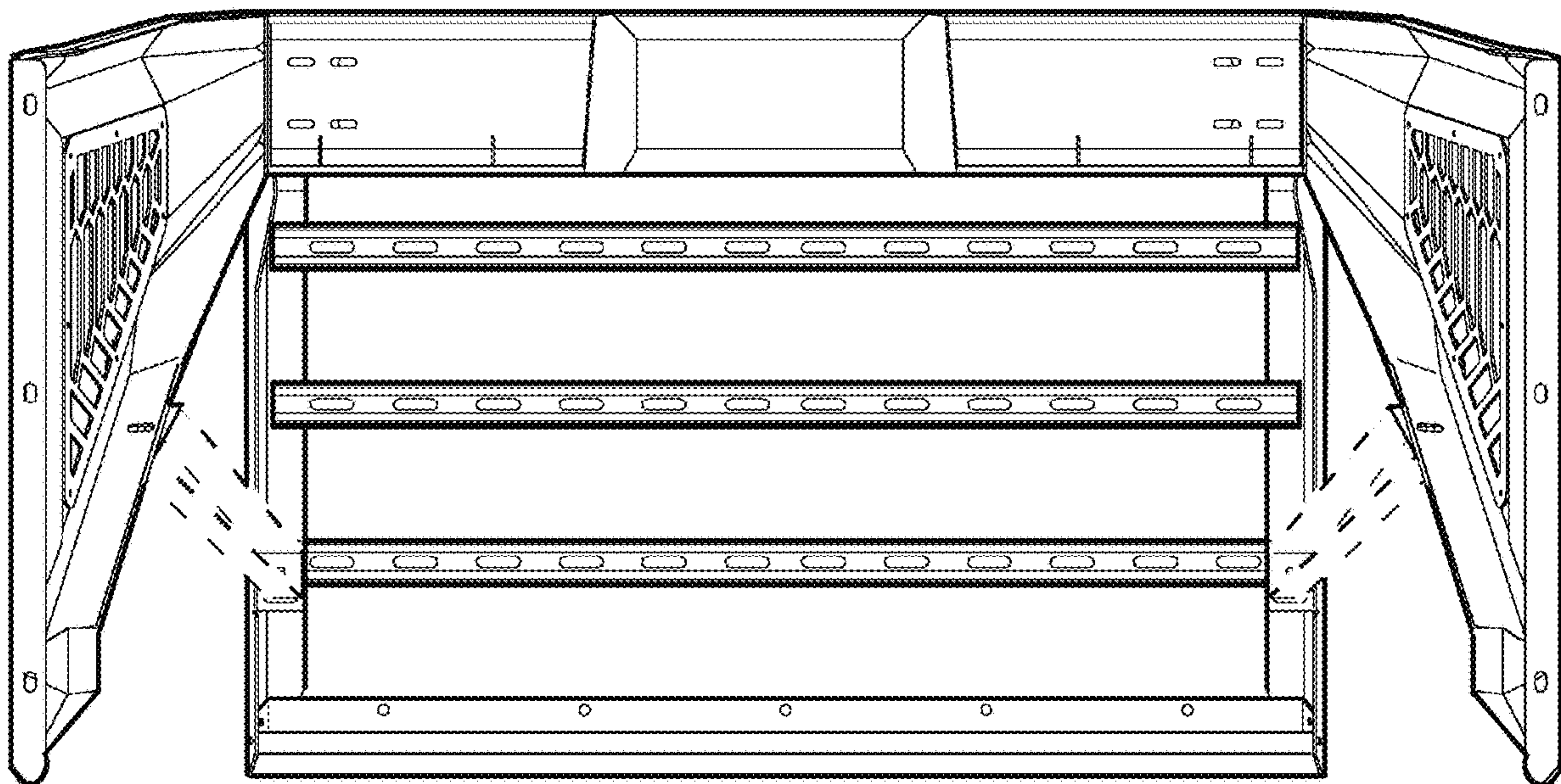

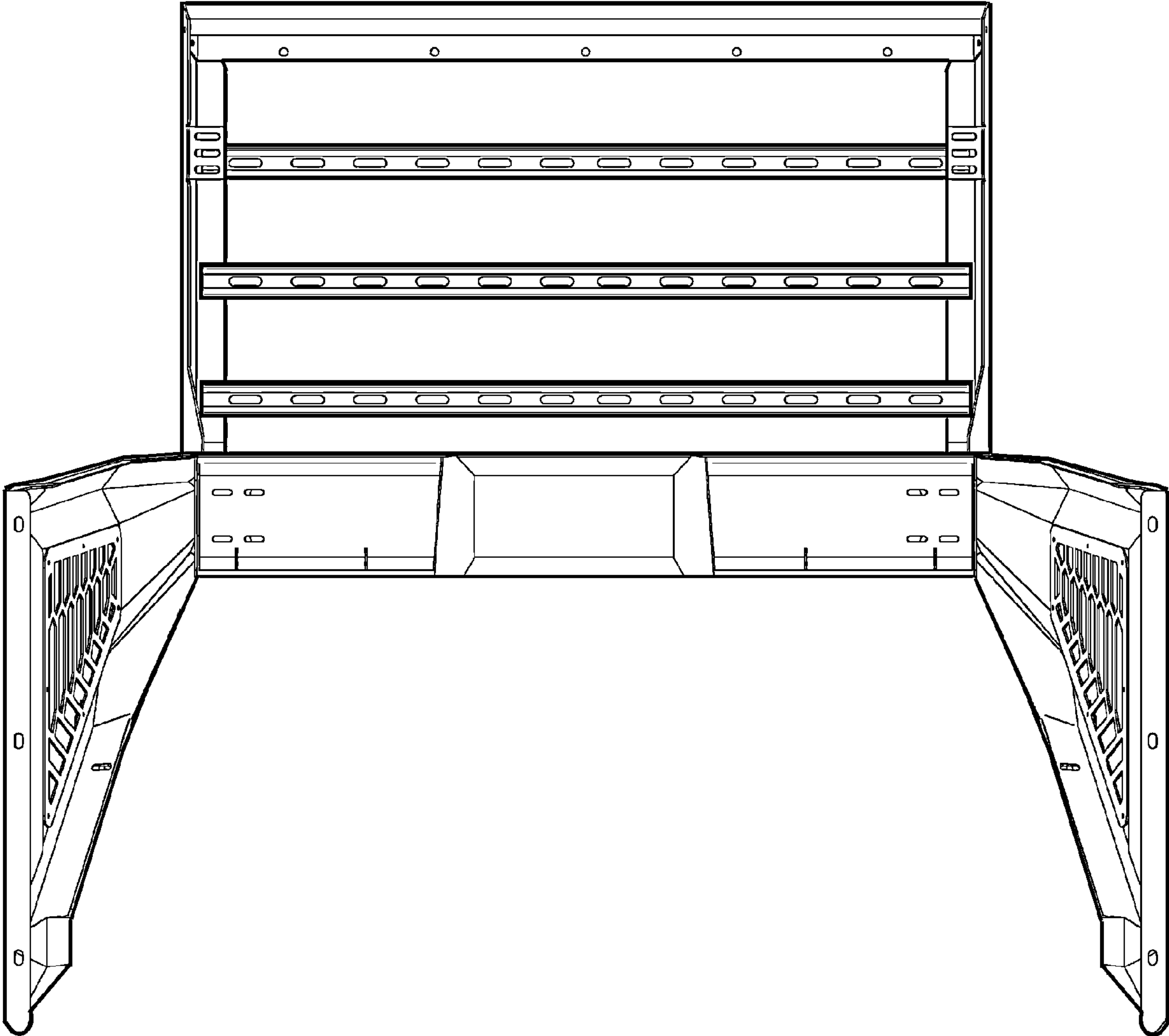
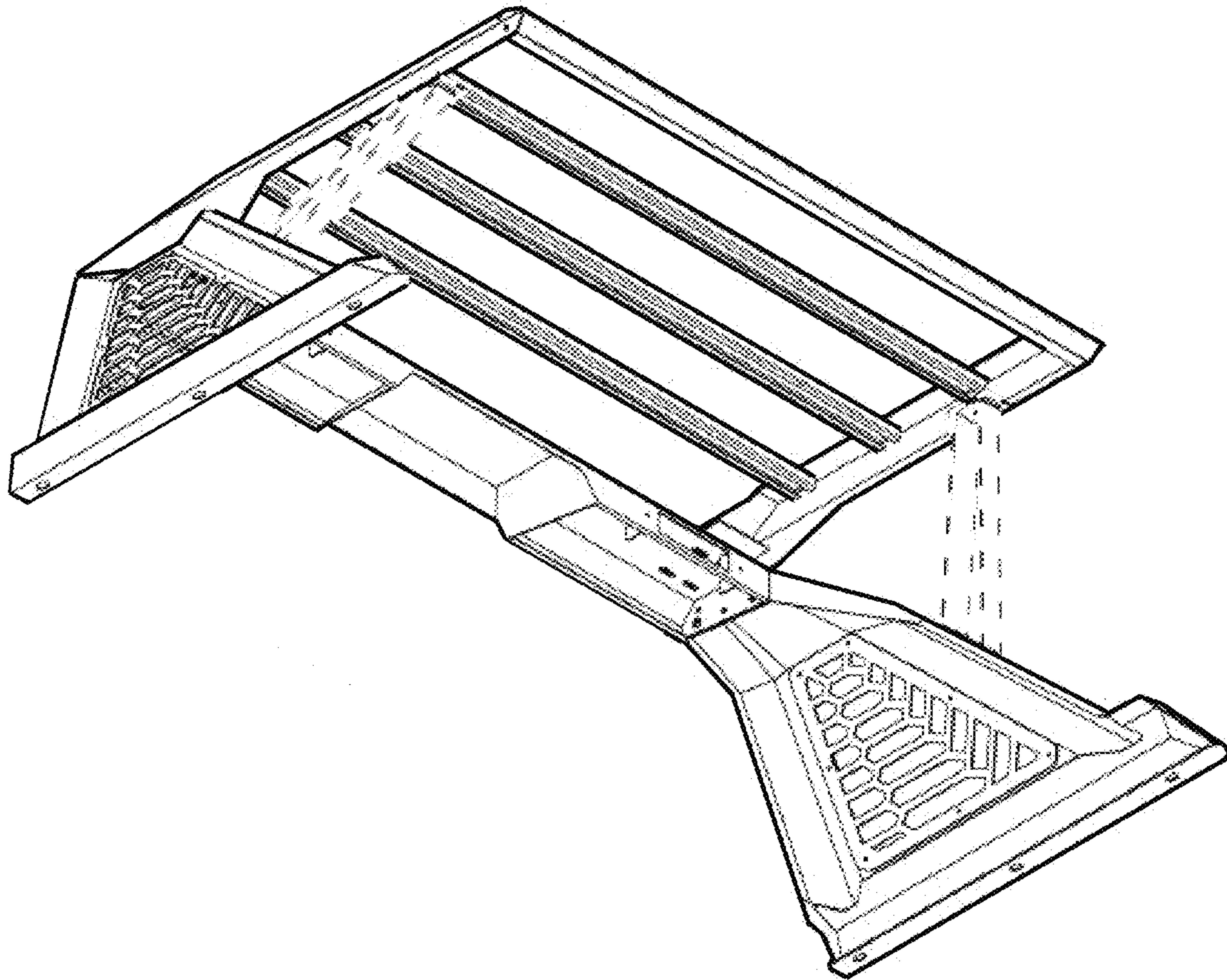

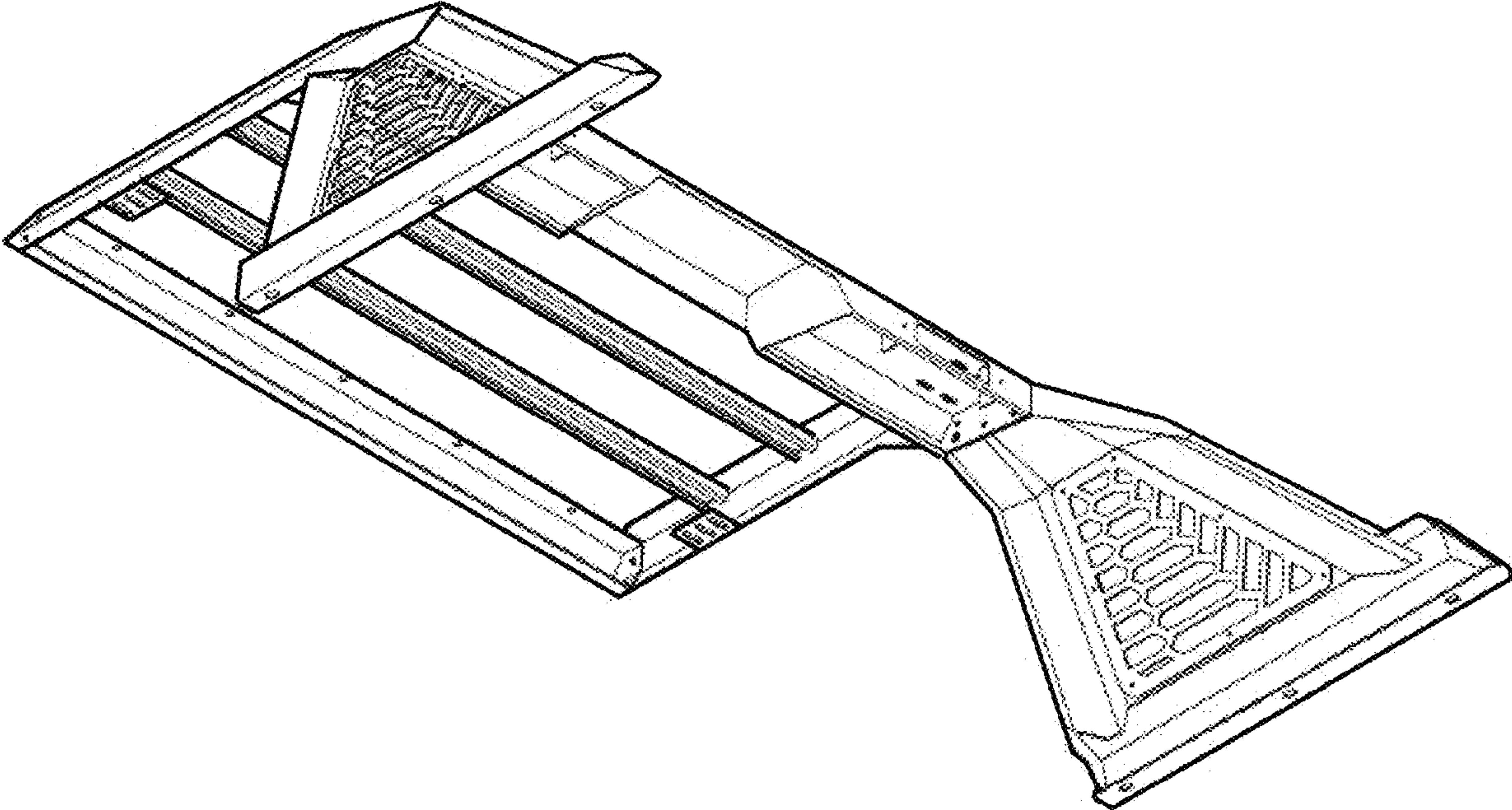
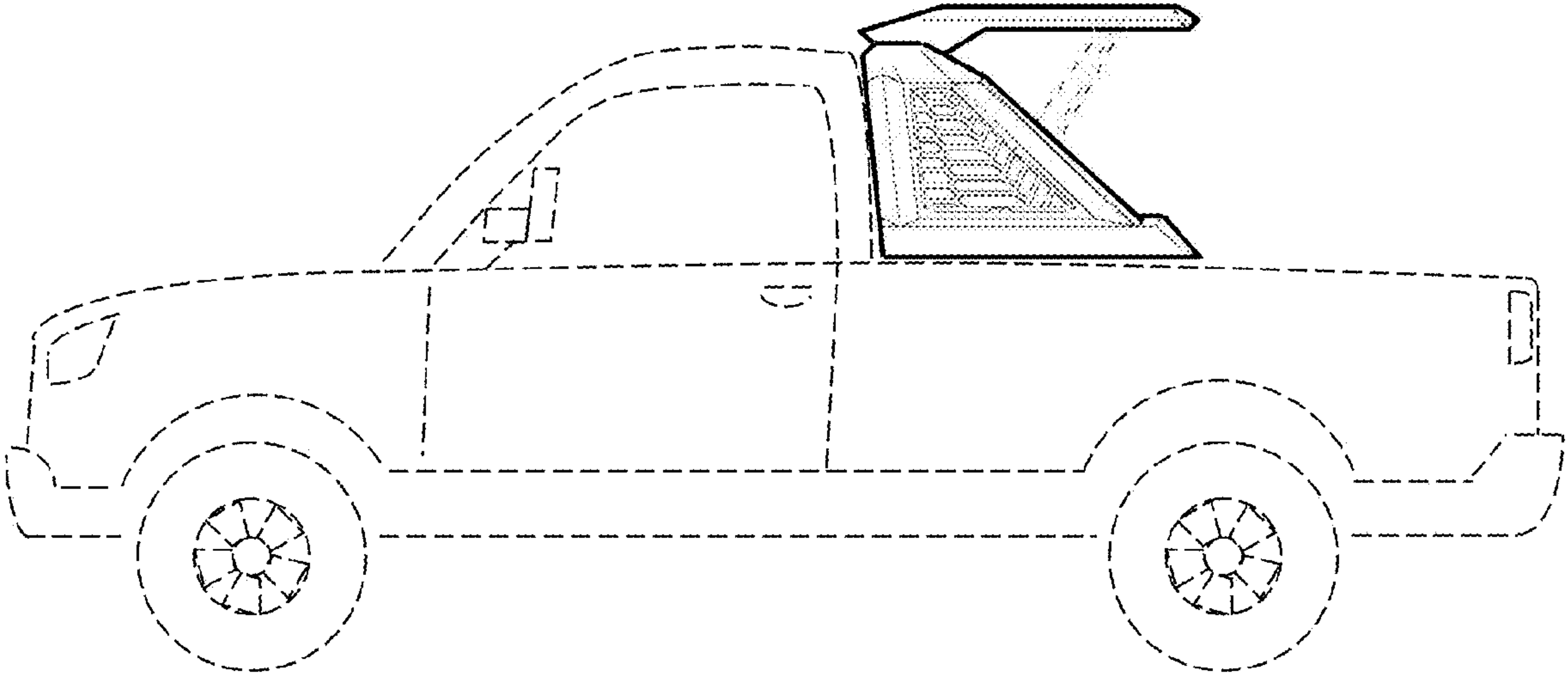
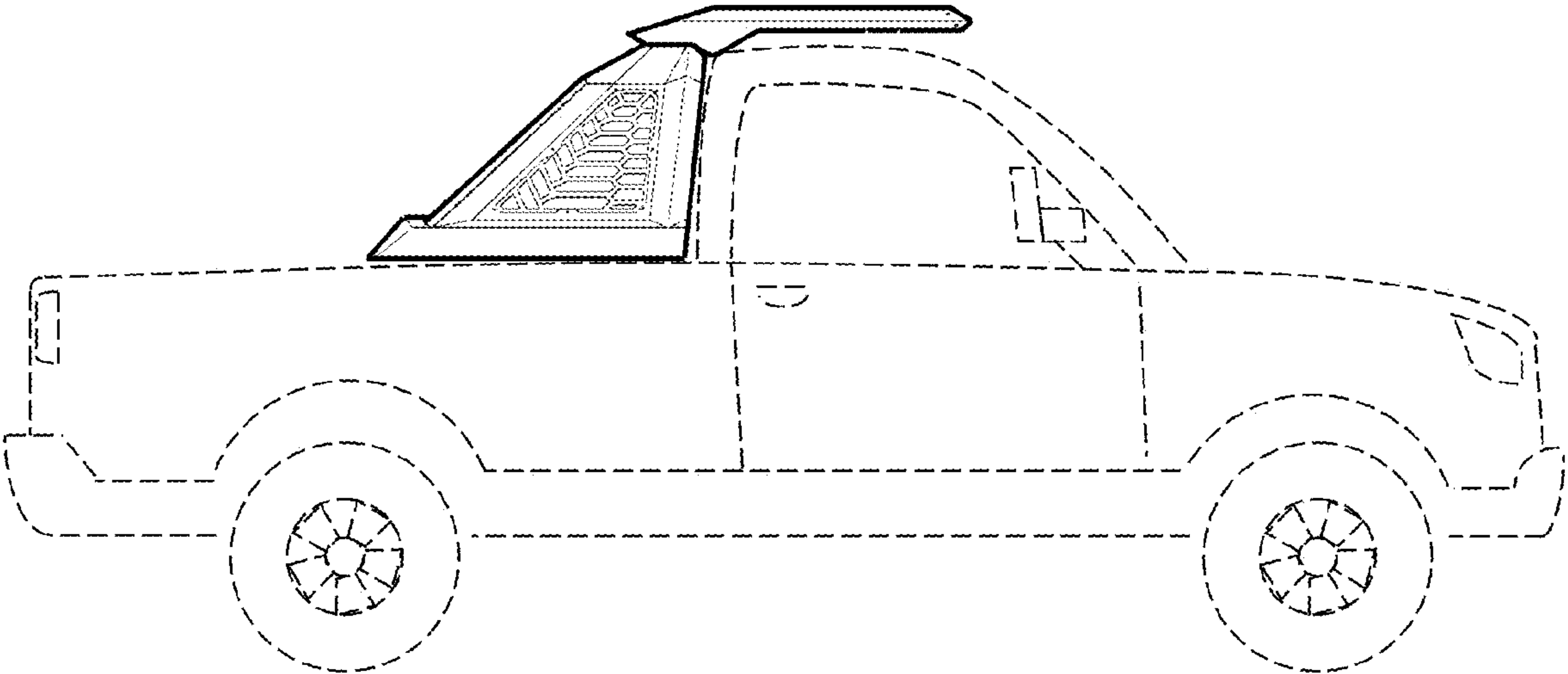
