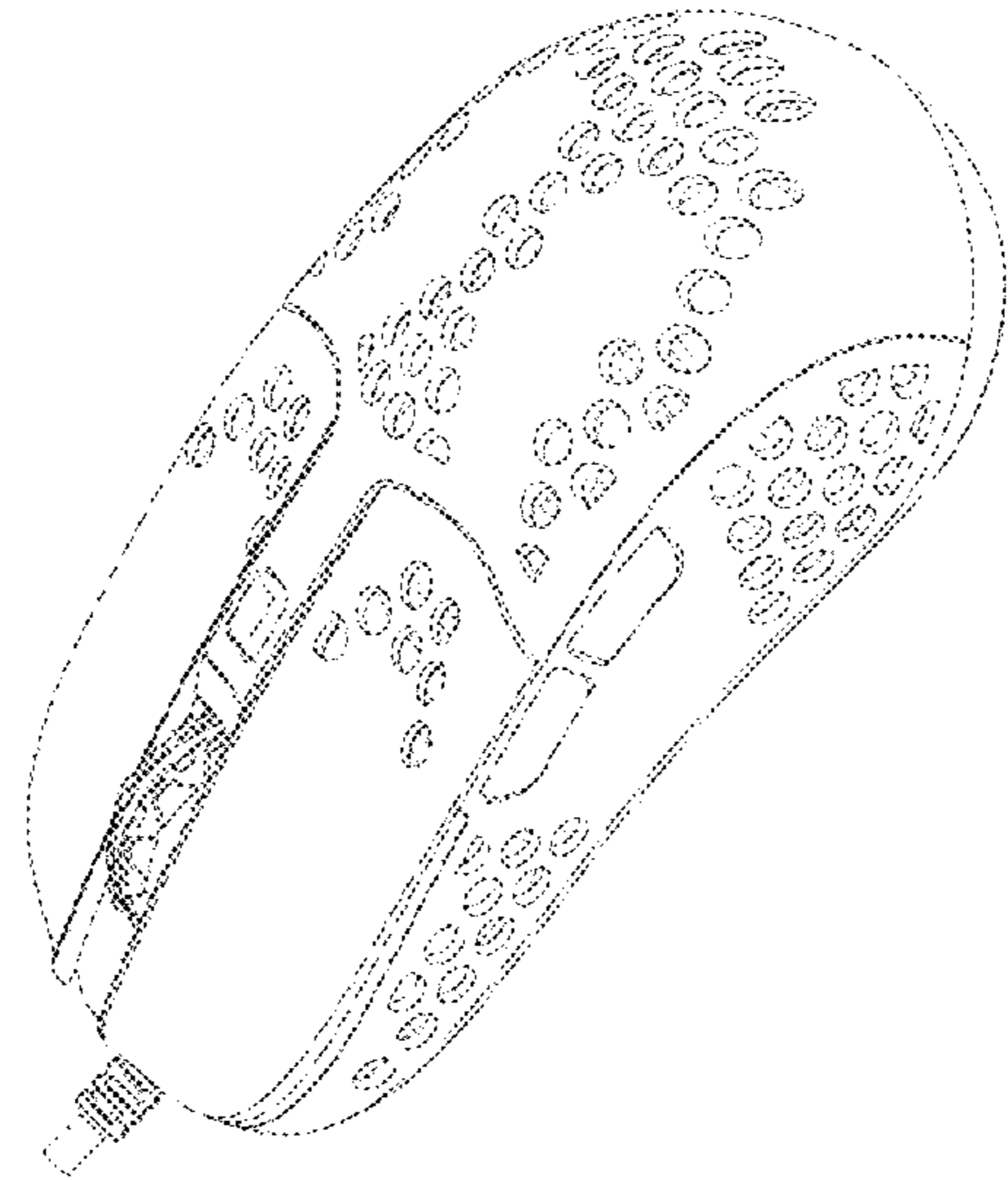
The ornamental design for a computer mouse, as shown and described.

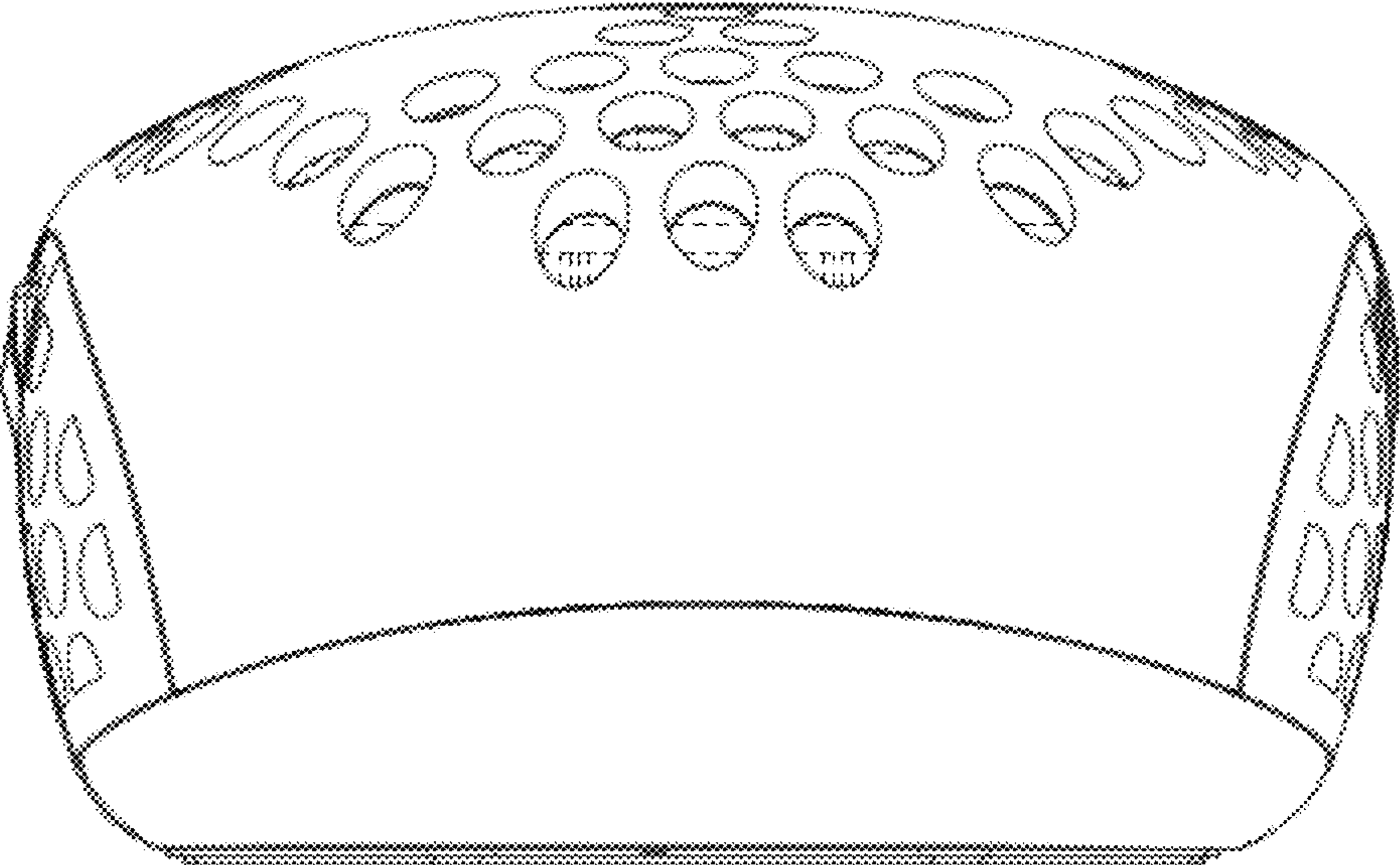

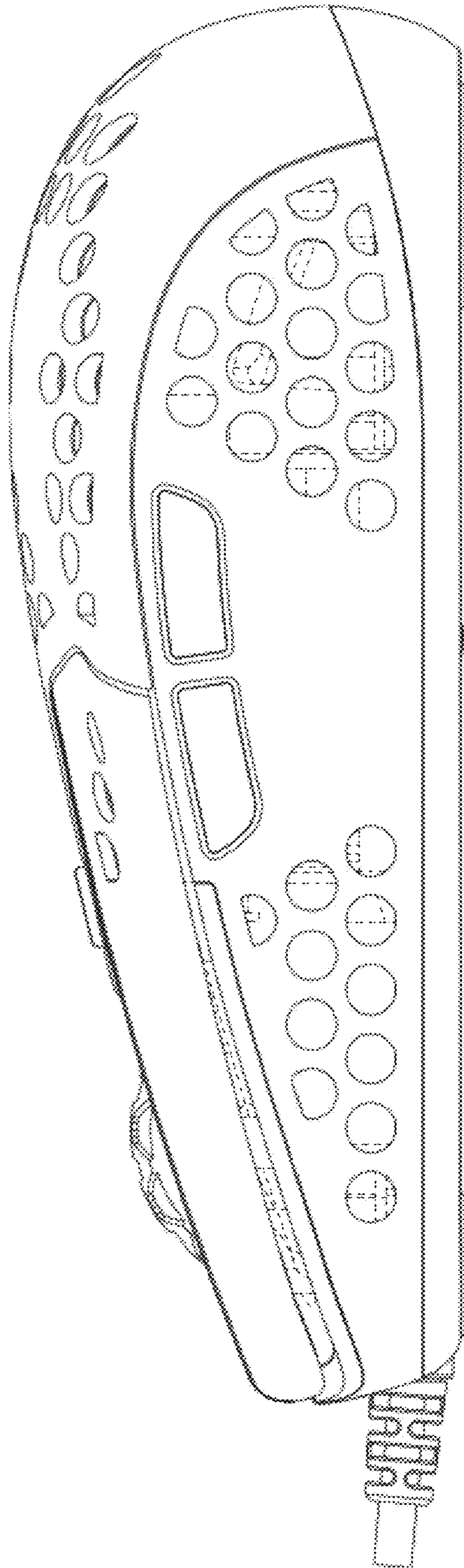

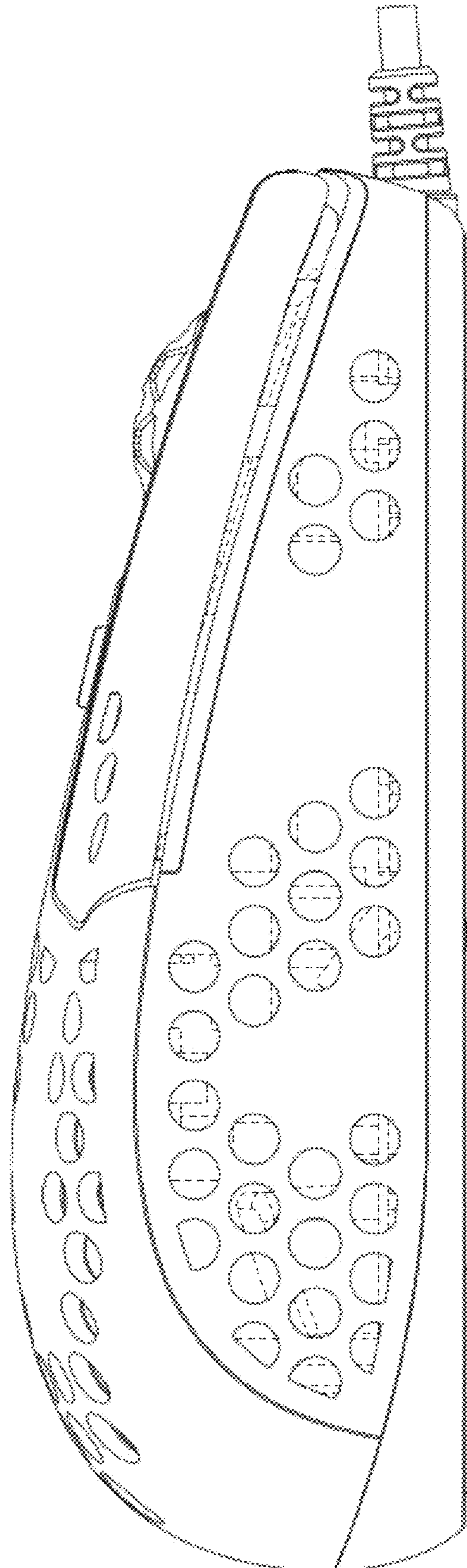

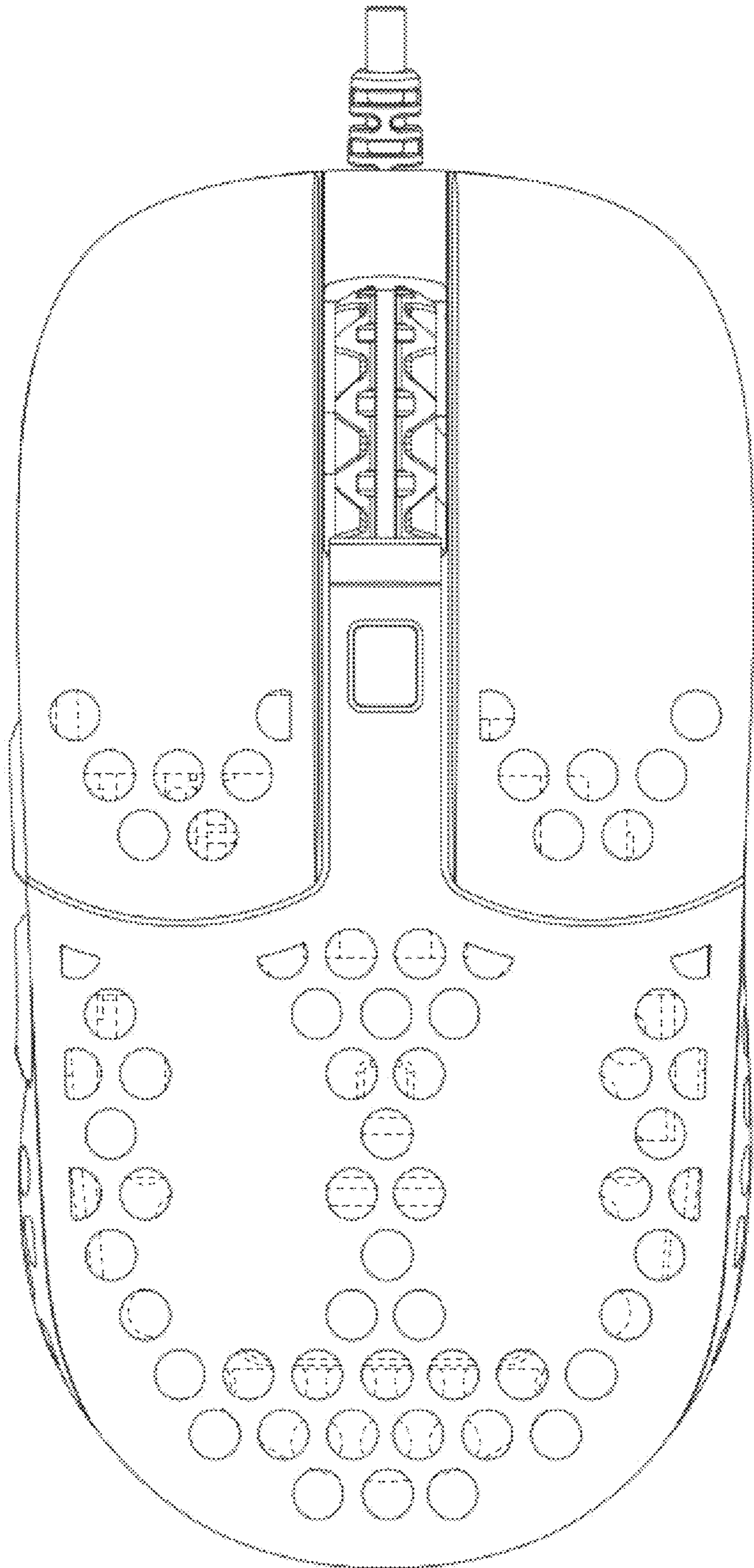
