(57) **CLAIM**

The ornamental design for a display panel portion with an animated computer icon, substantially as shown and described.

FIG. 8 is an eighth image in the sequence thereof.

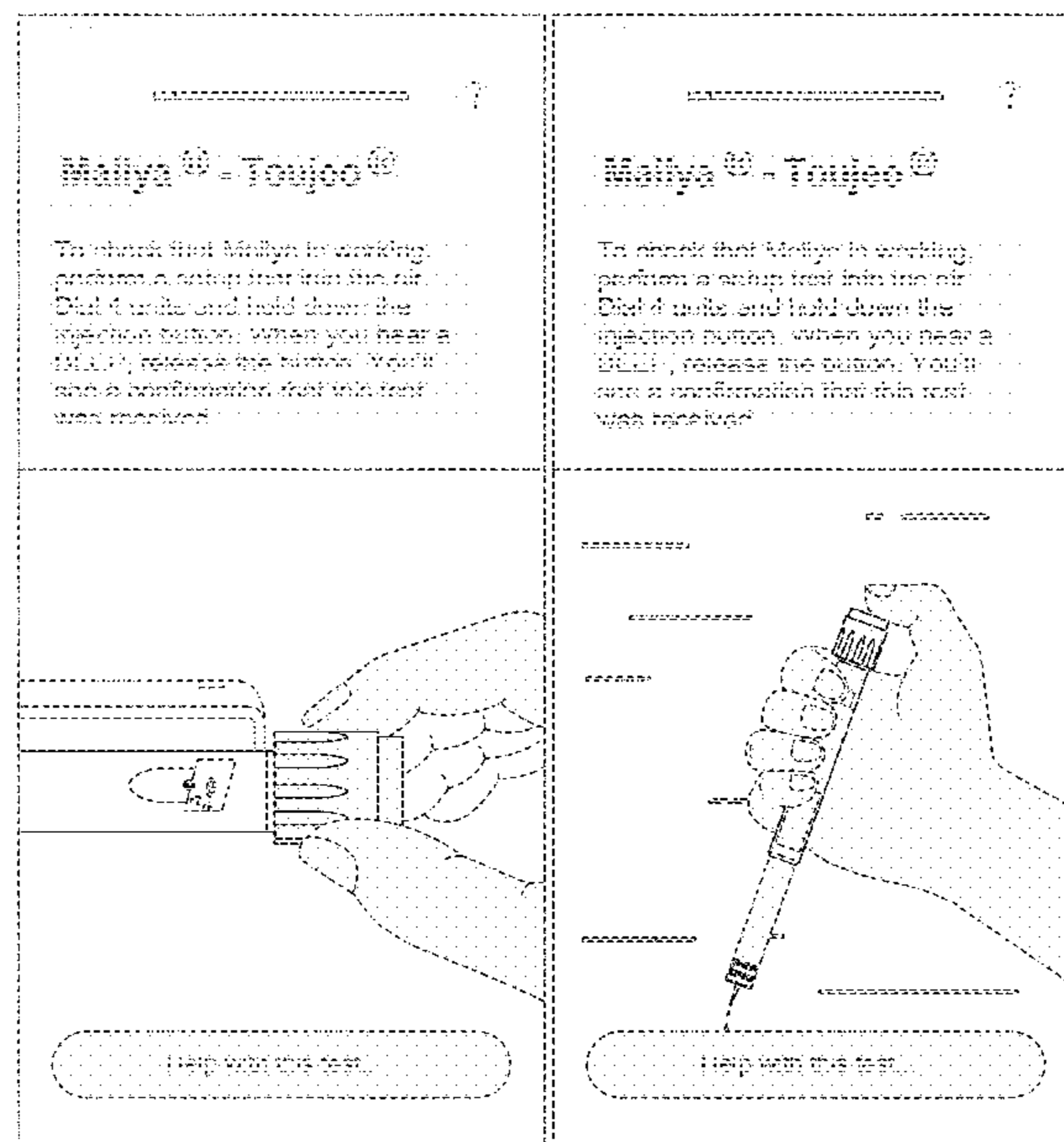
FIG. 9 is a ninth image in the sequence thereof; and,

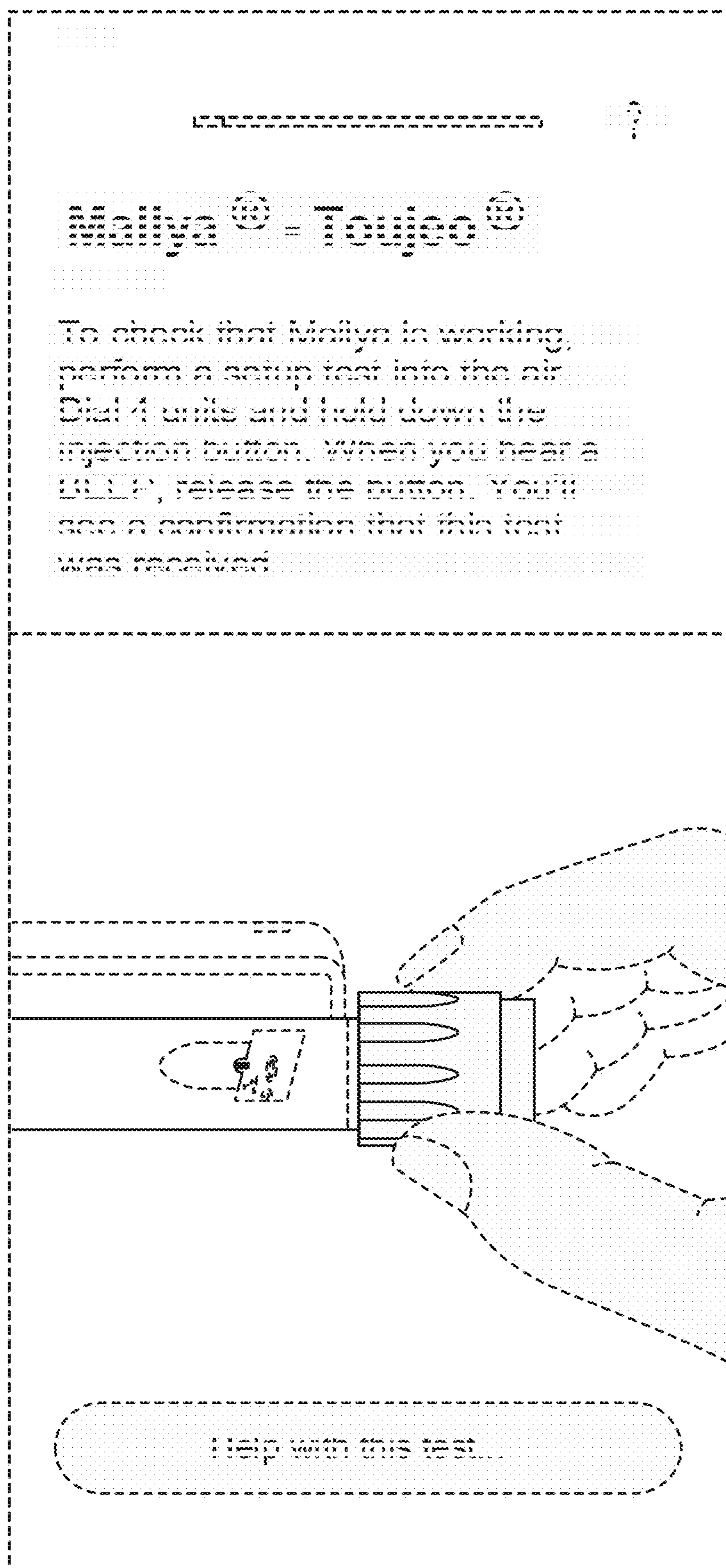

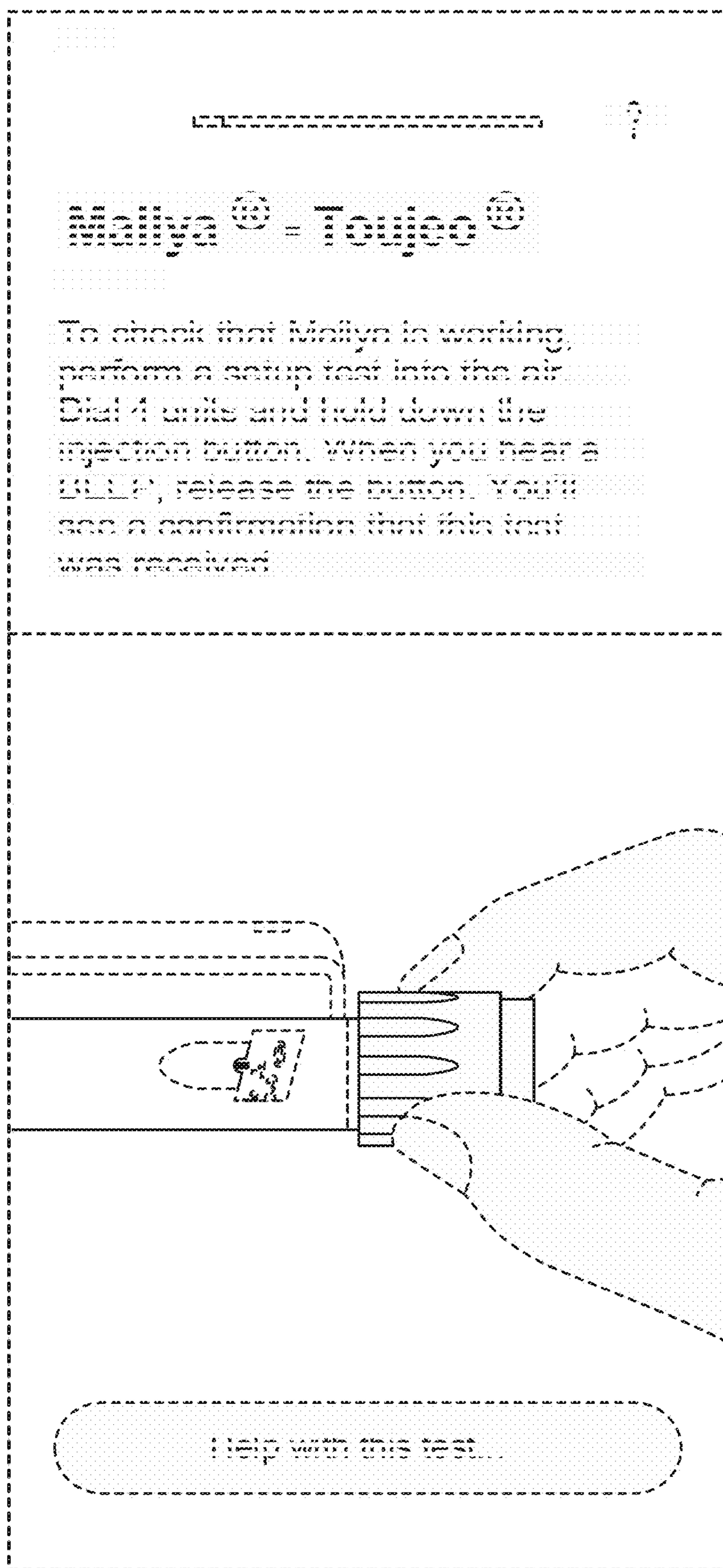

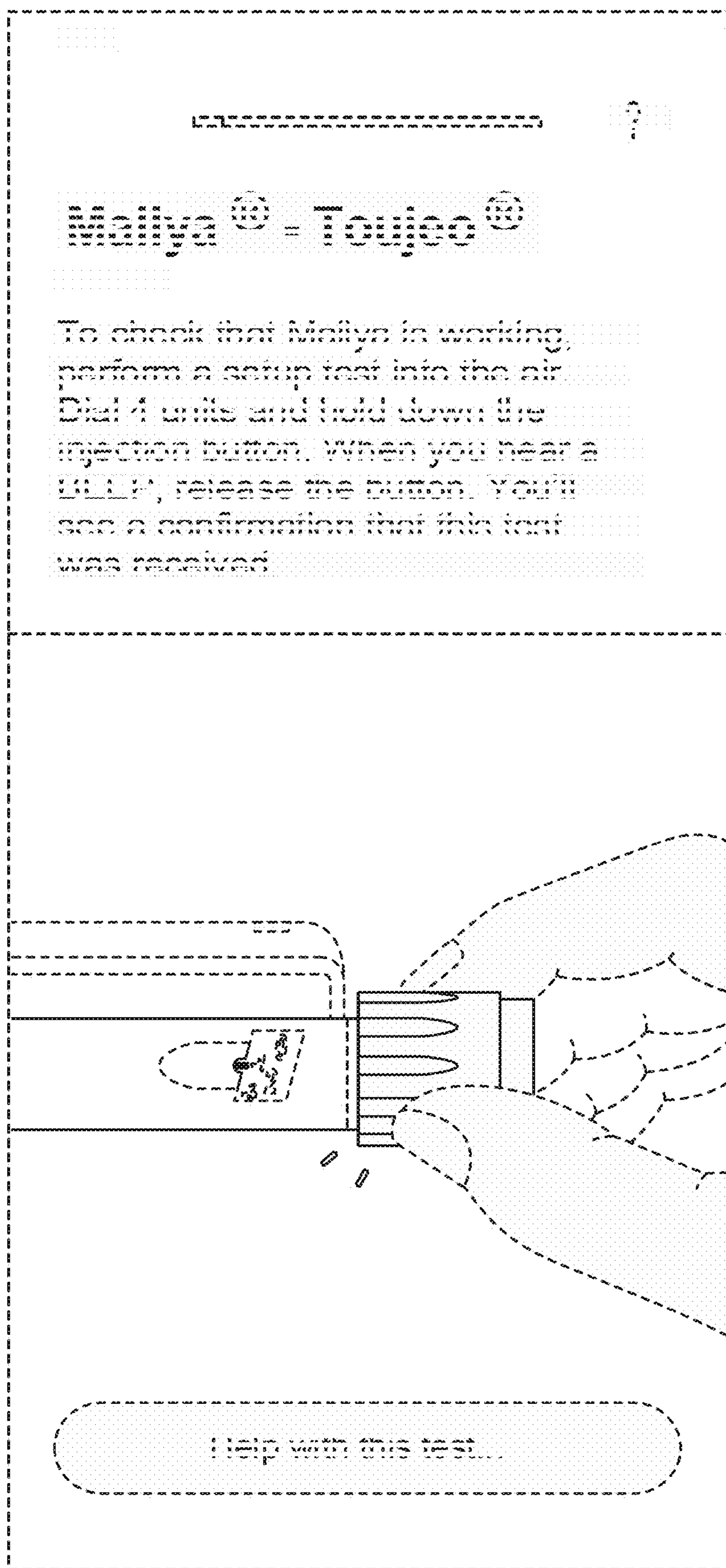

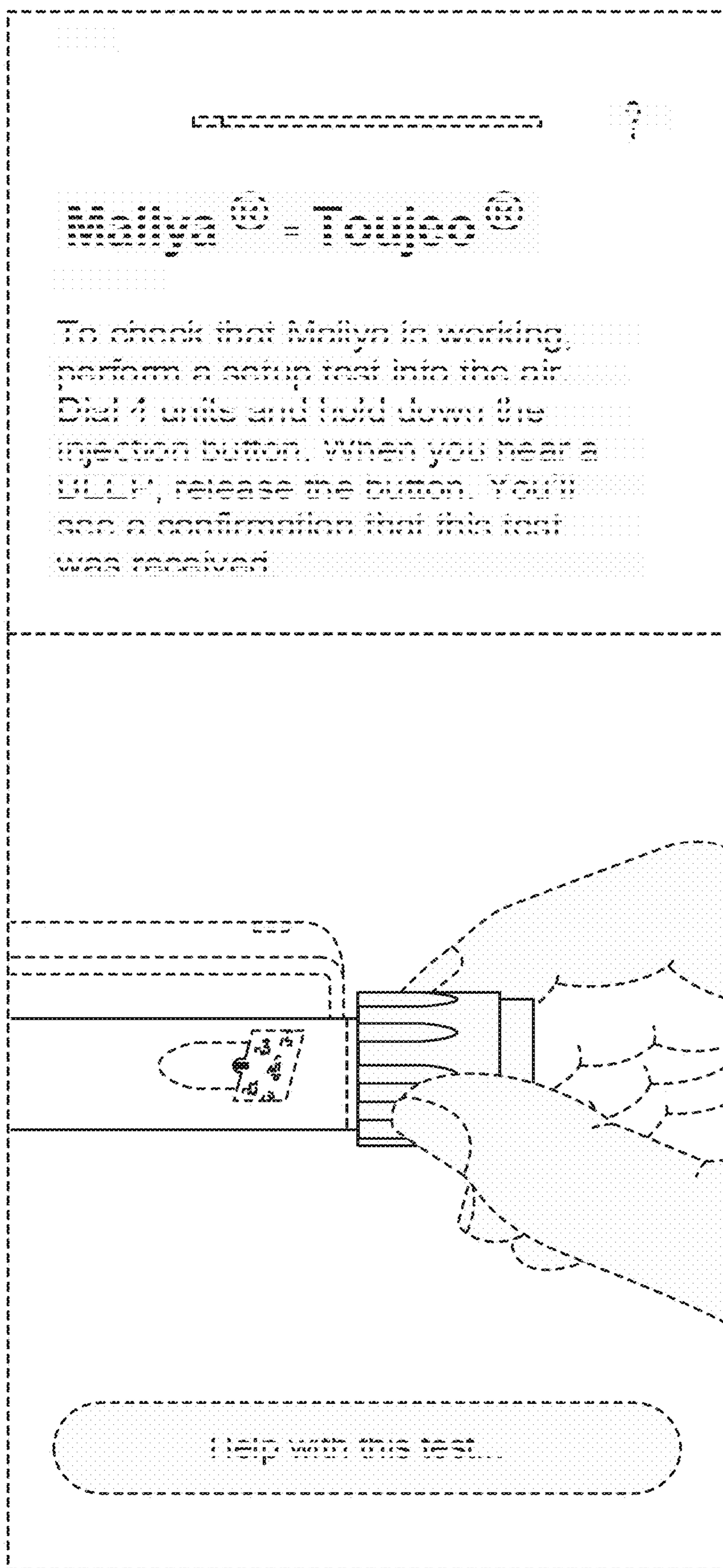

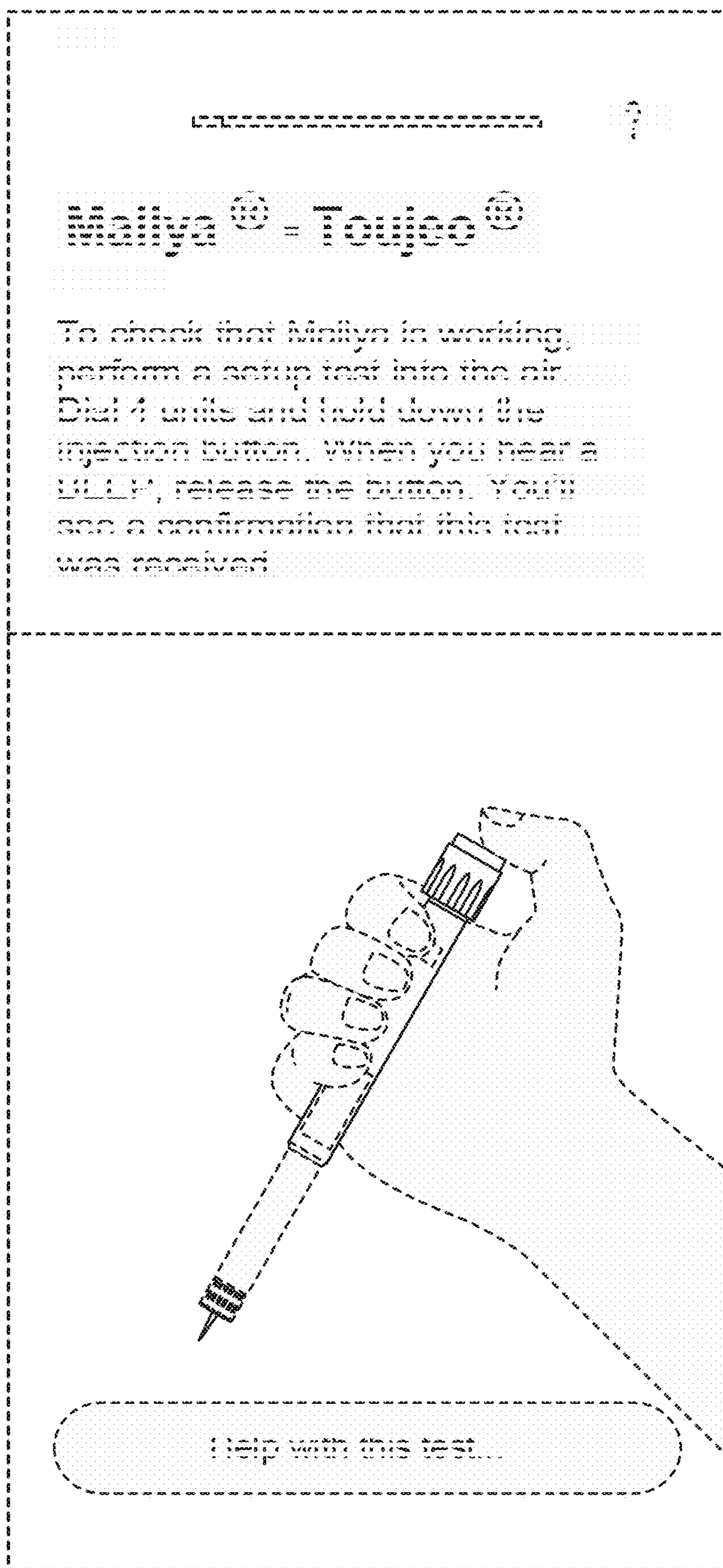

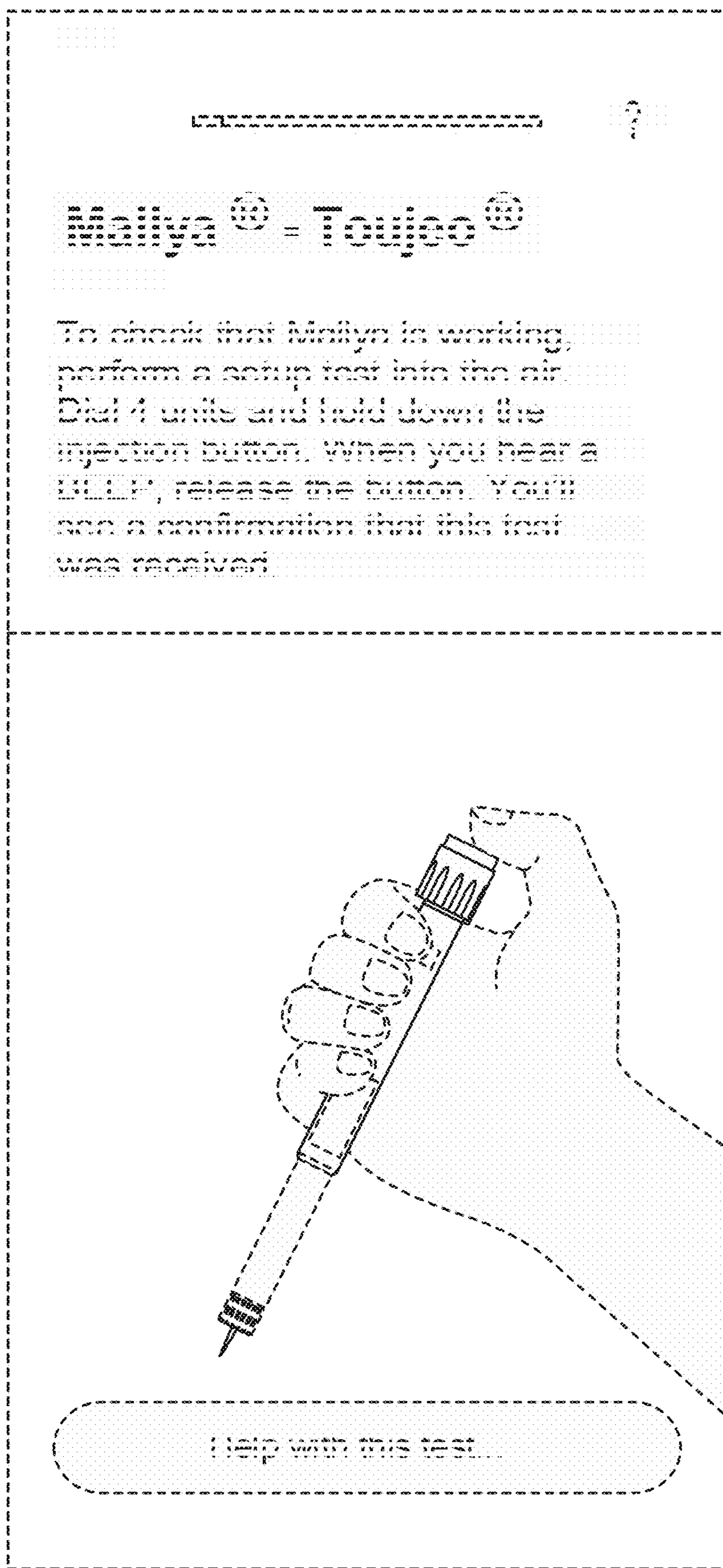

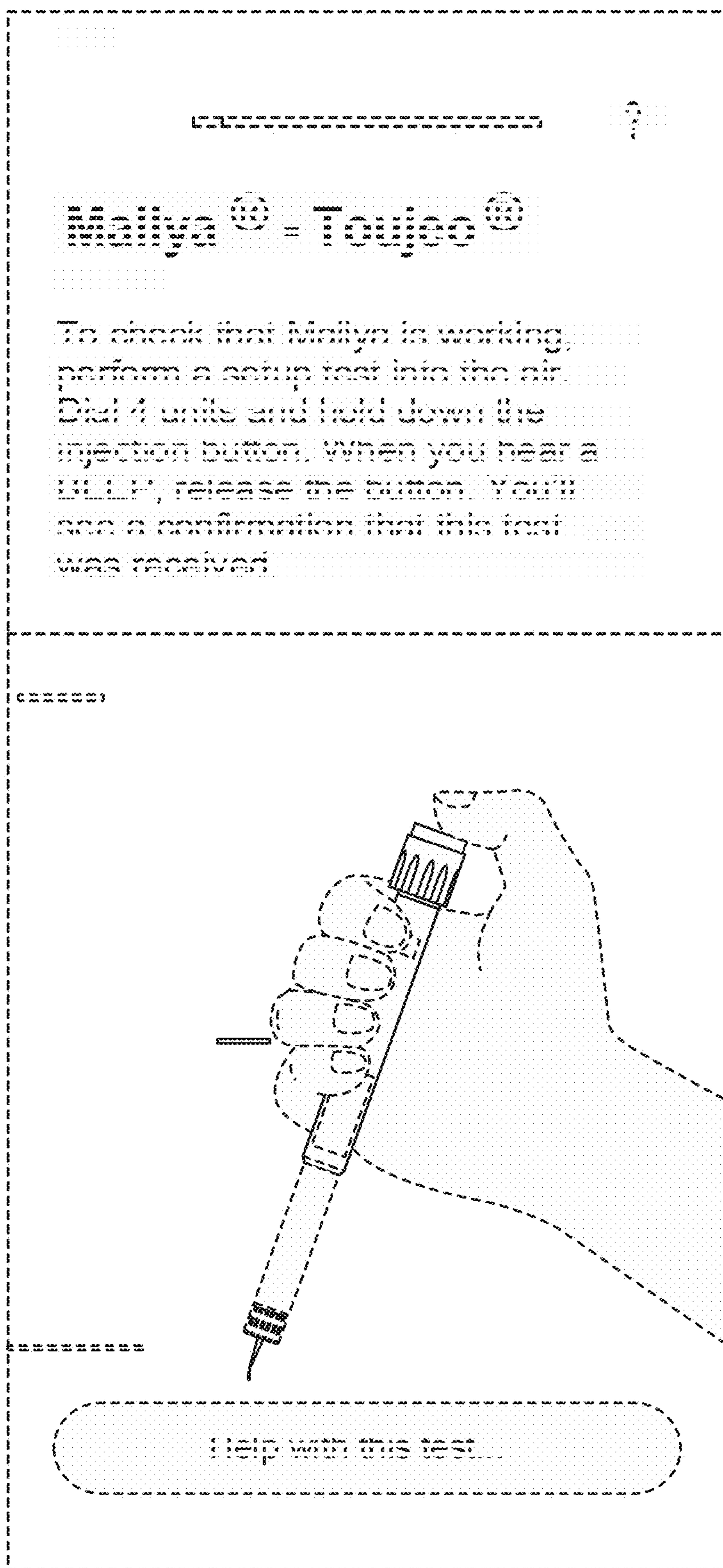

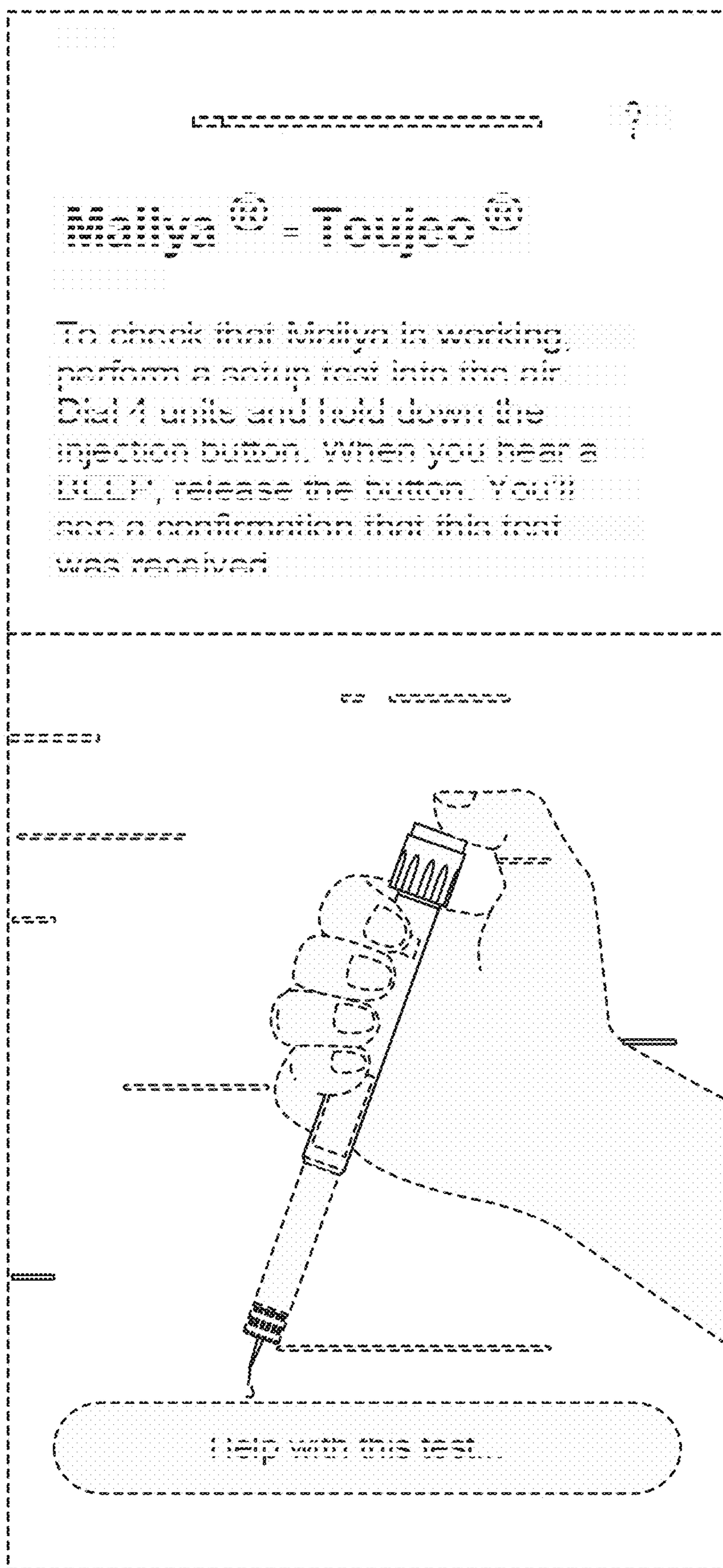

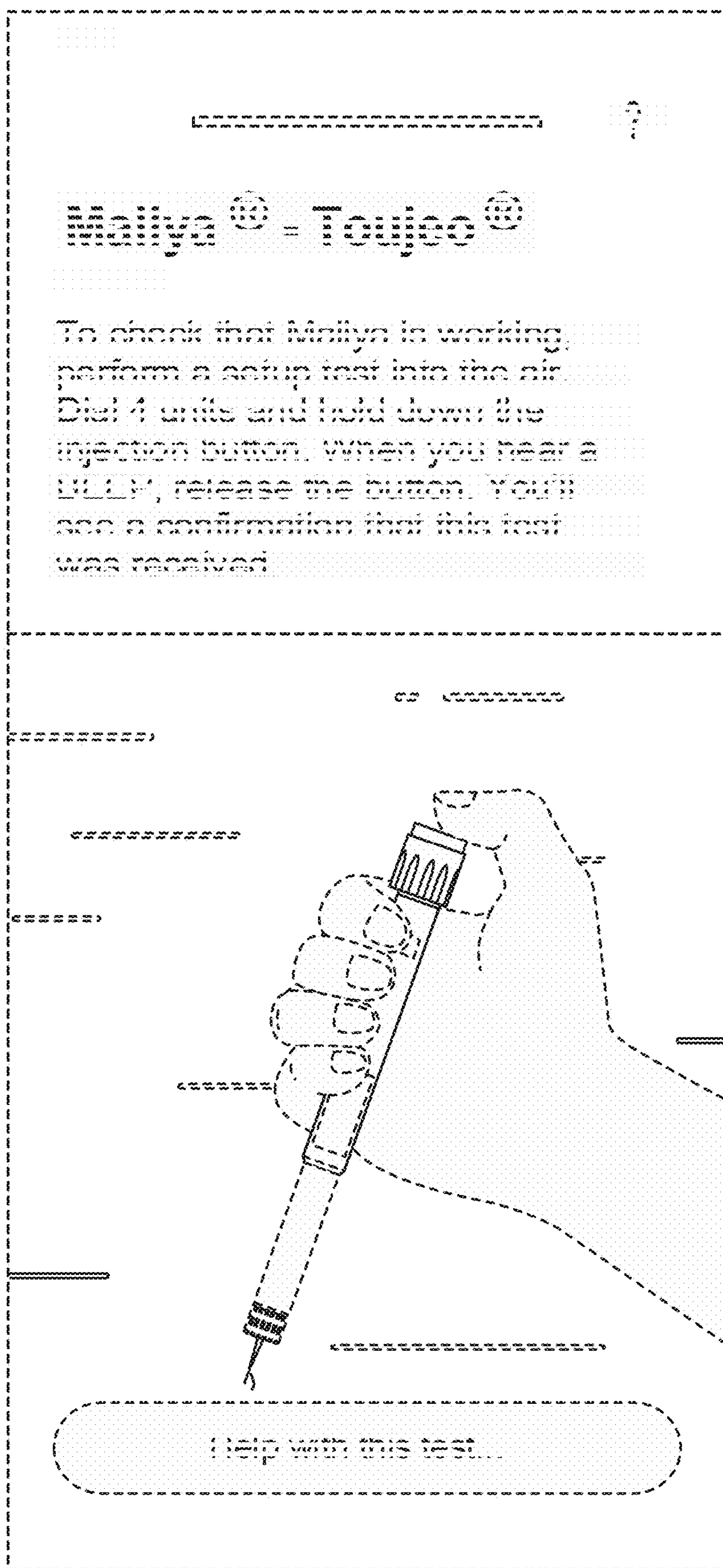

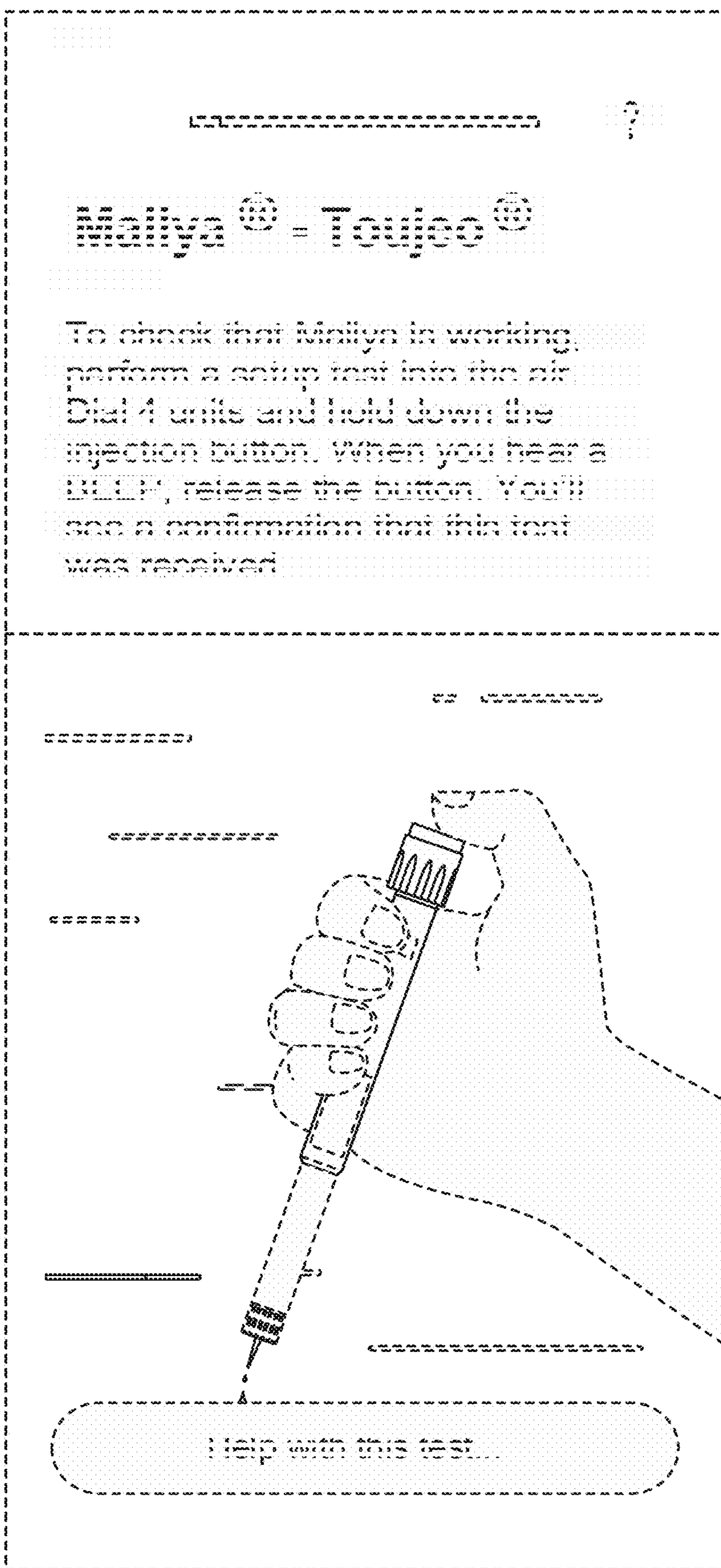
