FIG. 1 depicts a front view of a display screen with a graphical user interface showing a first embodiment of the design.

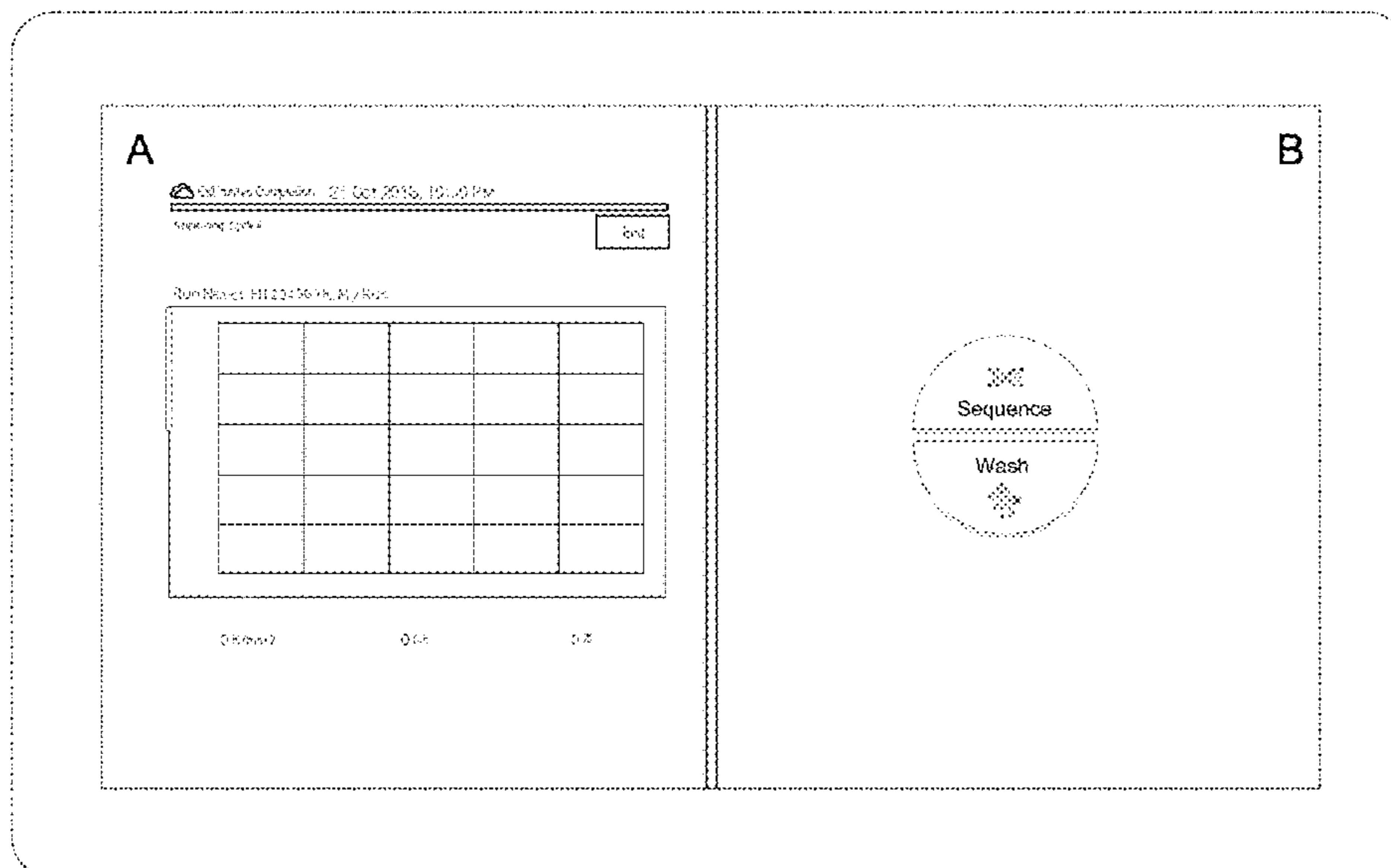
FIG. 2 depicts a front view of a display screen with a graphical user interface showing a second embodiment thereof.

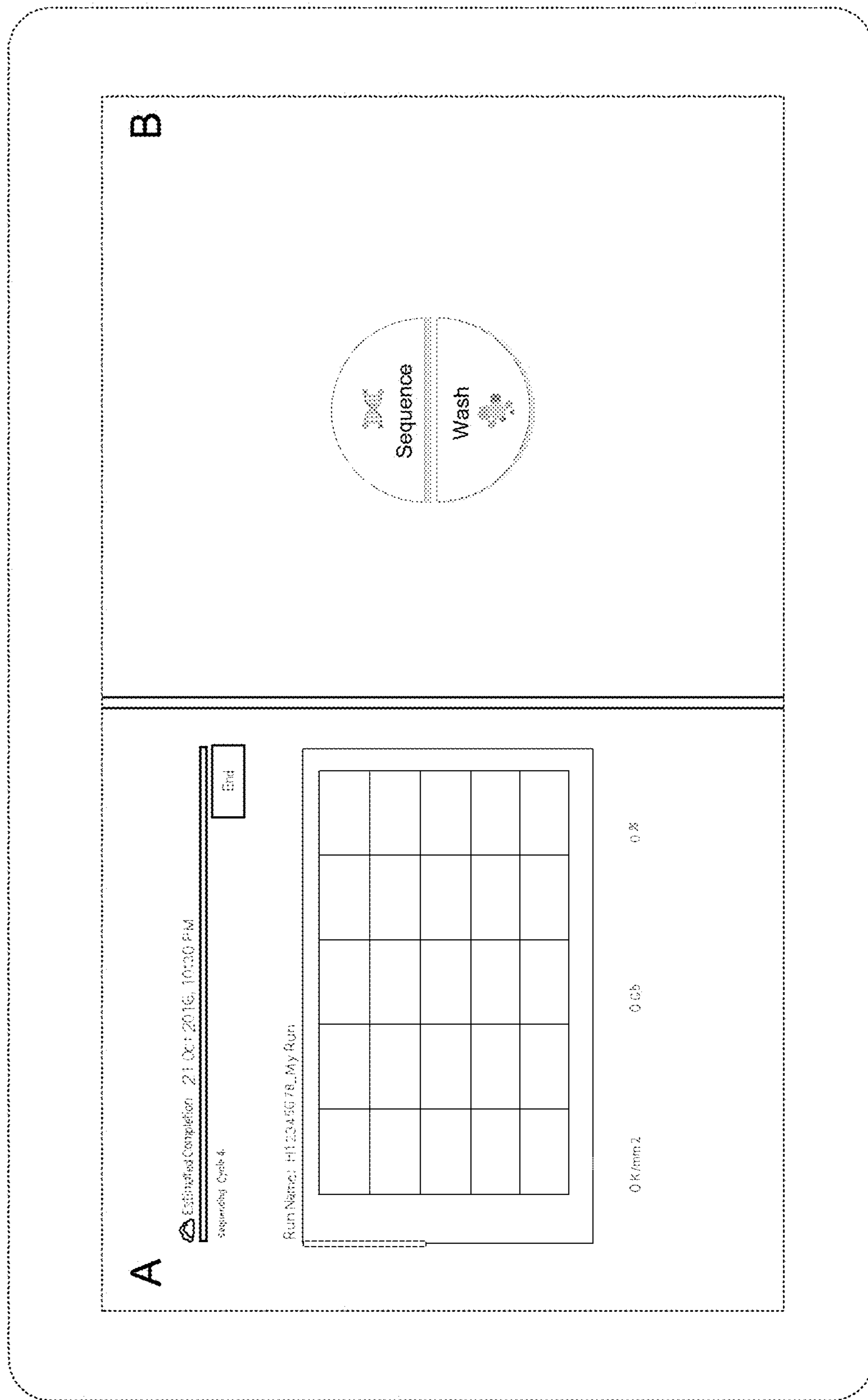

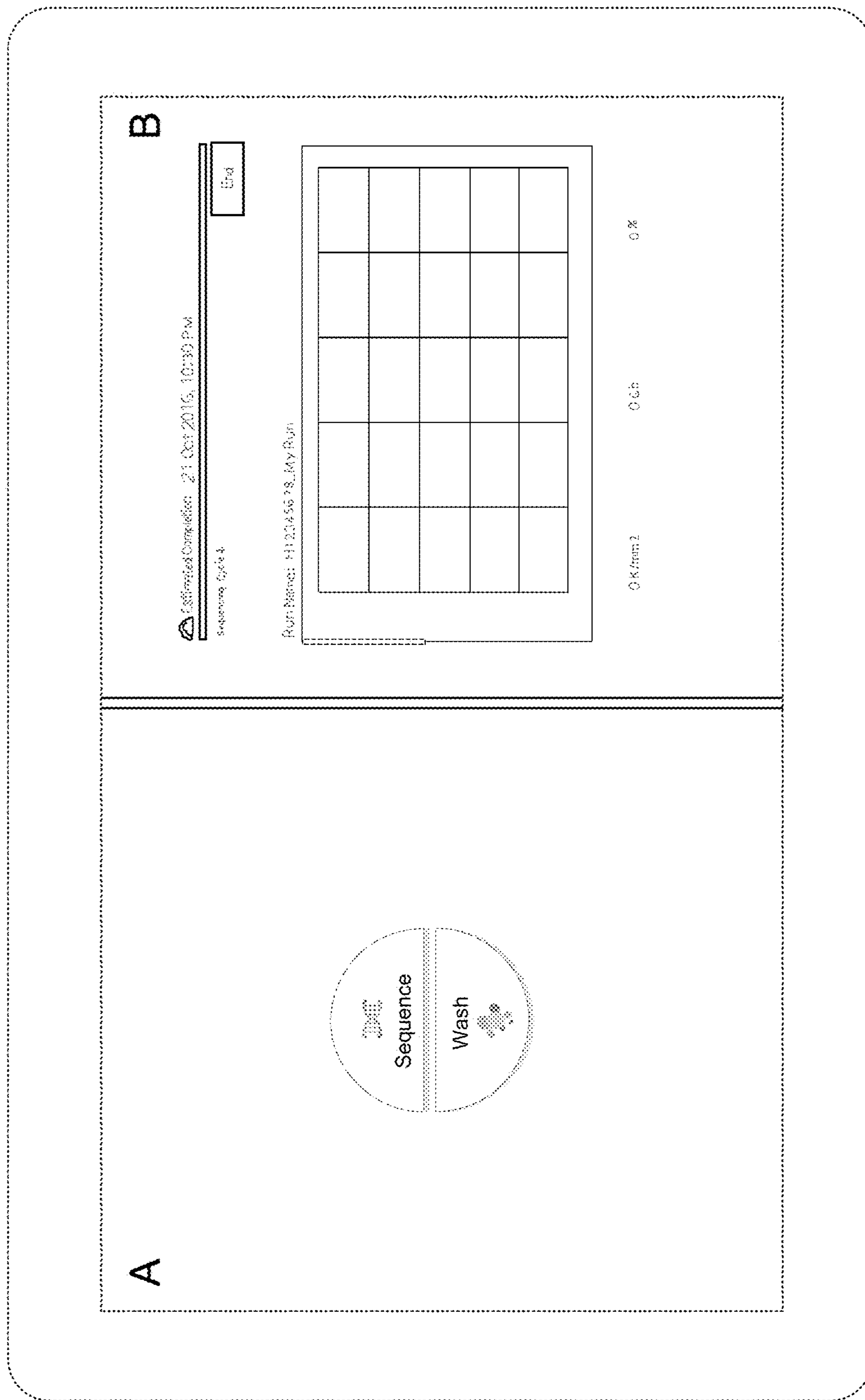
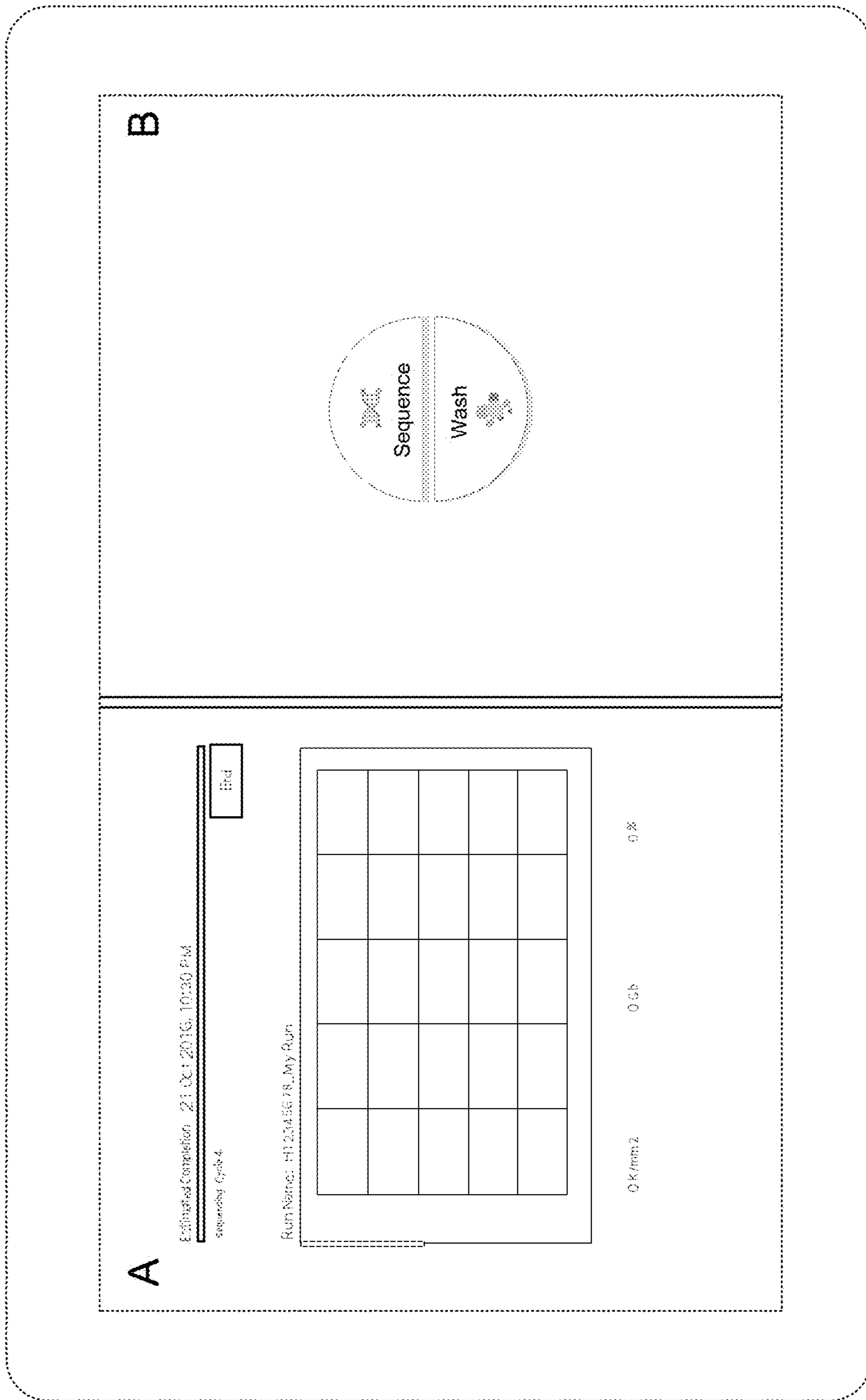
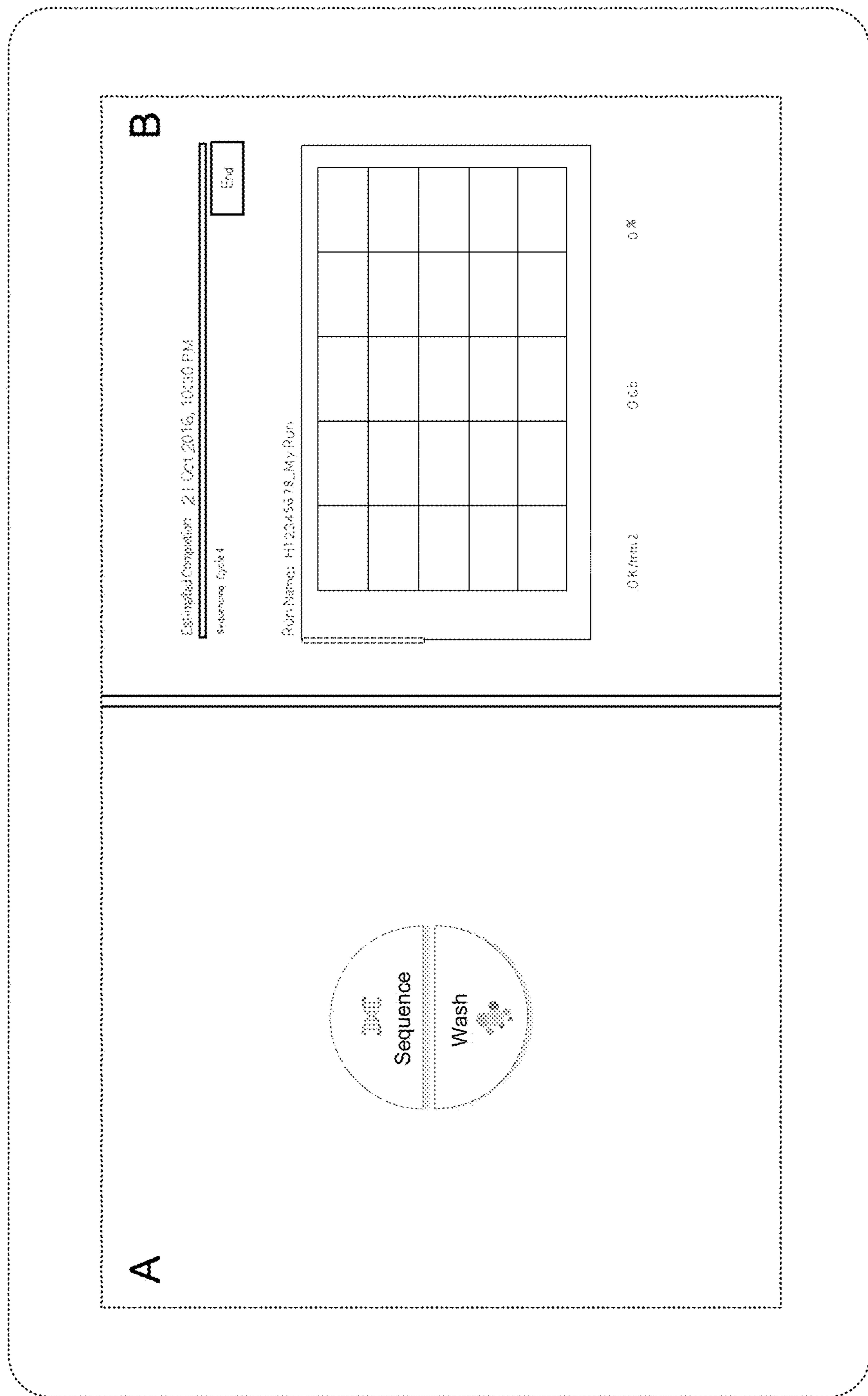
