FIG. 4 is a top plan view thereof;


FIG. 5 is a bottom view thereof;


FIG. 6 is a left side view thereof;

FIG. 8 is a cross-sectional view thereof along the line 8-8 in FIG. 2.


The broken lines depict portions of the air conditioner that form no part of claimed design.










