DESCRIPTION

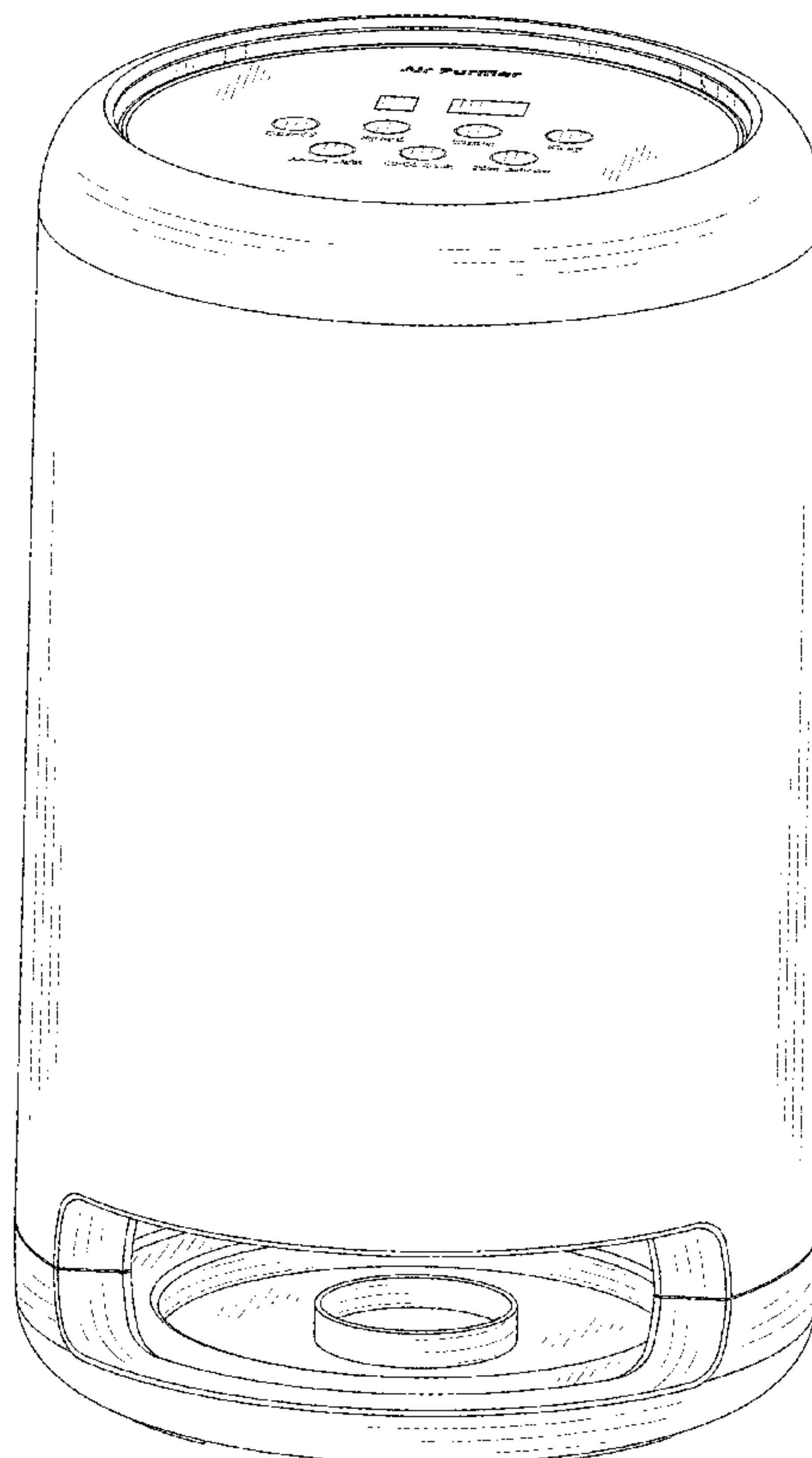
FIG. 1 is a perspective view of an air purifier showing my new design;

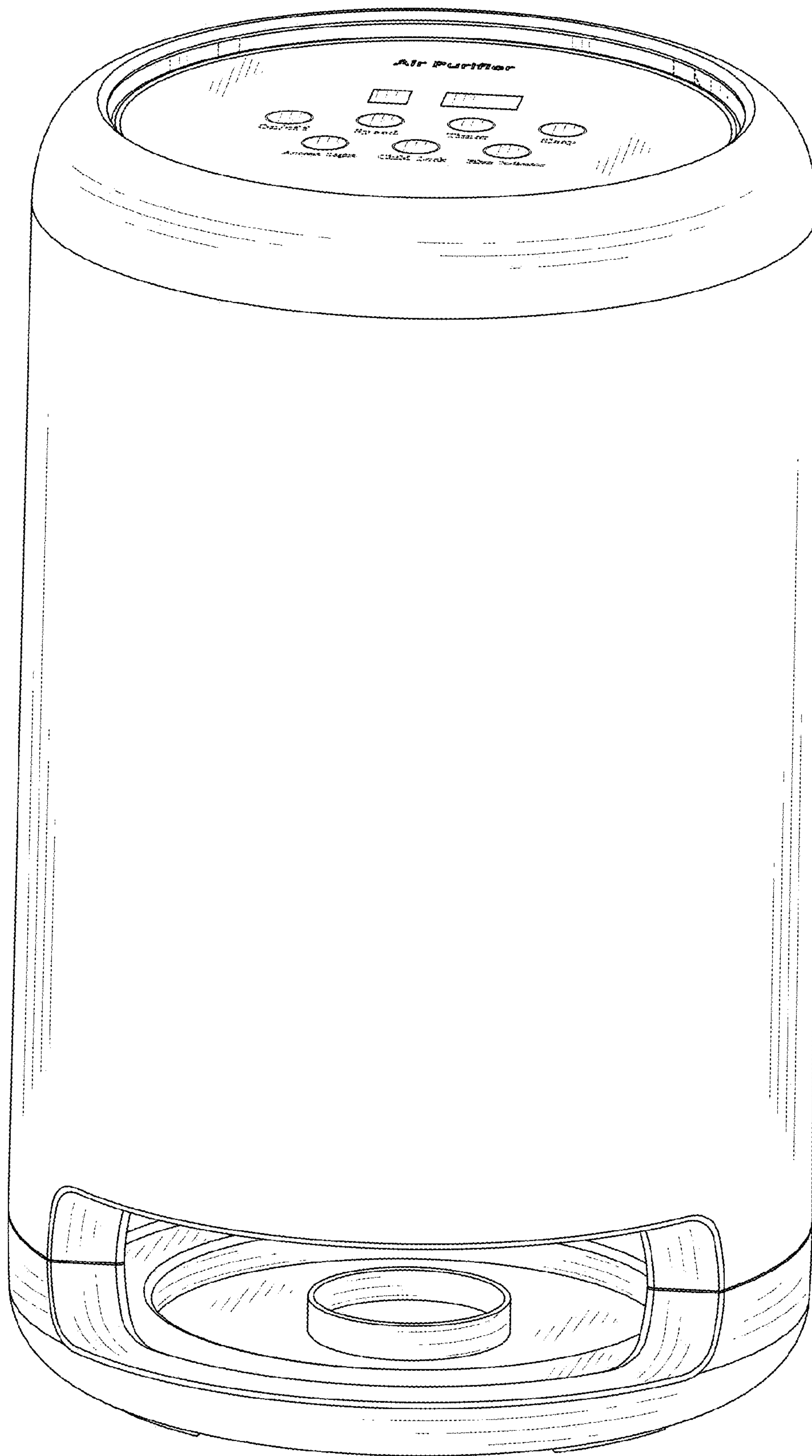

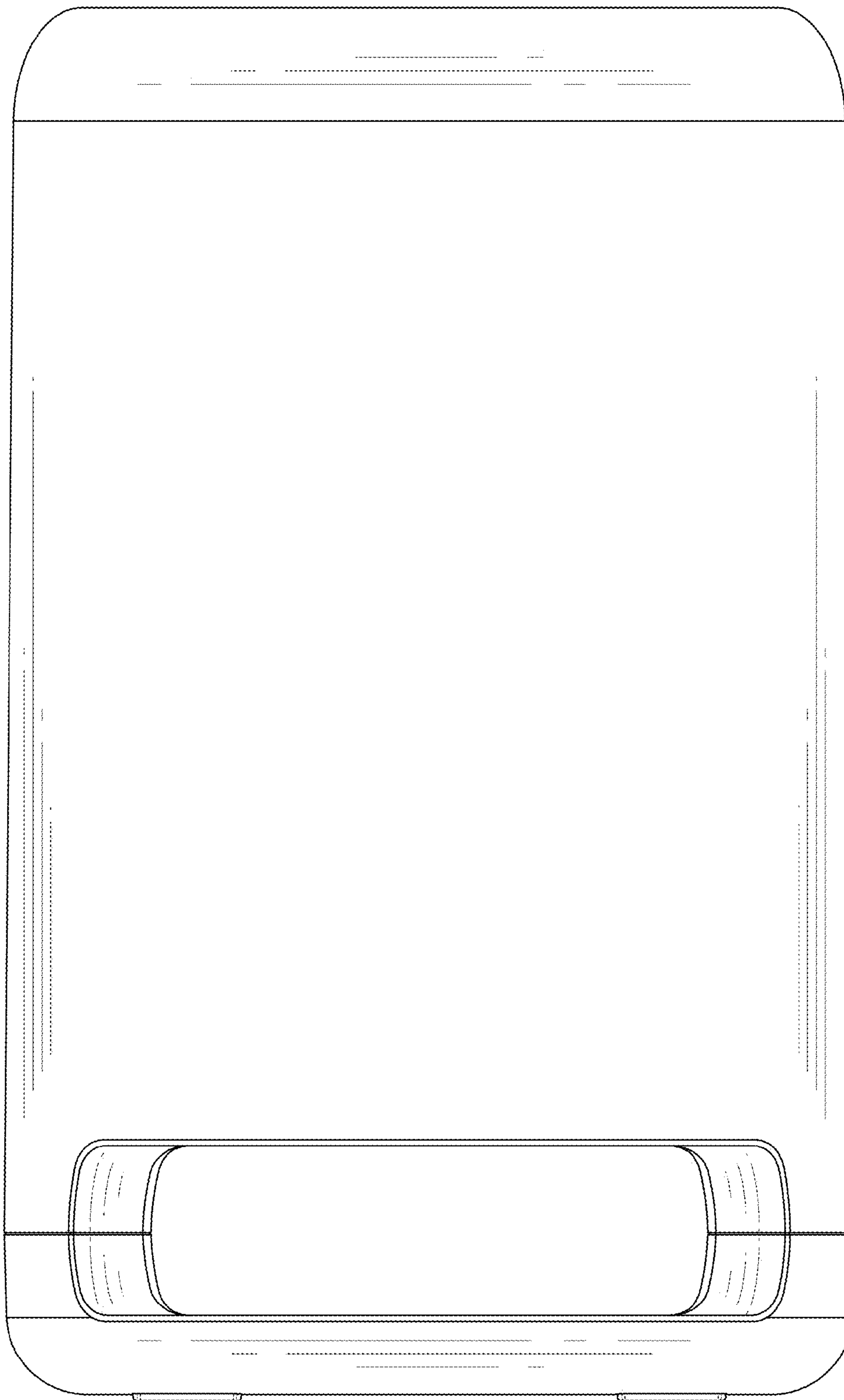

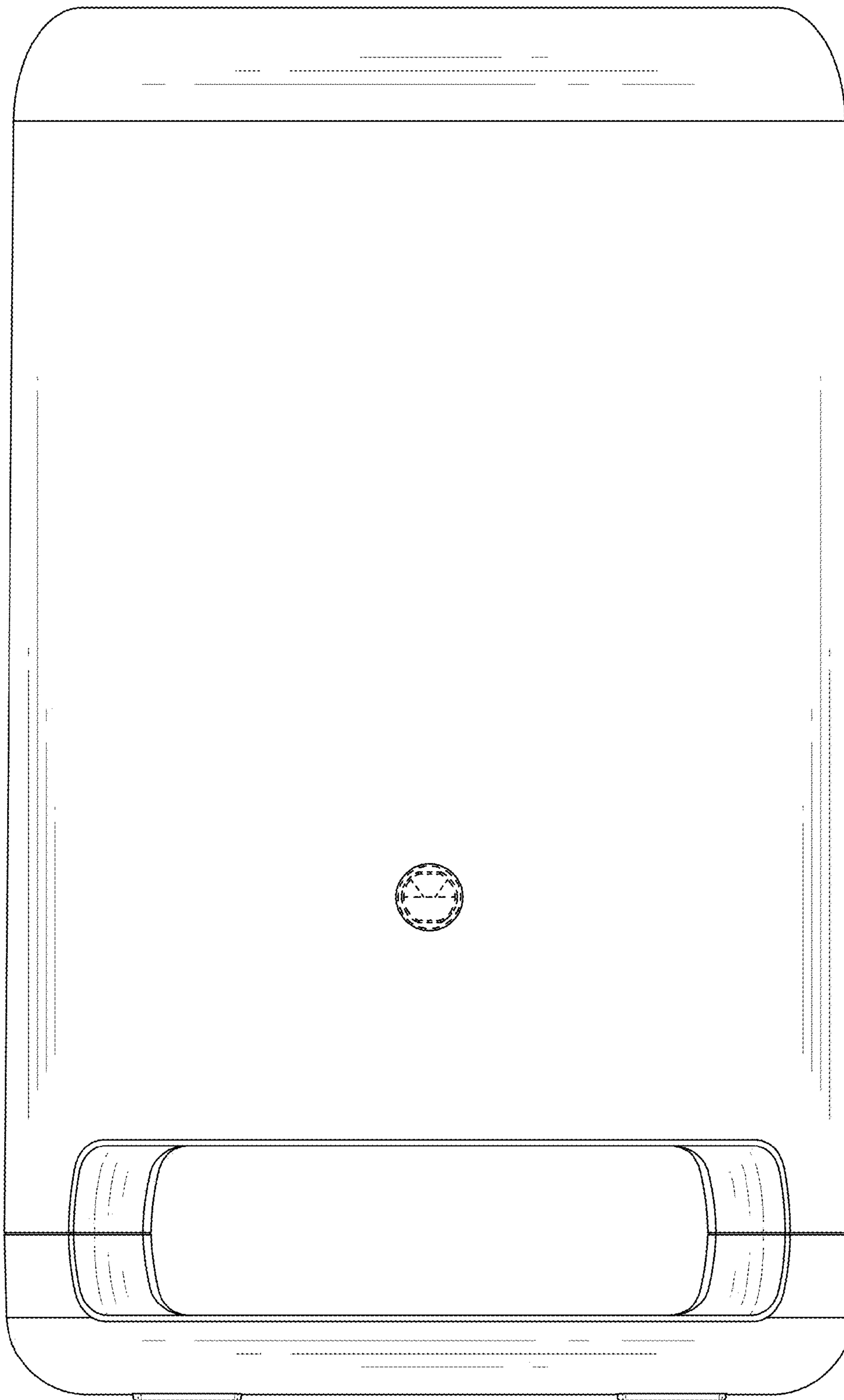

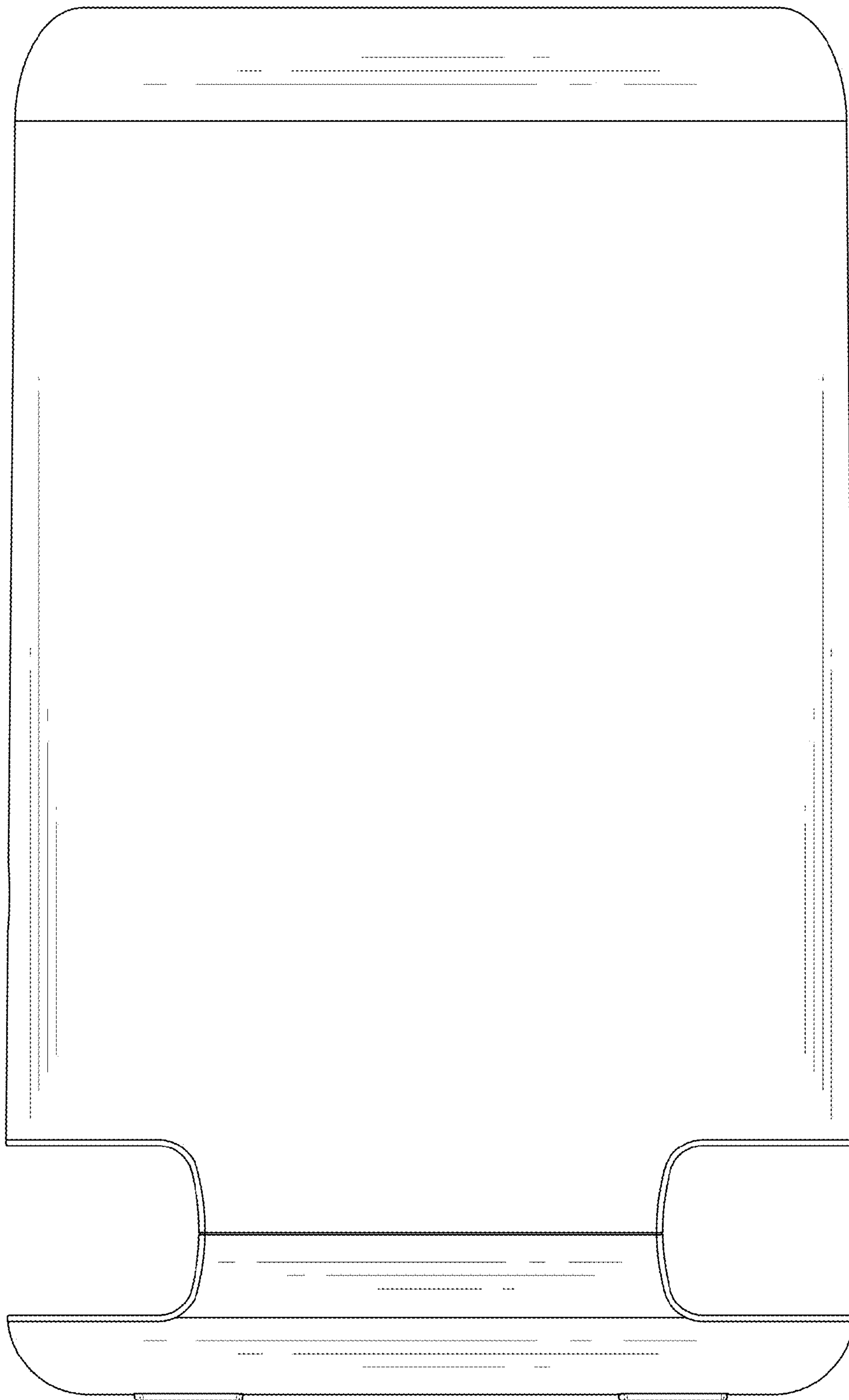

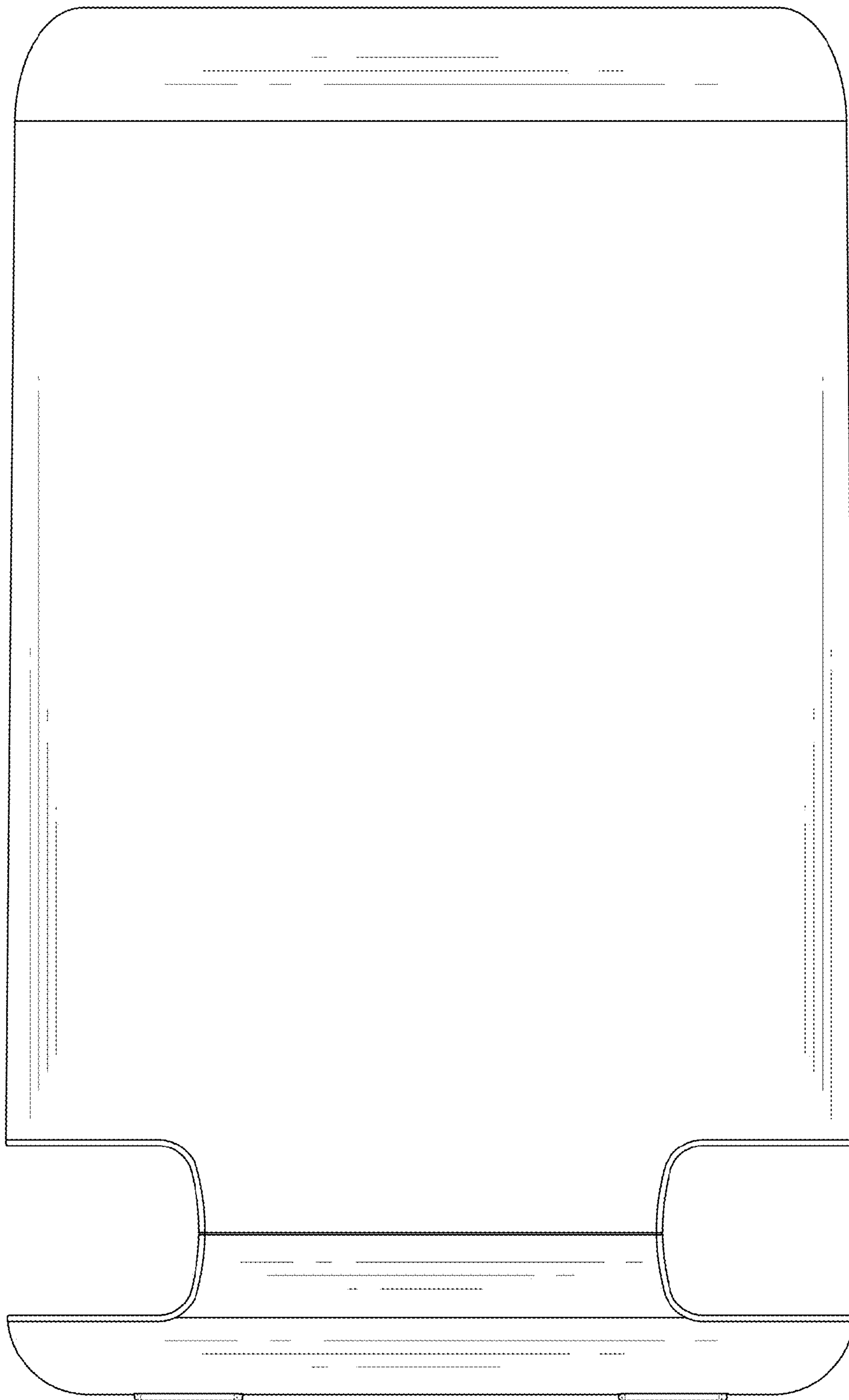

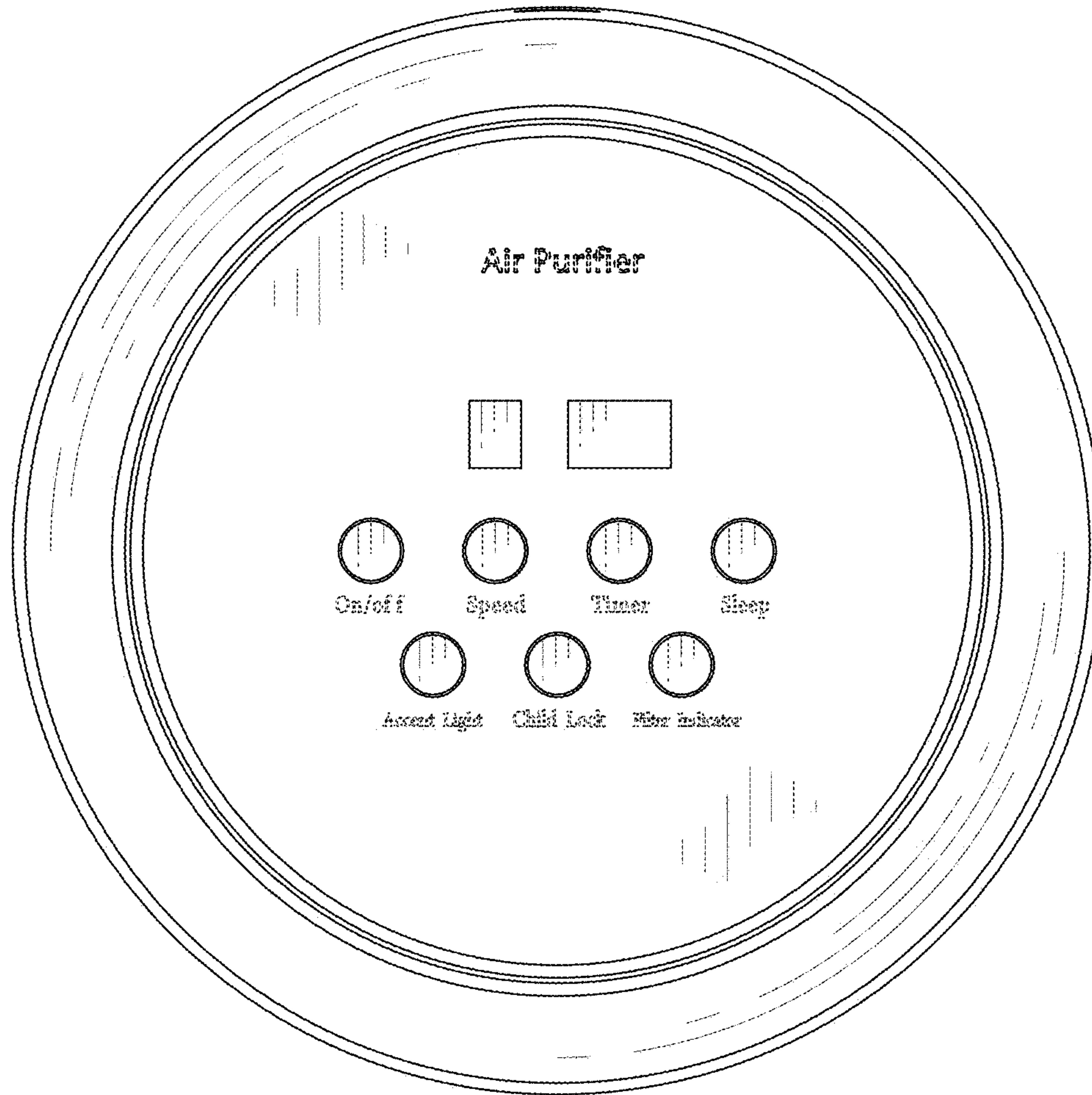

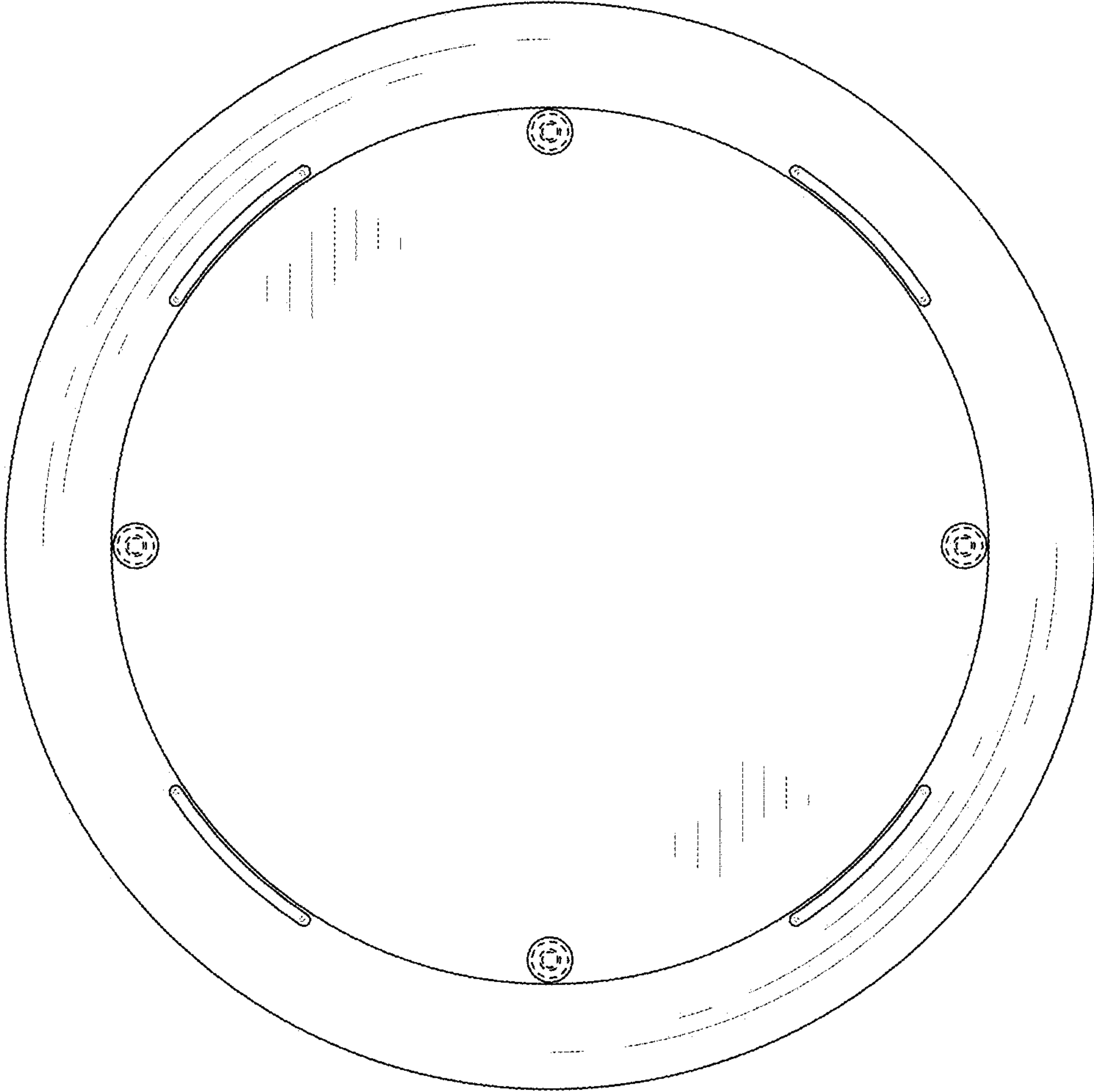

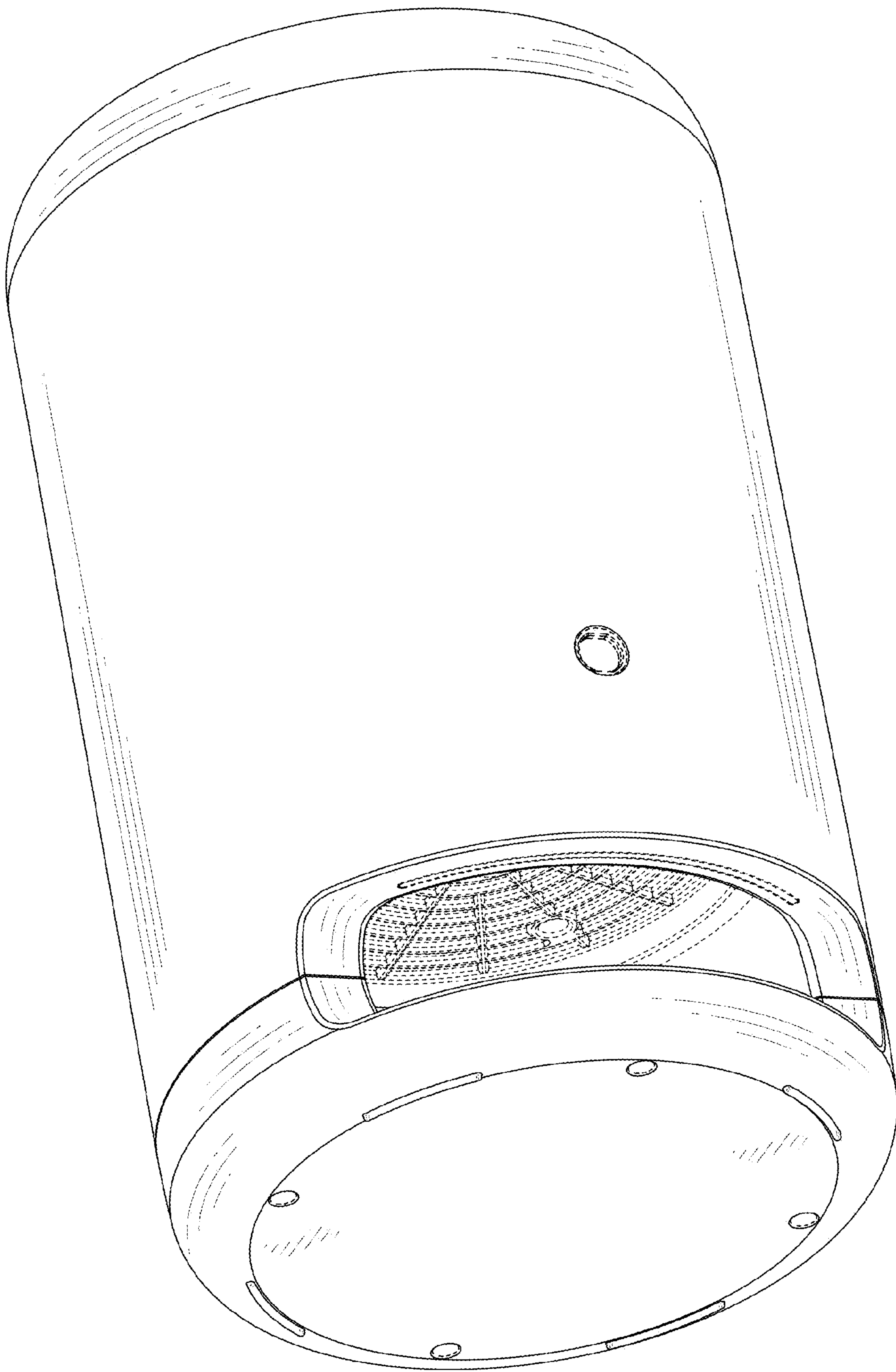
