(57) **CLAIM**

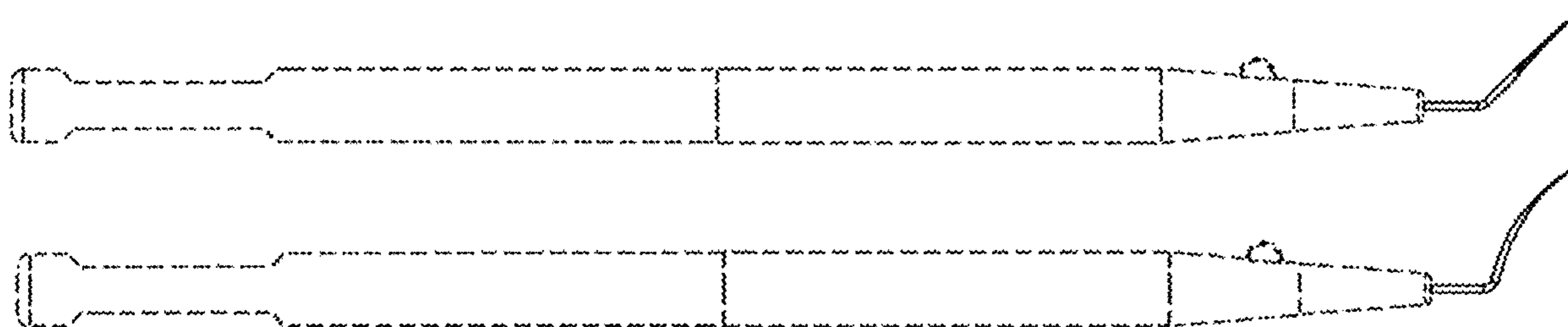
The ornamental design for a knife for surgical purposes, as shown and described.

**DESCRIPTION**

  - 1.6 : Enlarged left view
  - 1.7 : Enlarged right view

  - 2.3 : Bottom
  - 2.4 : Left
  - 2.5 : Right
  - 2.6 : Enlarged left view
  - 2.7 : Enlarged right view

Designs 1 and 2: broken lines form no part of the claimed designs; rear views are omitted because they are symmetrical to the front views of each design; the knife of each design has the blade bent at a desired angle with respect to the axial direction of the handle thereof; the tip of the blade of design 1 is gently curved so as to match the shape of an eyeball; the blade of design 2 is gently curved as a whole so as to match the shape of an eyeball.

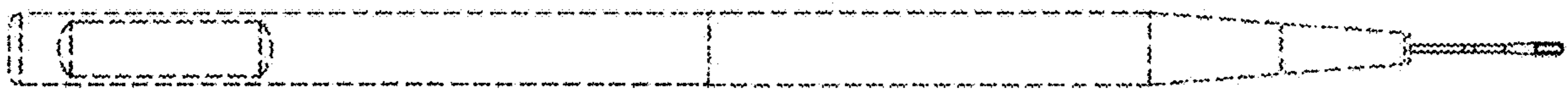

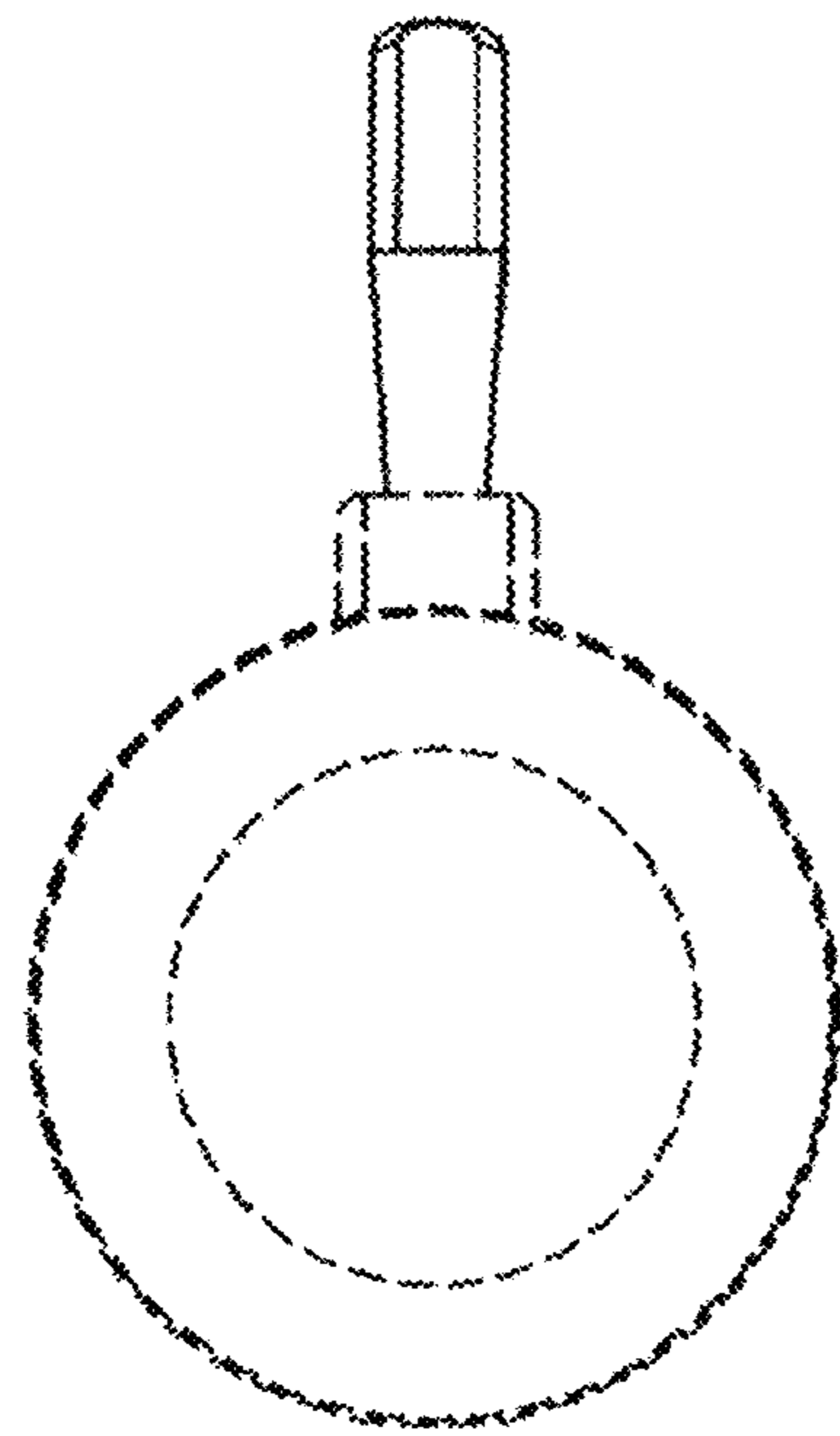

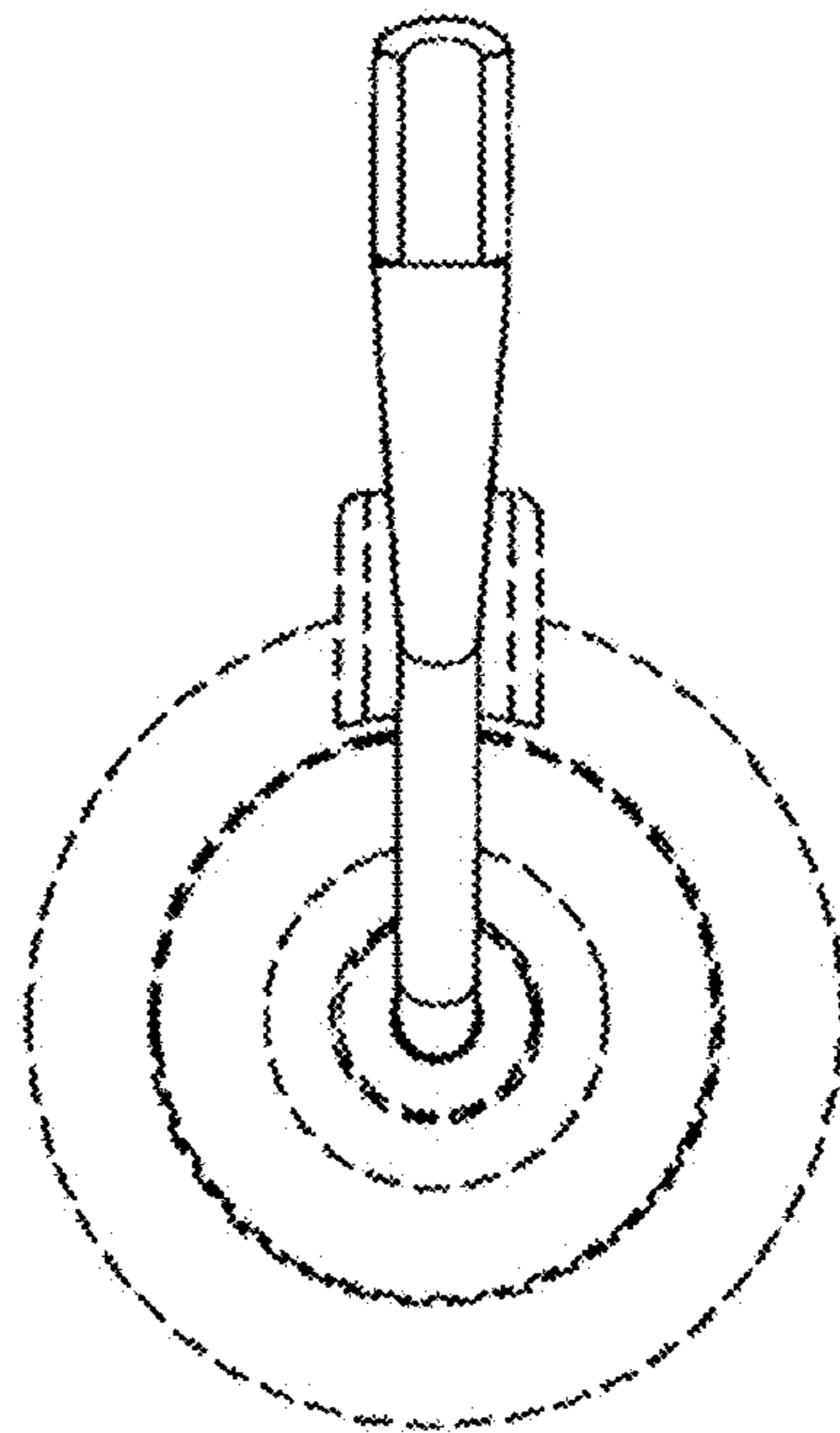

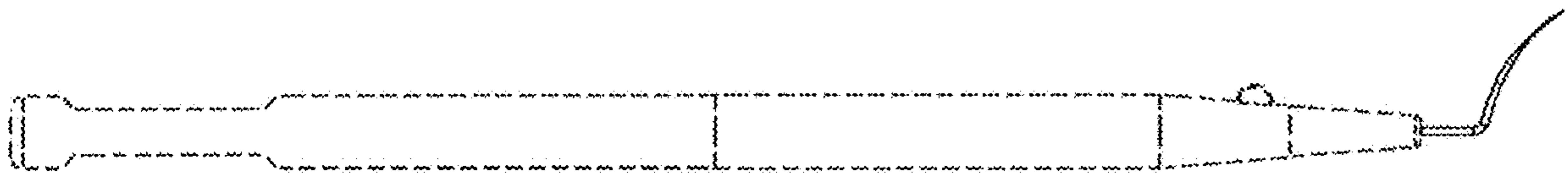

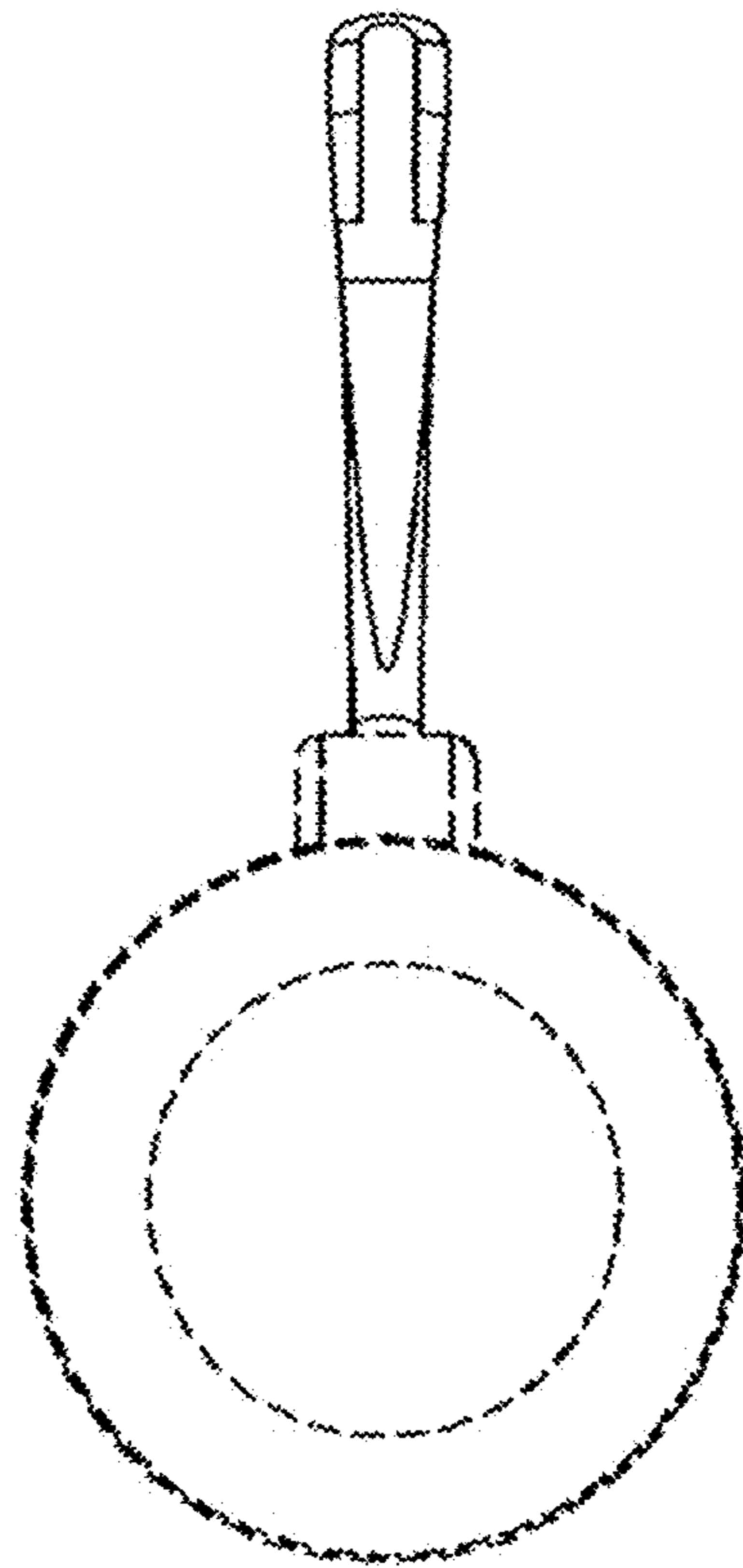
