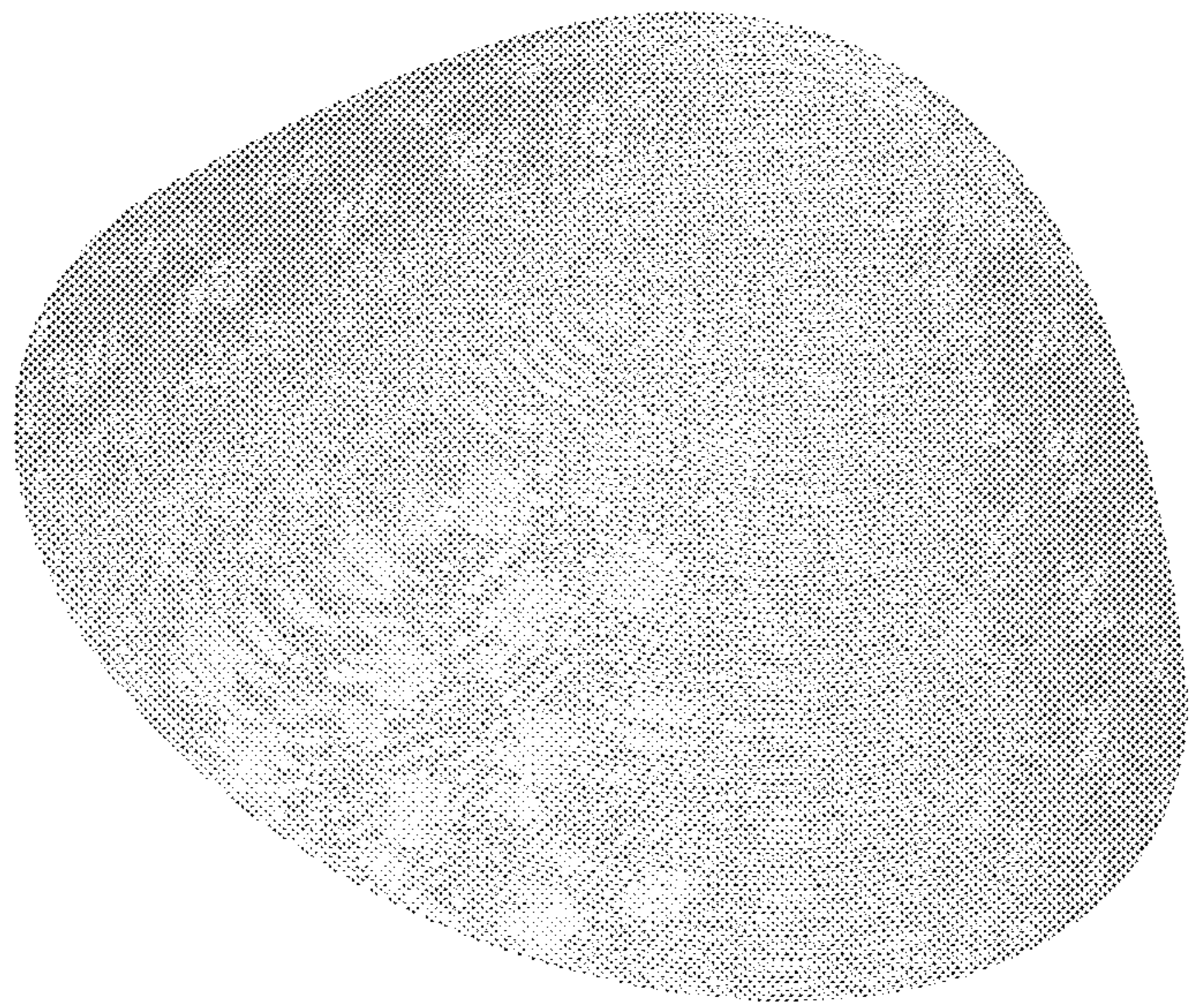

We claim the ornamental design for a chest implant, as shown and described.

DESCRIPTION

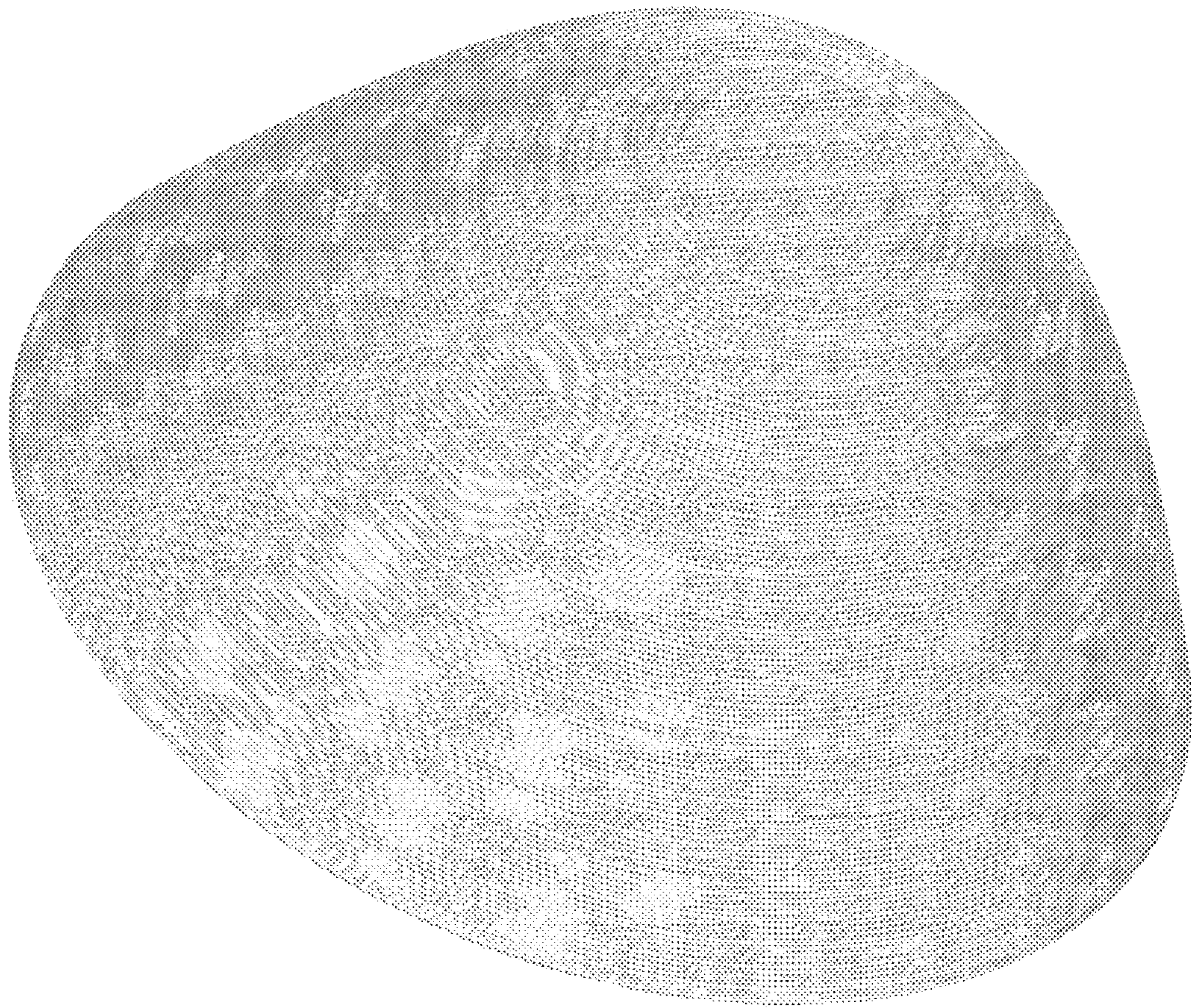

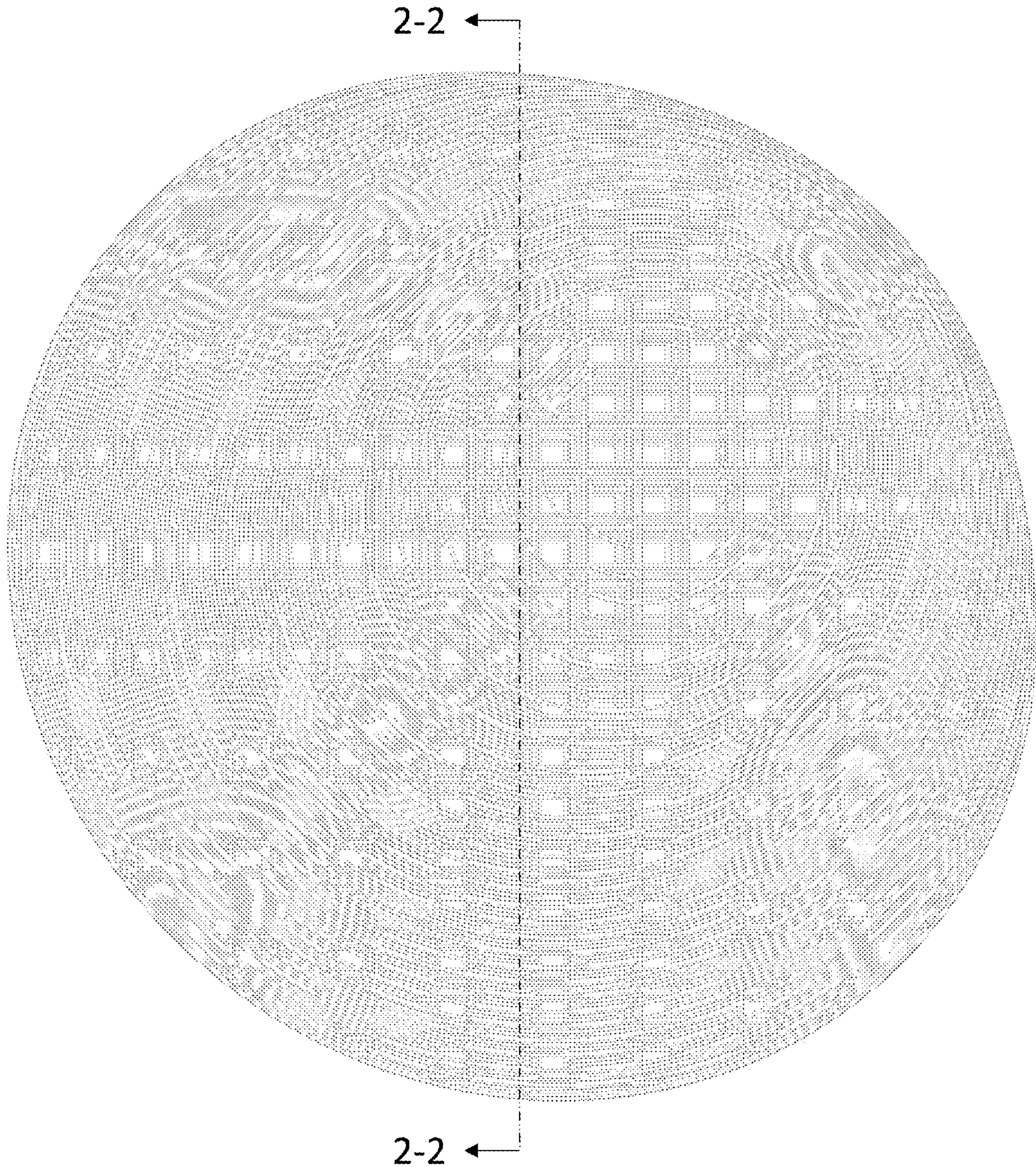

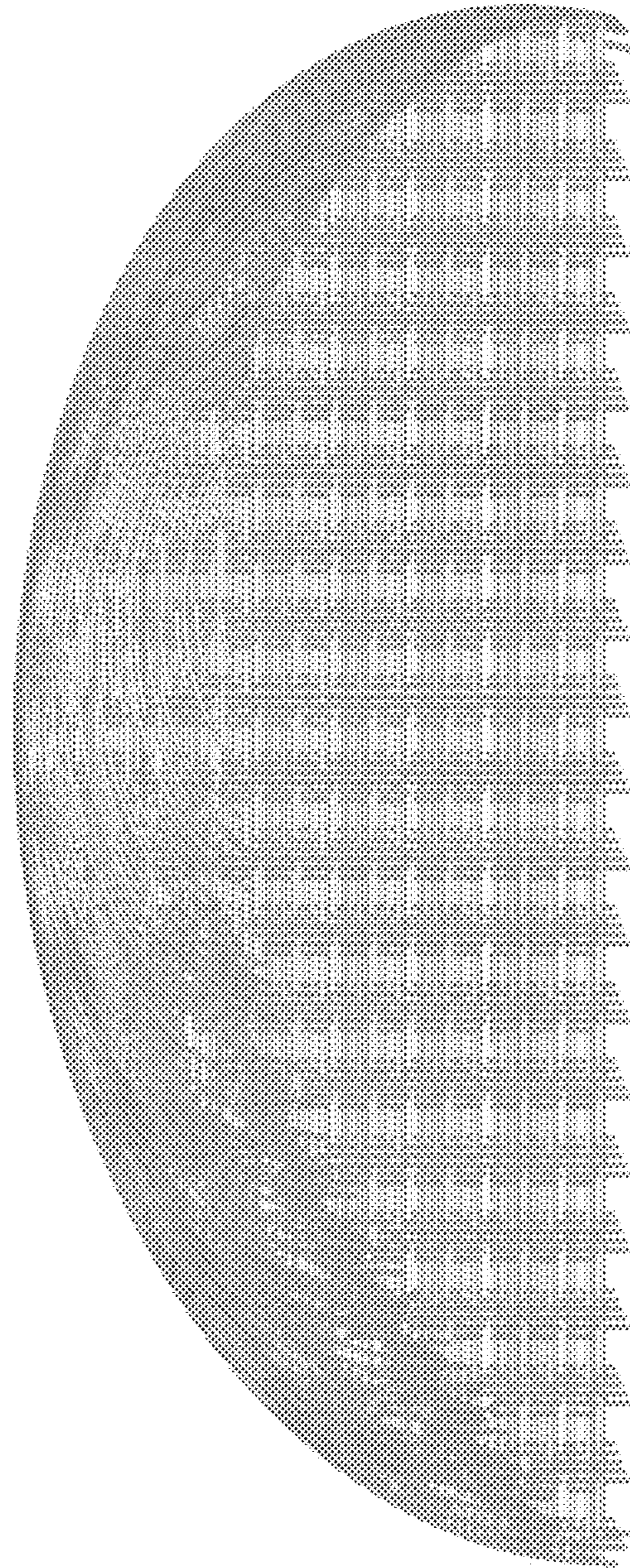

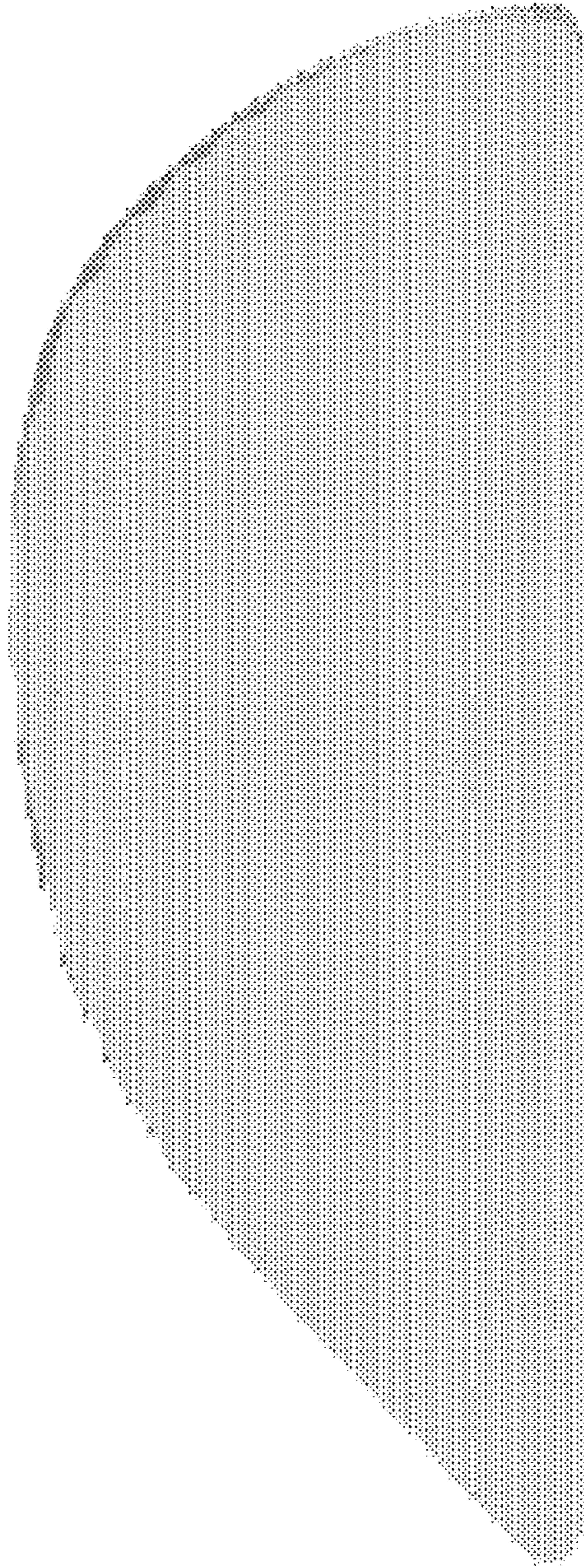

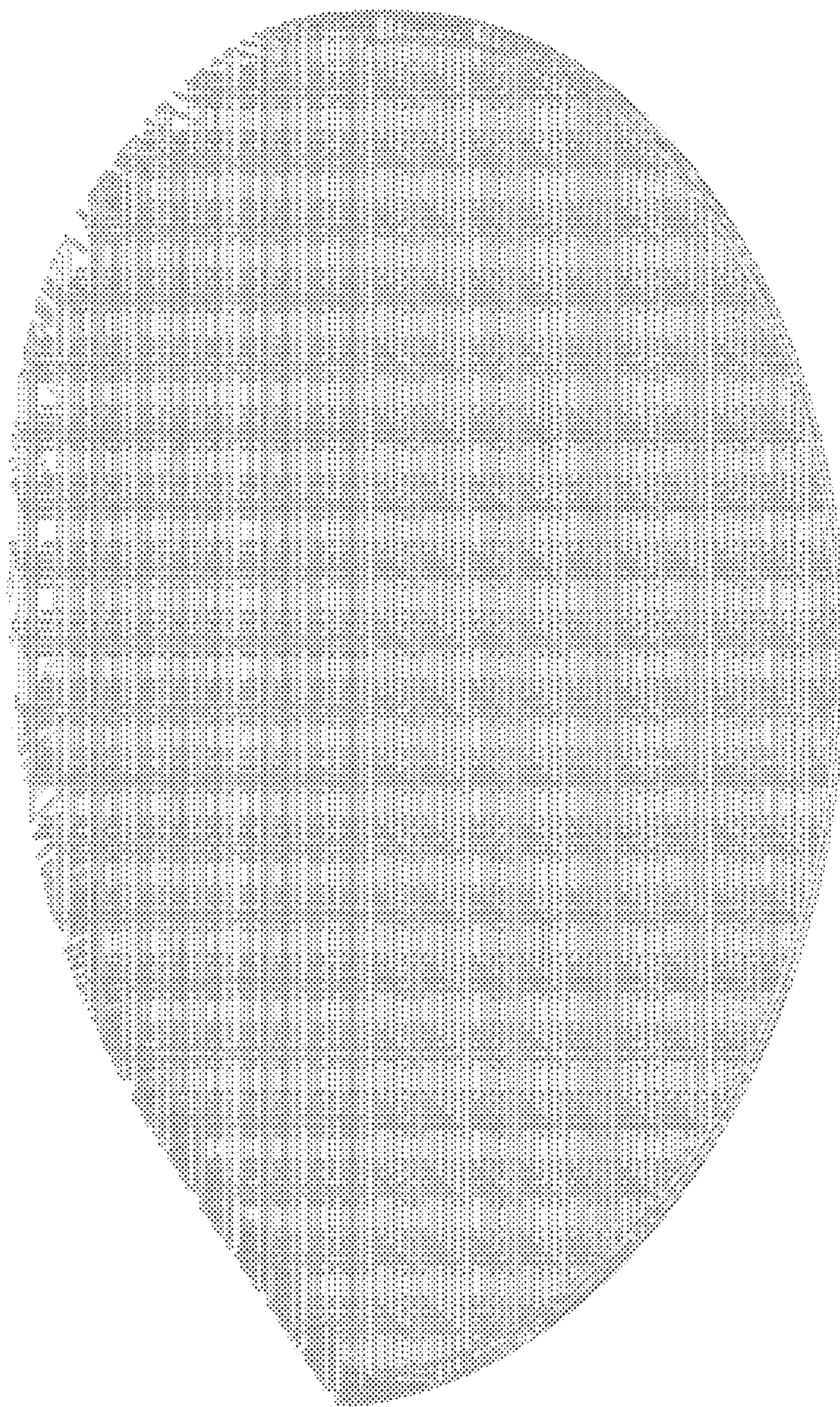

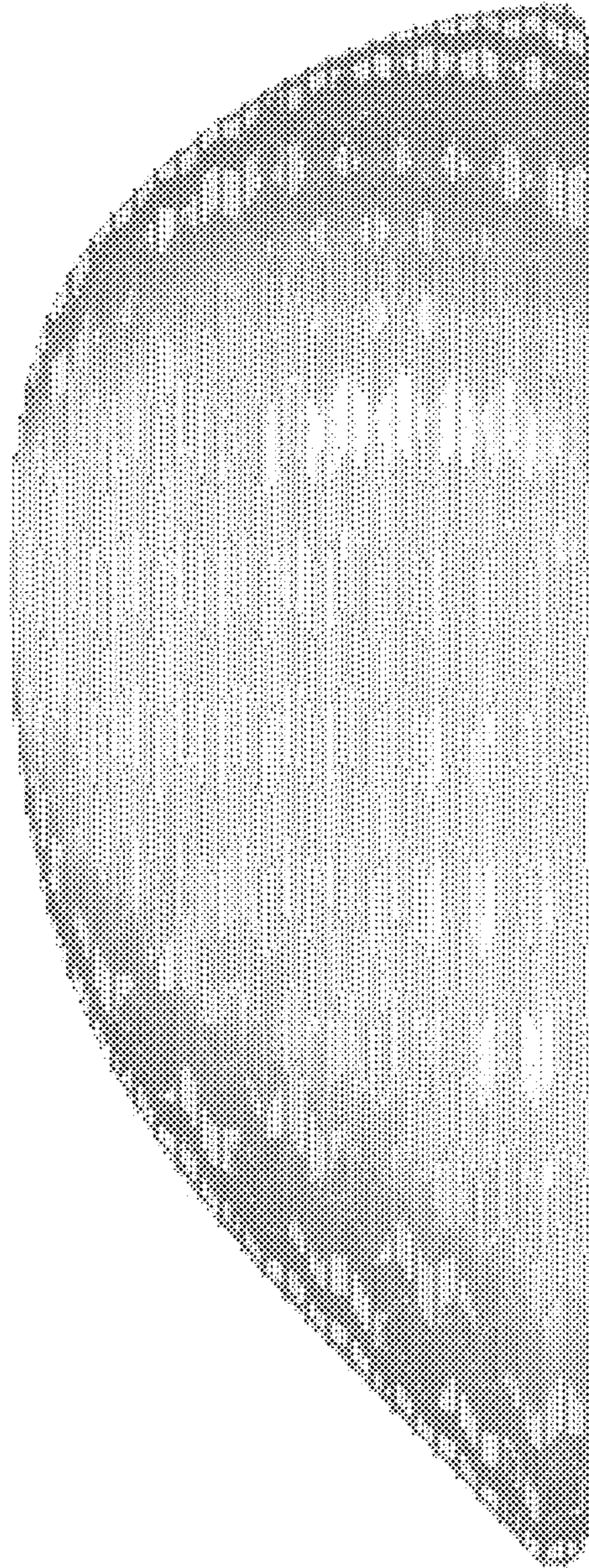

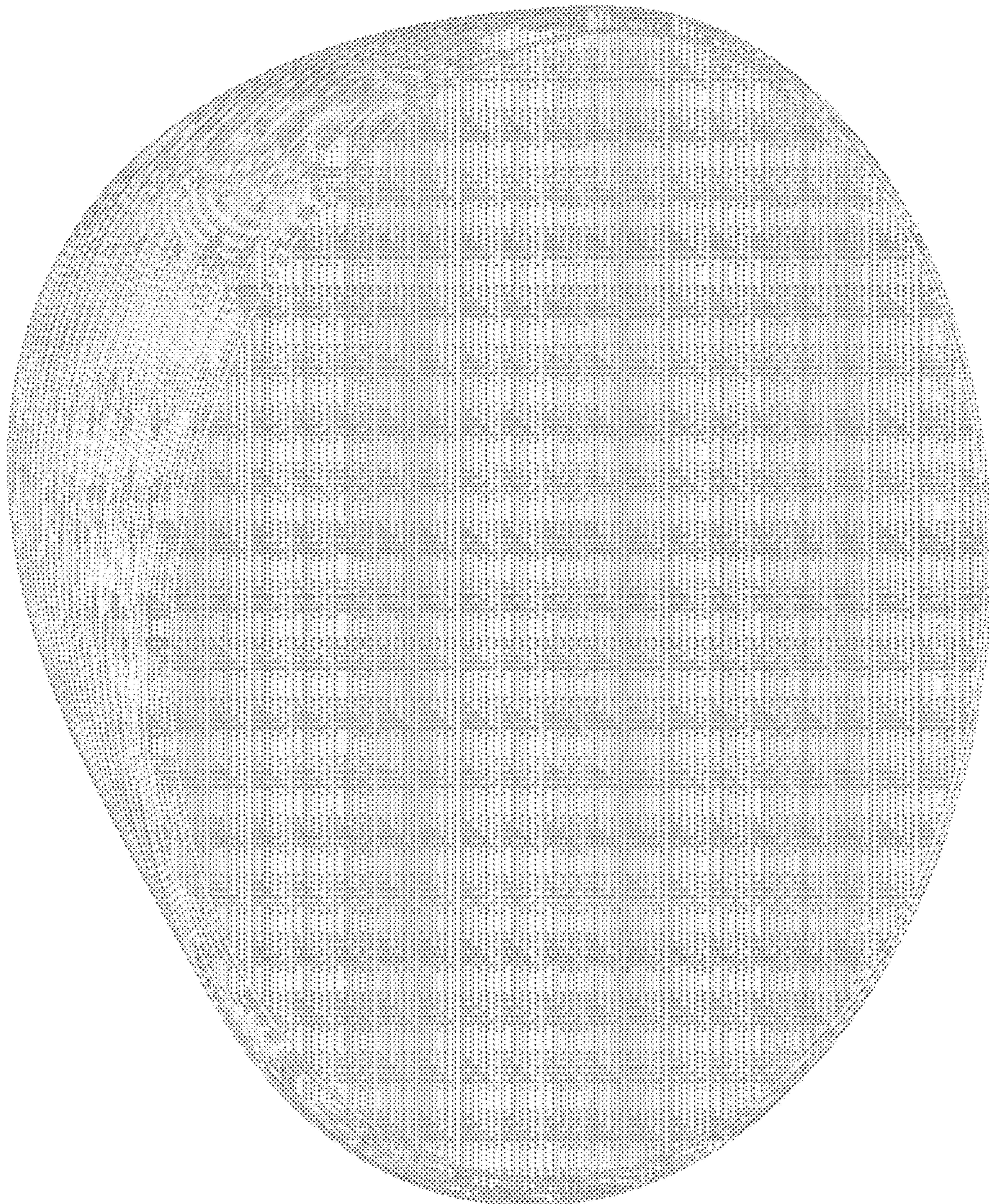

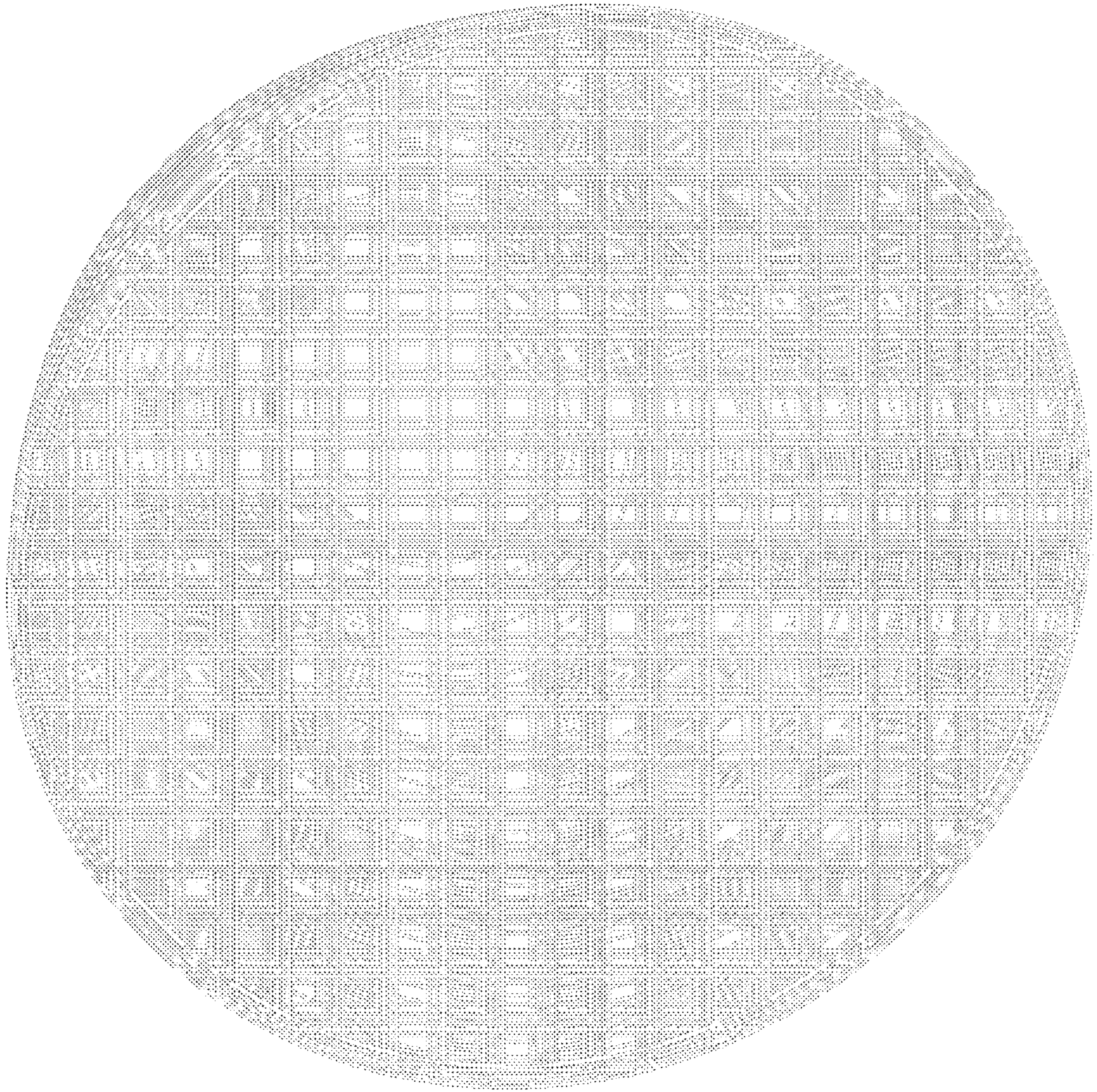

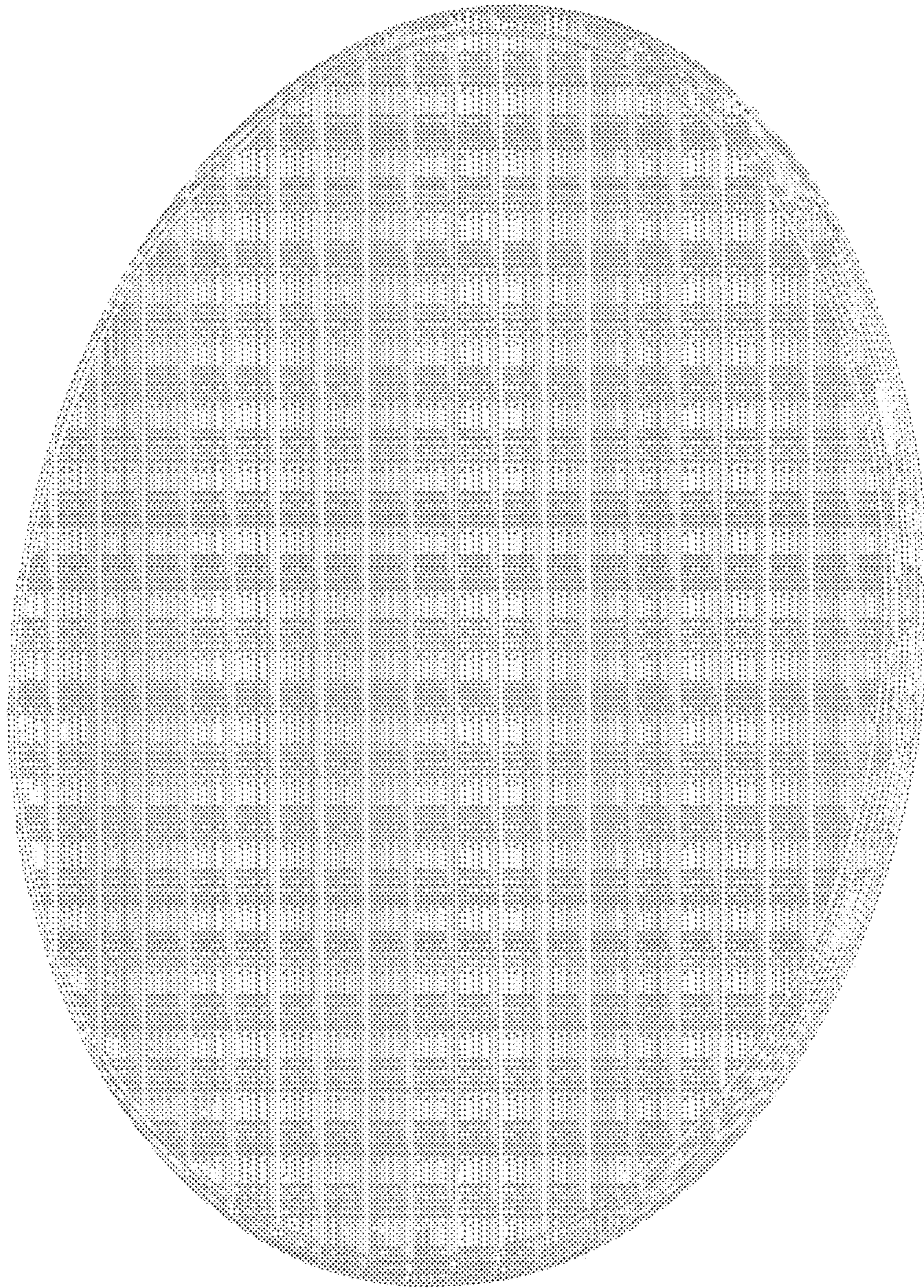

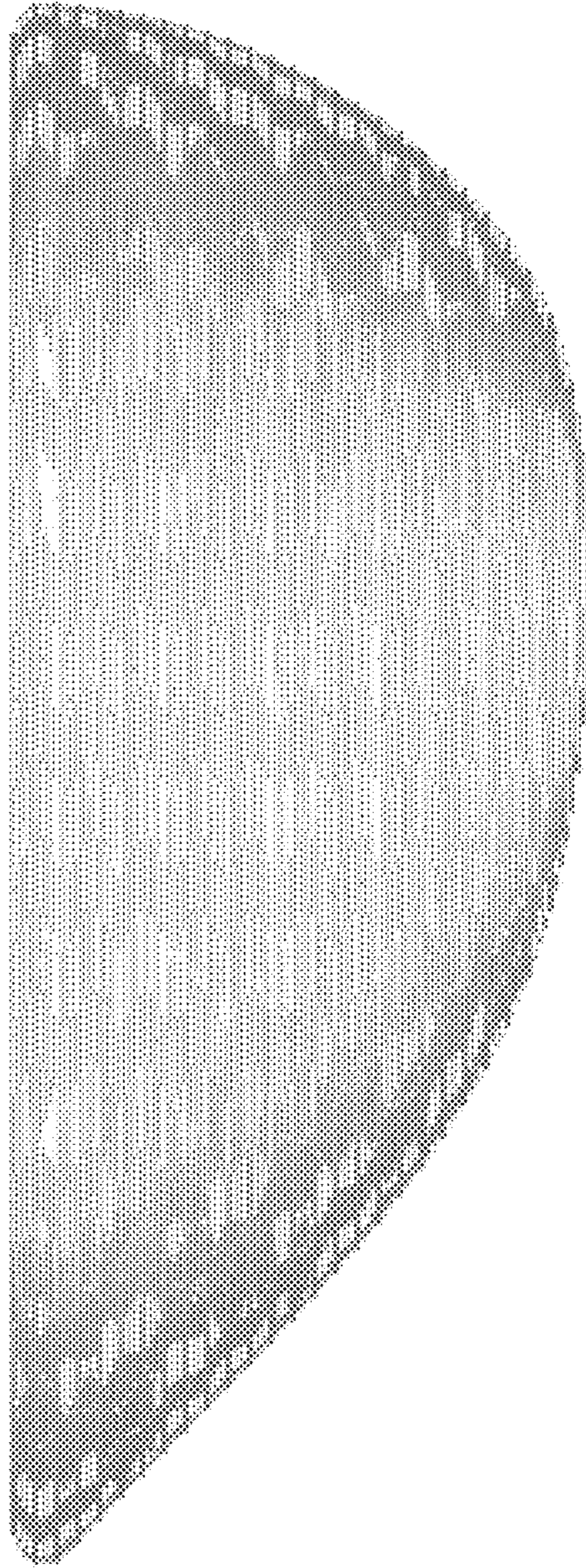

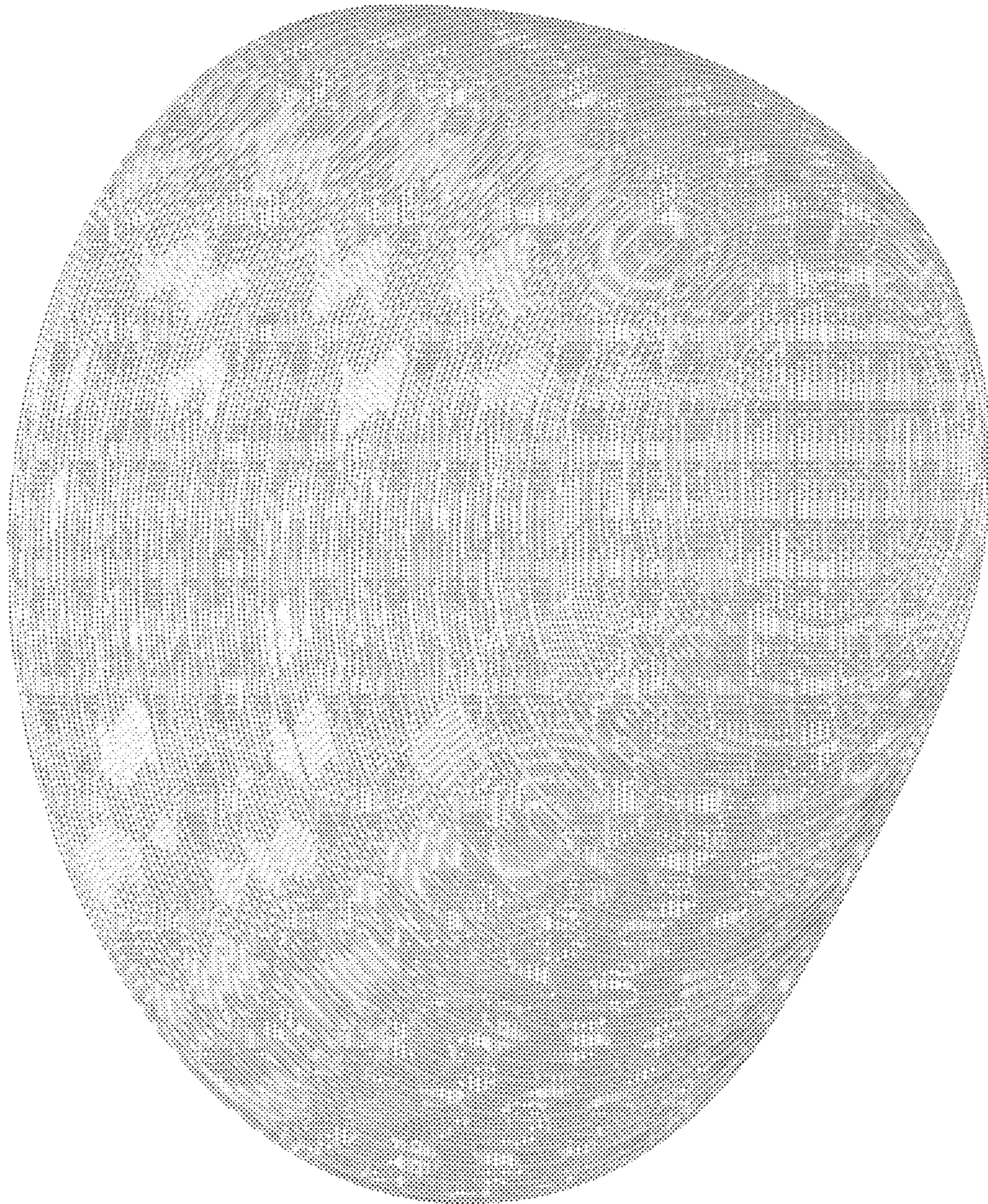

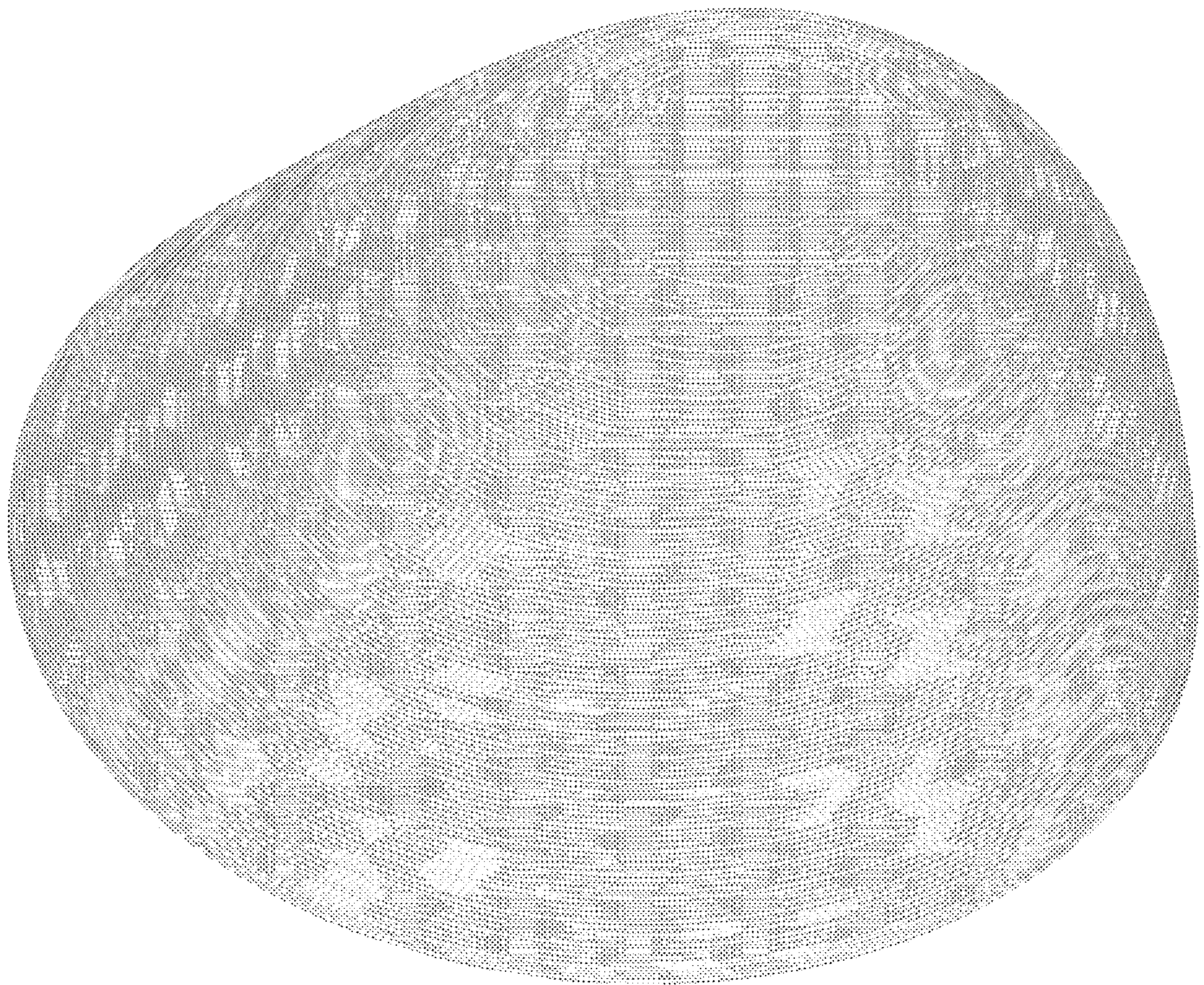

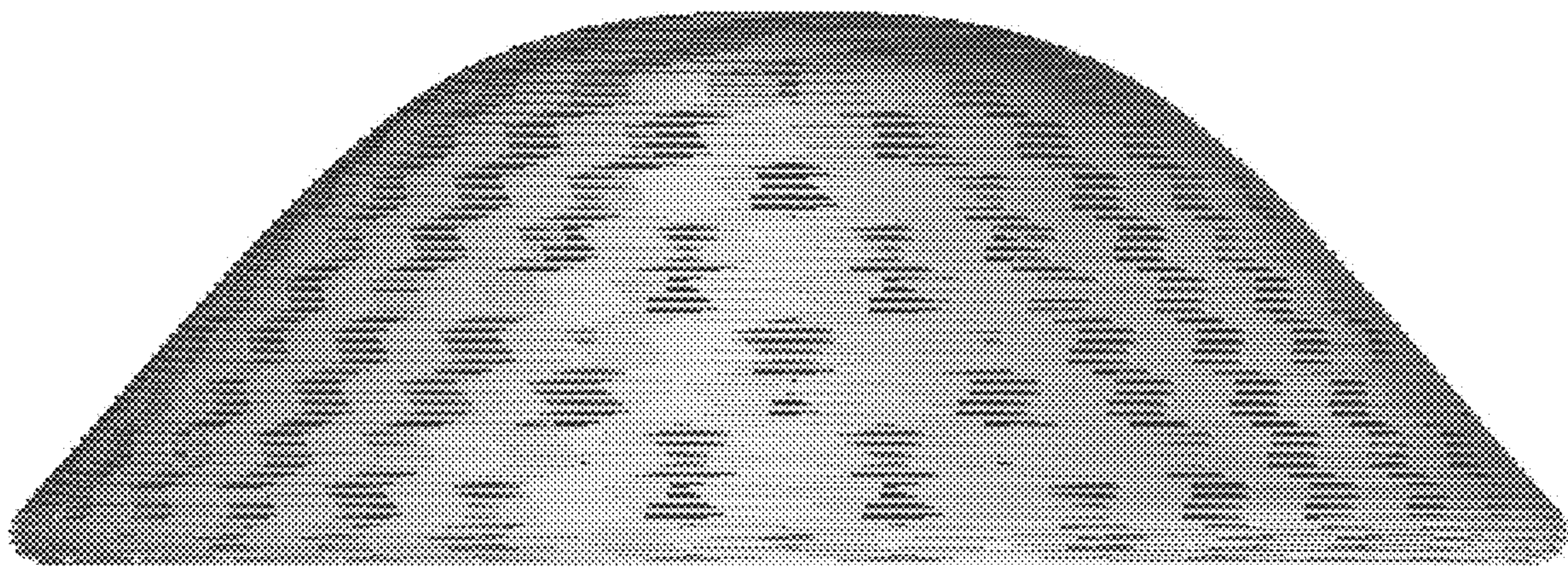

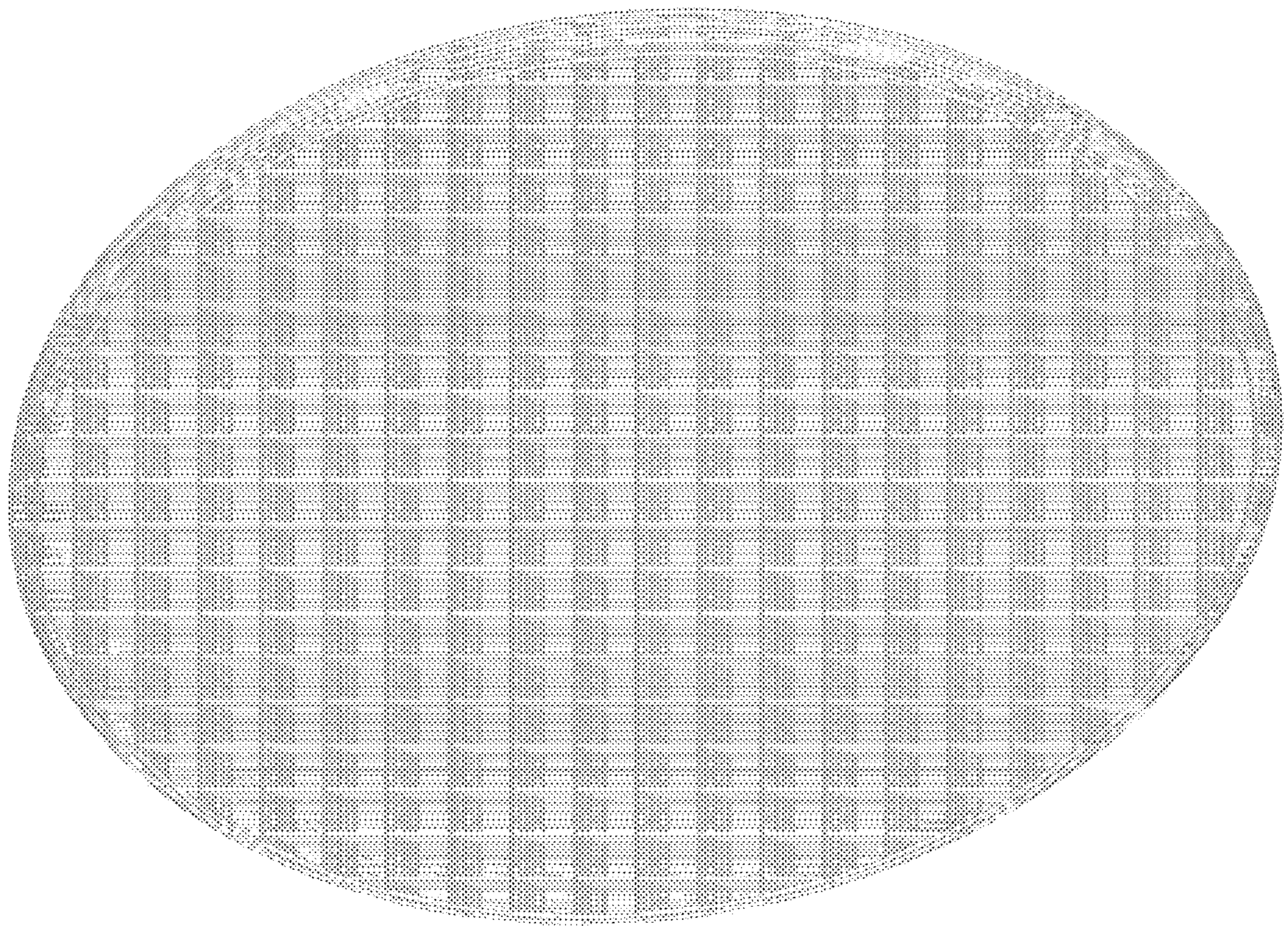

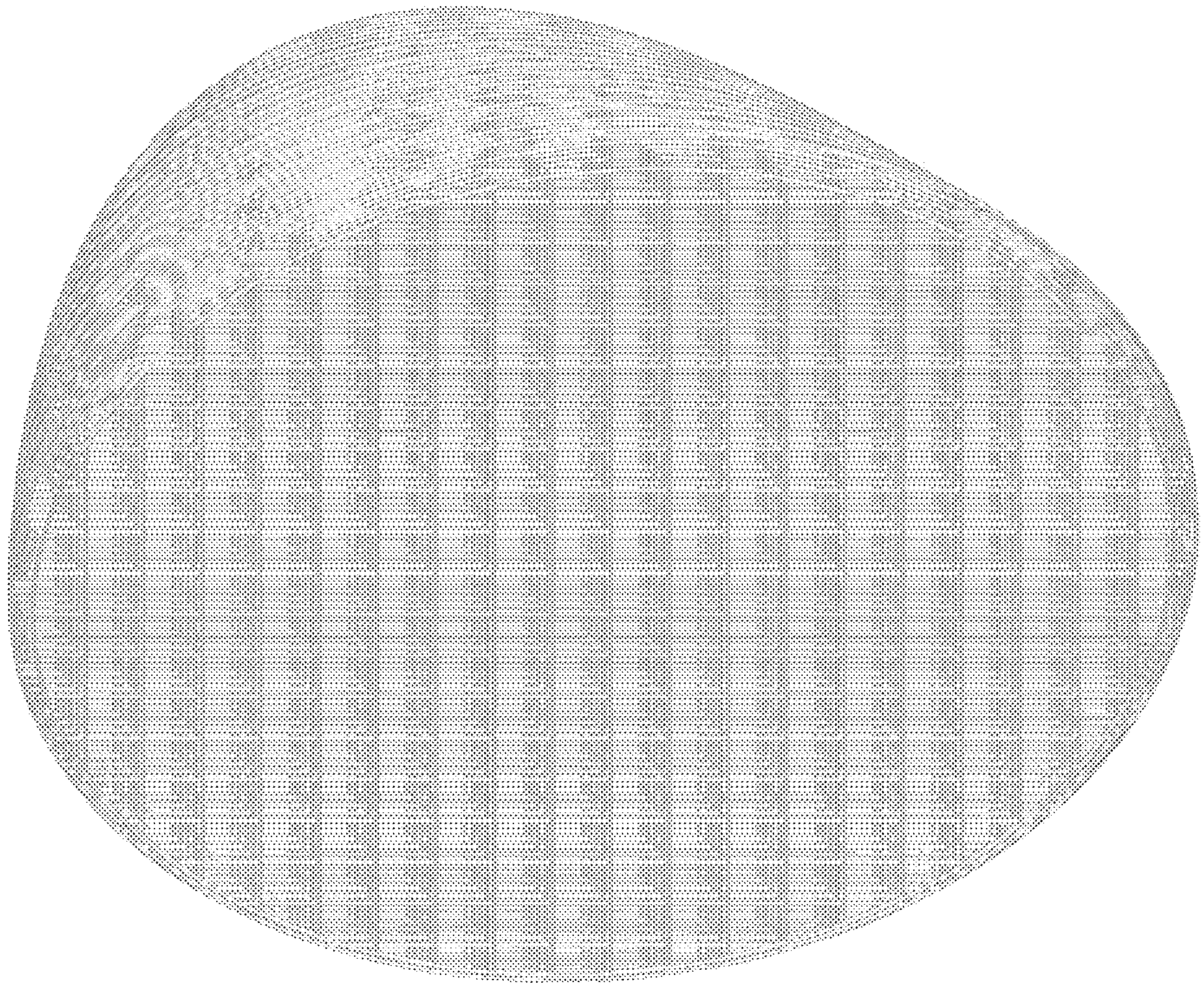

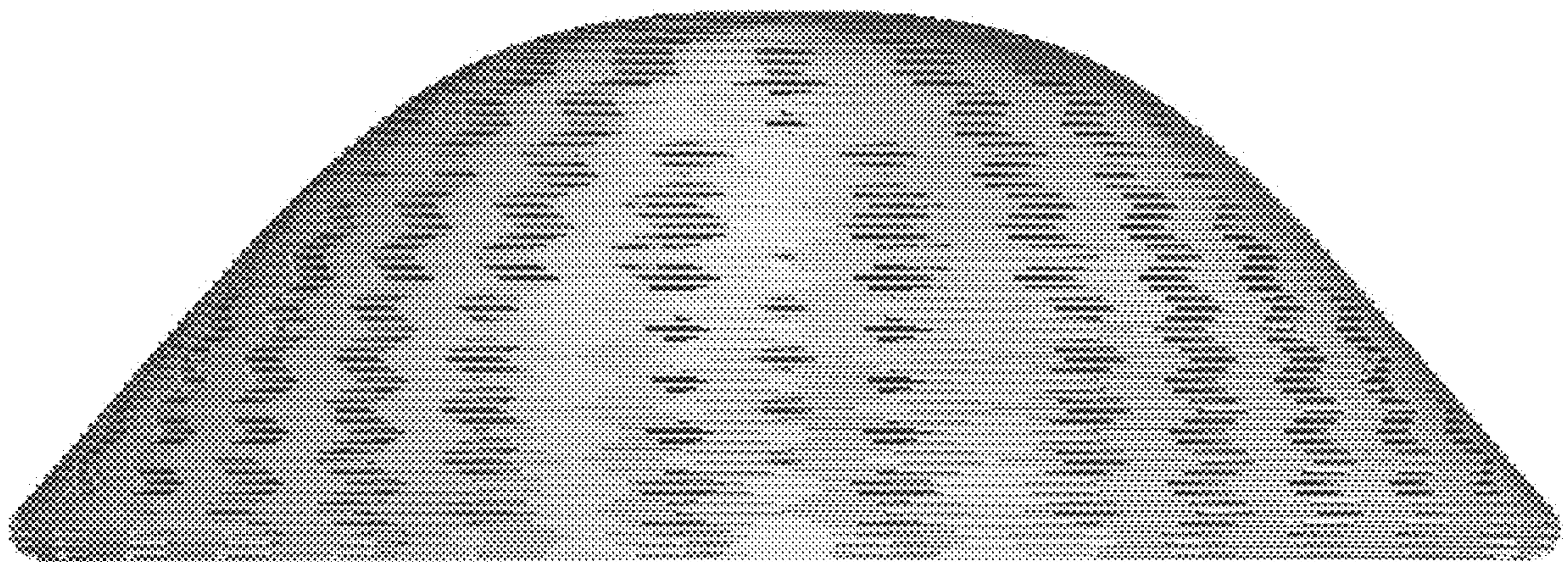

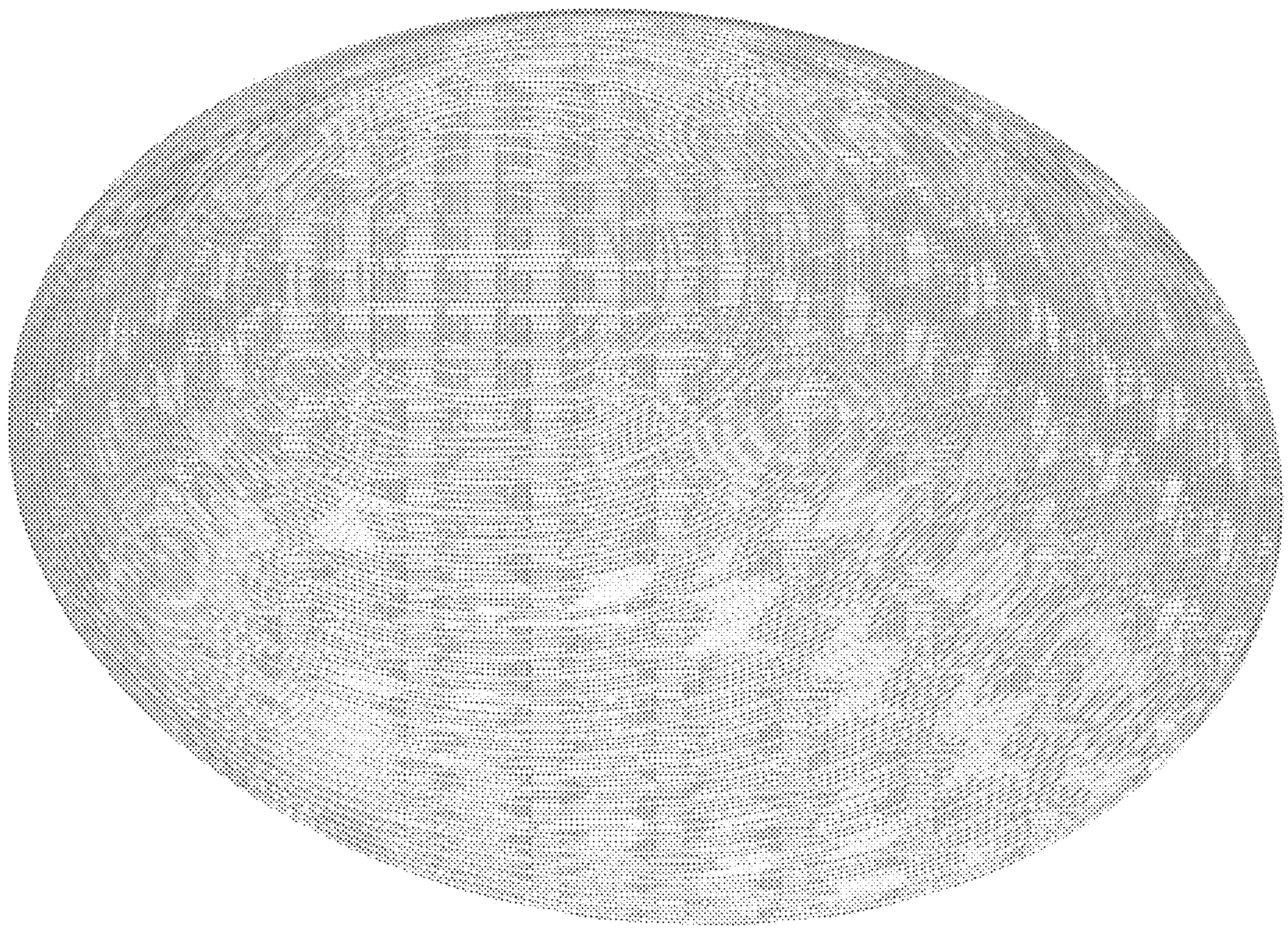

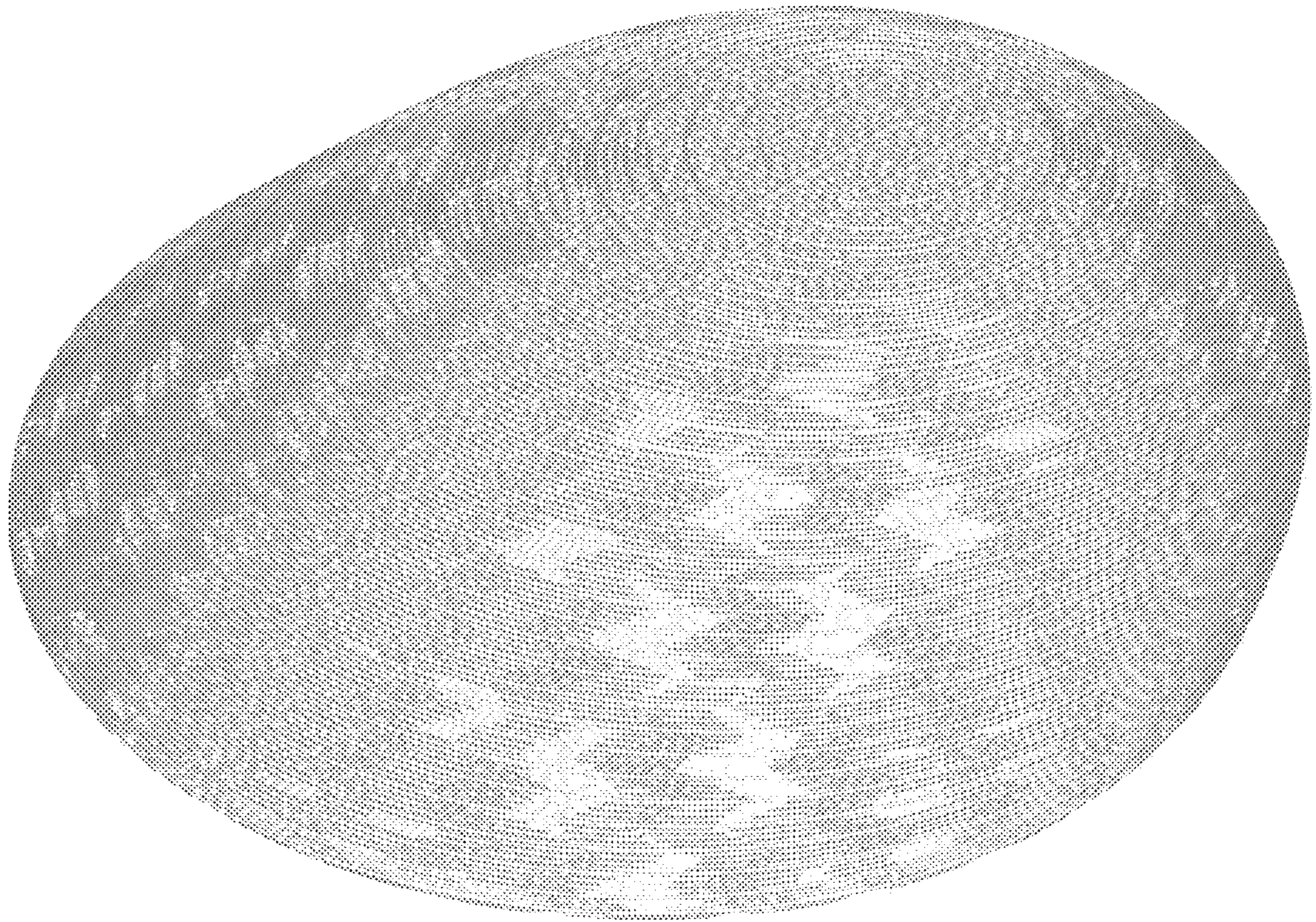

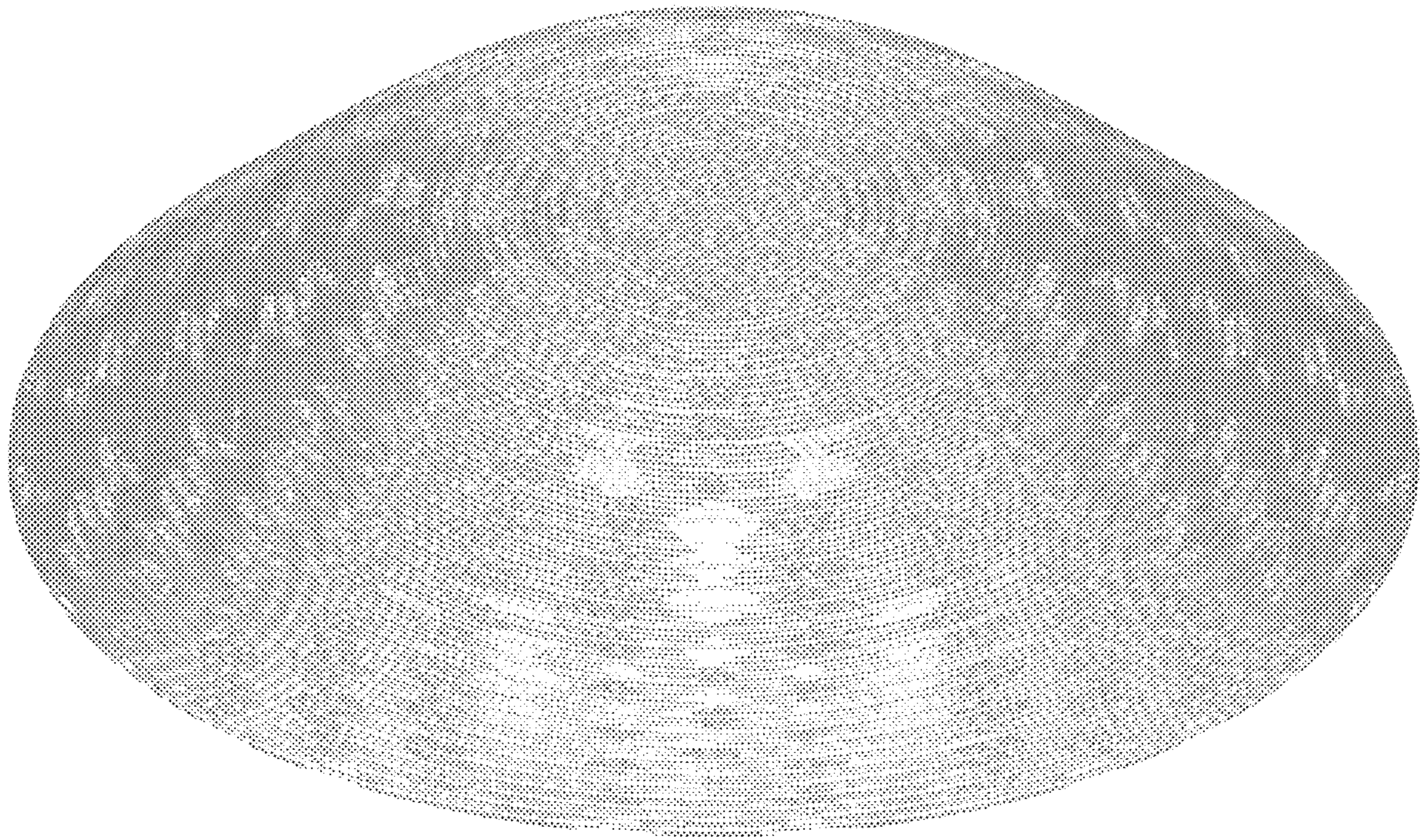

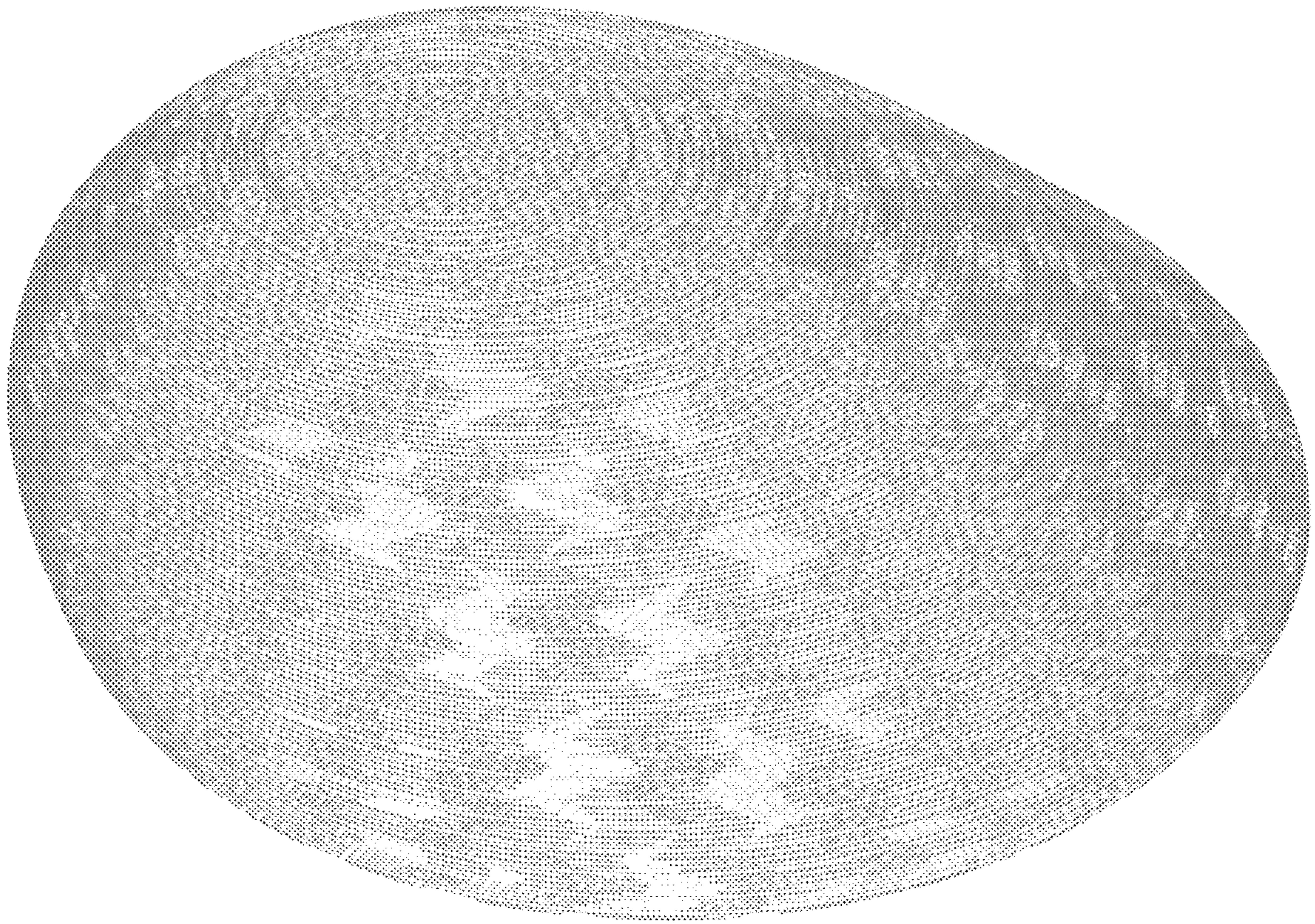

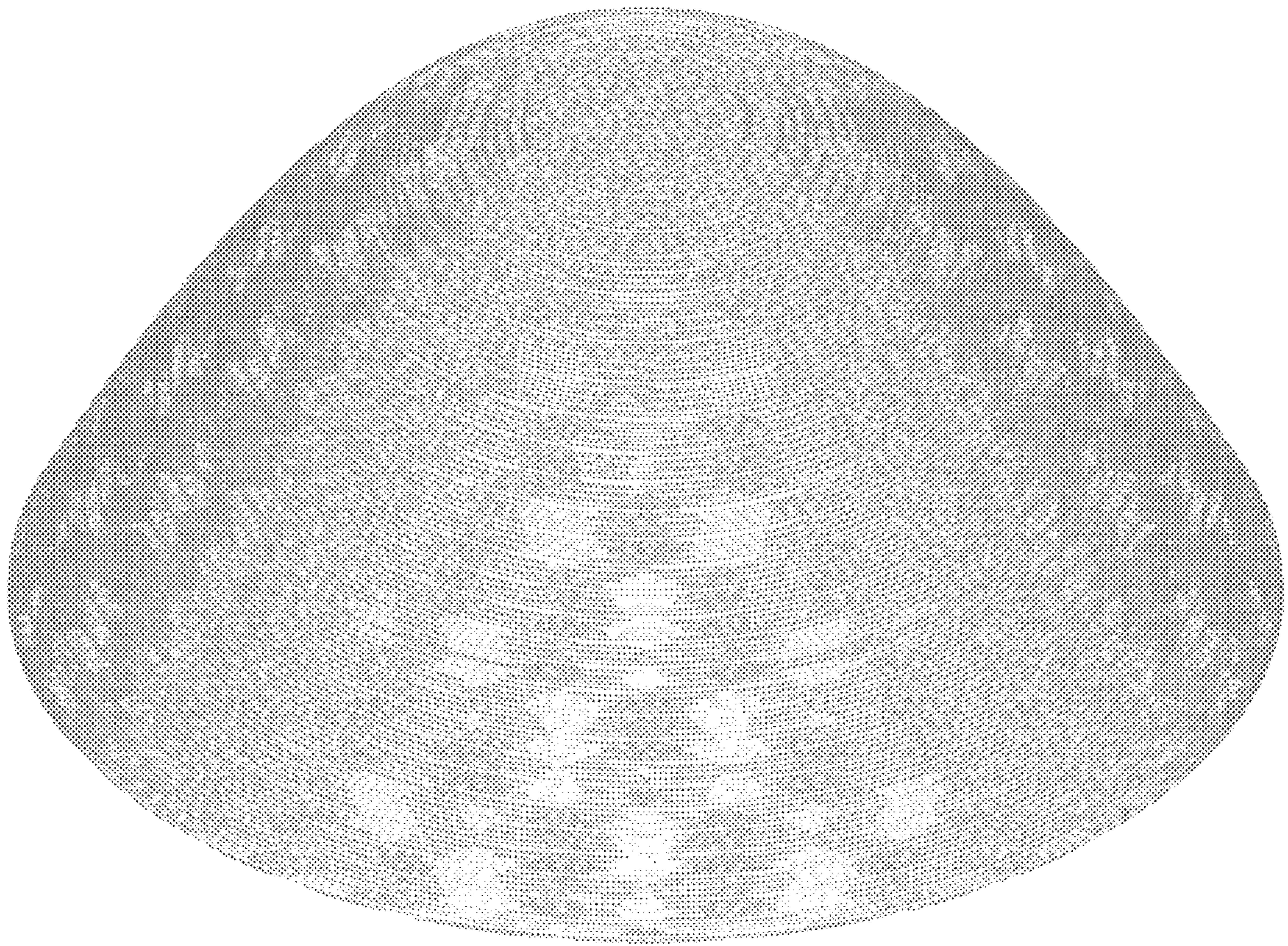

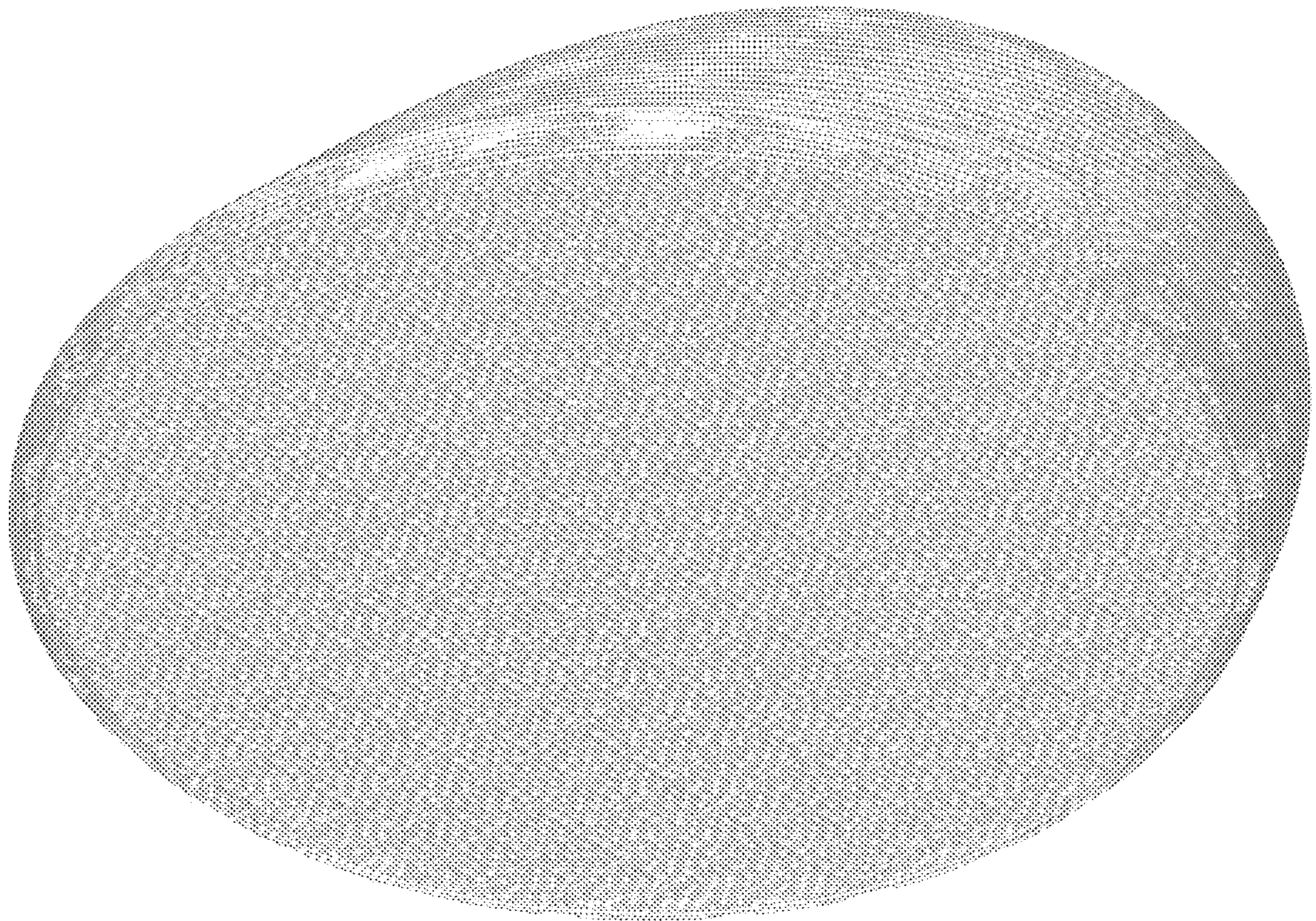

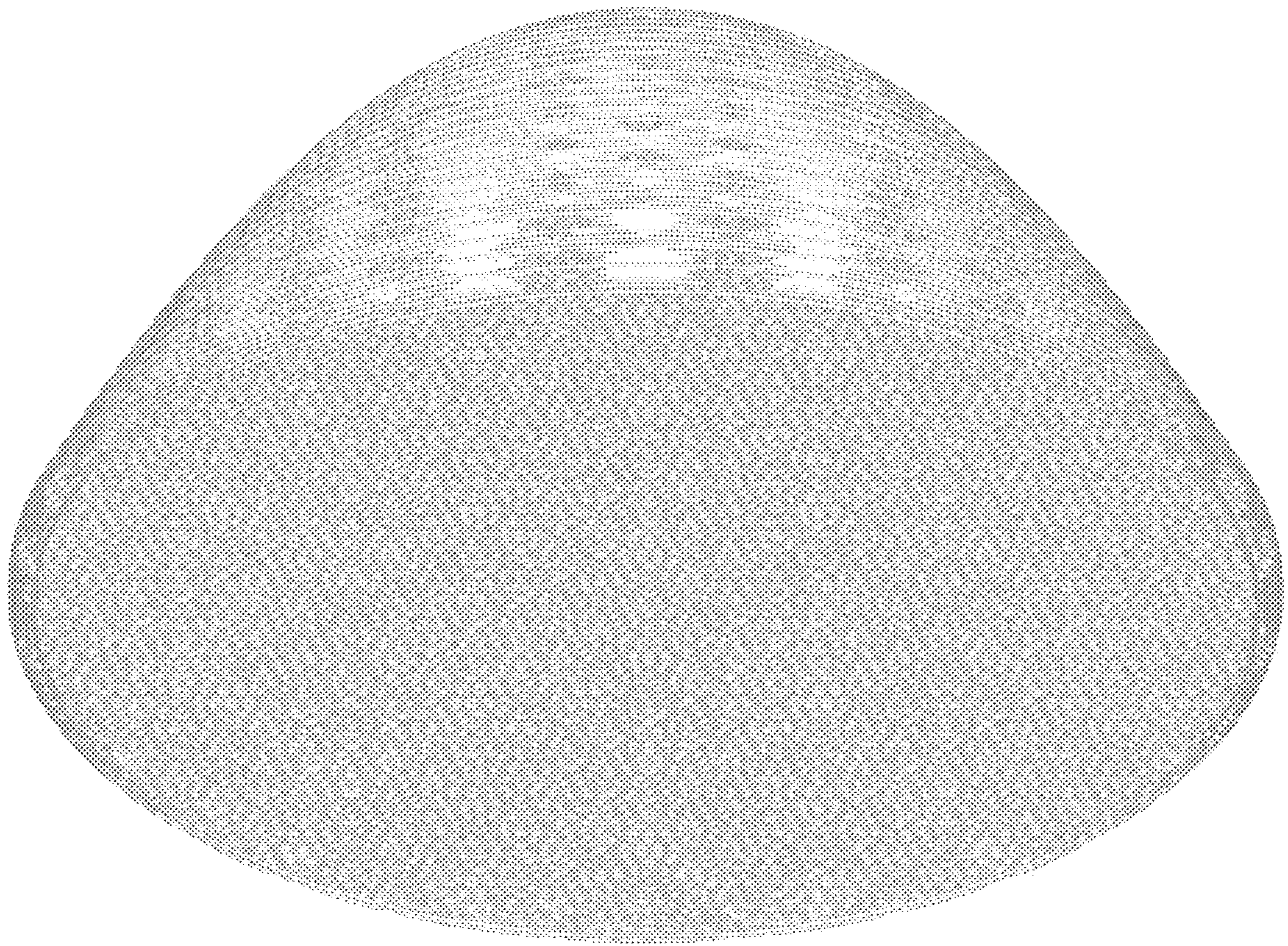

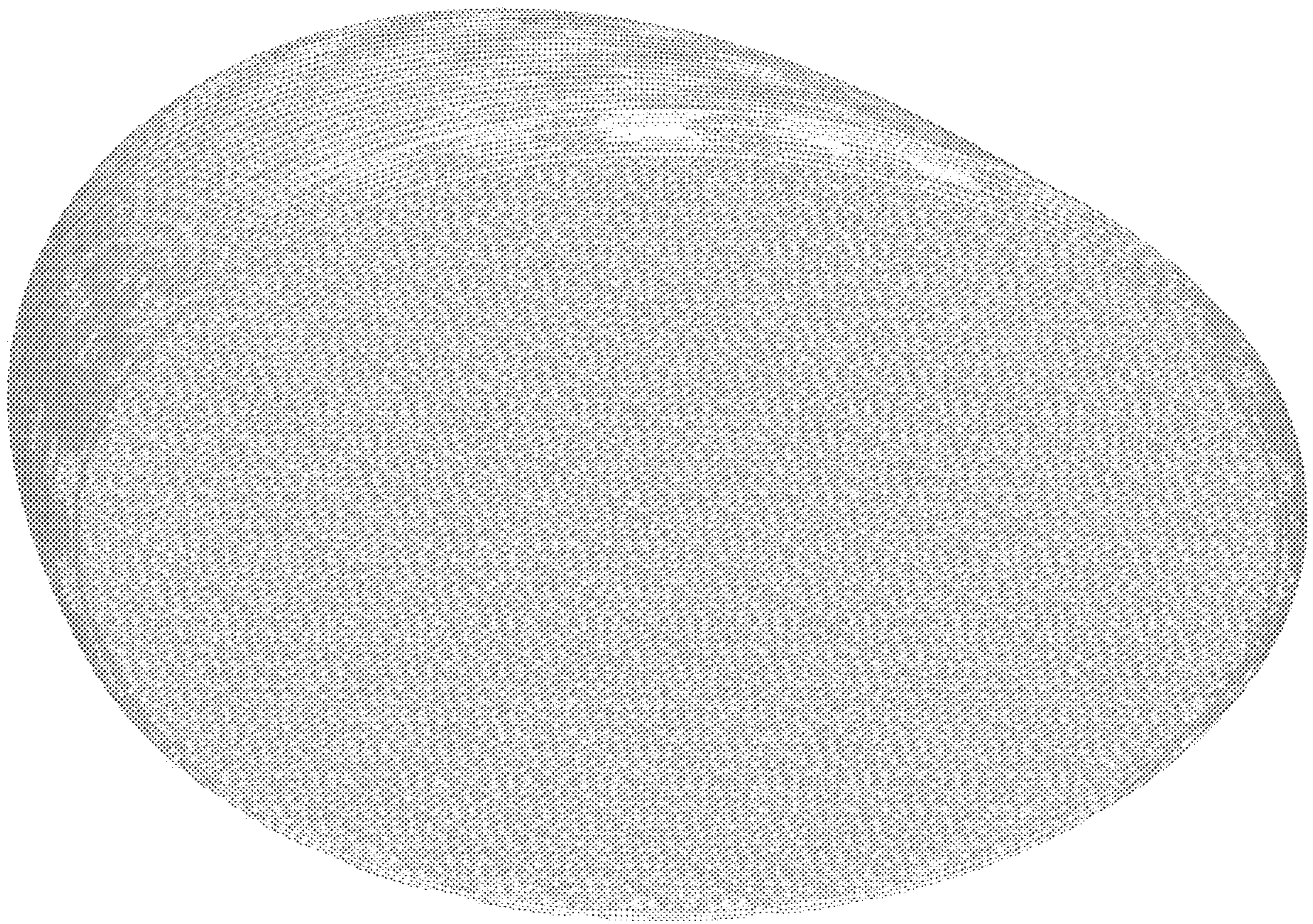

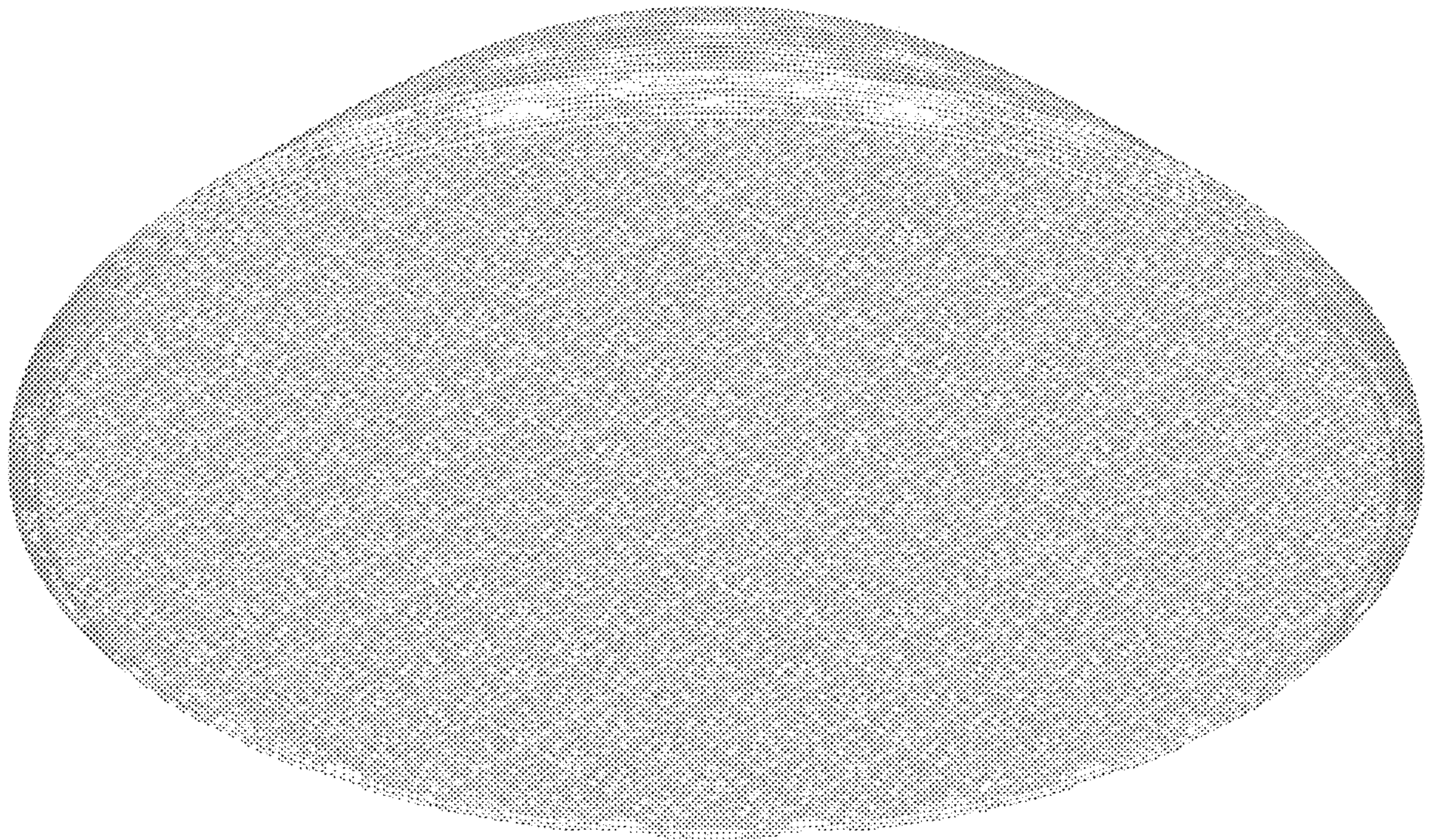
