DESCRIPTION

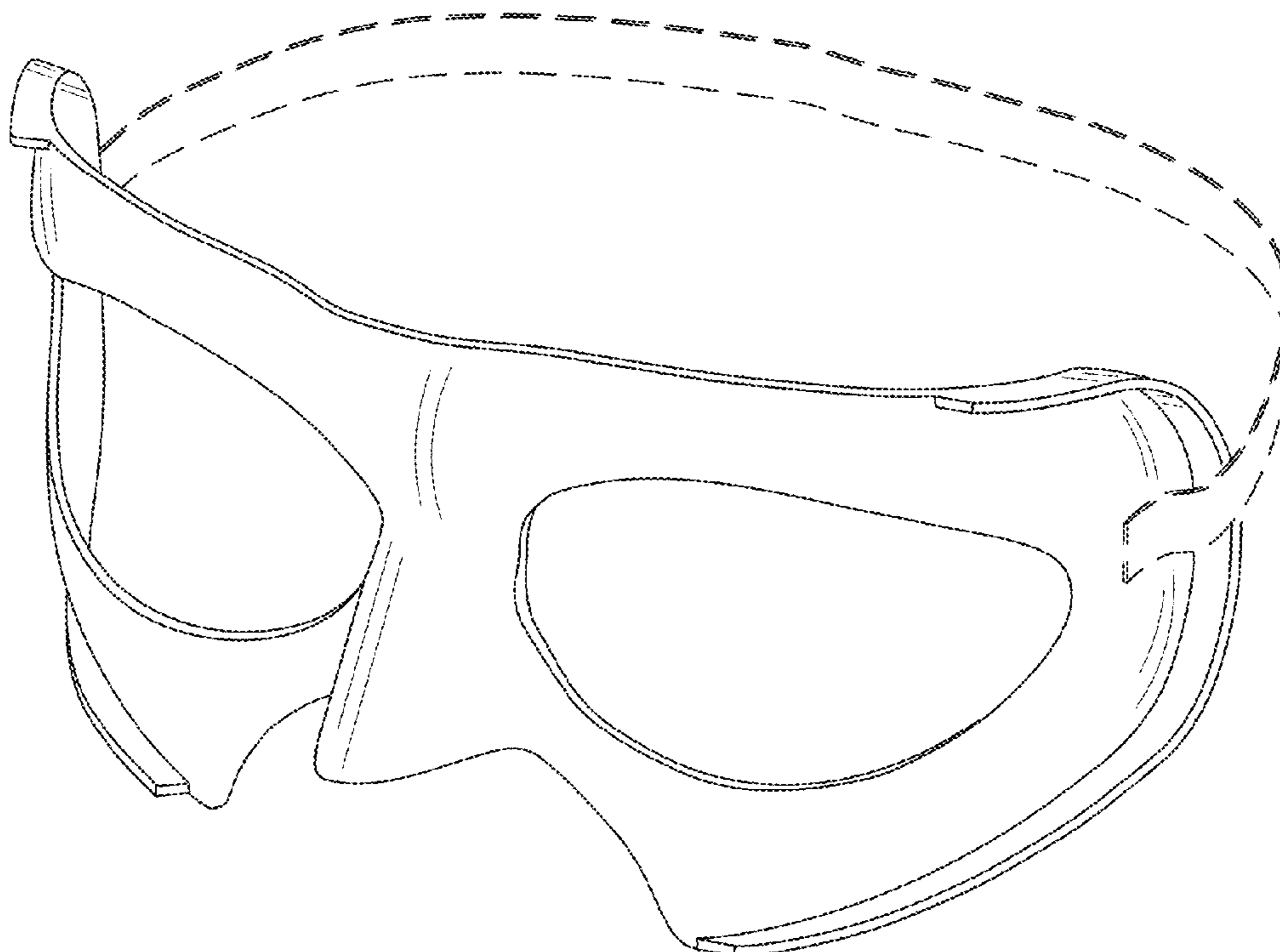
FIG. 1 is a front perspective view of the shaving template mask showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a left-side elevation view thereof, the right-side elevation view being a mirror image thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a rear elevation view thereof; and,
FIG. 7 is a left side elevation view shown in use.
The broken lines shown in the drawings illustrate portions of the shaving template mask that form no part of the claimed design.
The dash-dot-dash lines in the drawings illustrate a boundary that forms no part of the claimed design.

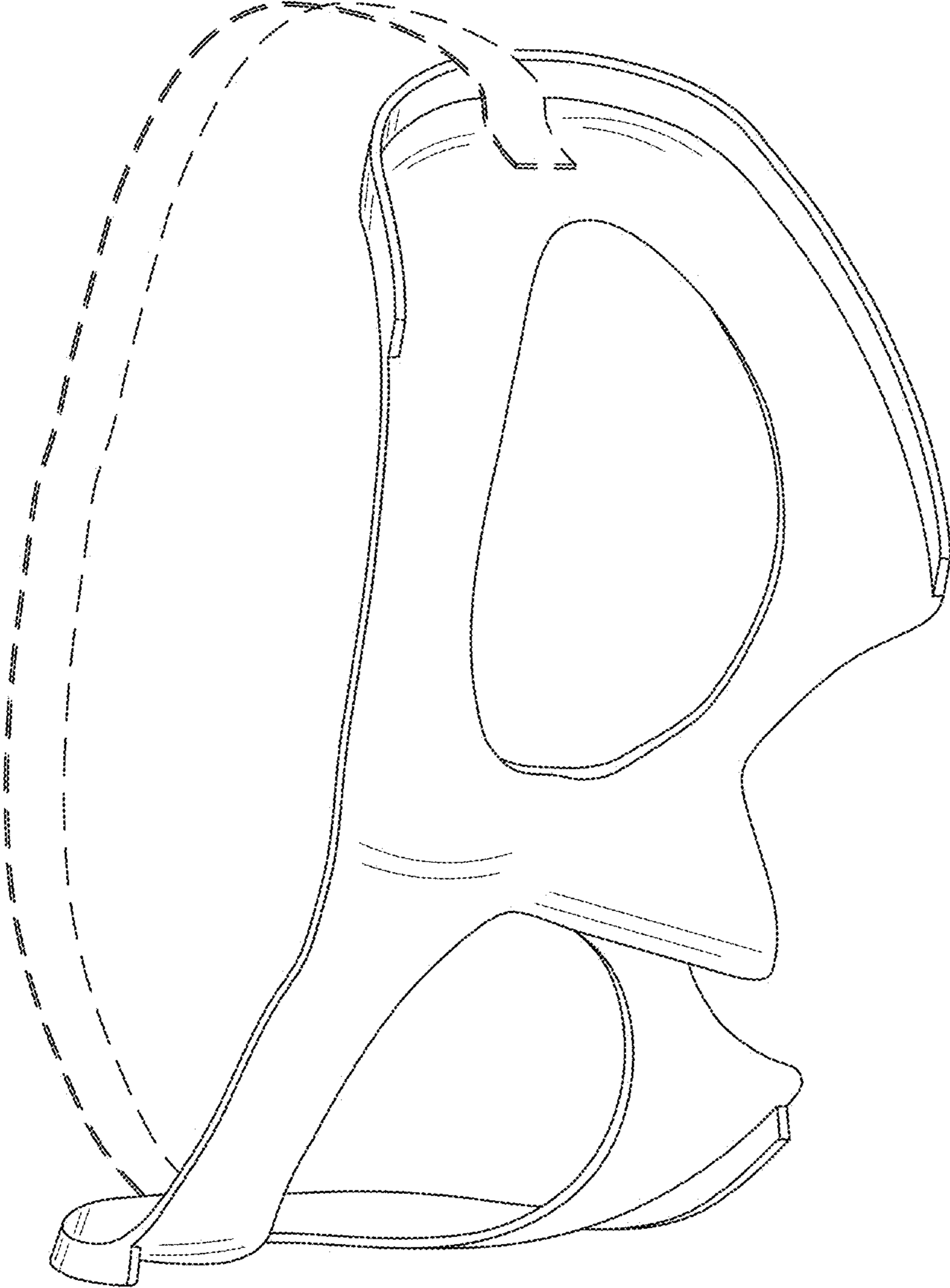

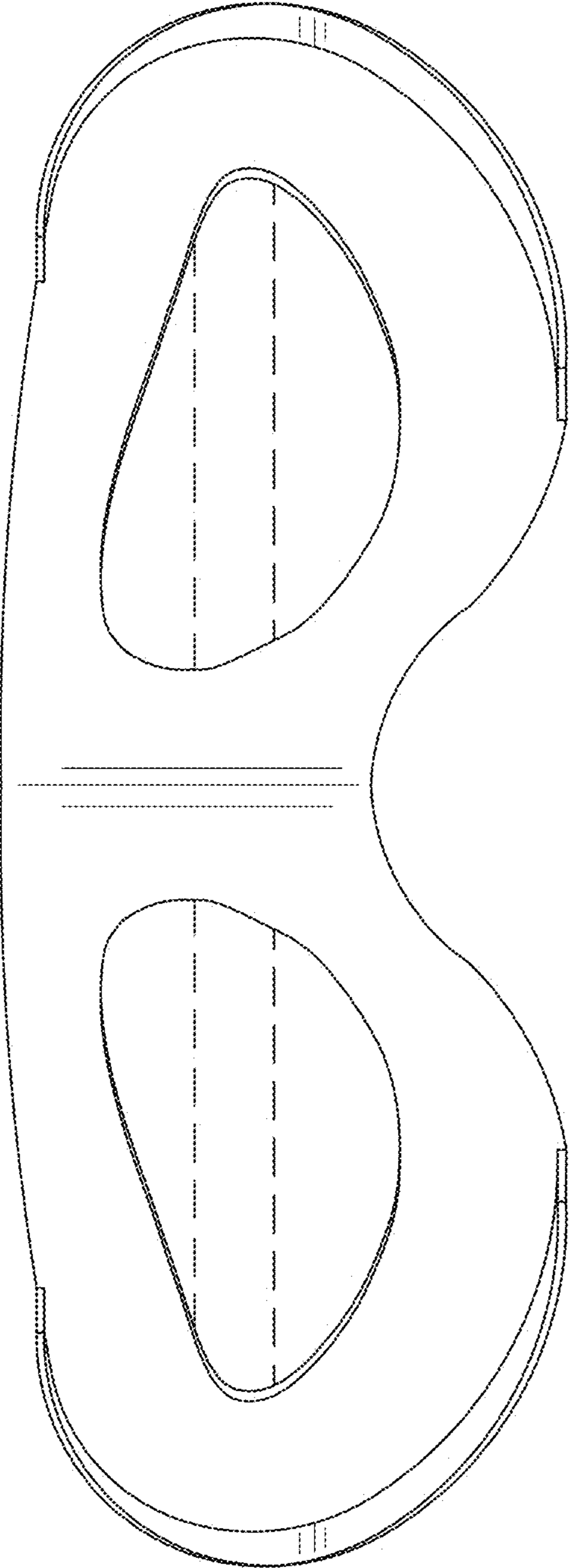

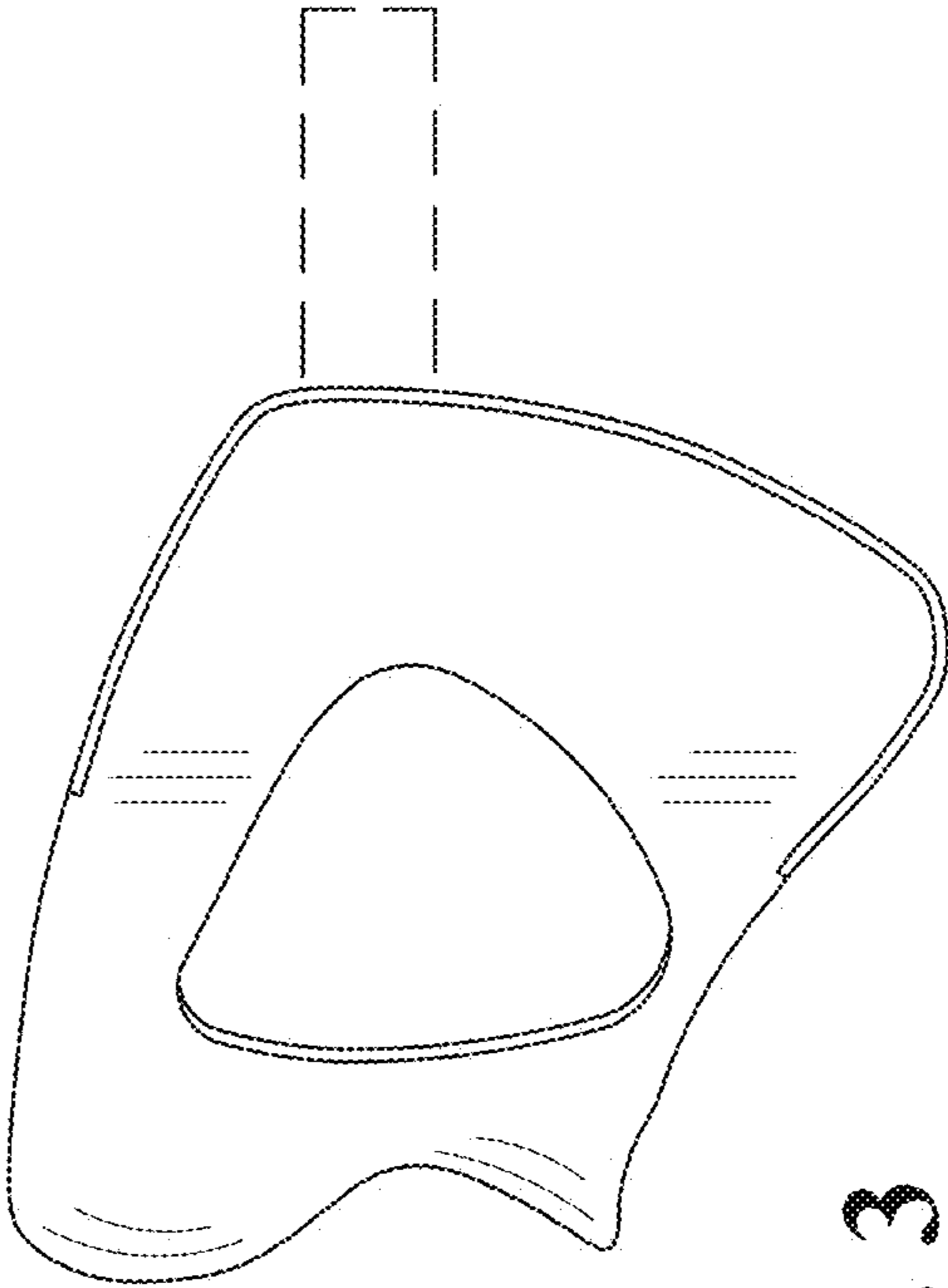

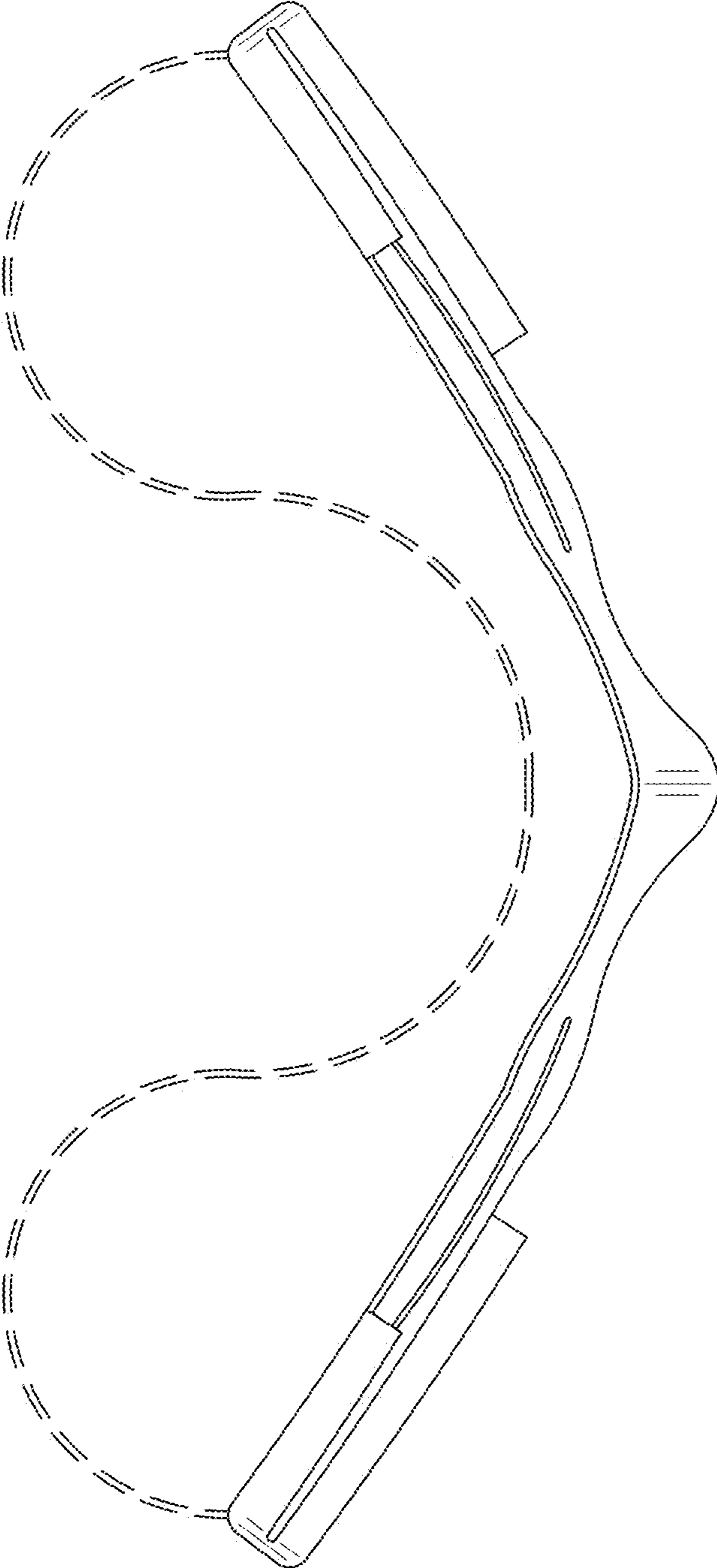

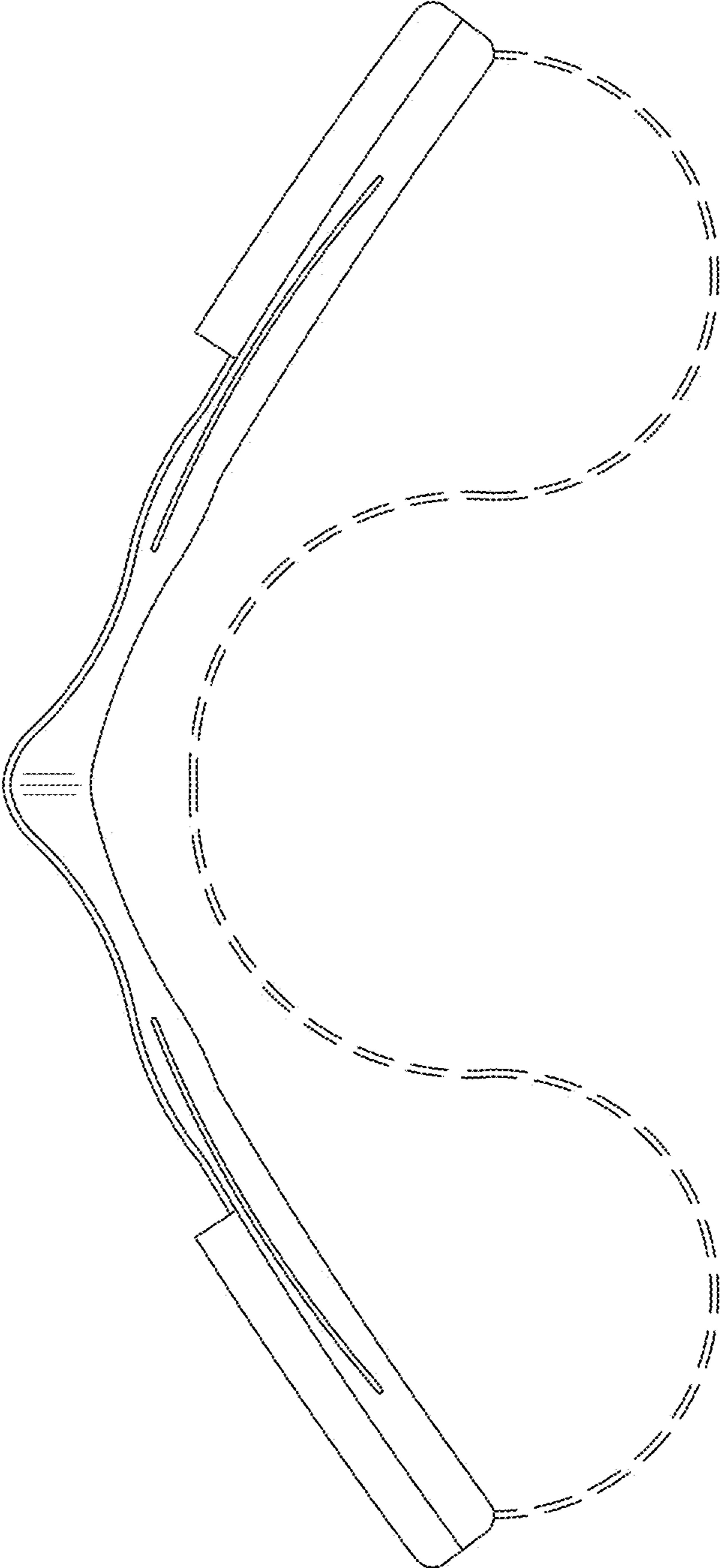

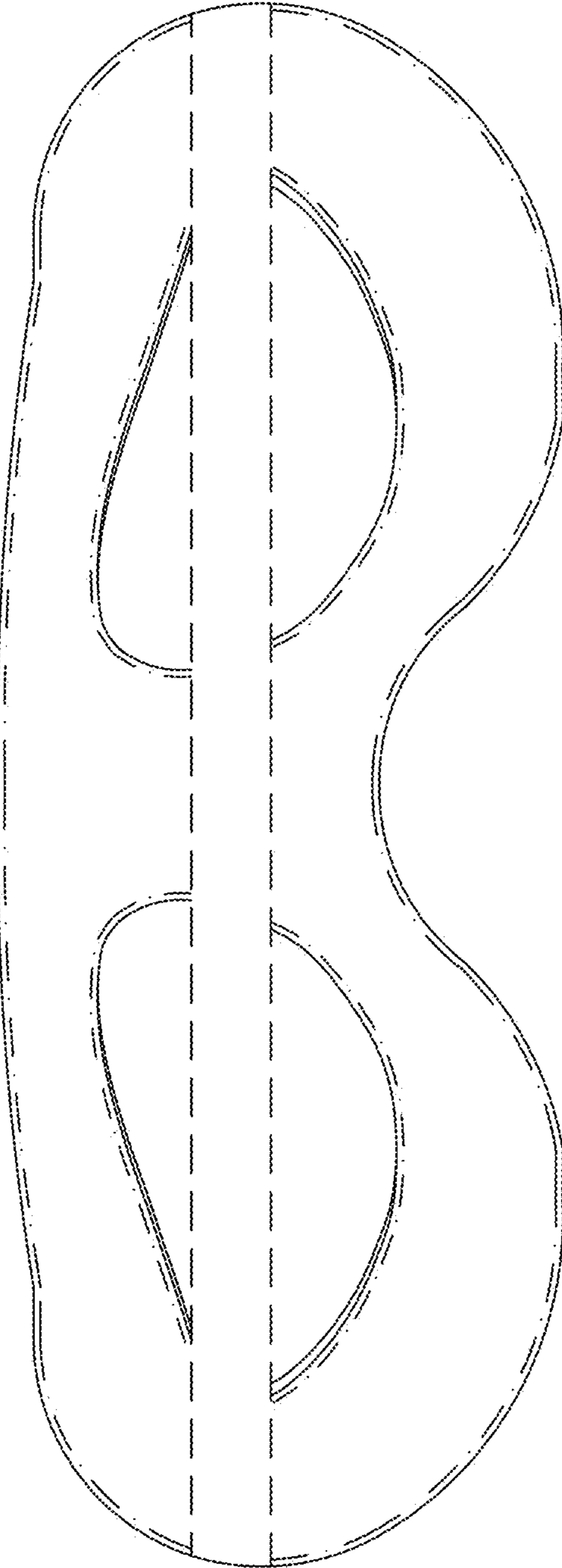

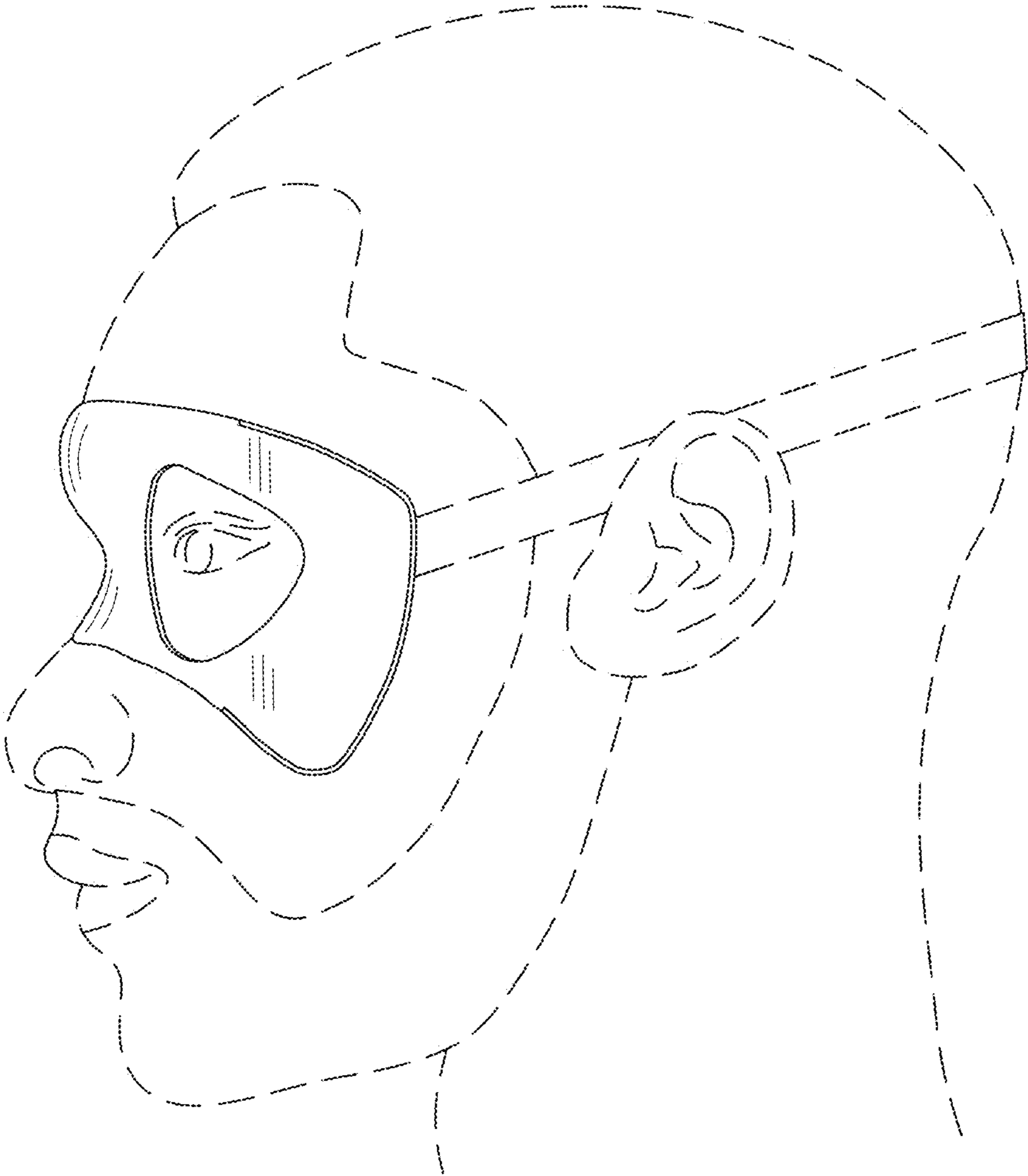
