(57) **CLAIM**

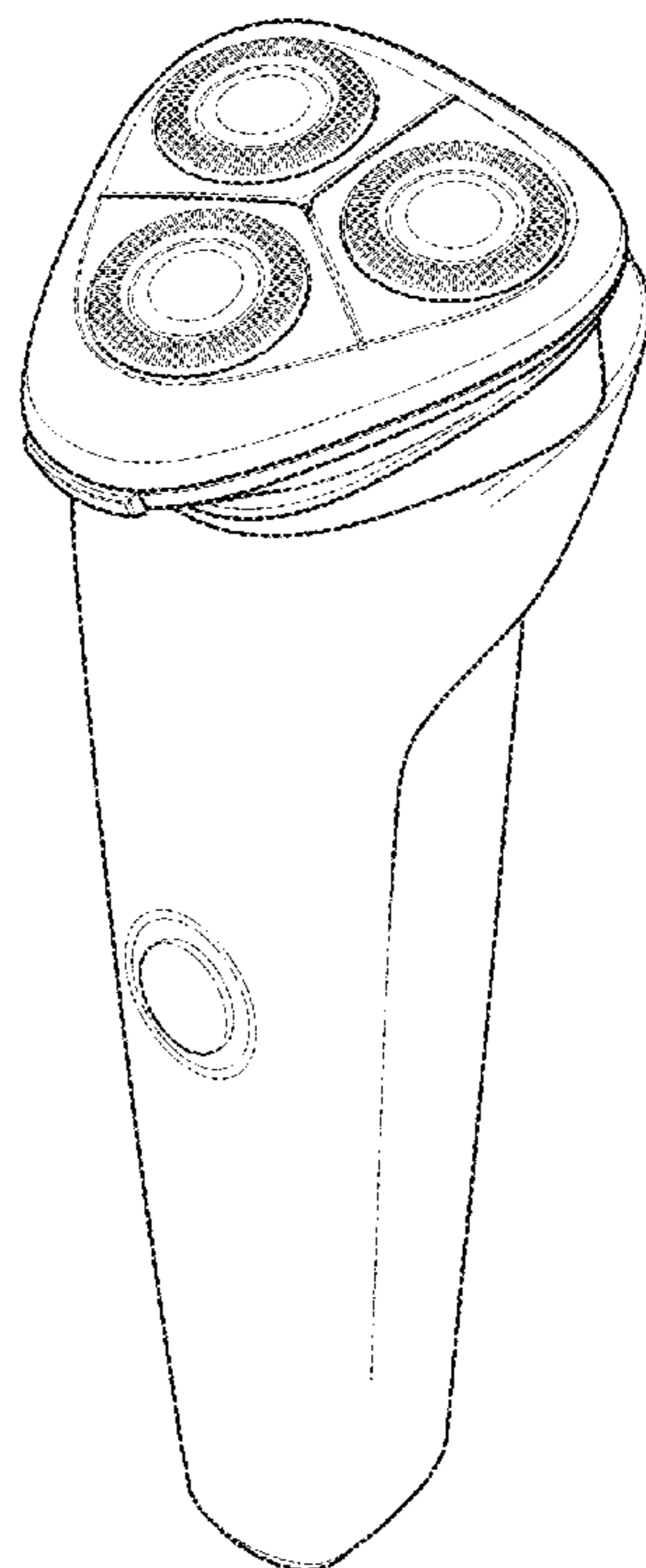
The ornamental design for a shaver, as shown and described.

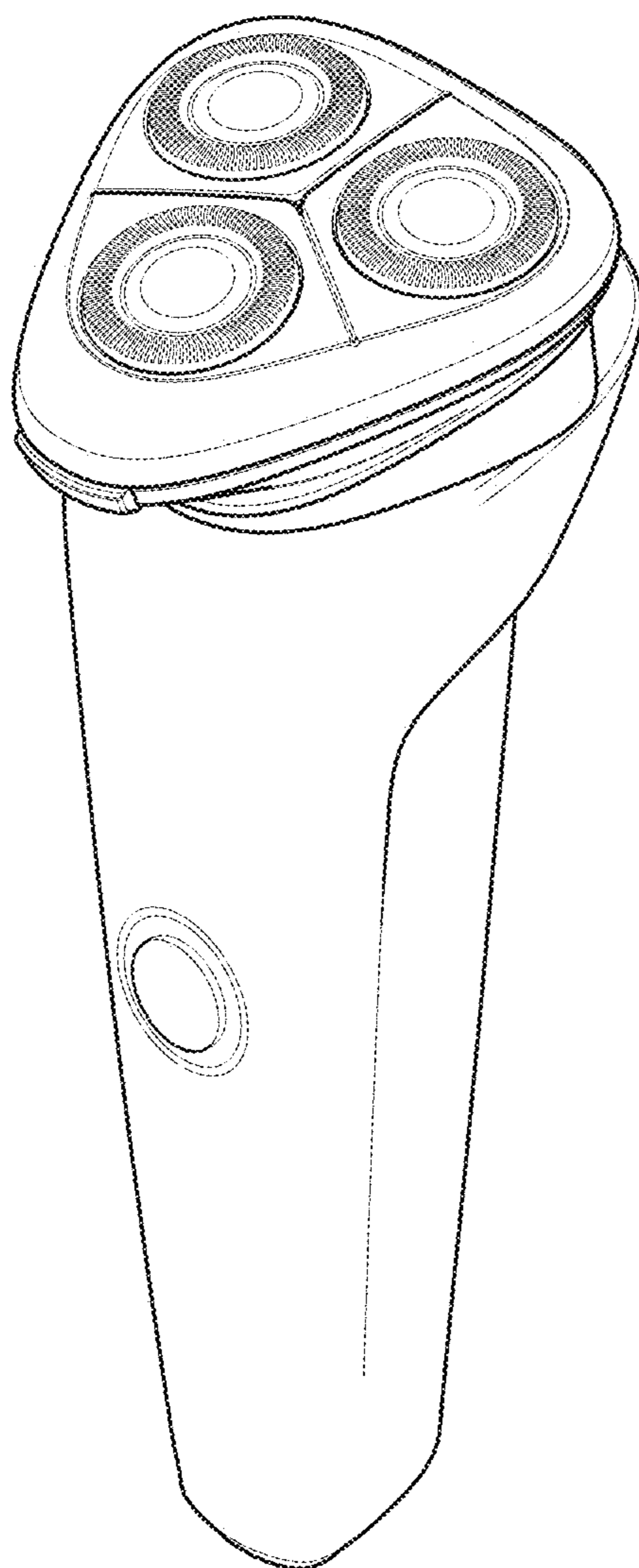

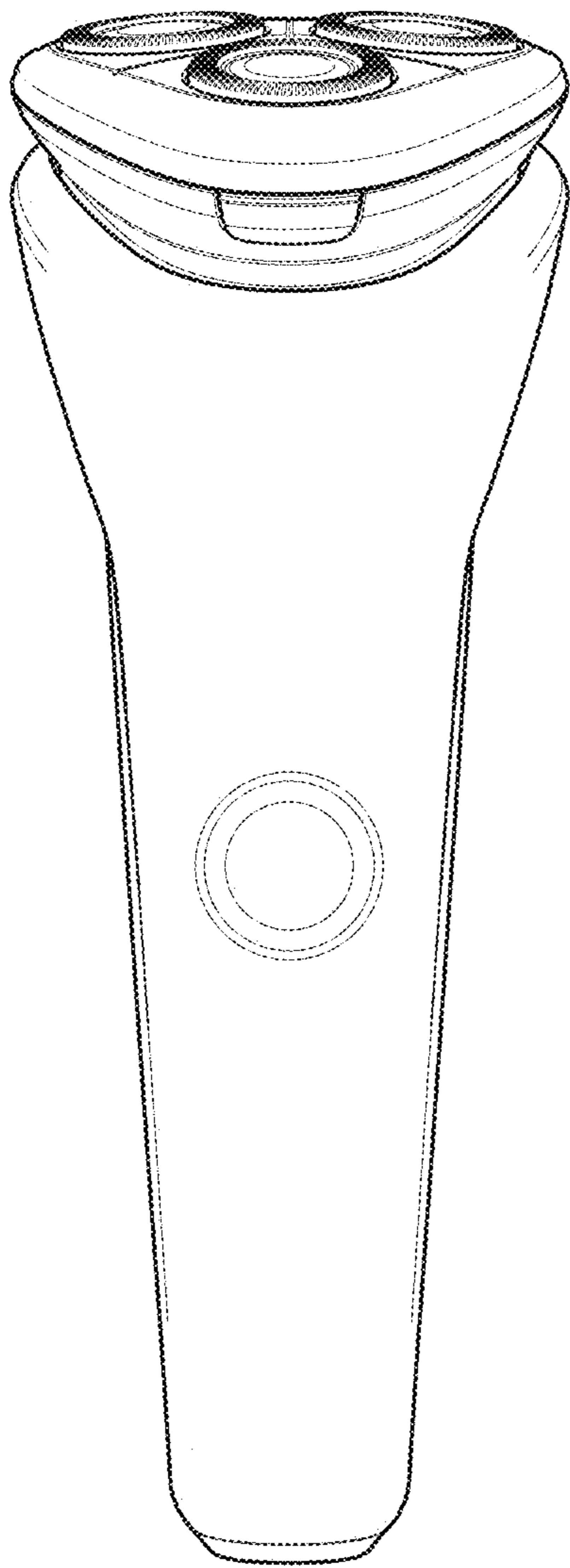

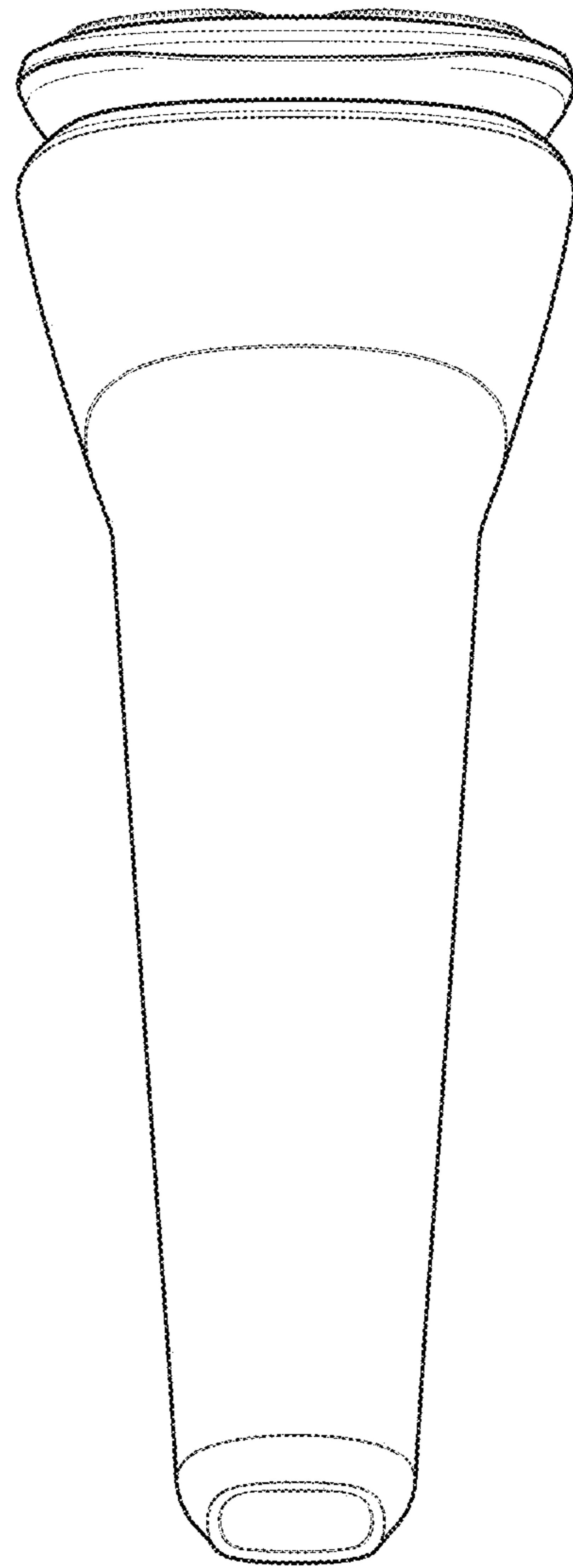

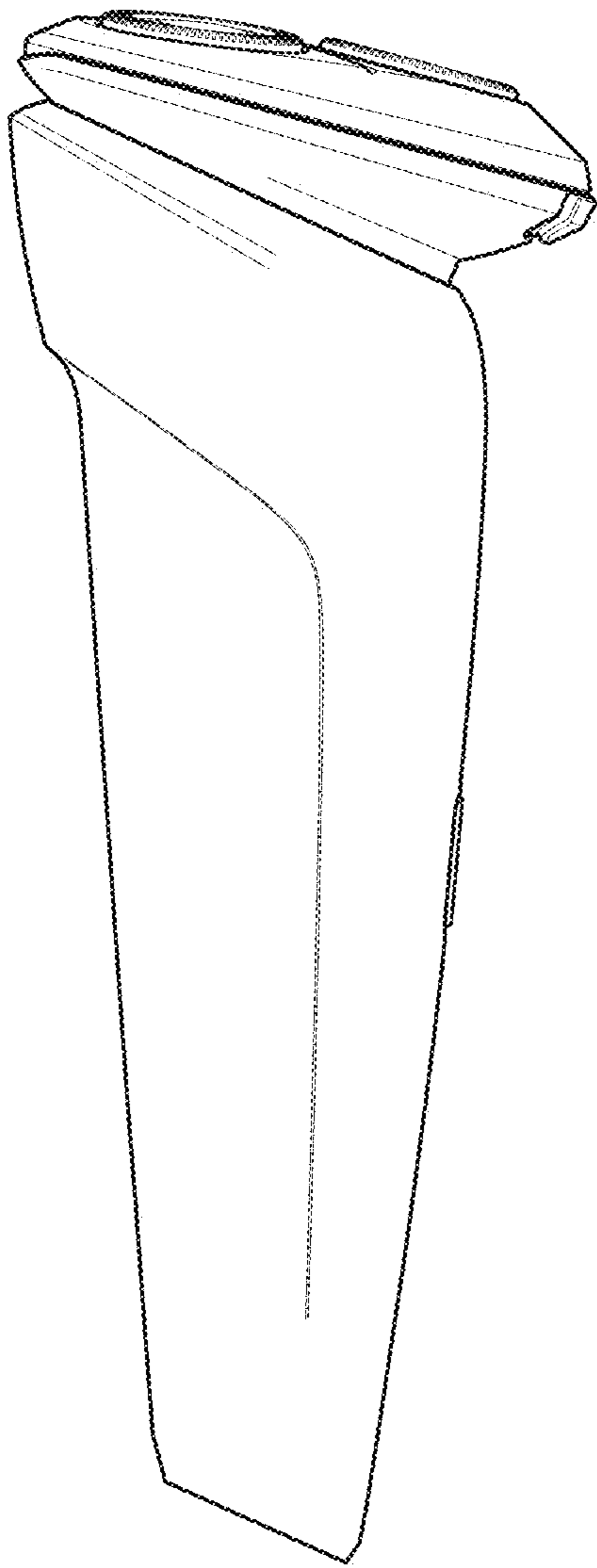

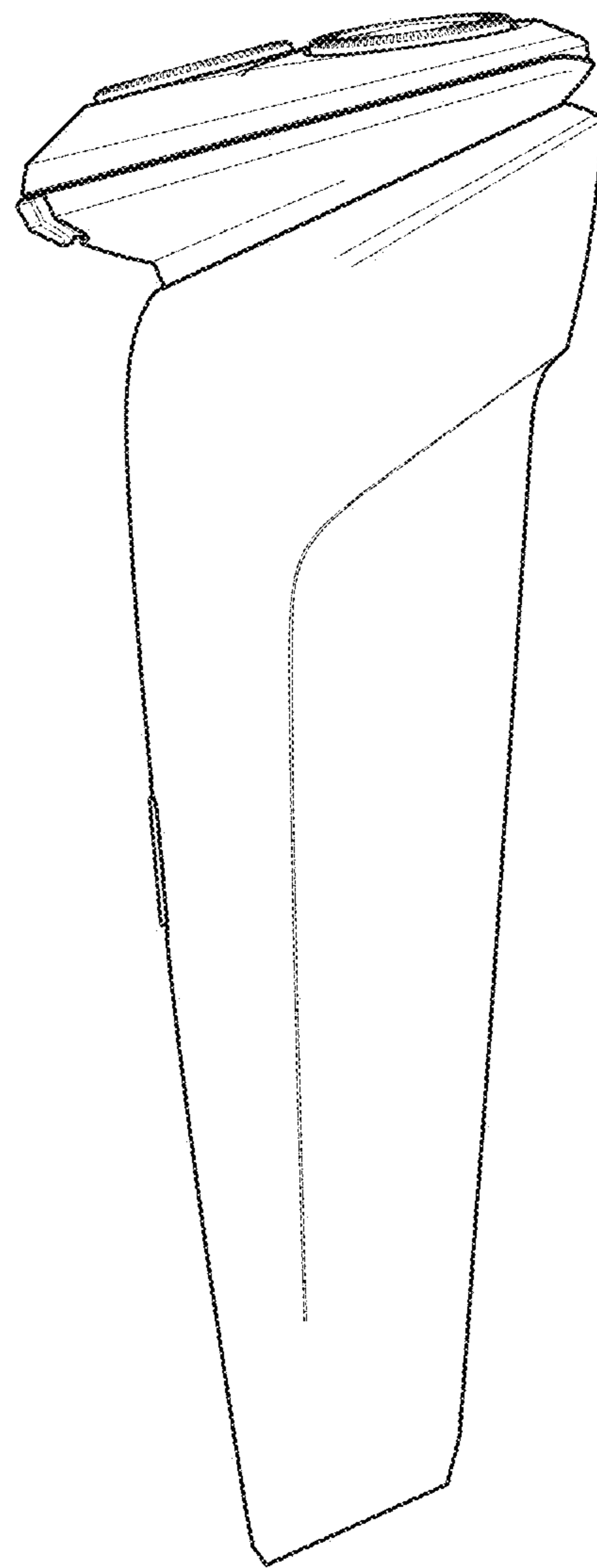

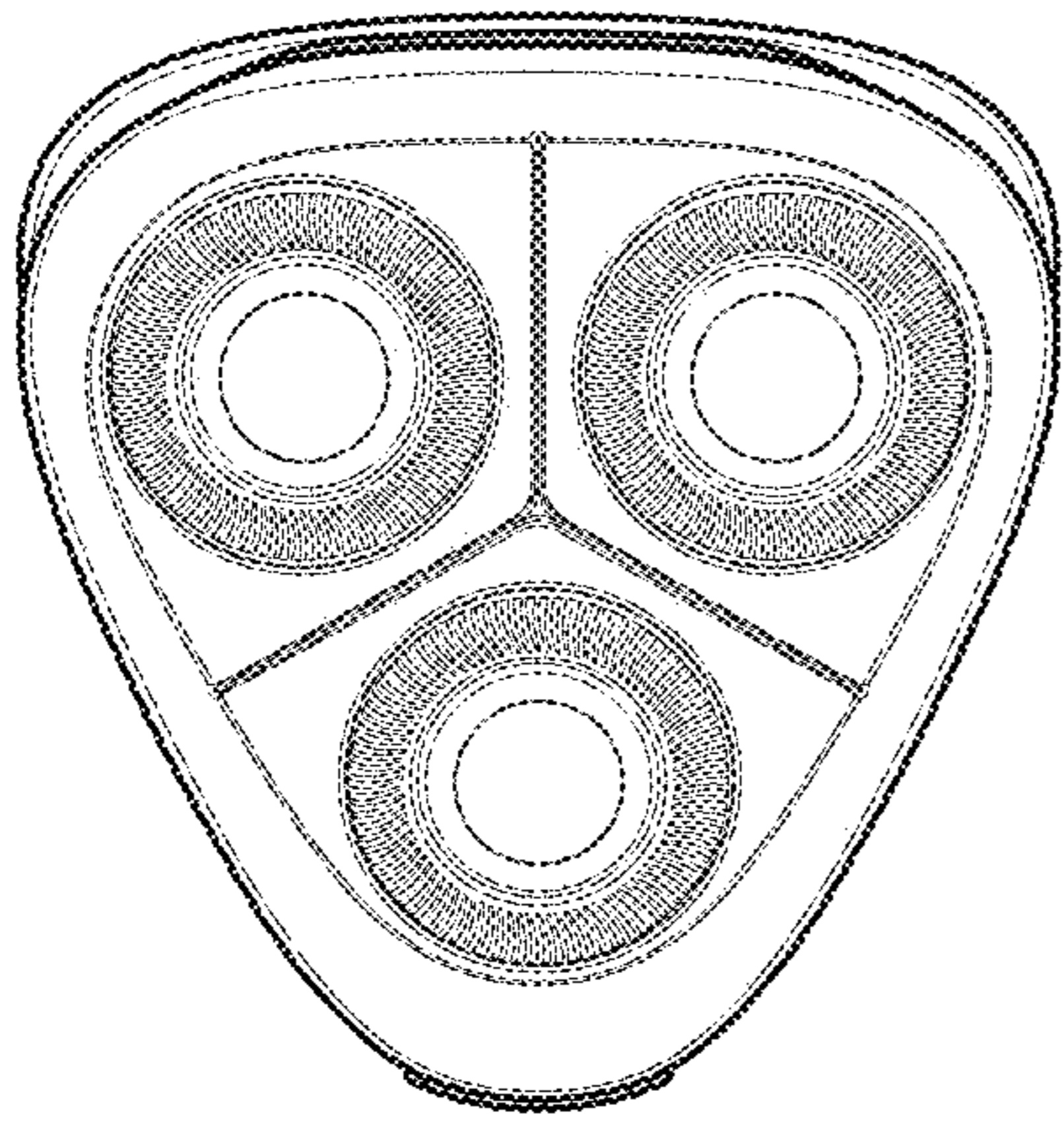

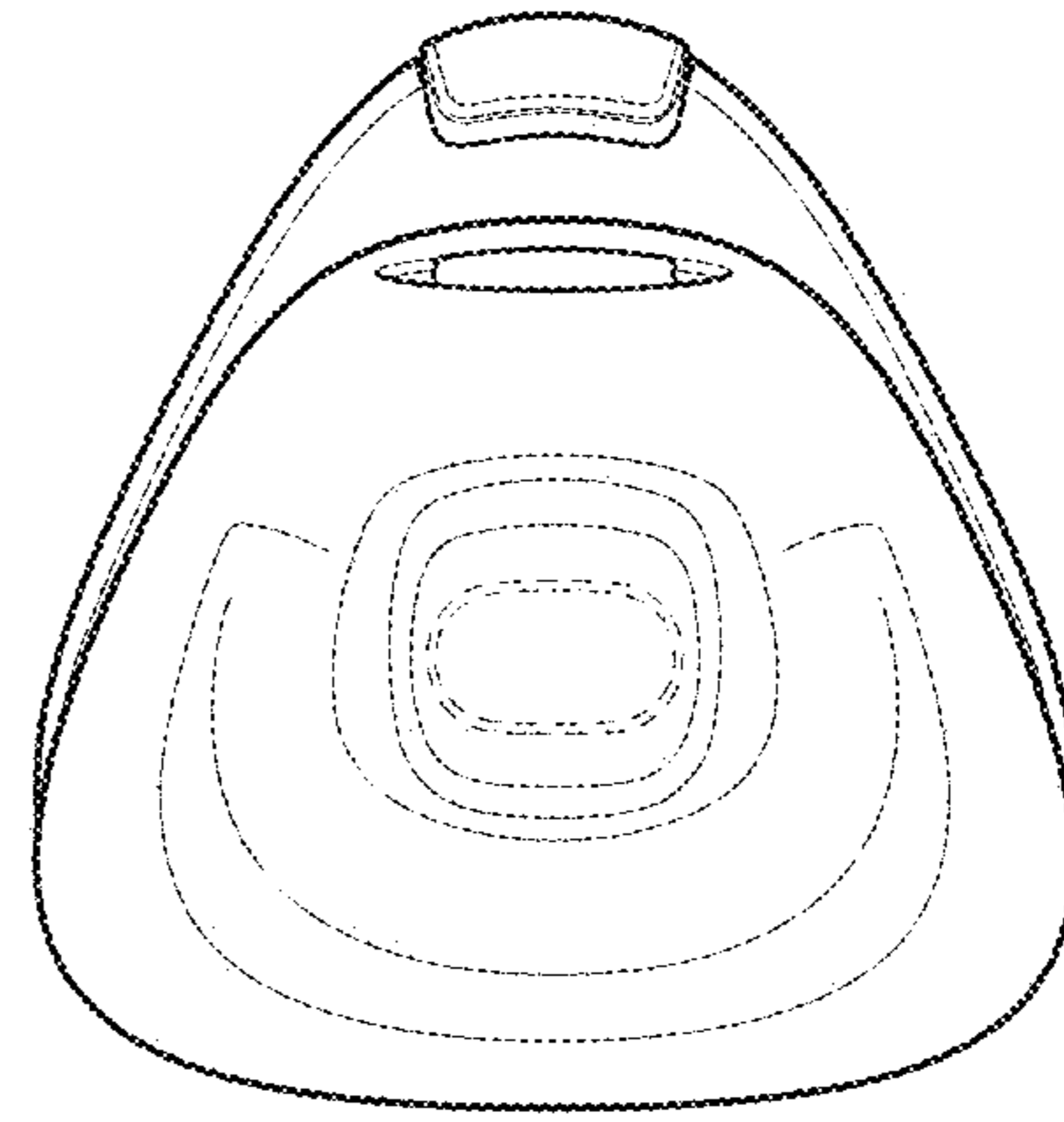
