**DESCRIPTION**

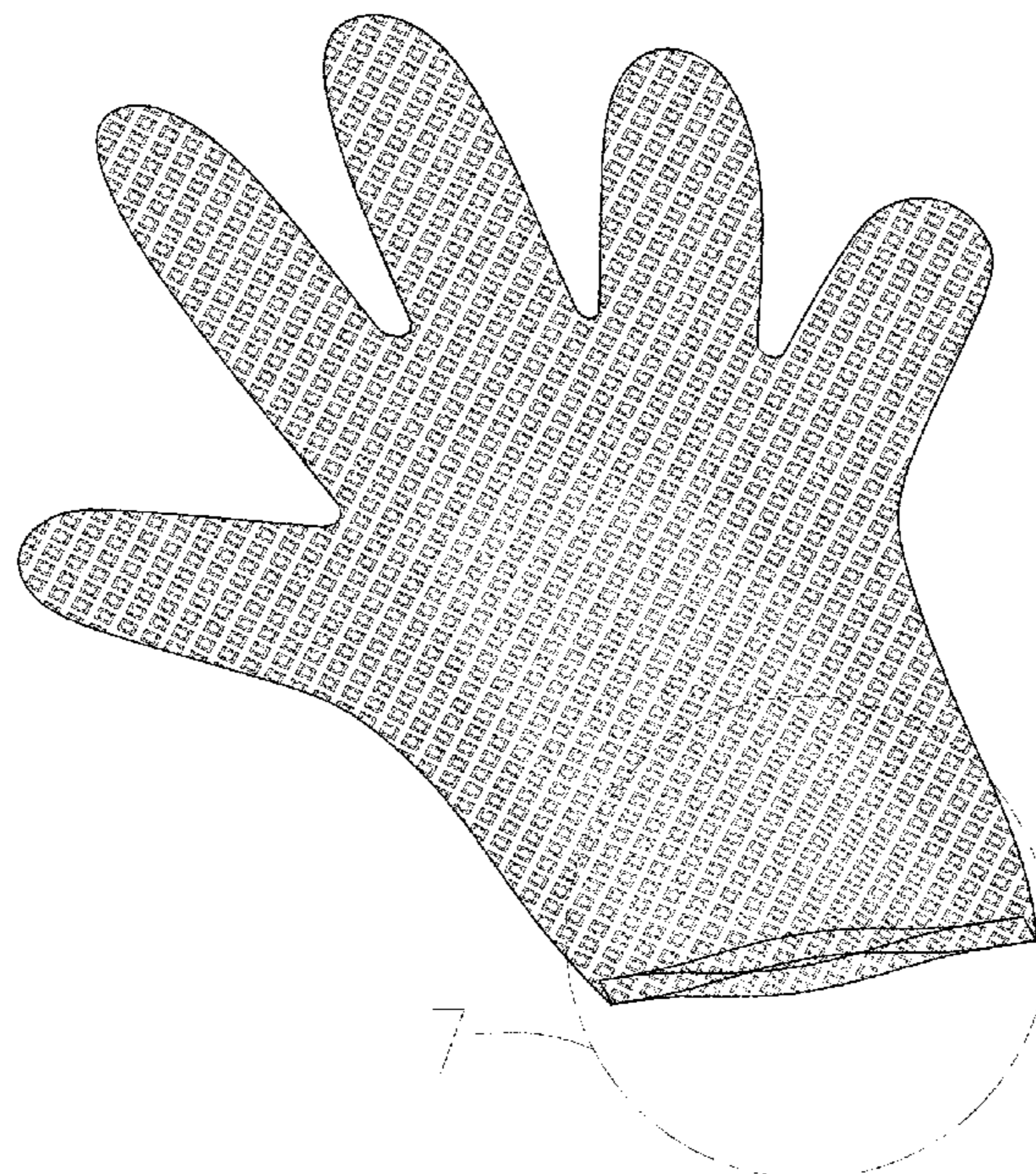
FIG. 1 is a first perspective view of a disposable glove showing my new design;

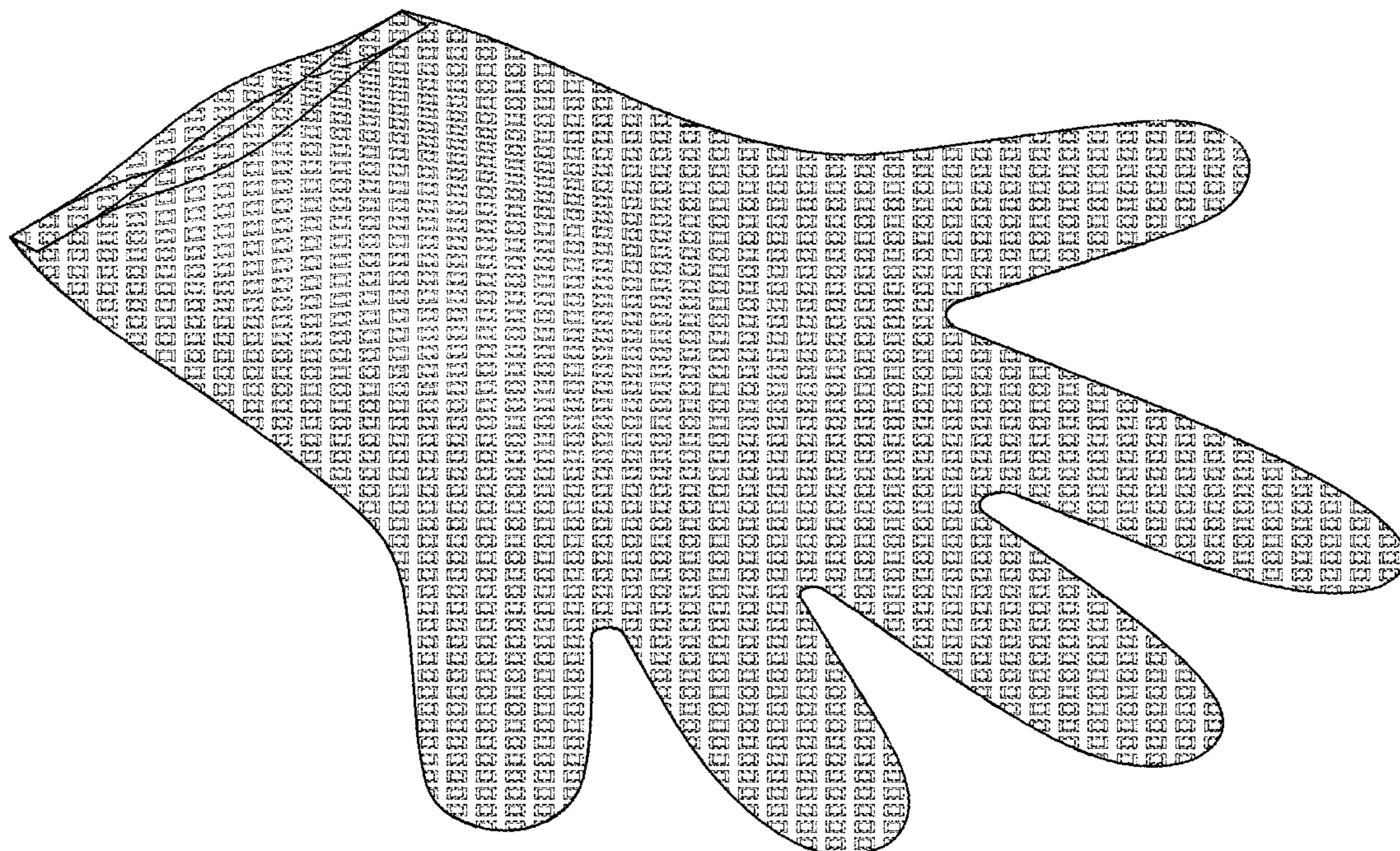

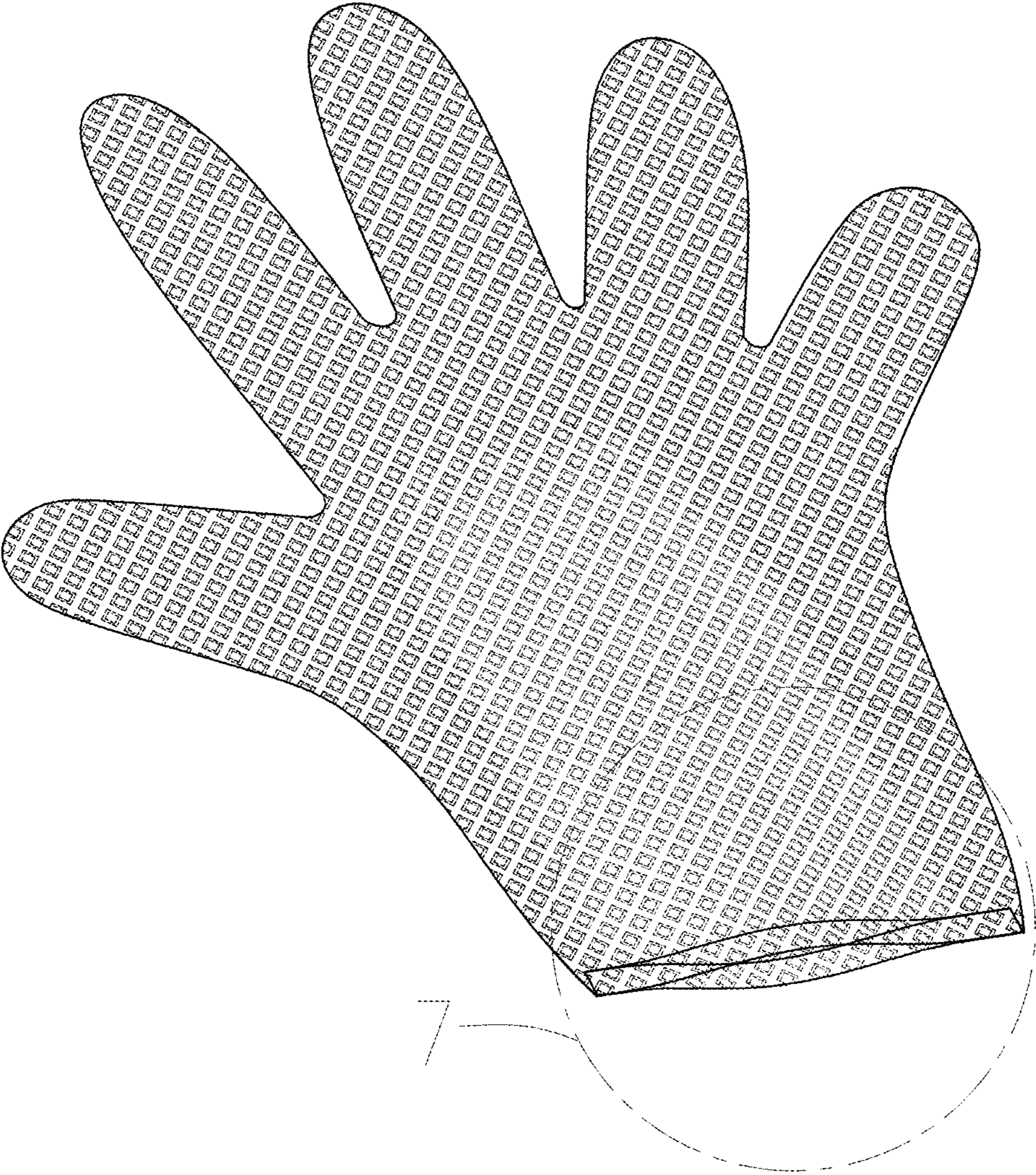

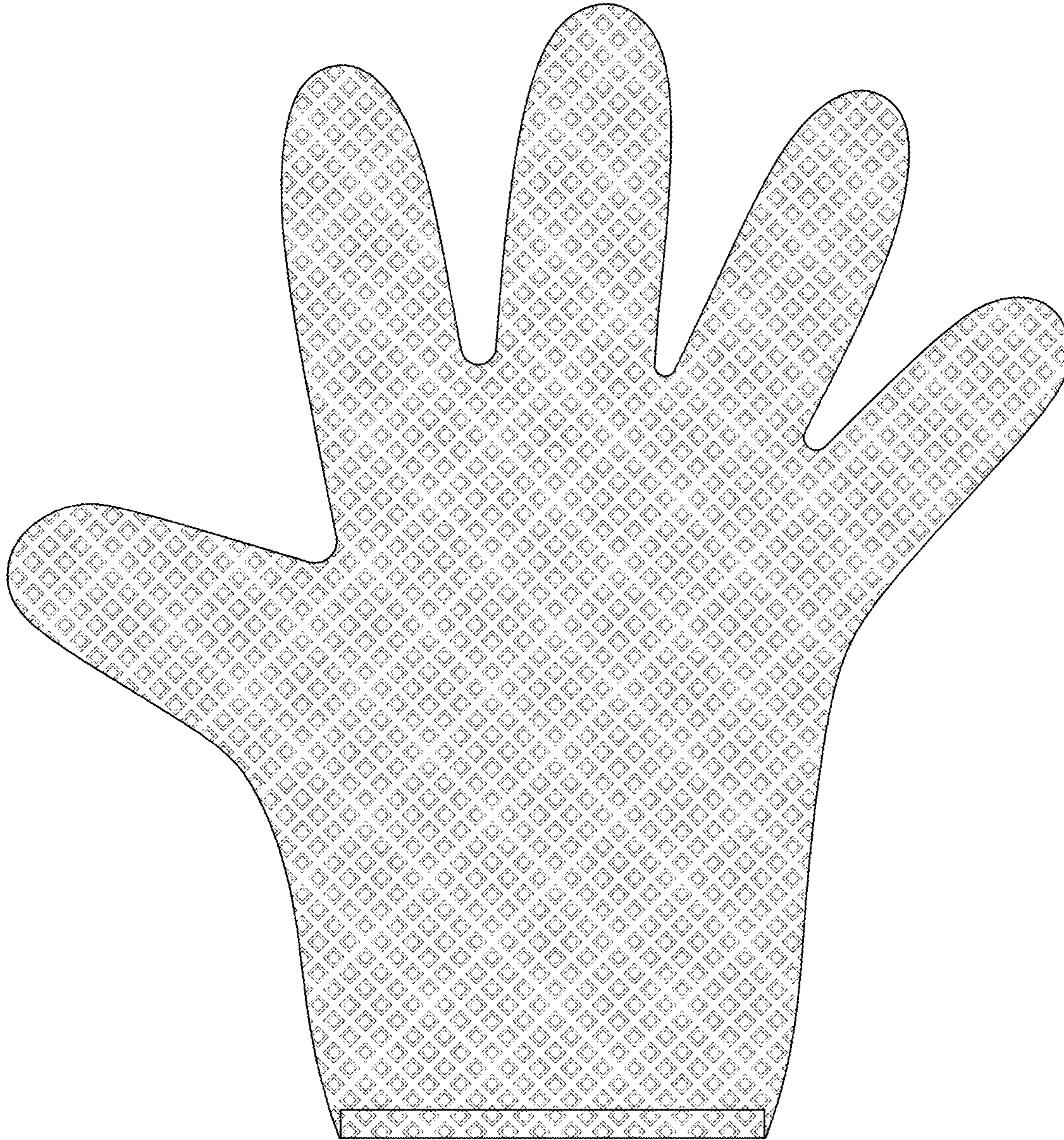

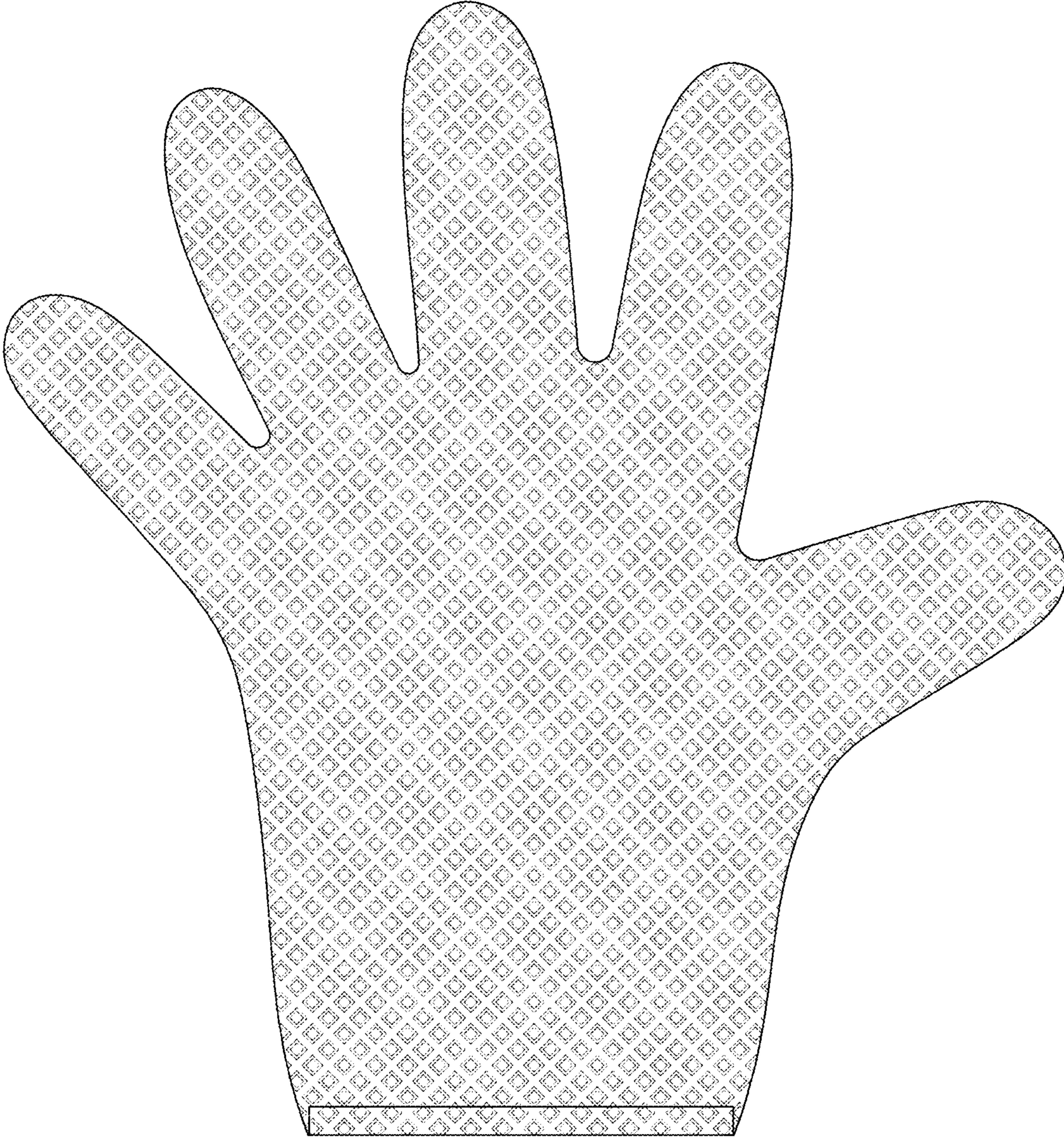

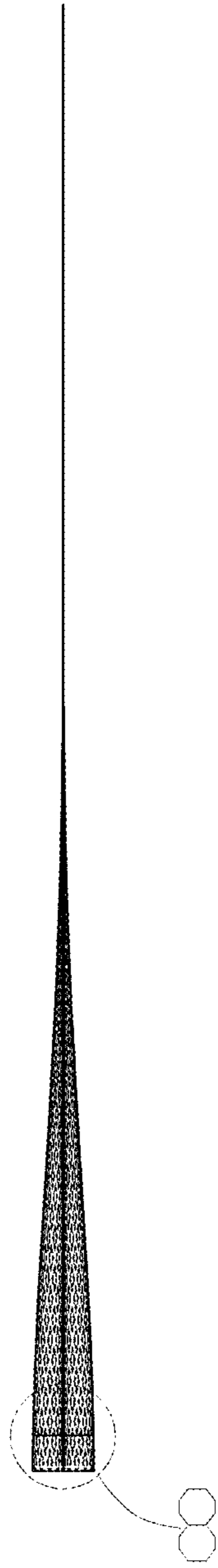

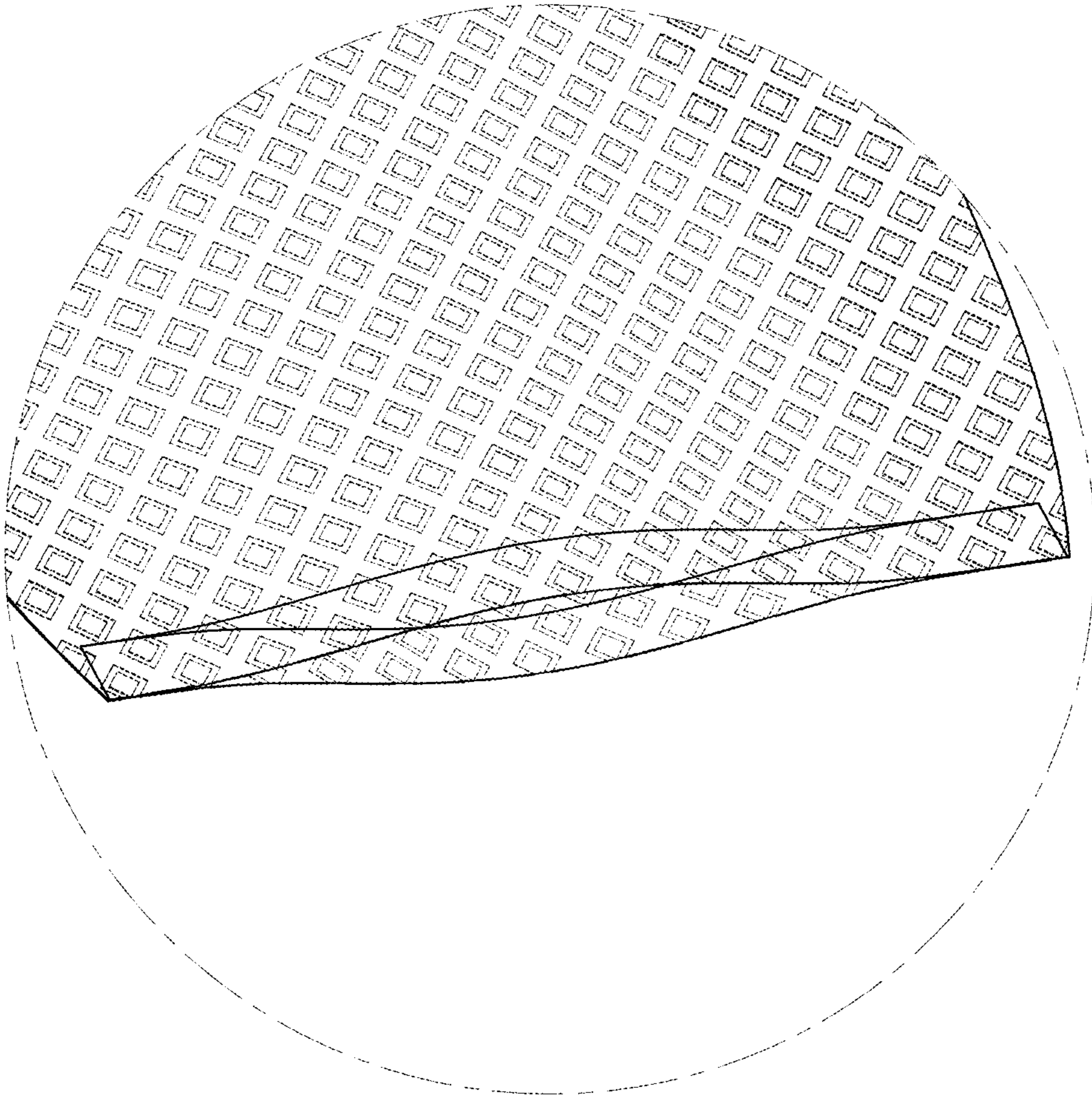

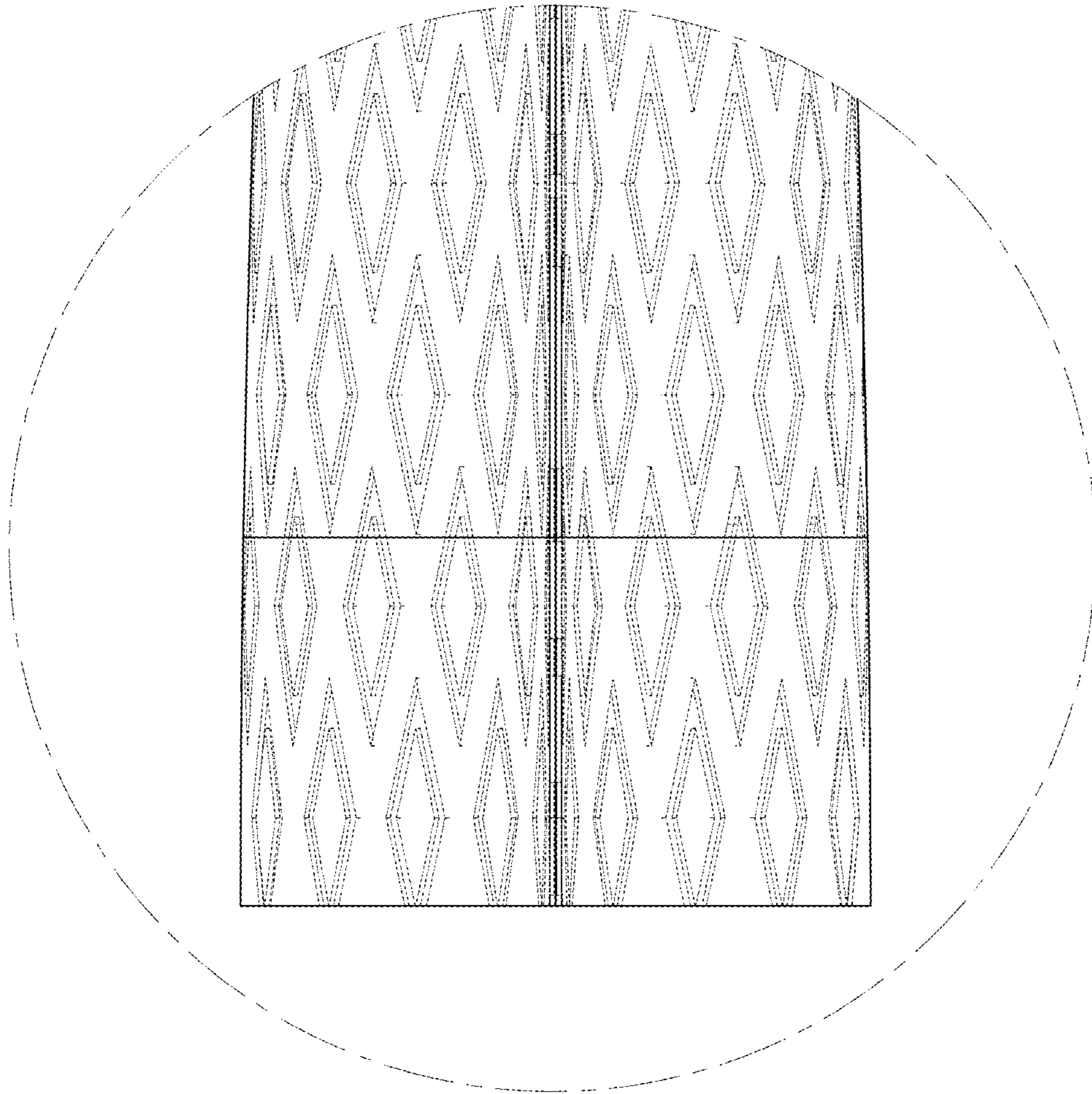
