The ornamental design for a cart, as shown and described.

**DESCRIPTION**

FIG. 1 is a front right isometric view of a cart showing our new design.

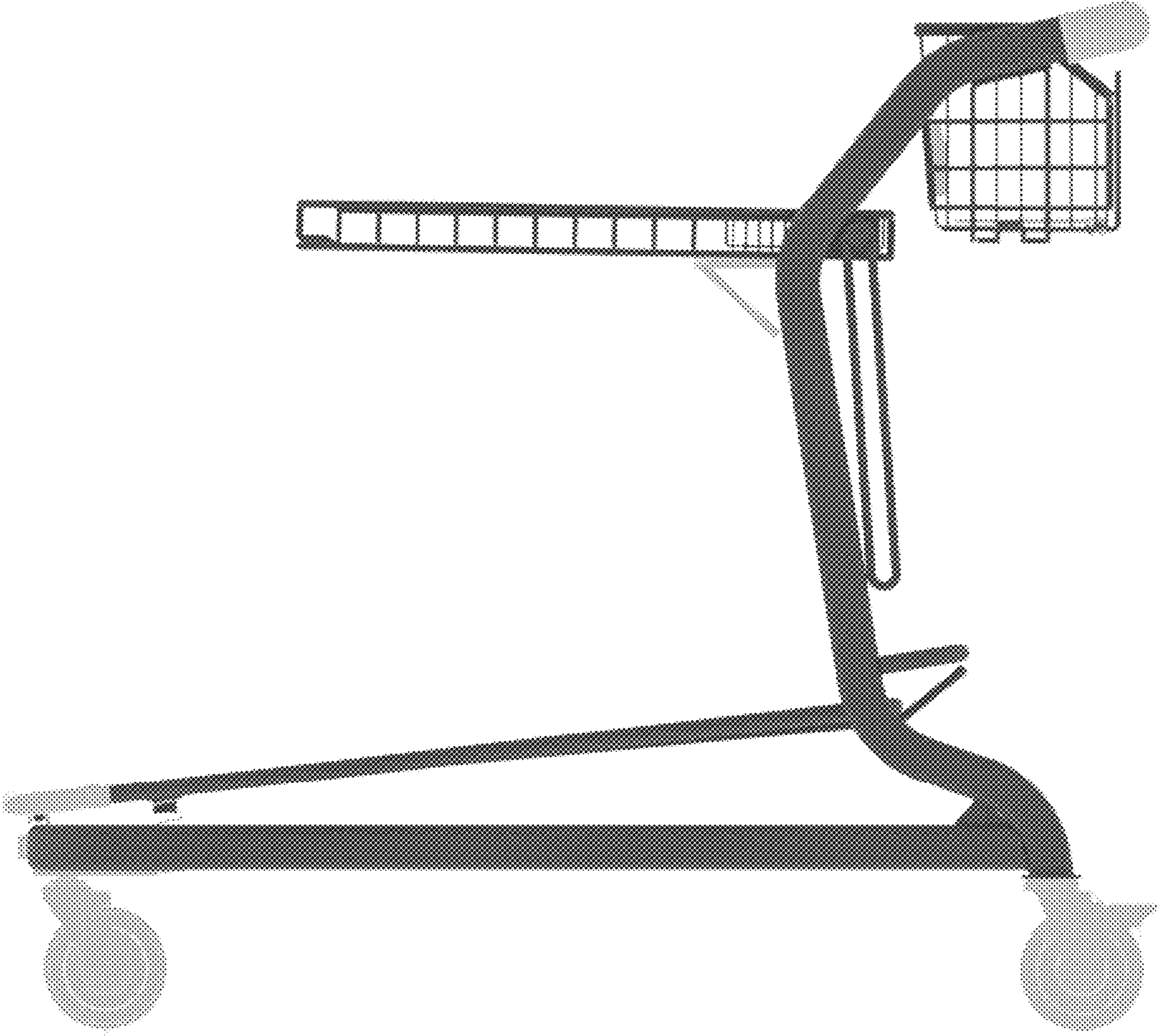

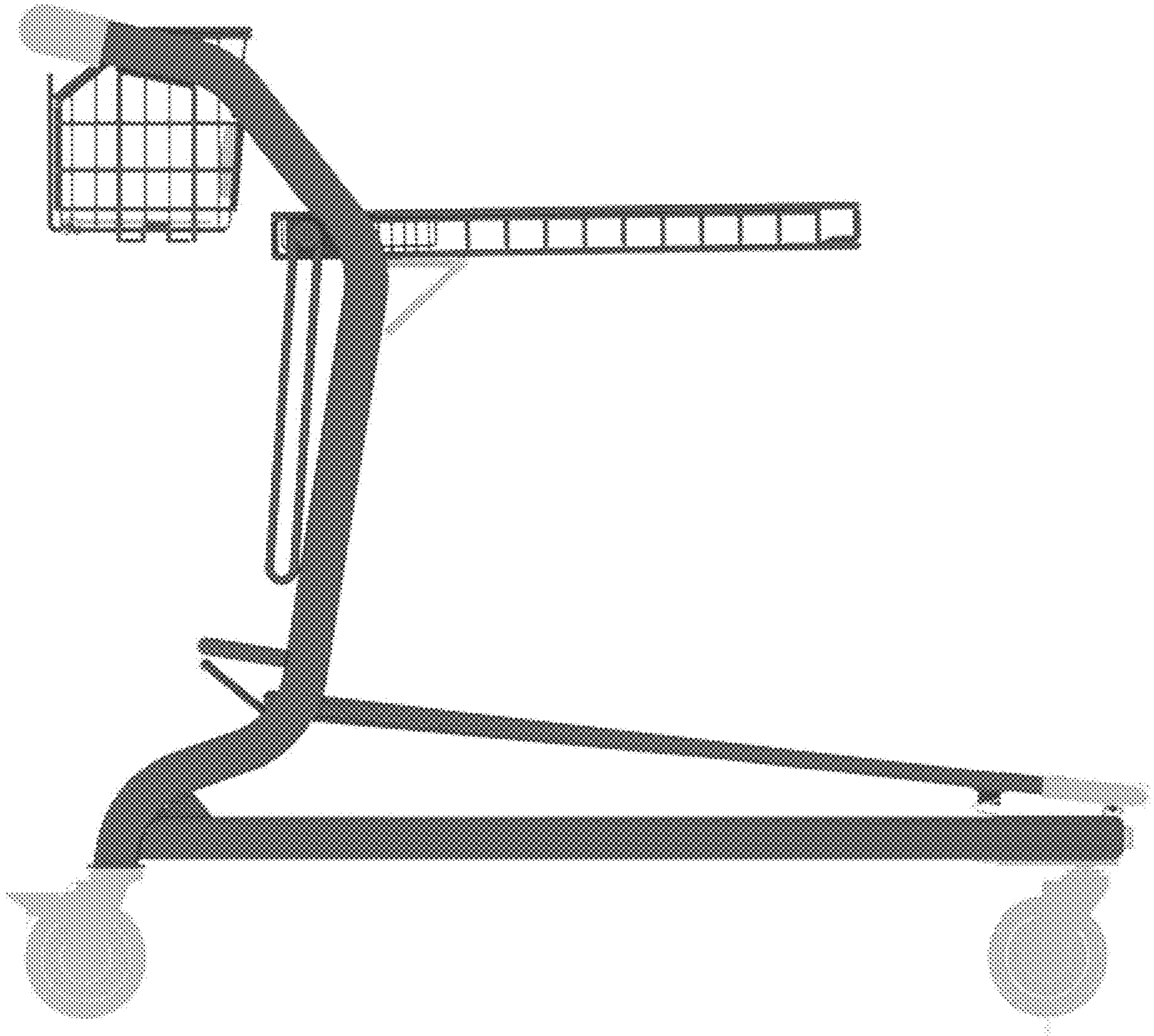

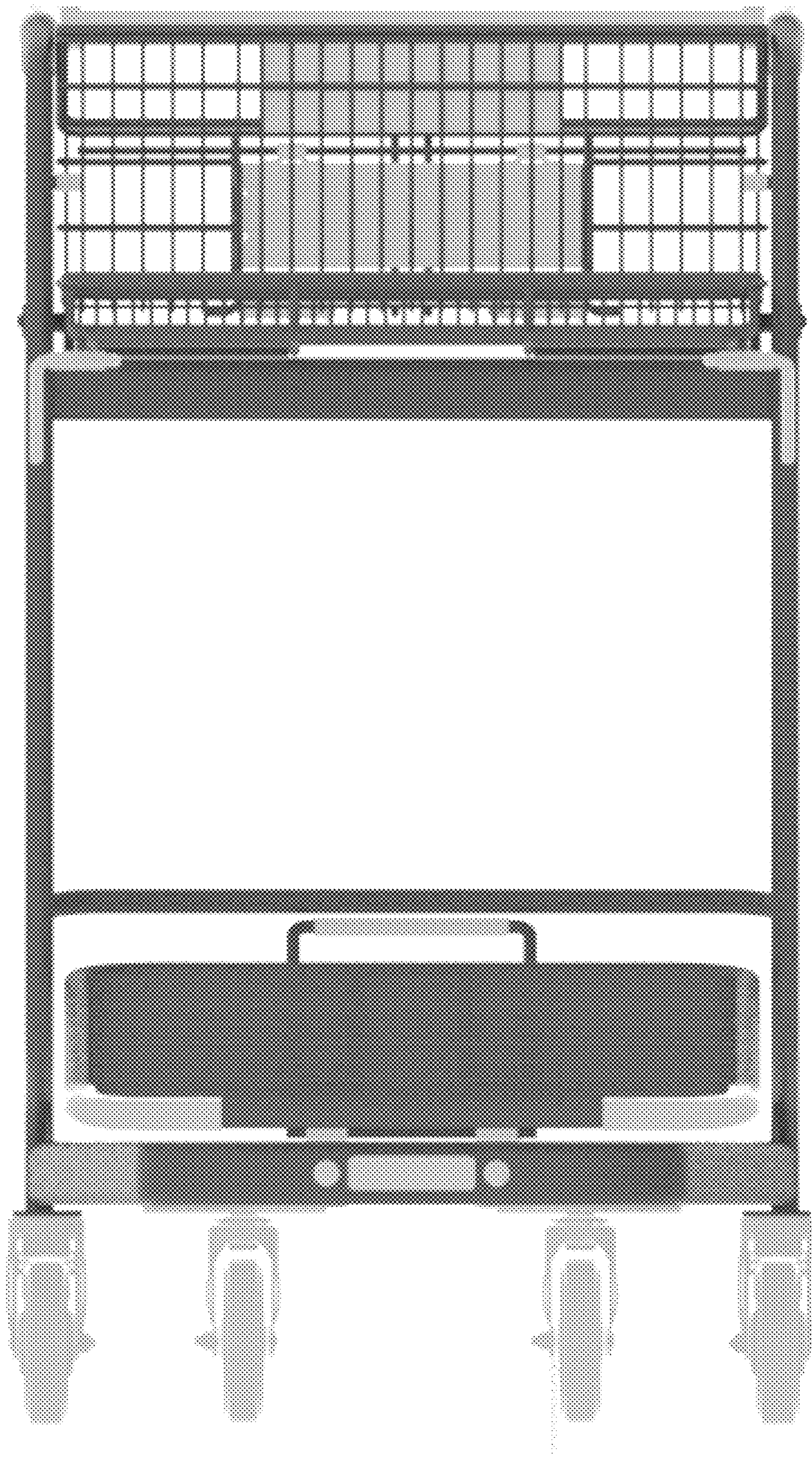

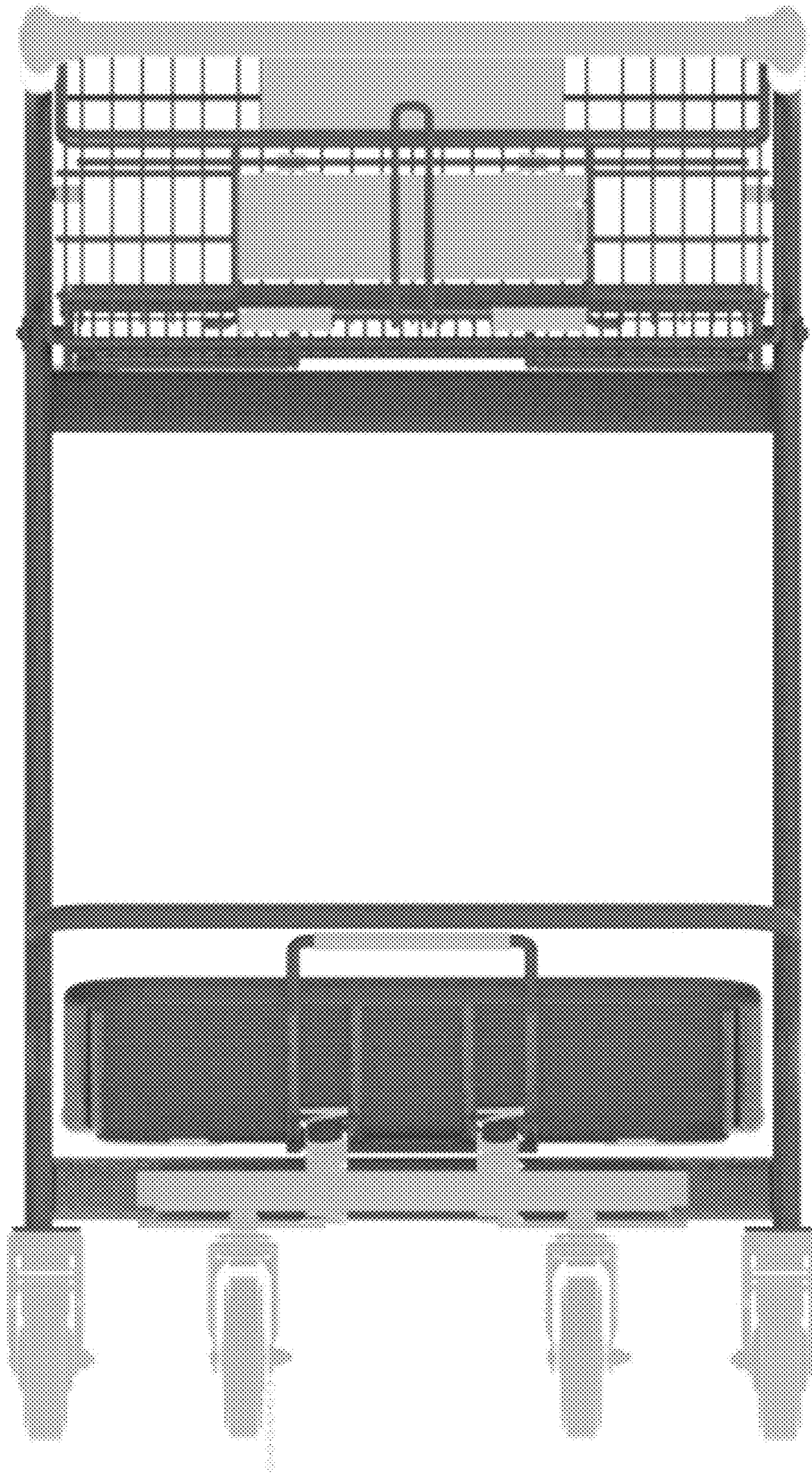

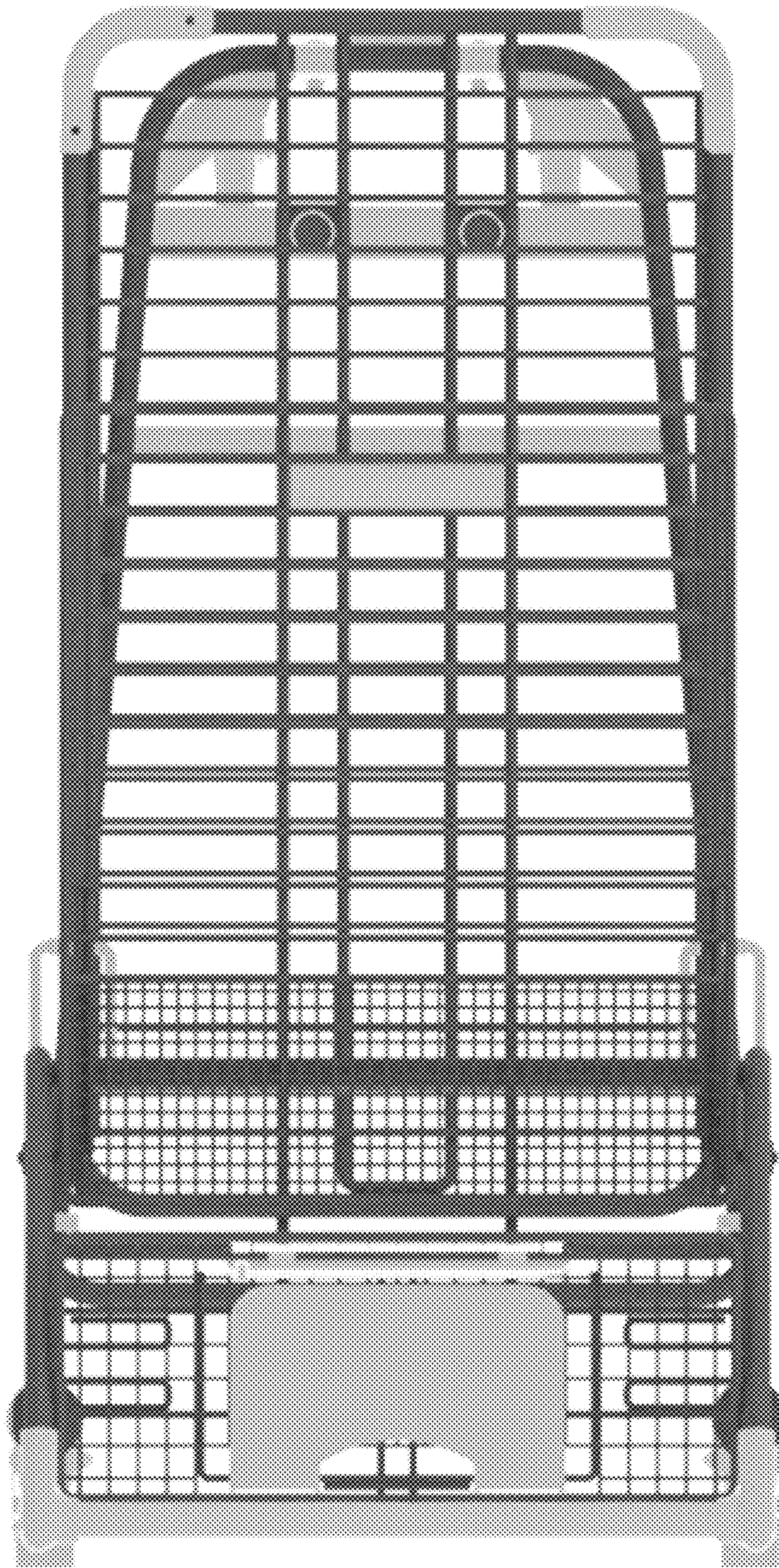

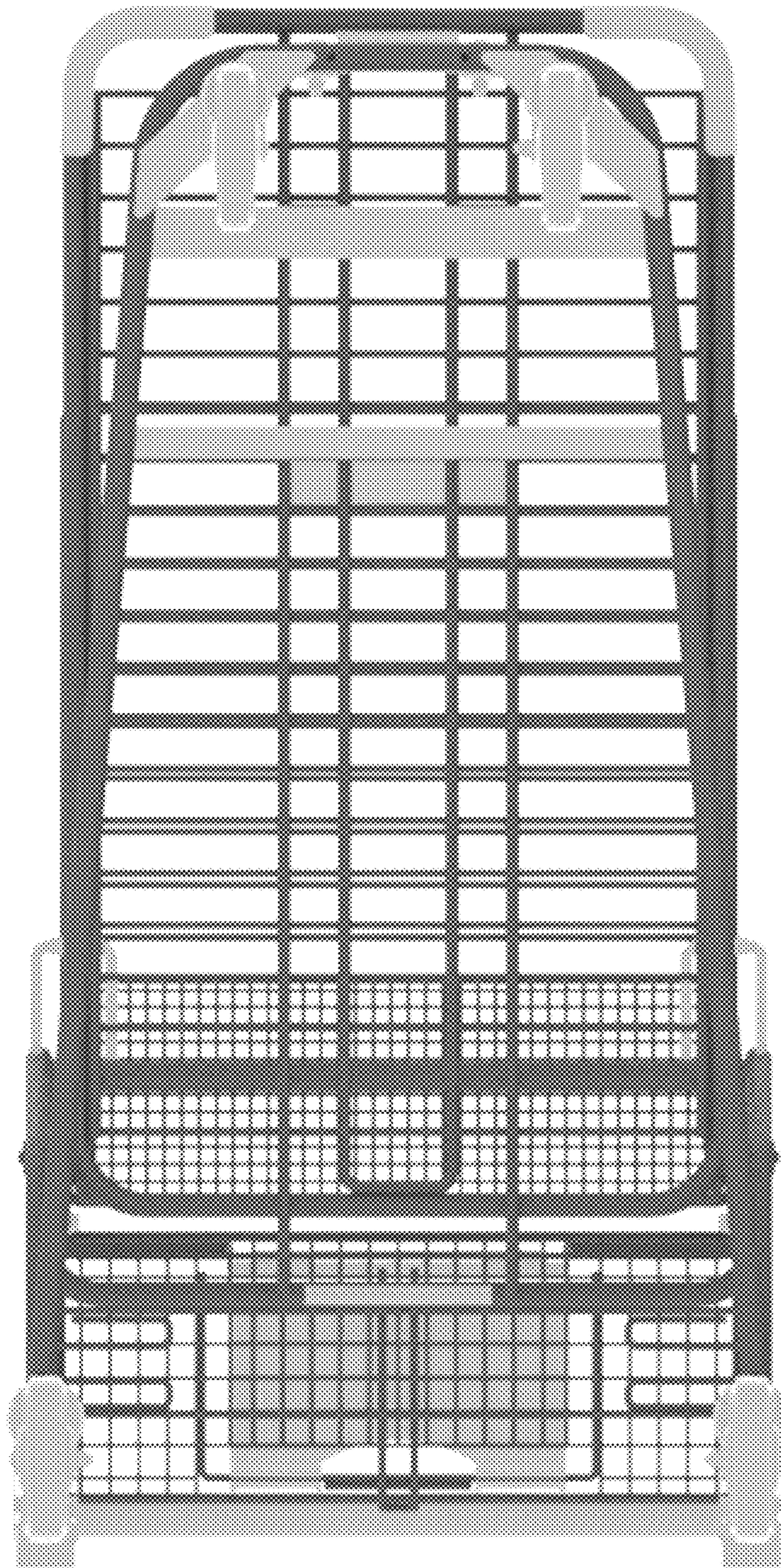

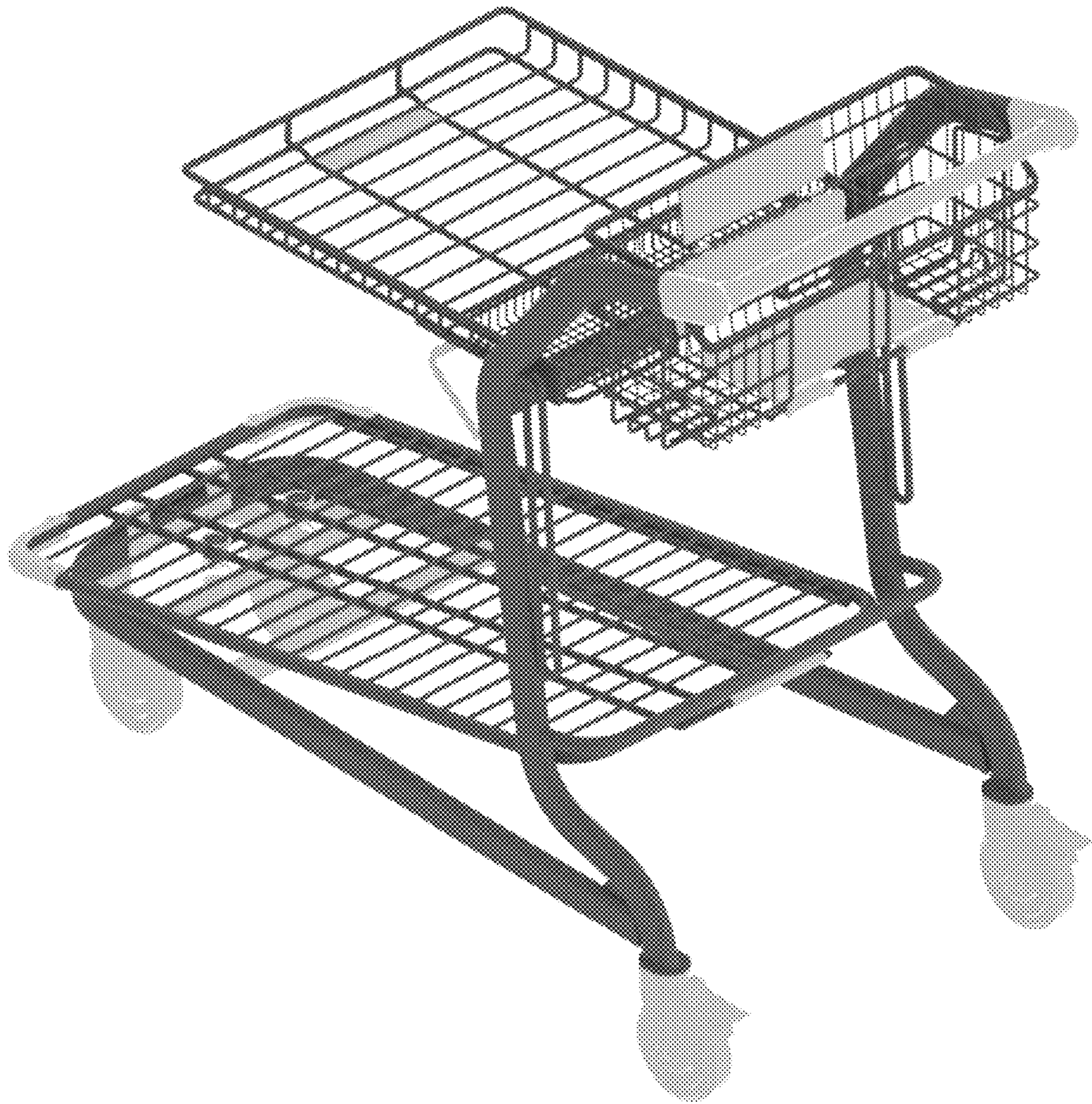

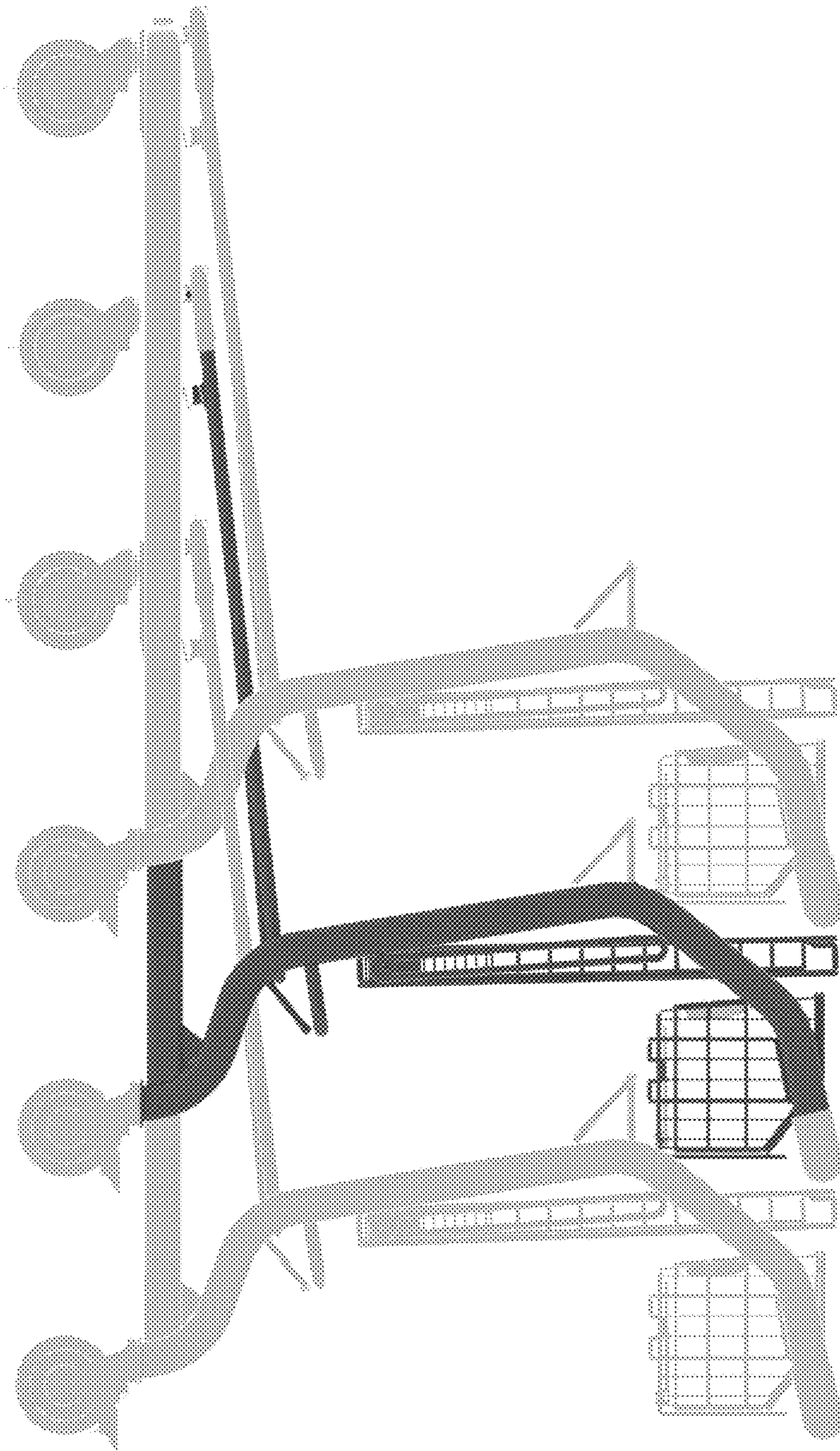
