DESCRIPTION

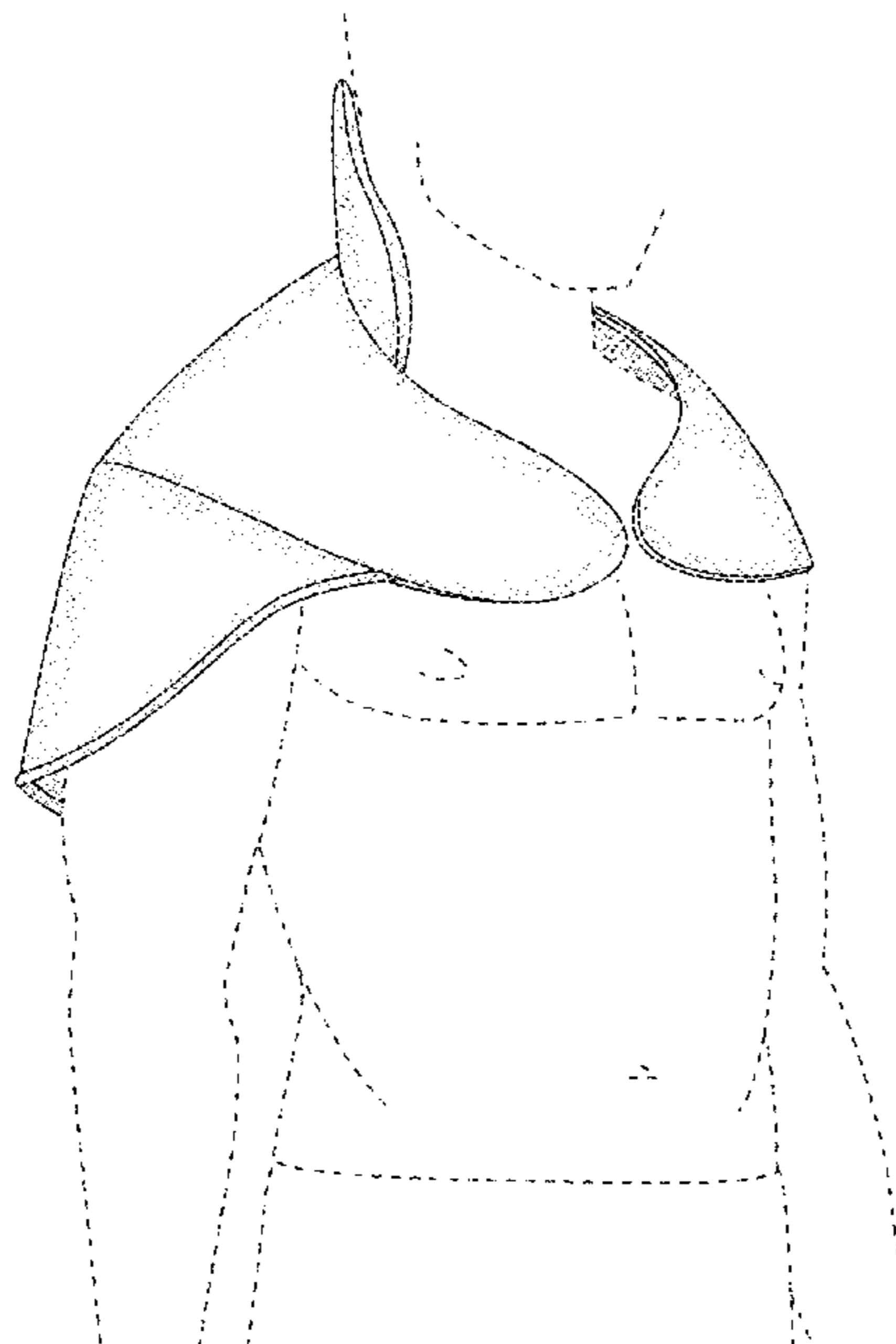

The right and left sides are symmetric. Dashed lines are used to show the environment and other shading lines are used, neither of which comprise any of the claimed invention.

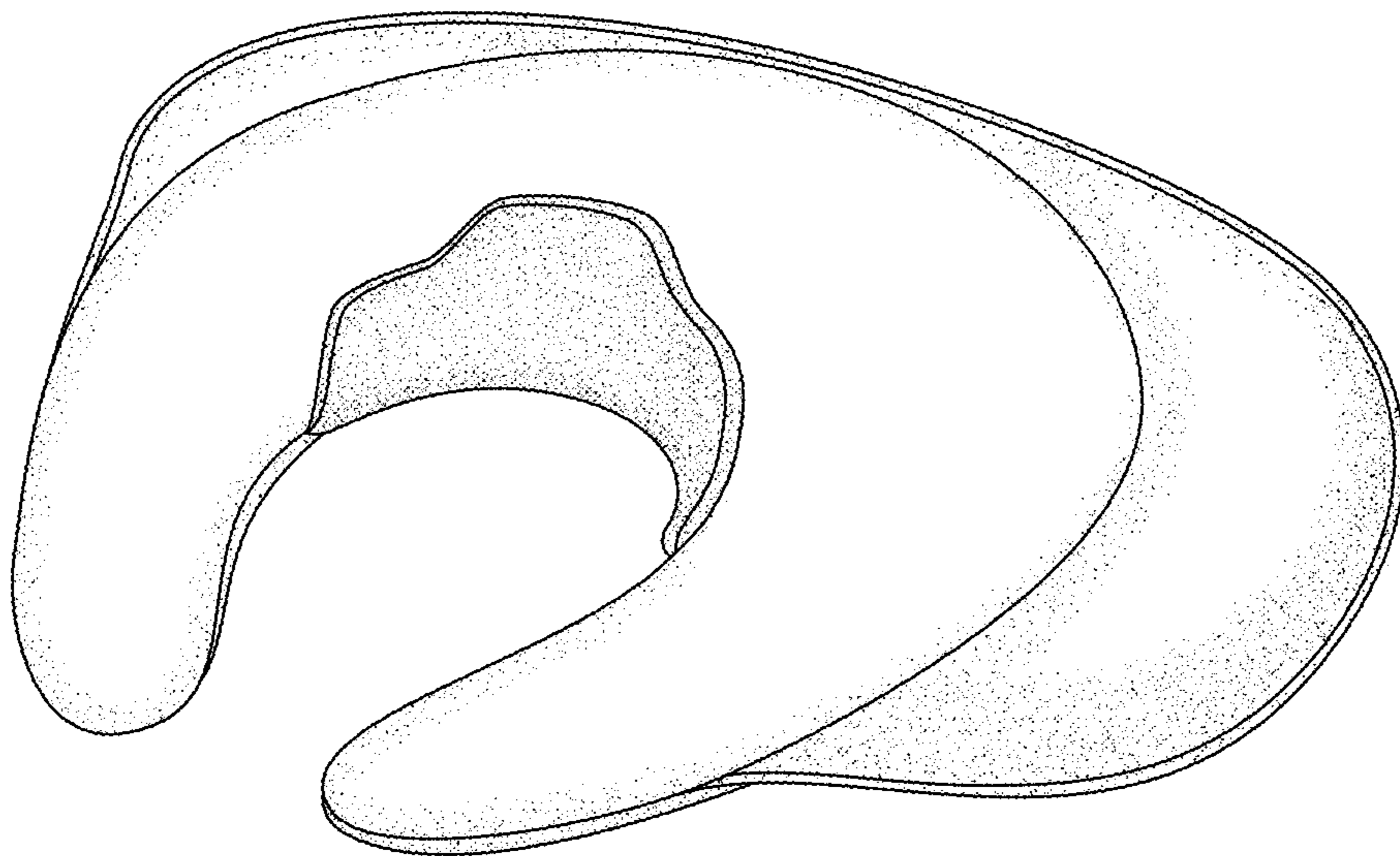

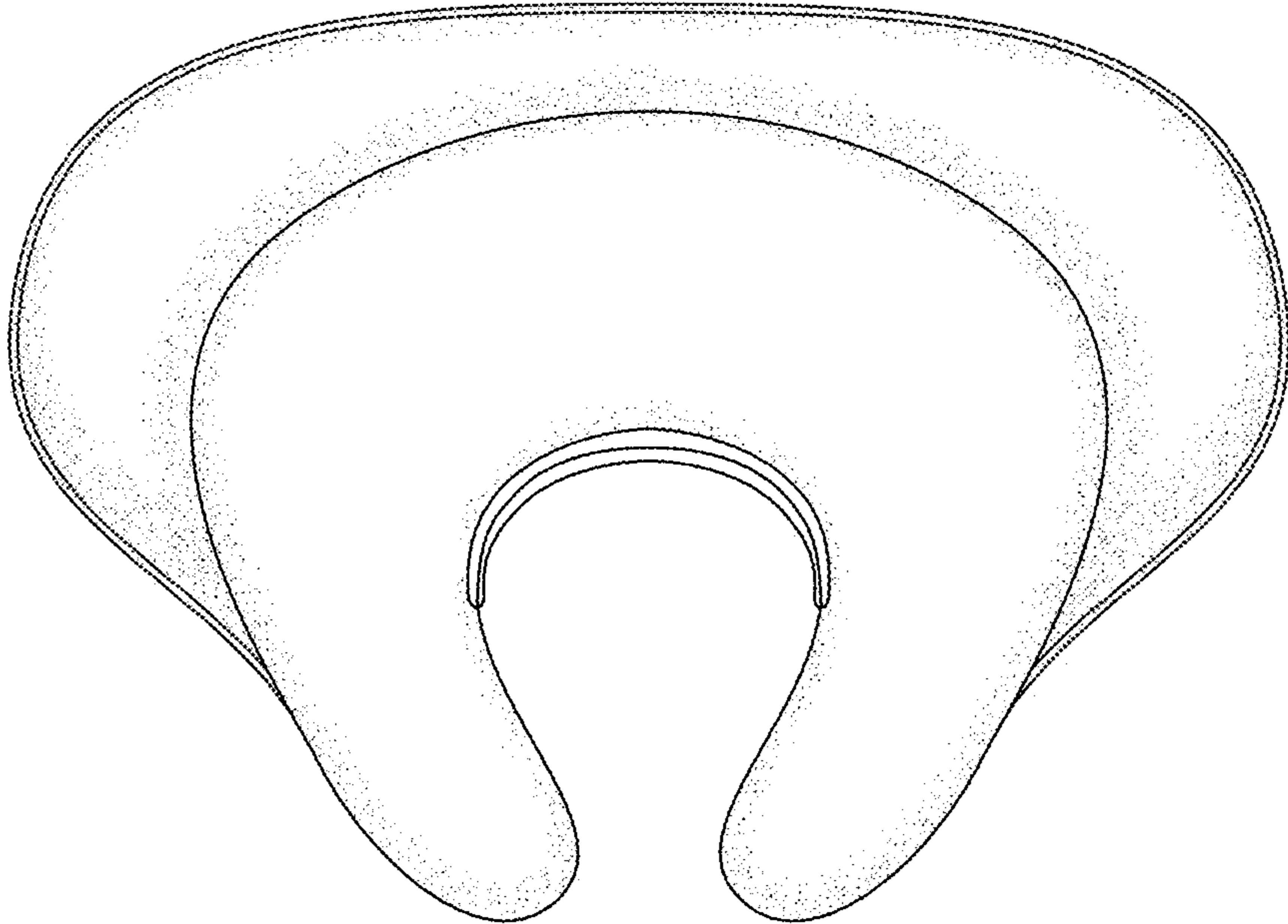

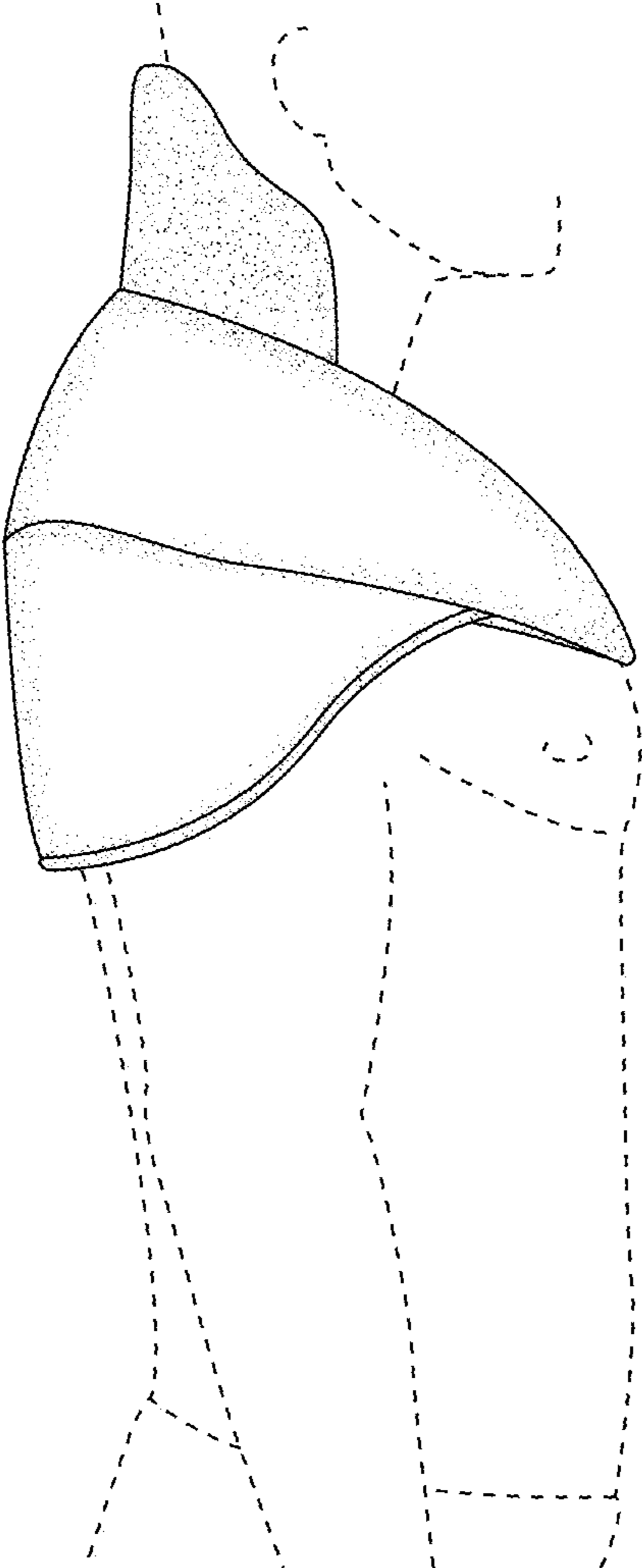

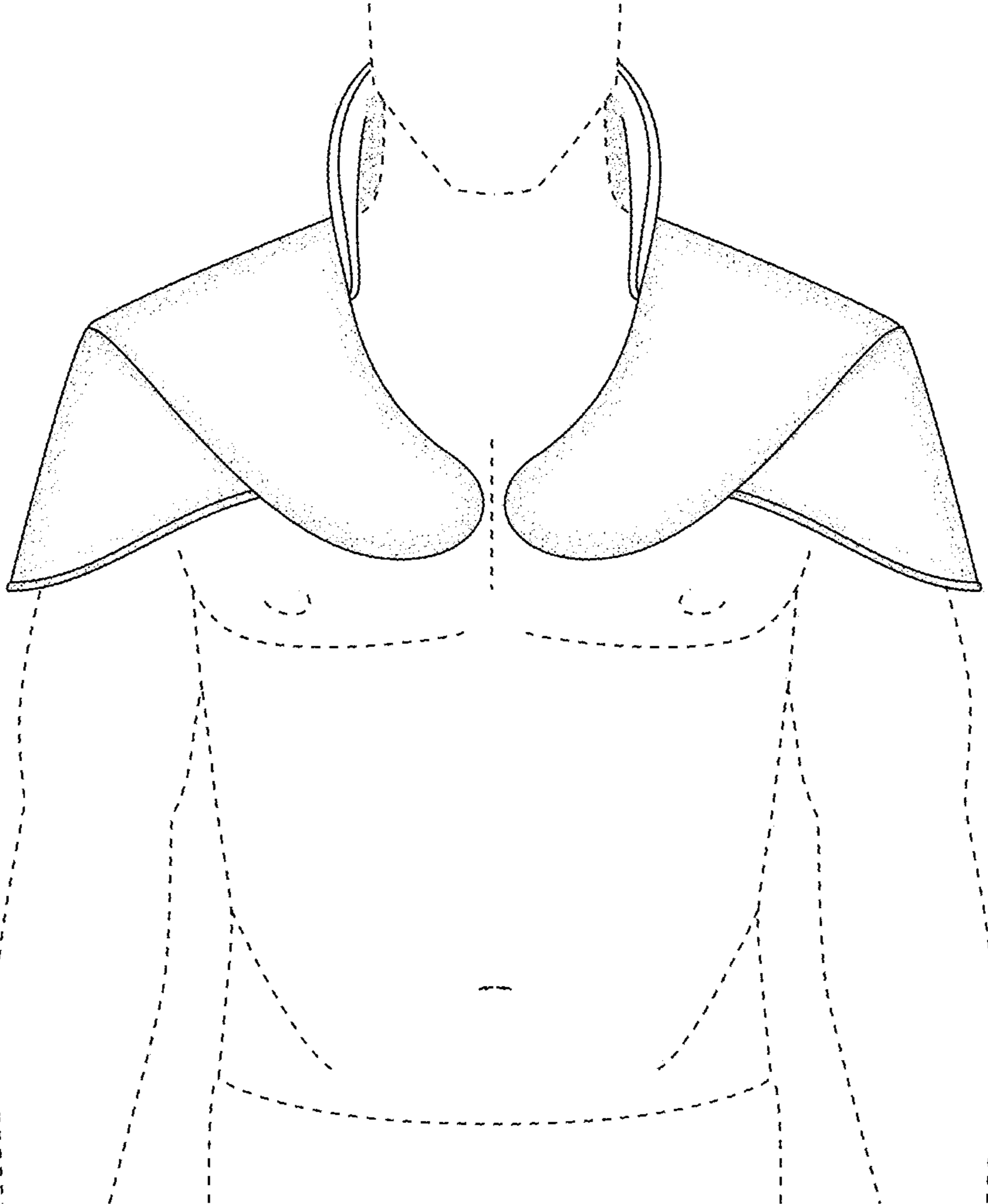

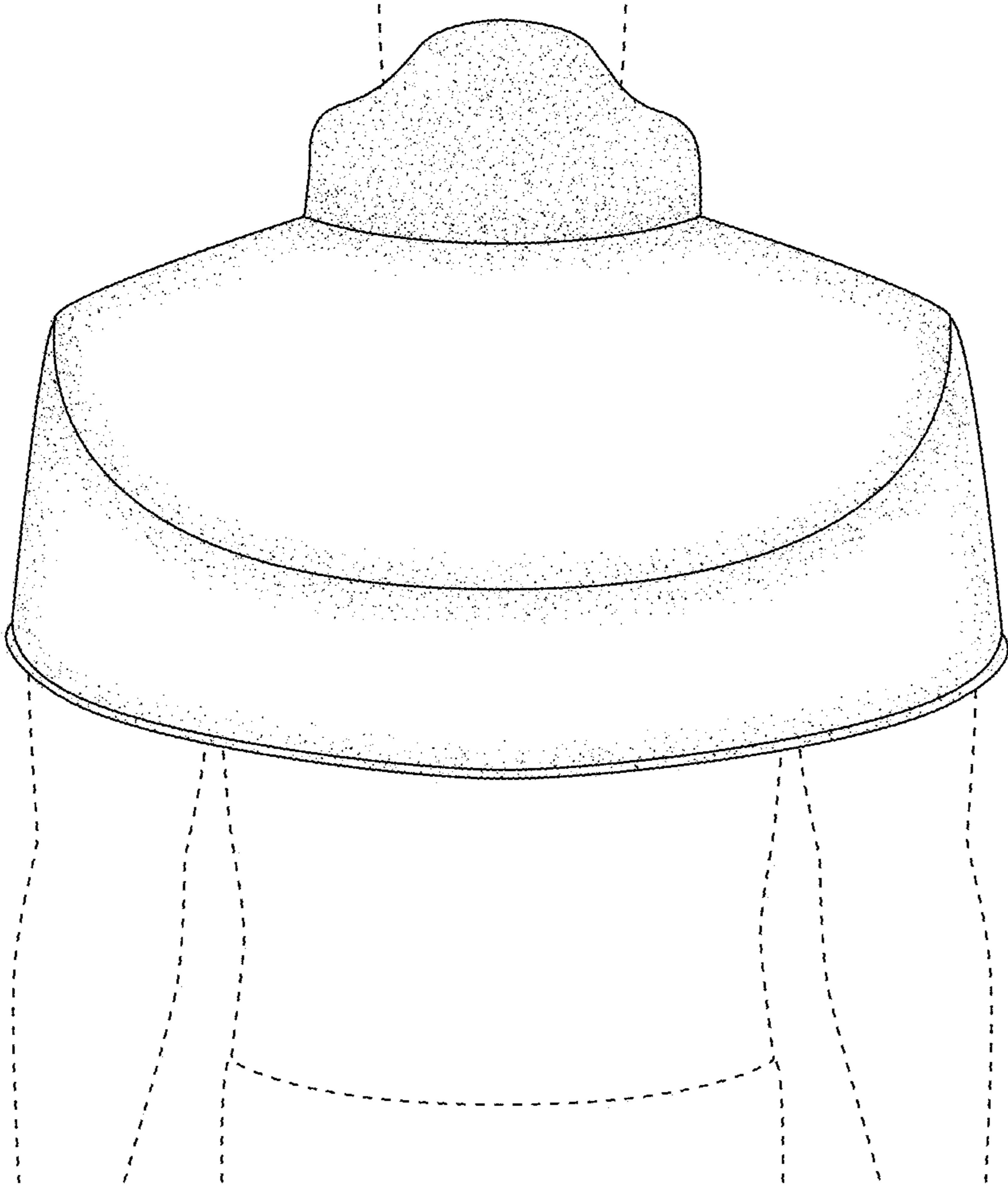
