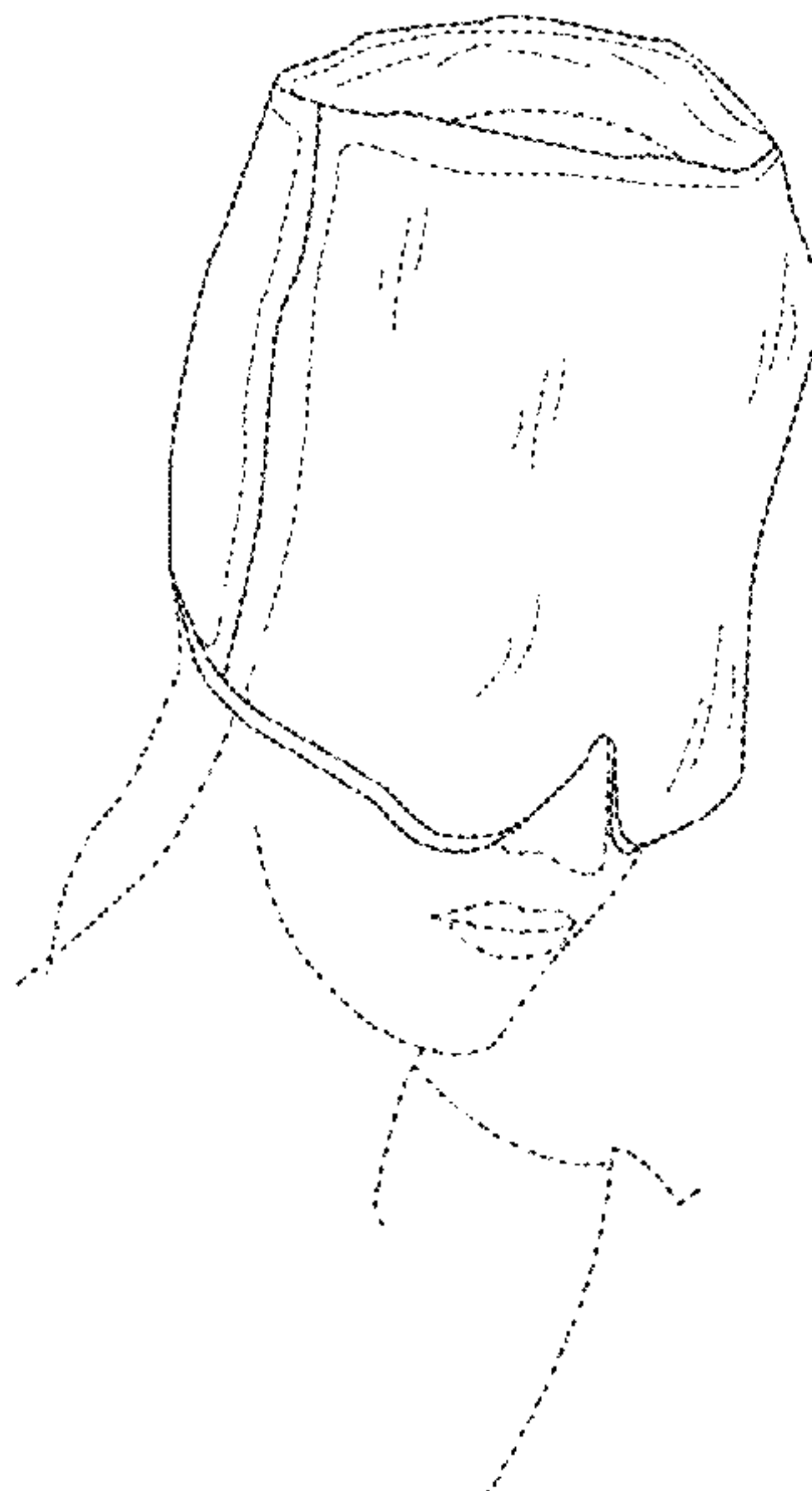
(57) **CLAIM**

The ornamental design for a gel hat, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of an ornamental design for gel hat in an open position;
FIG. 2 is a left front perspective view of the gel hat inserted over a person's head;
FIG. 3 is a front elevational view thereof in an open position;
FIG. 4 is a rear elevational view thereof in an open position;
FIG. 5 is a left side view thereof in an open position;
FIG. 6 is a right side view thereof in an open position;
FIG. 7 is a bottom view thereof in an open position;
FIG. 8 is a top view thereof in an open position;
FIG. 9 is a left front perspective view of an ornamental design for gel hat in a closed position;
FIG. 10 is a rear elevational view thereof in a closed position;
FIG. 11 is a front elevational view thereof in a closed position;
FIG. 12 is a bottom view thereof in a closed position;
FIG. 13 is a top view thereof in a closed position;
FIG. 14 is a left side view thereof in a closed position; and, FIG. 15 is a right side view thereof in a closed position.

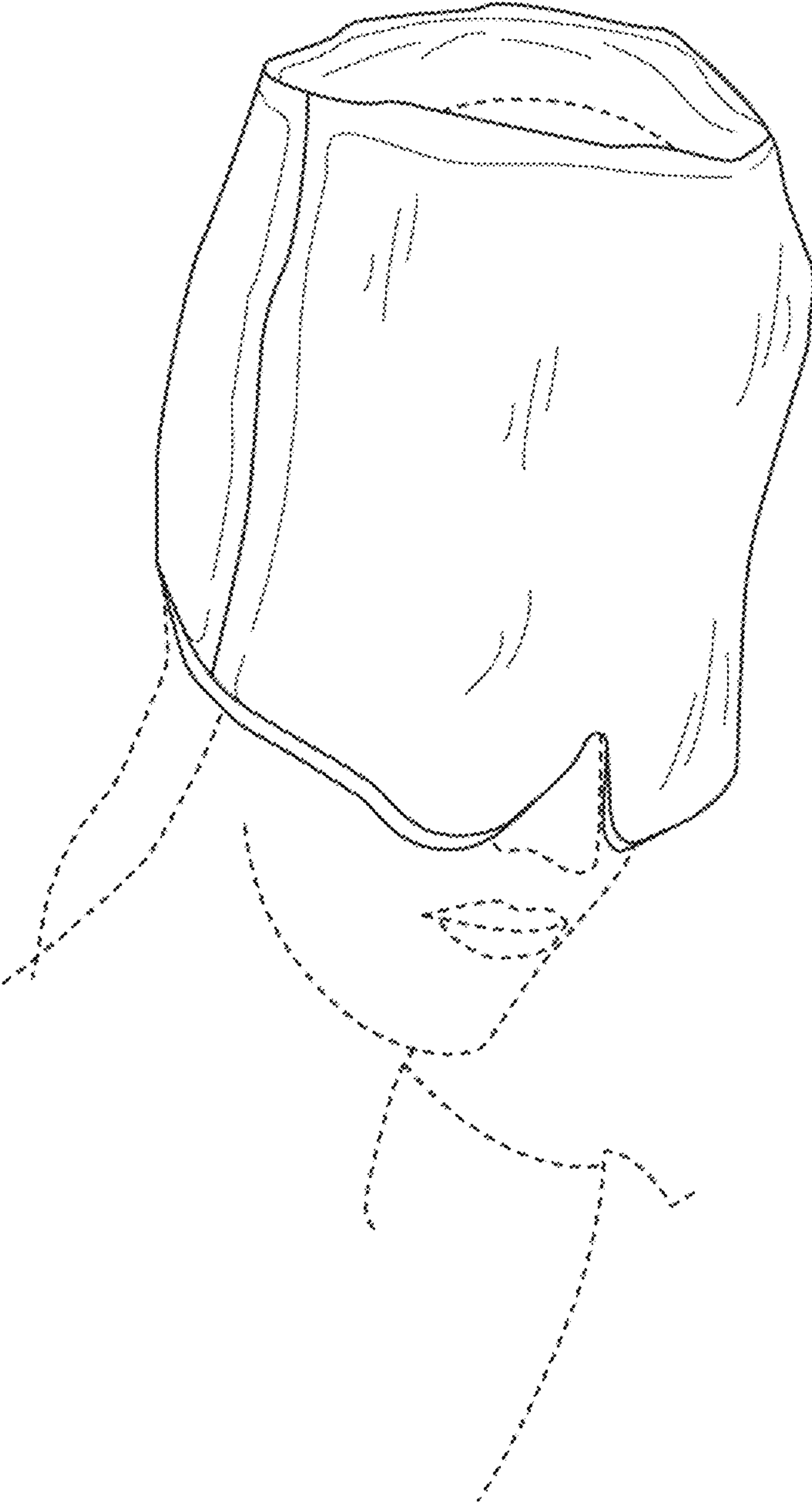

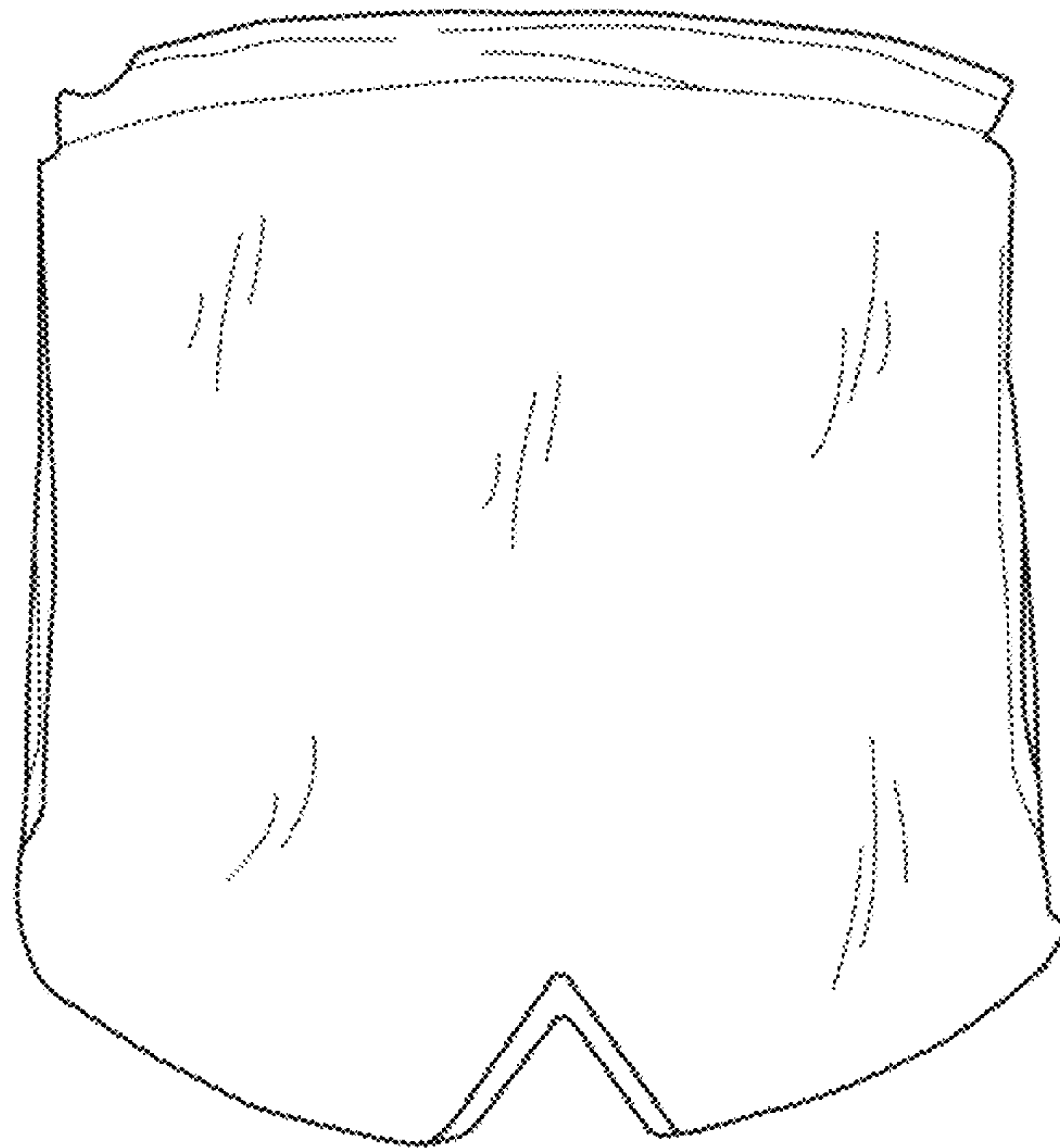

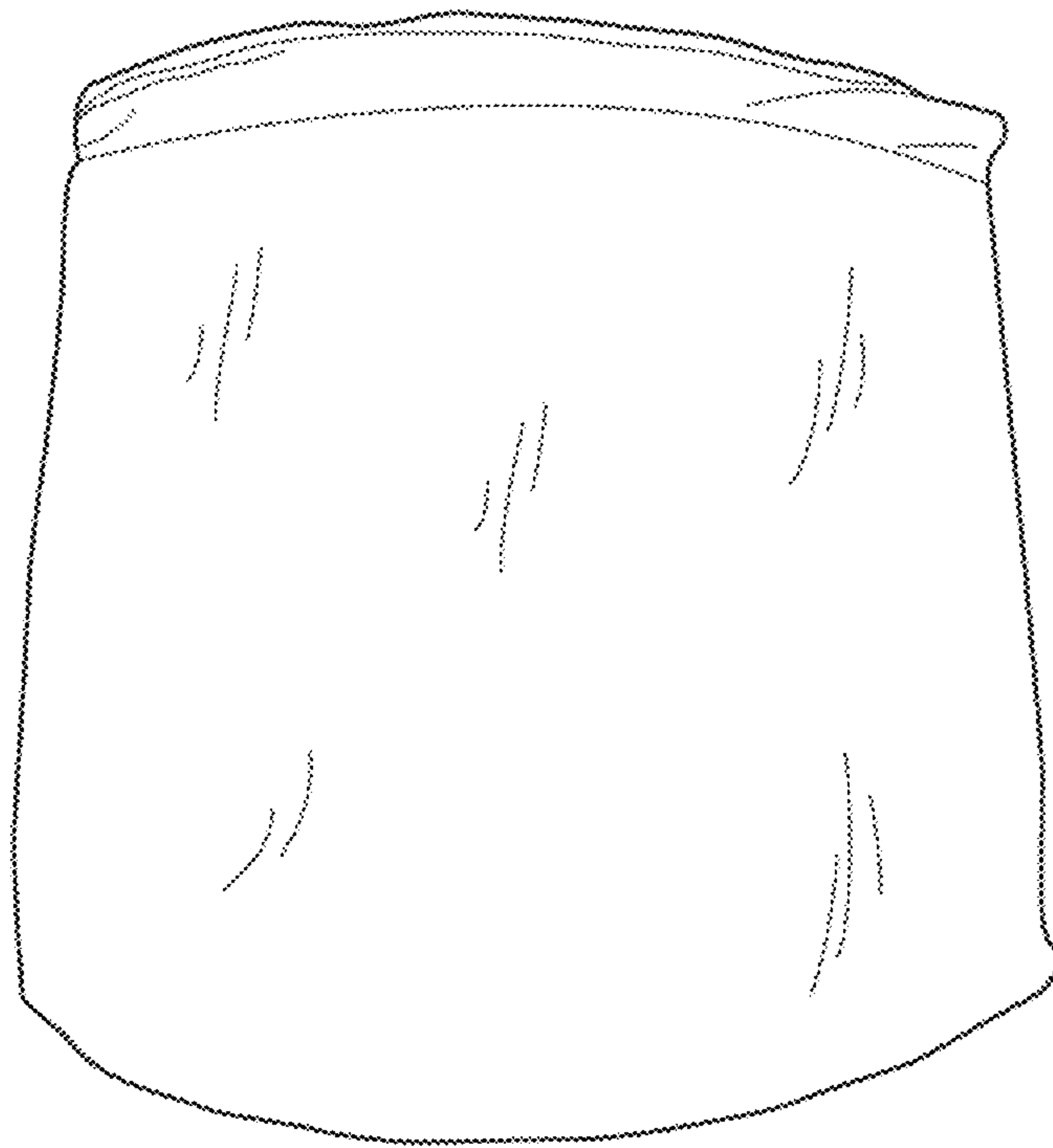

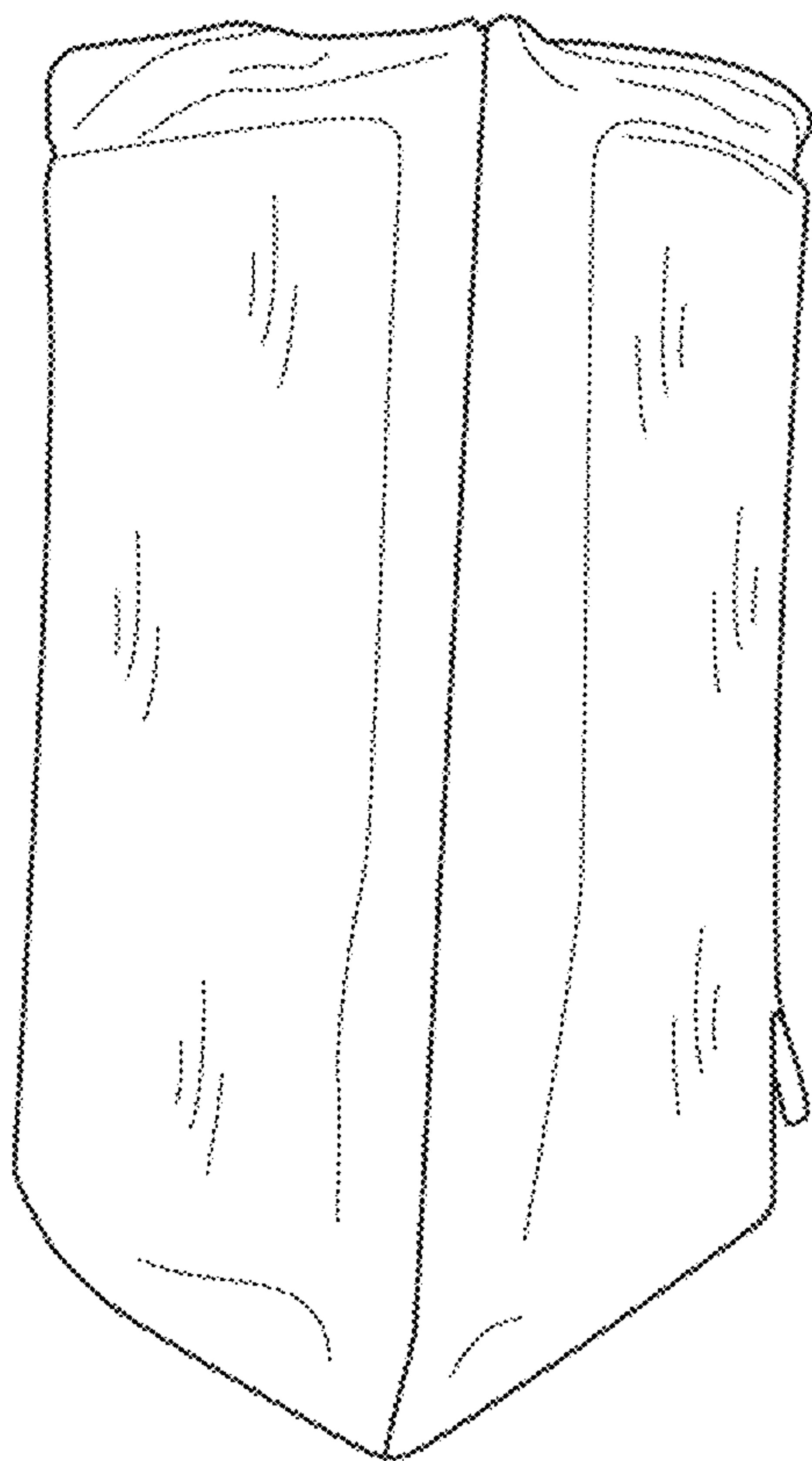

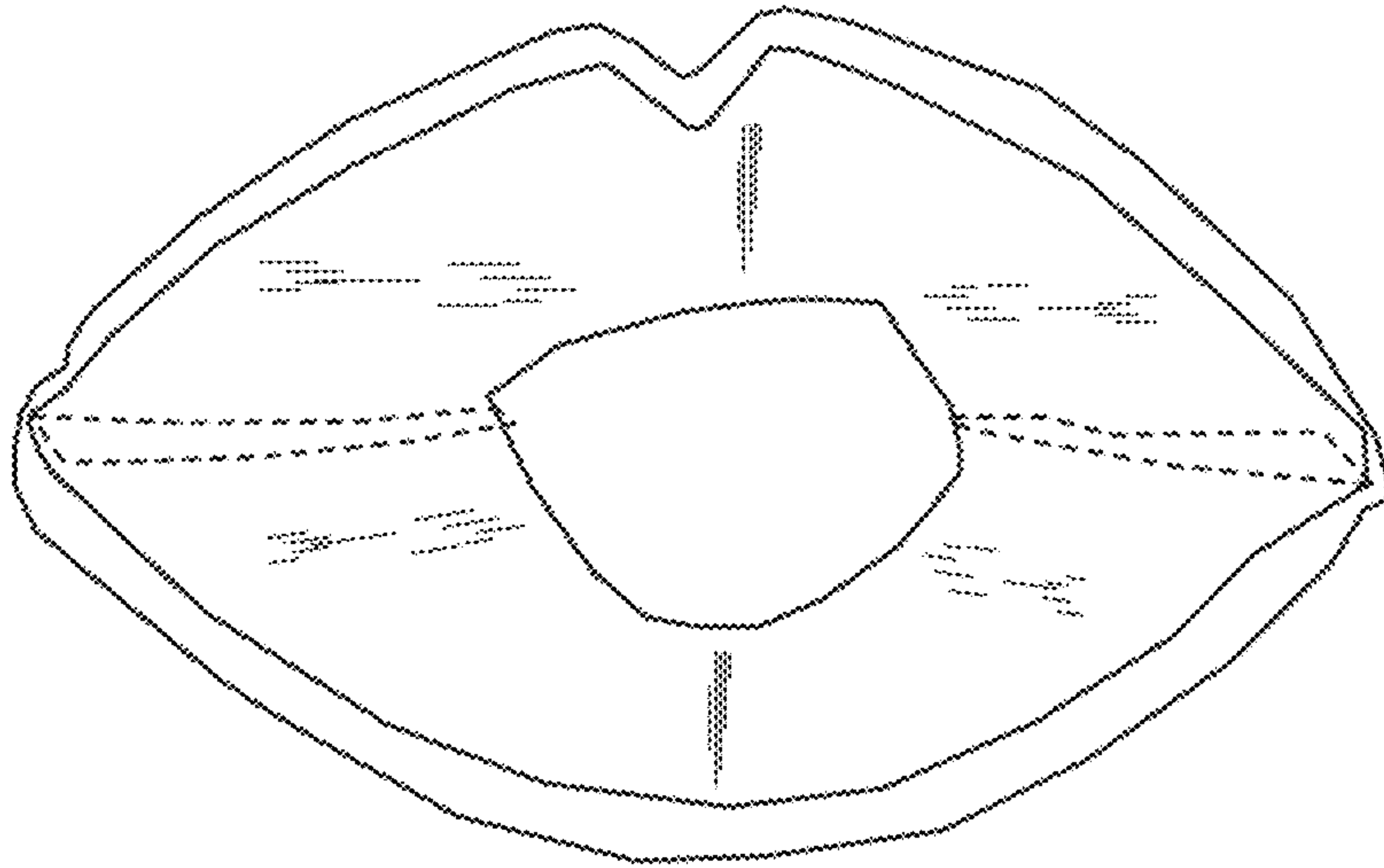

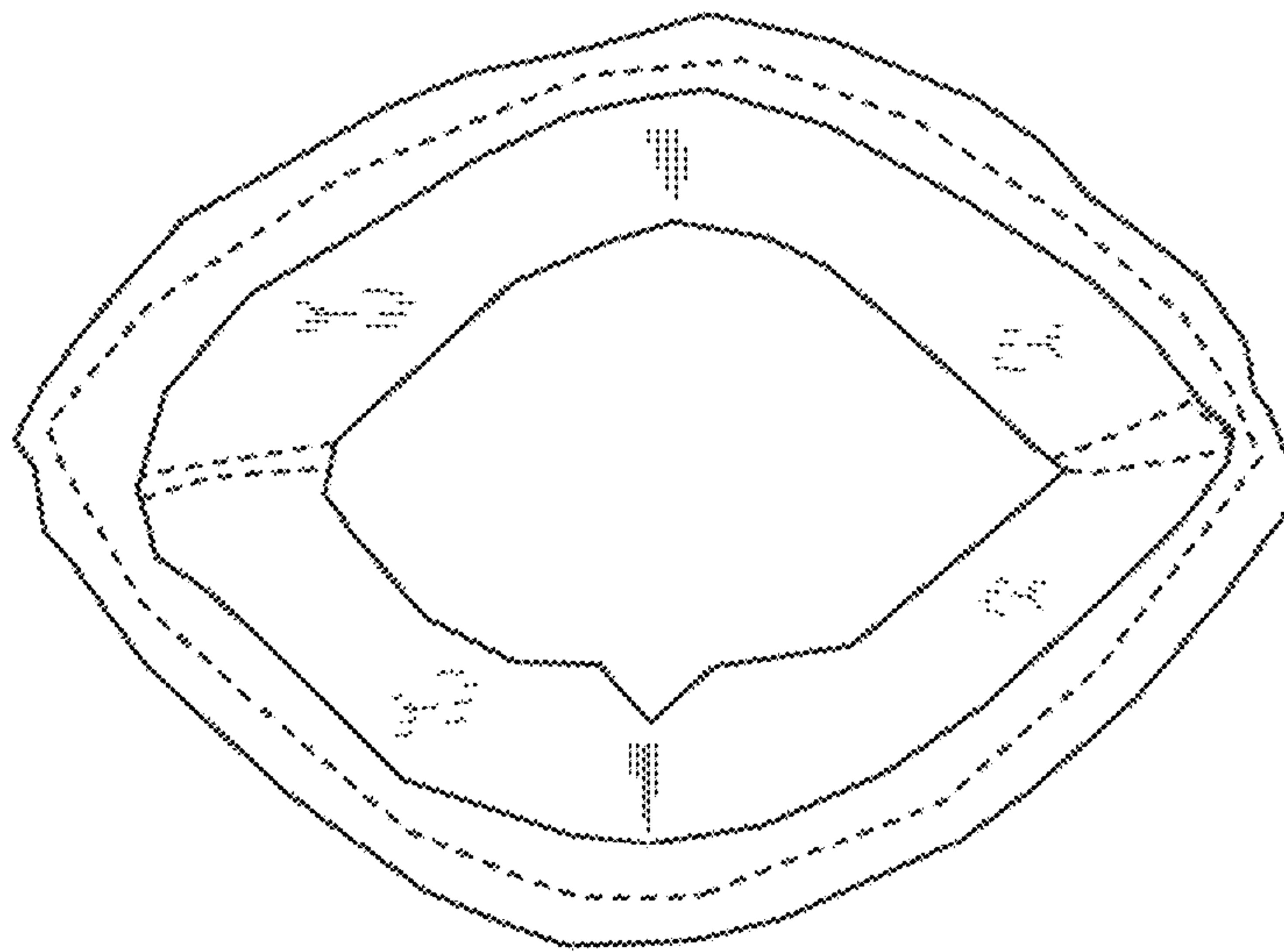

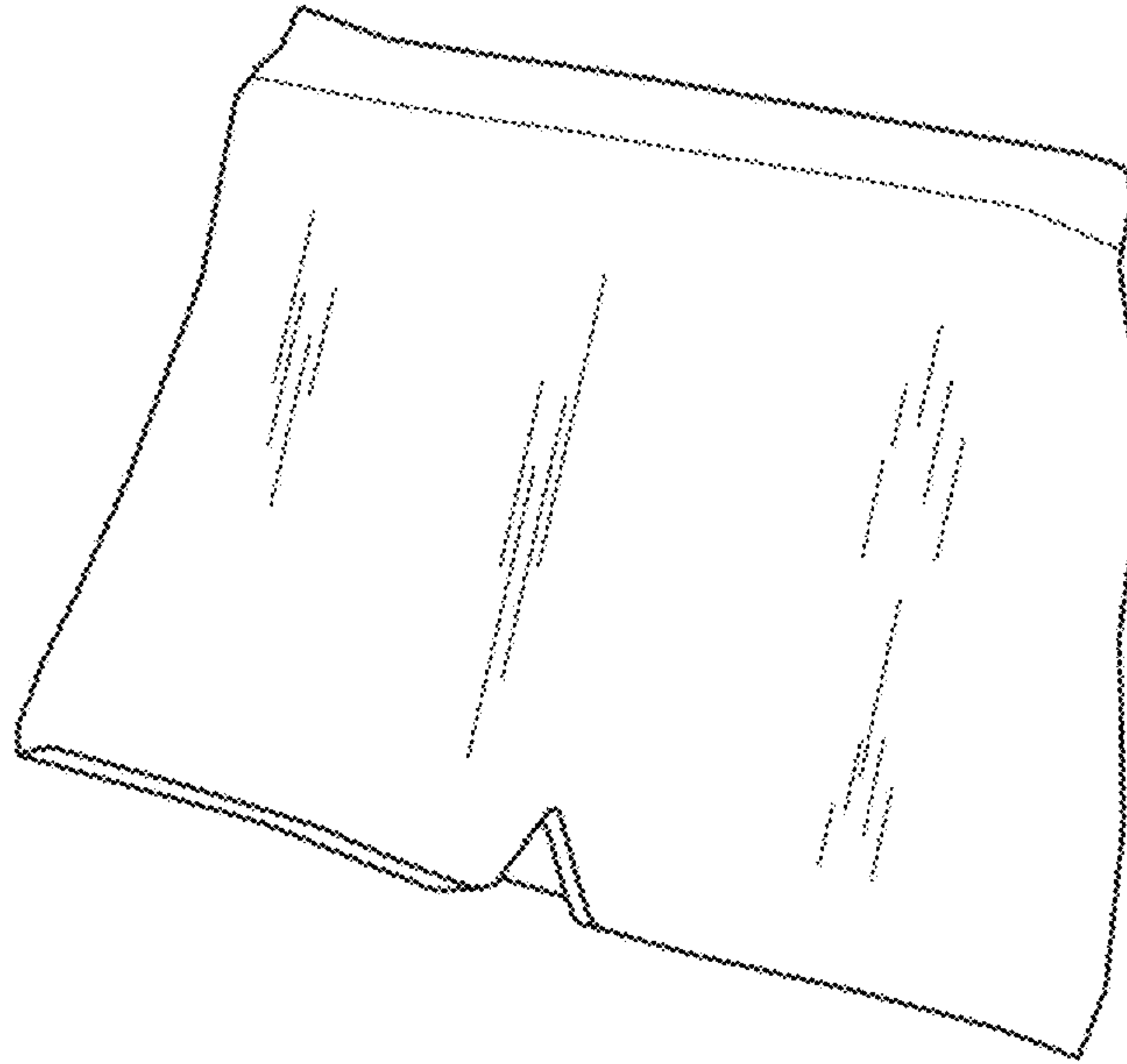

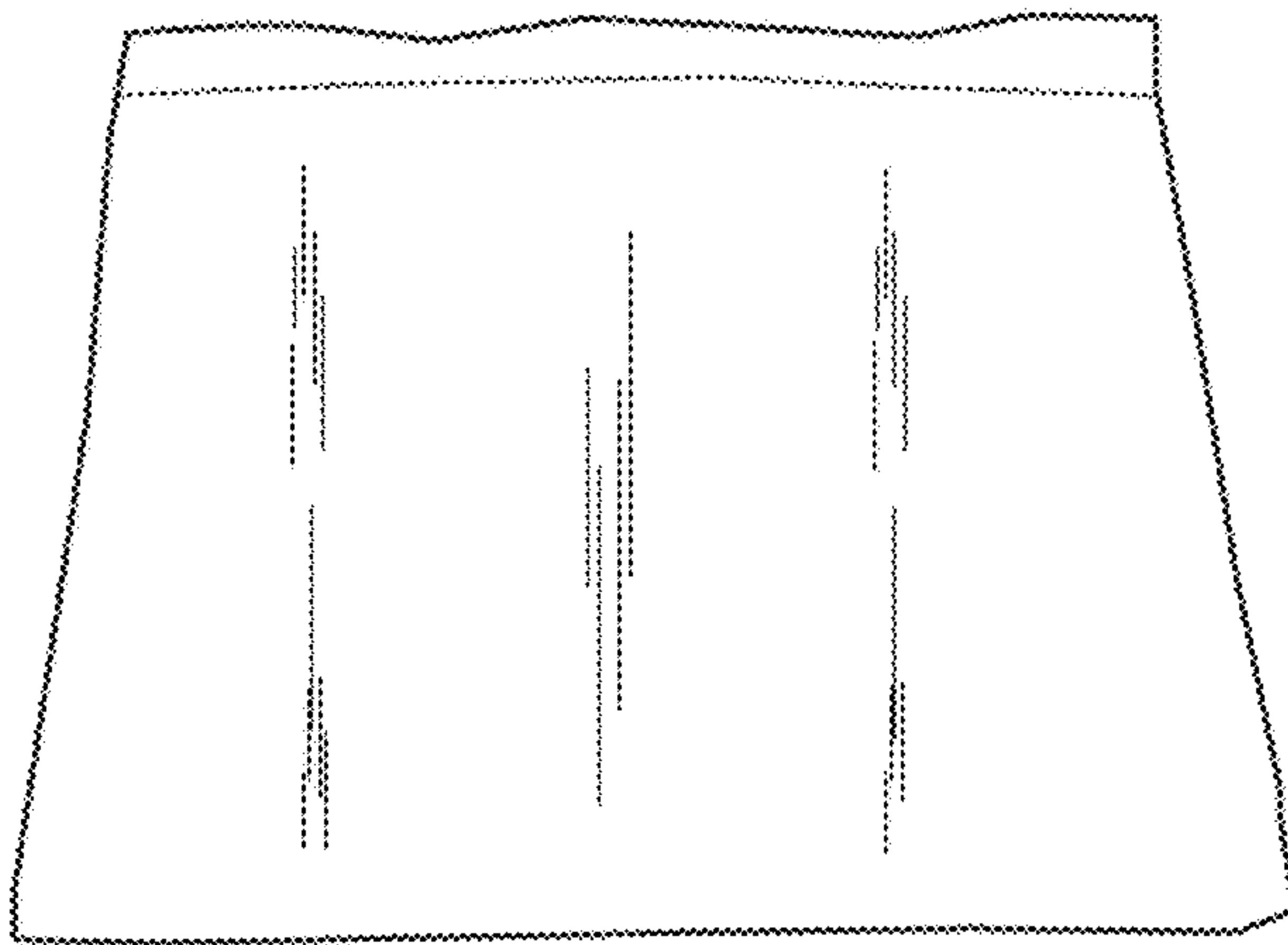

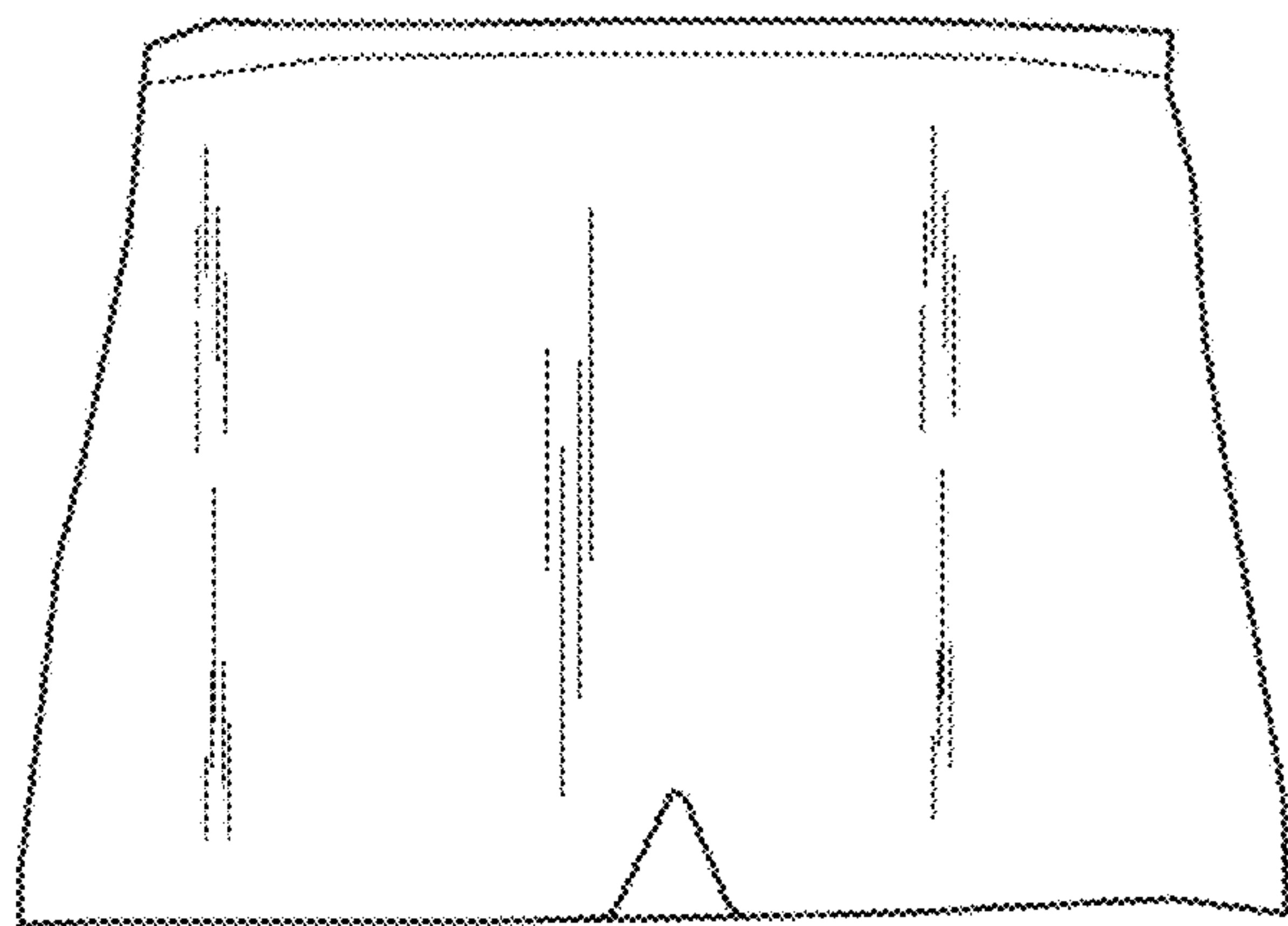

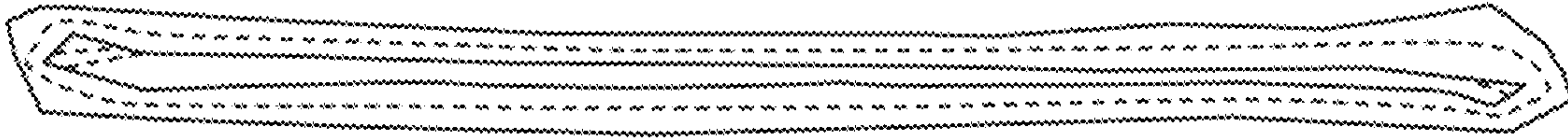

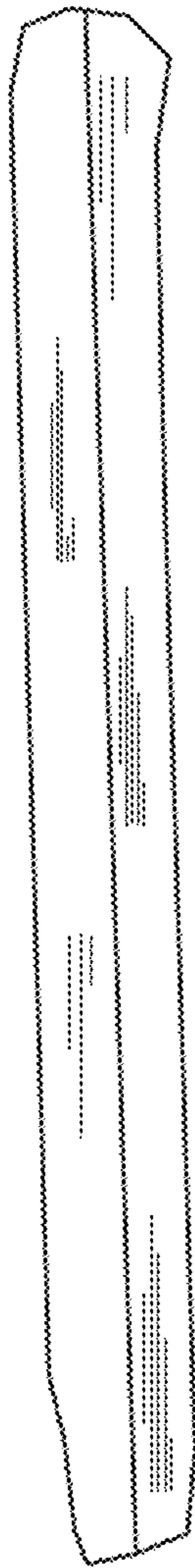

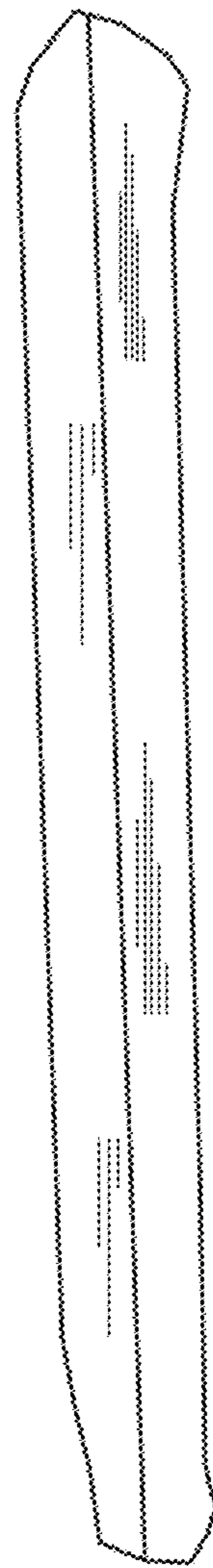
