The ornamental design for a toothbrush, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a toothbrush showing my new design;

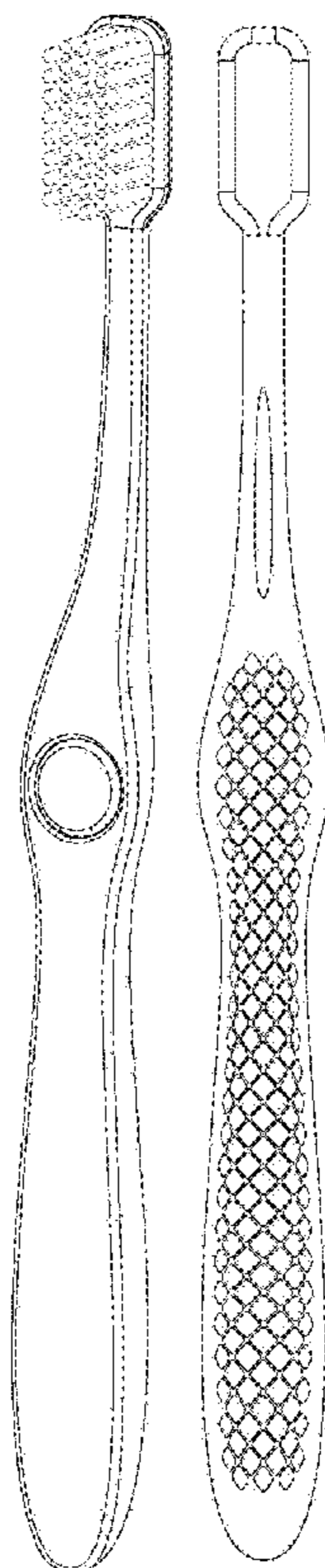

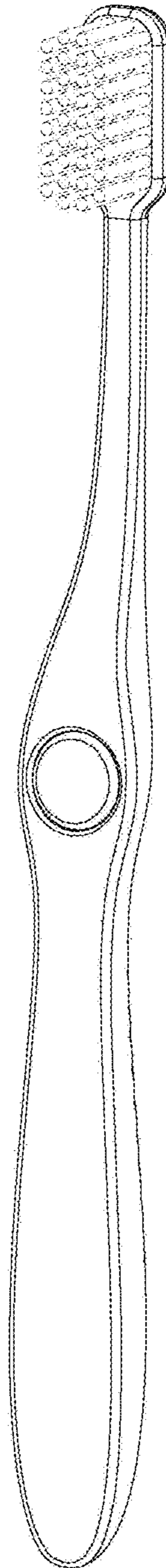

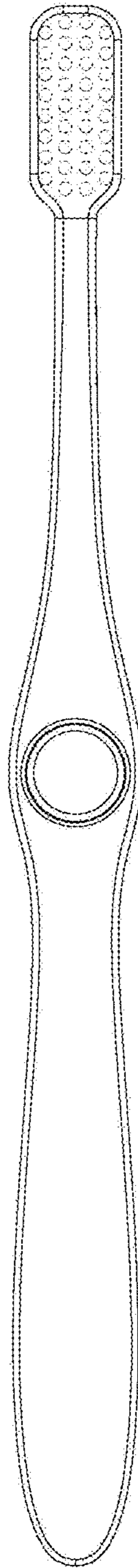

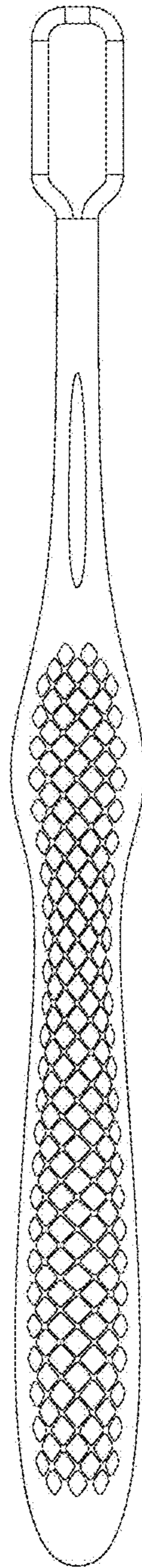

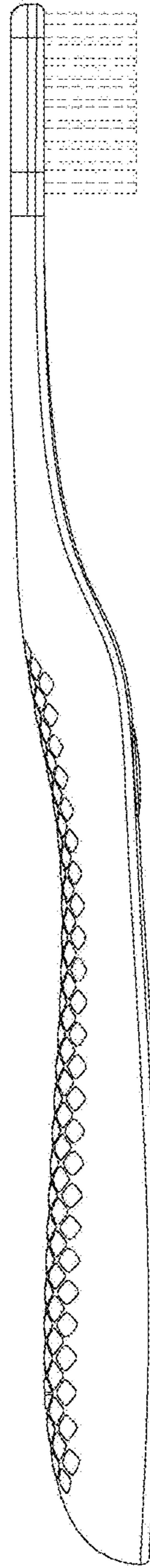

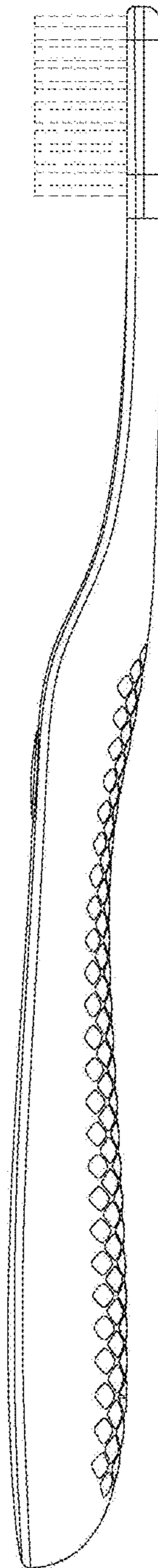

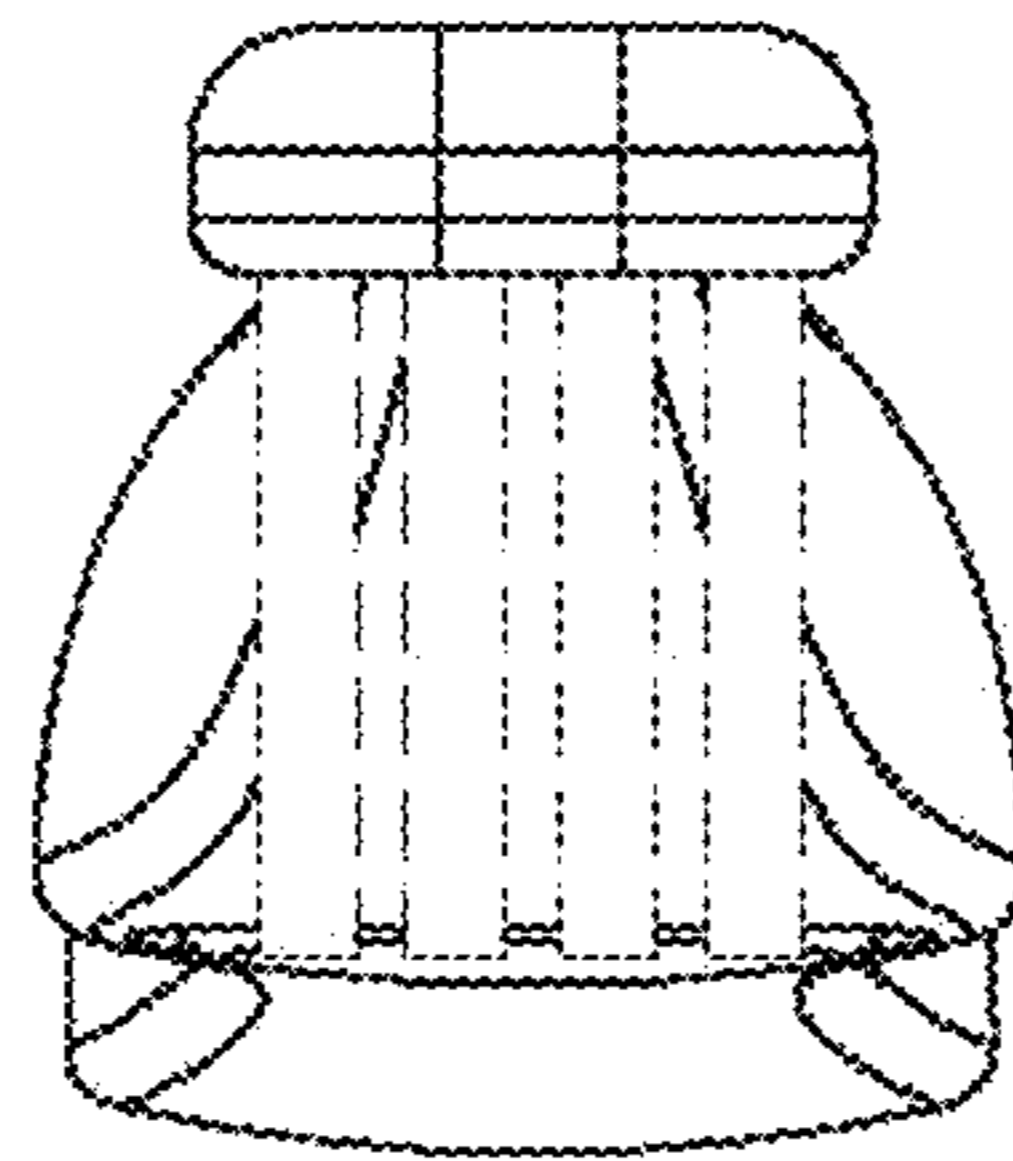
