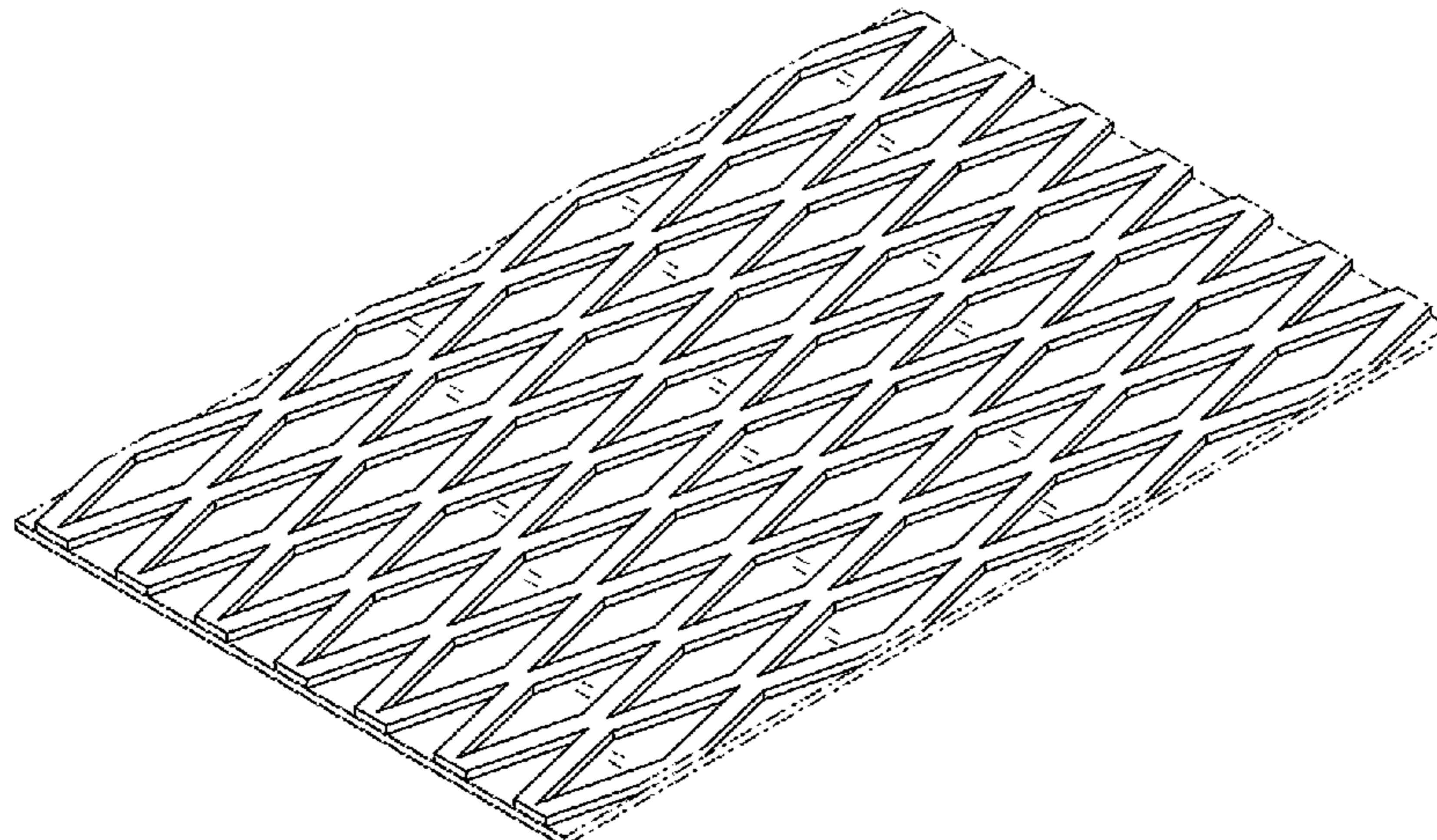

(57) CLAIM

The ornamental design for a patterned reflective material, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a patterned reflective material in accordance with an embodiment of the claimed design;

 FIG. 4 is a bottom plan view of the design of FIG. 1;
 FIG. 5 is a right side elevation view of the design of FIG. 1;
 FIG. 6 is a front right perspective view of a patterned reflective material in accordance with another embodiment of the claimed design;
 FIG. 7 is a front elevation view of the design of FIG. 6;

 The dot-dash broken lines in the figures immediately adjacent the solid lines illustrate a boundary between claimed and unclaimed subject matter and form no part of the claimed design.

The surfaces between the solid lines and between the solid lines and the dot-dash broken lines are part of the claimed design. These surfaces may not include surface shading, for the purpose of clarity, due to proximity of the lines.

The left side elevation views and the top plan views of each of the embodiments illustrated are not shown and form no part of the claimed design.

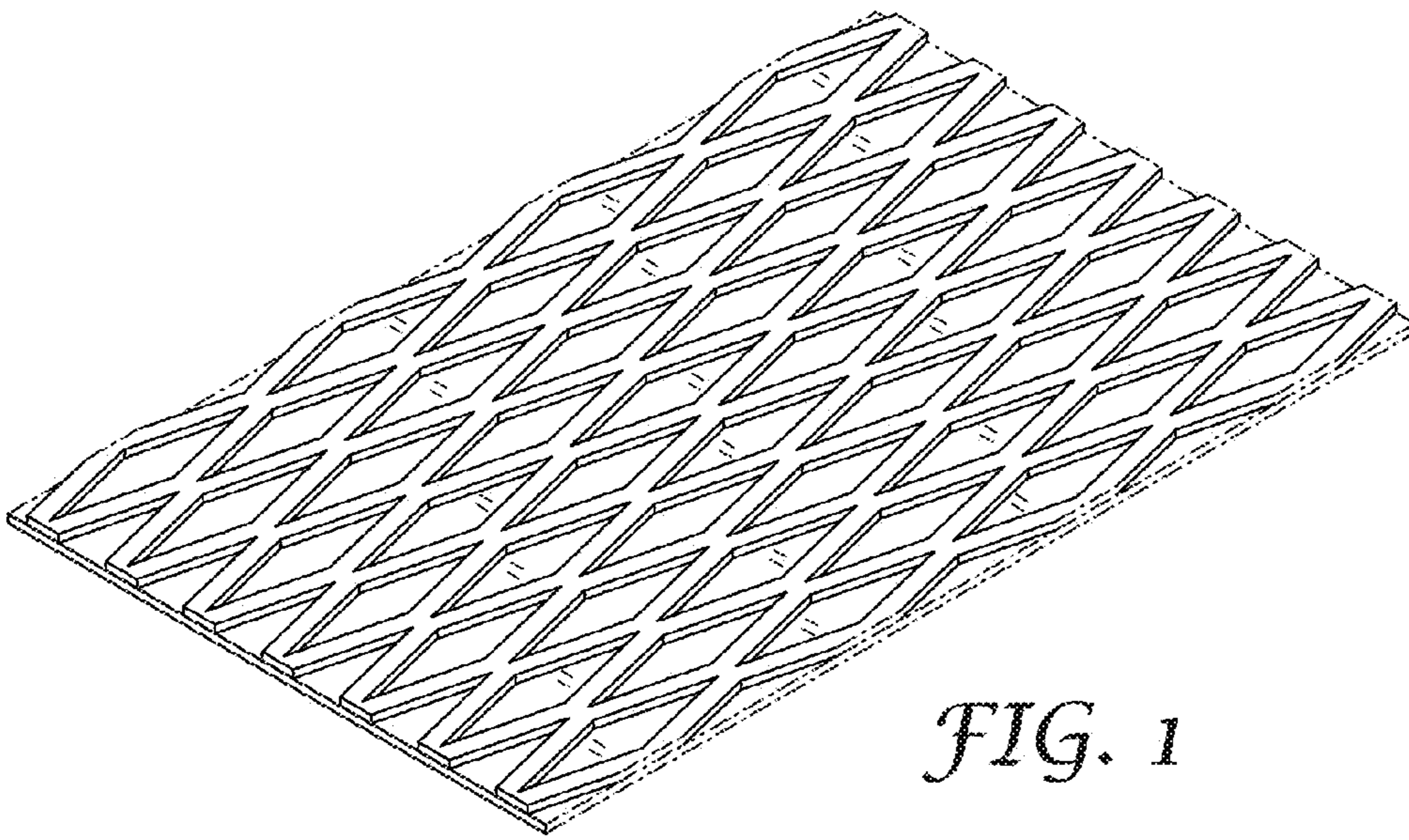

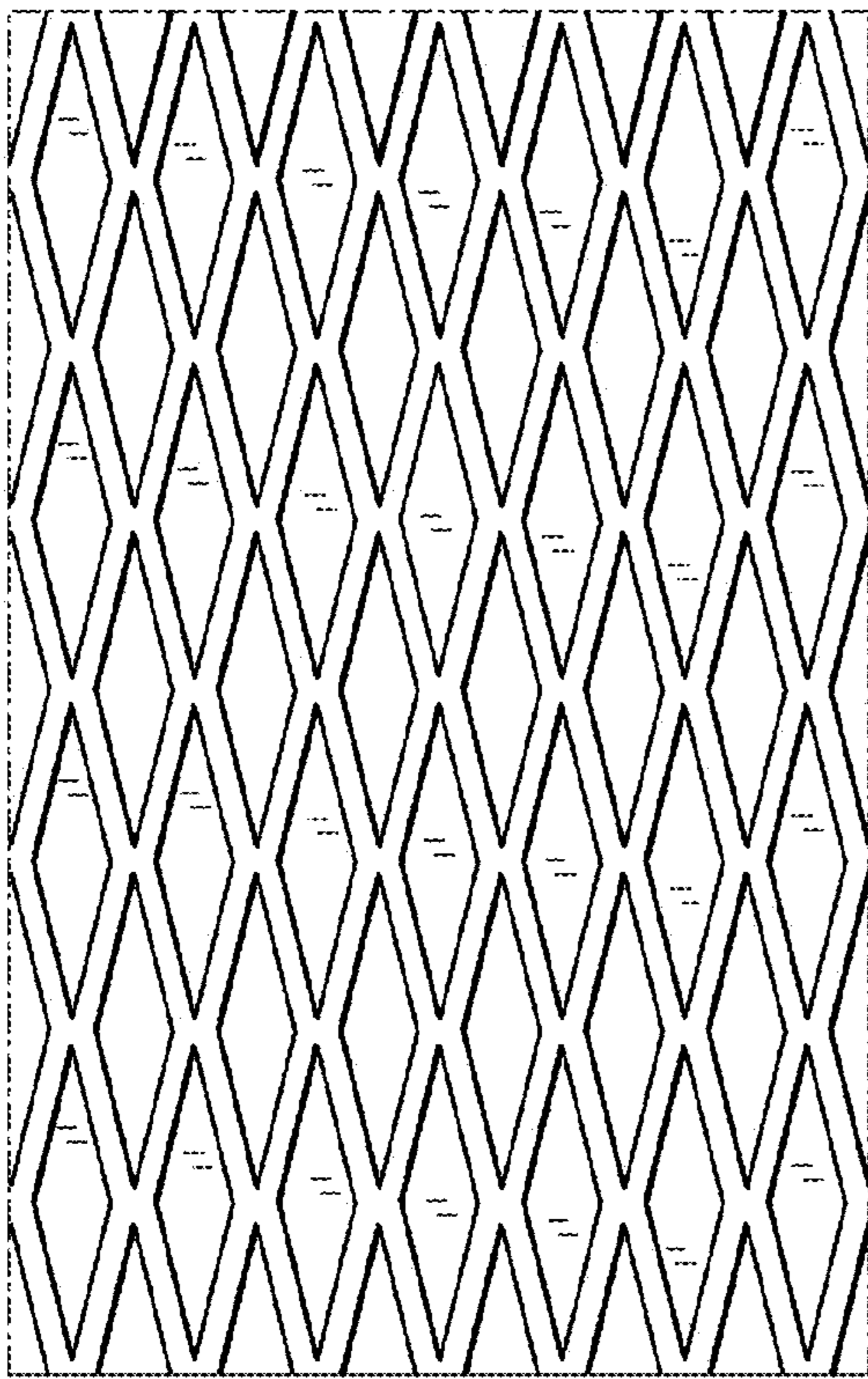

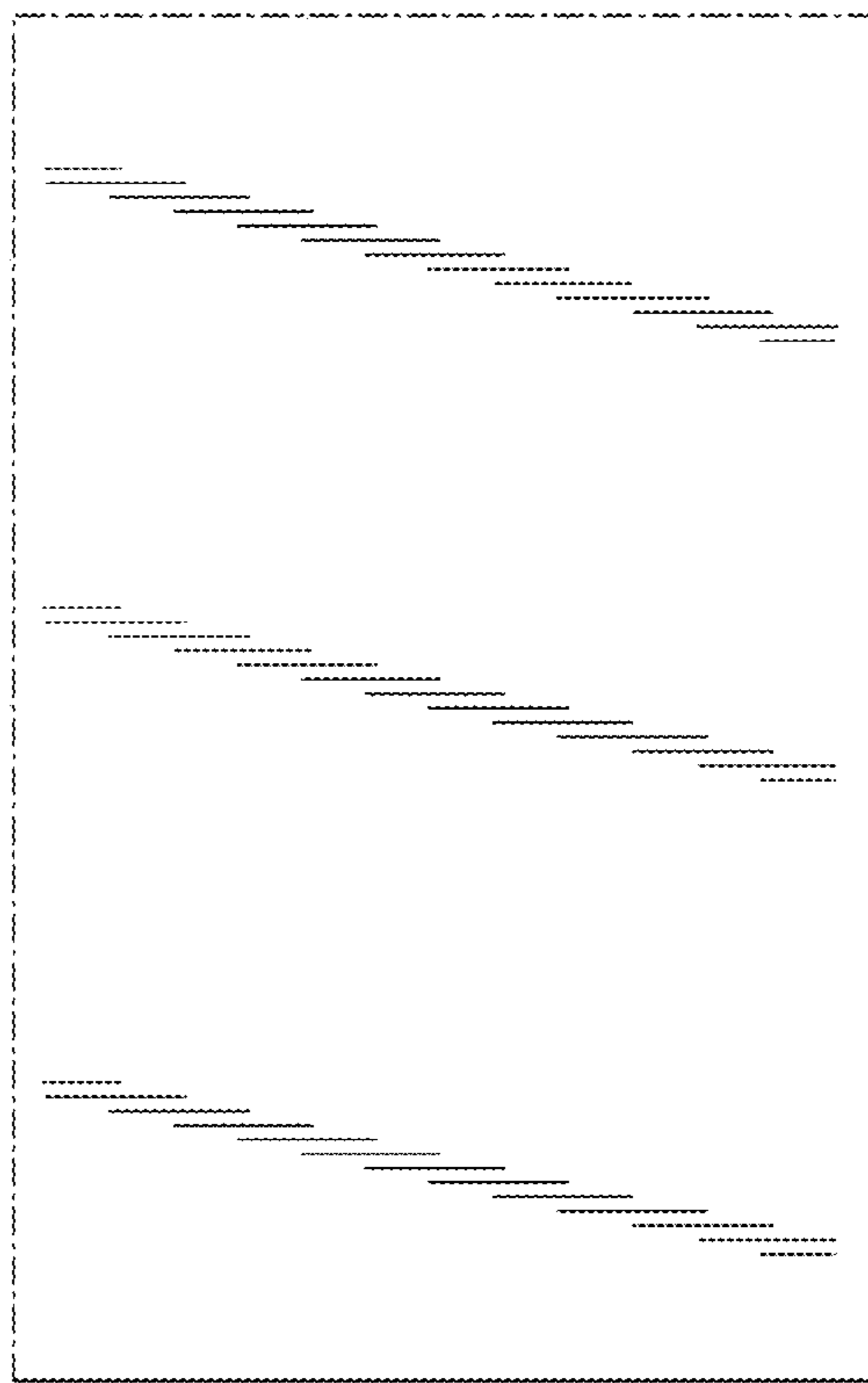

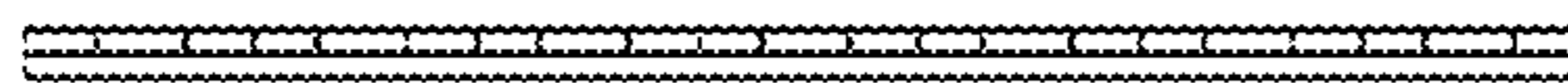

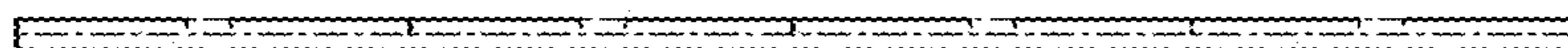

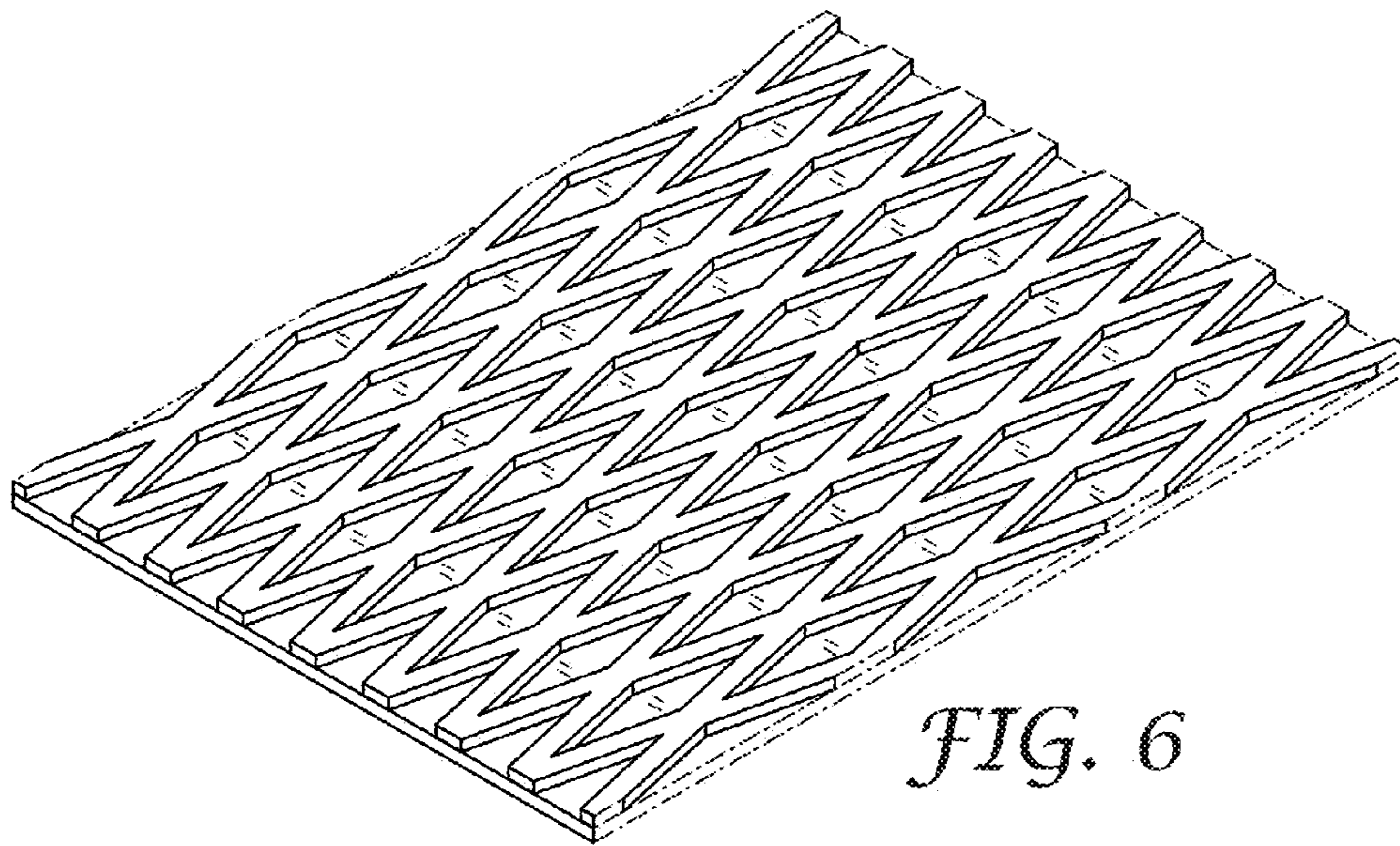

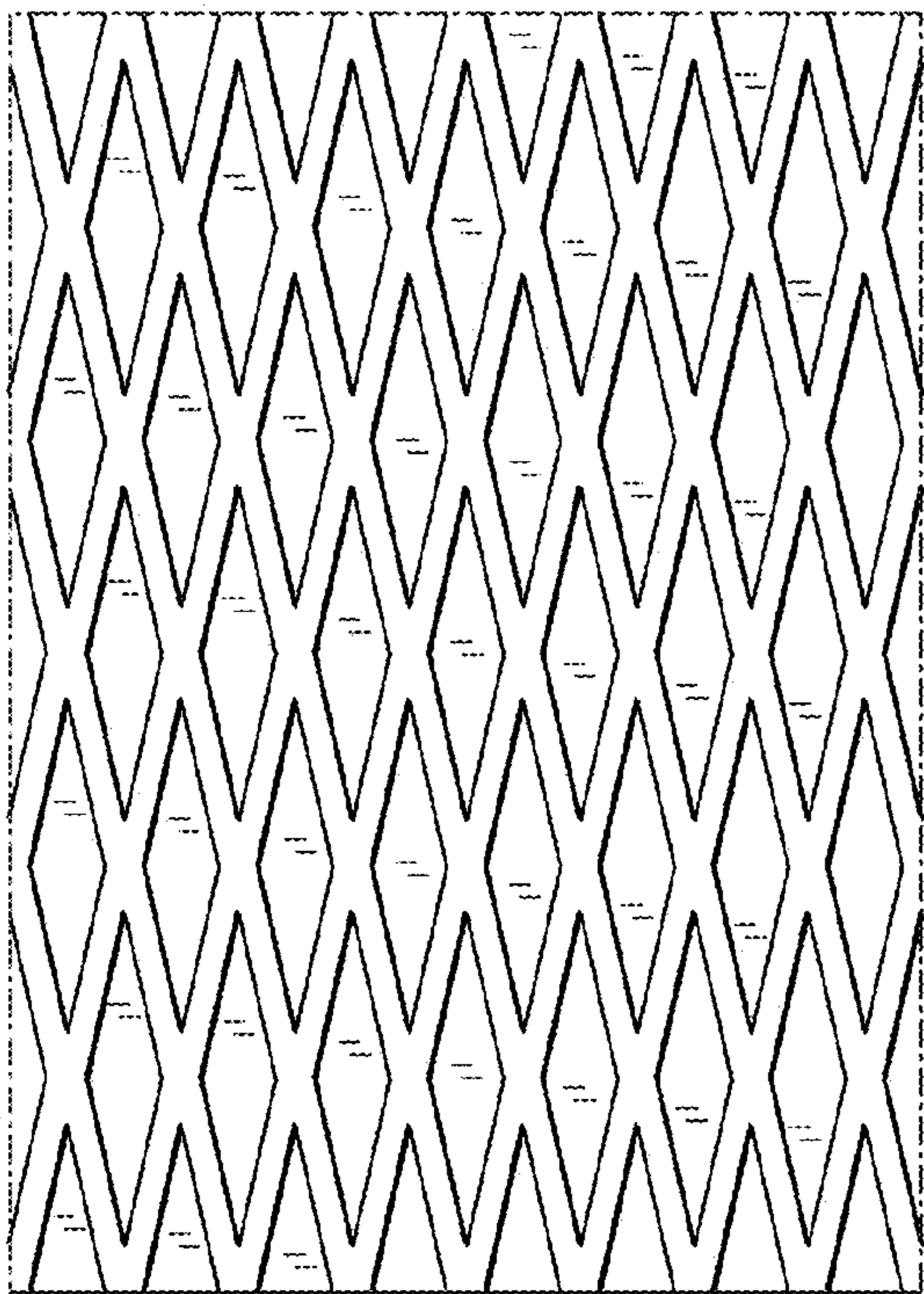

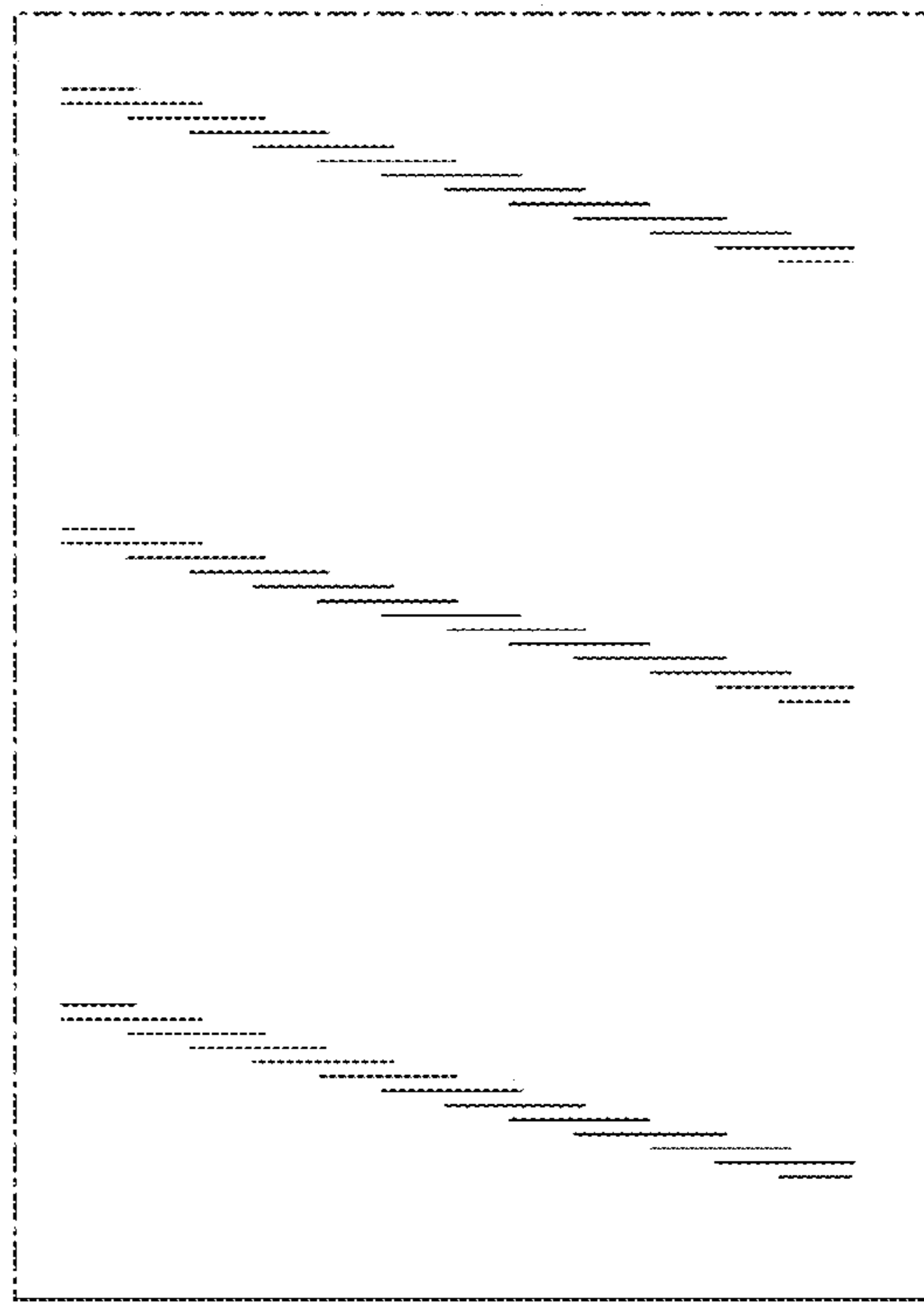

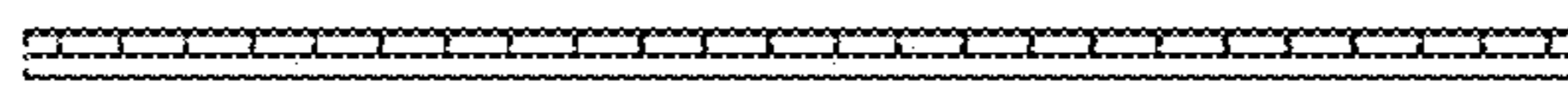

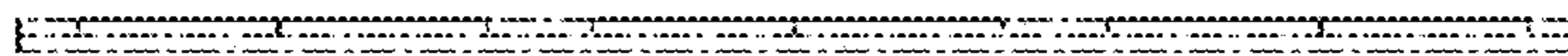

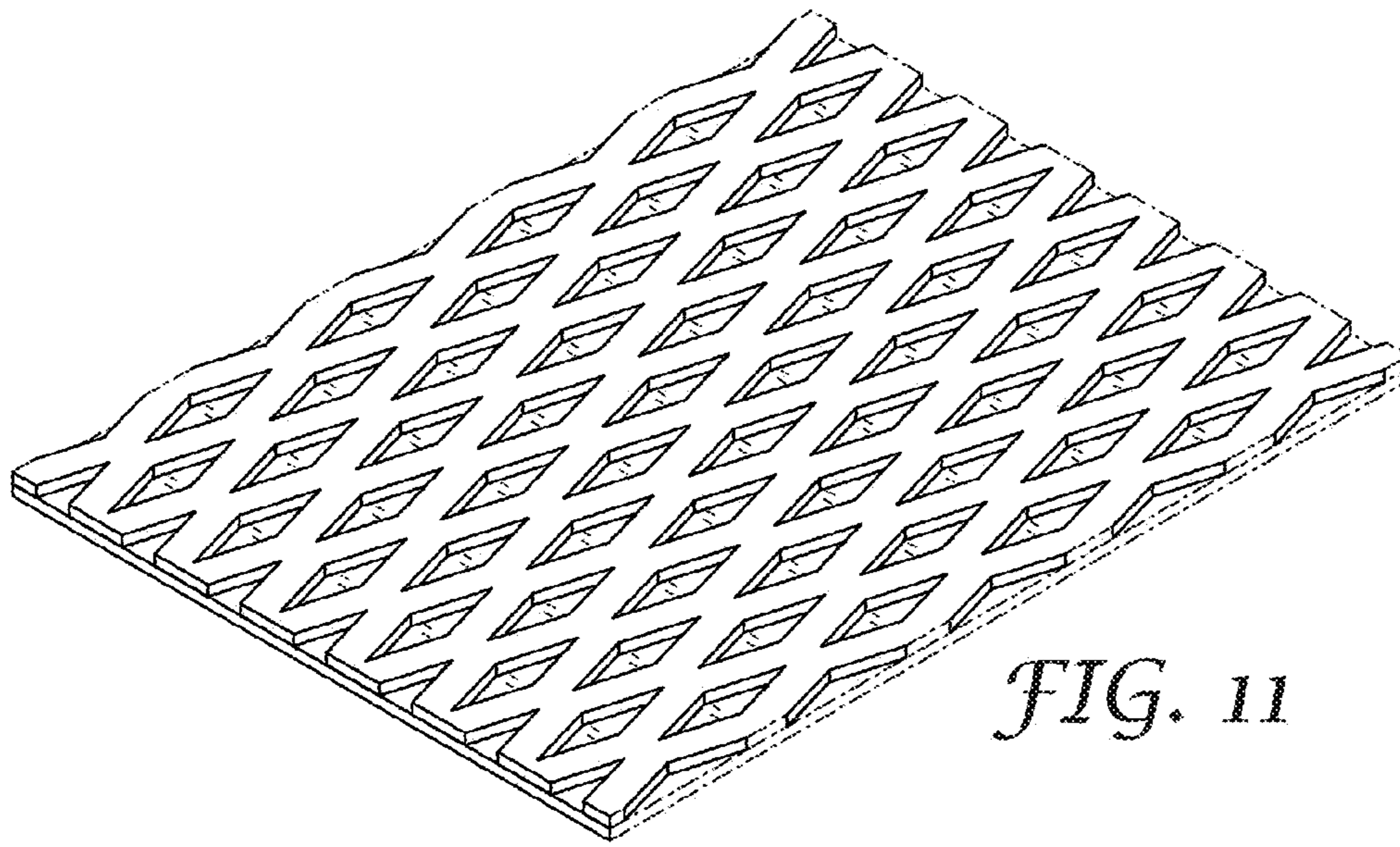

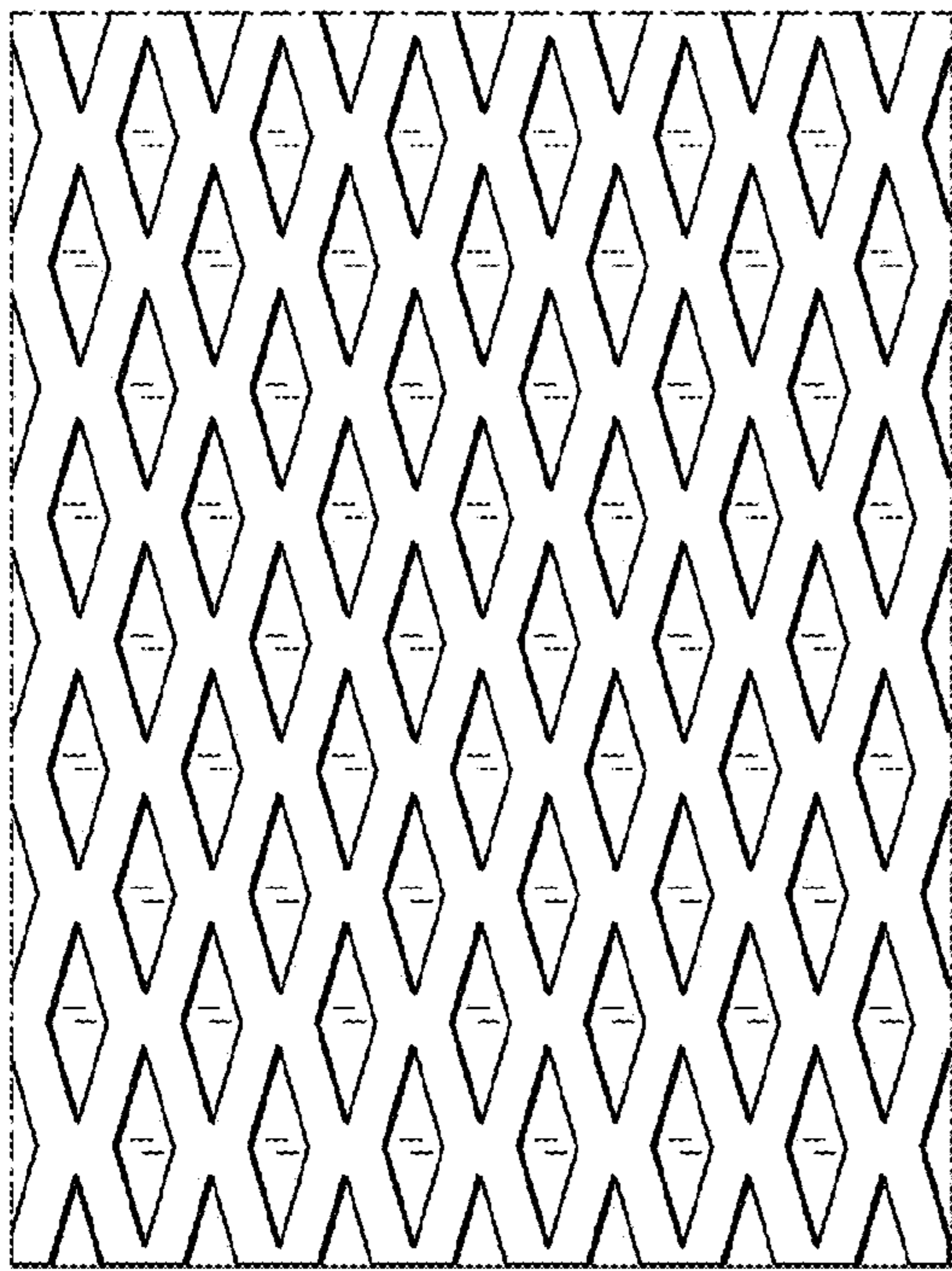

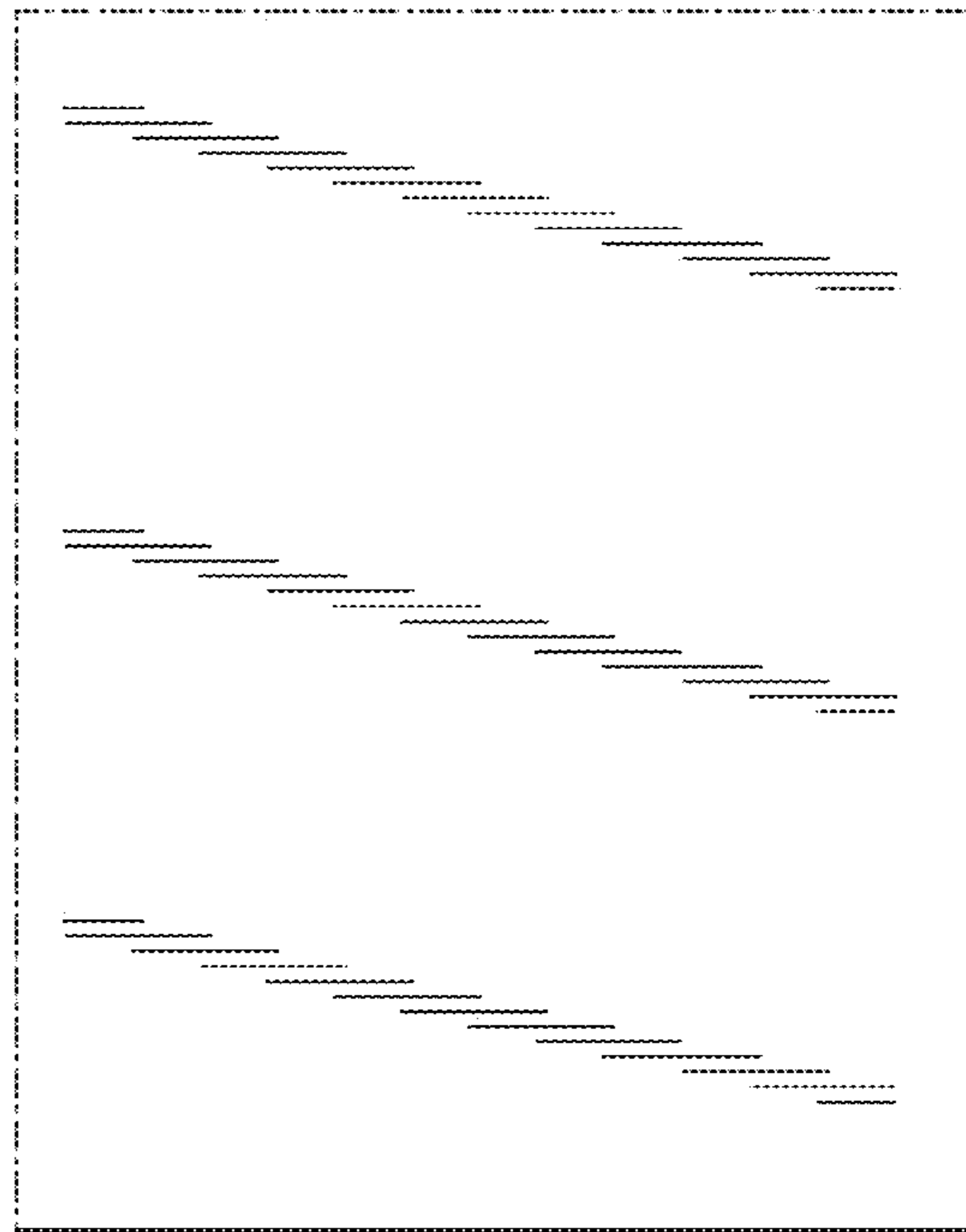

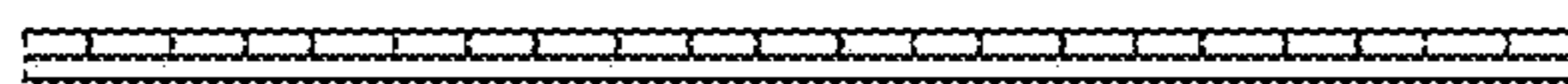

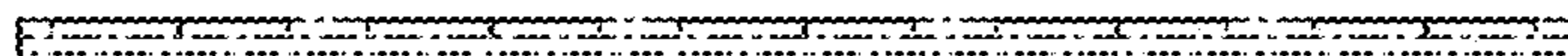

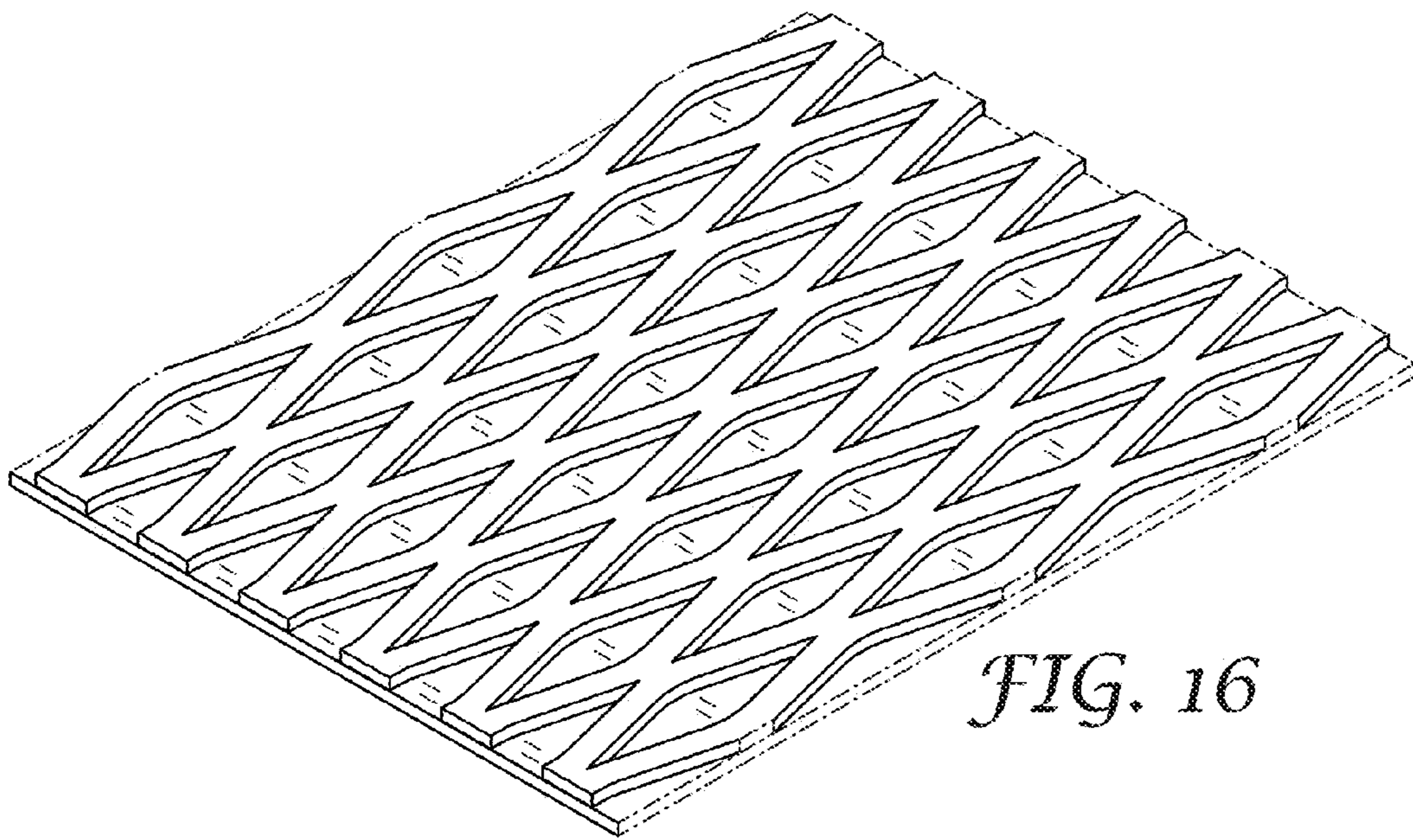

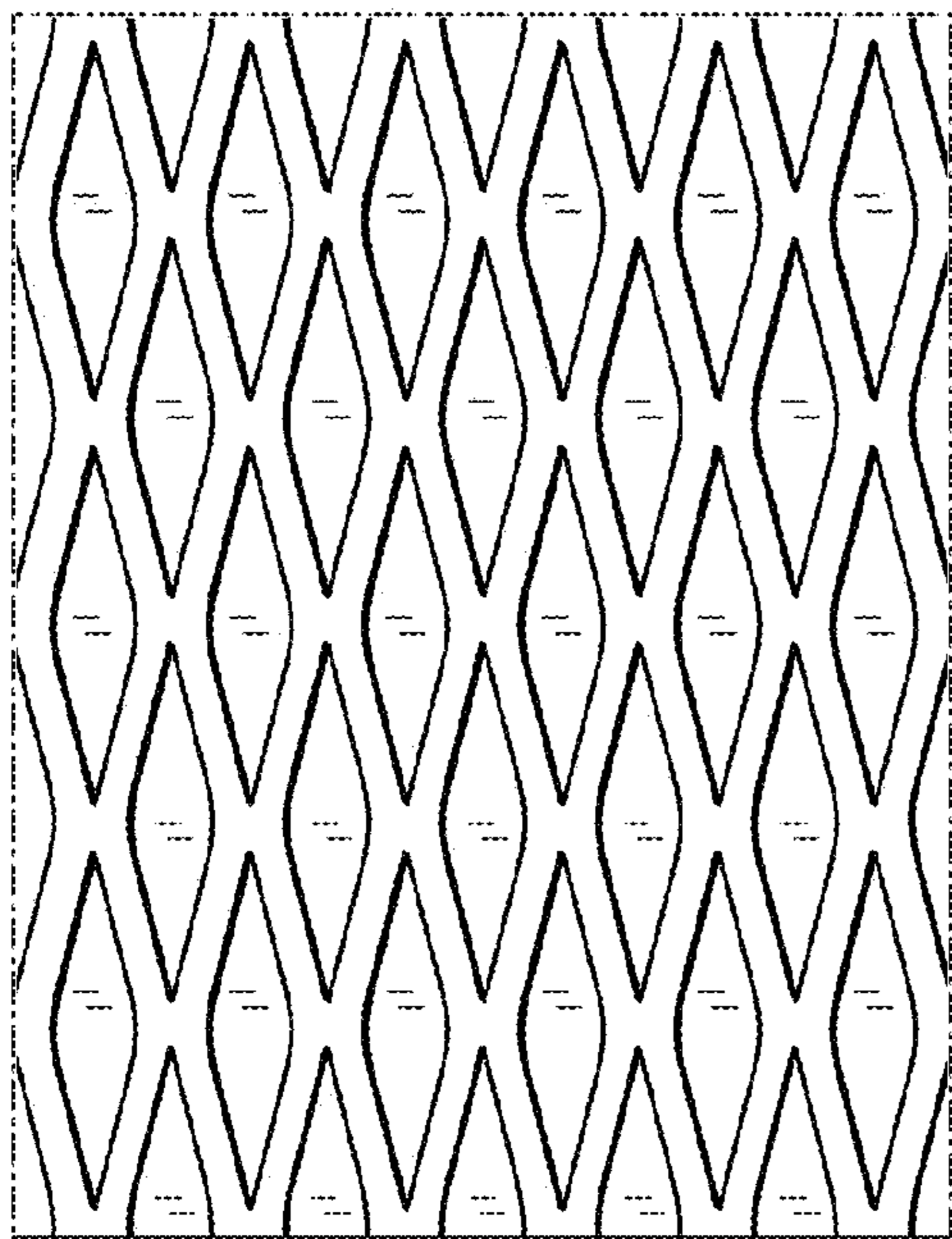

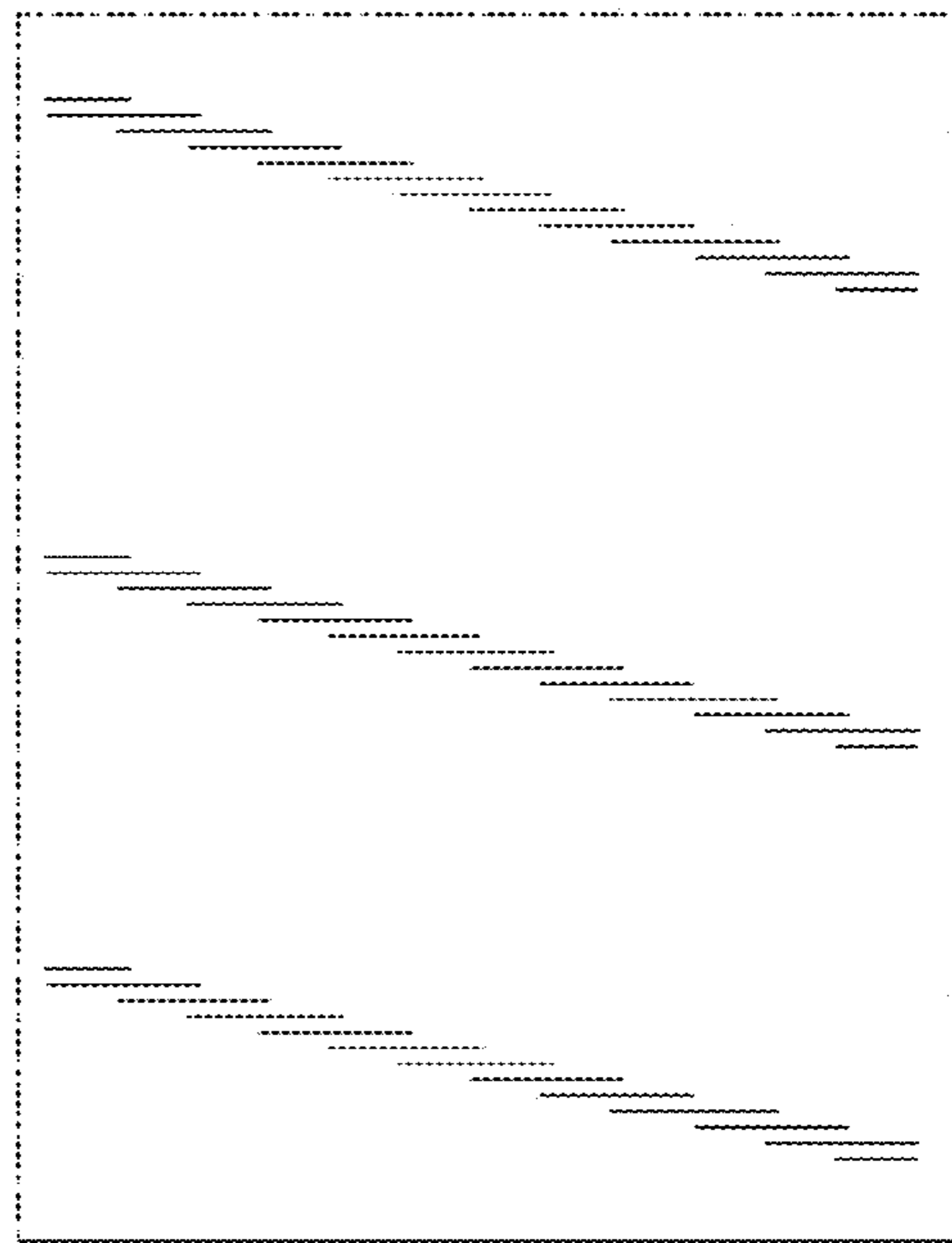

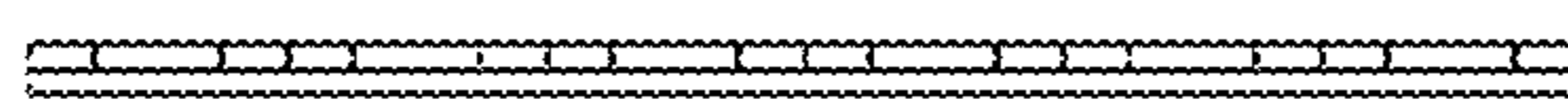

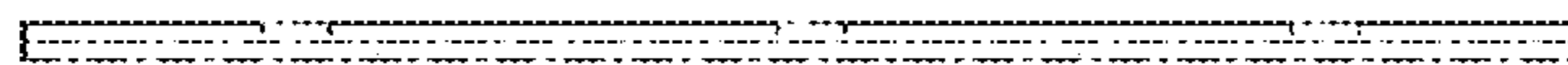

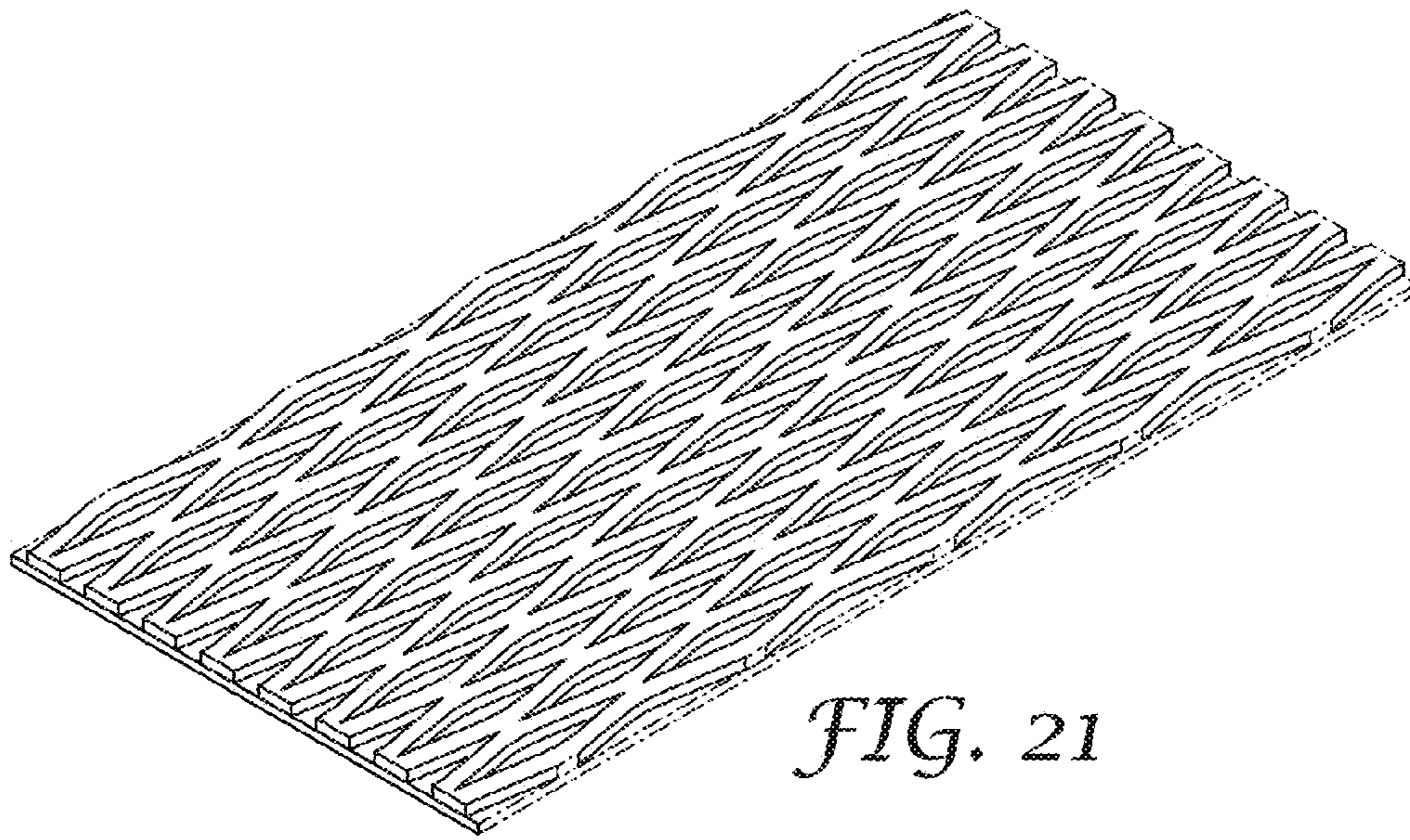

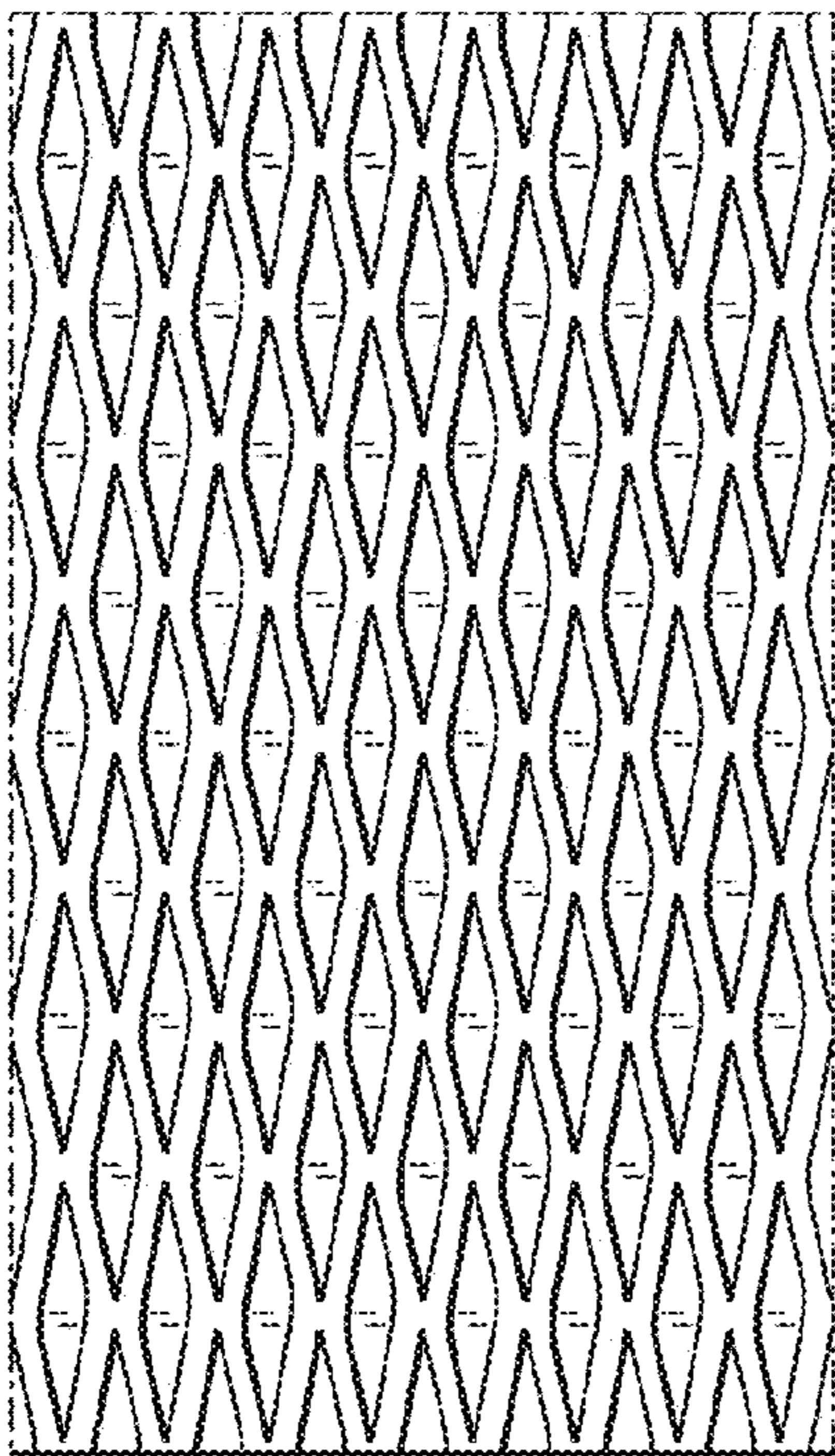

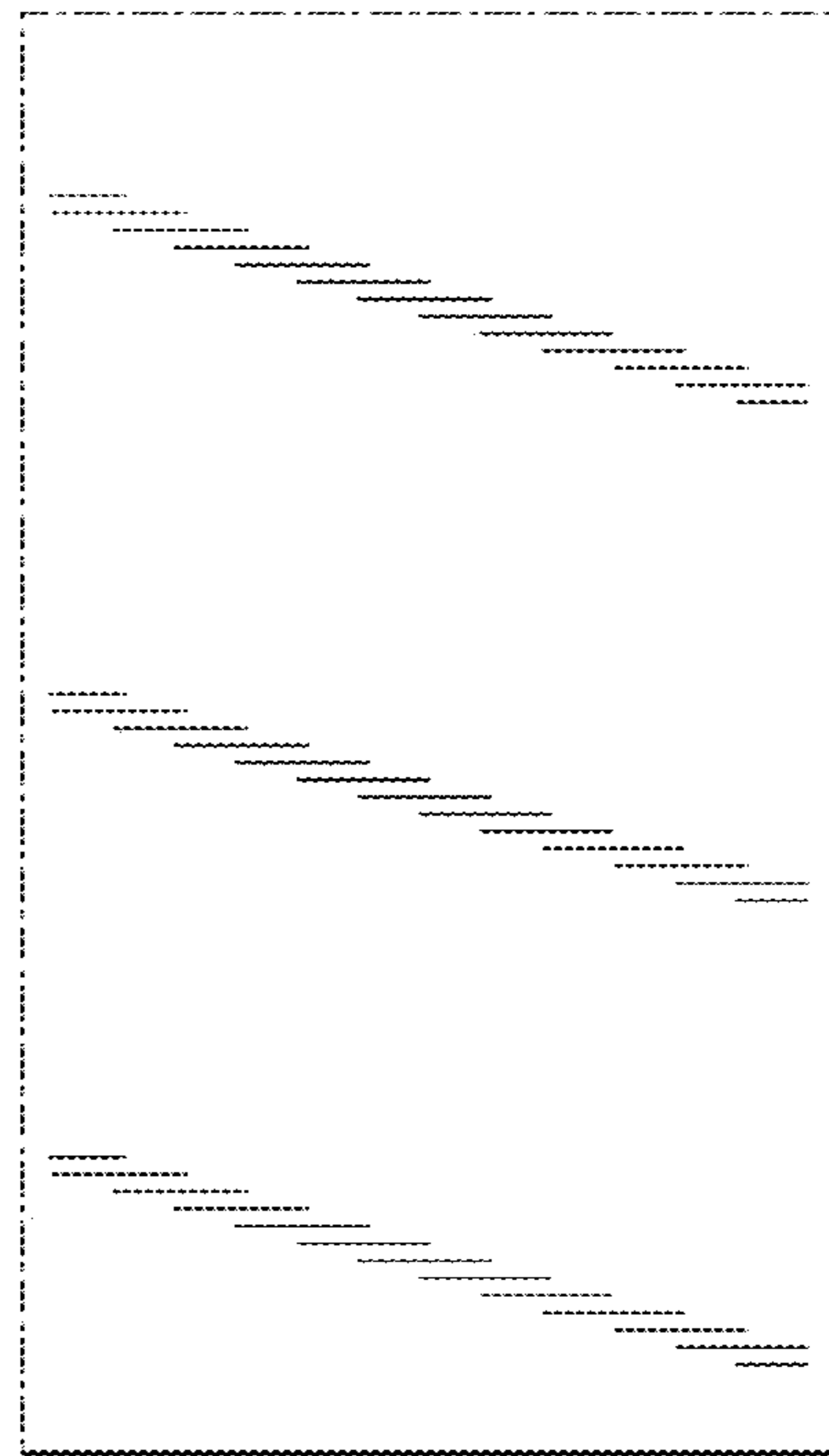

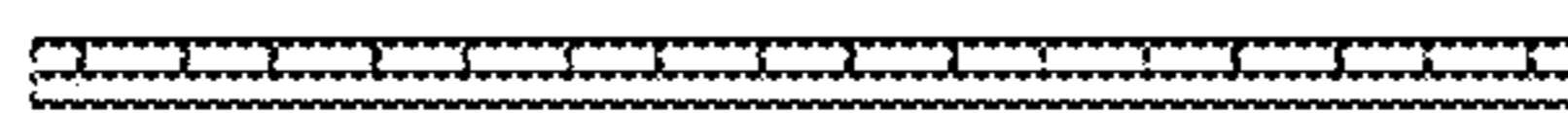

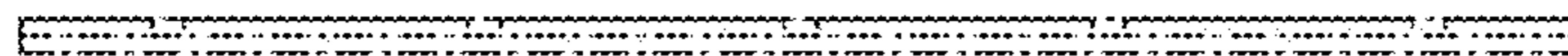
