FIG. 3 is a front side perspective view thereof.

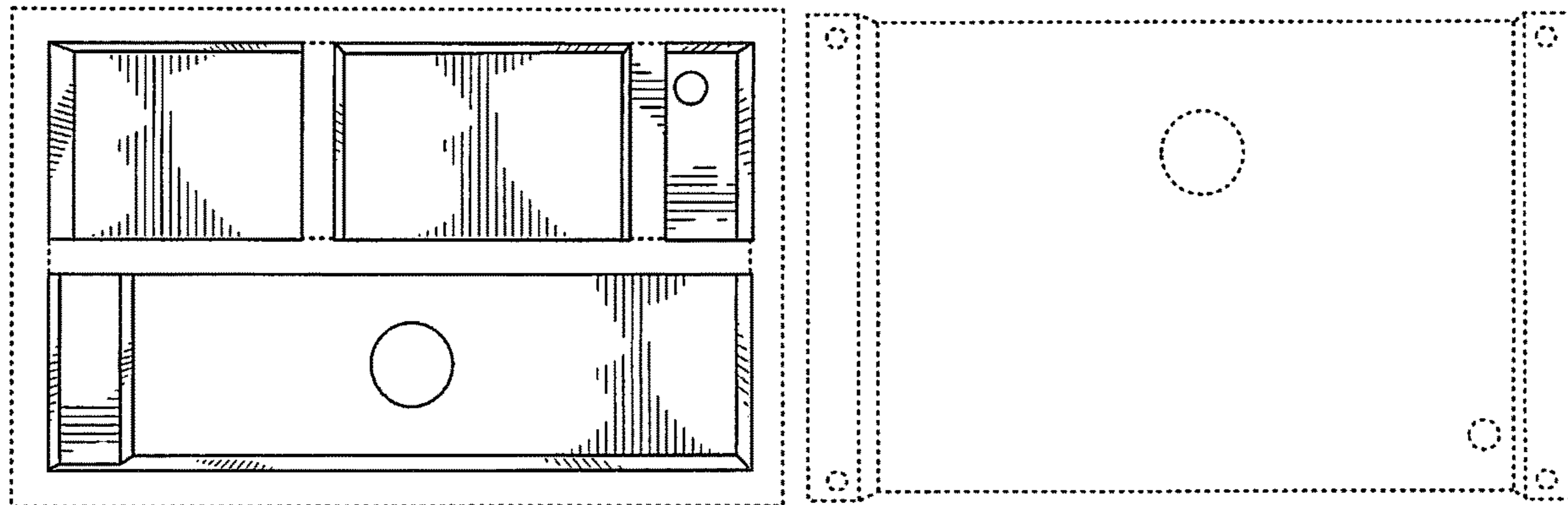
FIG. 4 is a back side perspective view thereof.

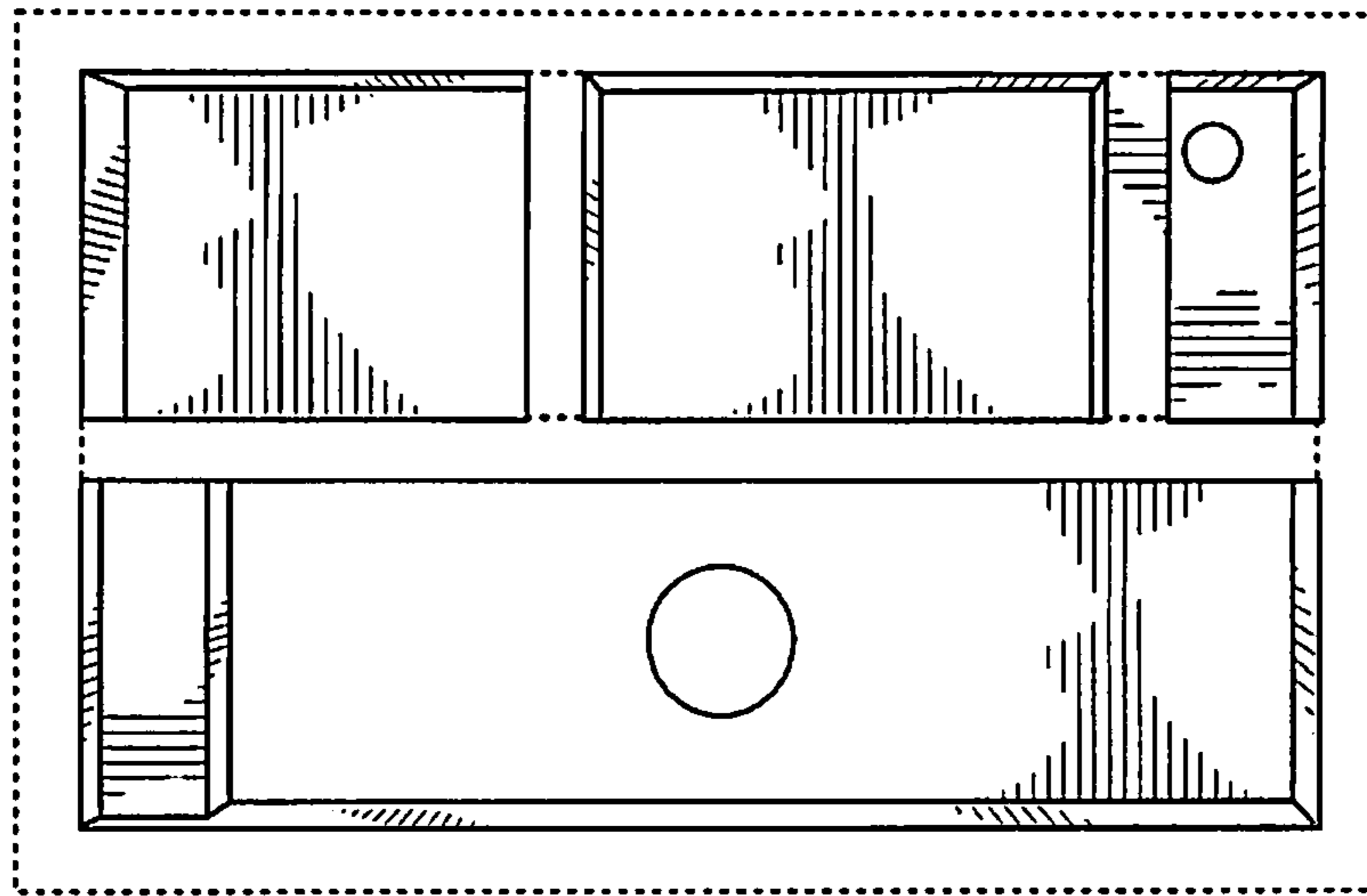

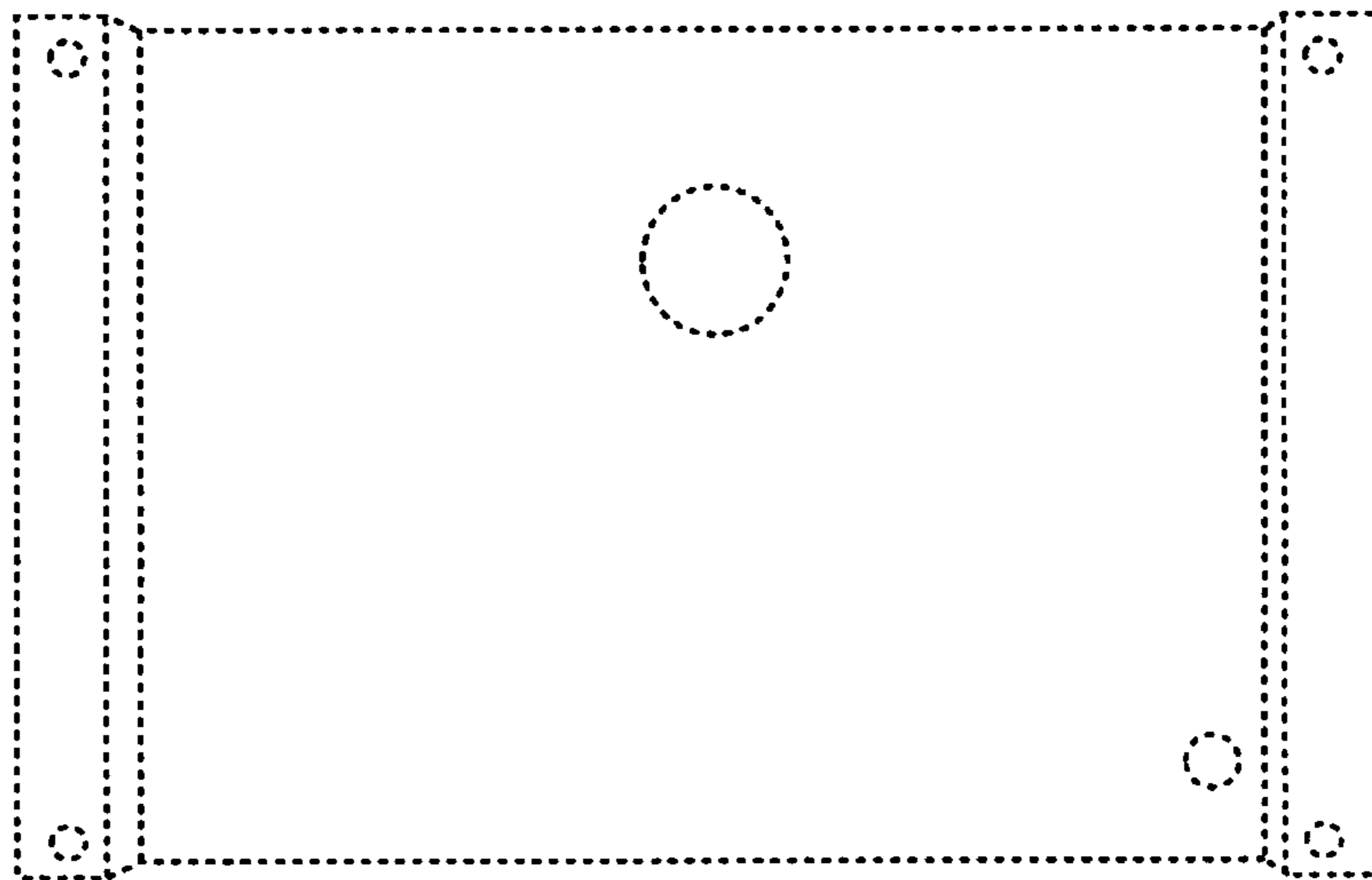

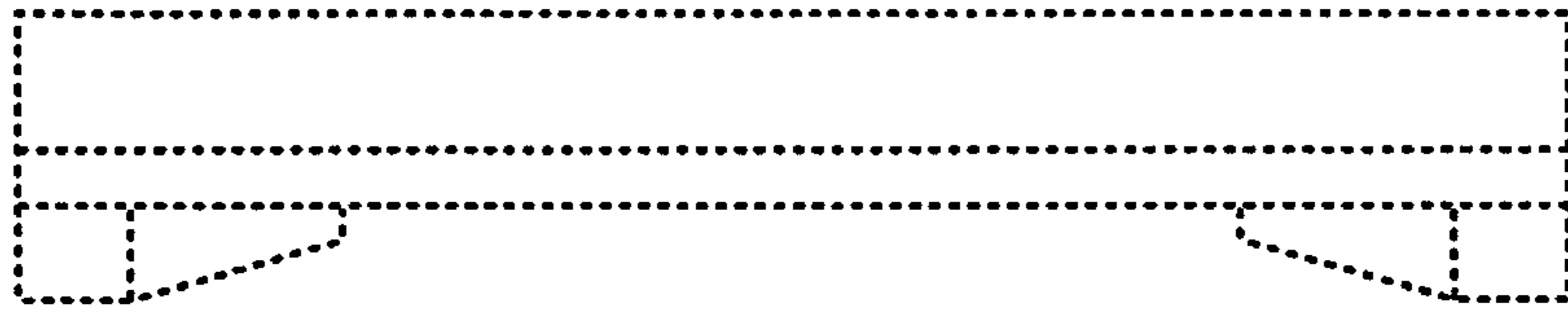

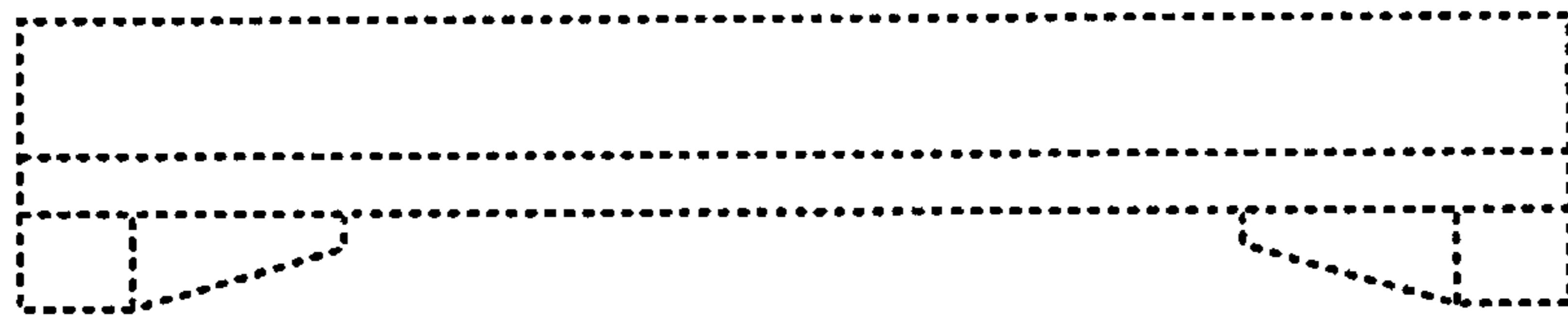

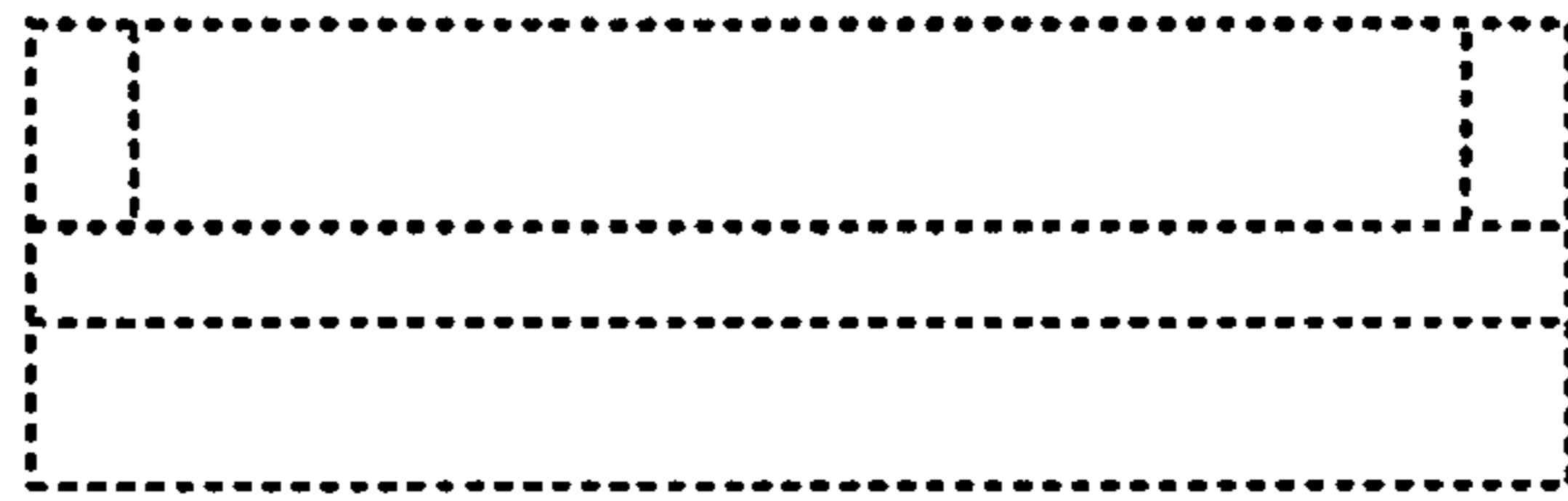

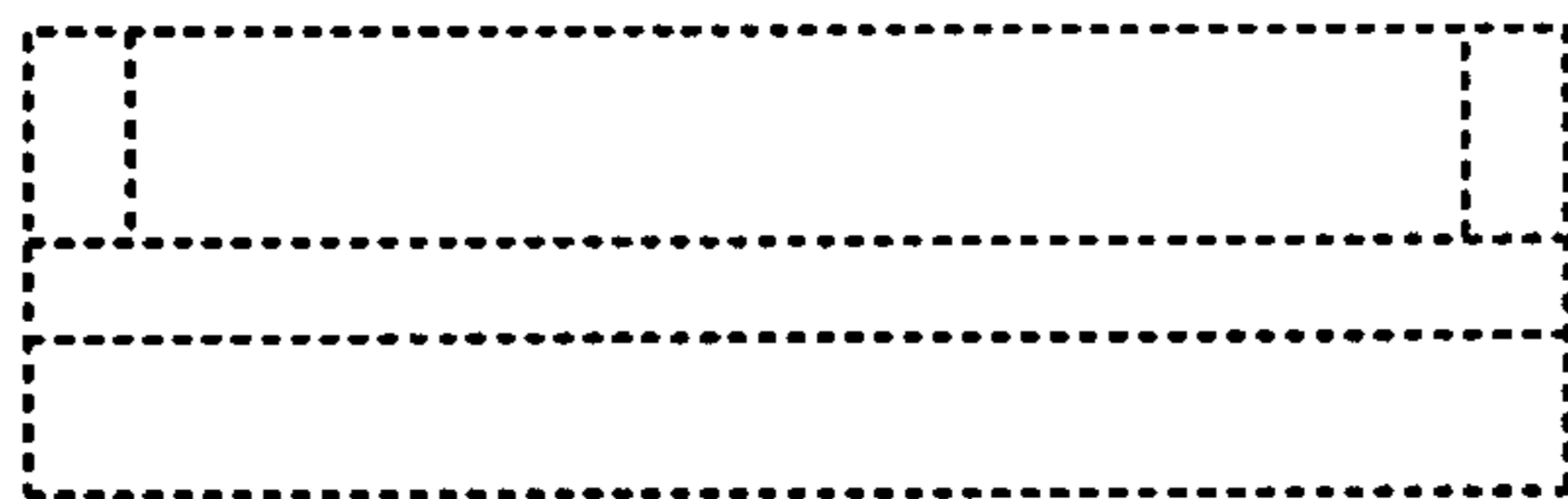
