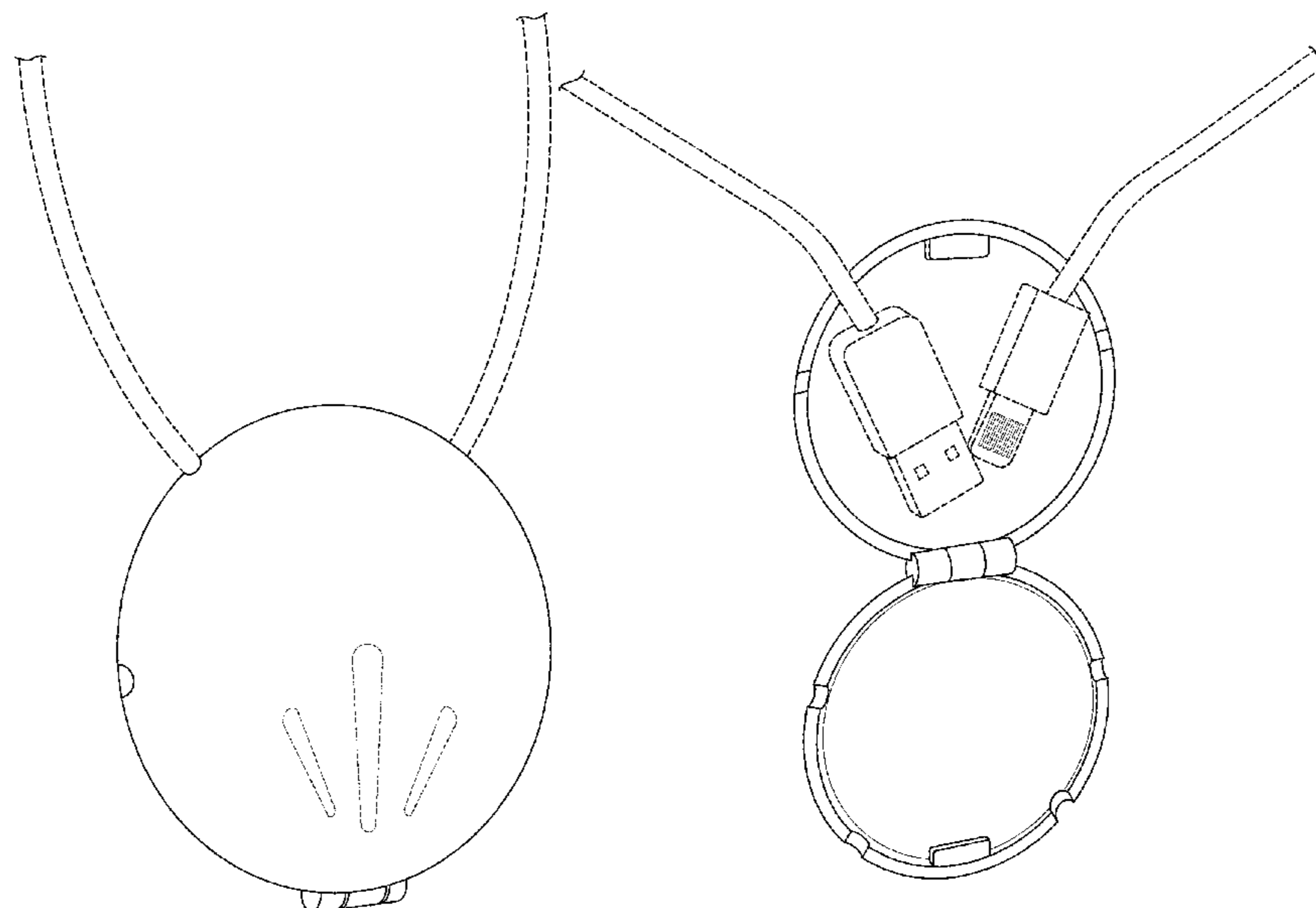
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an isometric view of a cord organizer showing my new design, in a closed configuration;

FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view thereof;

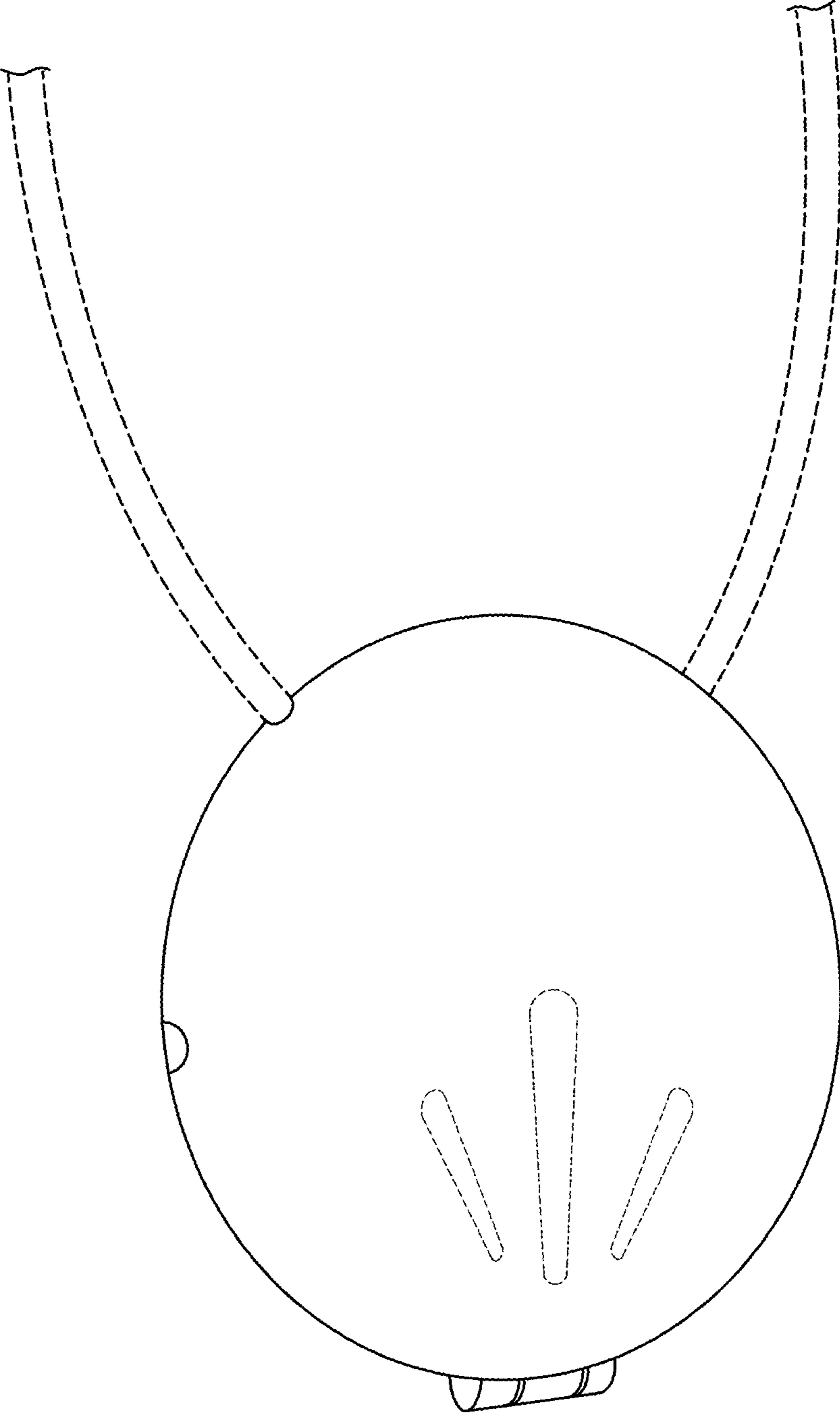

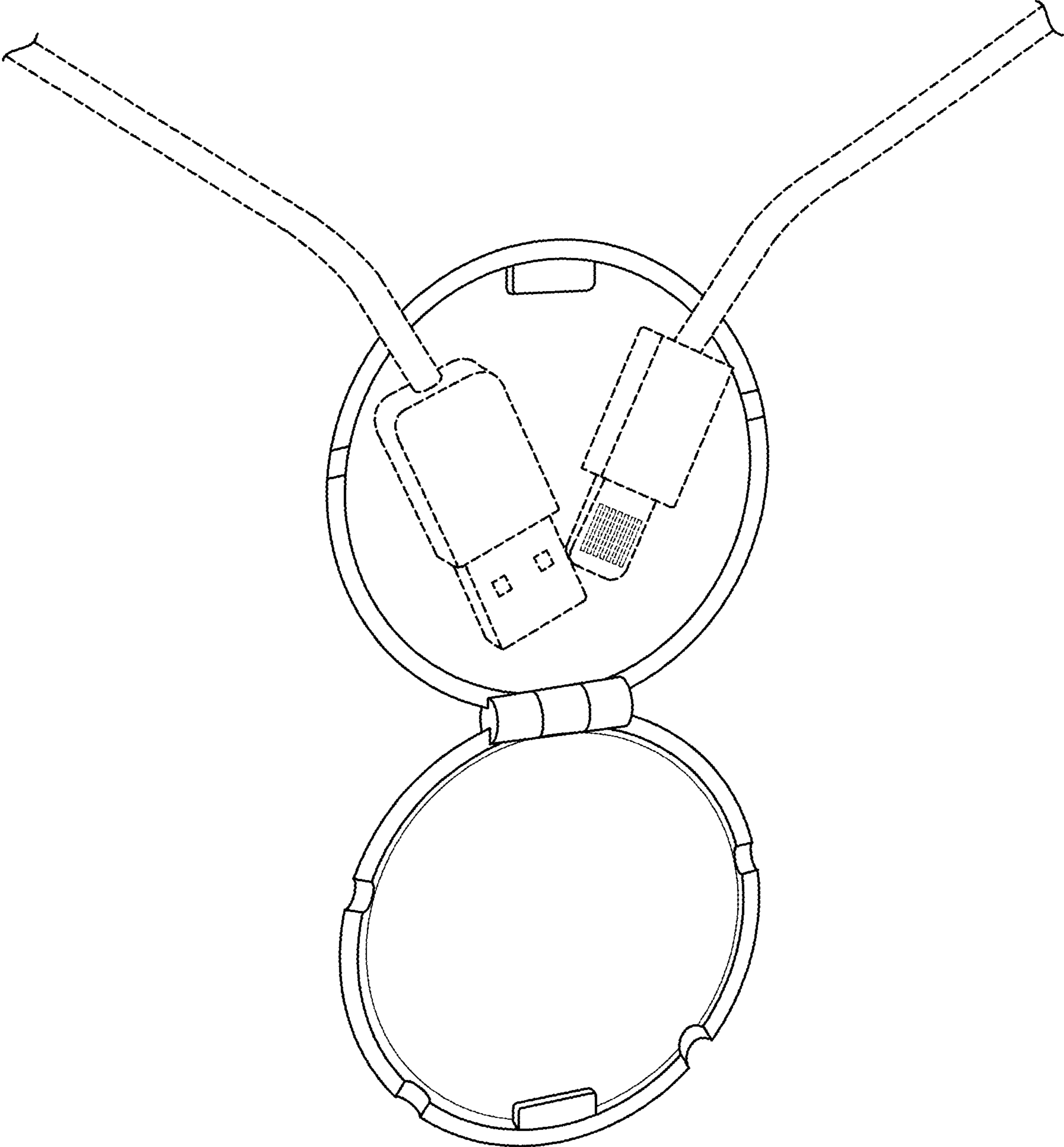

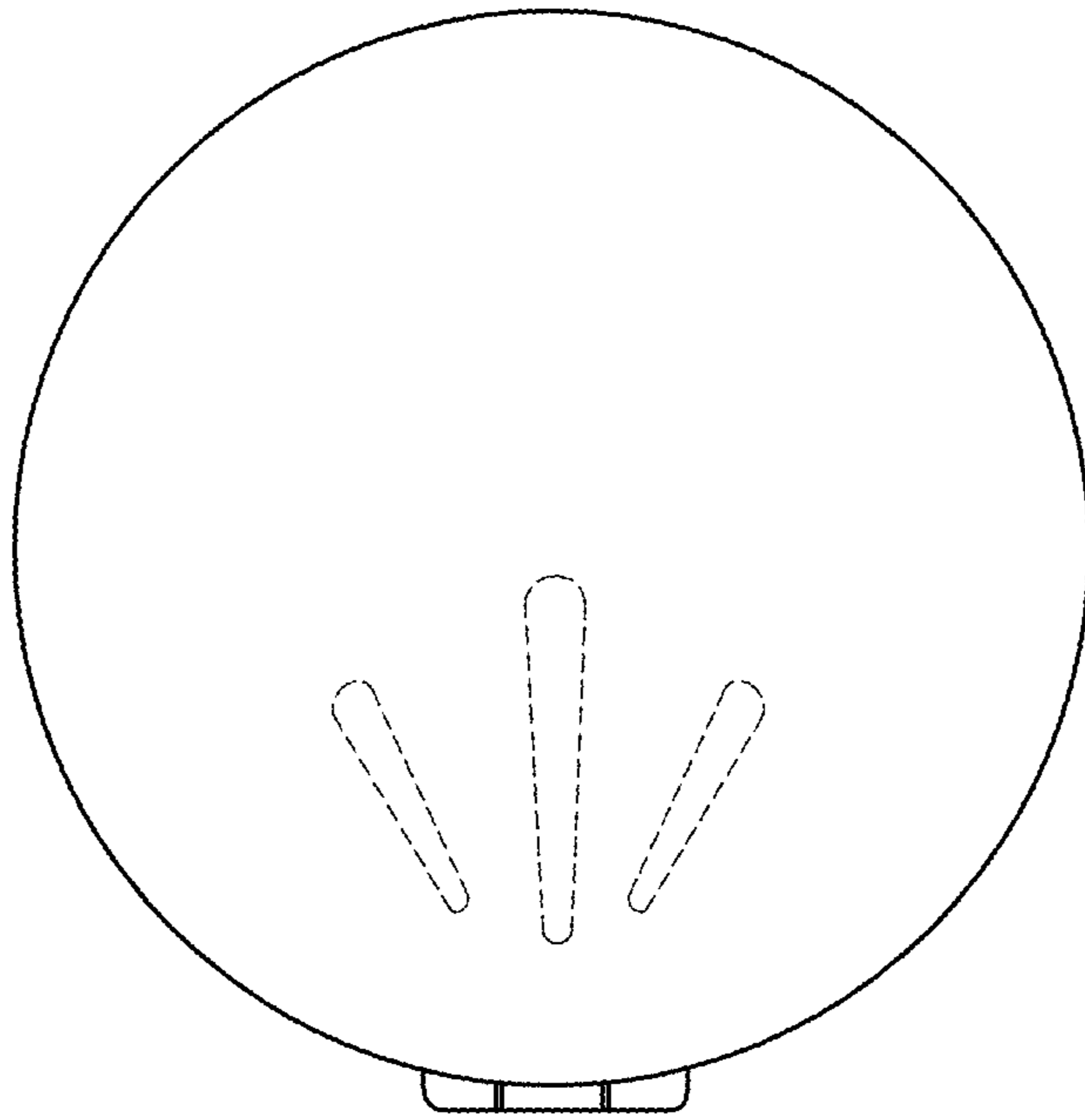

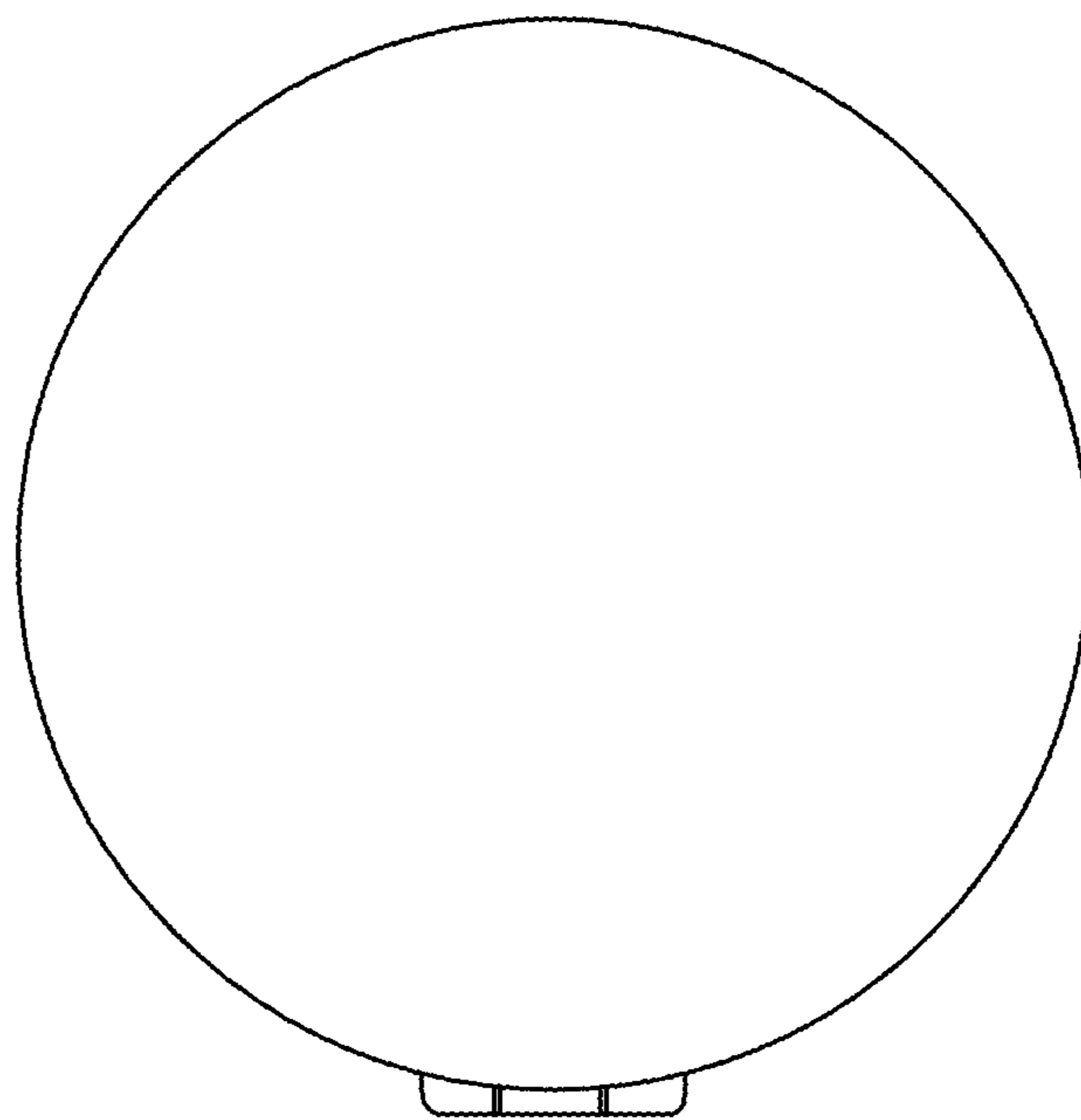

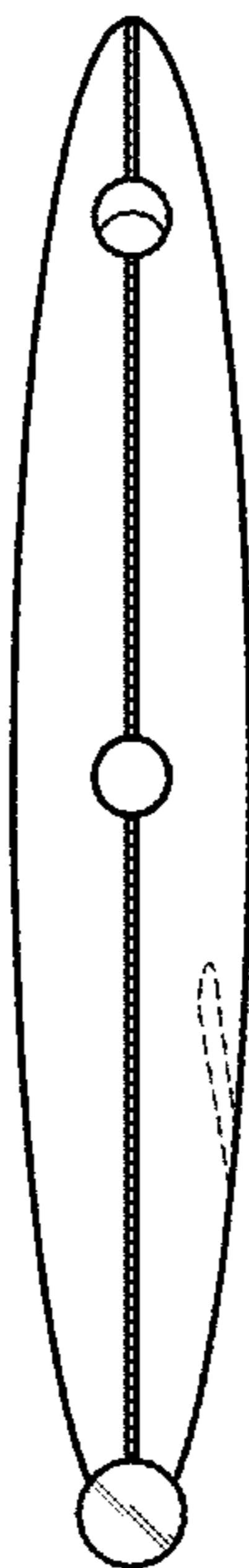

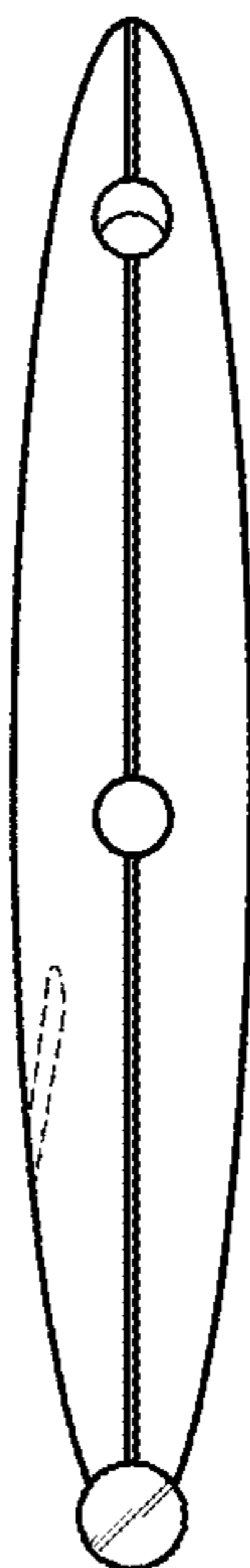

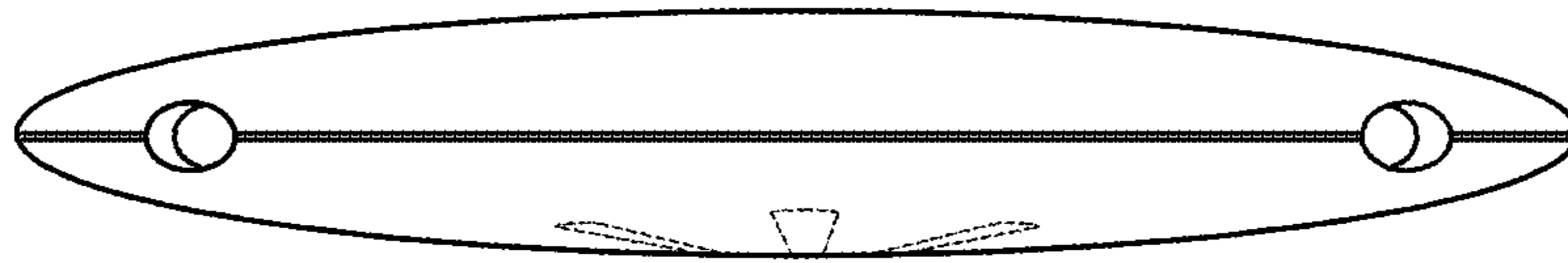

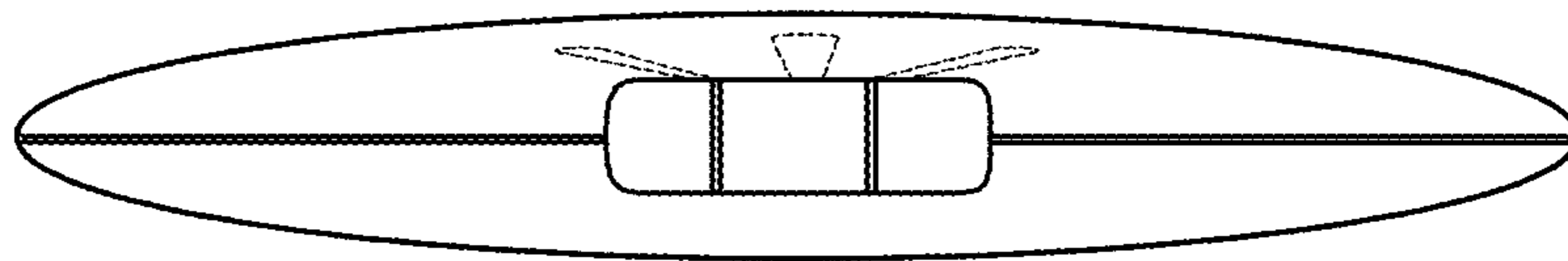
