(57) **CLAIM**

The ornamental design for a clip for securing elastic bands and attaching charms, as shown and described.

FIG. 6 is a bottom view thereof.

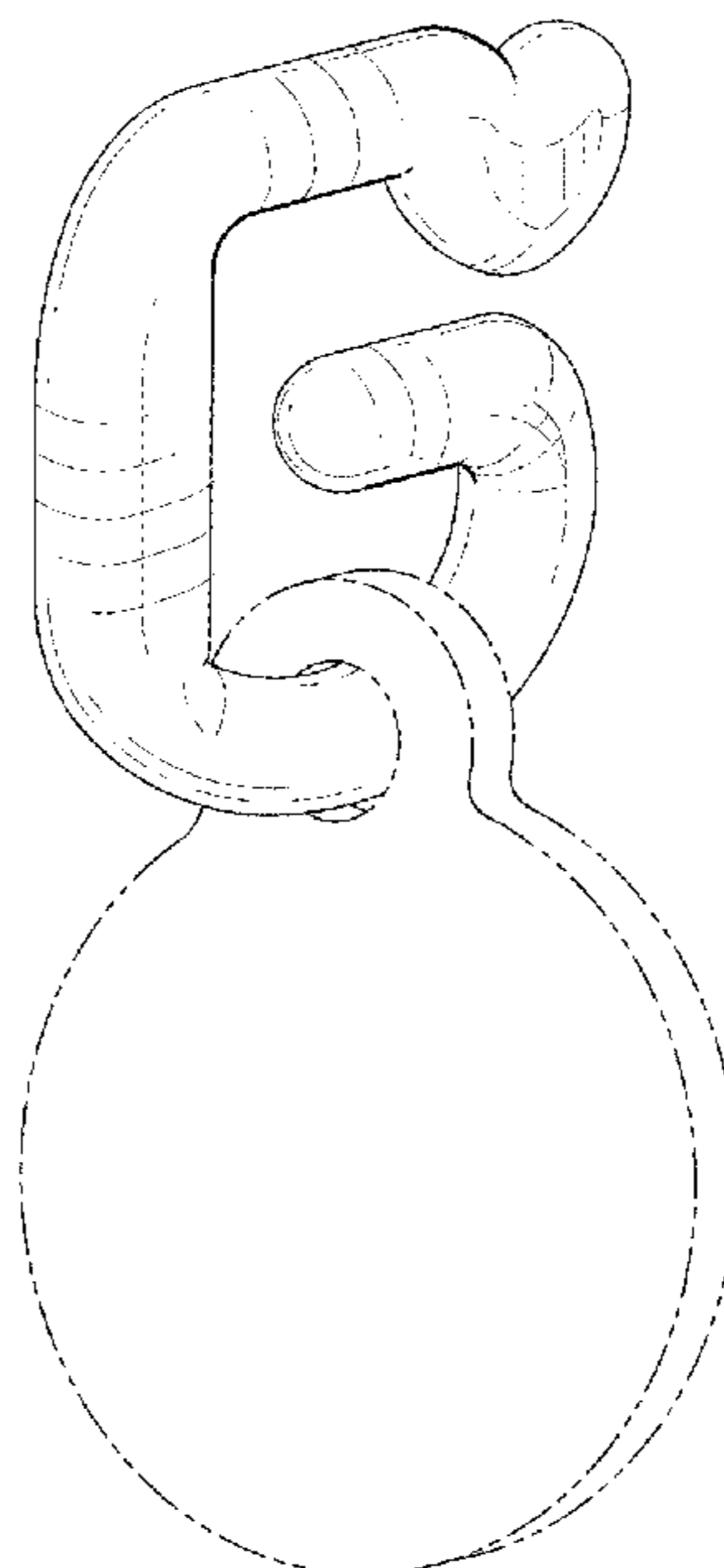
FIG. 7 is a top view thereof.

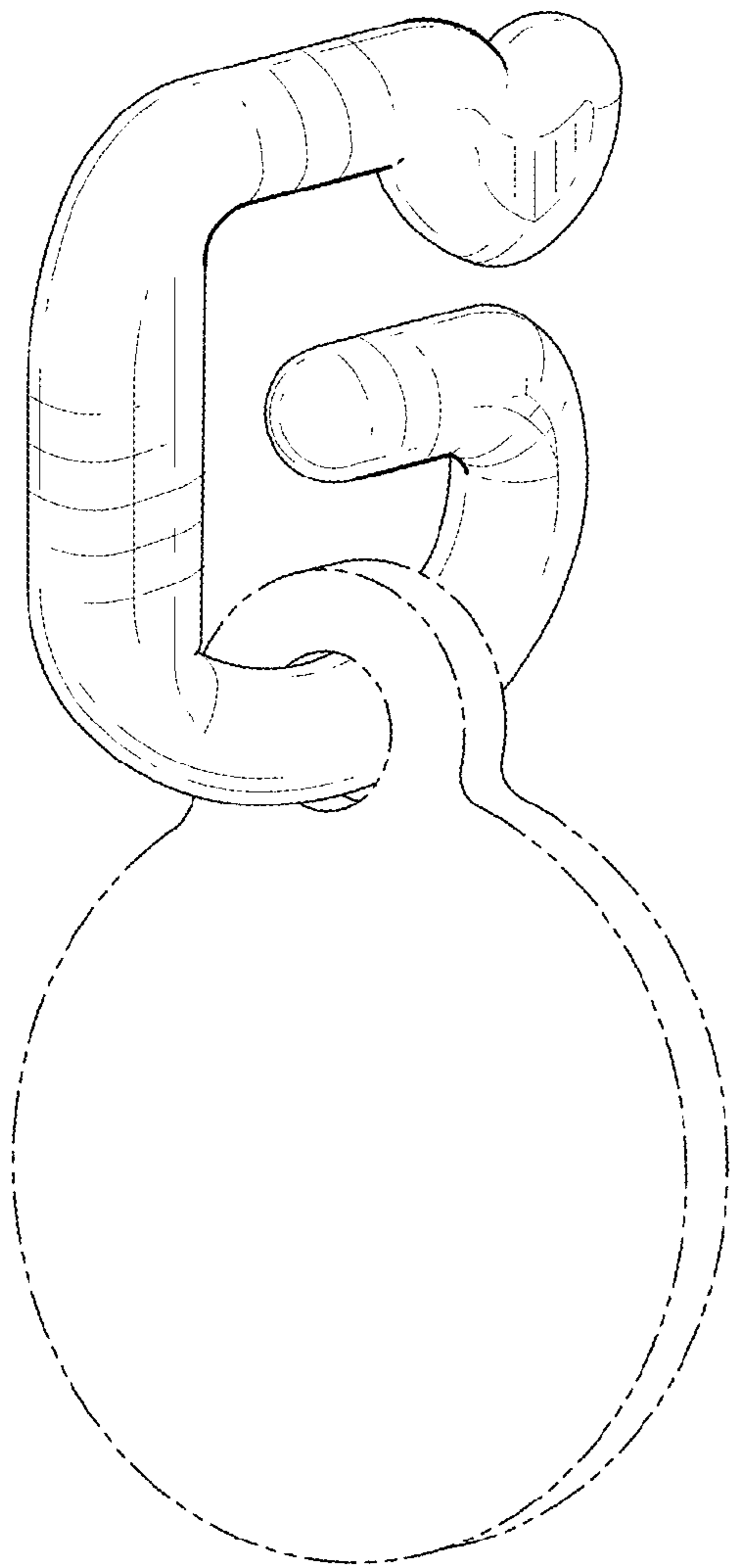

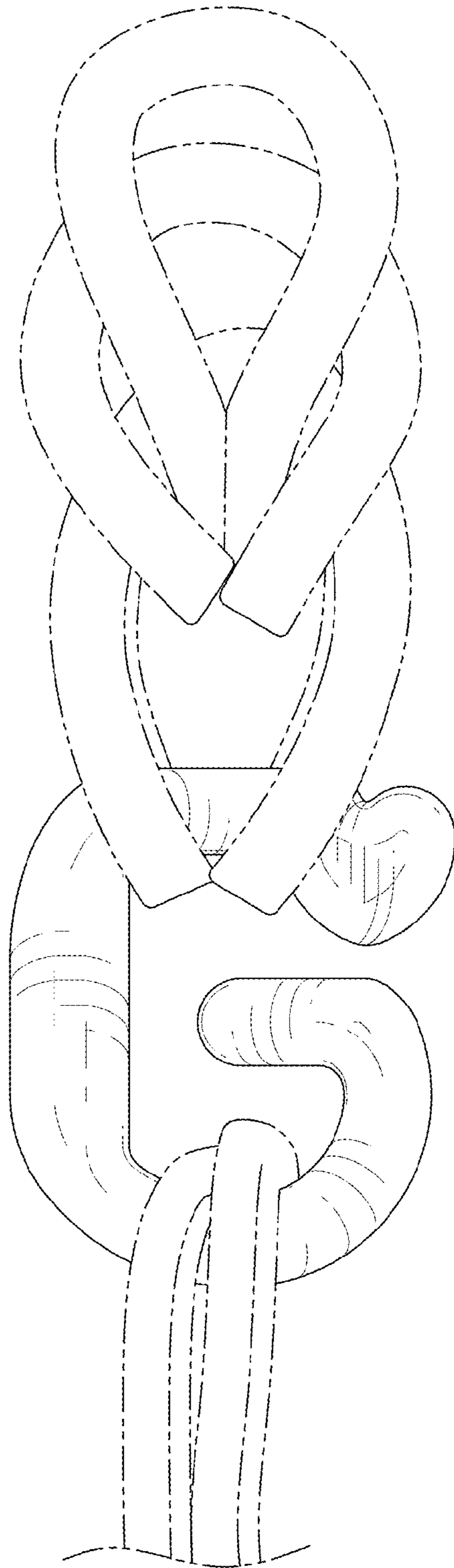

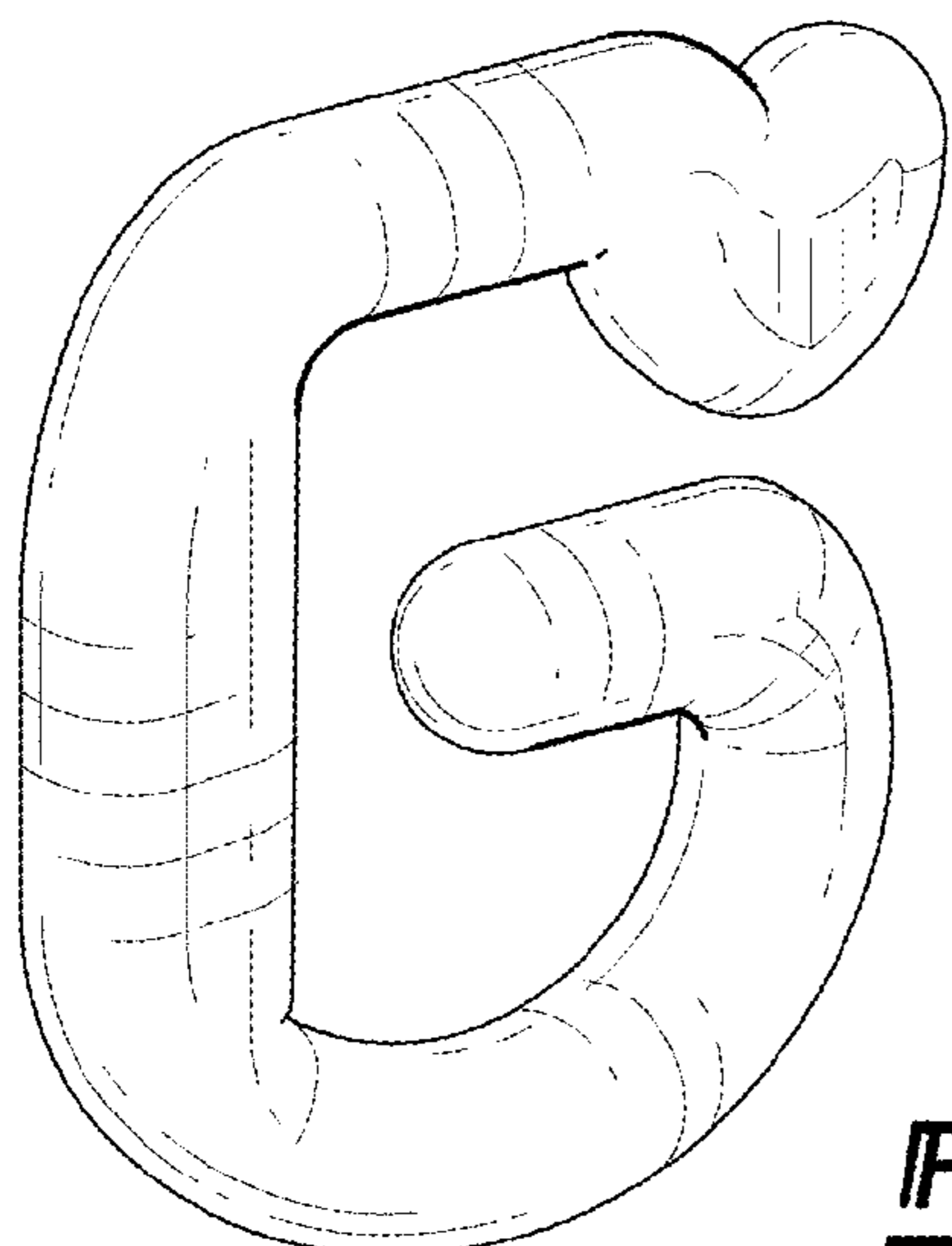

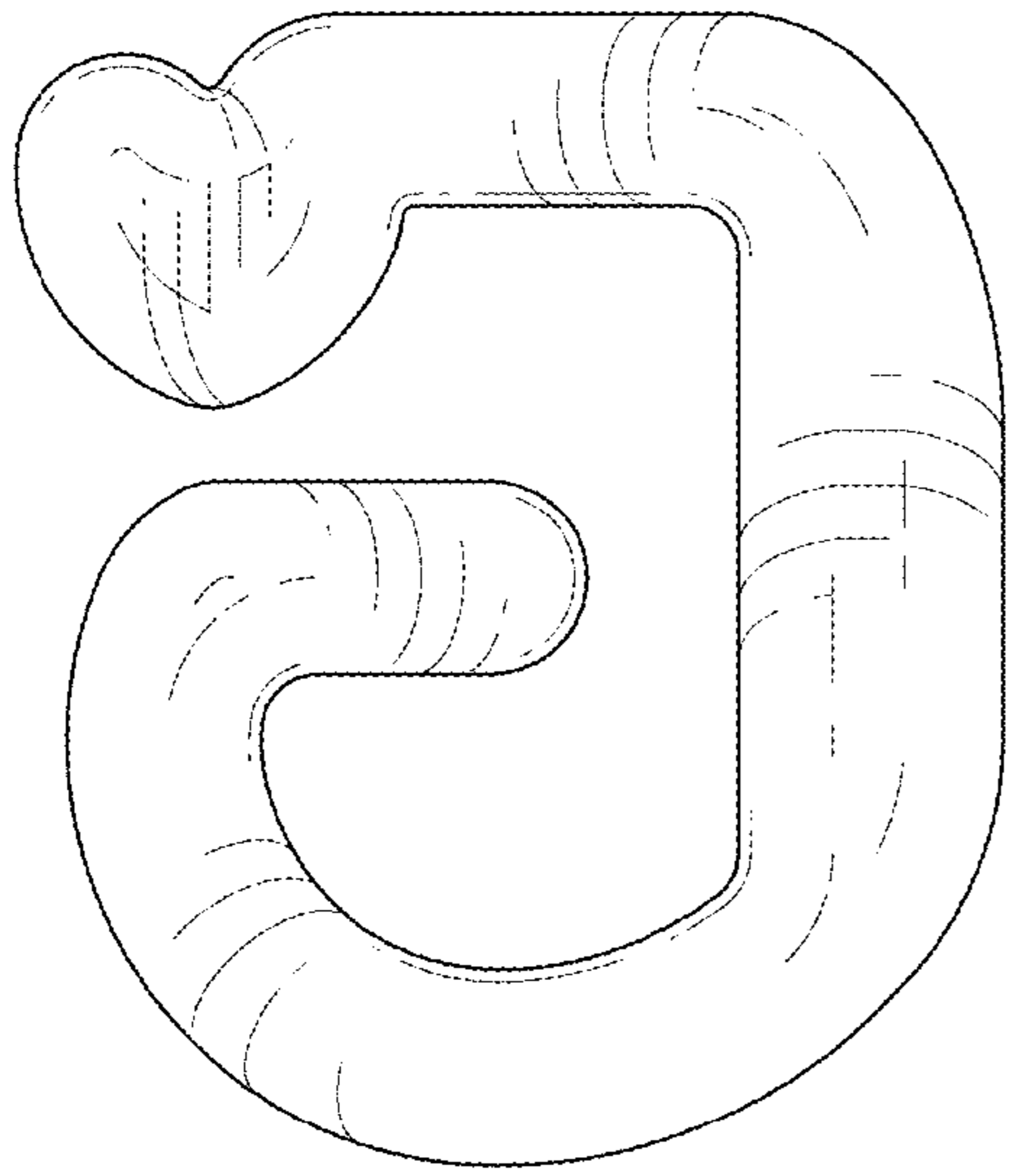

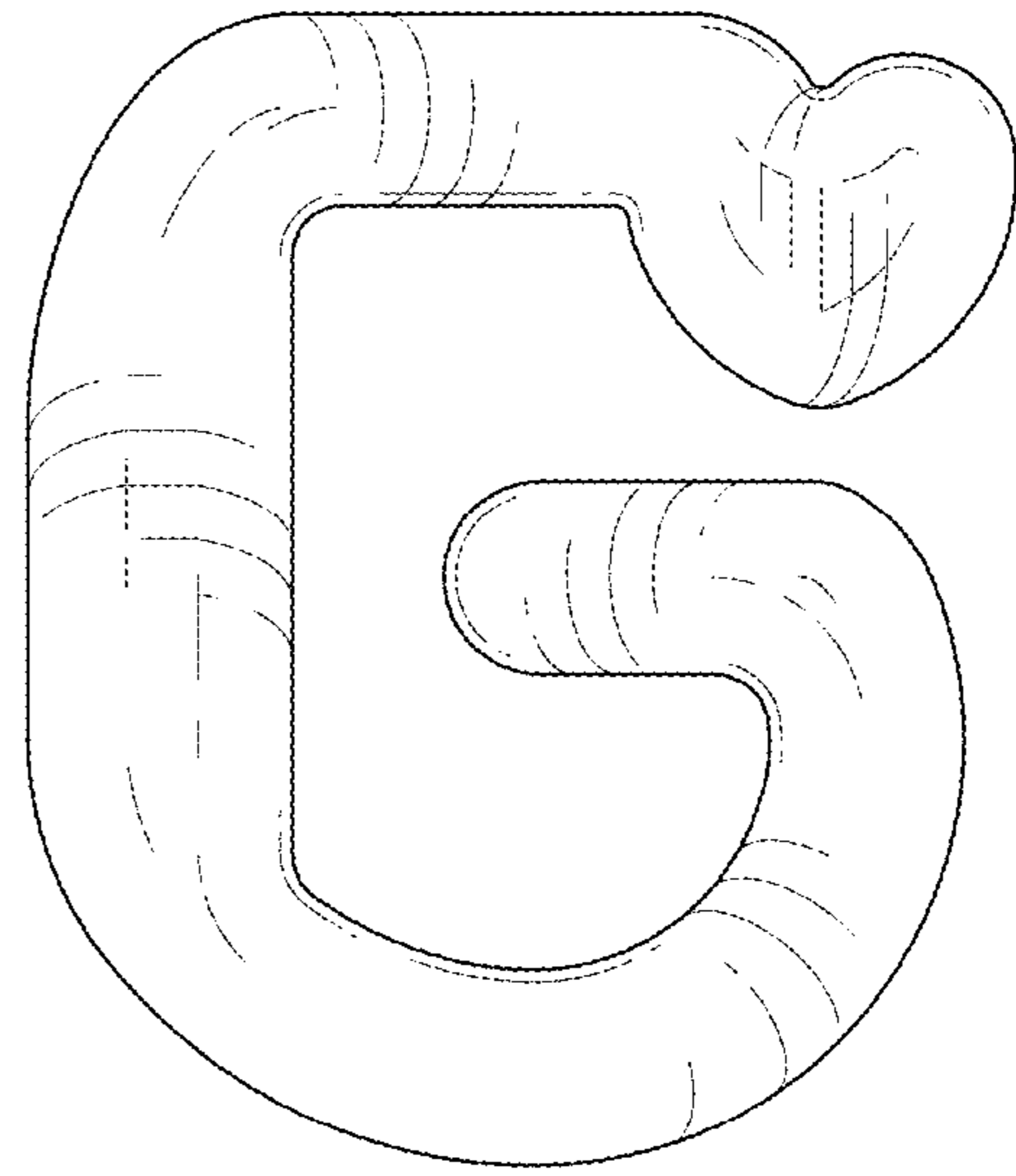

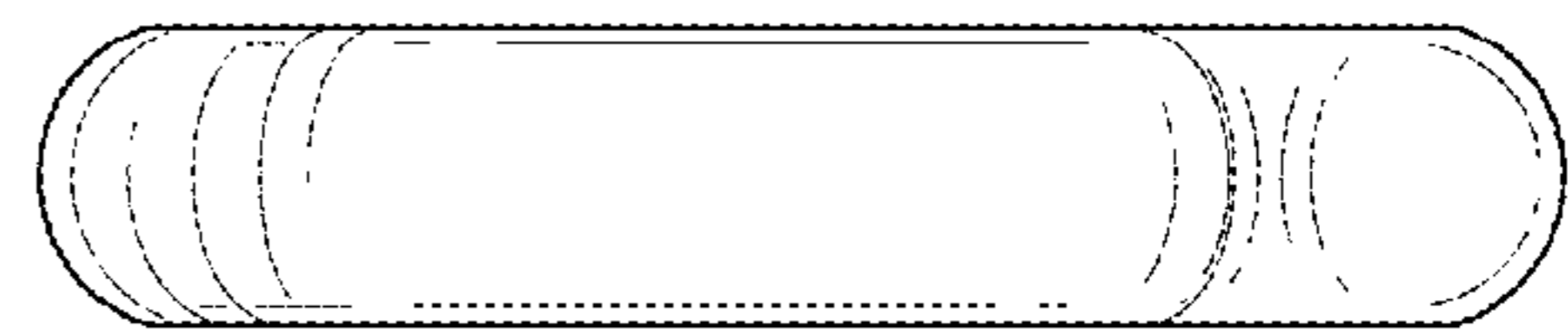

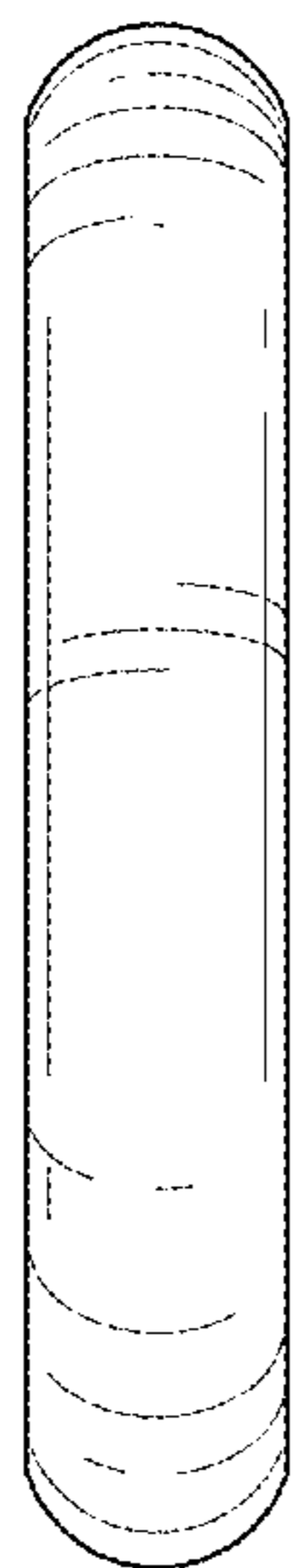
