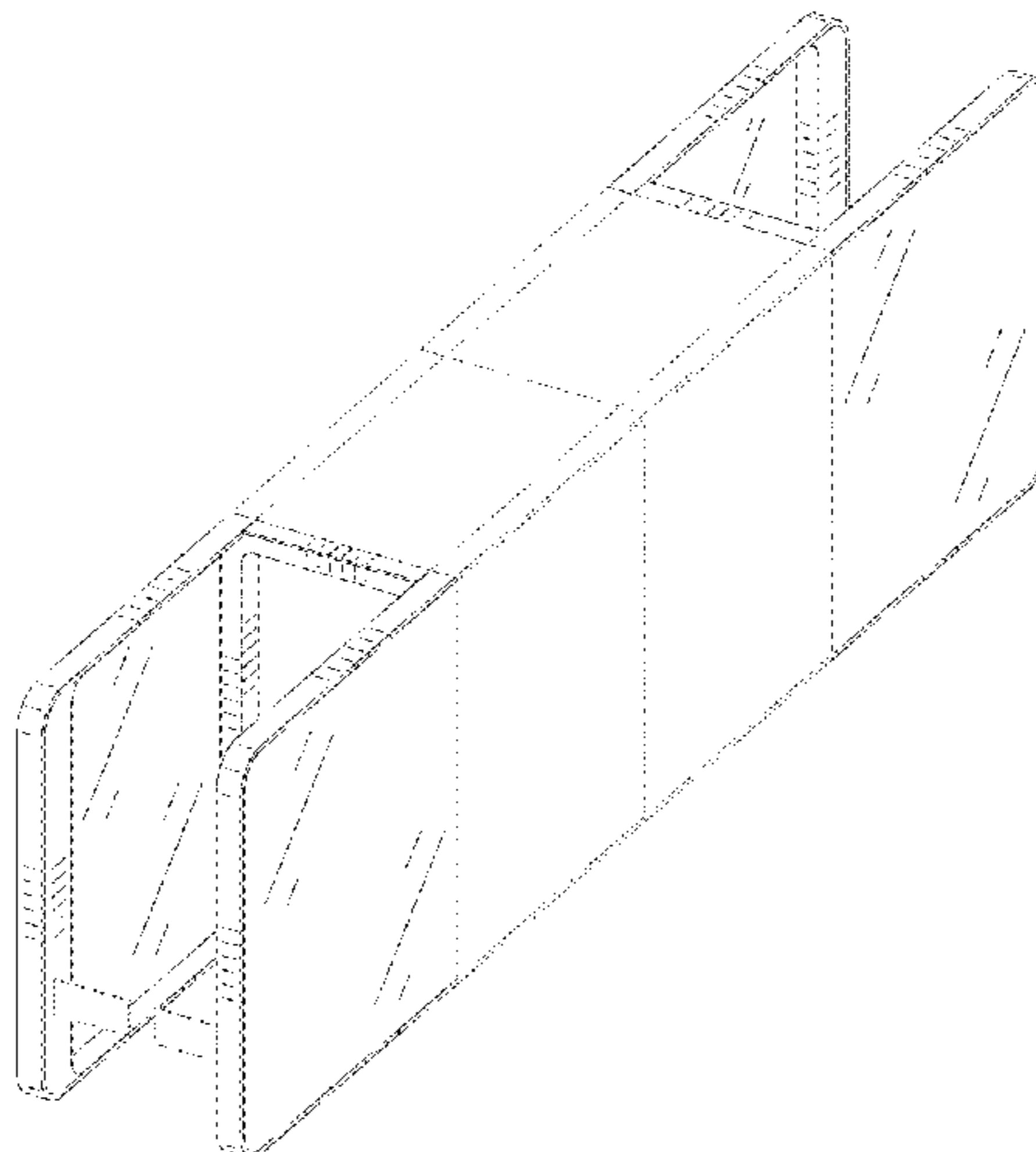
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a body scanner according to the invention;

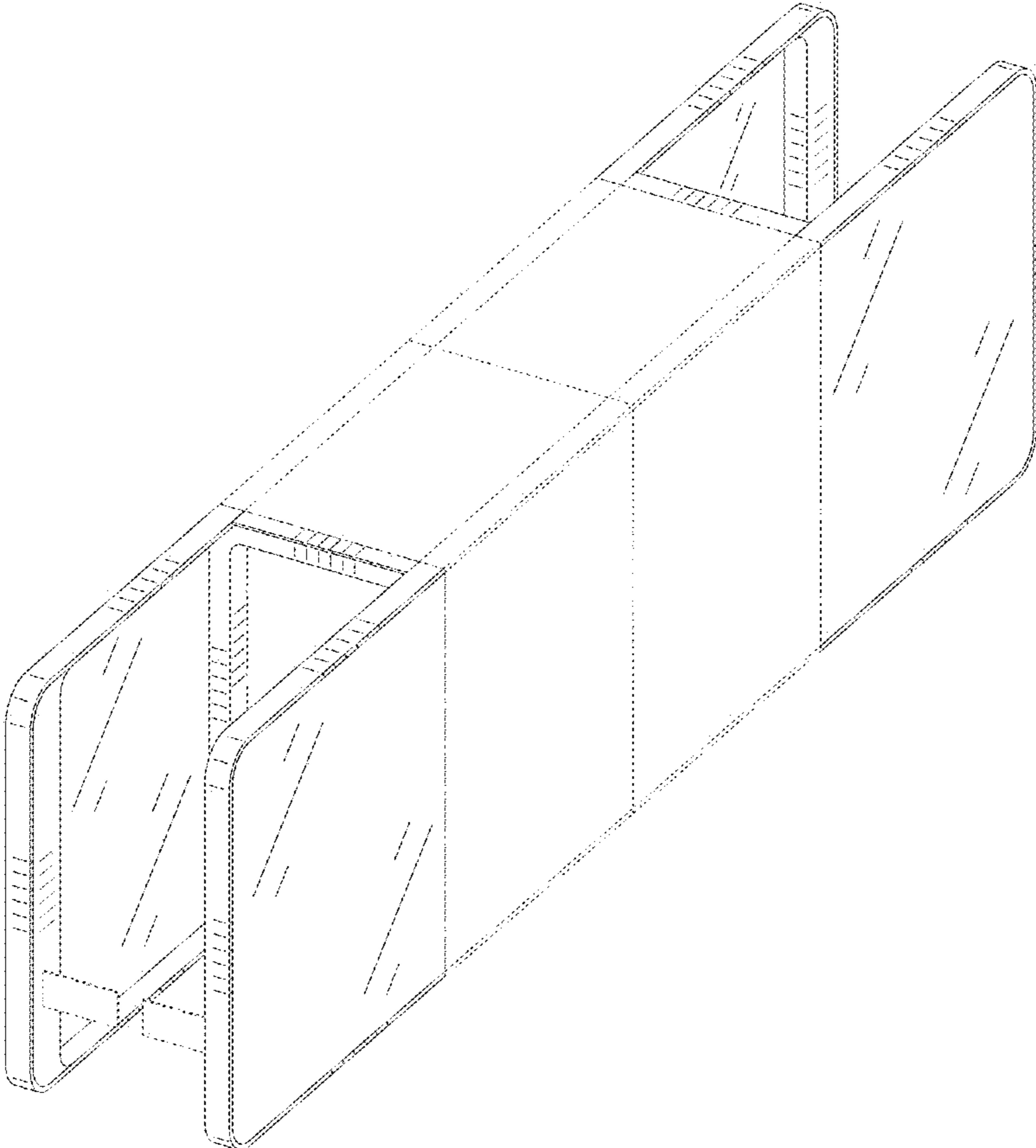

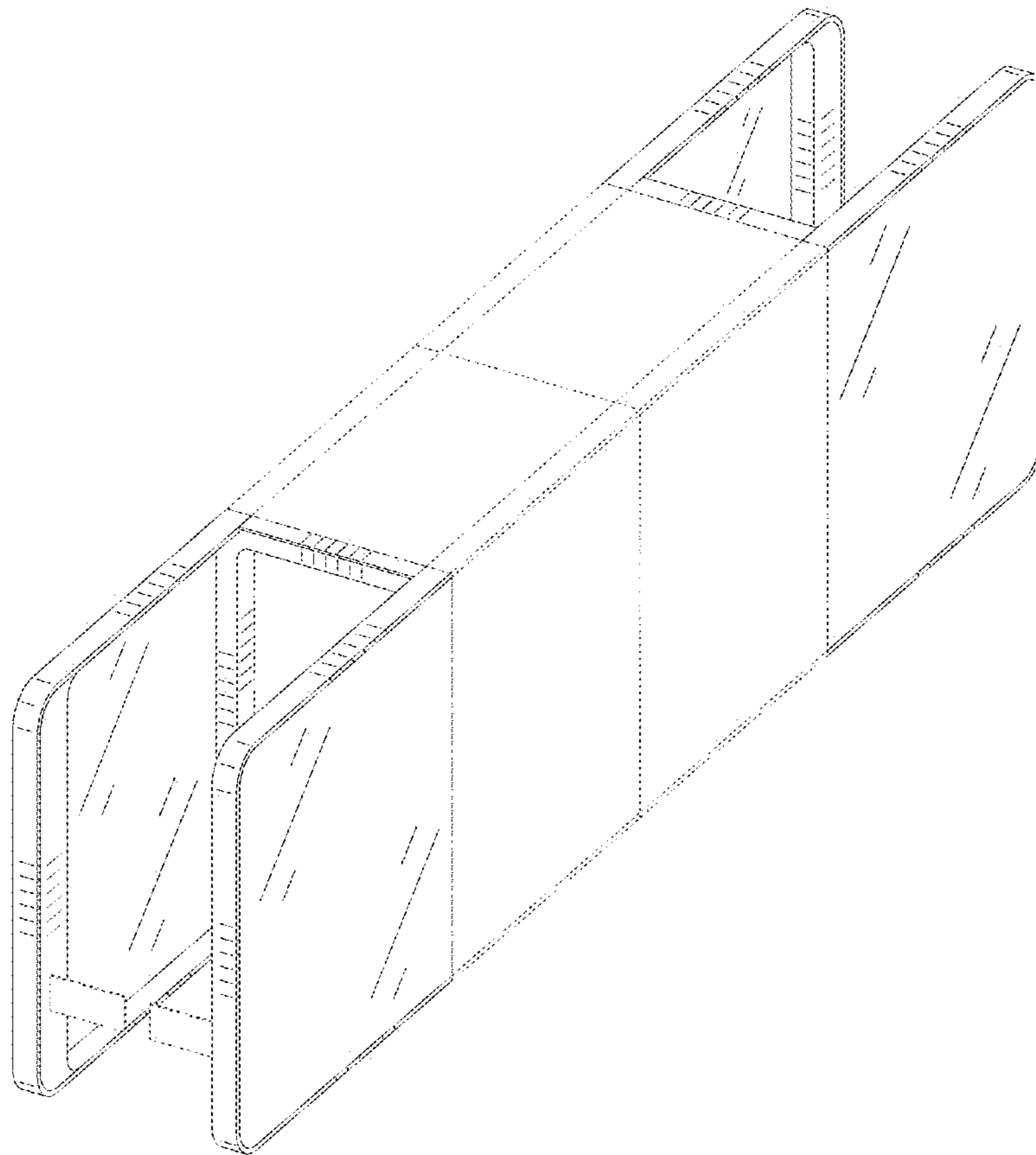

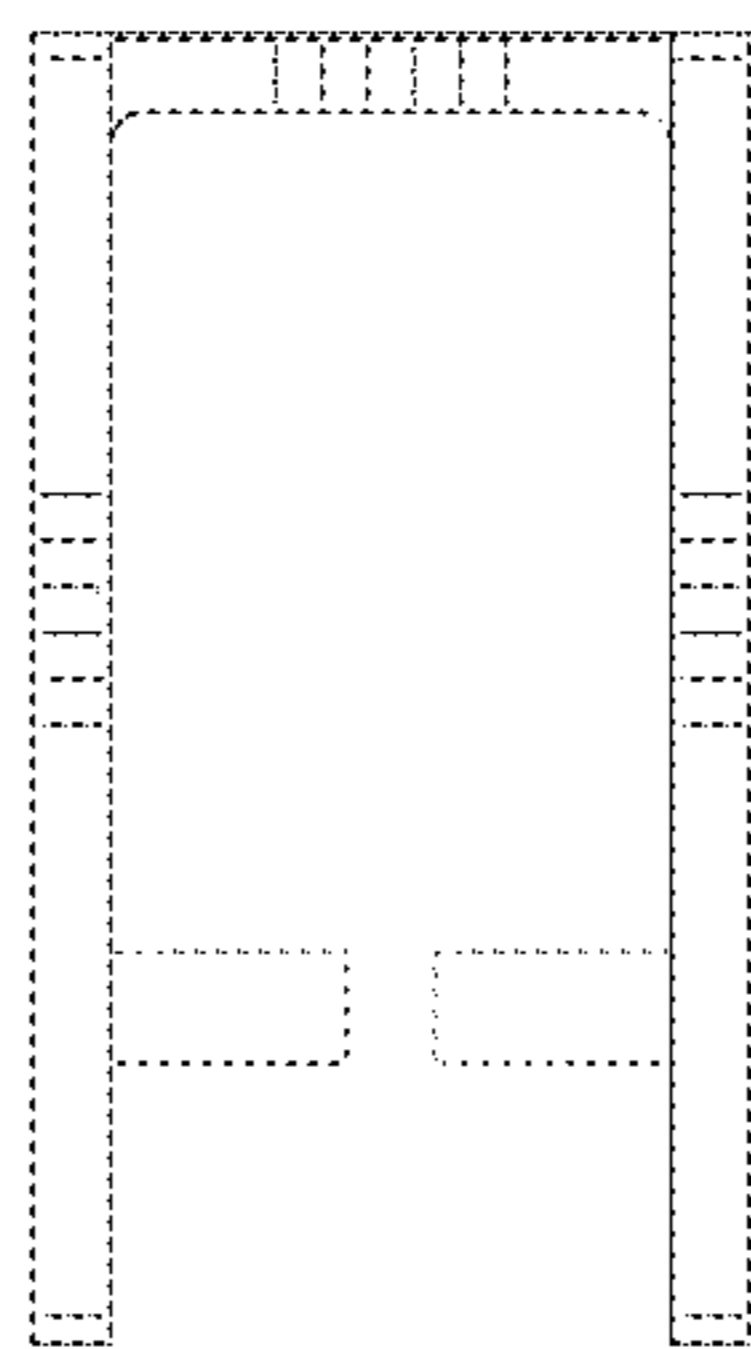

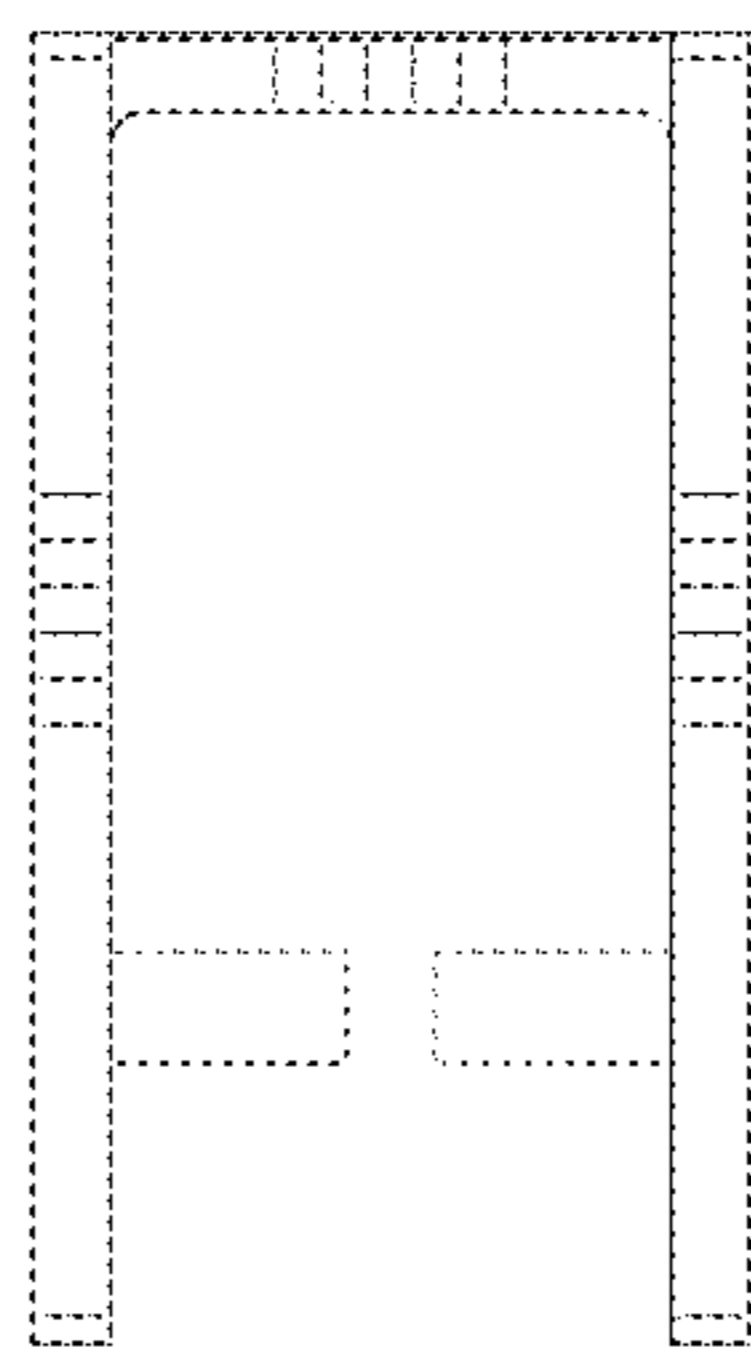

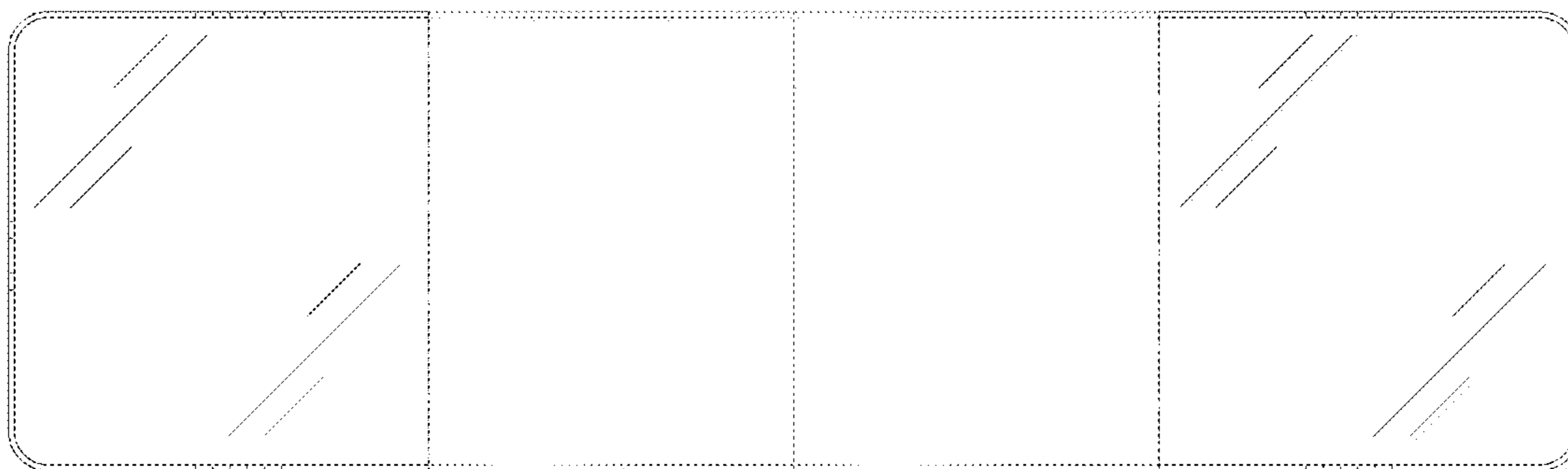

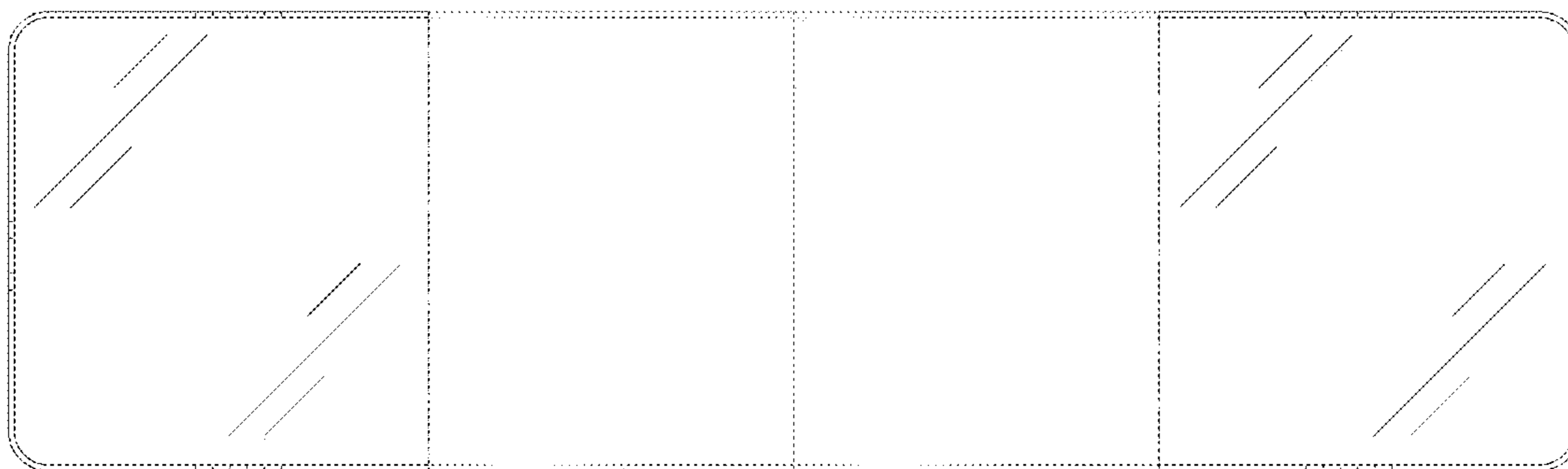
